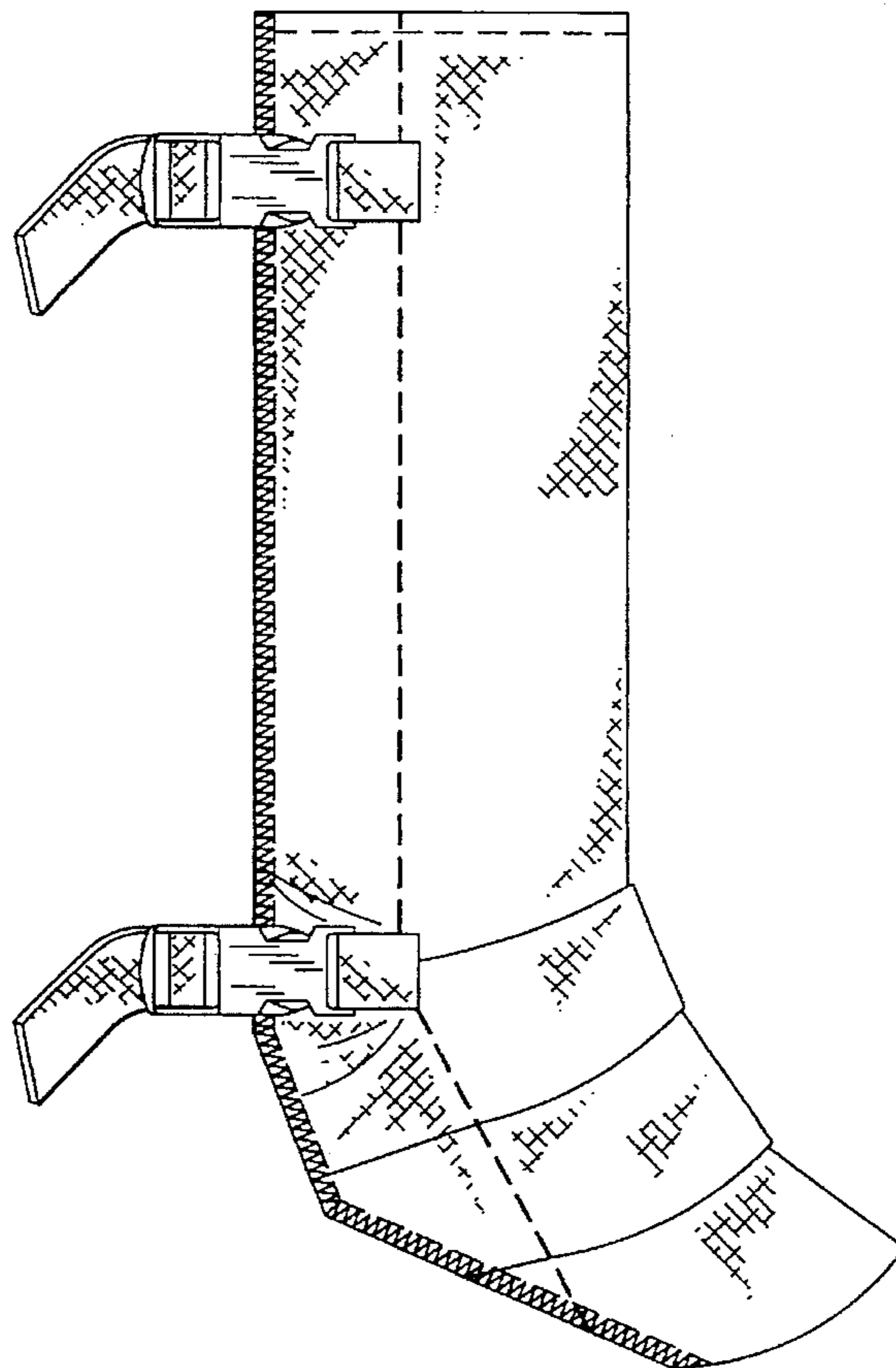
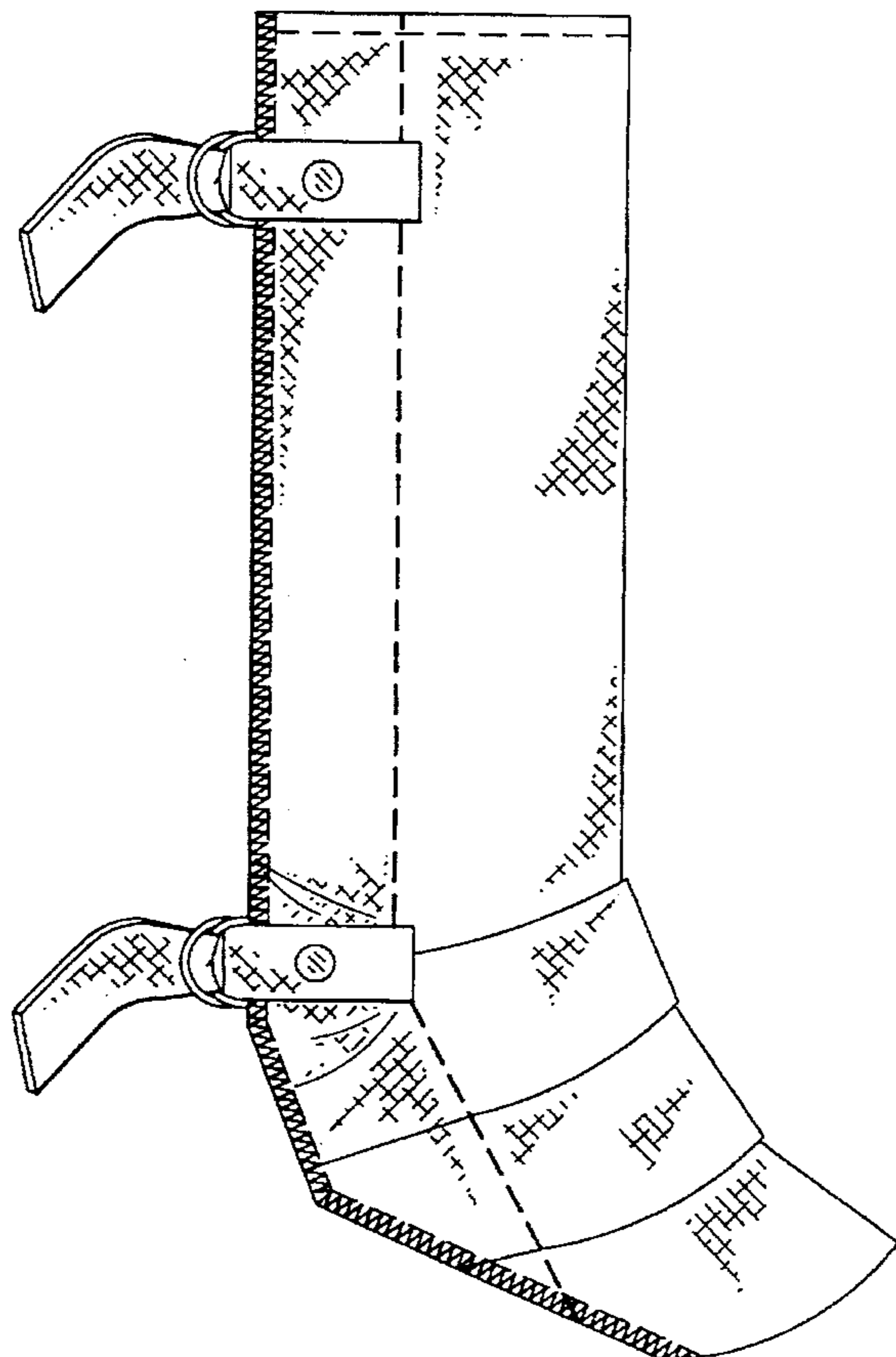
The design for a leg protector, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a leg protector showing our new design;
 FIG. 2 is a right side elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a top plan view of a second embodiment thereof;
 FIG. 8 is a right side elevational view thereof;
 FIG. 9 is a rear elevational view thereof;
 FIG. 10 is a front elevational view thereof;
 FIG. 11 is a left side elevational view thereof; and,
 FIG. 12 is a top plan view thereof.

The crosshatch surface shading is understood to repeat throughout the indicated area and the broken lines represent conventional stitching.

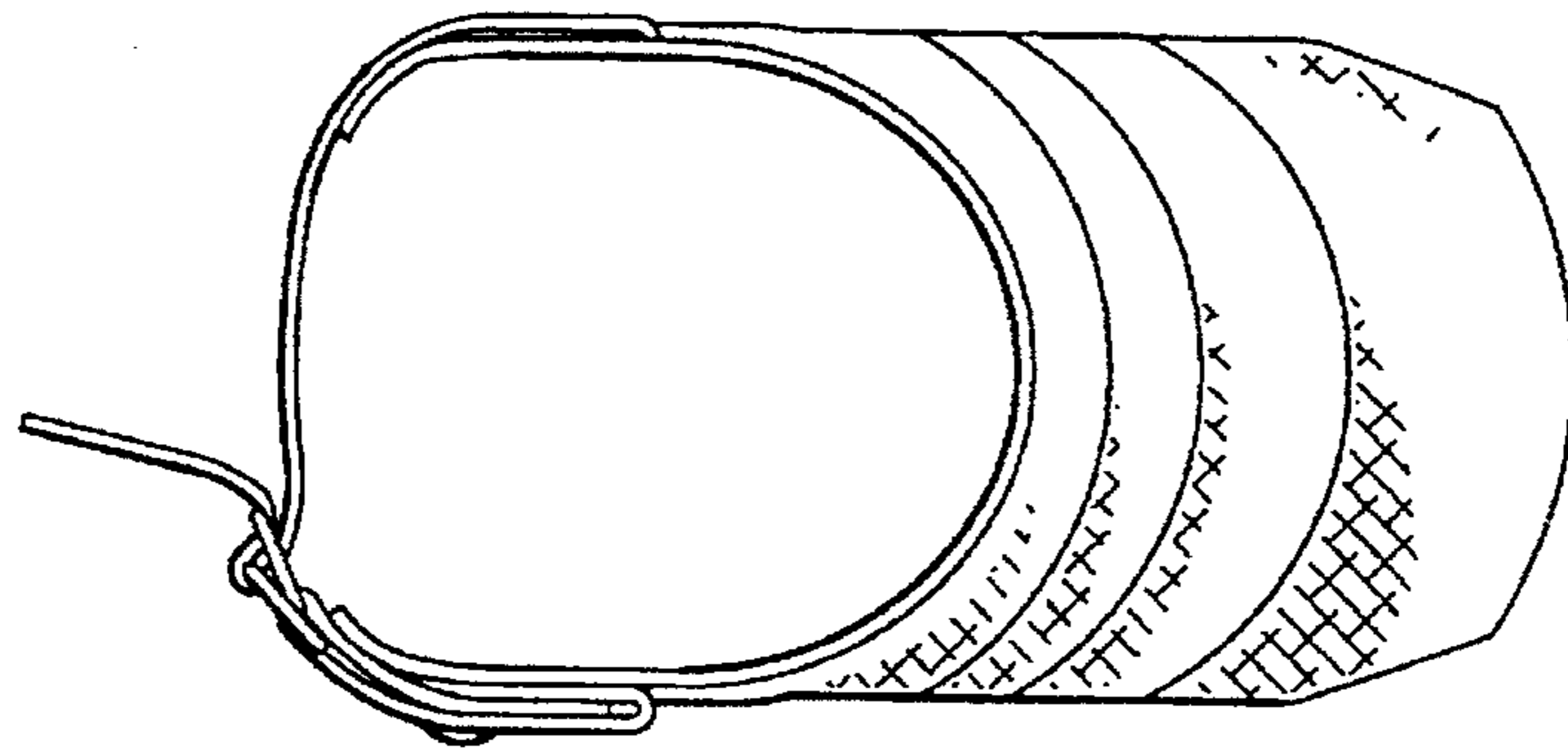

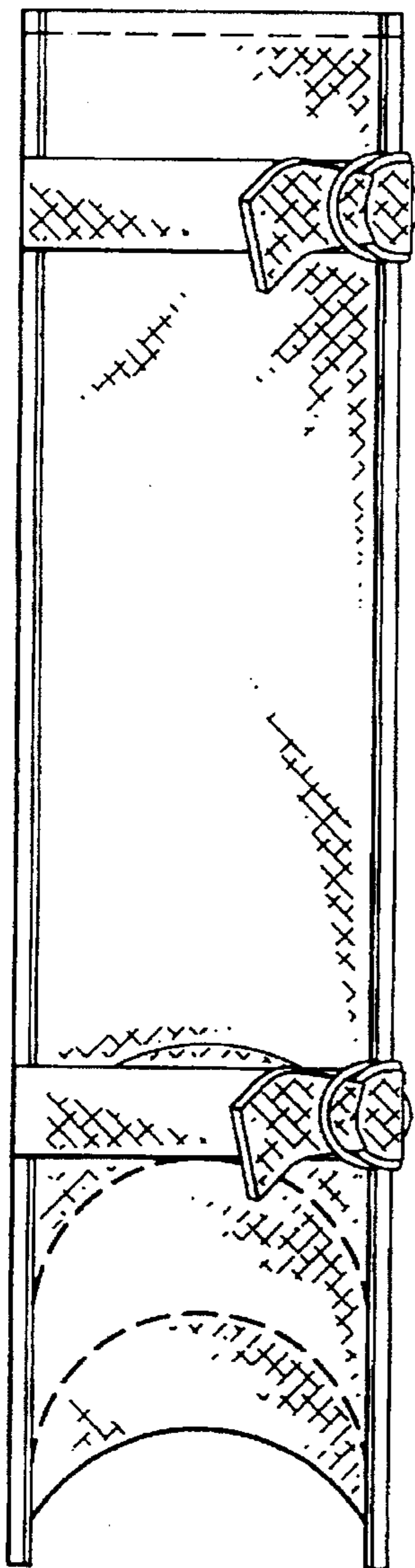

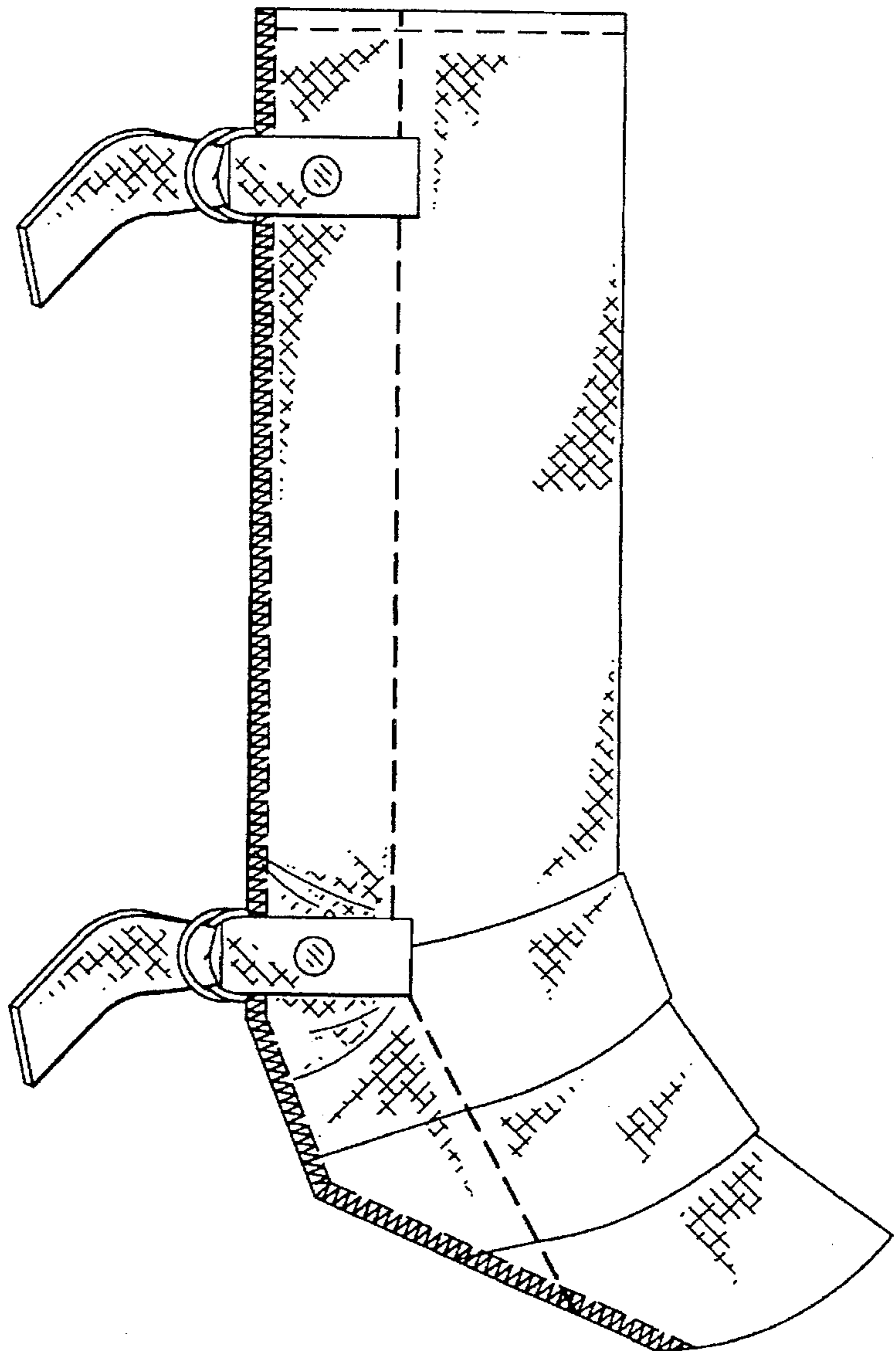

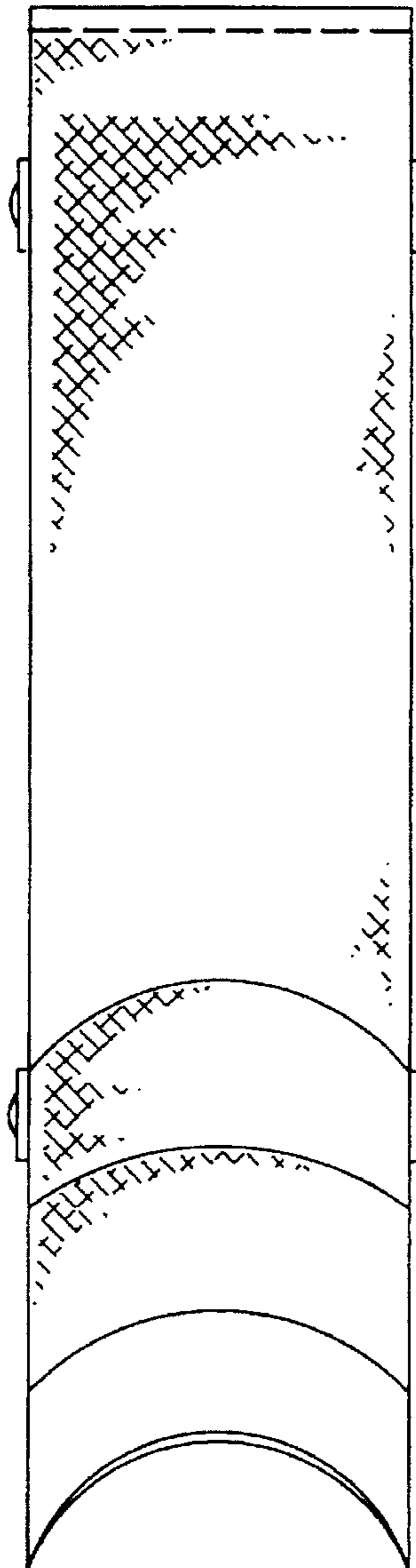

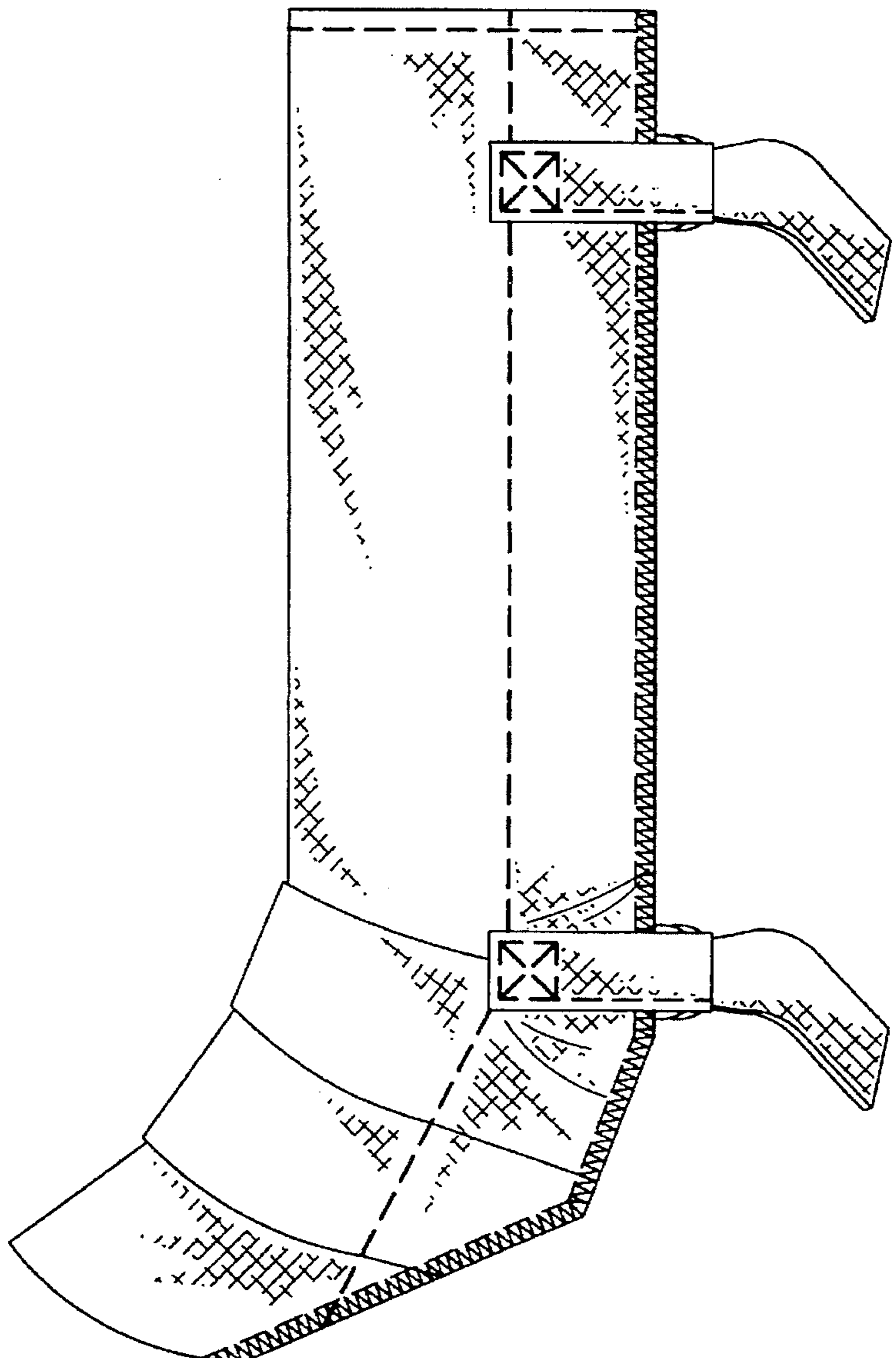

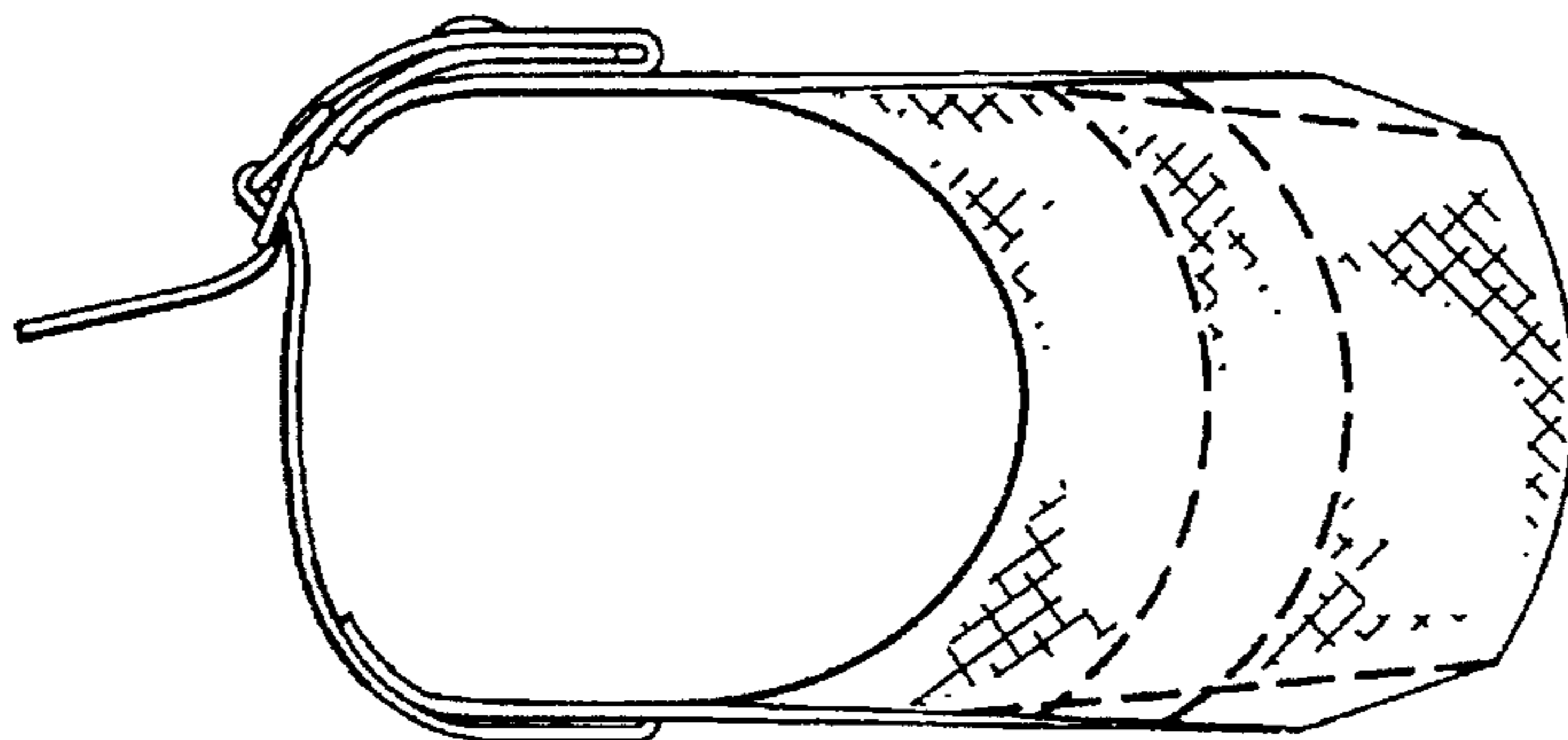

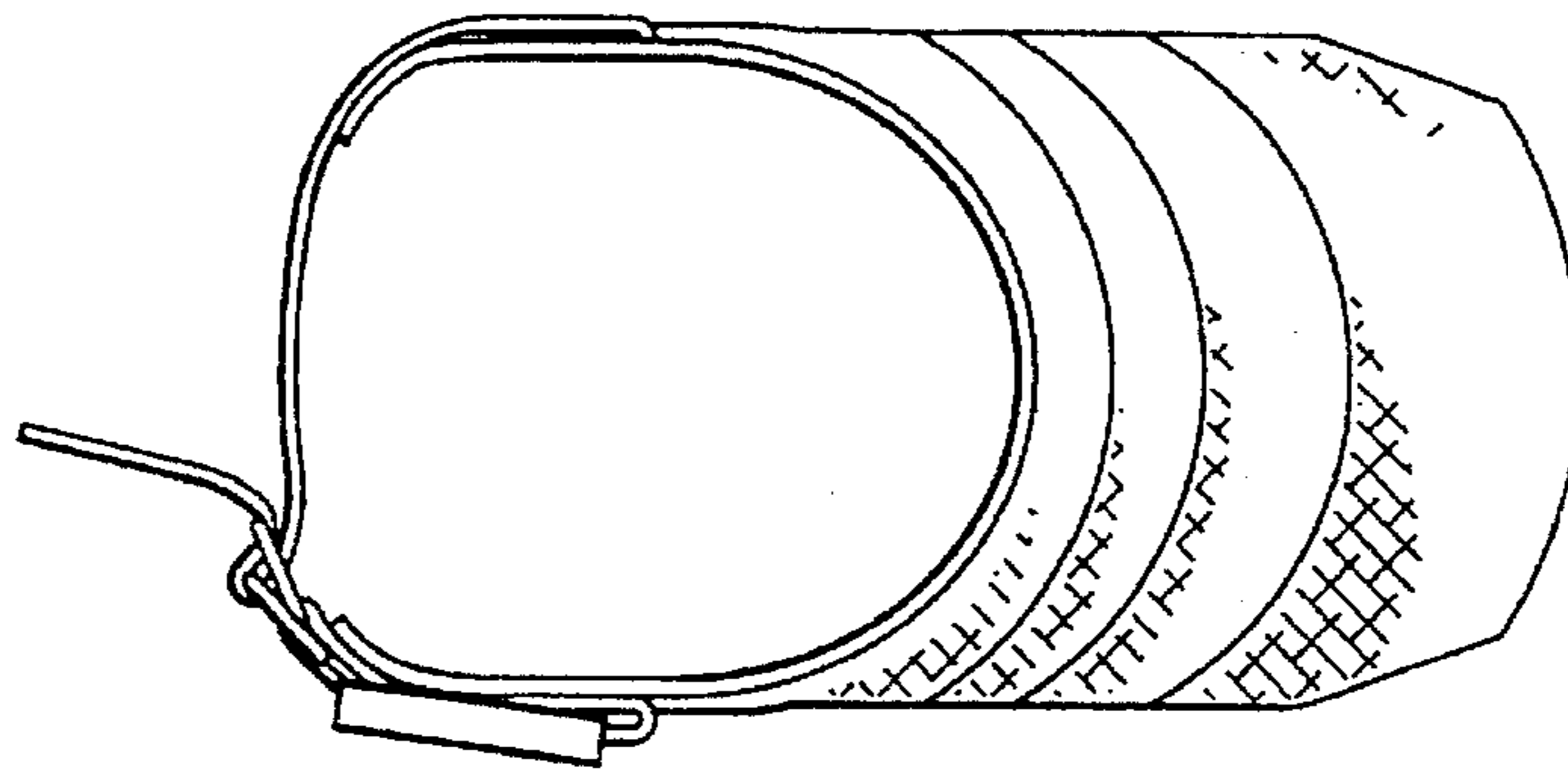

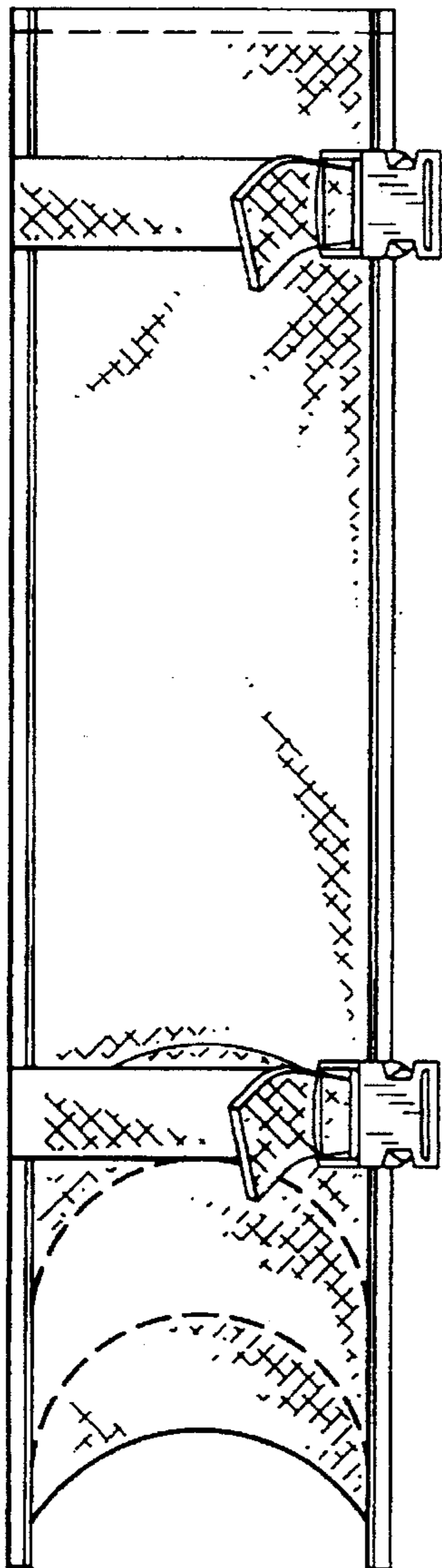

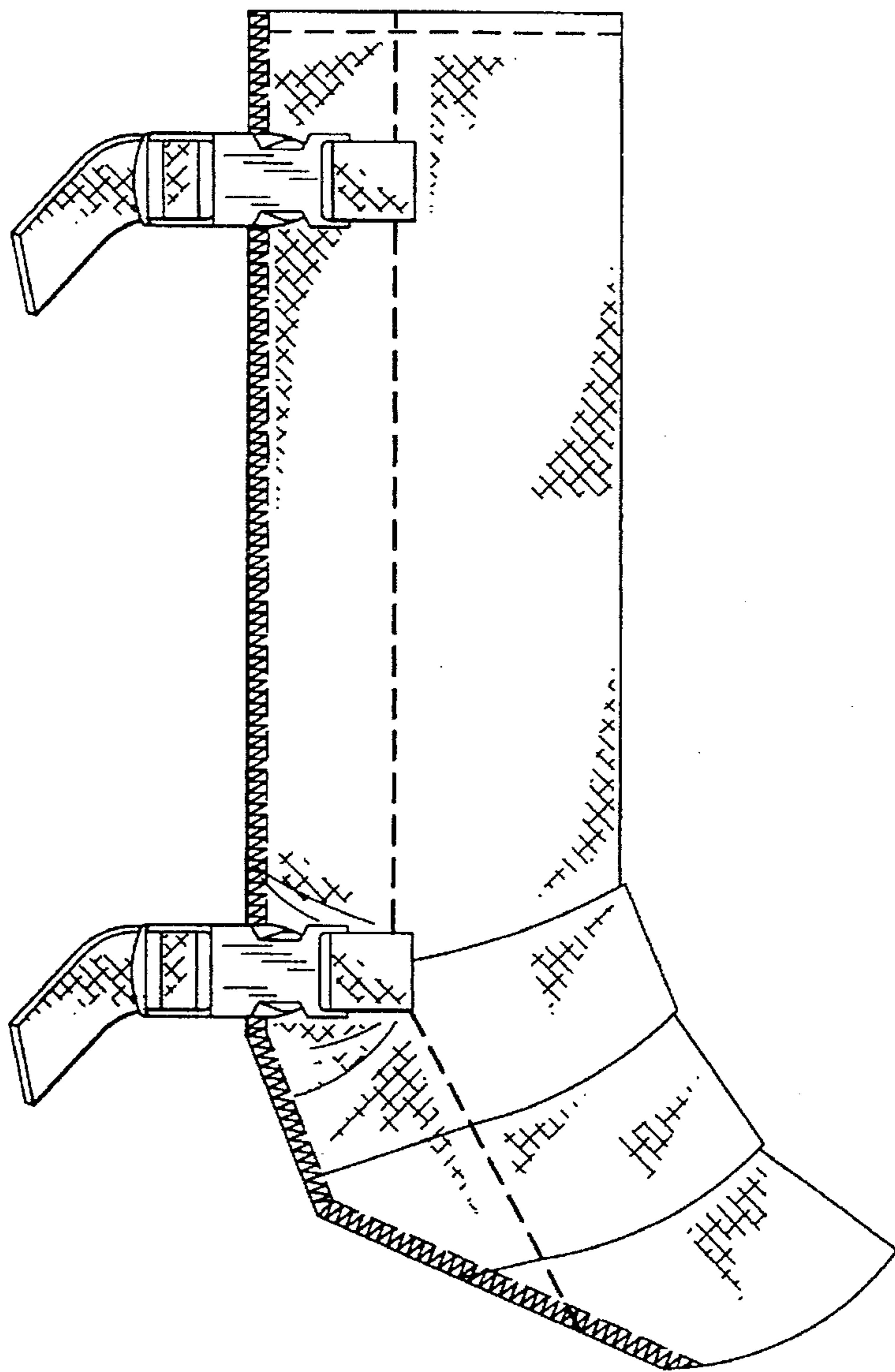

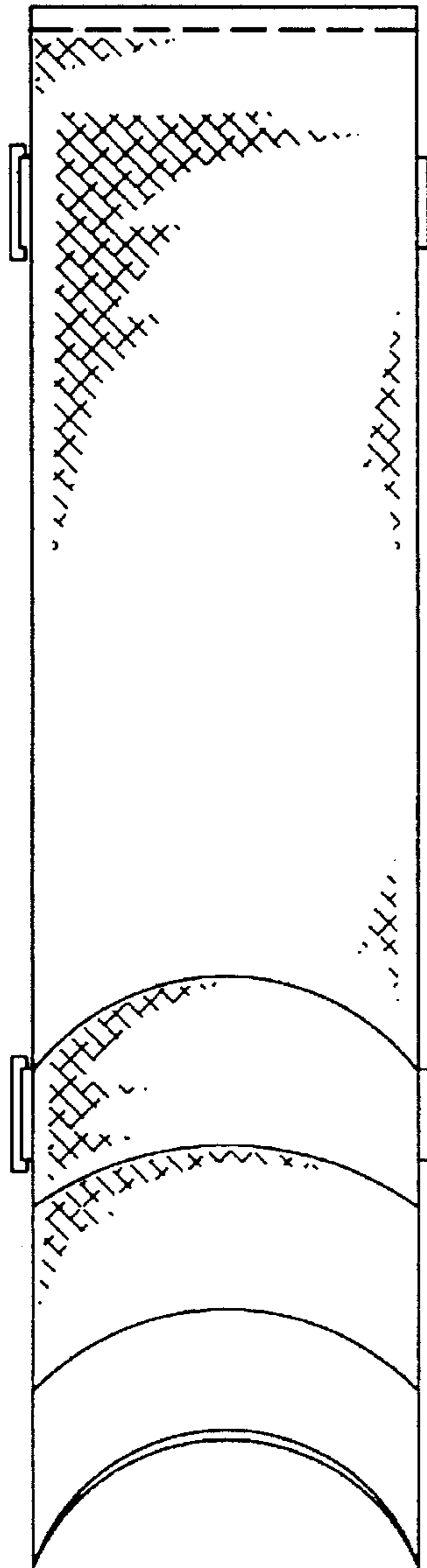

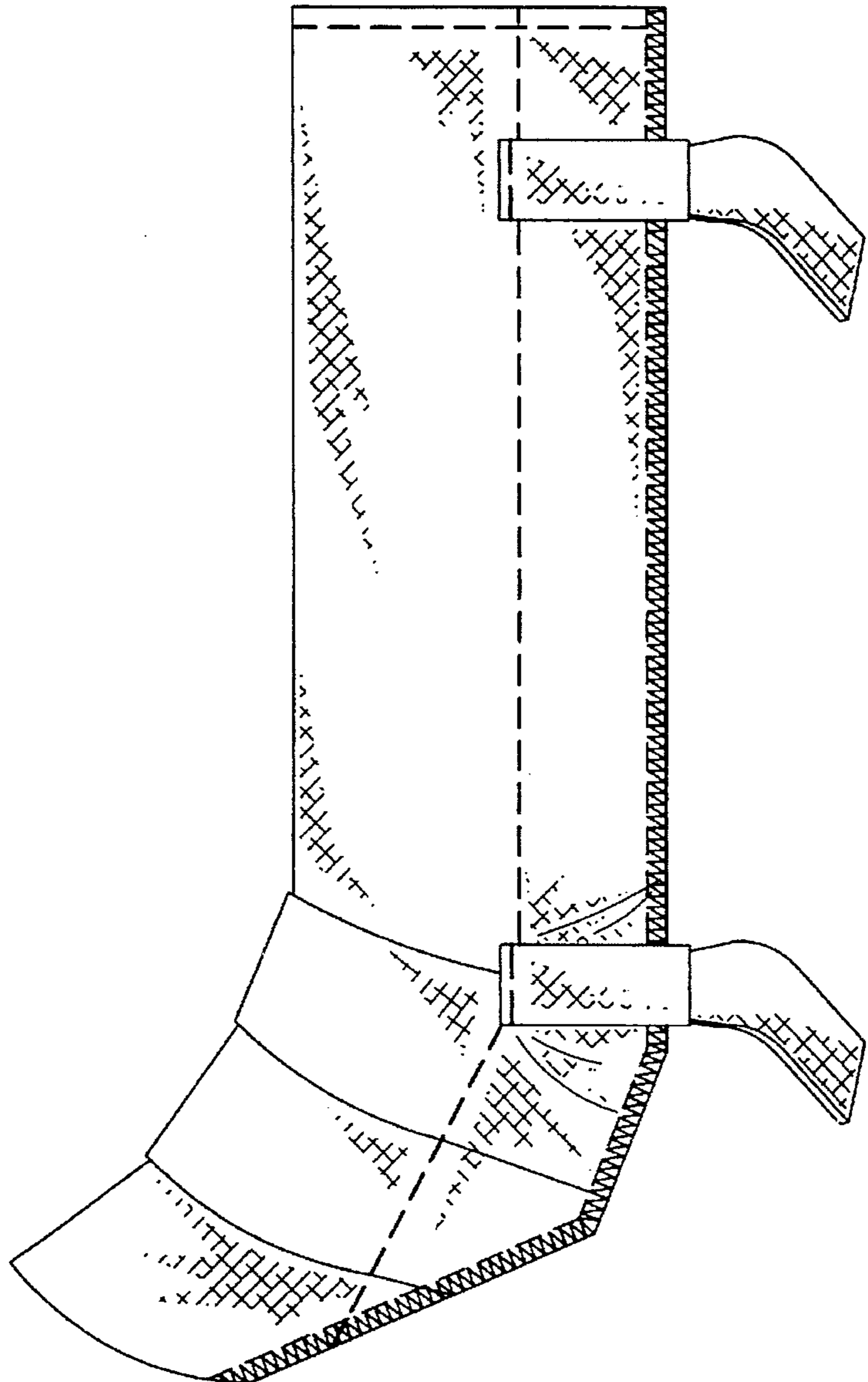

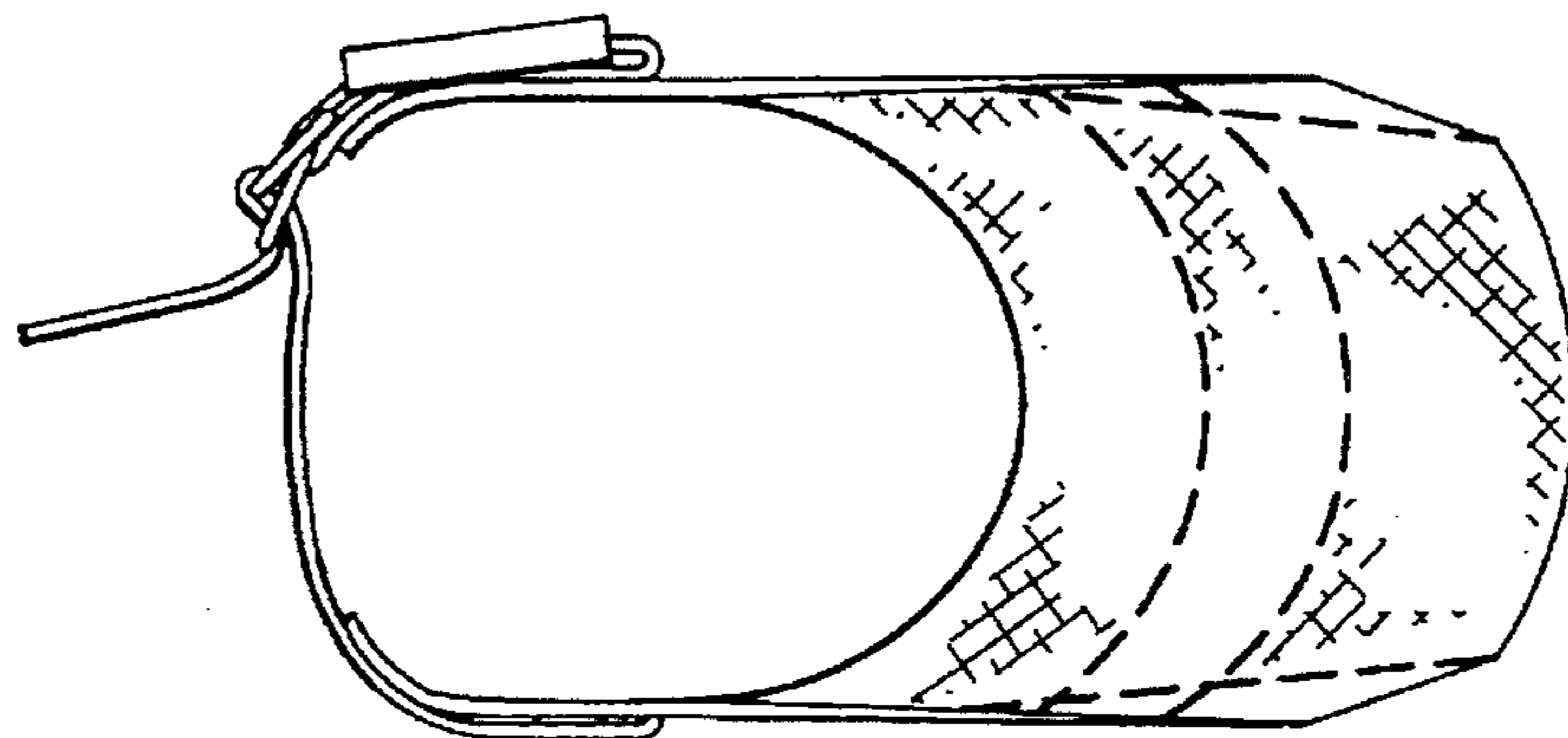
