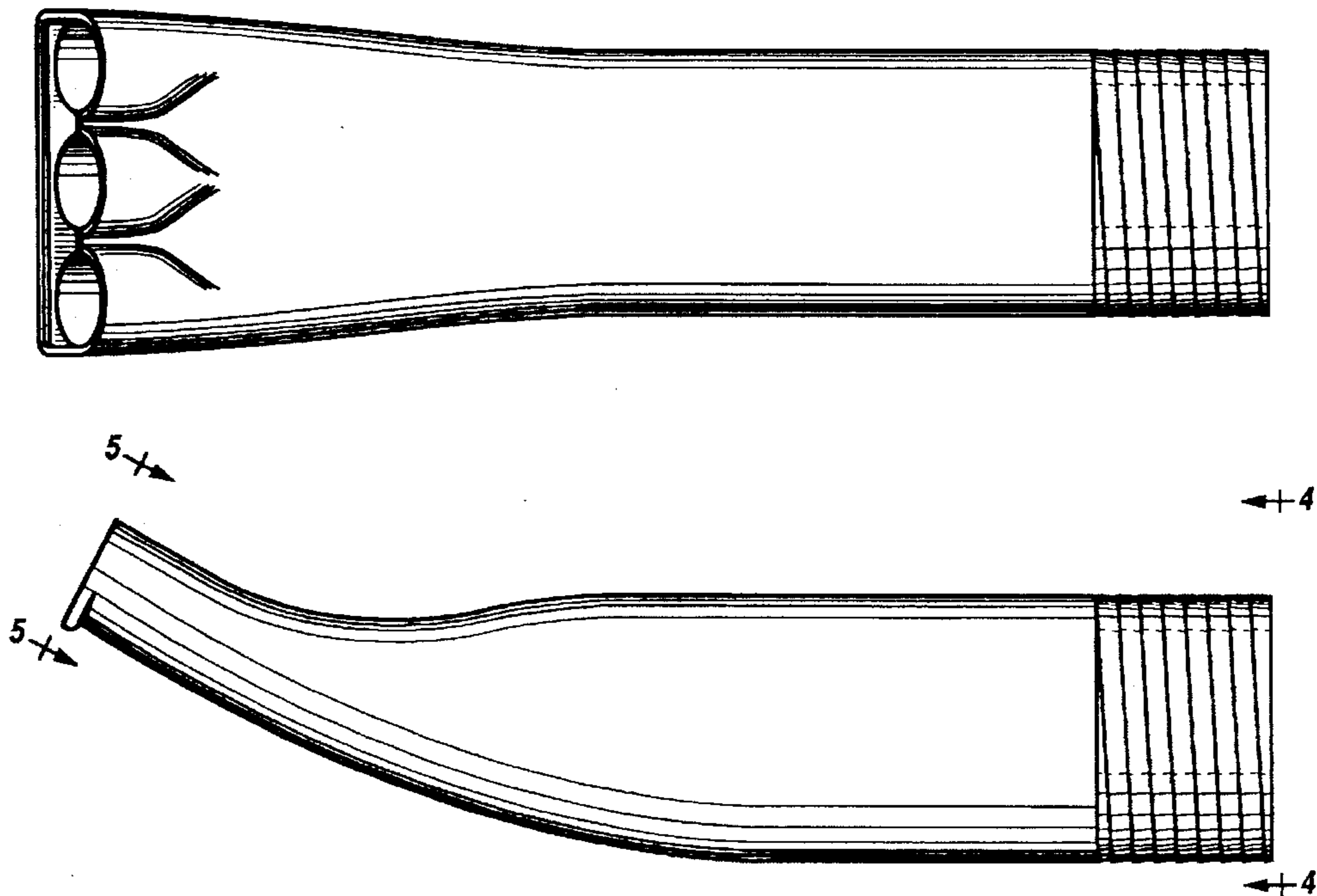
[57] **CLAIM**

The ornamental design for an air nozzle for a leaf blower, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a nozzle for a leaf blower showing the design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a top plan view of a second embodiment of a nozzle for a leaf blower showing the design; FIG. 7 is a left side elevational view of FIG. 6; FIG. 8 is a bottom plan view of FIG. 6; FIG. 9 is a rear elevational view of FIG. 6; FIG. 10 is a front elevational view of FIG. 6; FIG. 11 is a top plan view of a third embodiment of a nozzle for a leaf blower showing the design; FIG. 12 is a left side elevational view of FIG. 11; FIG. 13 is a bottom plan view of FIG. 11; FIG. 14 is a rear elevational view of FIG. 11; FIG. 15 is a front elevational view of FIG. 11; FIG. 16 is a top plan view of a fourth embodiment of a nozzle for a leaf blower showing the design; FIG. 17 is a left side elevational view of FIG. 16; FIG. 18 is a bottom plan view of FIG. 16; FIG. 19 is a rear elevational view of FIG. 16; FIG. 20 is a front elevational view of FIG. 16; and, FIG. 21 is a reduced side elevational view of FIG. 1. The right side elevational view of each of the four embodiments is a mirror image of the left side elevational view of the respective embodiment. The leaf blower indicated by broken lines in FIG. 21 is for illustrative purposes only and forms no part of the claimed design.

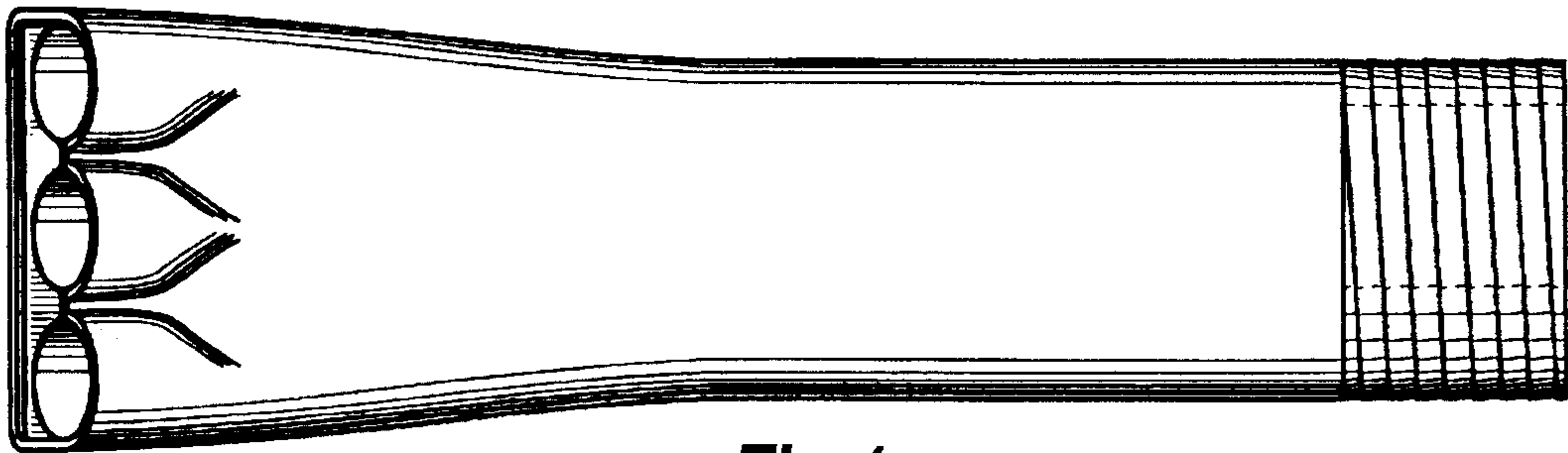

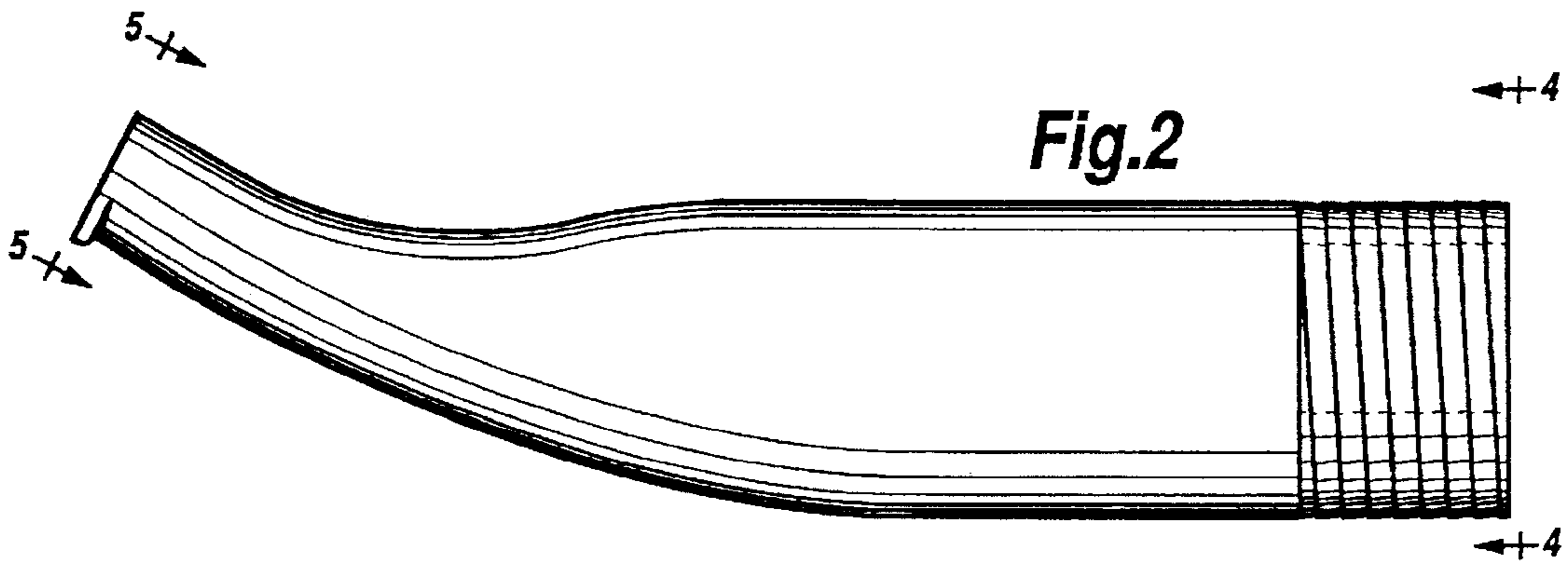

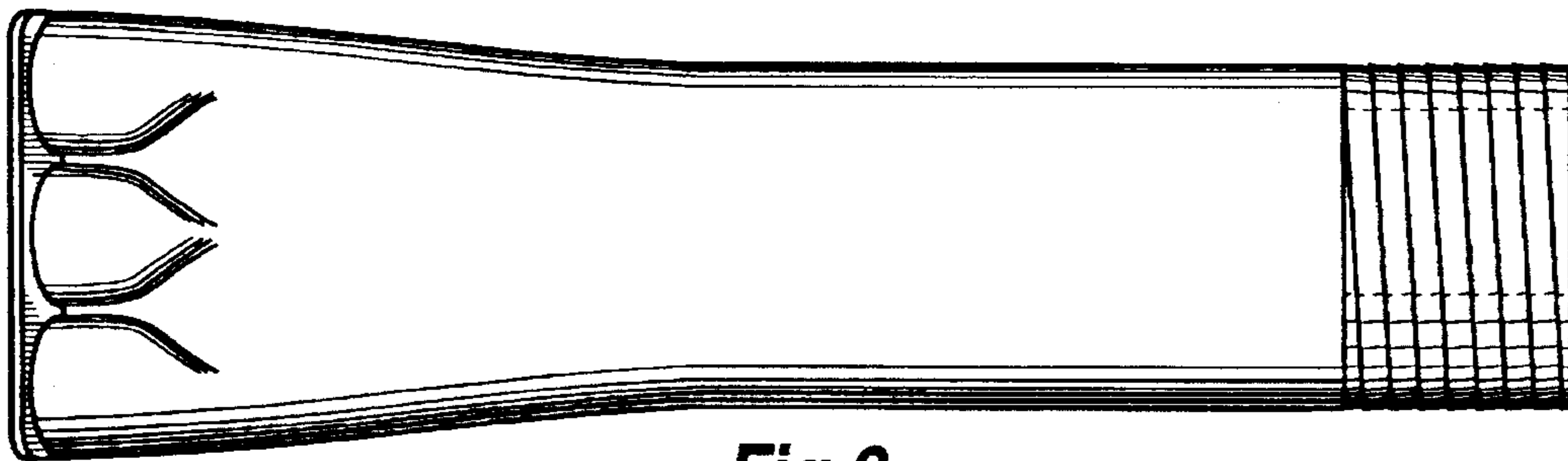

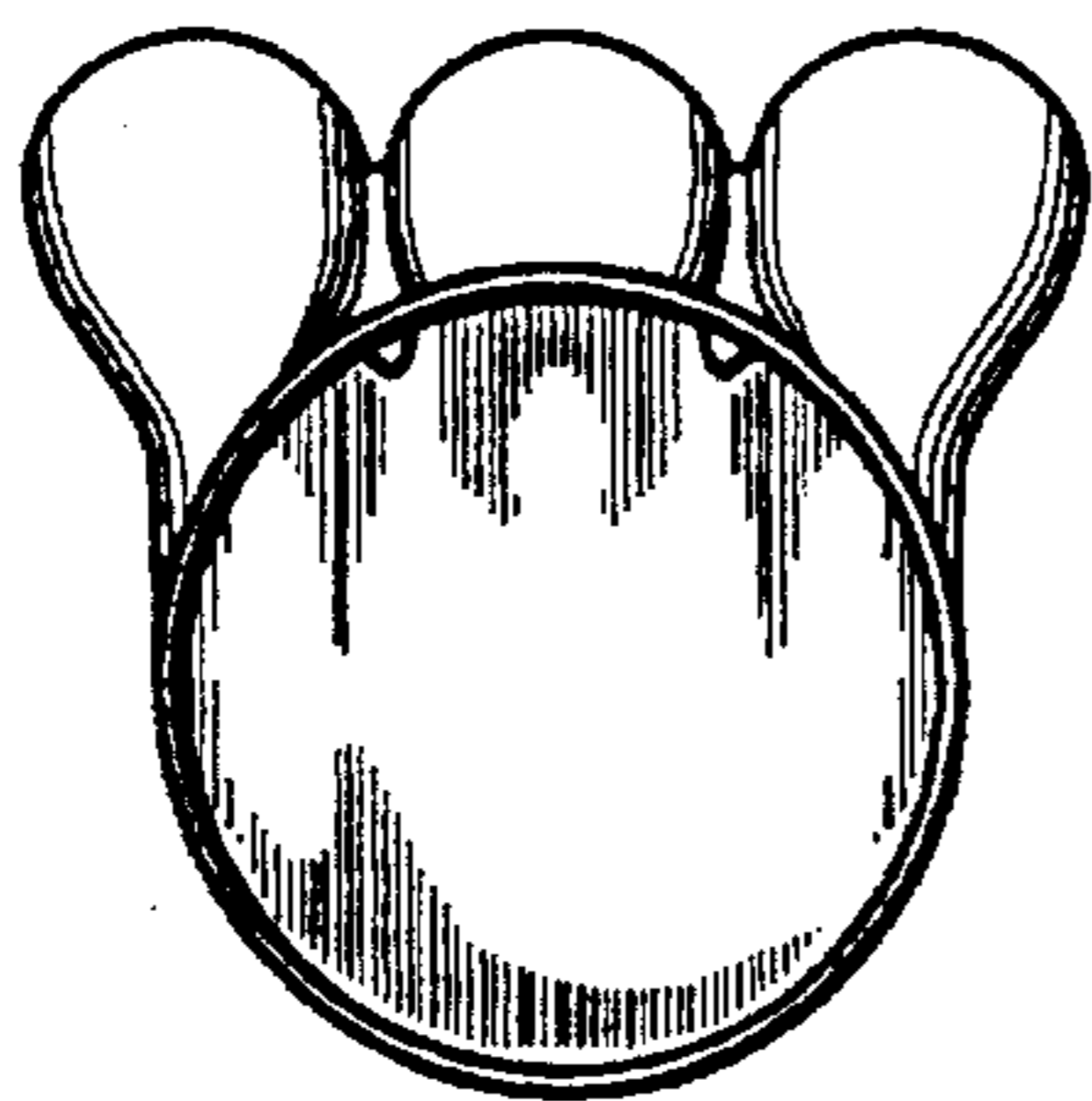

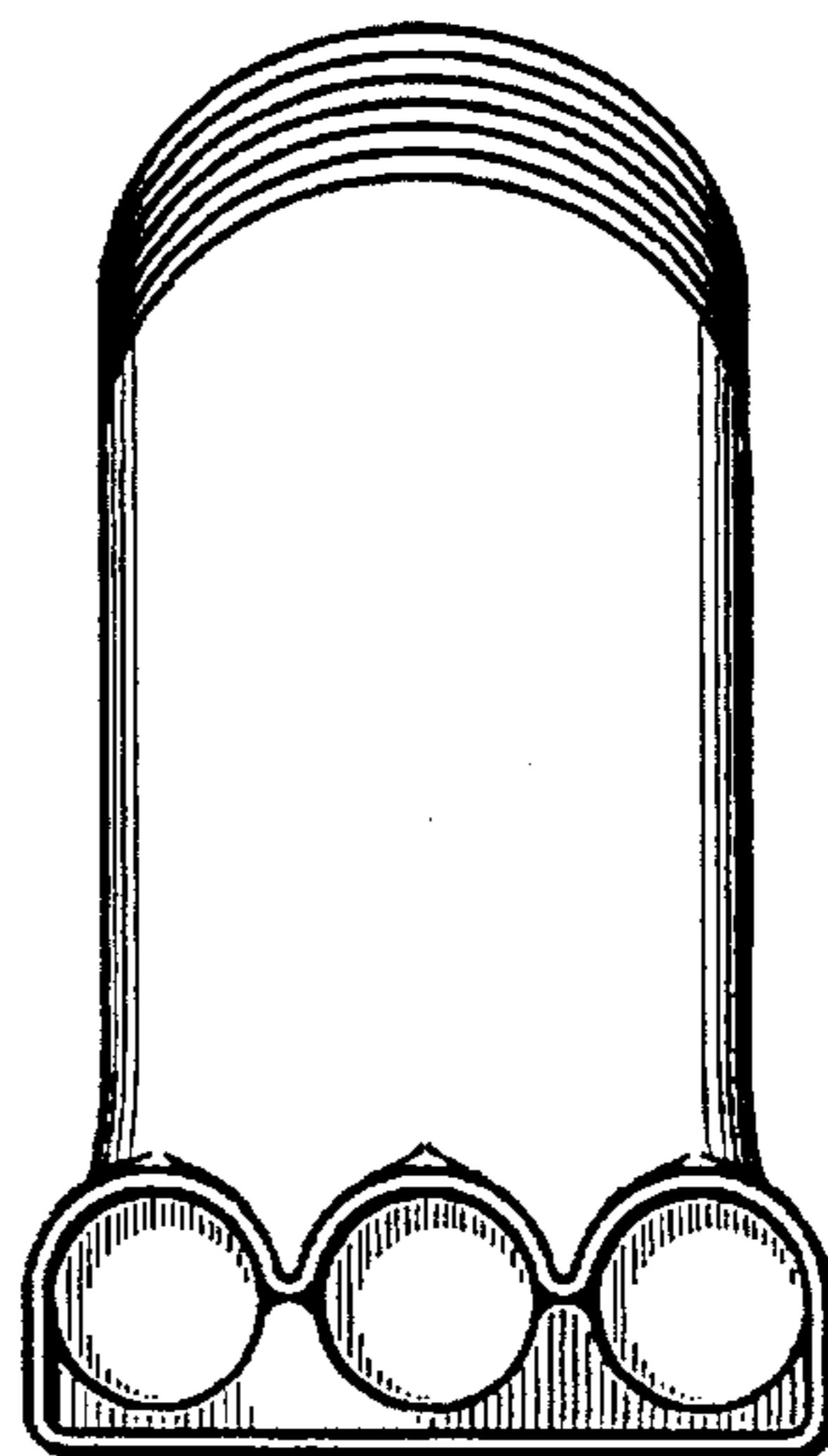

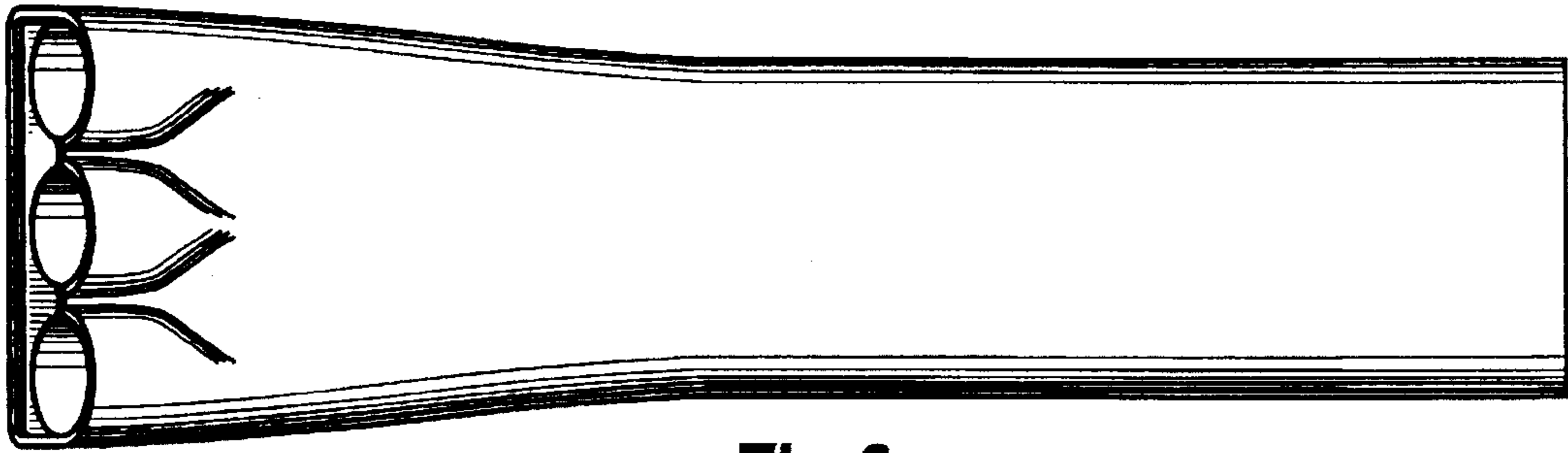

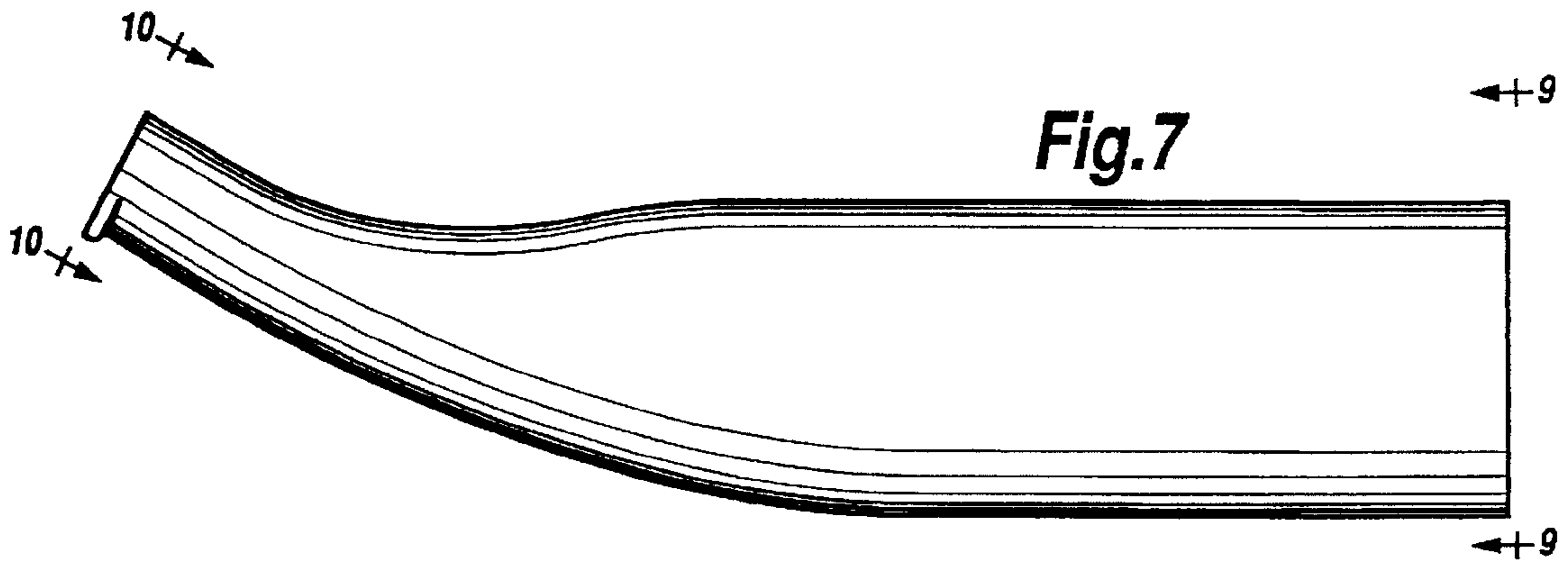

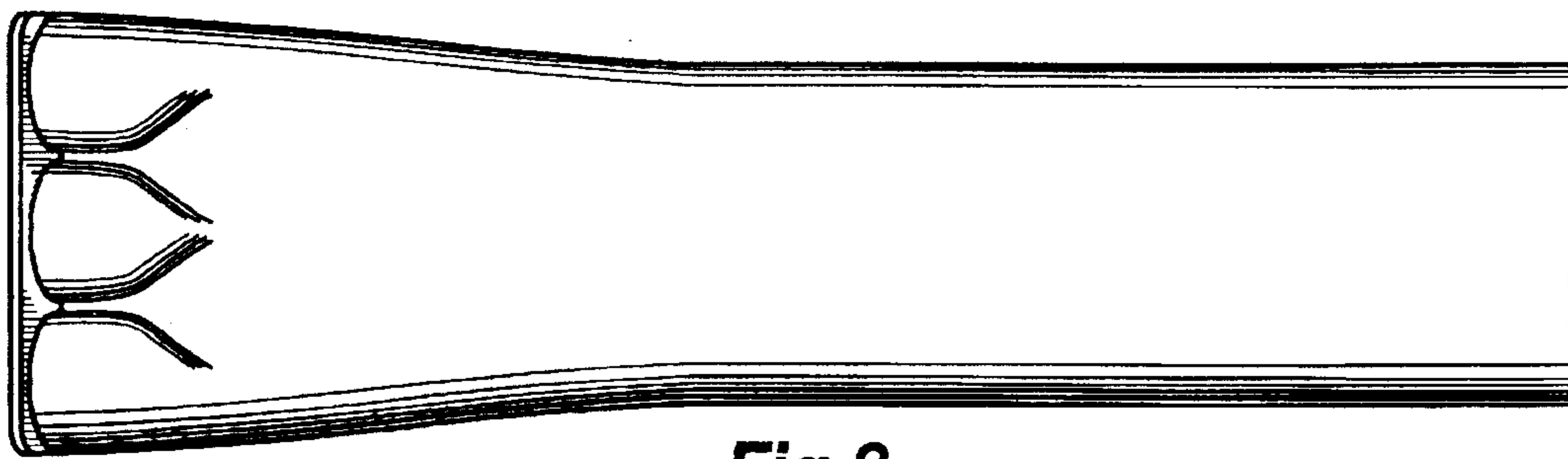

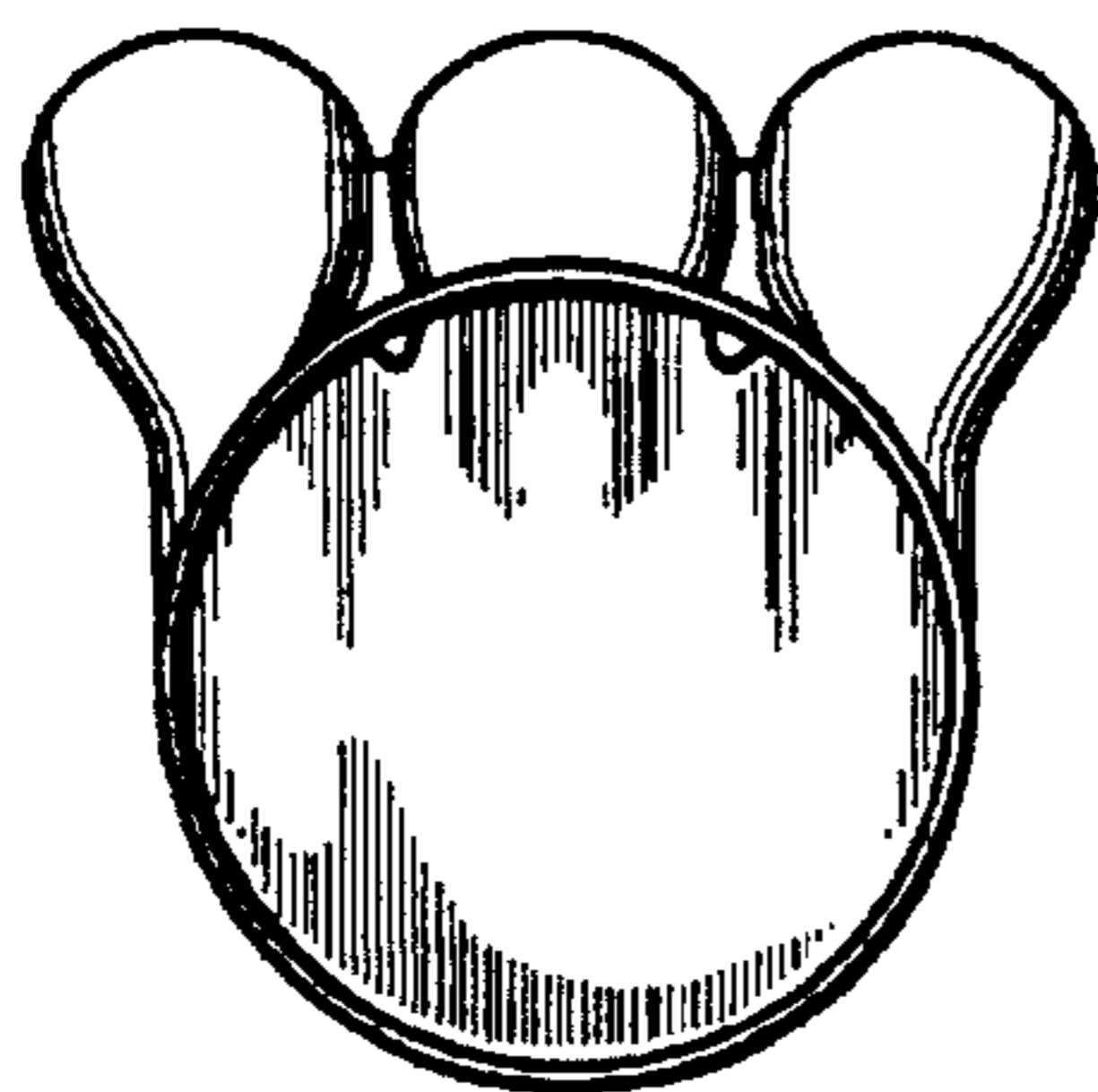

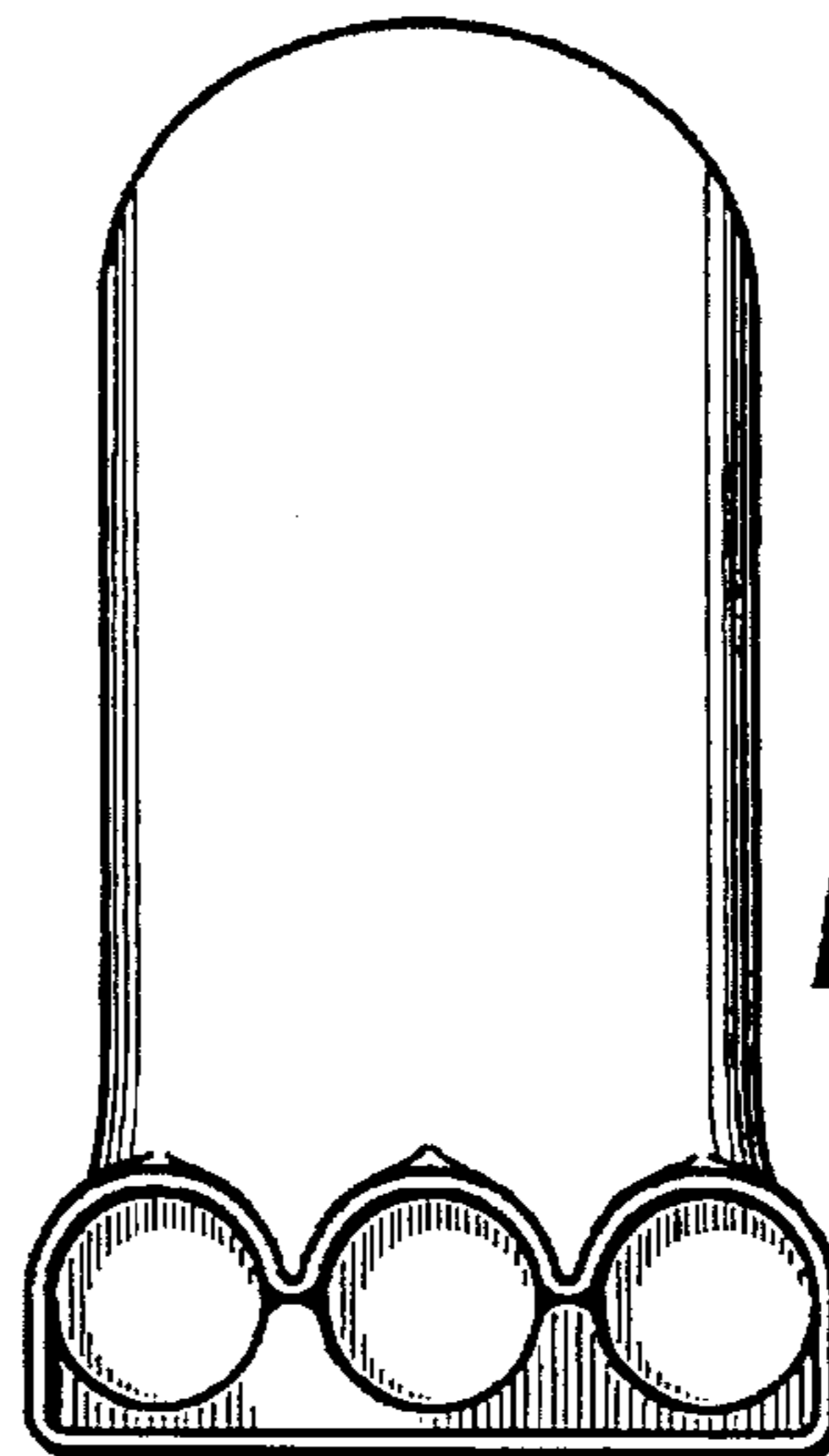

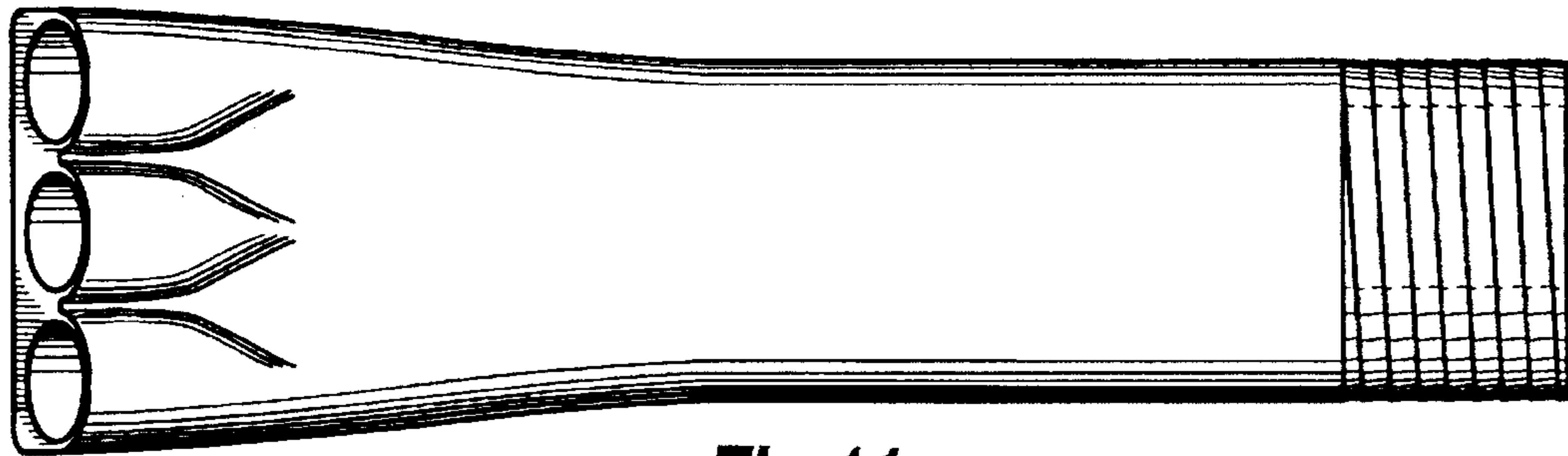

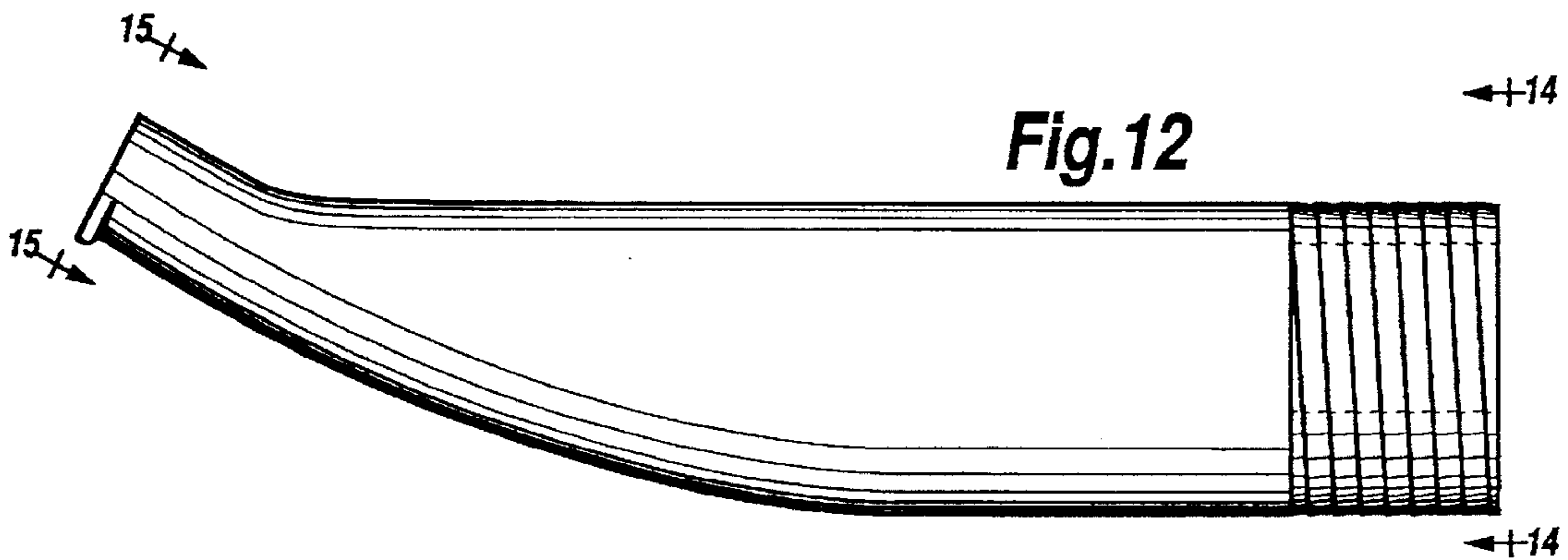

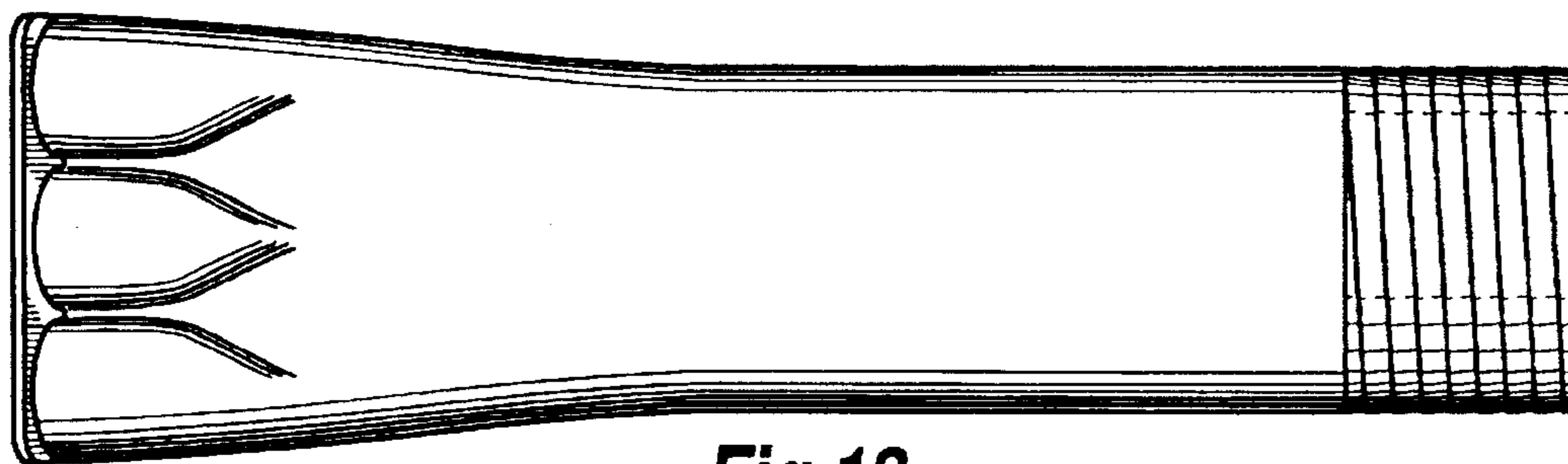

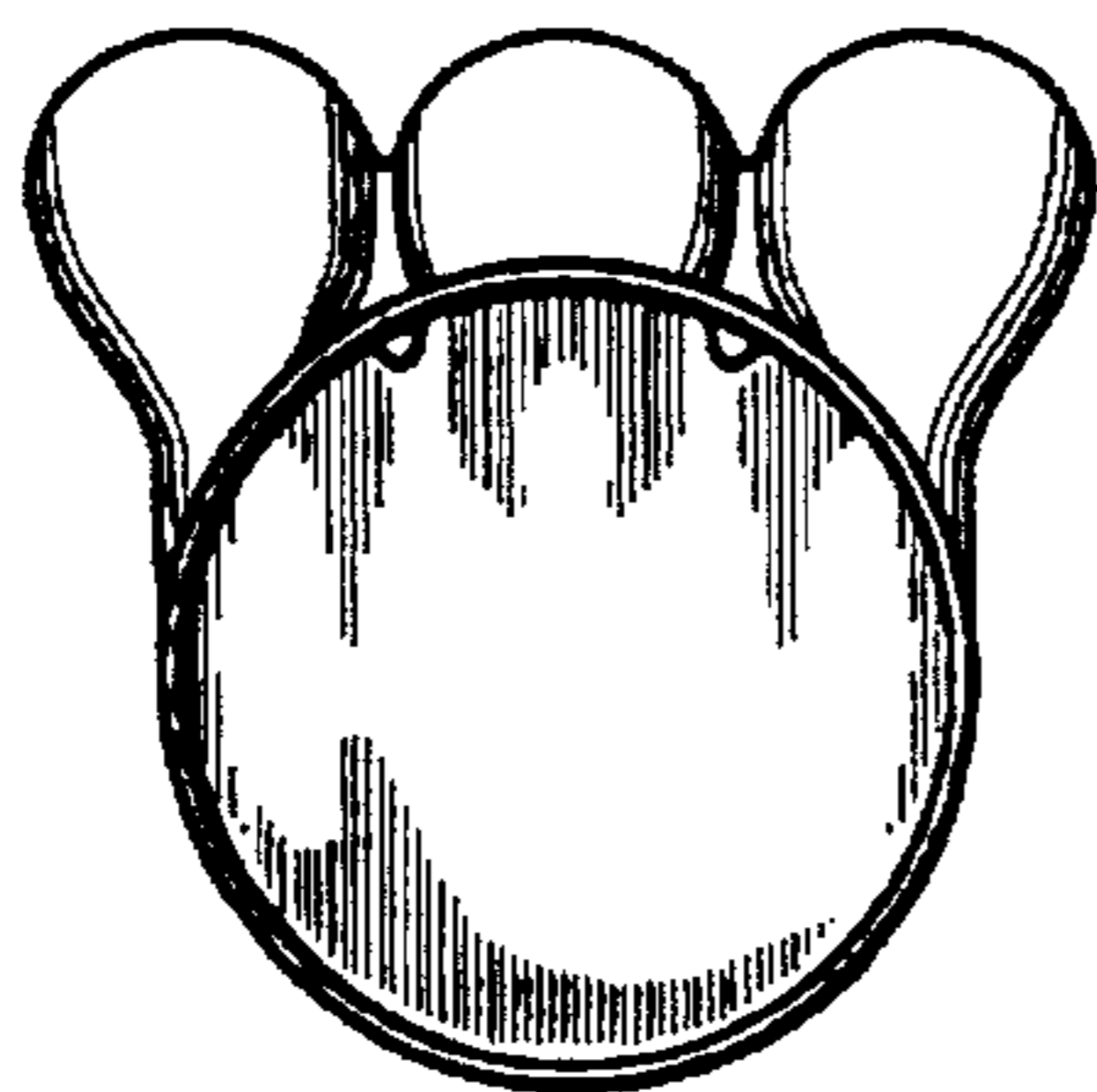

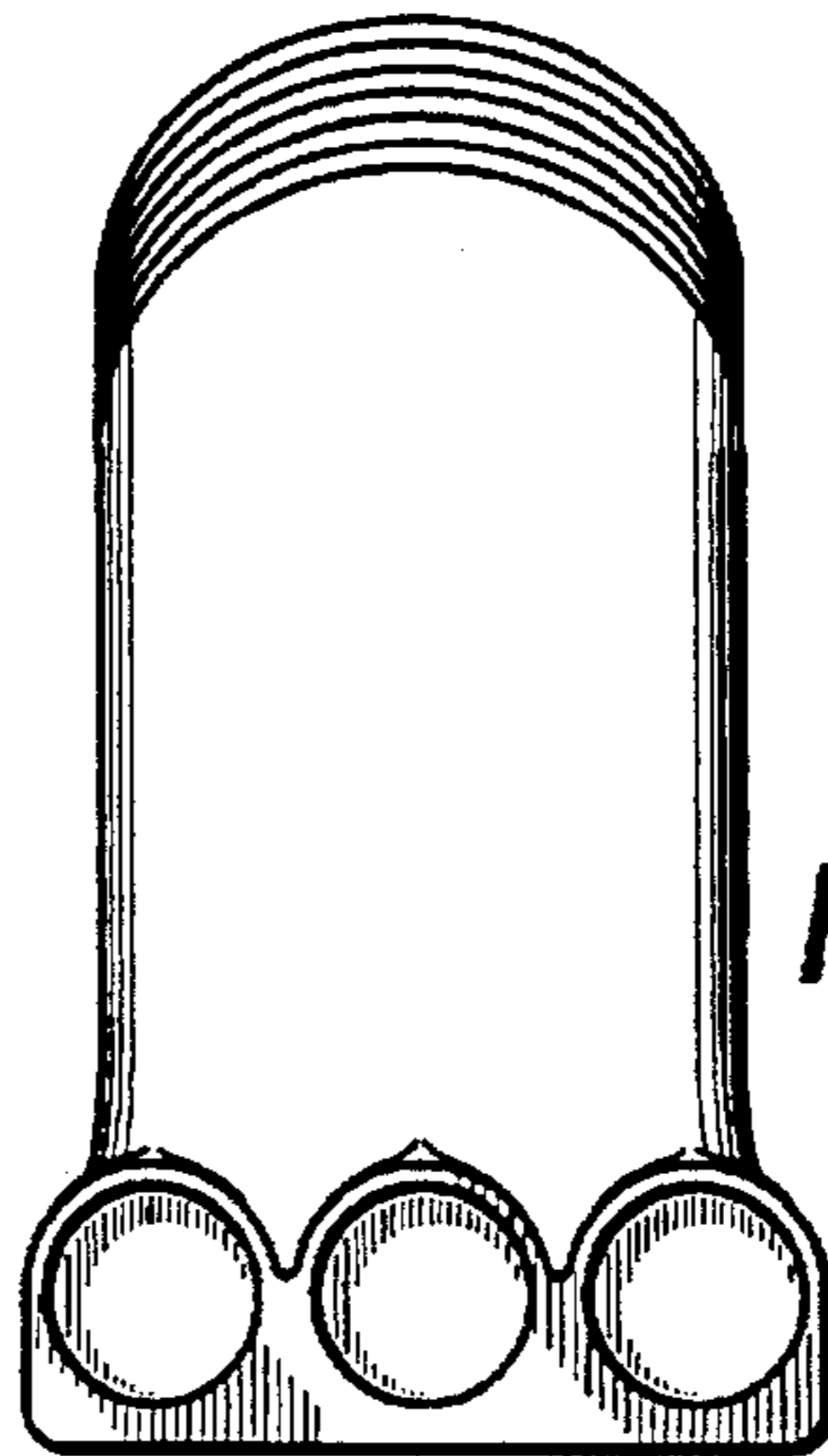

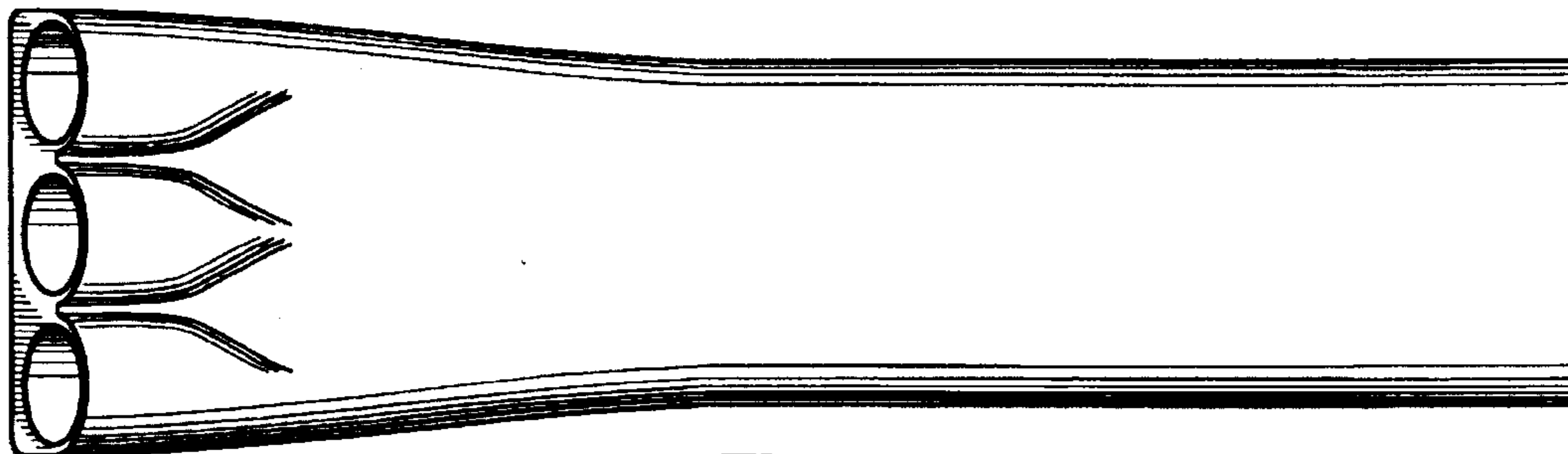

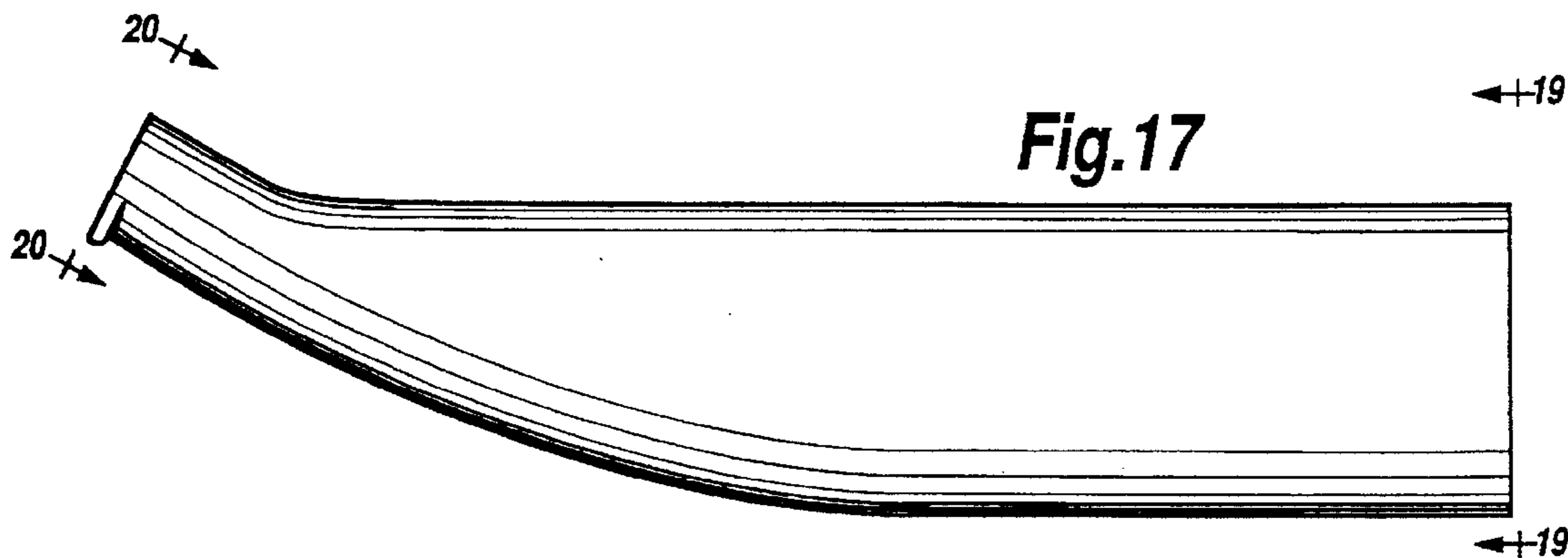

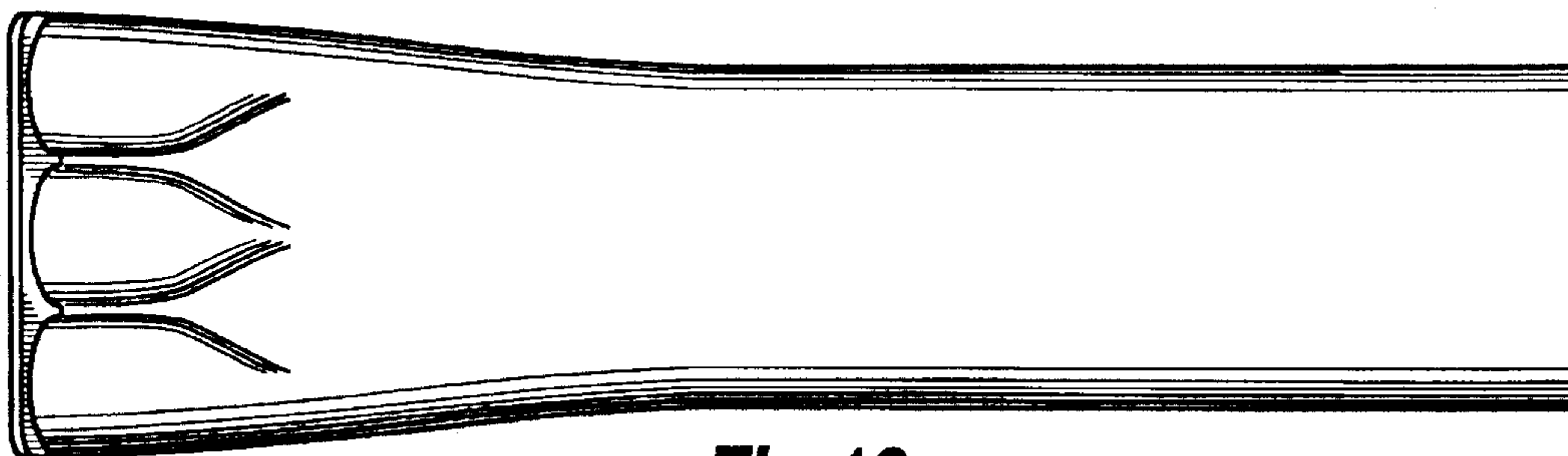

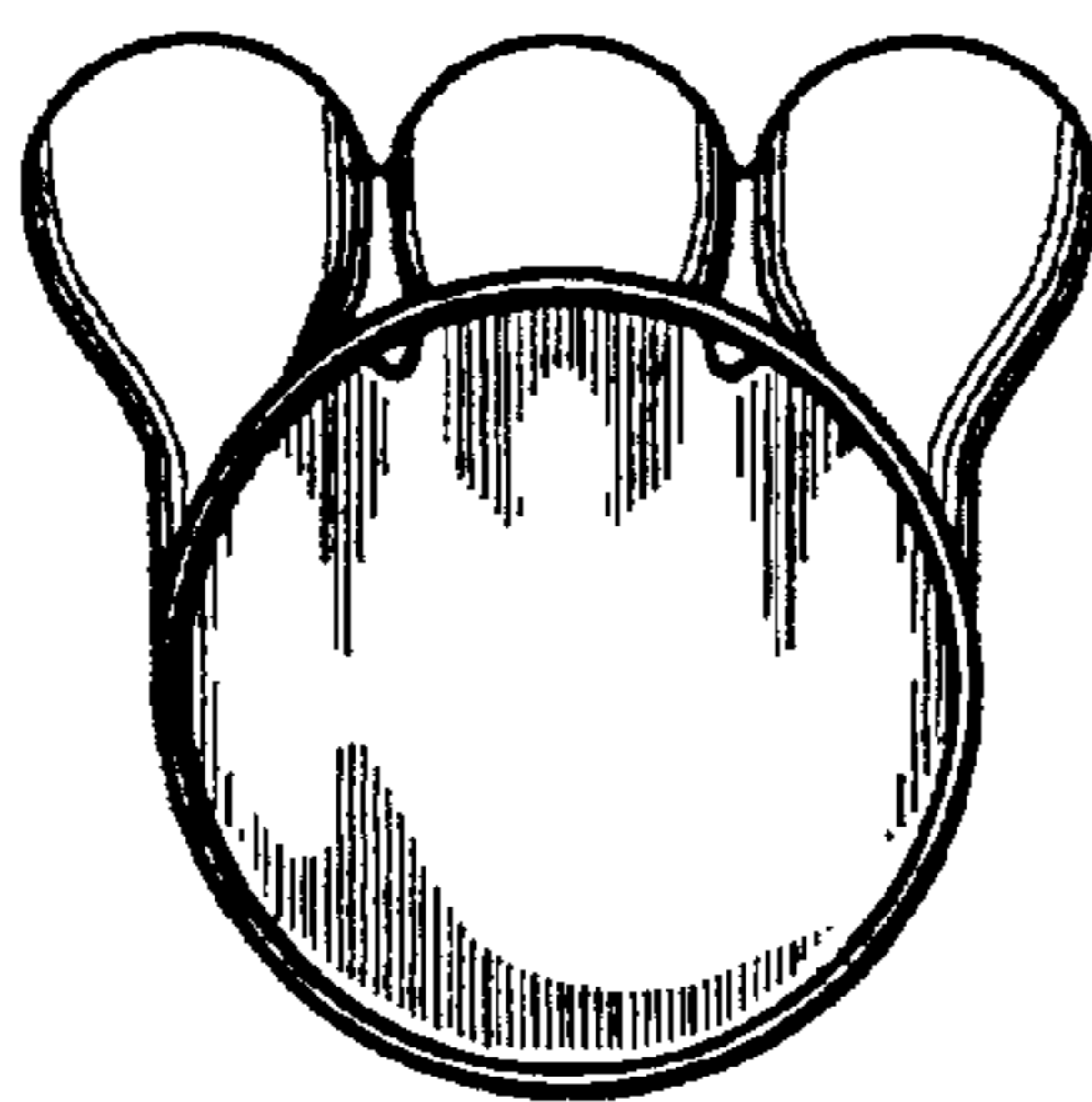

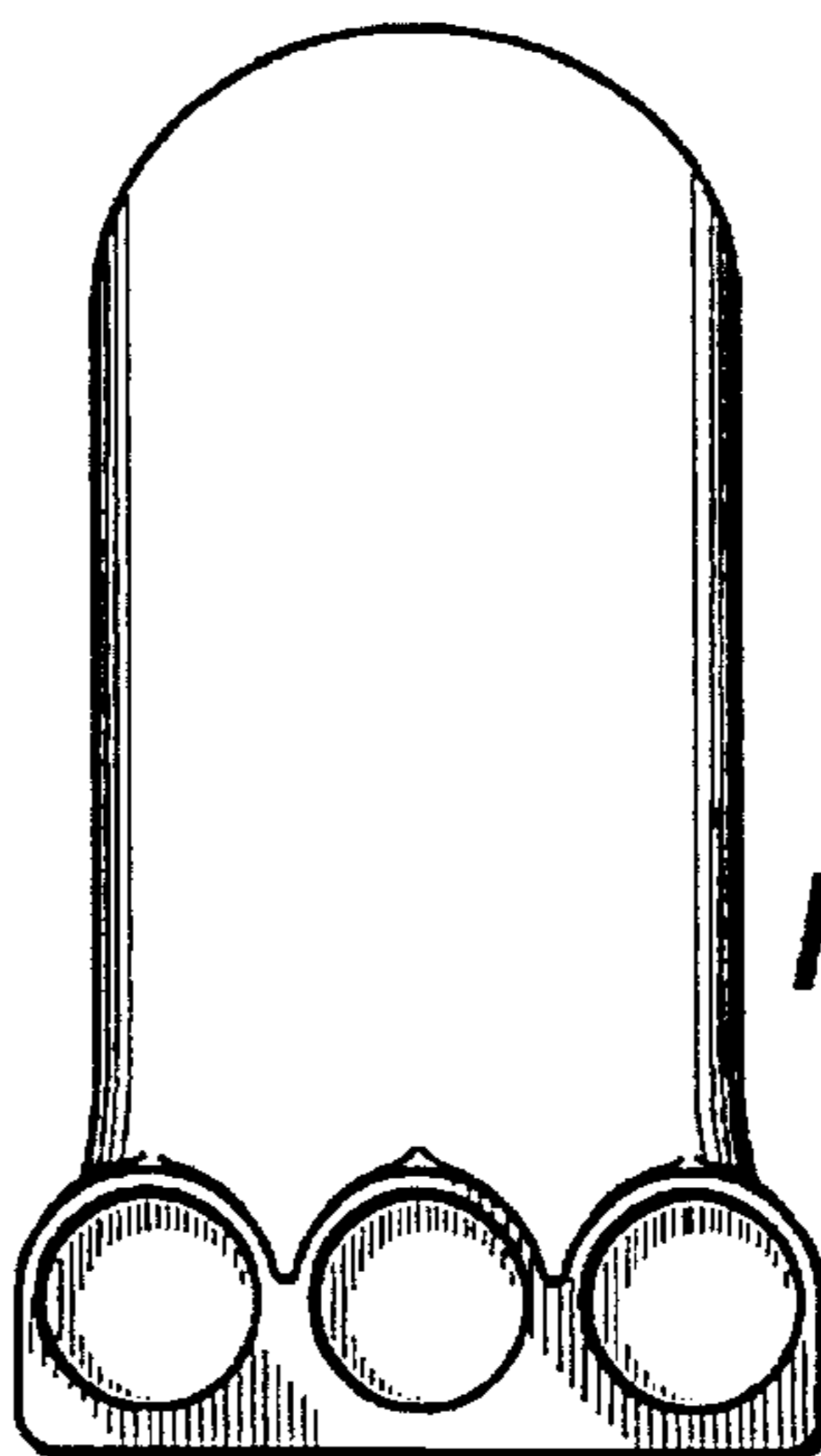

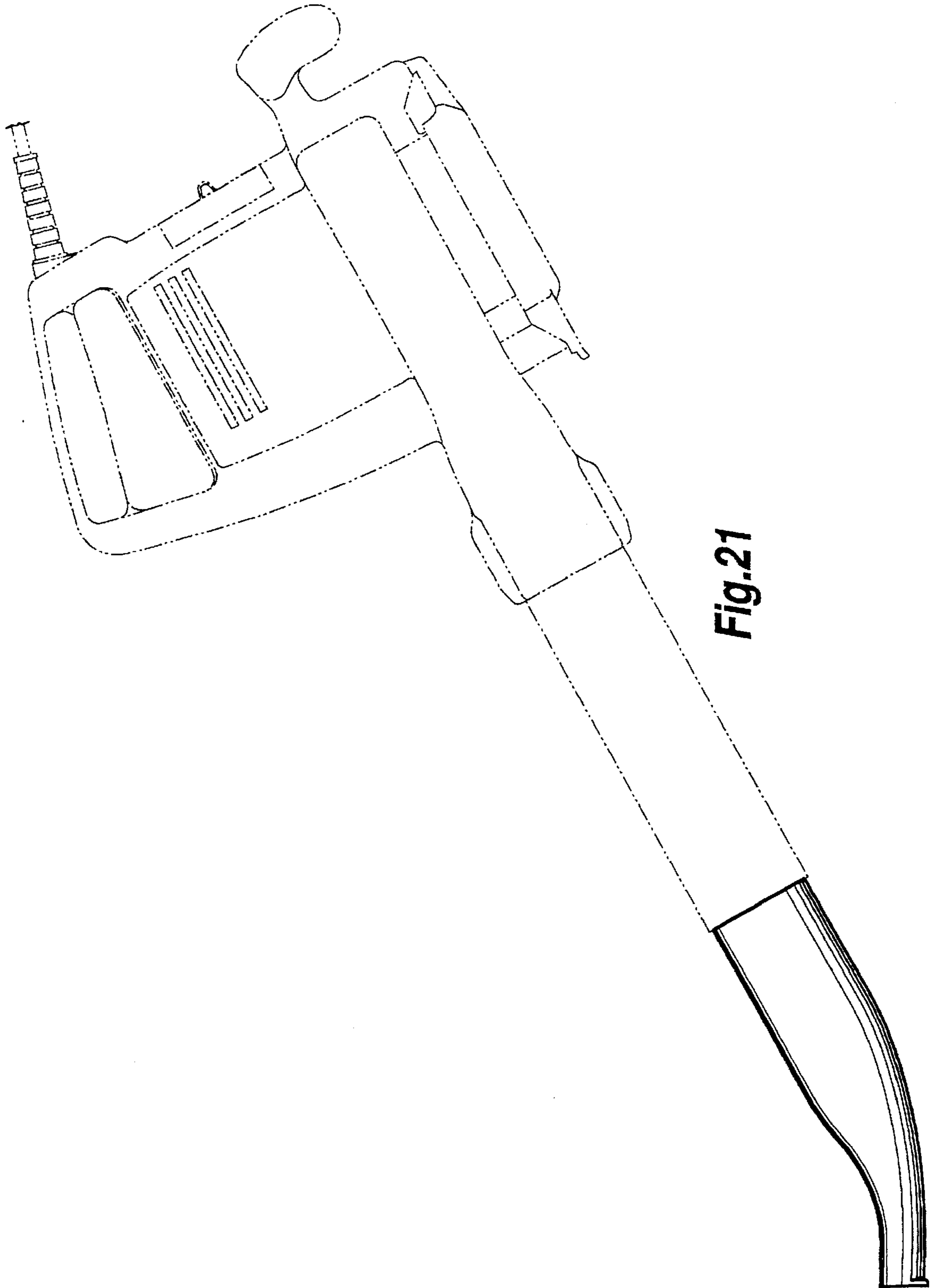
