[57] CLAIM

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a seat showing our new design in the form of a sofa;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view, the left side being a mirror image thereof;

FIG. 5 is a rear perspective view thereof;

FIG. 6 is a front elevational view of a seat showing our new design in the form of a loveseat;

FIG. 7 is front elevational view of a seat showing our new design in the form of a chair;

FIG. 8 is a front perspective view of a seat showing our new design in the form of a sectional sofa; and,

FIG. 9 is a top plan view thereof.

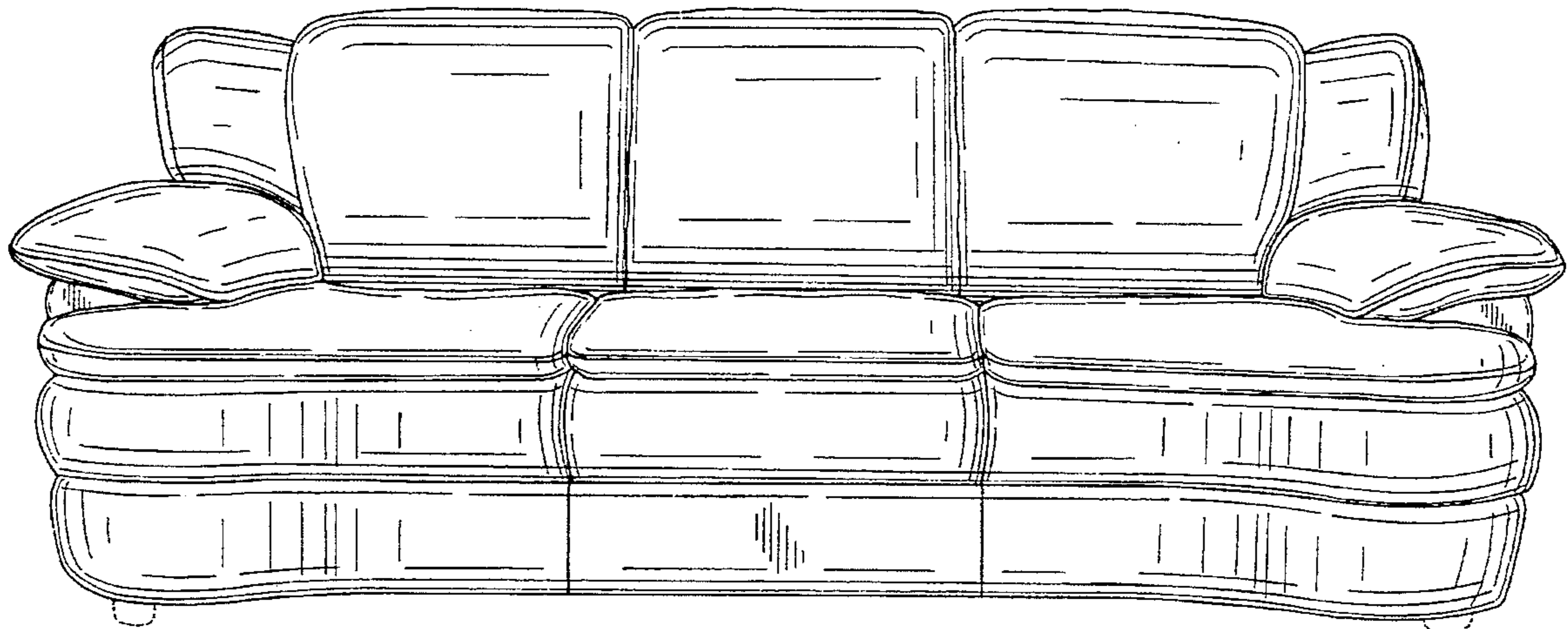
The broken lines shown herein are for illustrative purposes only and forms no part of the claimed design.

The rear views of FIGS. 6, 7, and 8 are like FIG. 5, the difference being substantially a matter of length.

The view of the end frames of FIGS. 6, 7, and 8 are like FIG. 4.

FIG. 1 has been shown on an enlarged scale and FIGS. 8 and 9 have been shown on a smaller scale with respect to FIGS. 2 through 7.

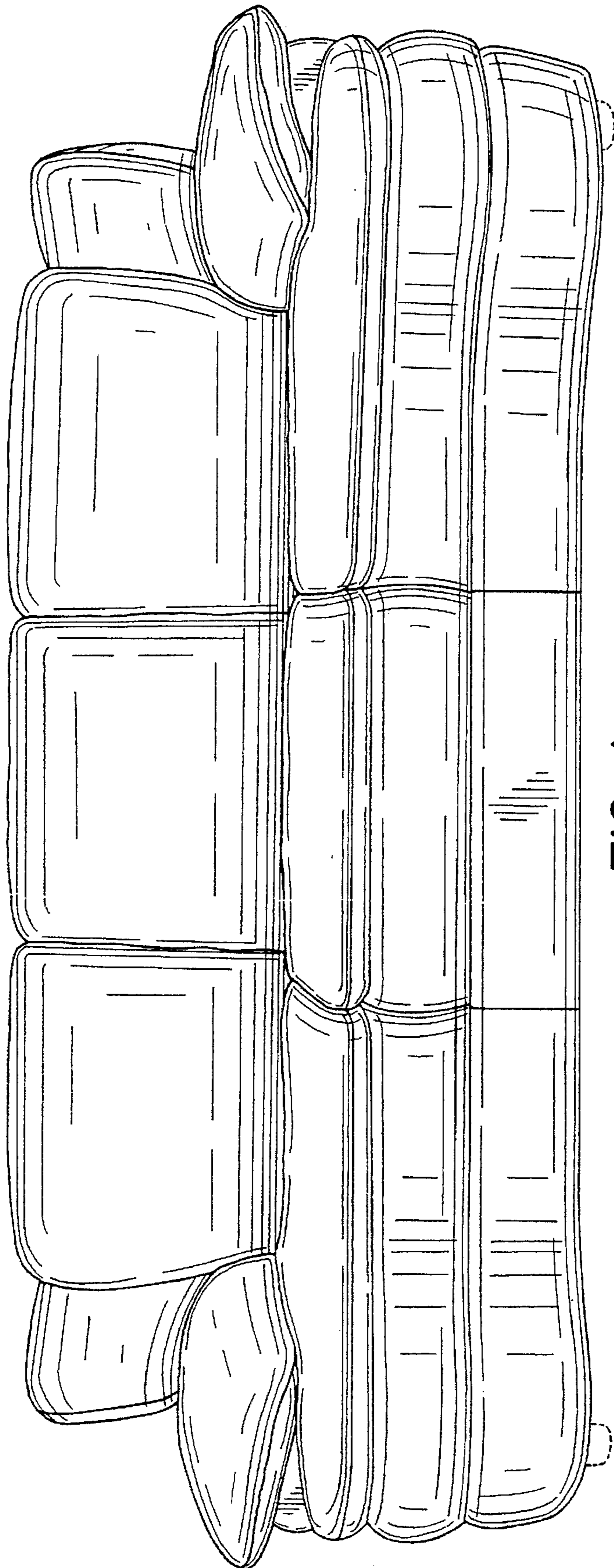

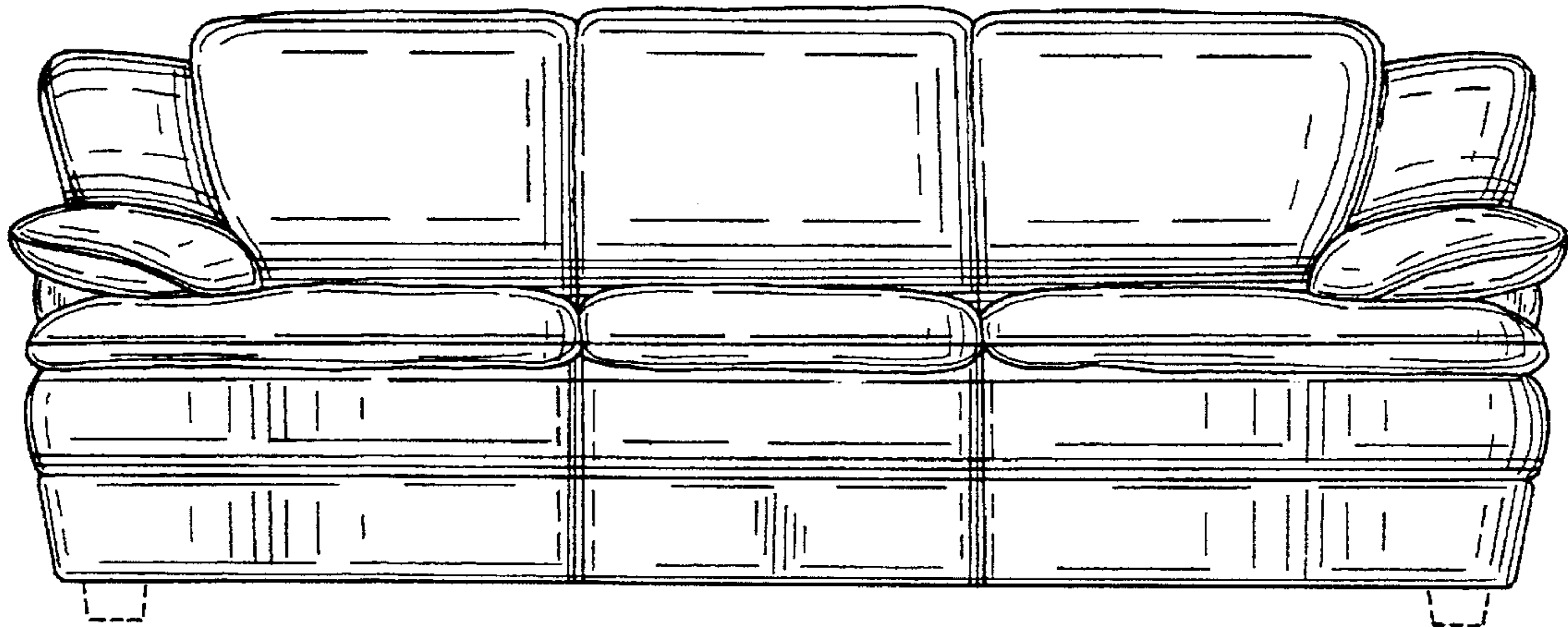

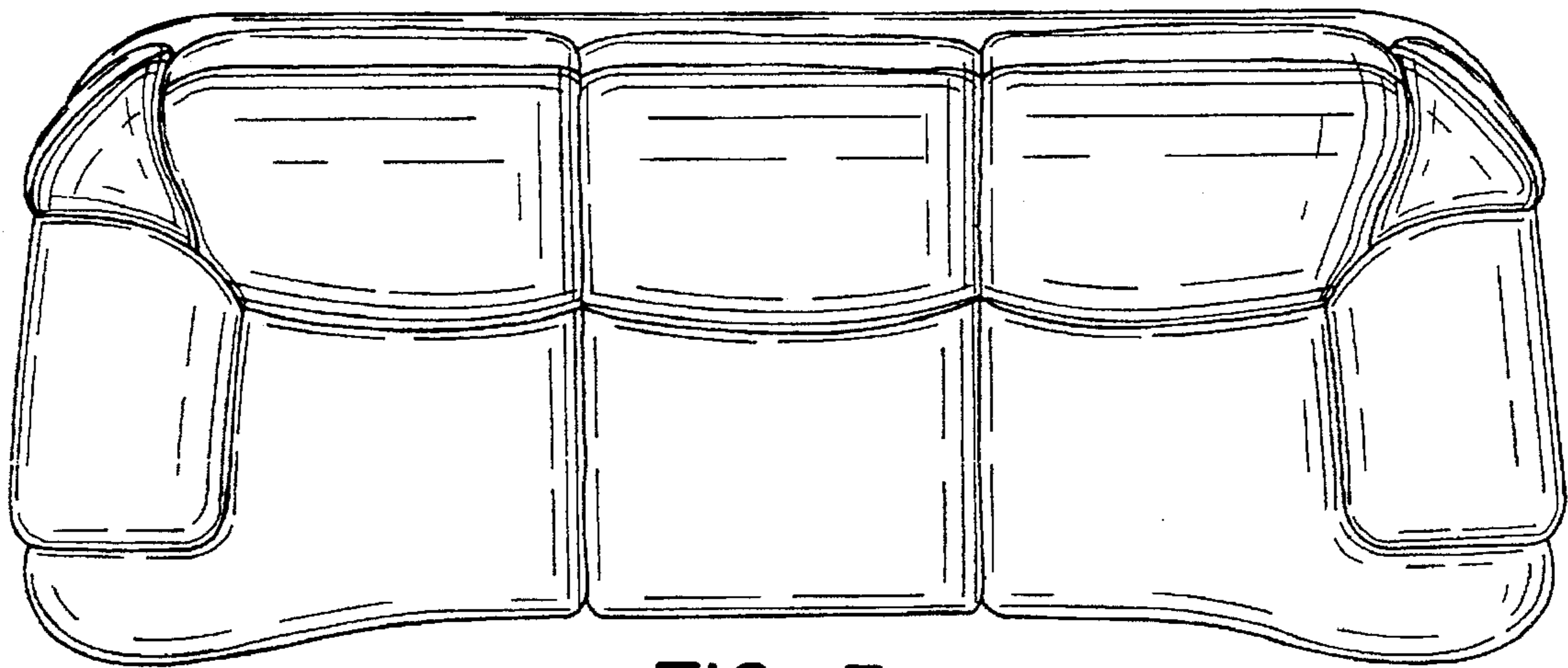

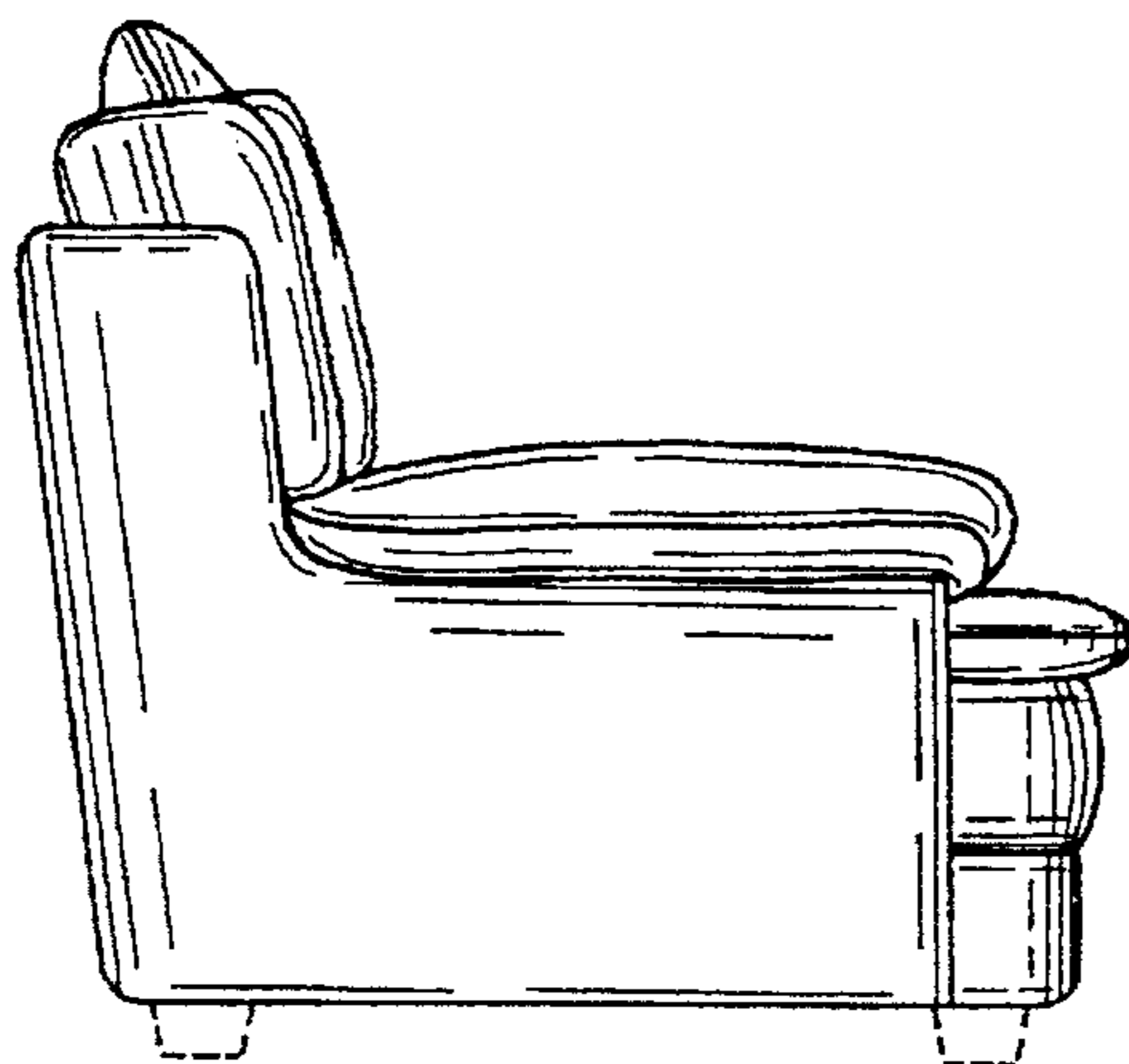

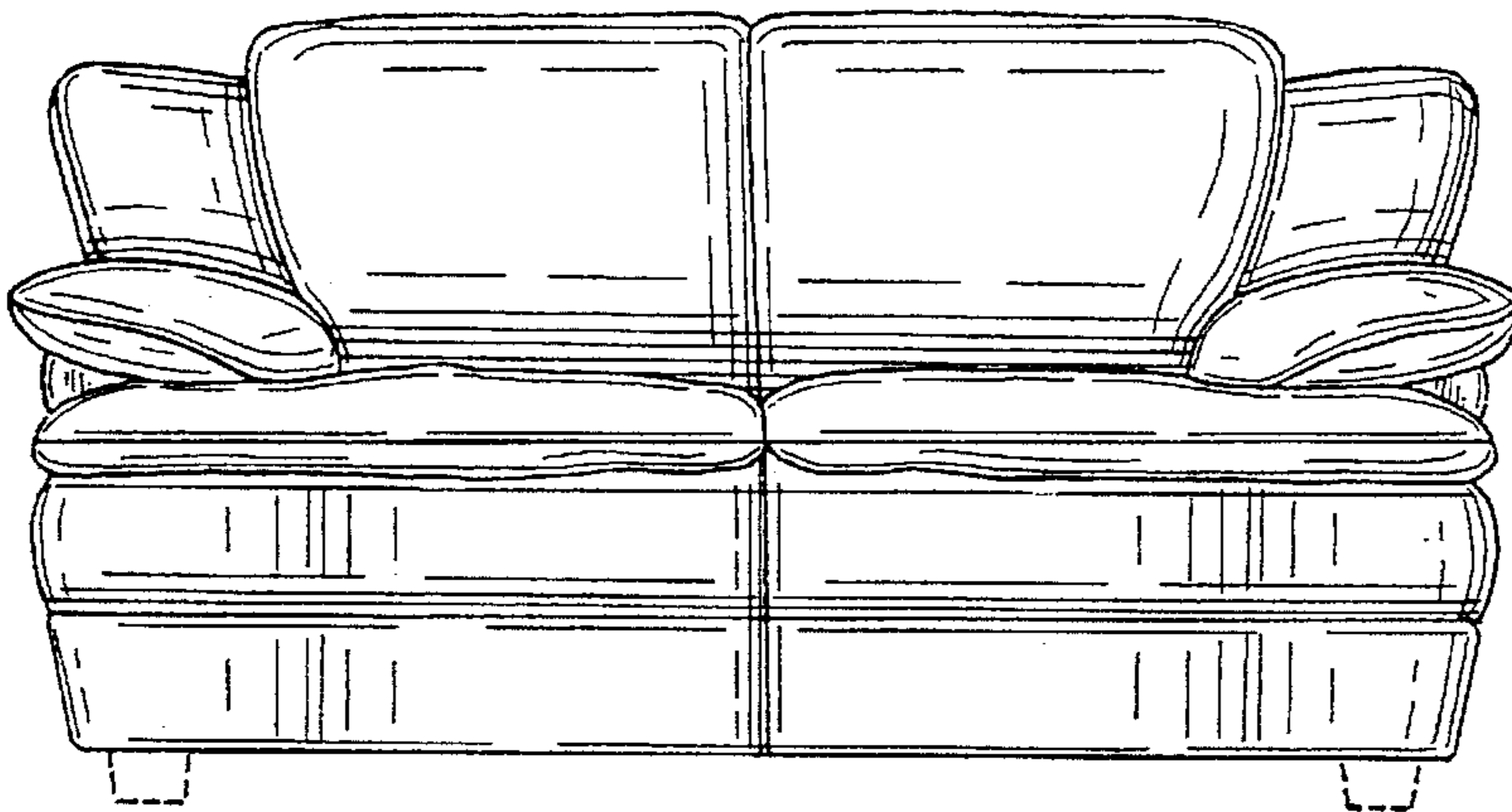
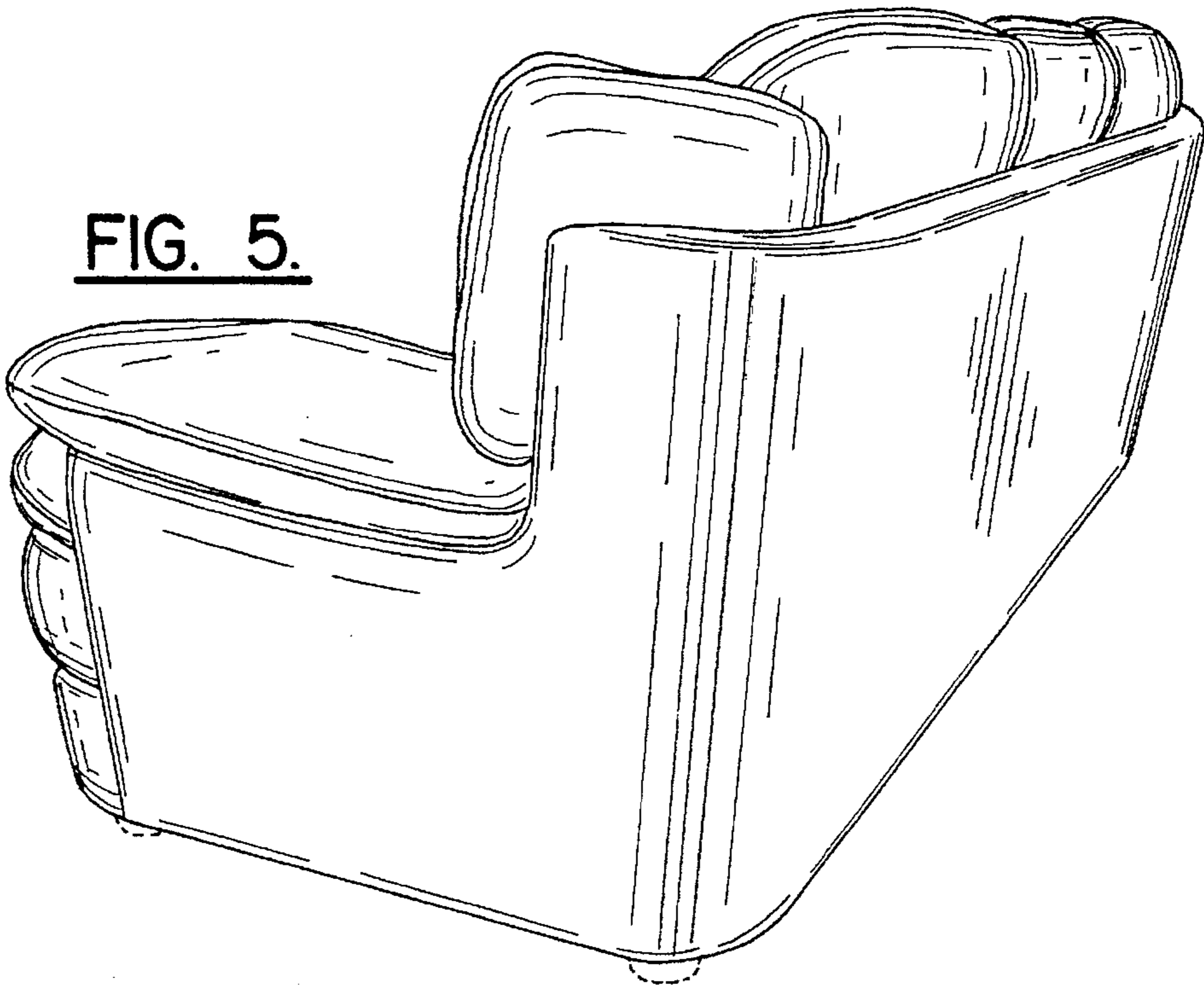
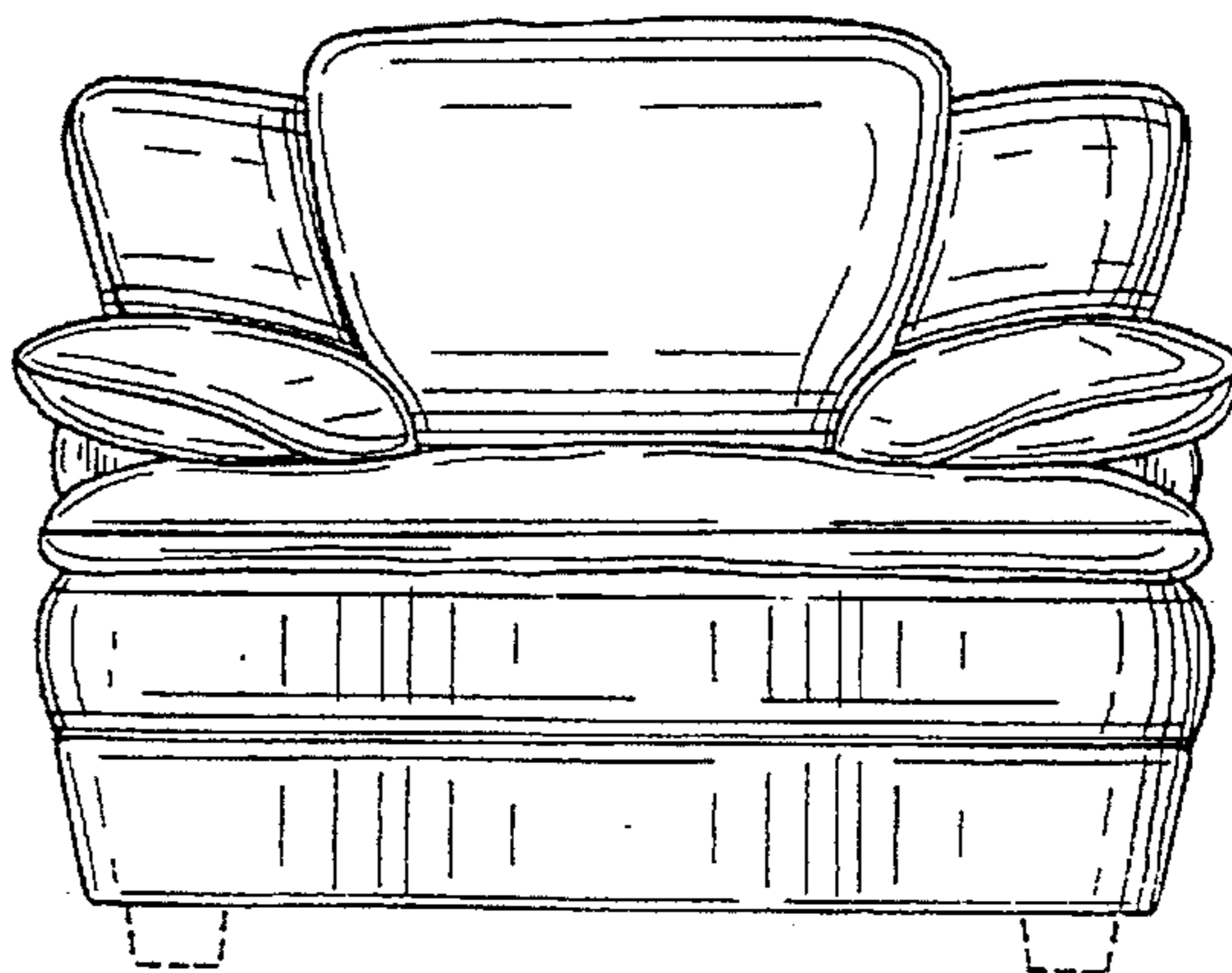

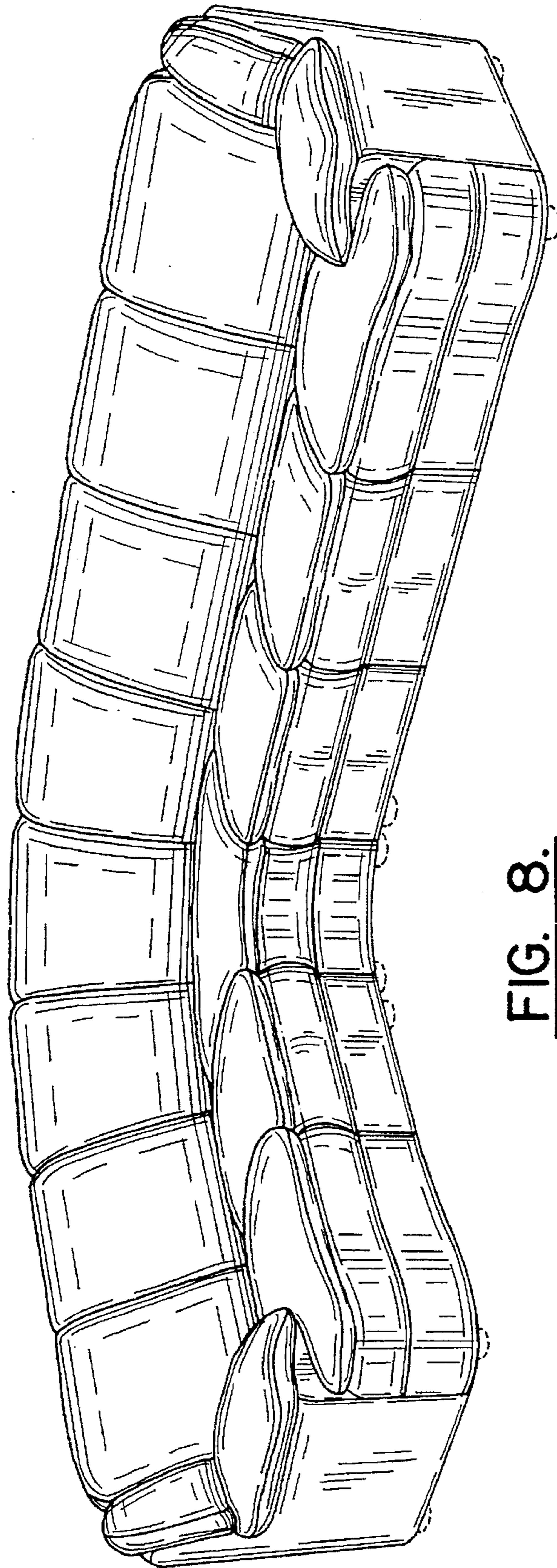

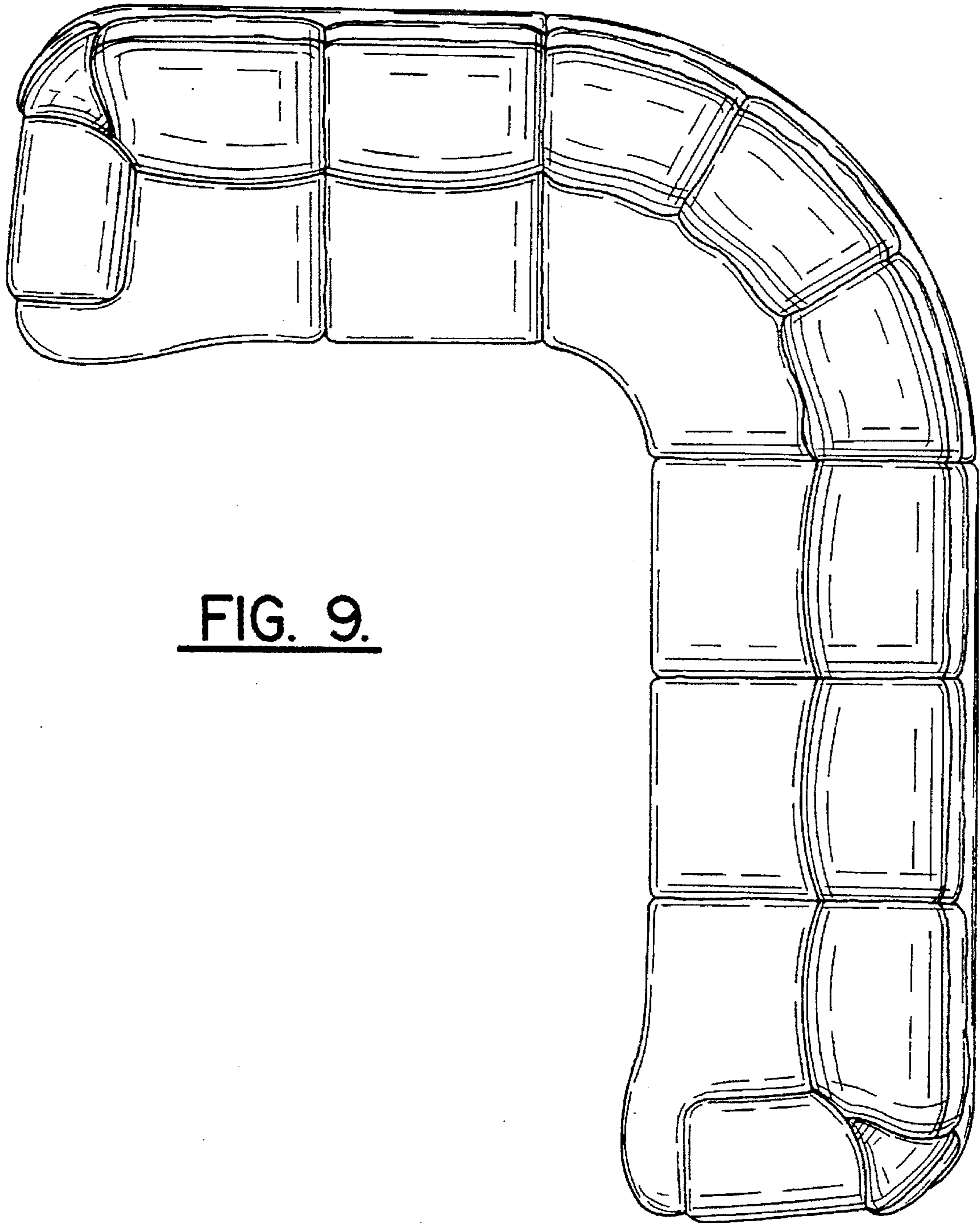
