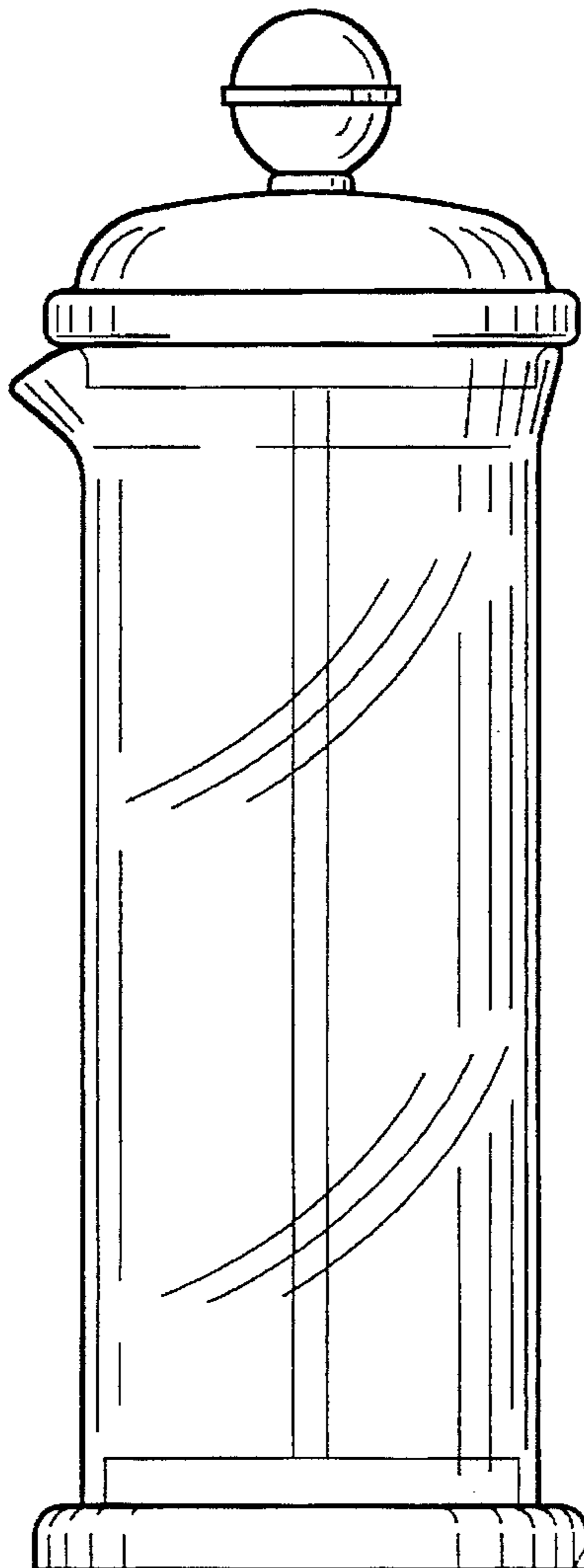
[57] **CLAIM**

The ornamental design for a container for foaming or frothing milk or milk products, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view of the container showing my new design;
- FIG. 2 is a side elevational view thereof, the other side being a mirror image;
- FIG. 3 is a top plan view thereof;
- FIG. 4 is a front elevational view thereof;
- FIG. 5 is a rear elevational view thereof; and,
- FIG. 6 is a bottom plan view thereof.

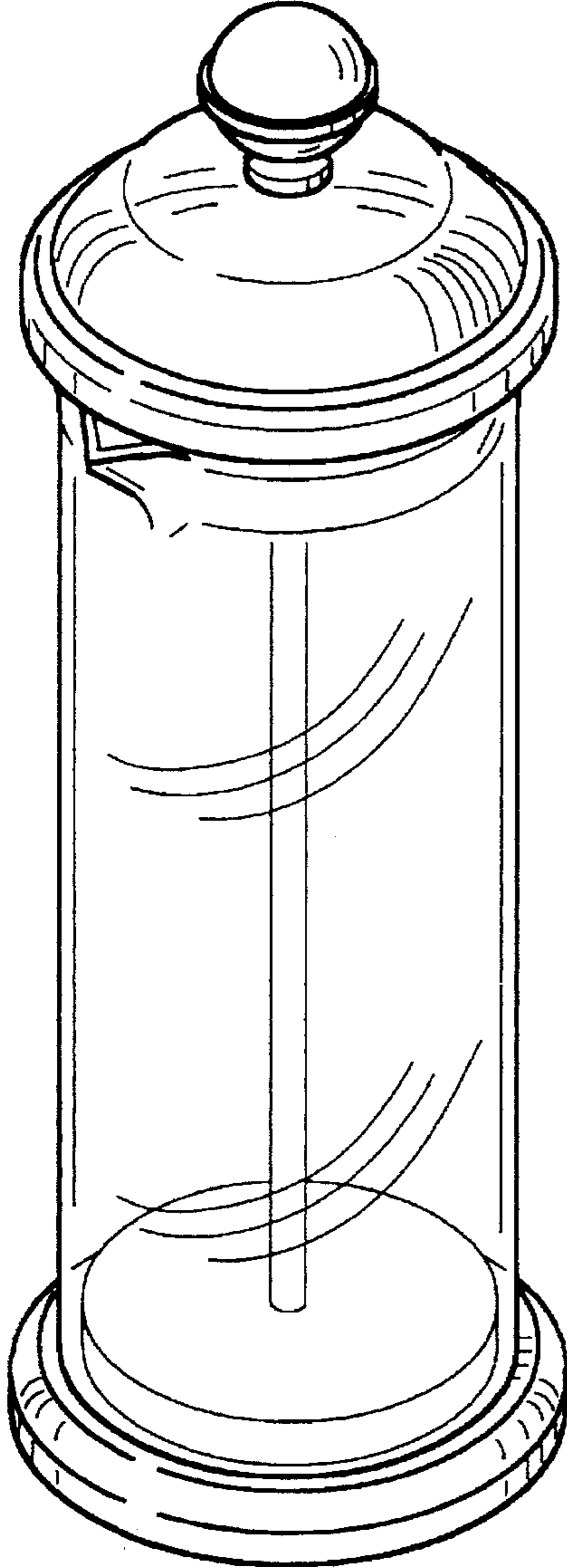

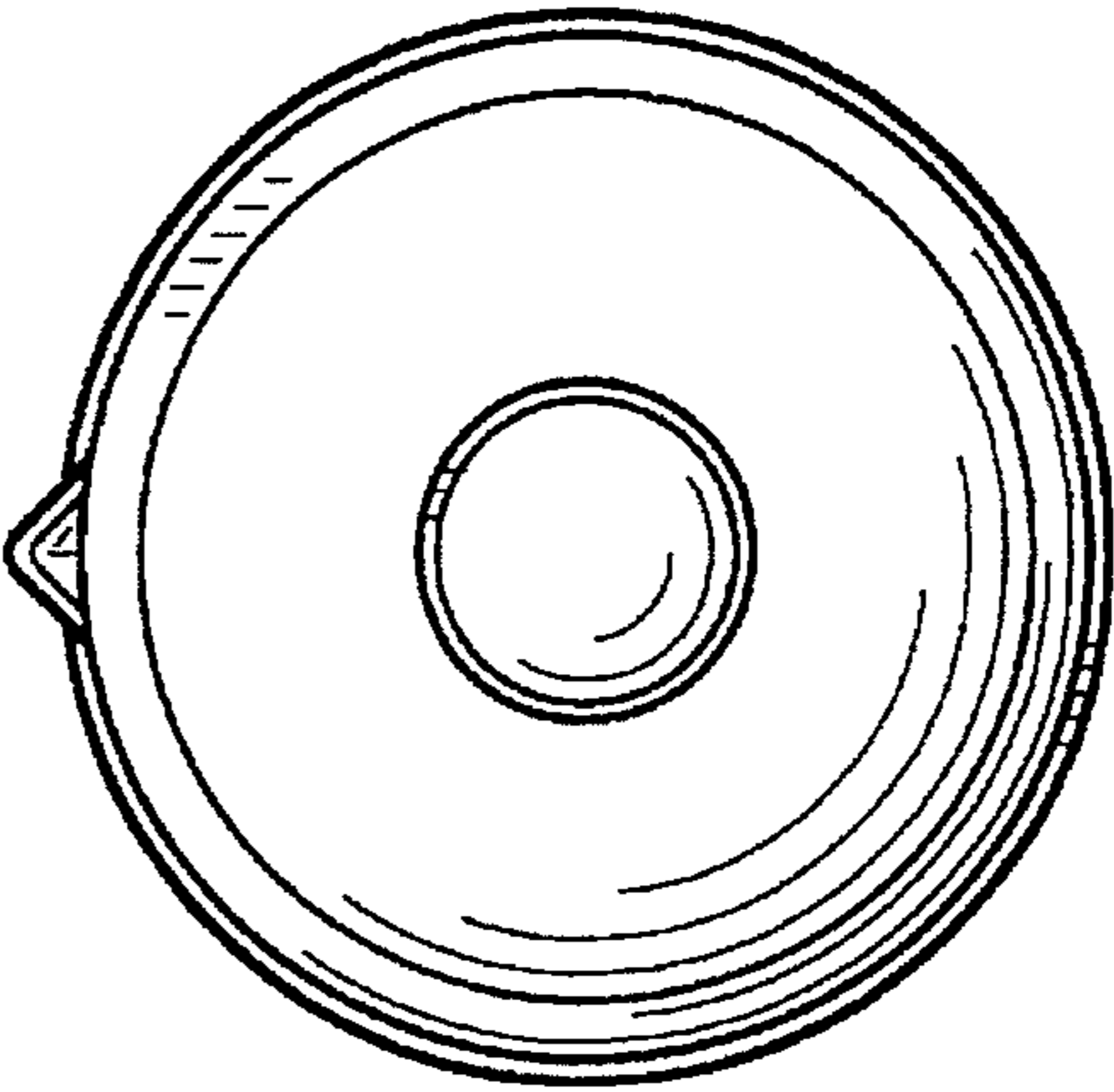

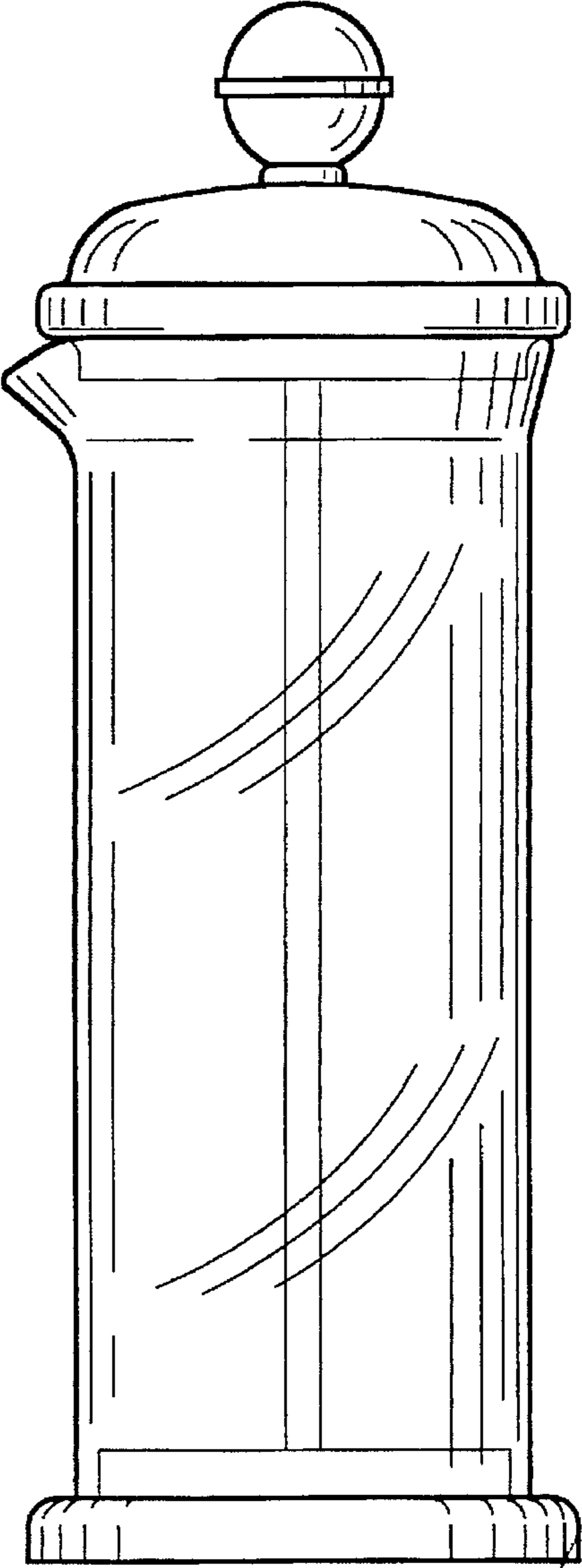

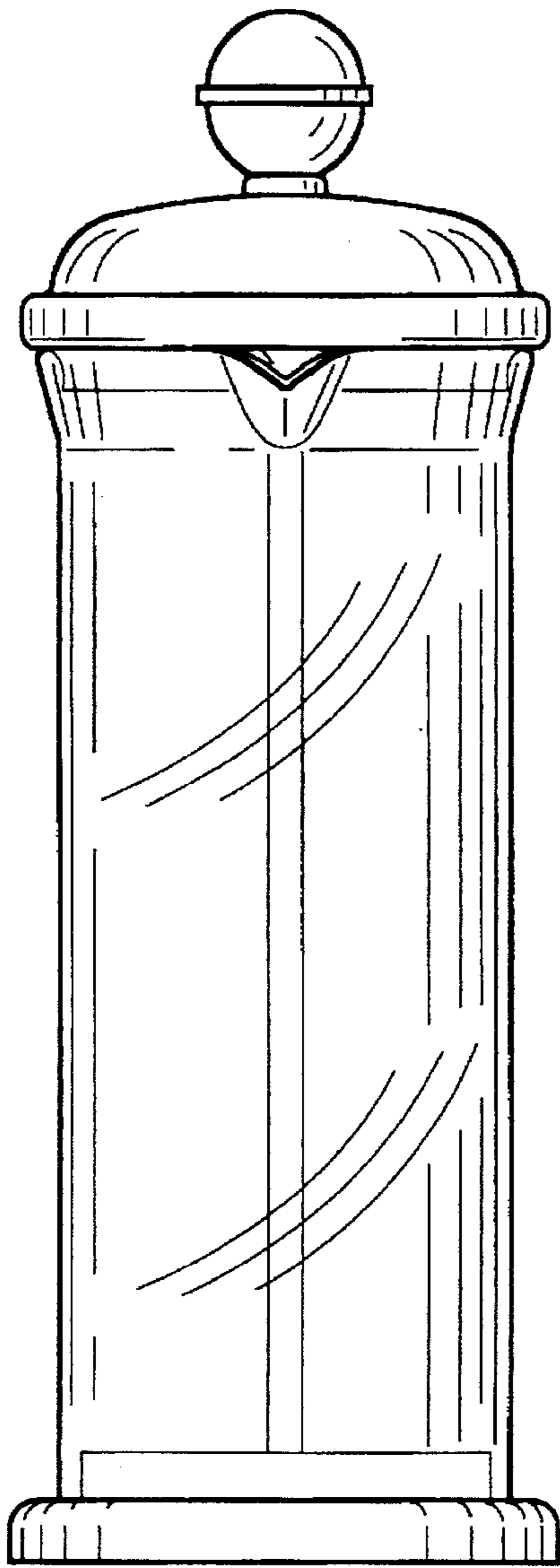

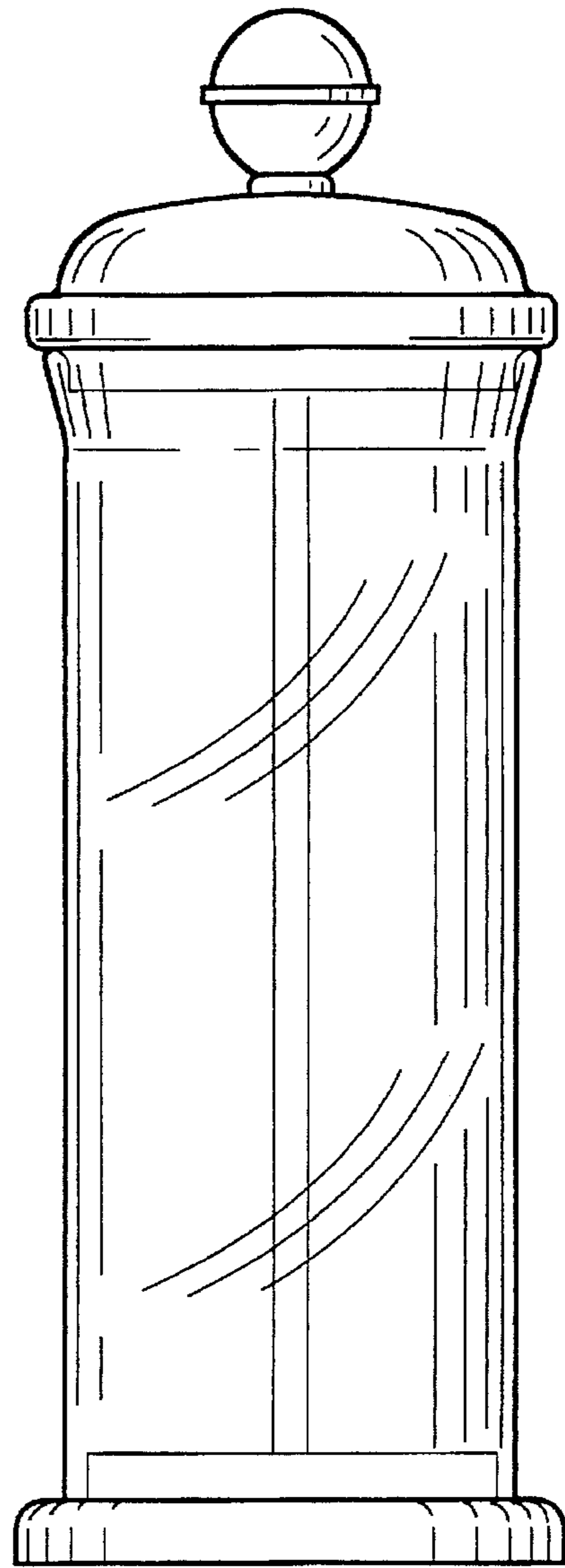

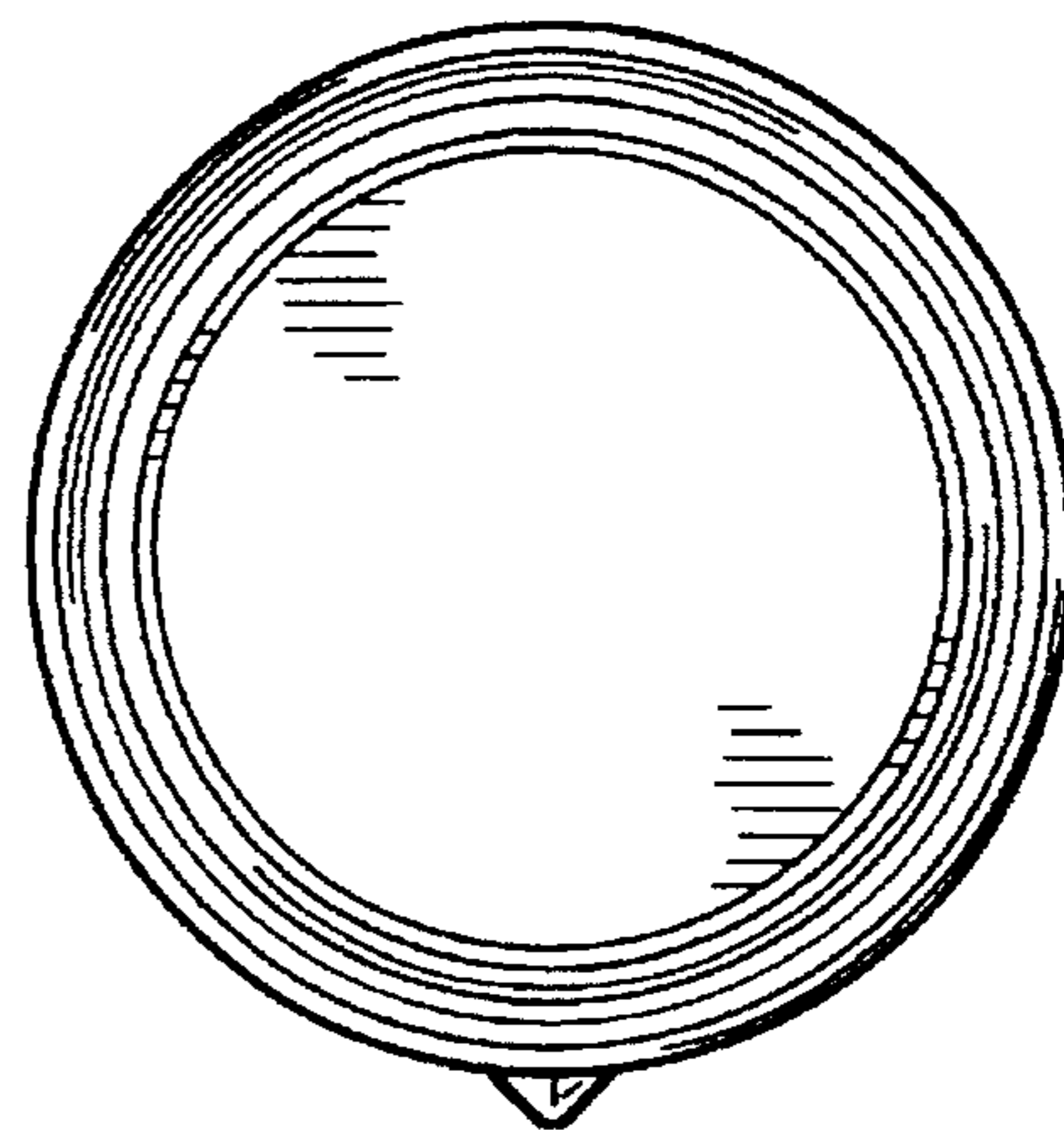
