The ornamental design for a saw blade, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view on an enlarged scale of a saw blade made in accordance with the present invention;

FIG. 2 is a front view of the saw blade of FIG. 1;

FIG. 3 is a left side view of the saw blade of FIG. 2;

FIG. 4 is a top side view of the saw blade of FIG. 2;

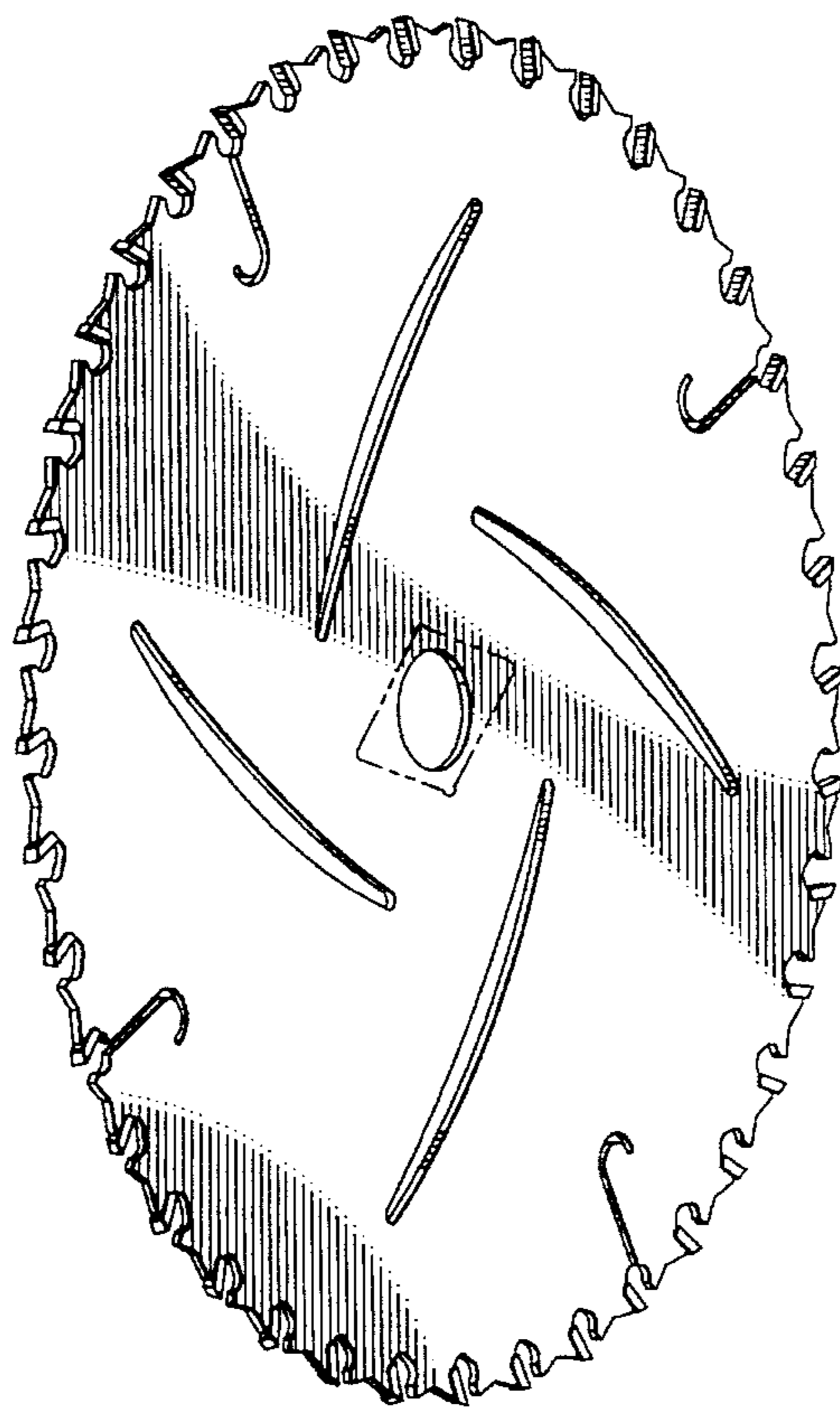
FIG. 5 is a right side view of the saw blade of FIG. 2;

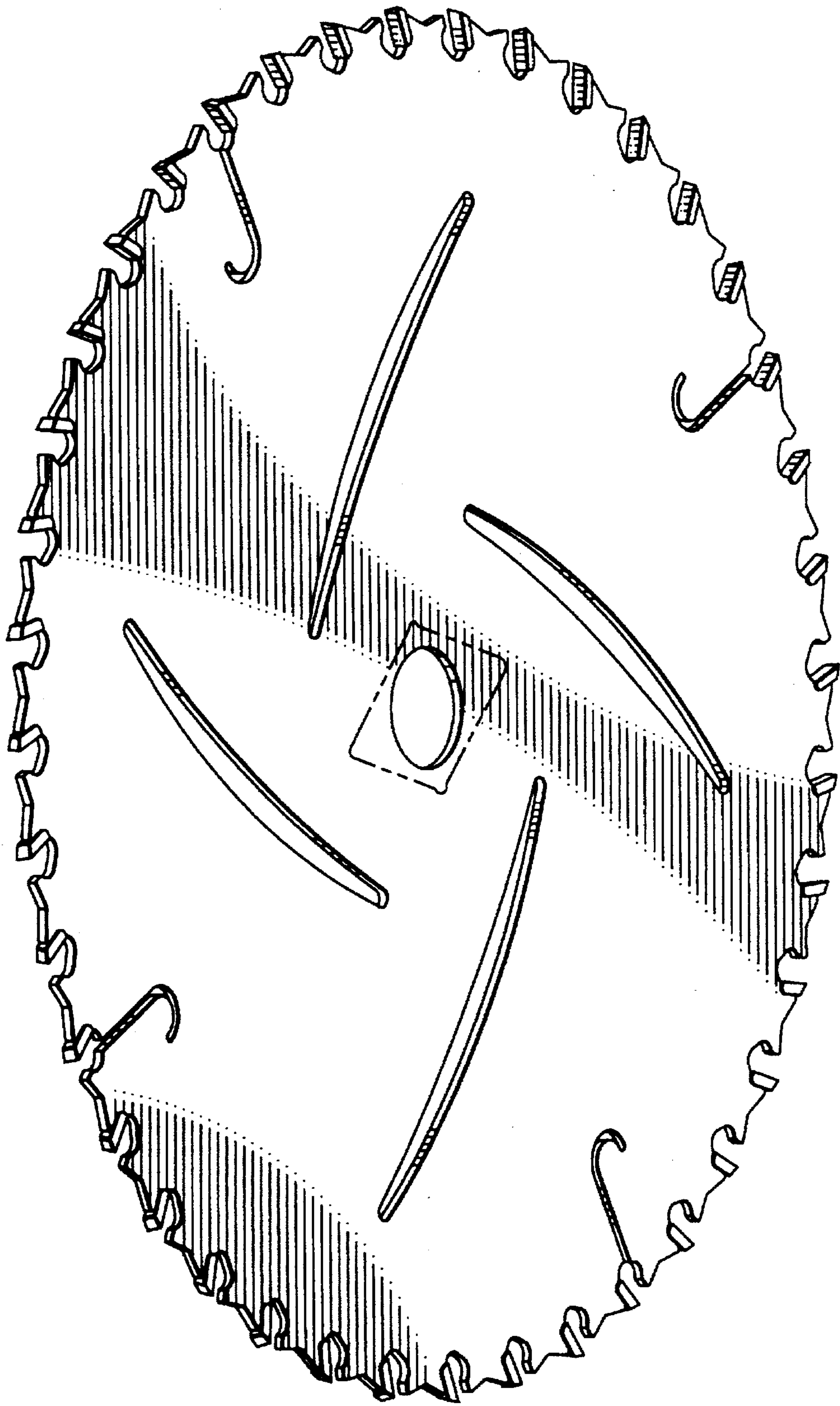

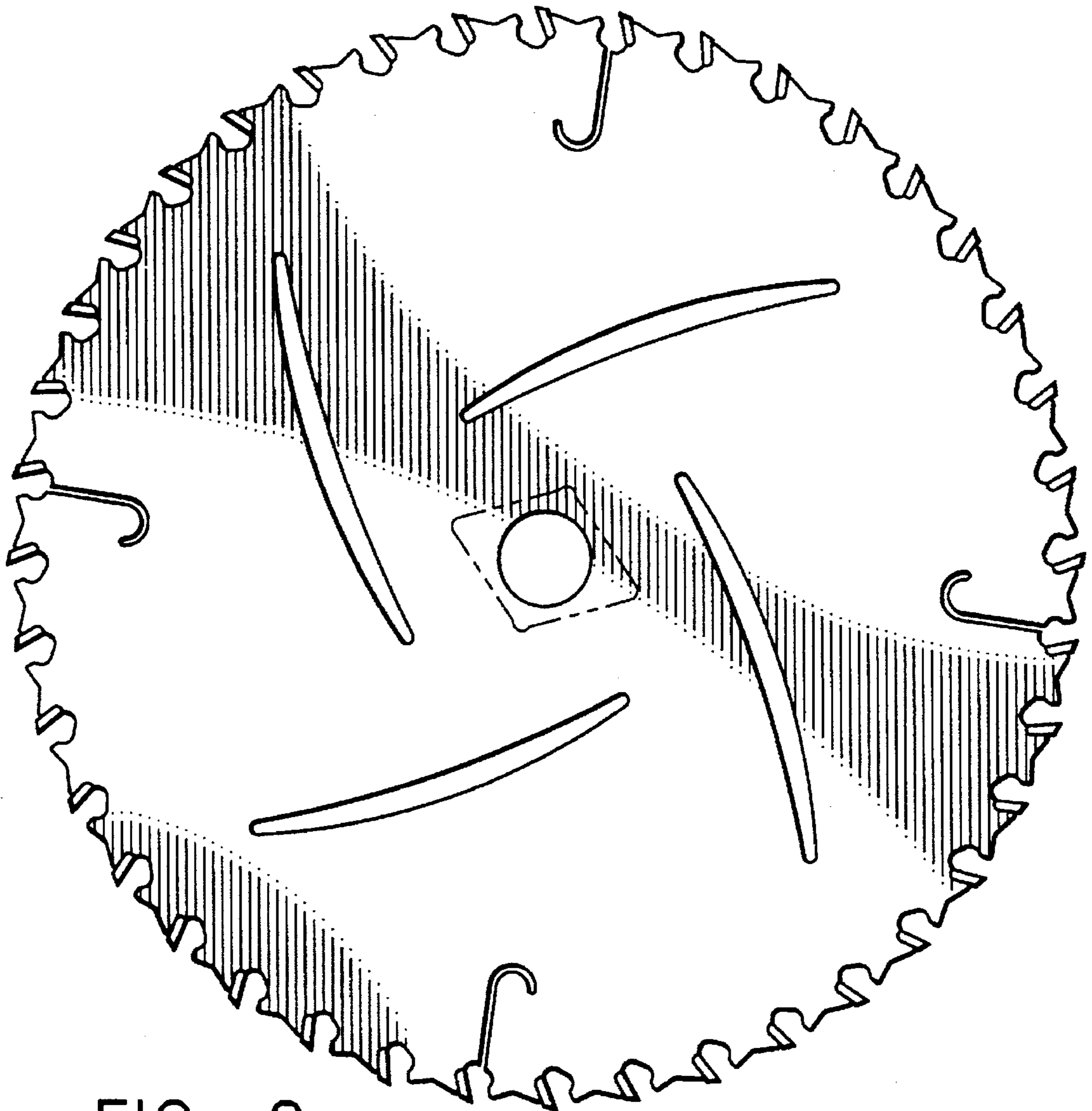

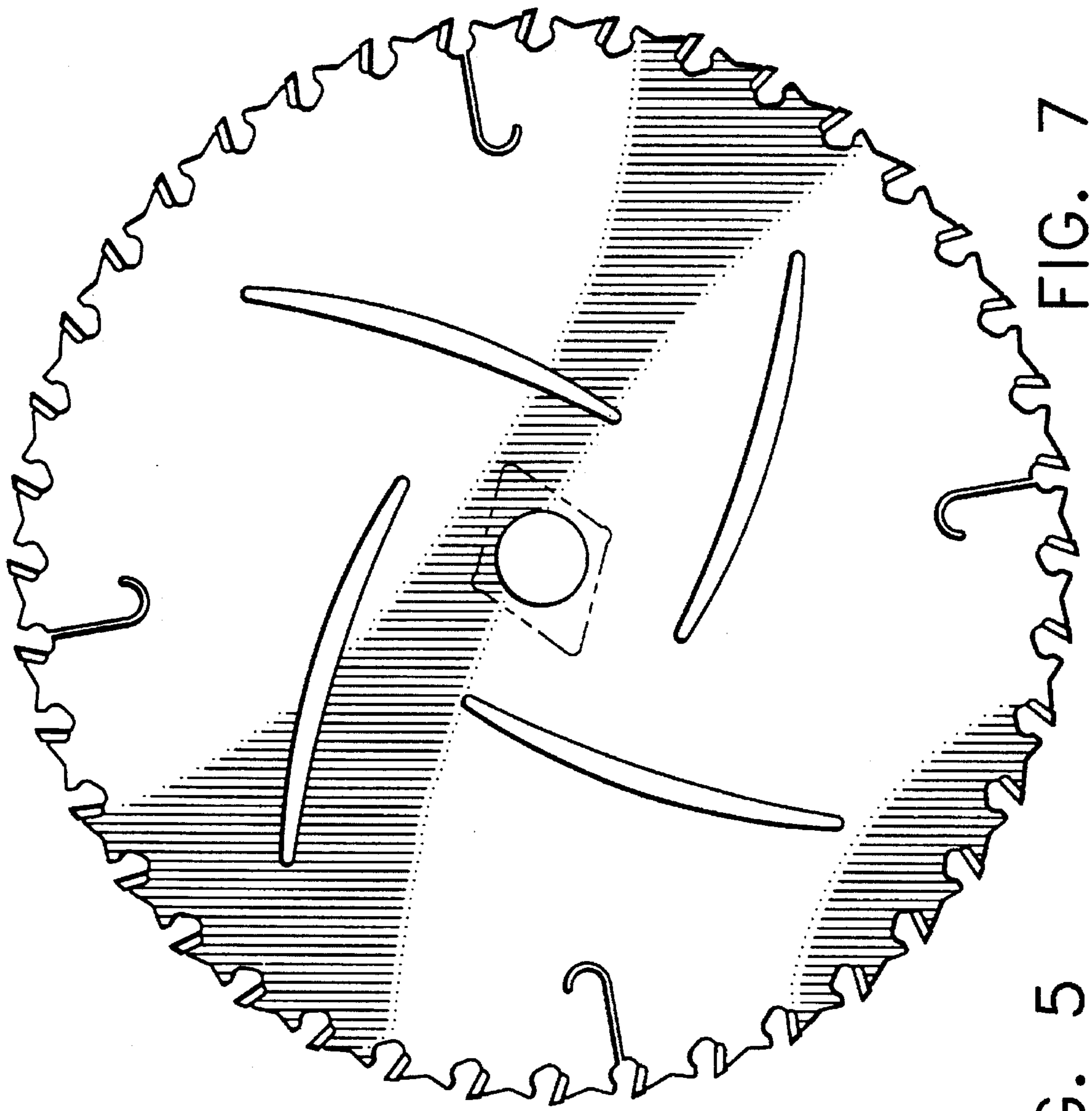

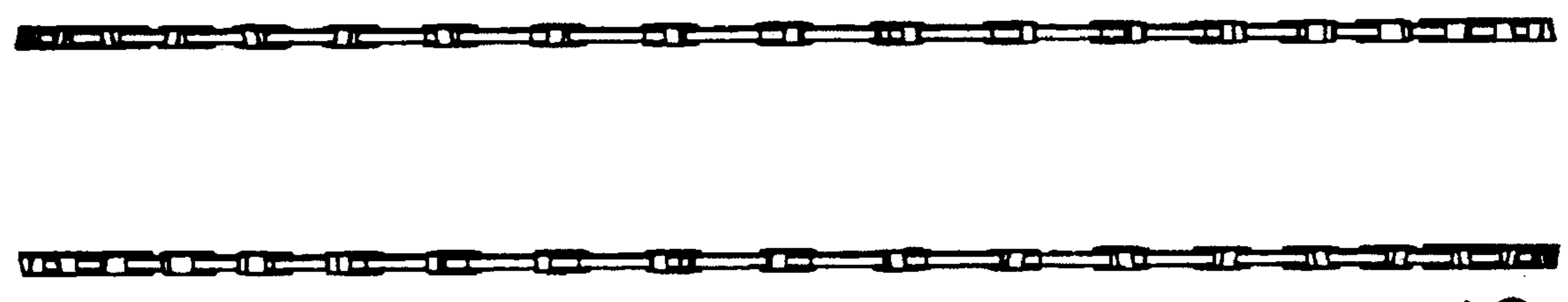
