[57] **CLAIM**

The ornamental design for an interior surface-mountable assembly of a push-button lock, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an interior surface-mountable assembly of a push-button lock embodying our design, with the view showing principally front, left and bottom exterior portions thereof;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

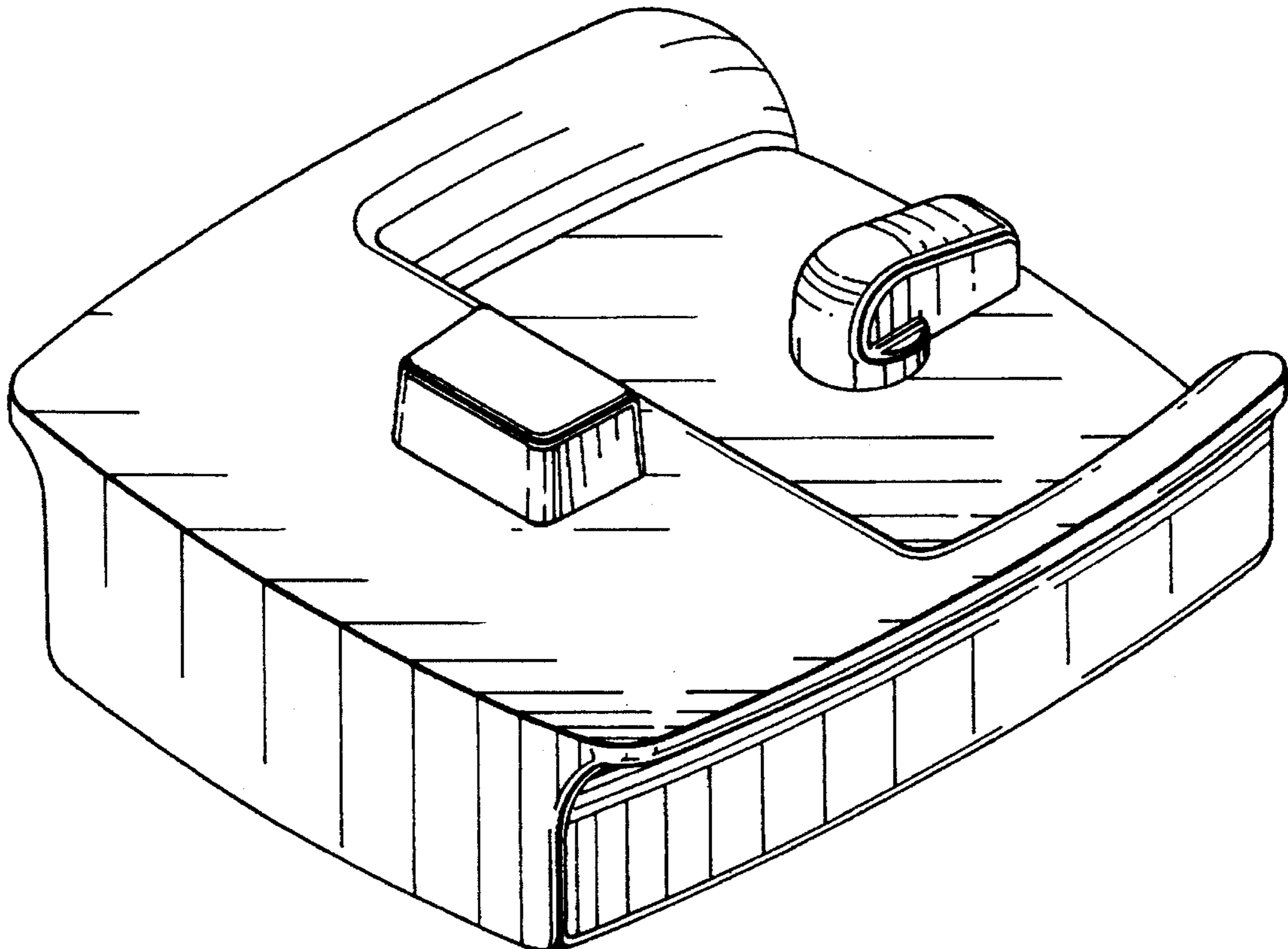
FIG. 4 is a right side elevational view thereof;

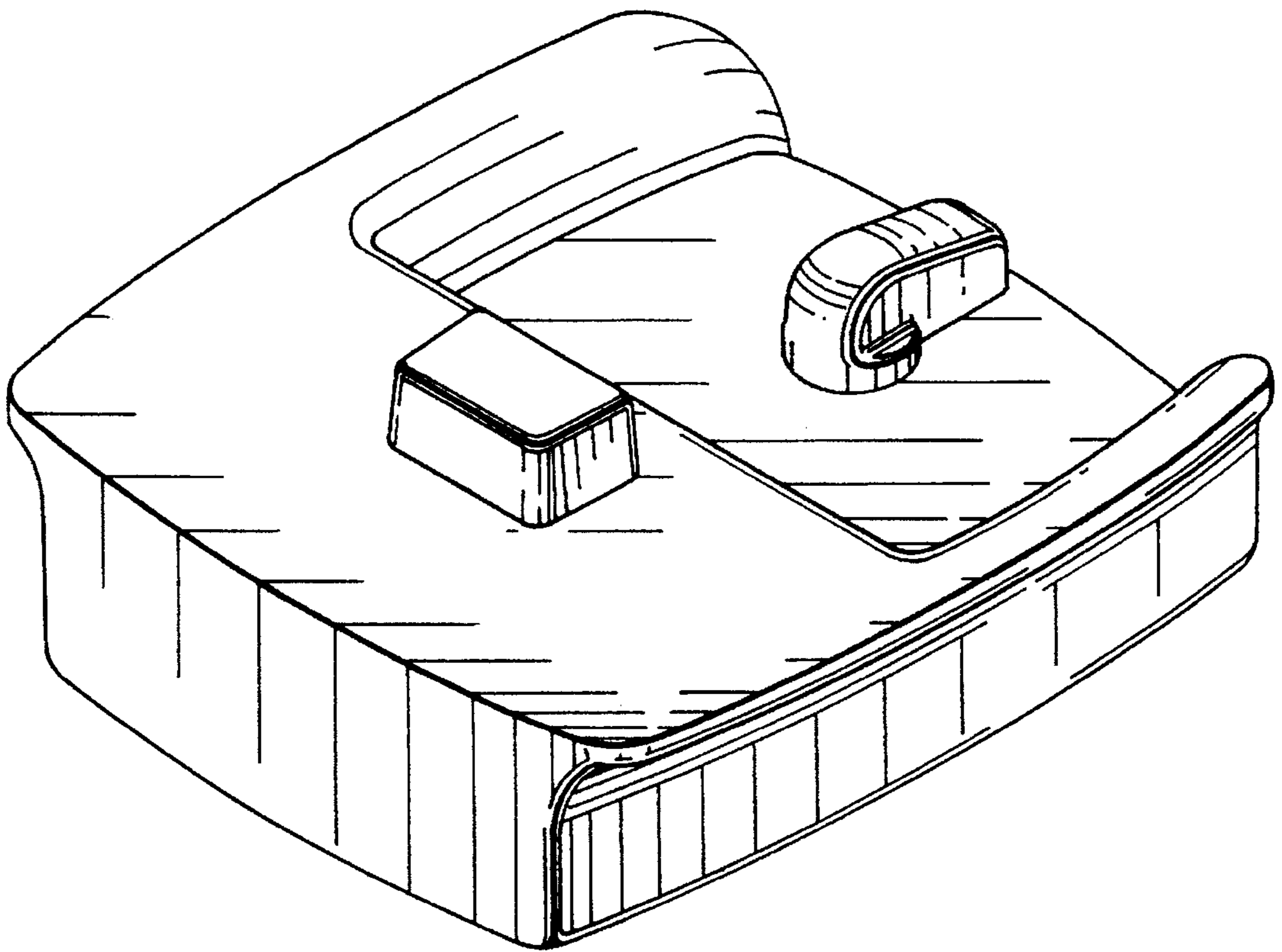

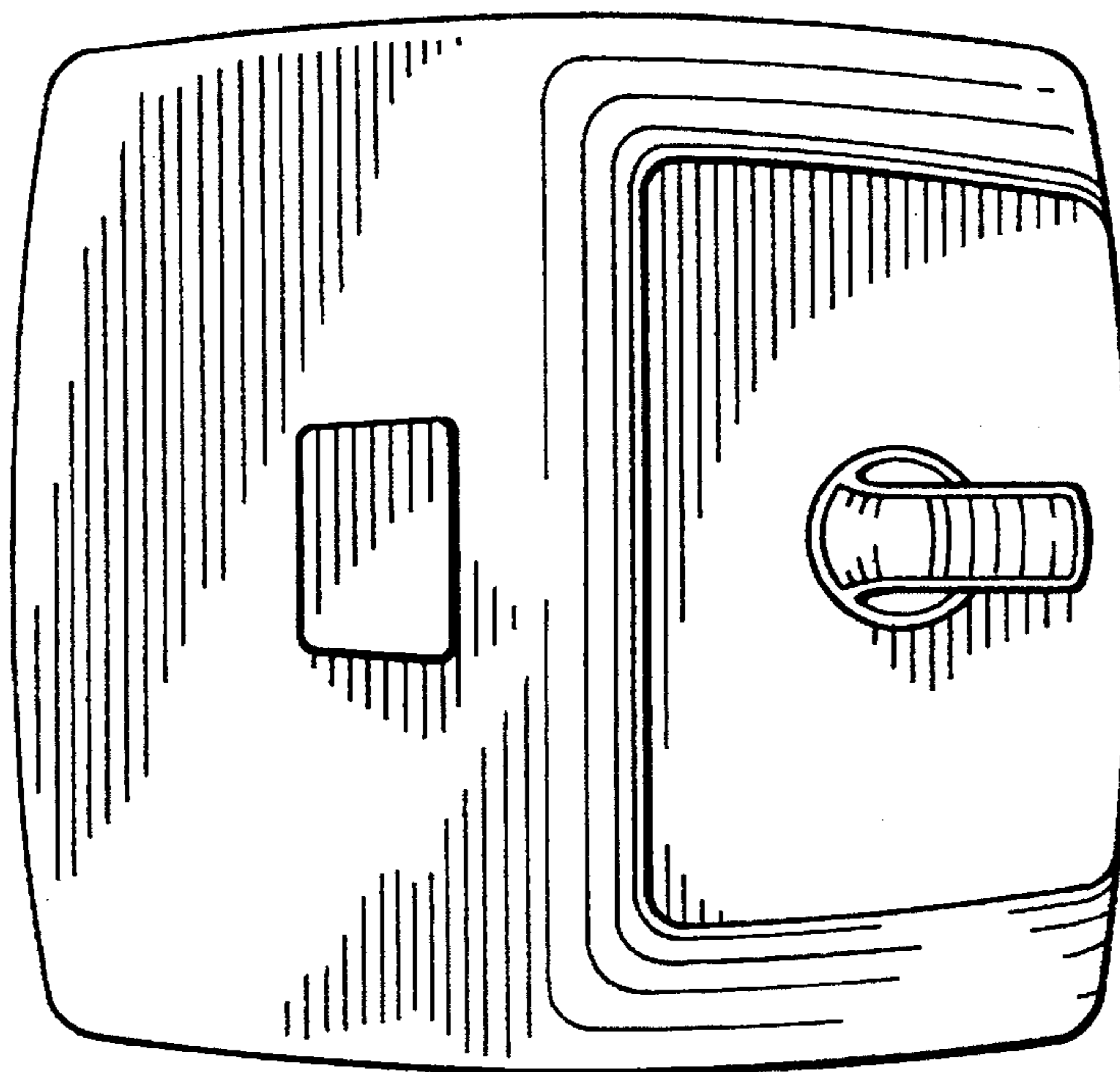

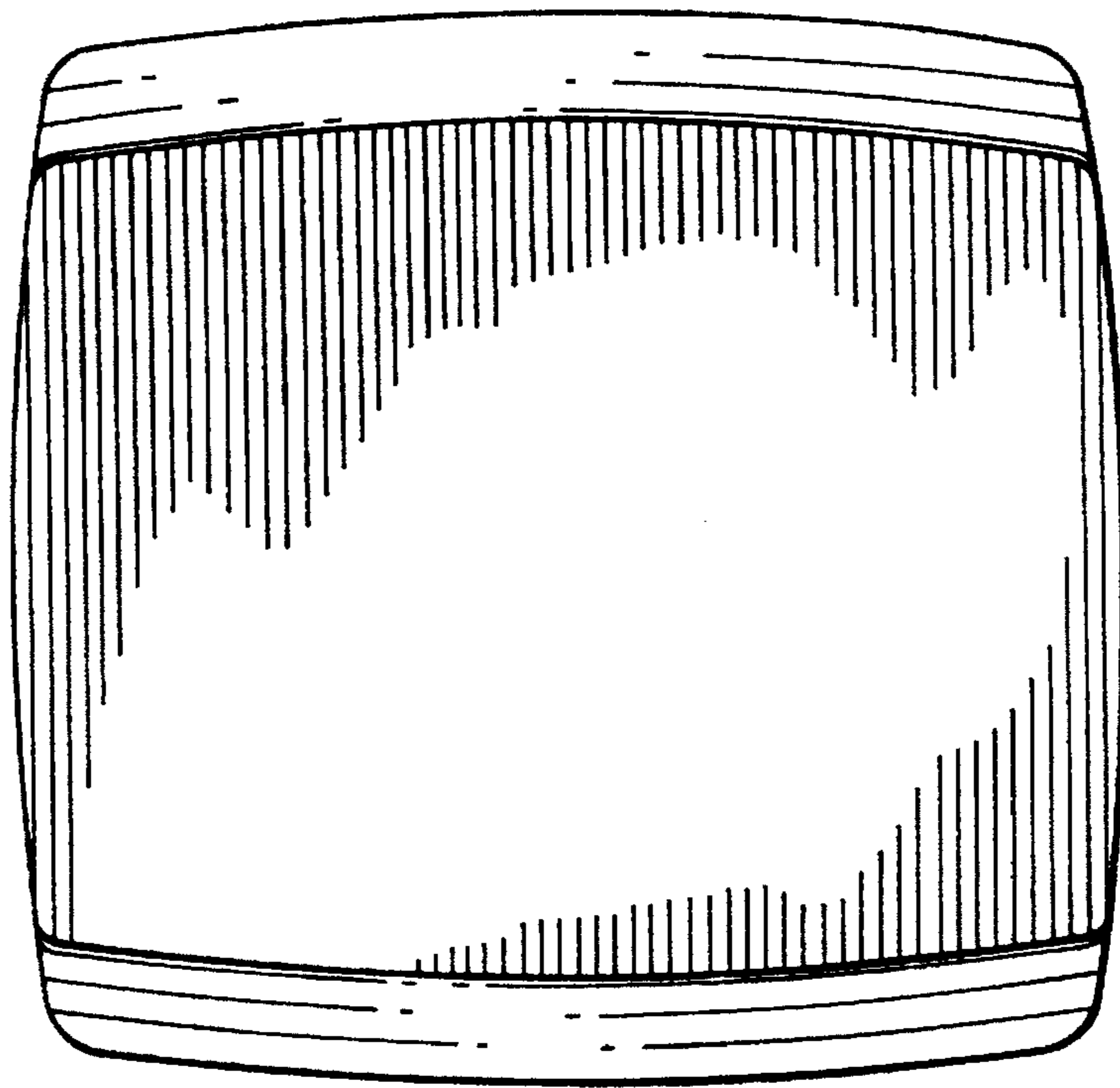

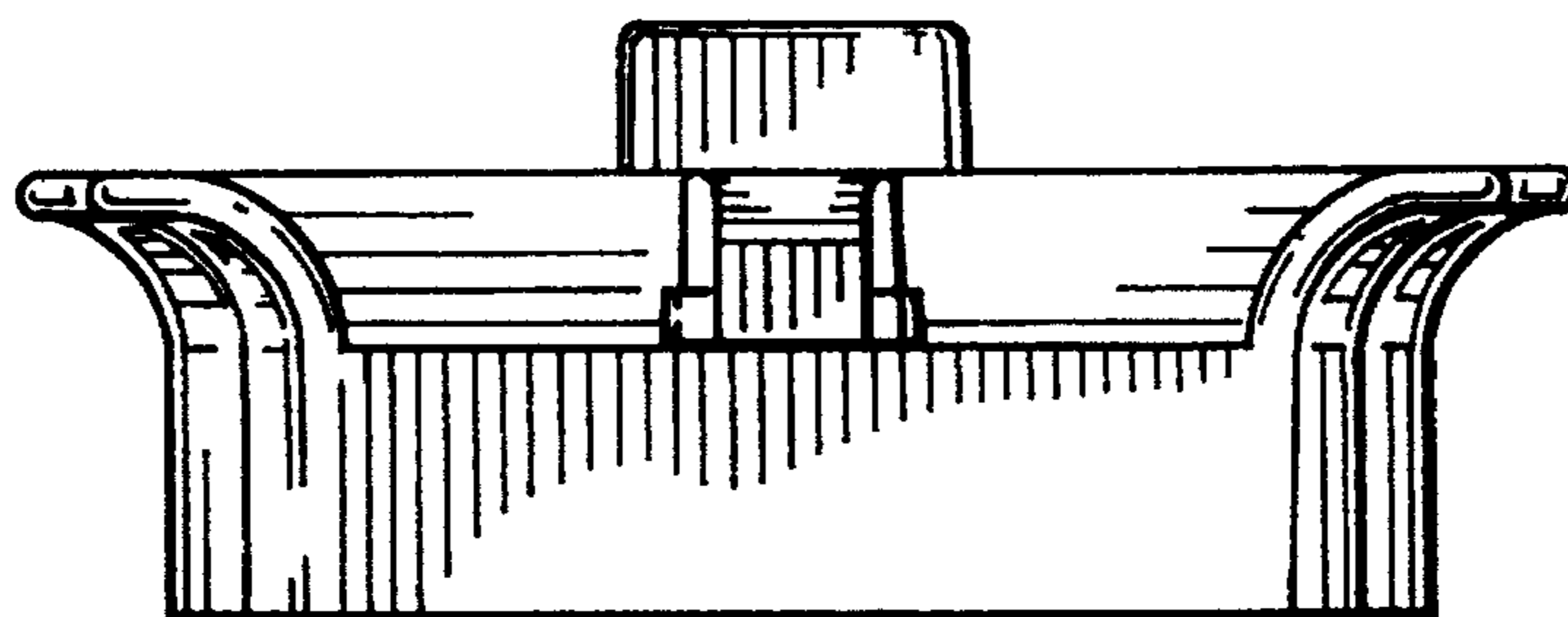

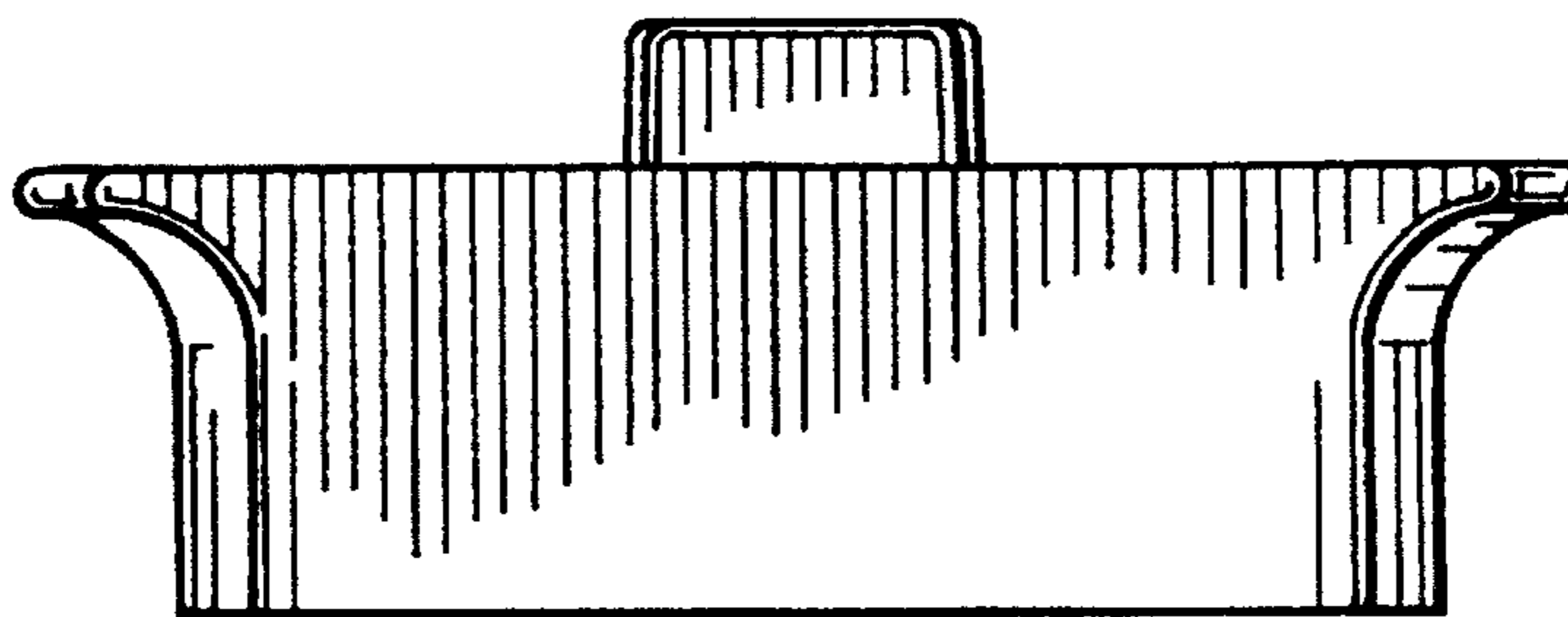

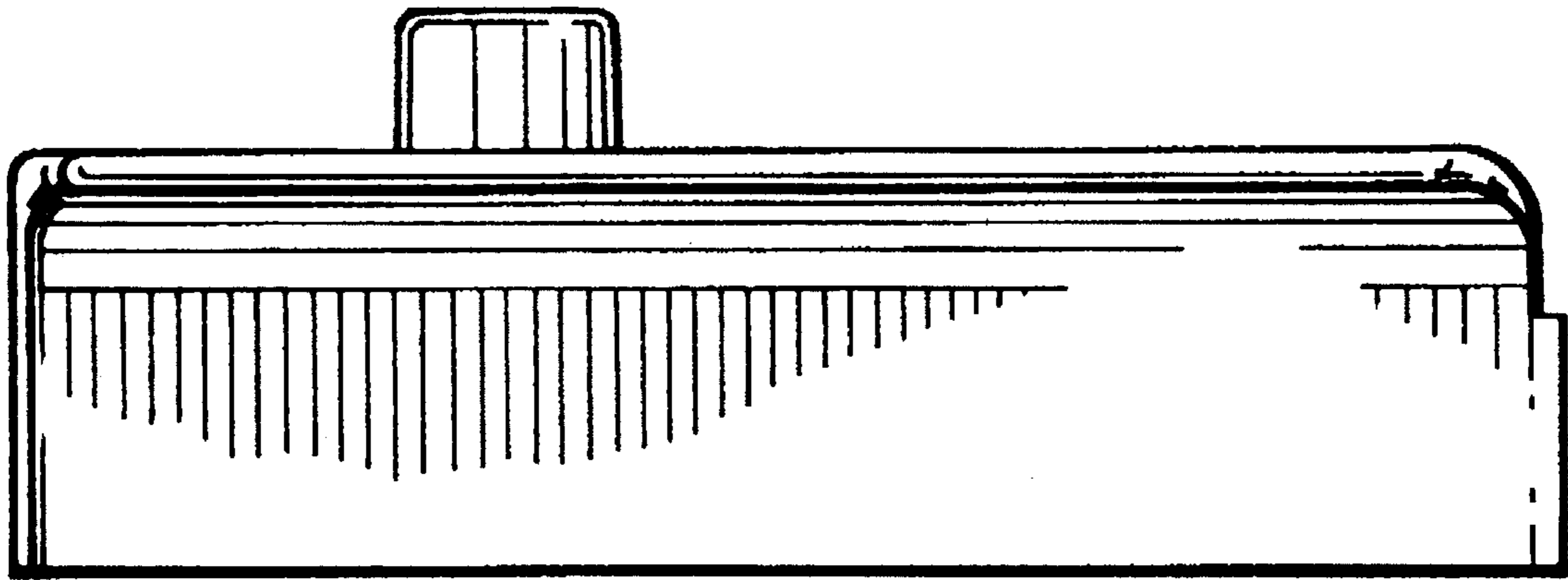

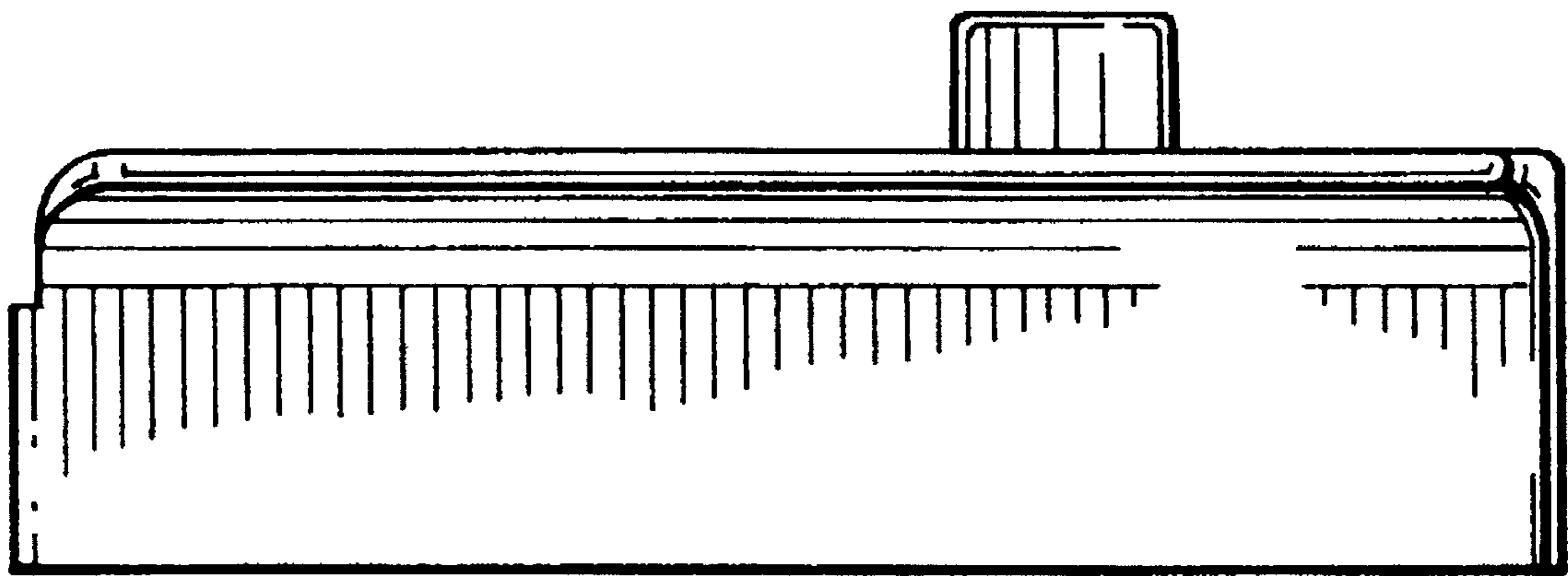
