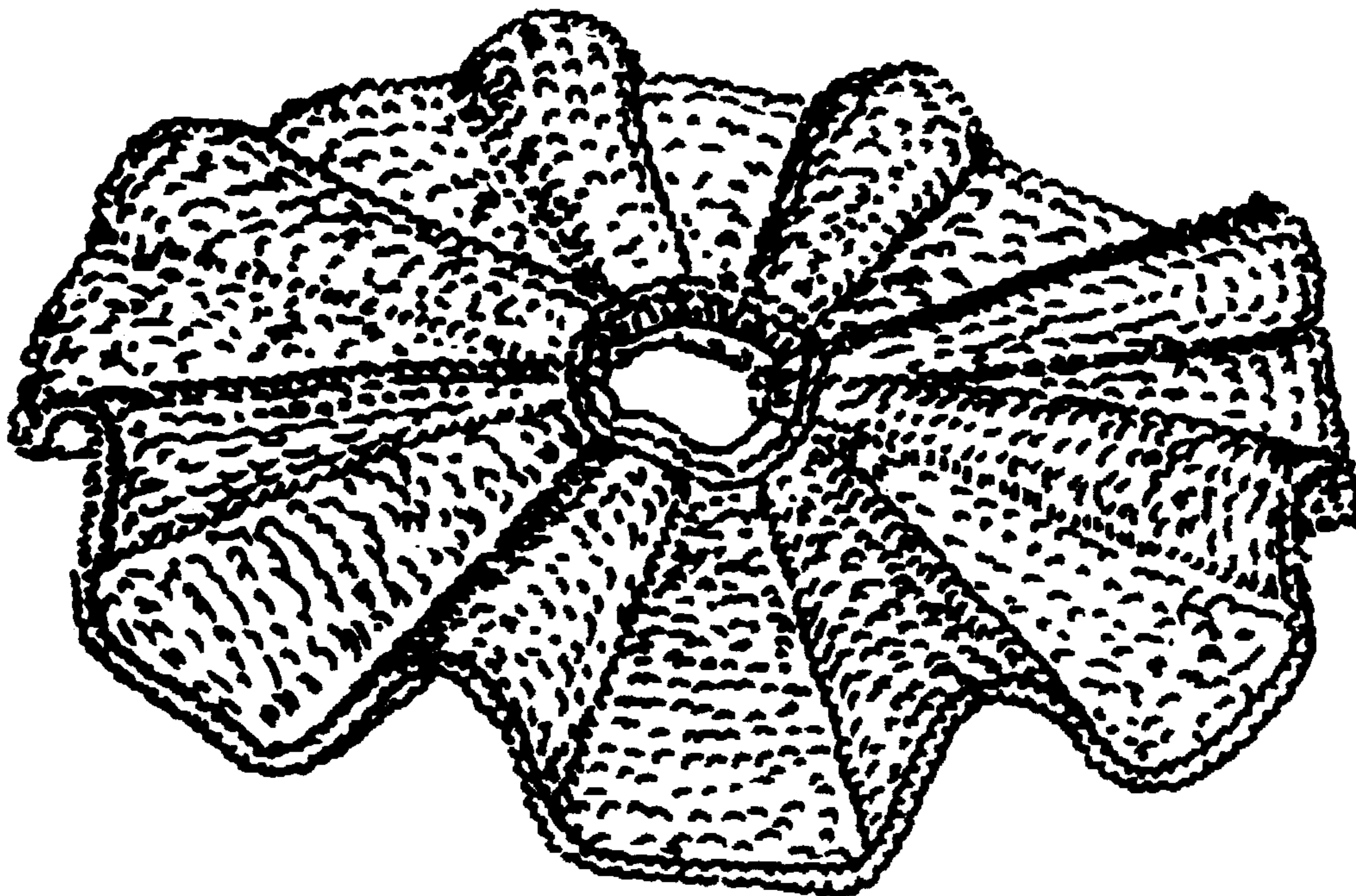
[57] **CLAIM**

The ornamental design for a bottle skirt, as shown and described.

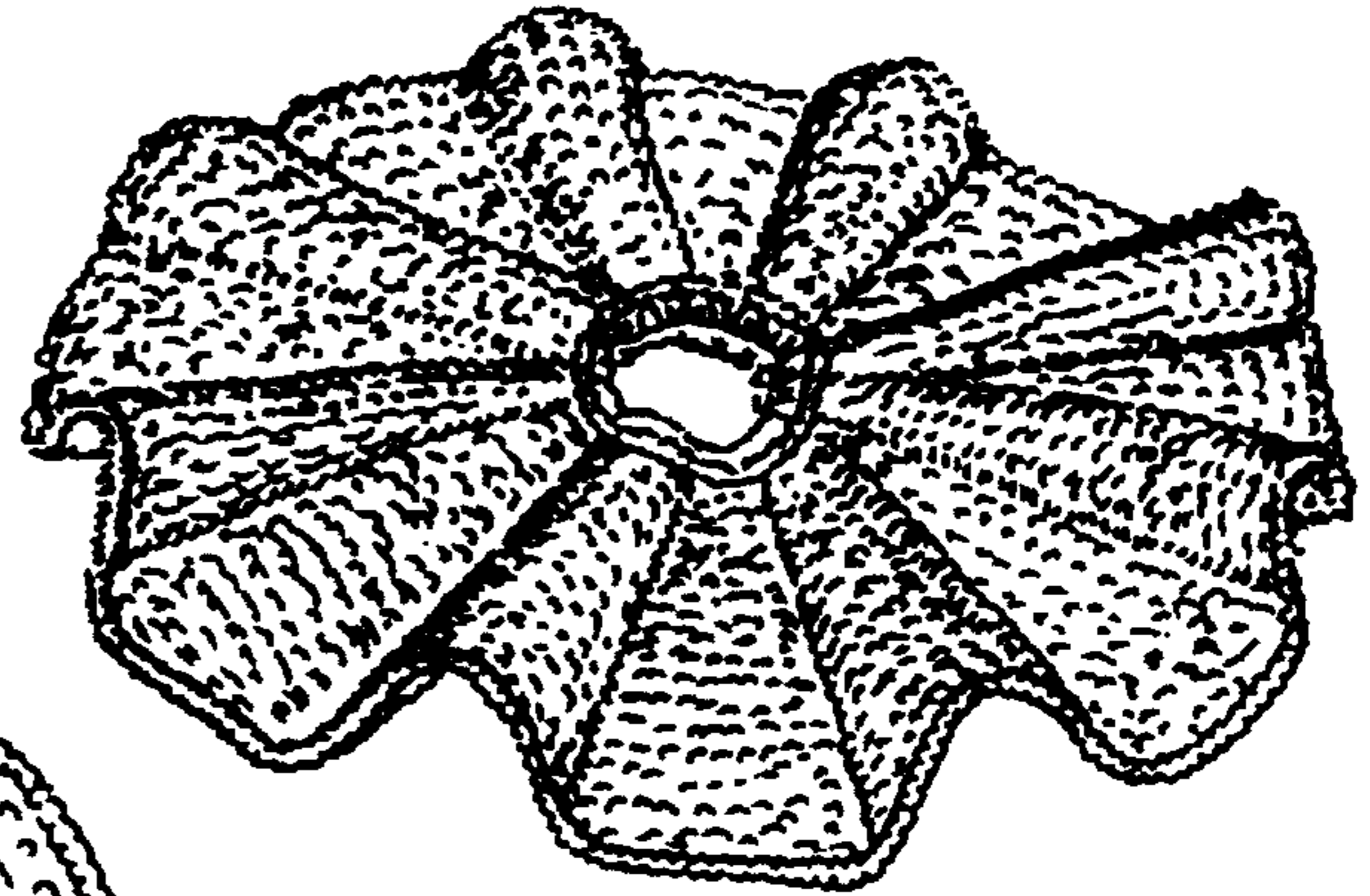
**DESCRIPTION**

FIG. 4 is a bottom plan view thereof.

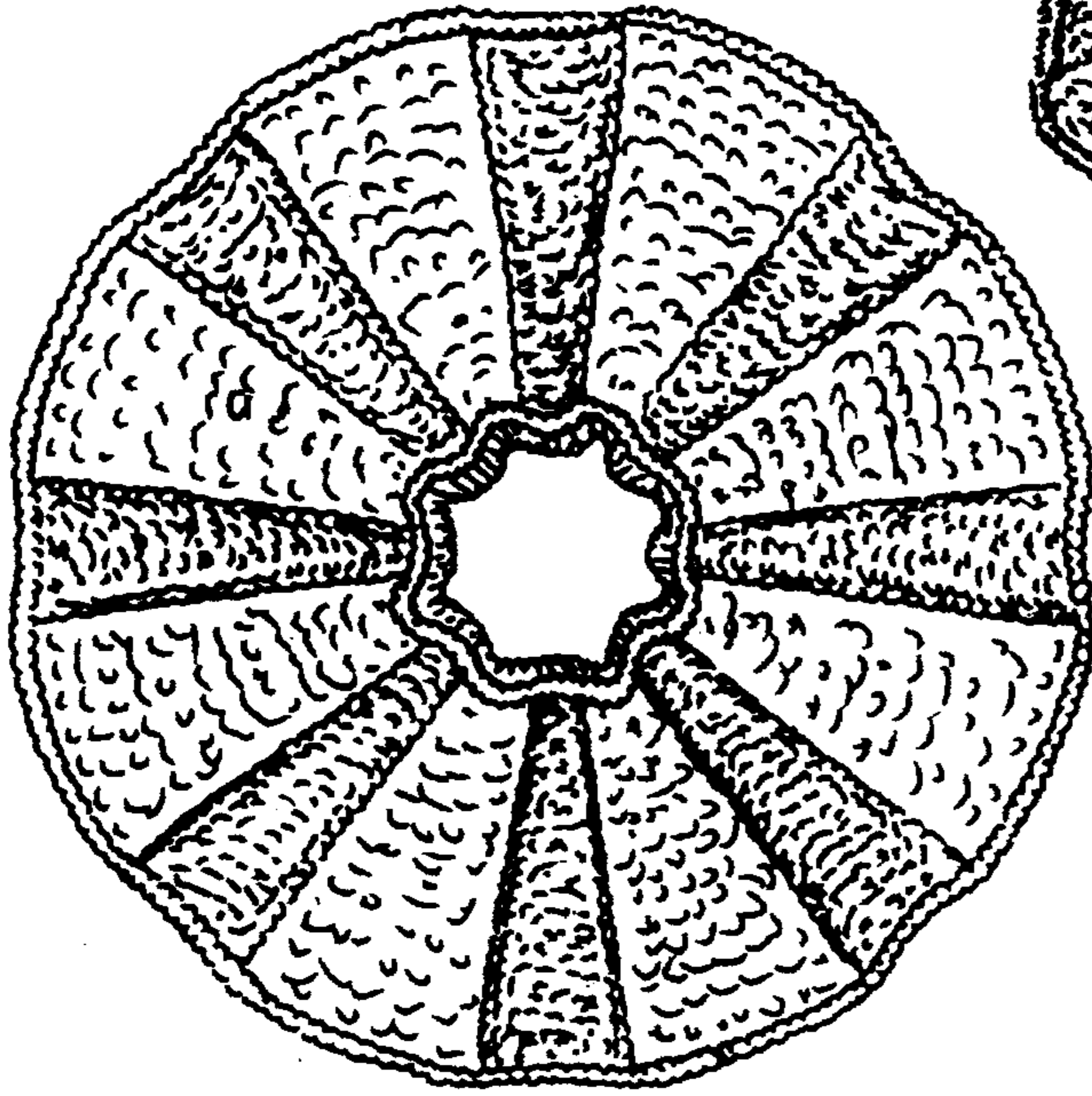

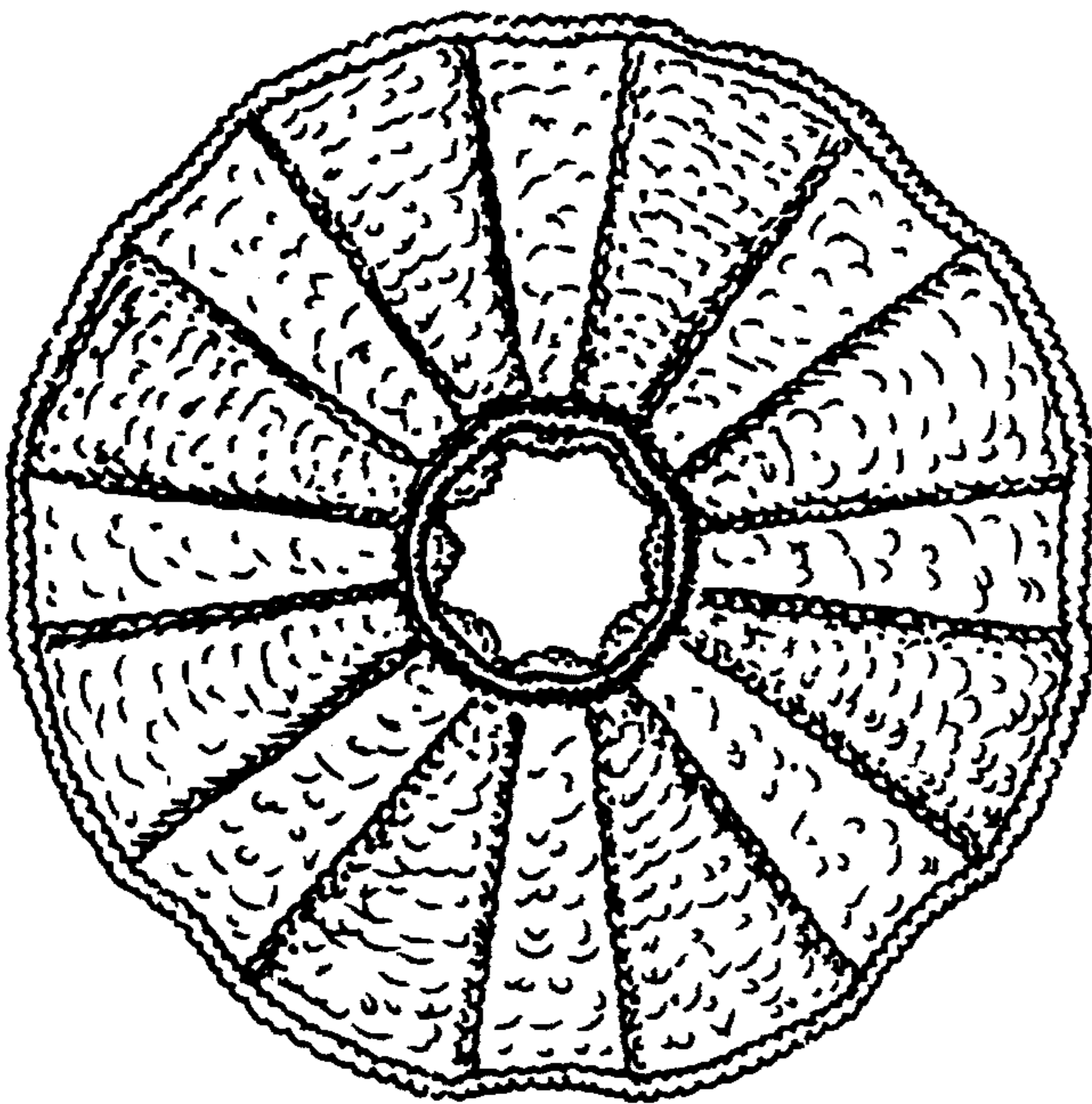
