[57] **CLAIM**

The ornamental design for a combined set of alphabet figures with shelving unit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined set of alphabet figures with shelving unit showing my new design; The alphabets A through Z retained within the shelving unit are shown in their actual details in the following FIGS. 5 through 30 respectively.

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof; the right side elevational view being a mirror image thereof;

FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image thereof;

FIG. 6 is an enlarged detail view of the letter B;

FIG. 7 is an enlarged detail view of the letter C;

FIG. 27 is an enlarged detail view of the letter W;

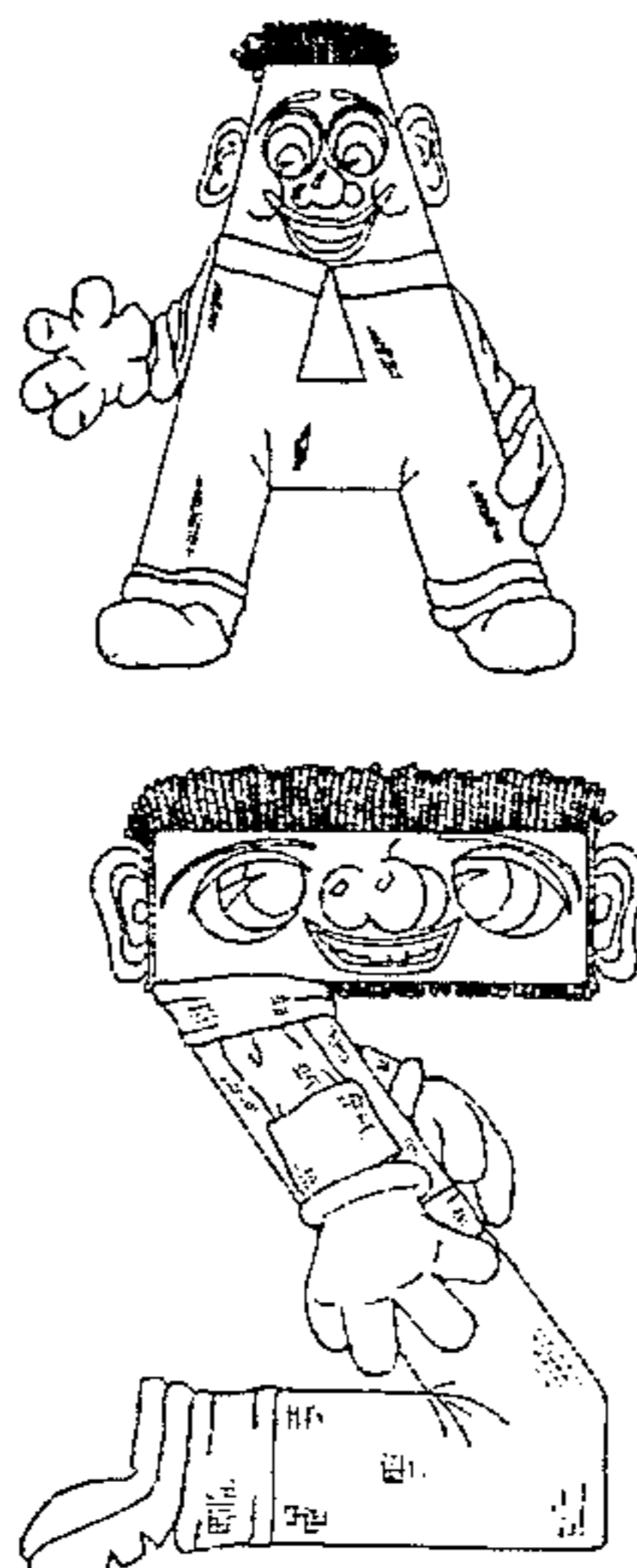
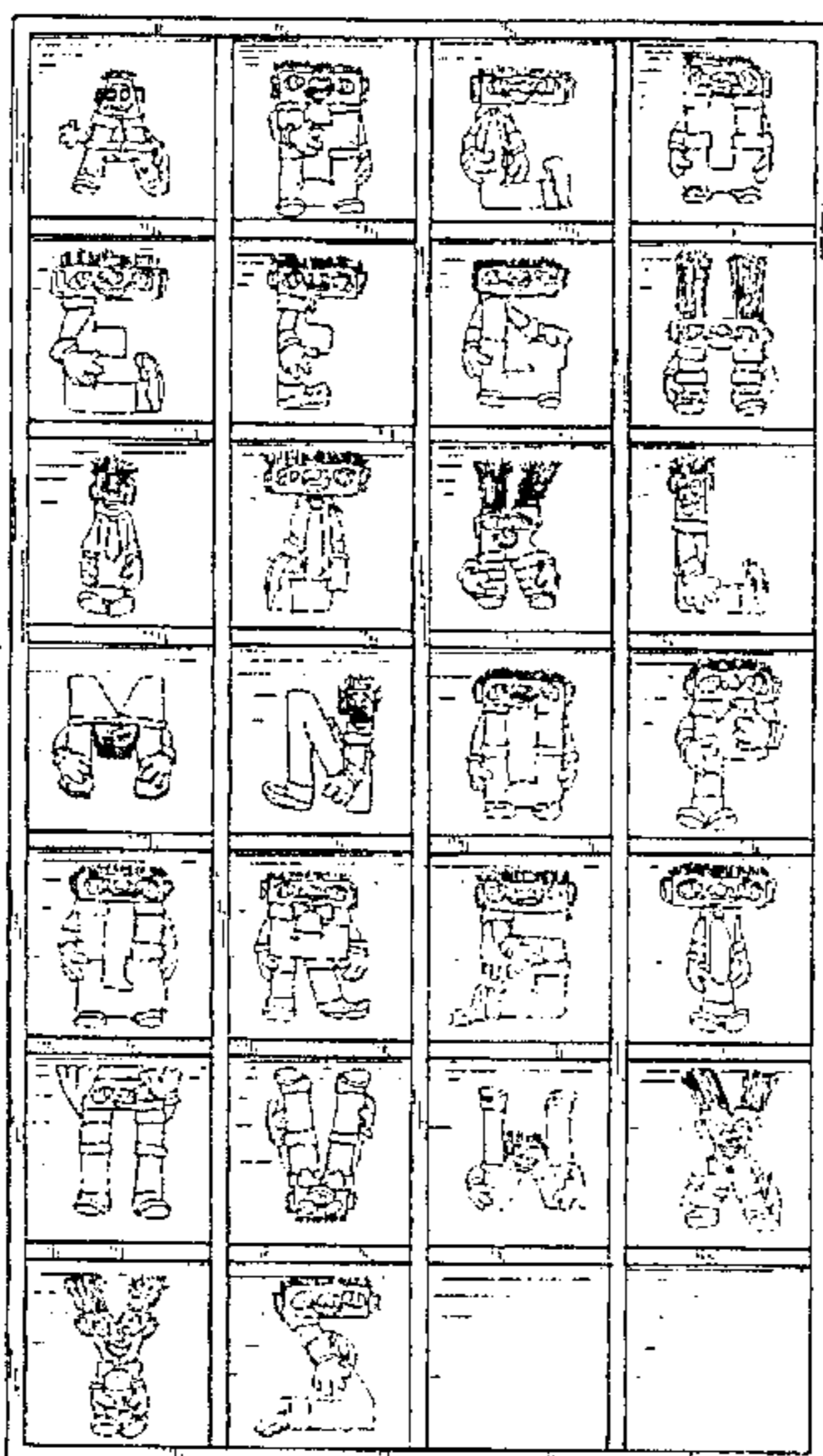
FIG. 28 is an enlarged detail view of the letter X;

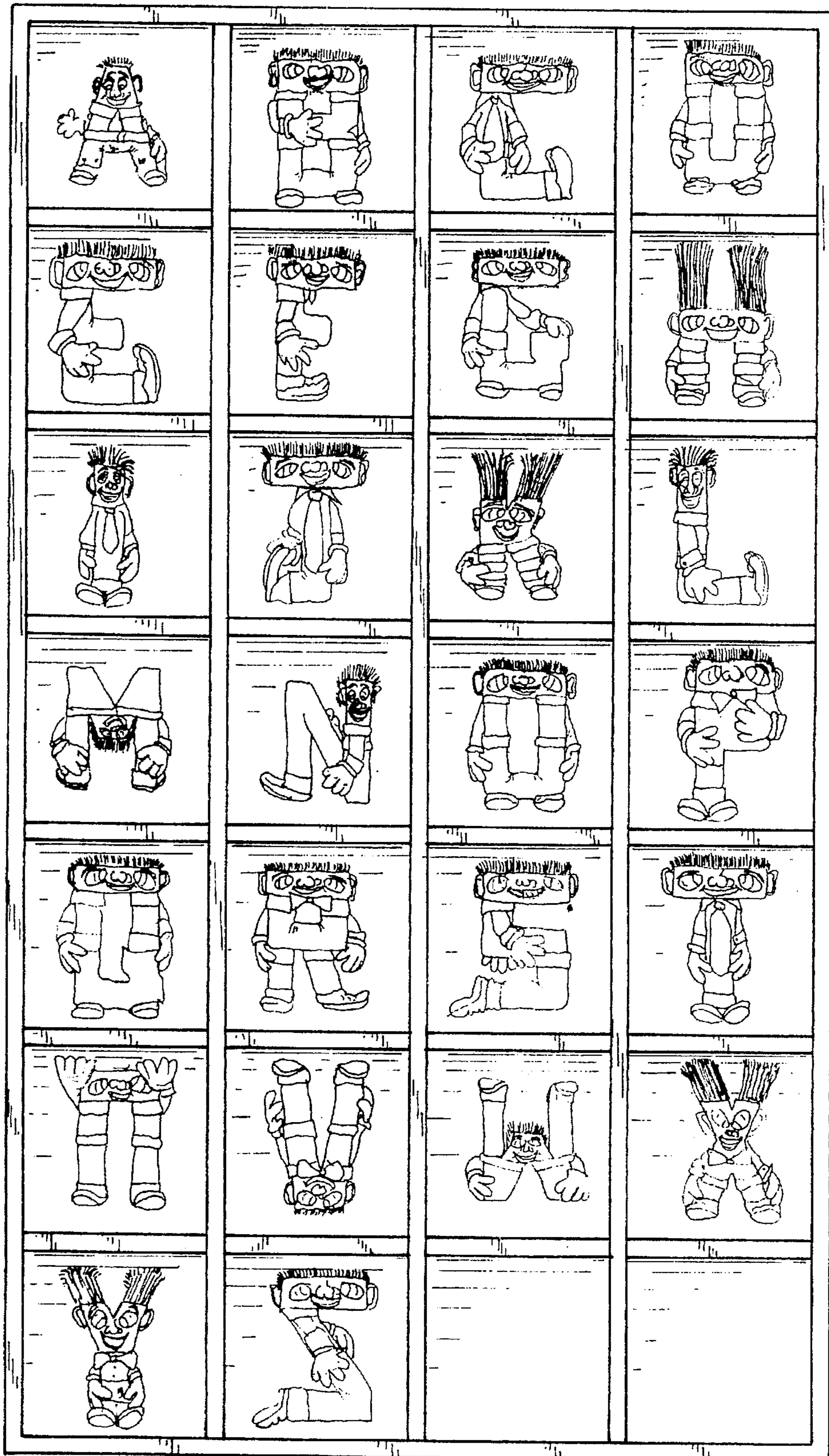

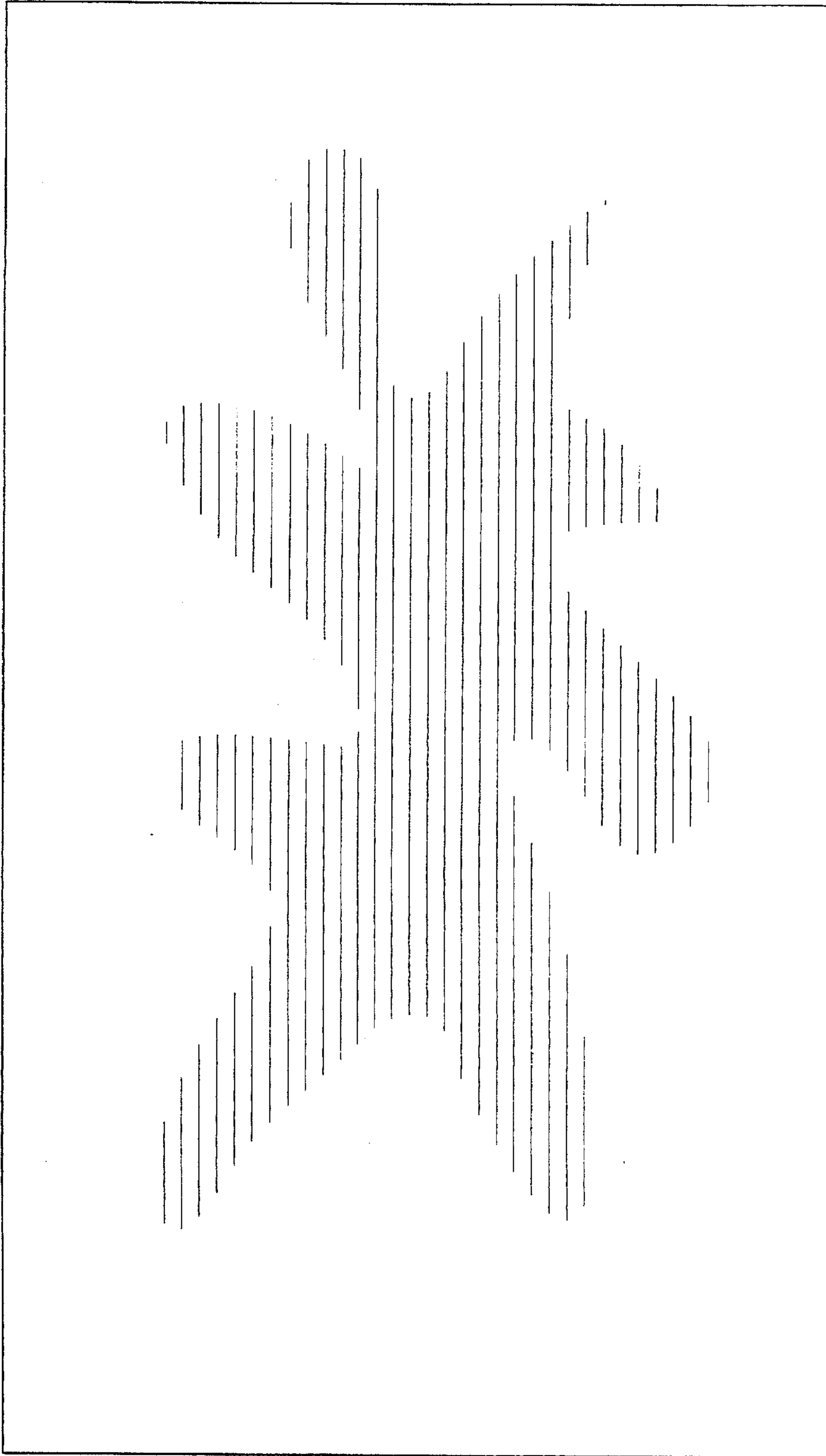

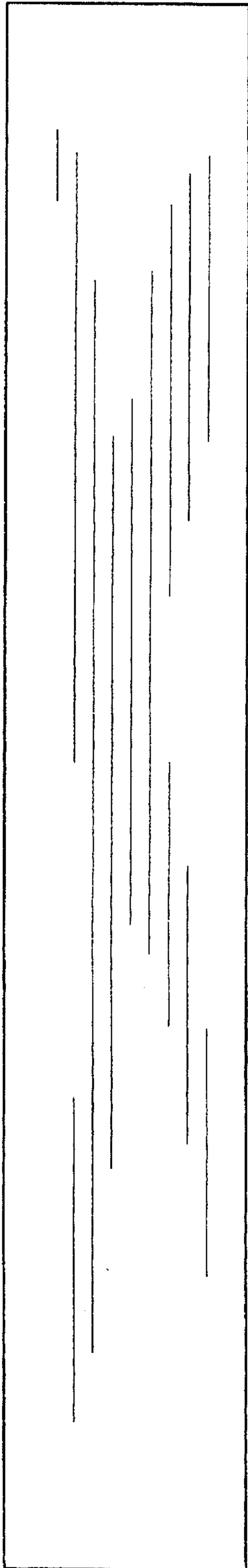

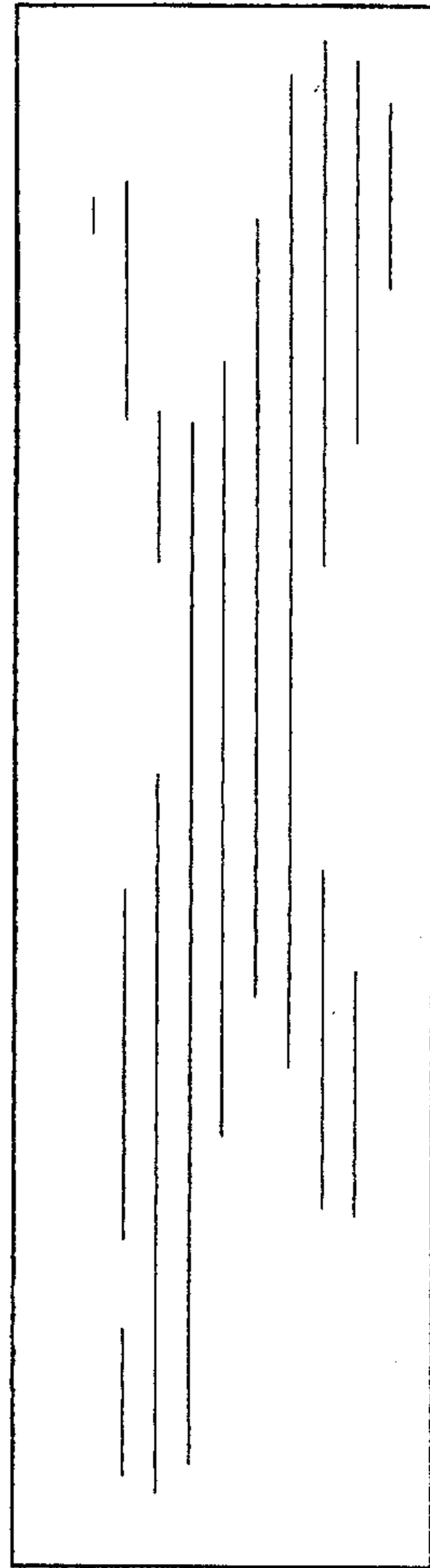

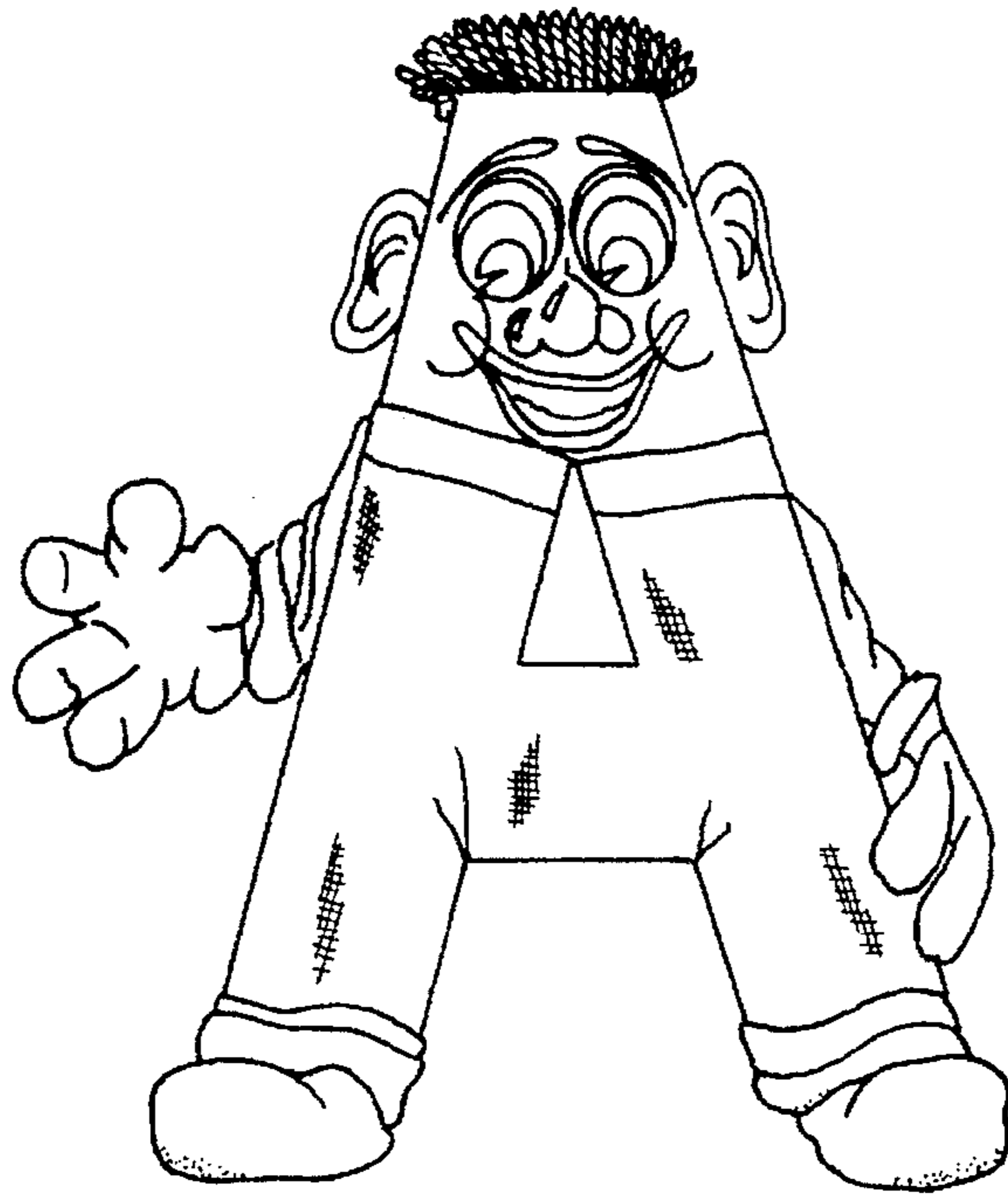

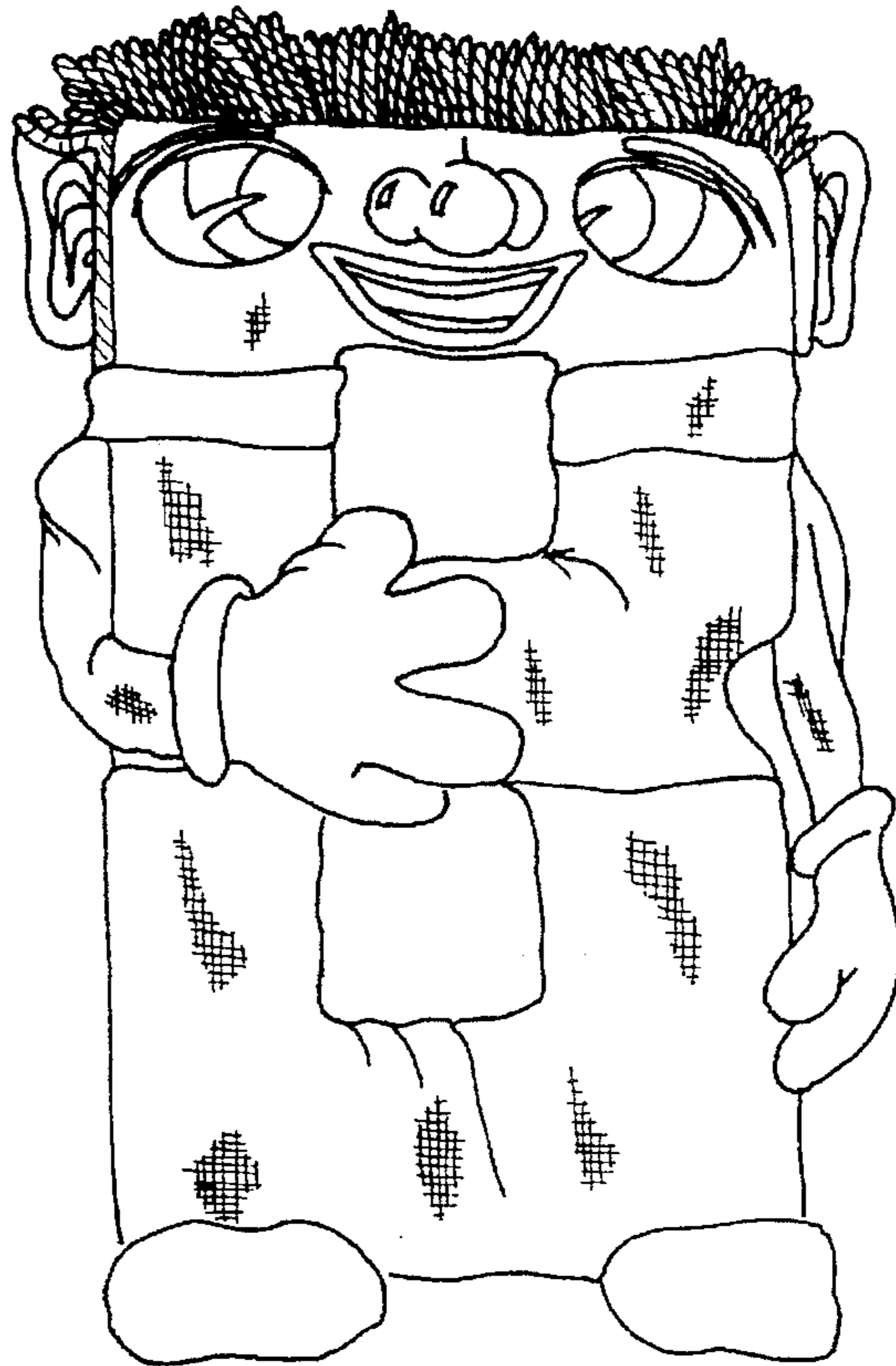

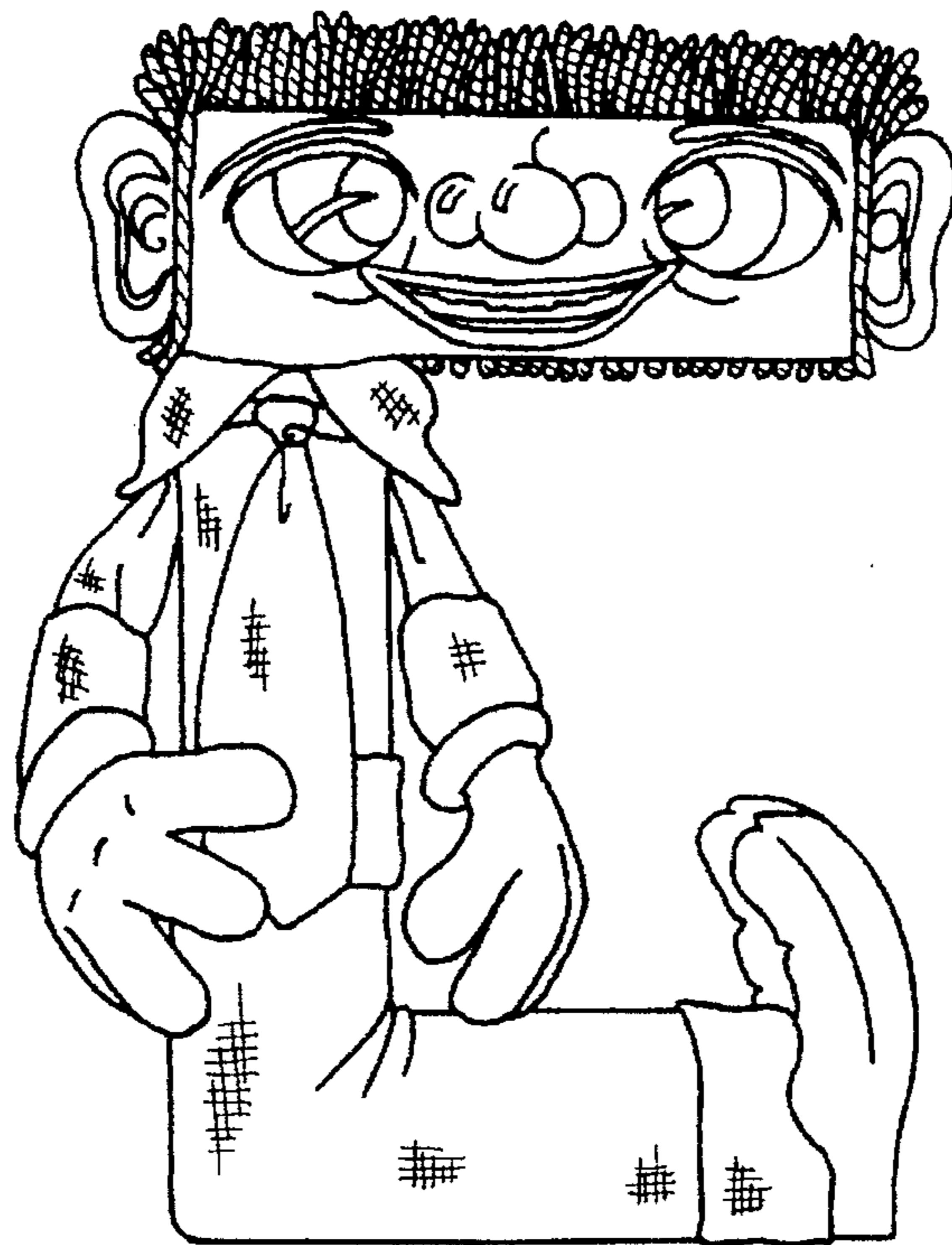

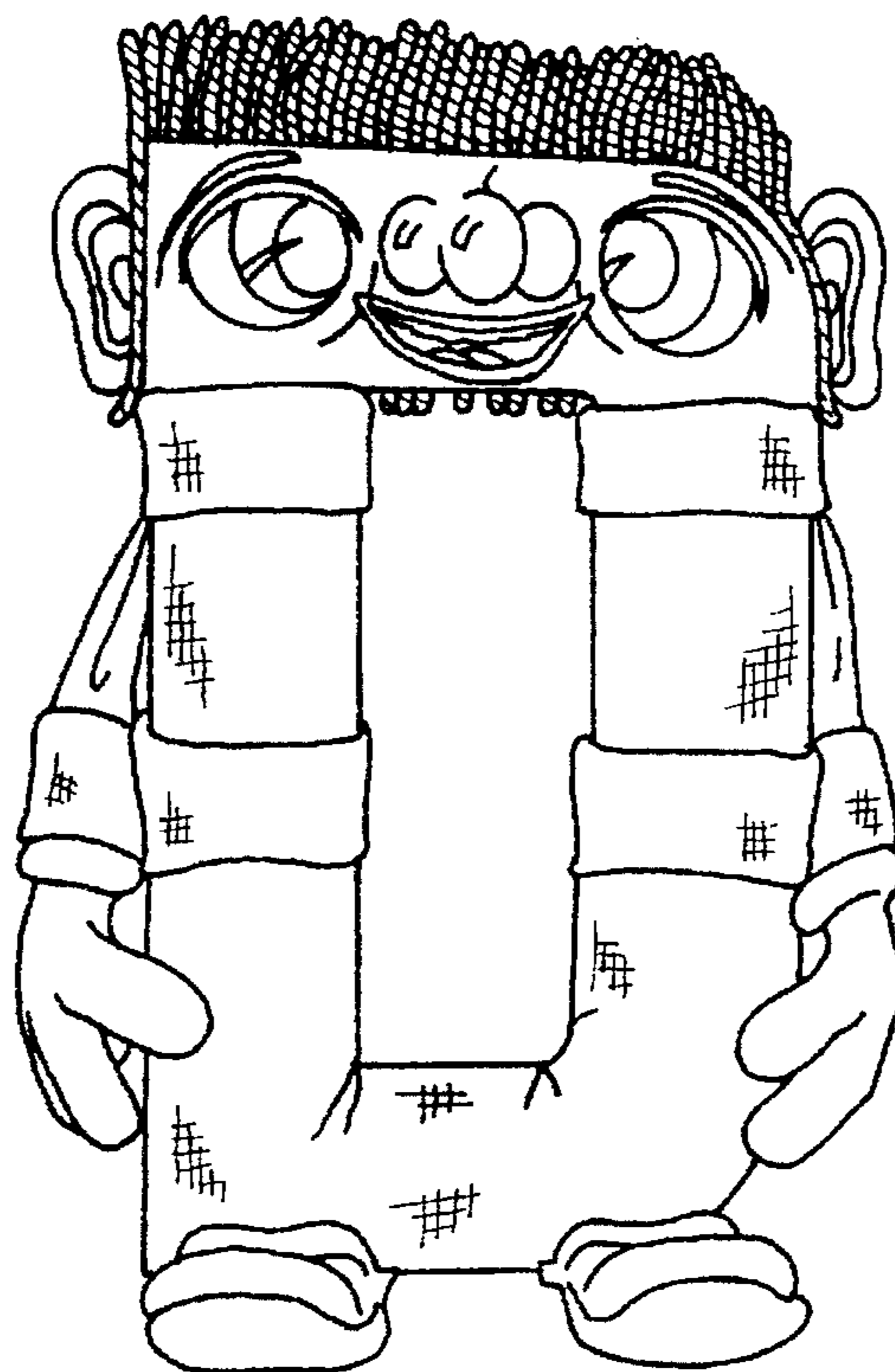

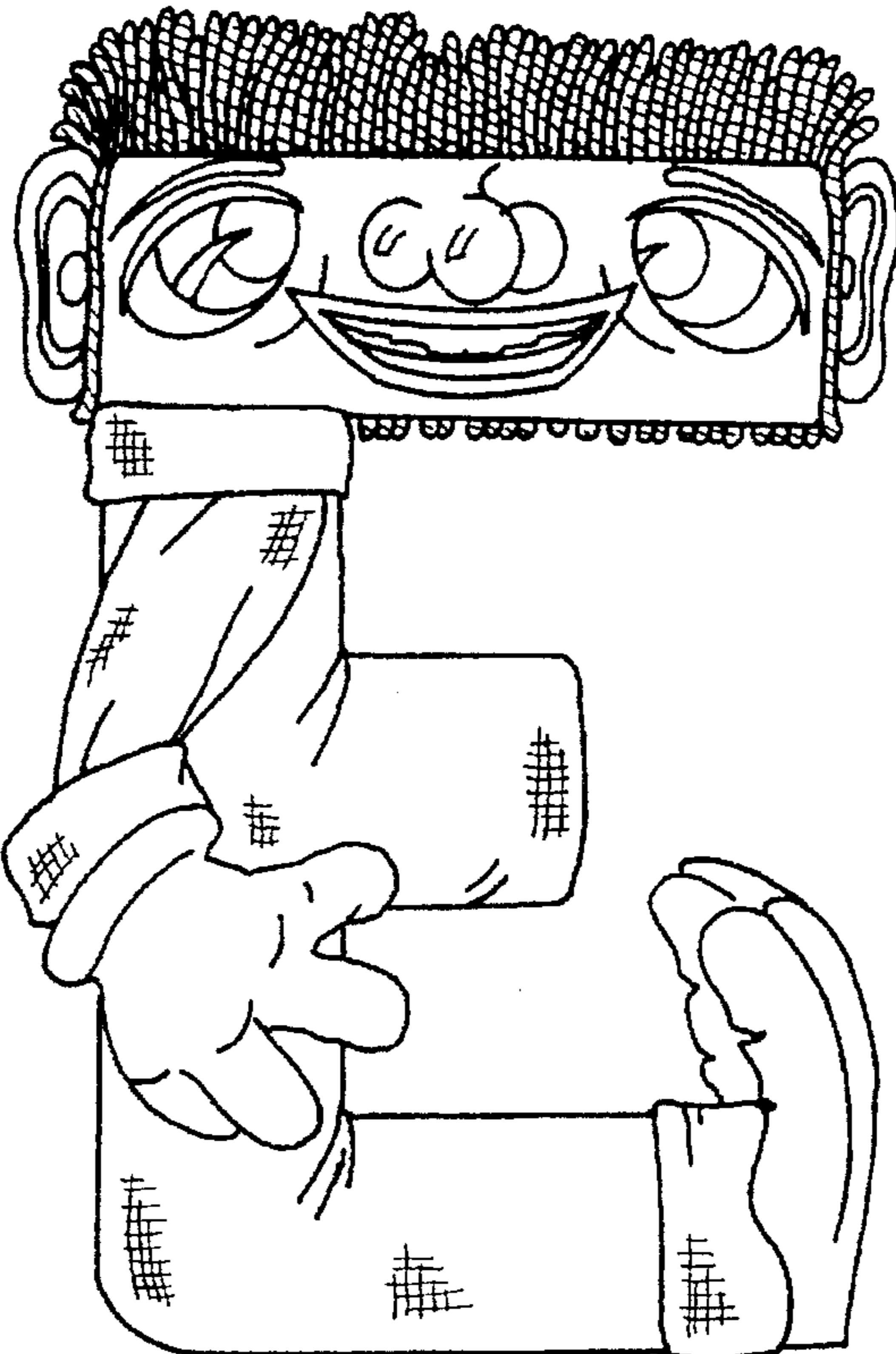

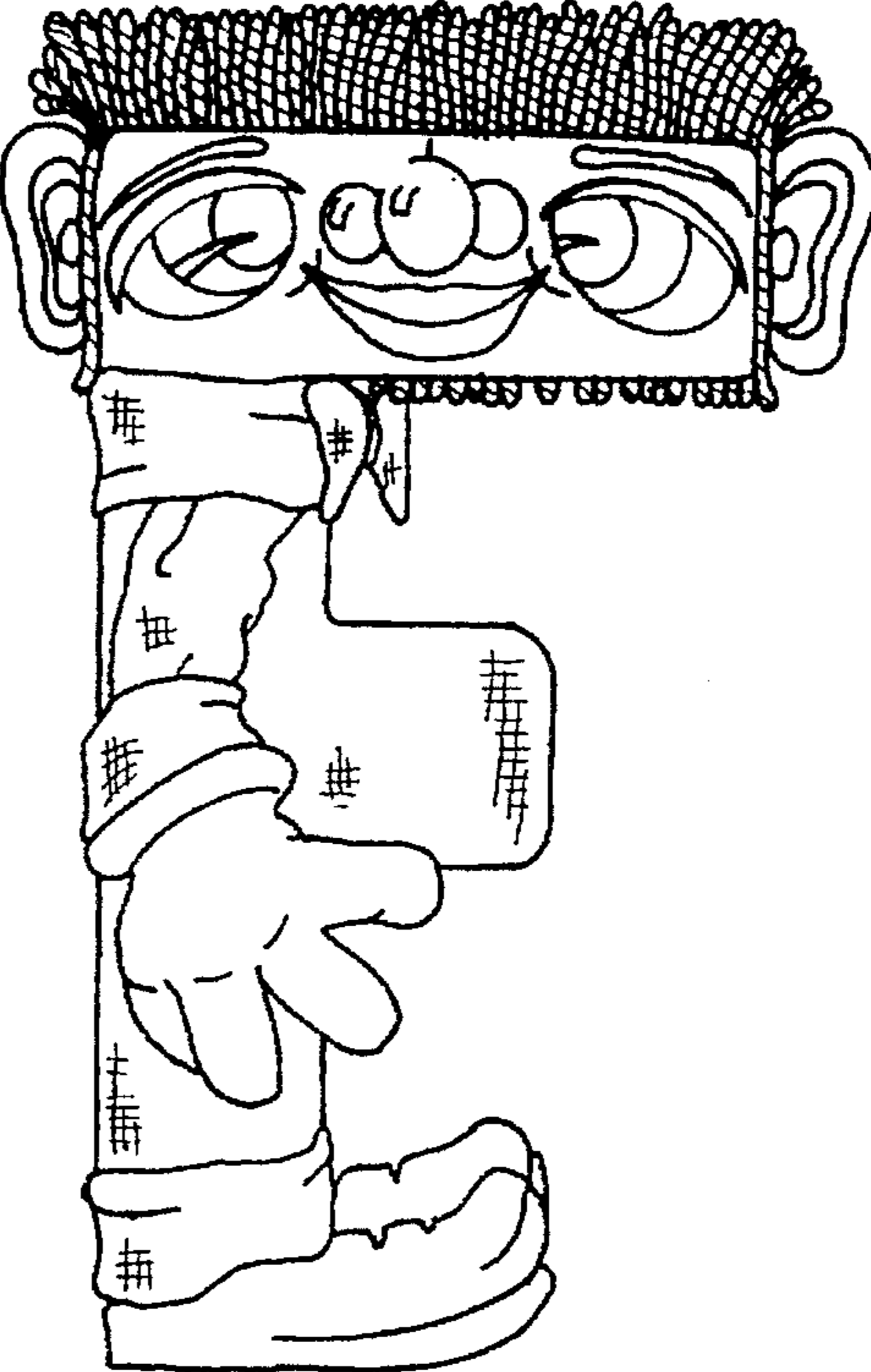

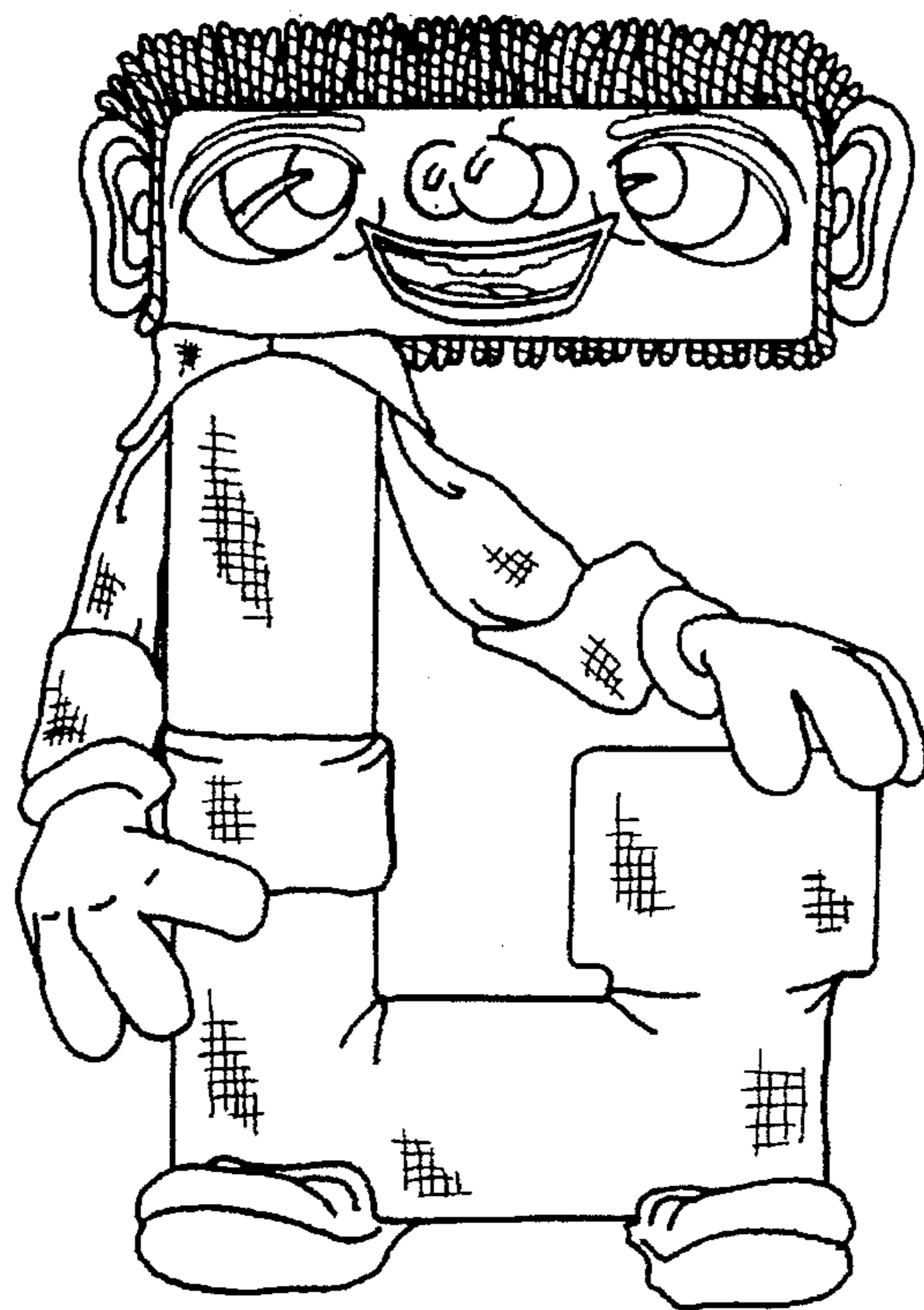

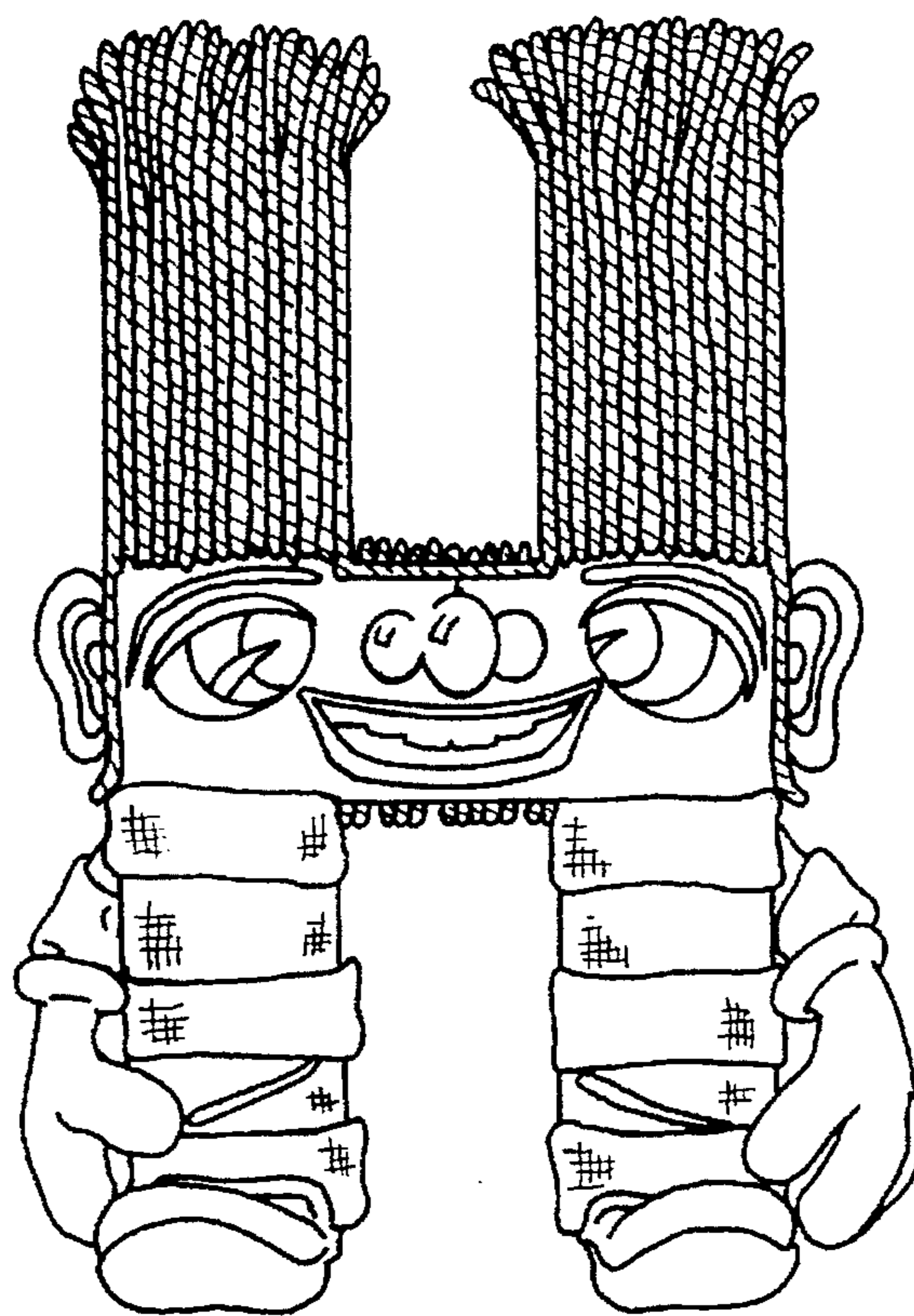

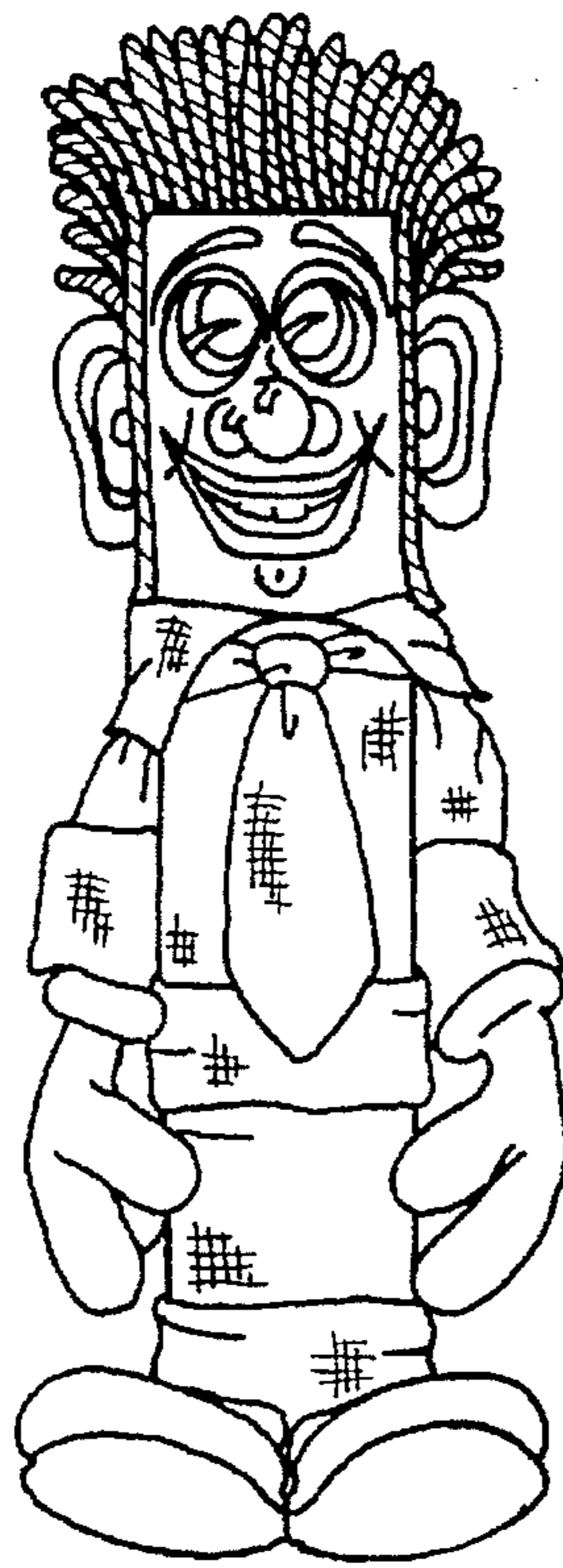

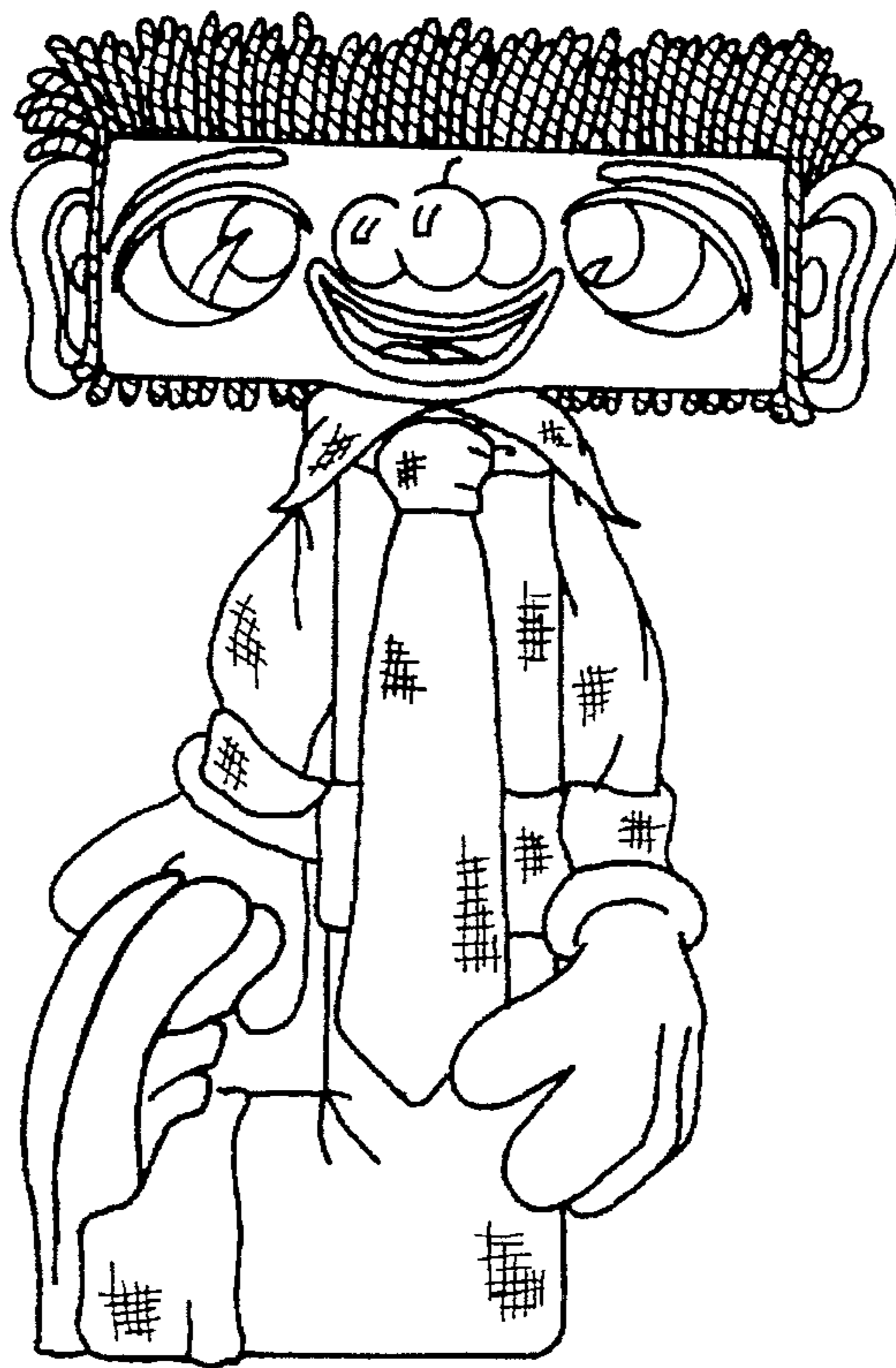

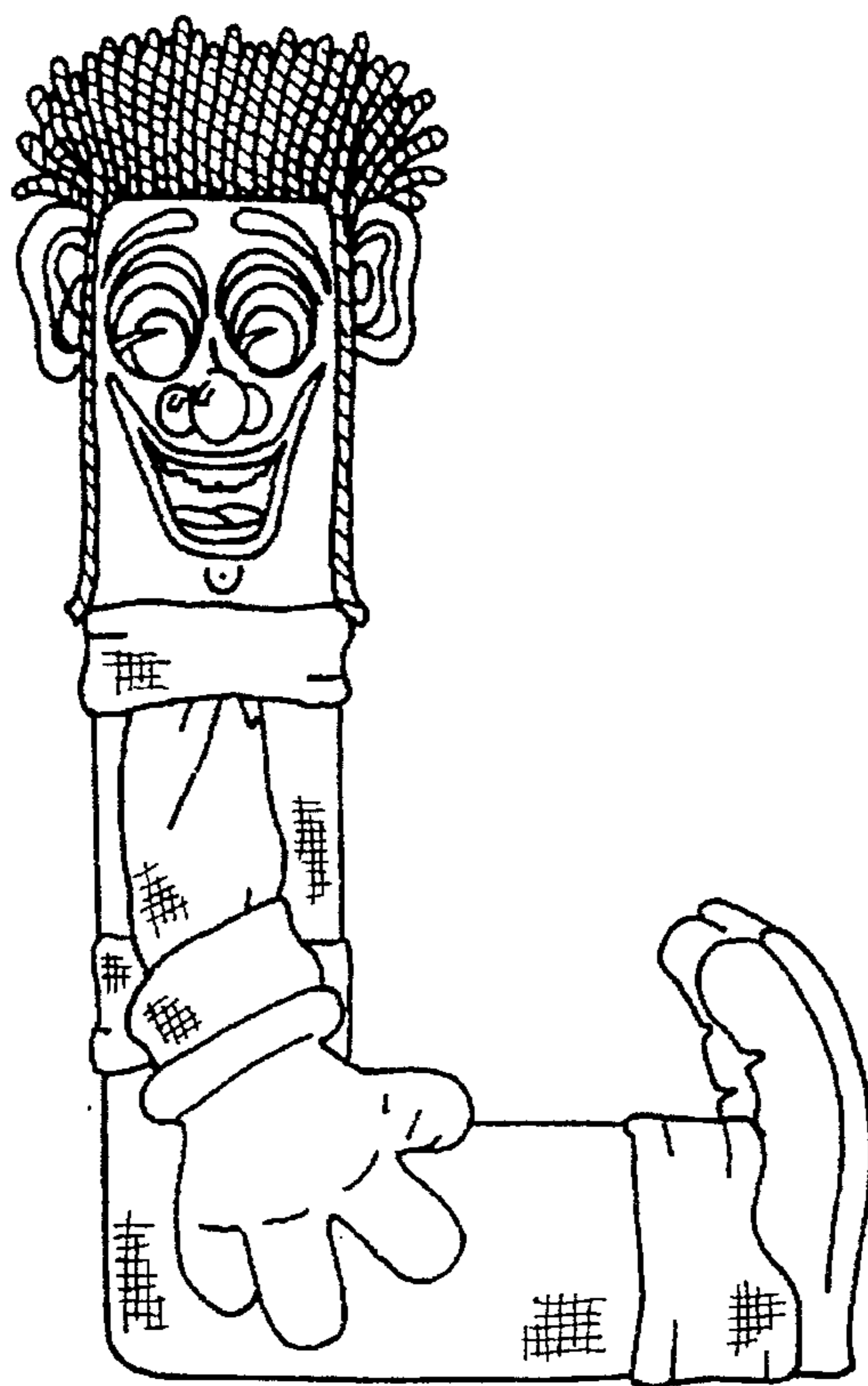

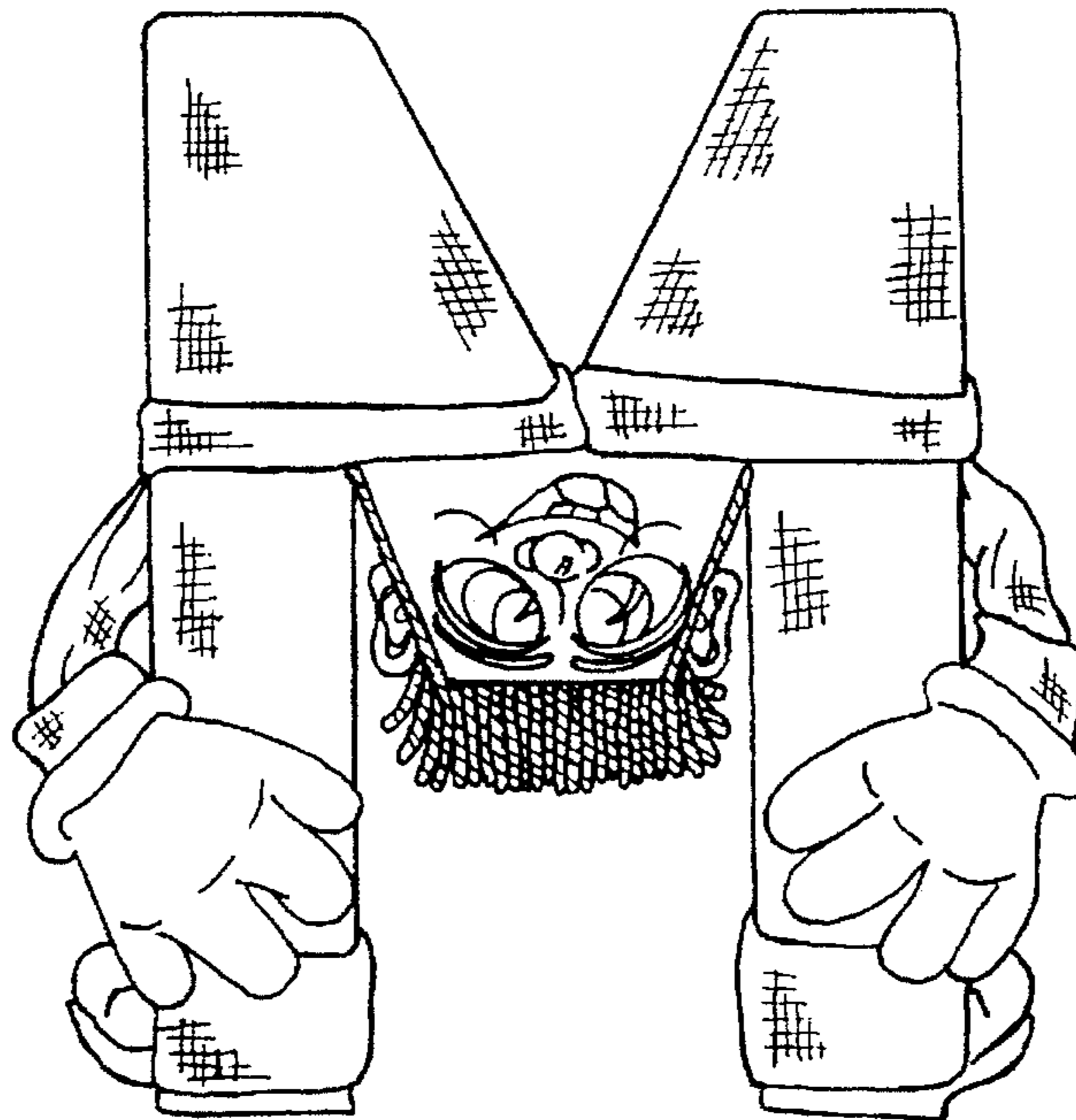

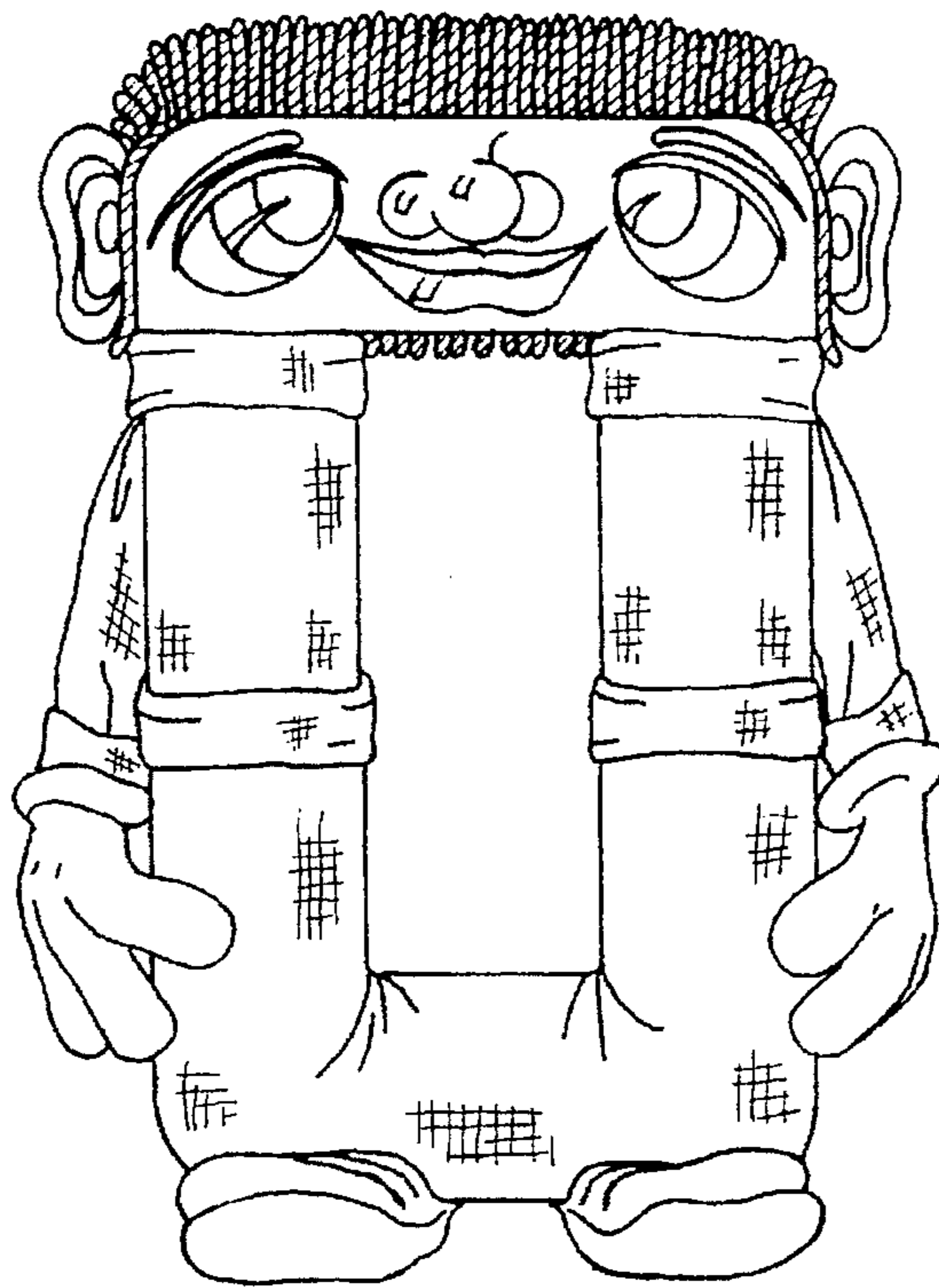

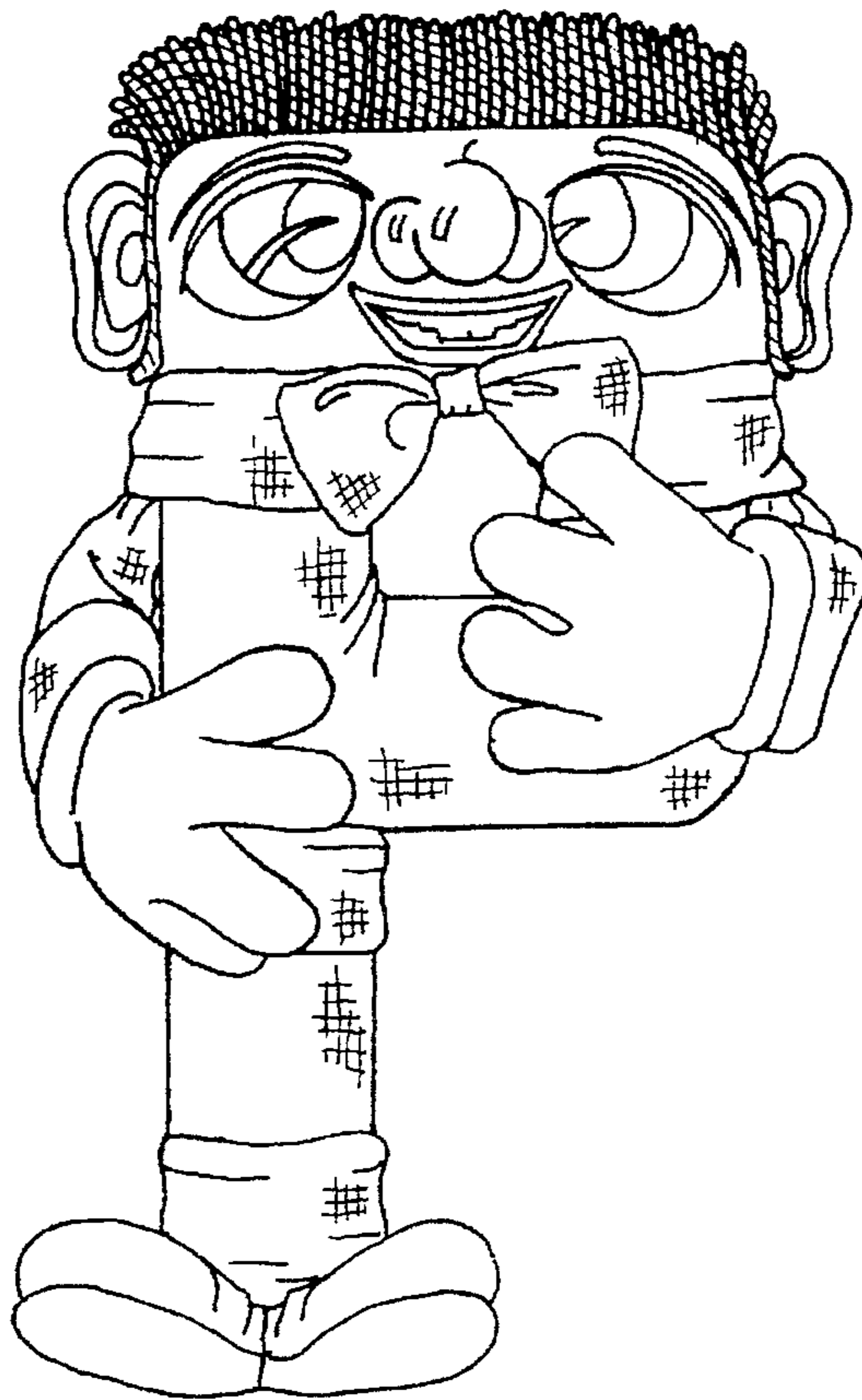

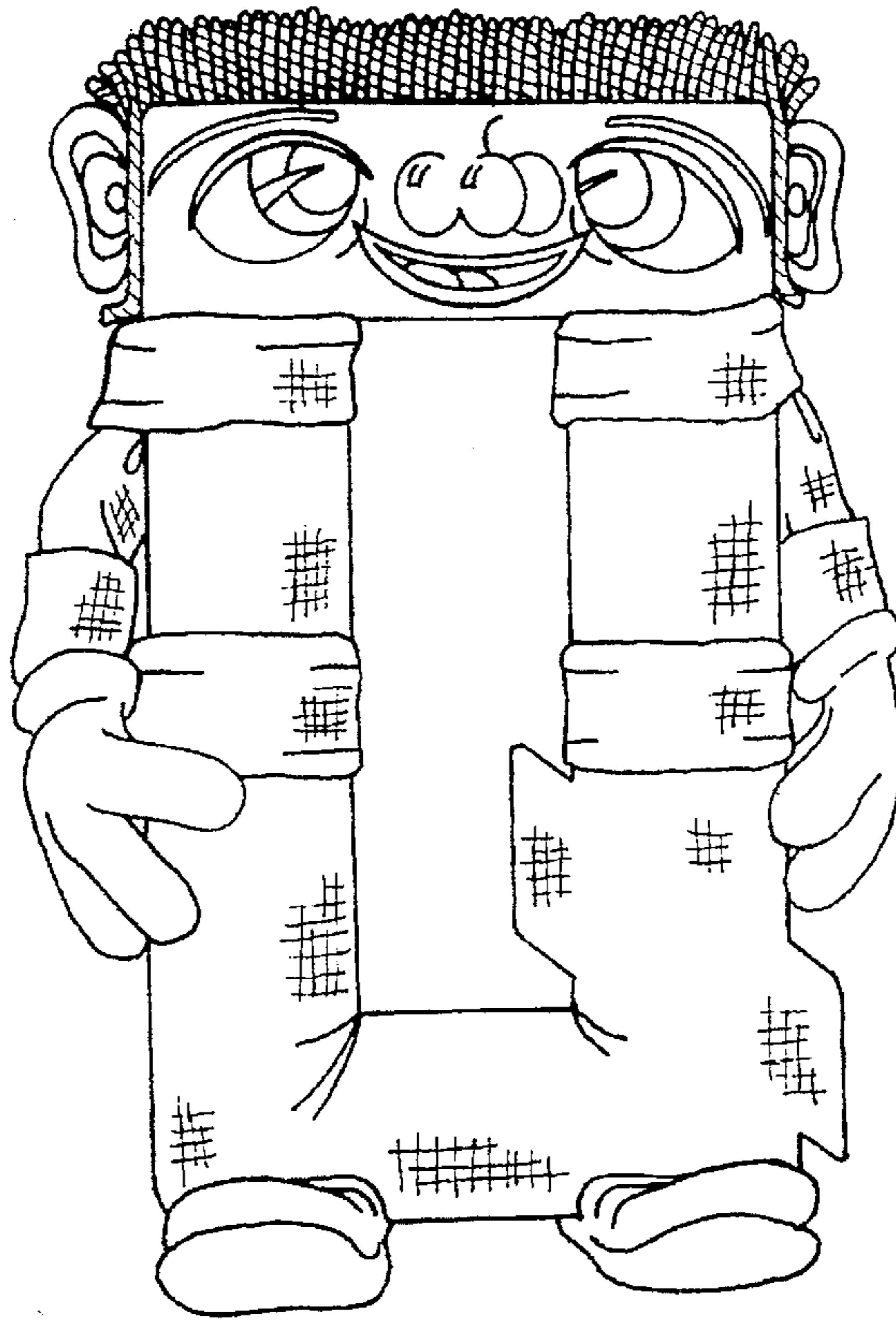

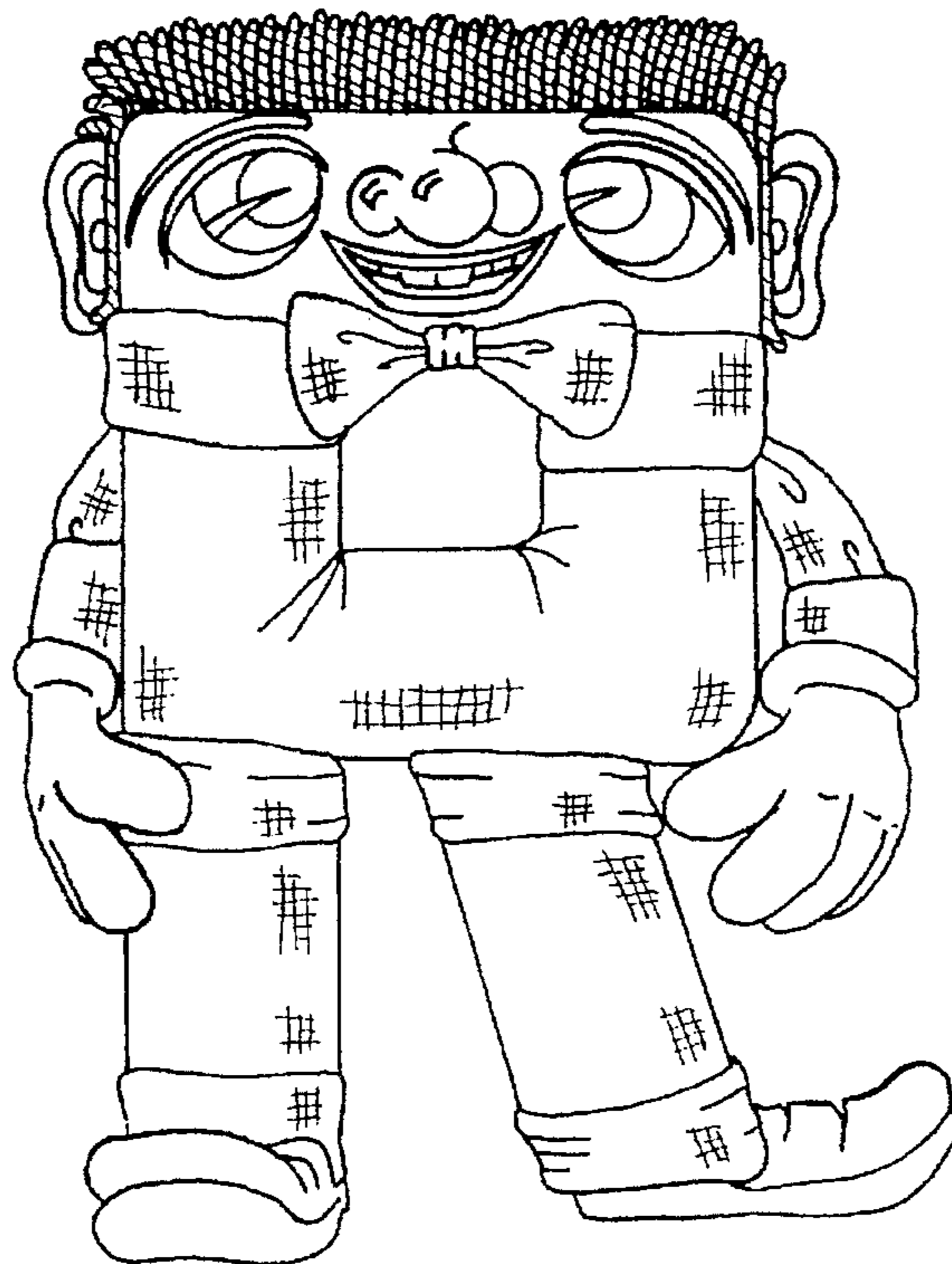

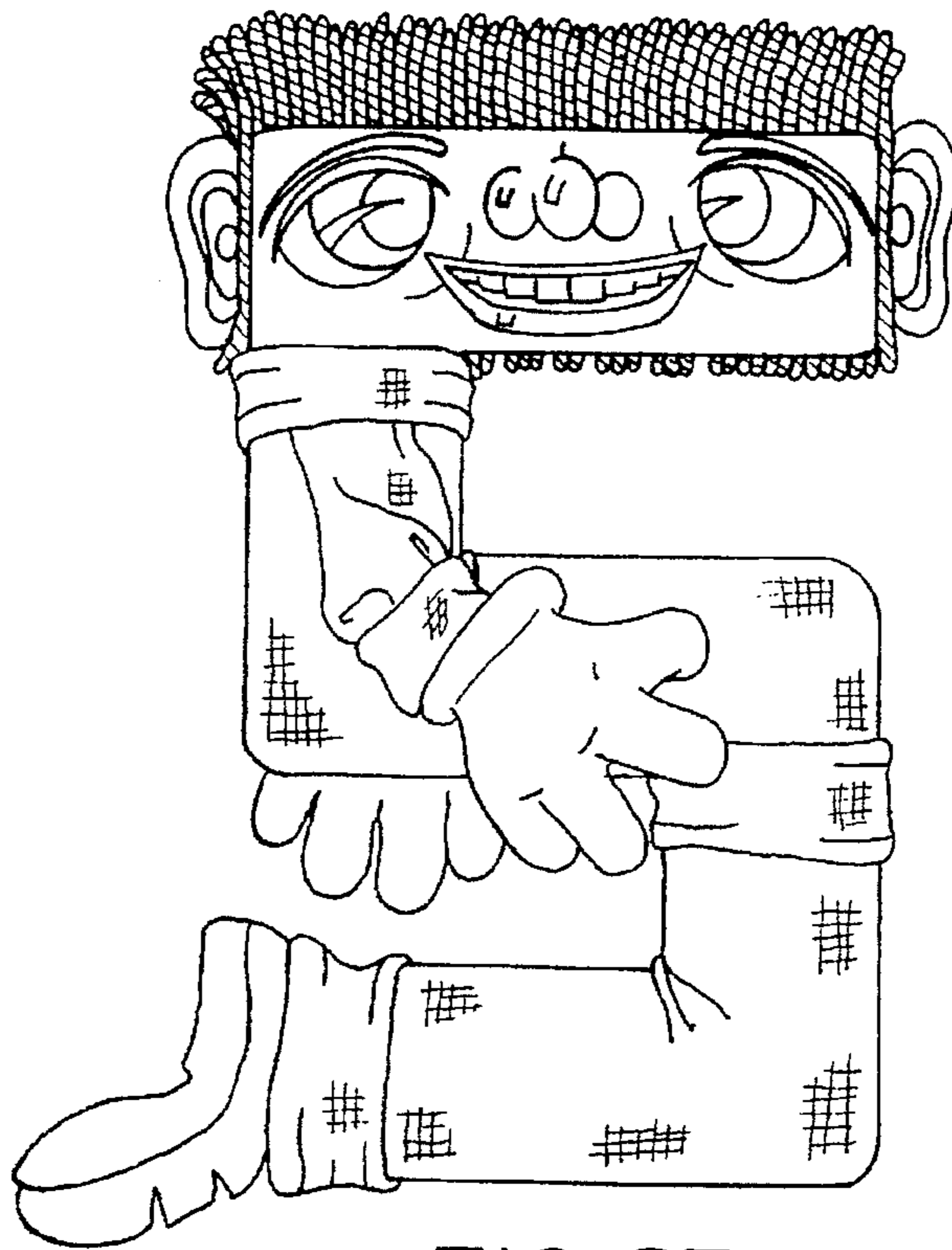

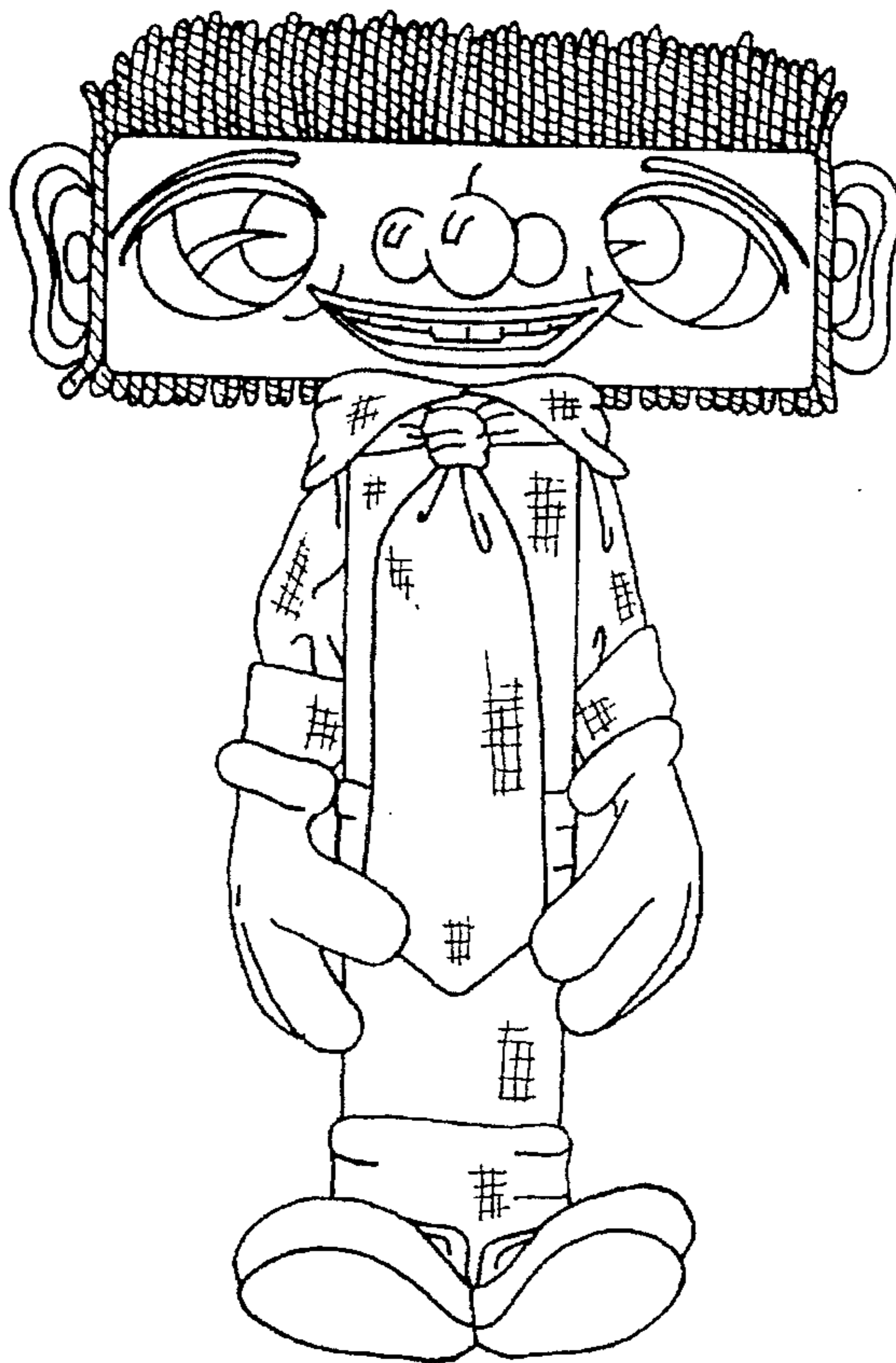

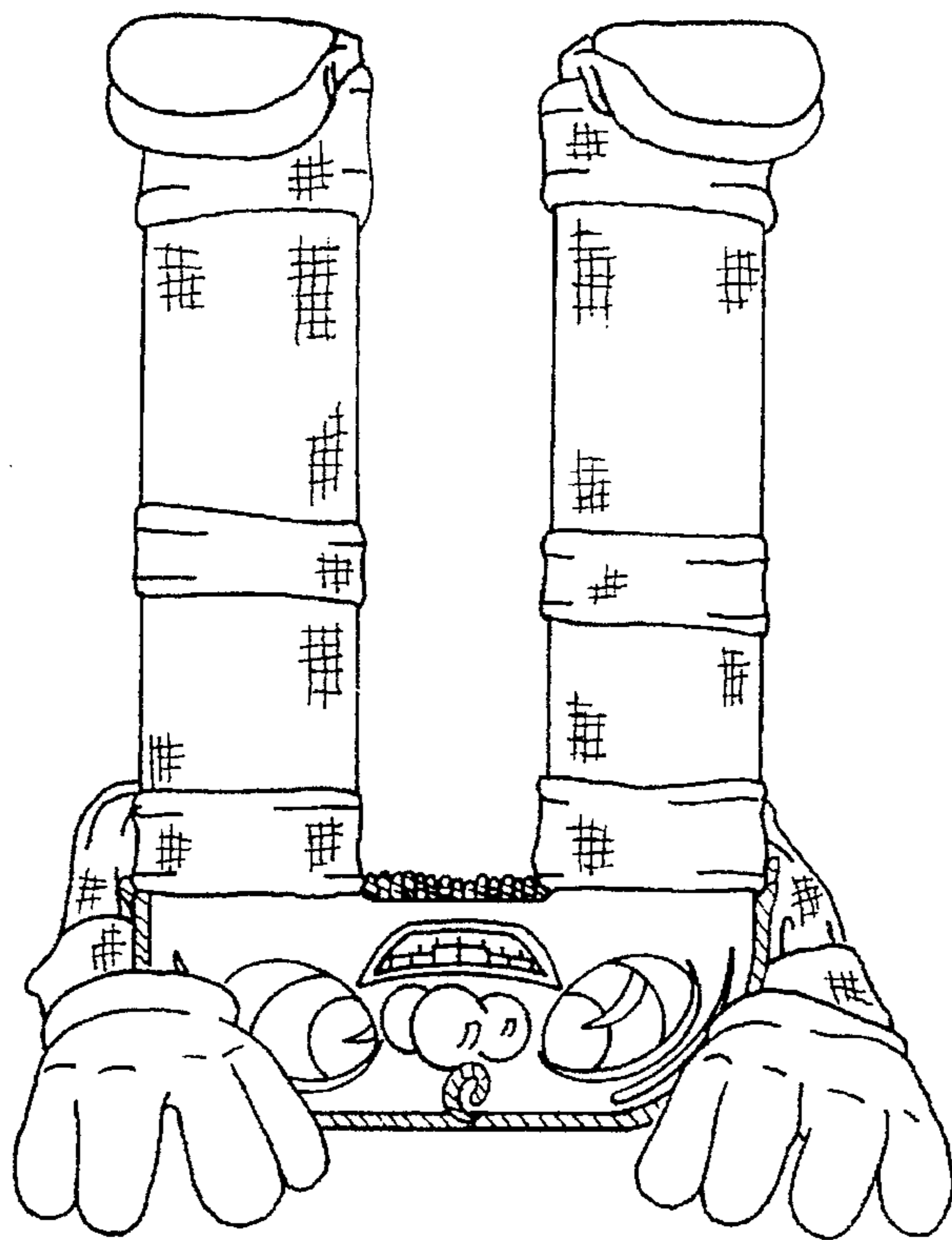

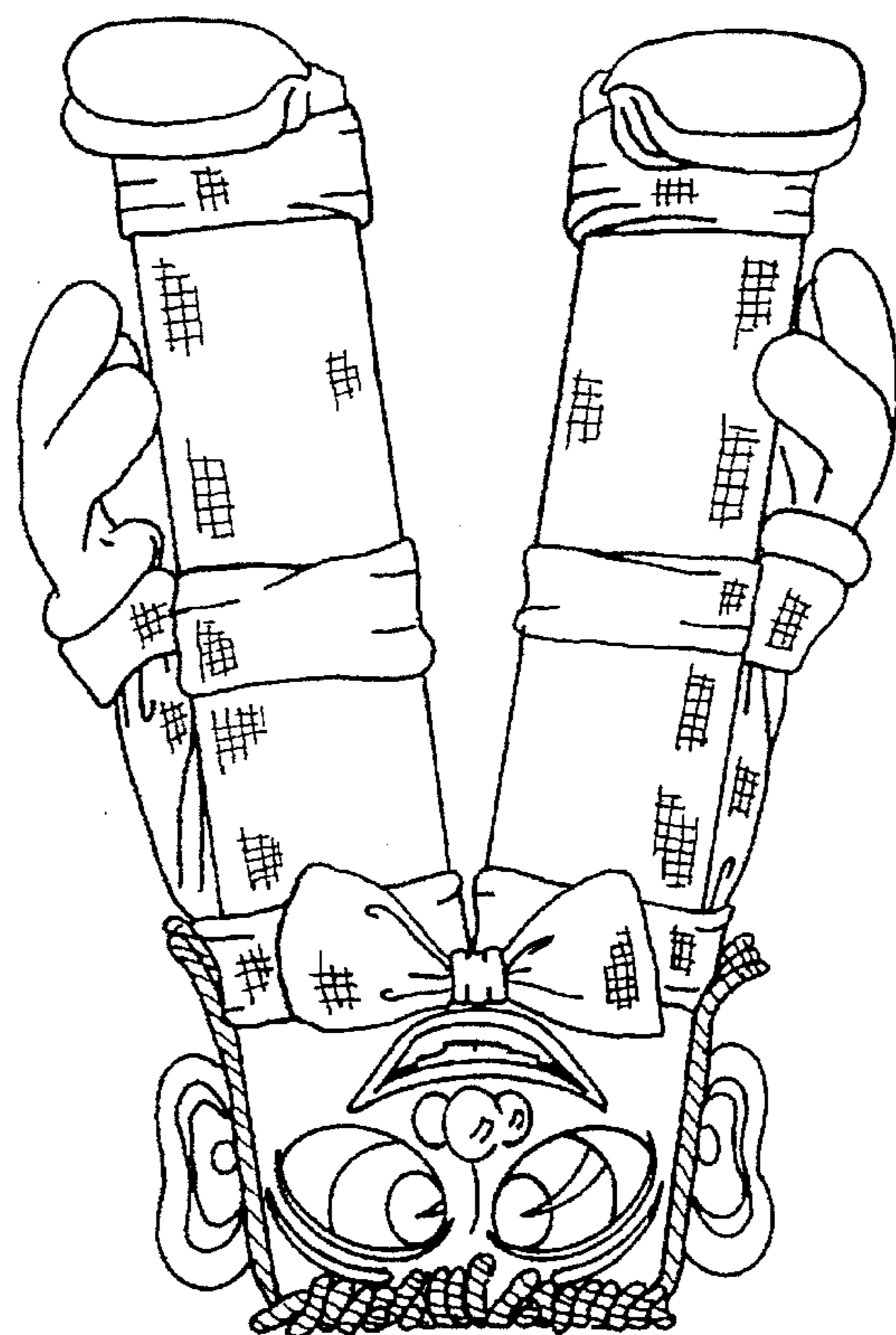

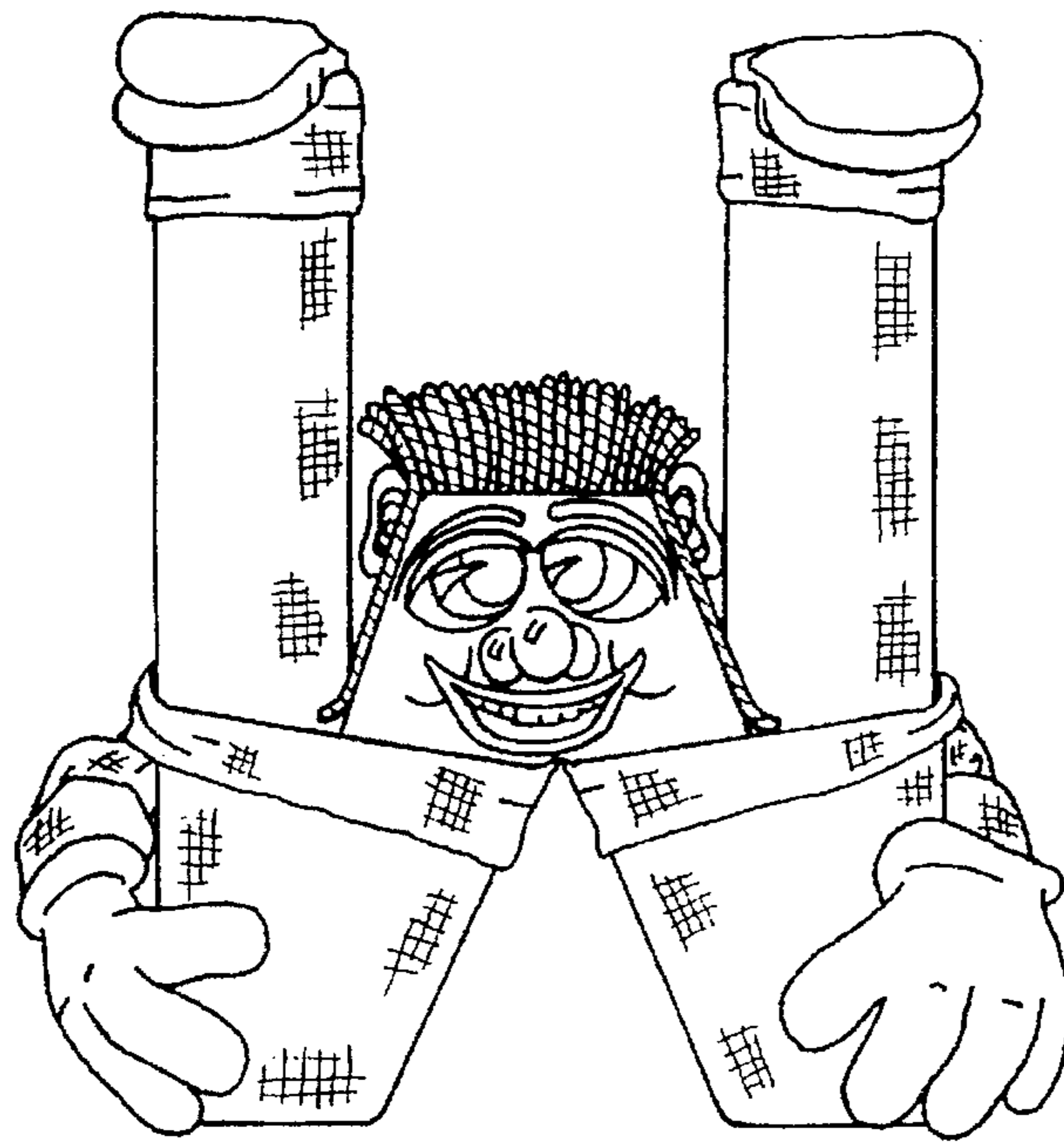

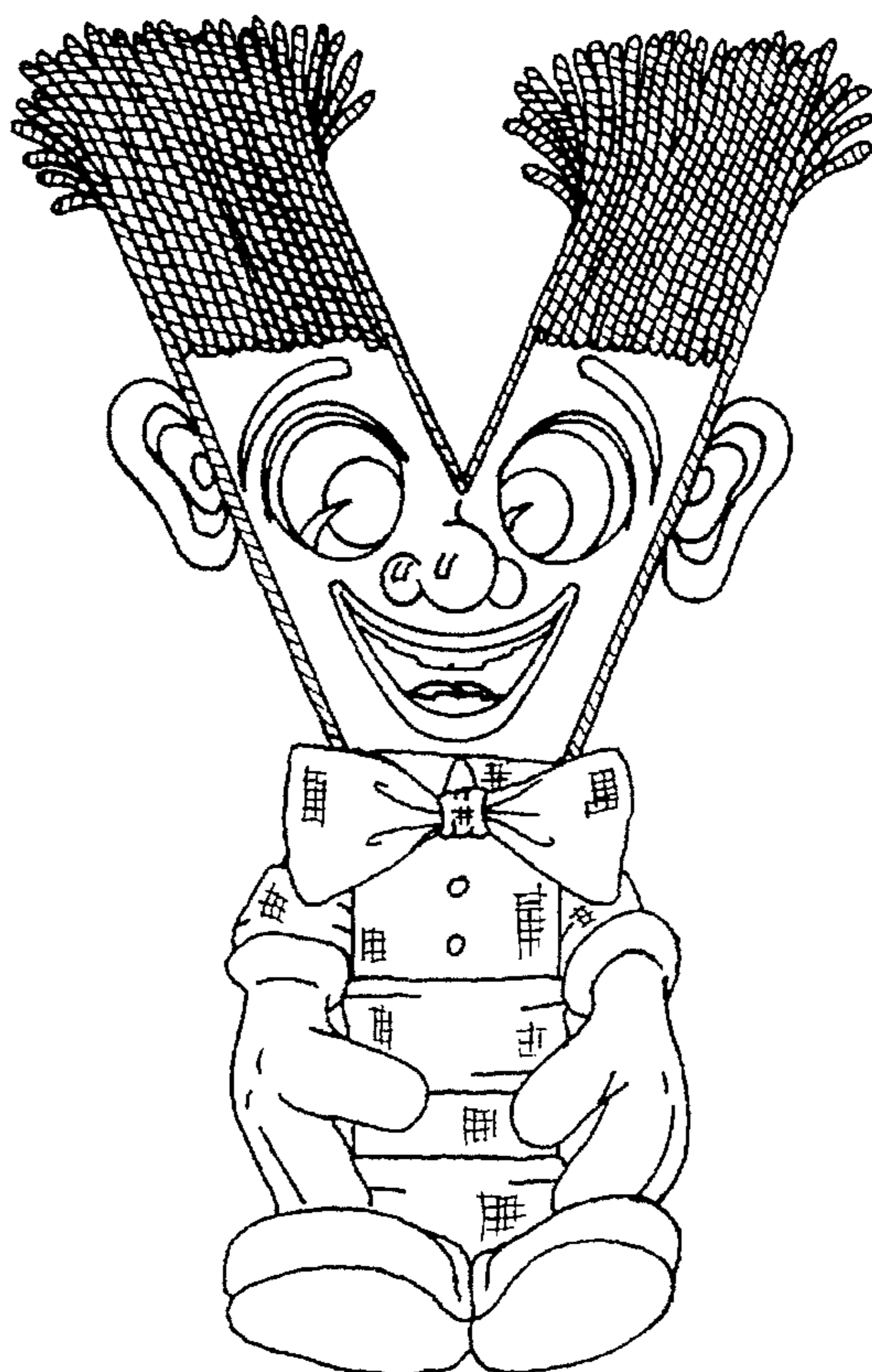

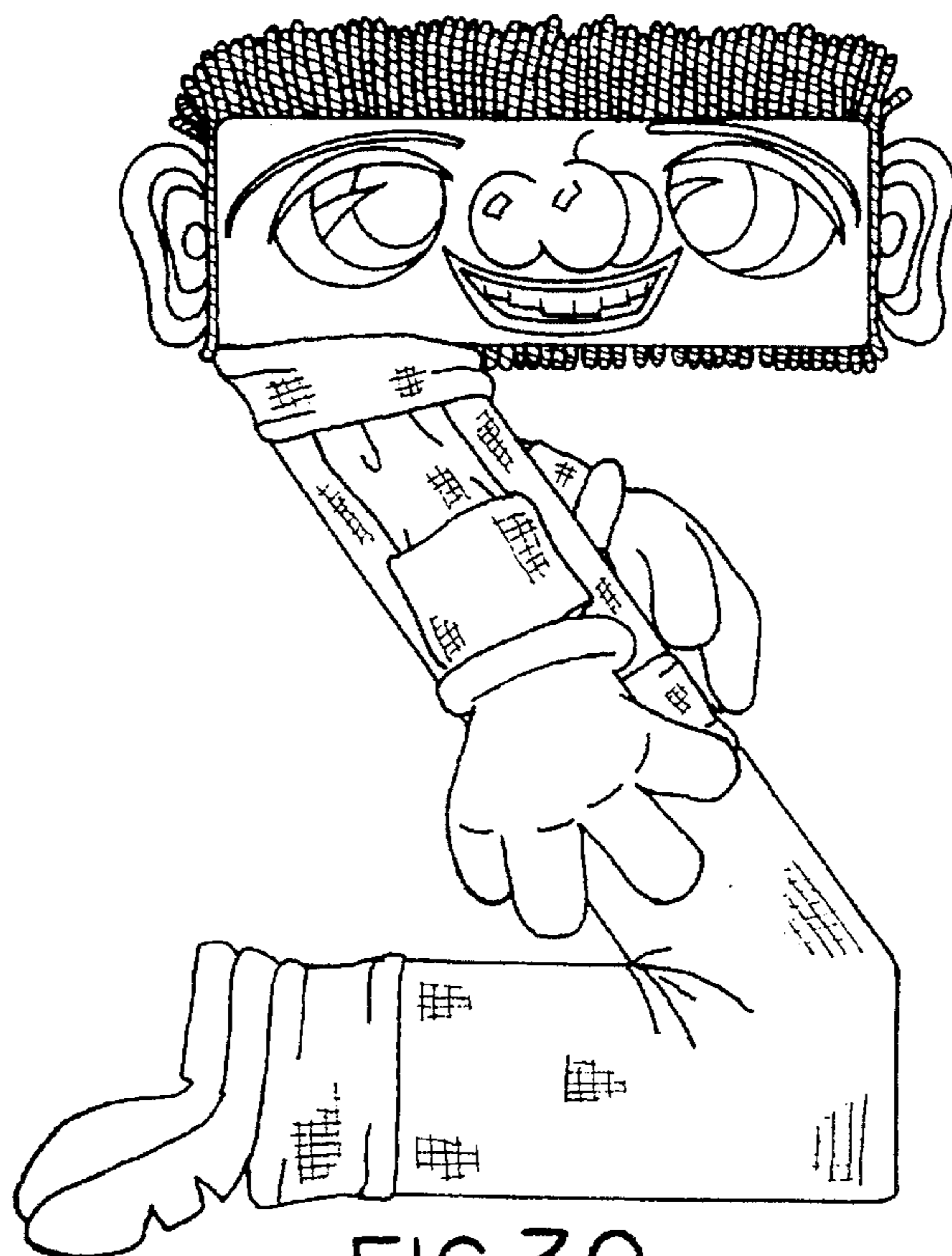
