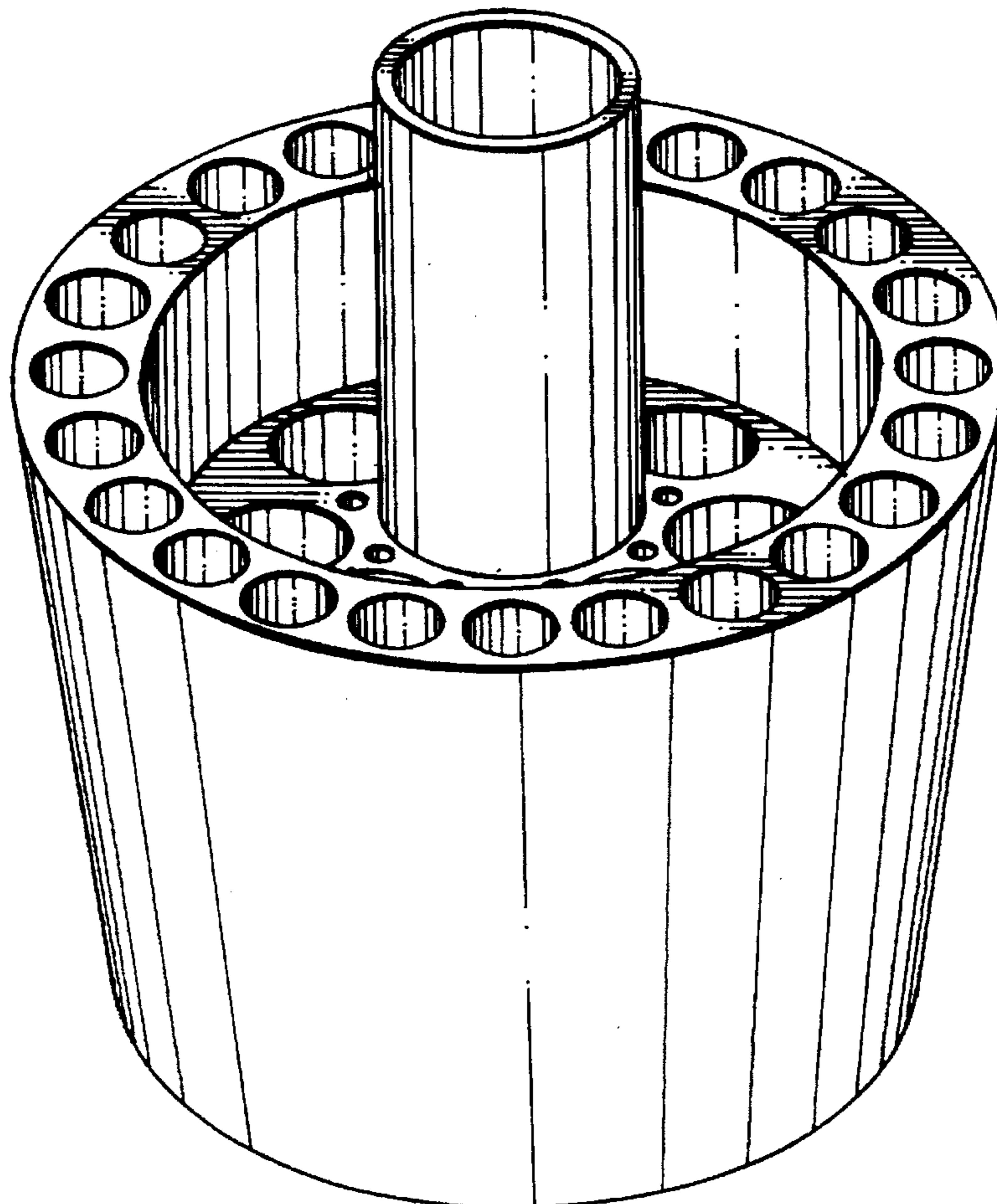
[57] **CLAIM**

The ornamental design for a tool holding bucket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and side perspective view of the tool holding bucket showing my new design;  
FIG. 2 is a front elevational view thereof, the back and sides being a mirror image of the front shown in FIG. 2;  
FIG. 3 is a top plan view thereof; and,  
FIG. 4 is a bottom plan view thereof.  
FIGS. 2-4 are shown at a reduced scale.

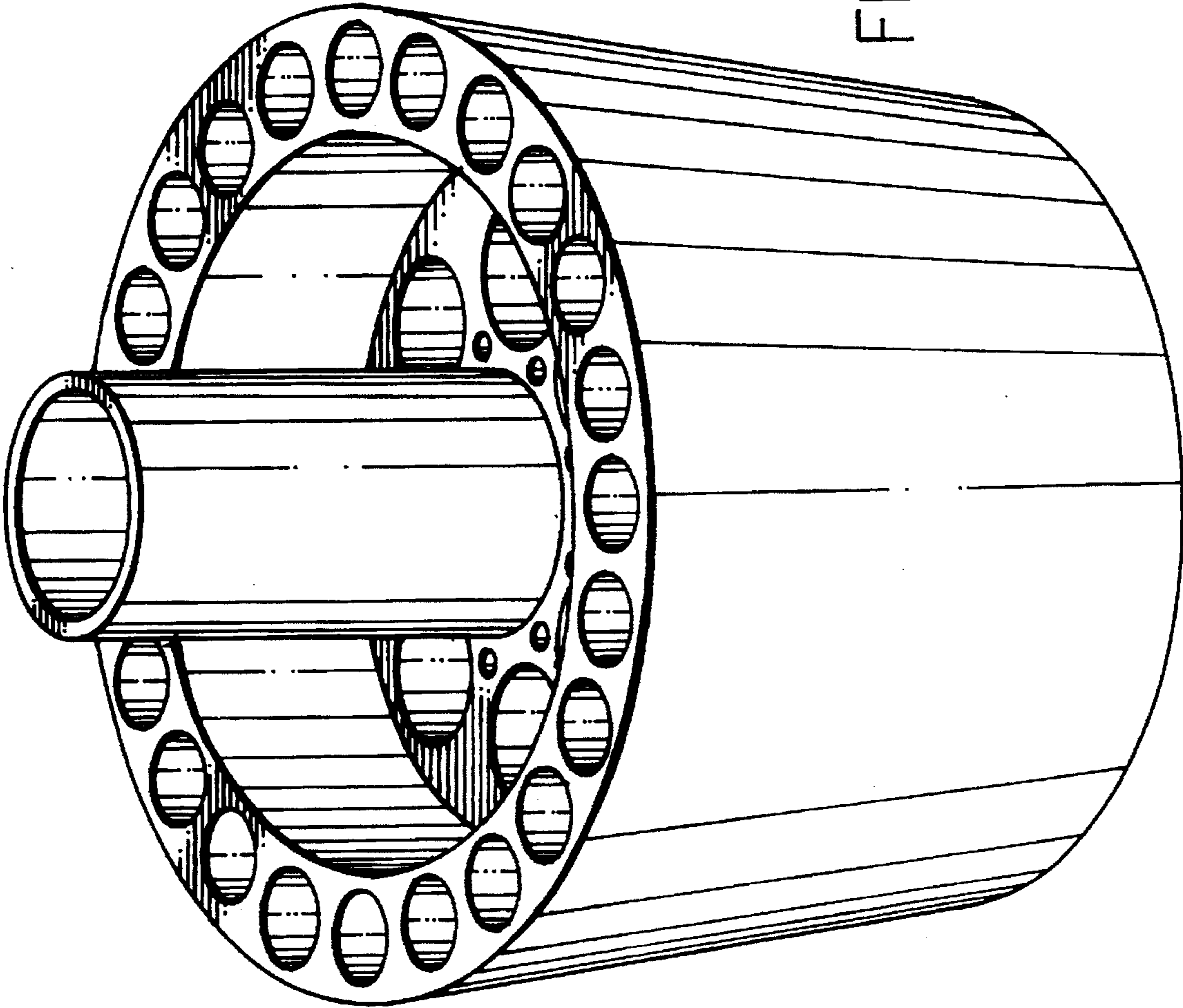

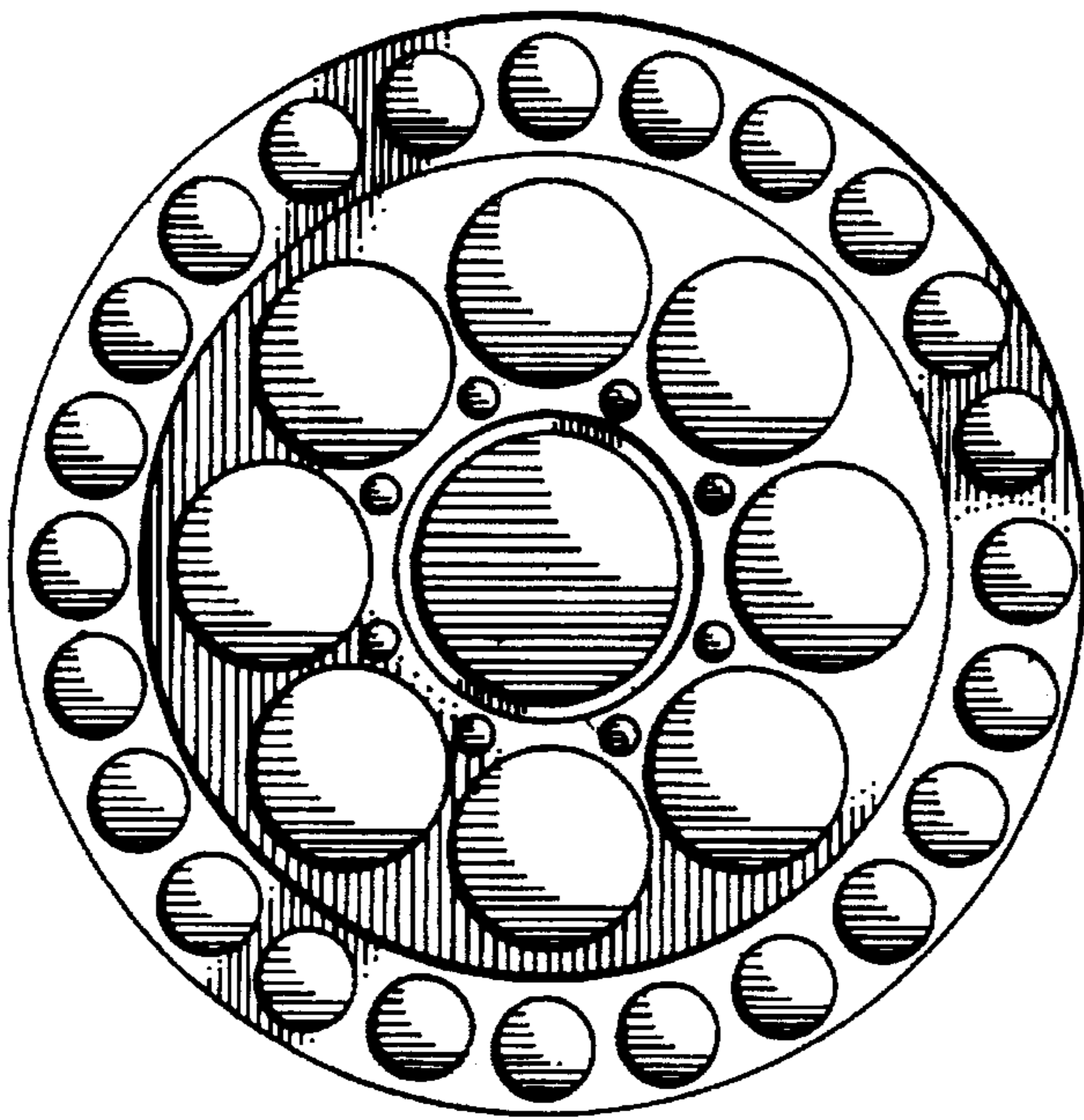

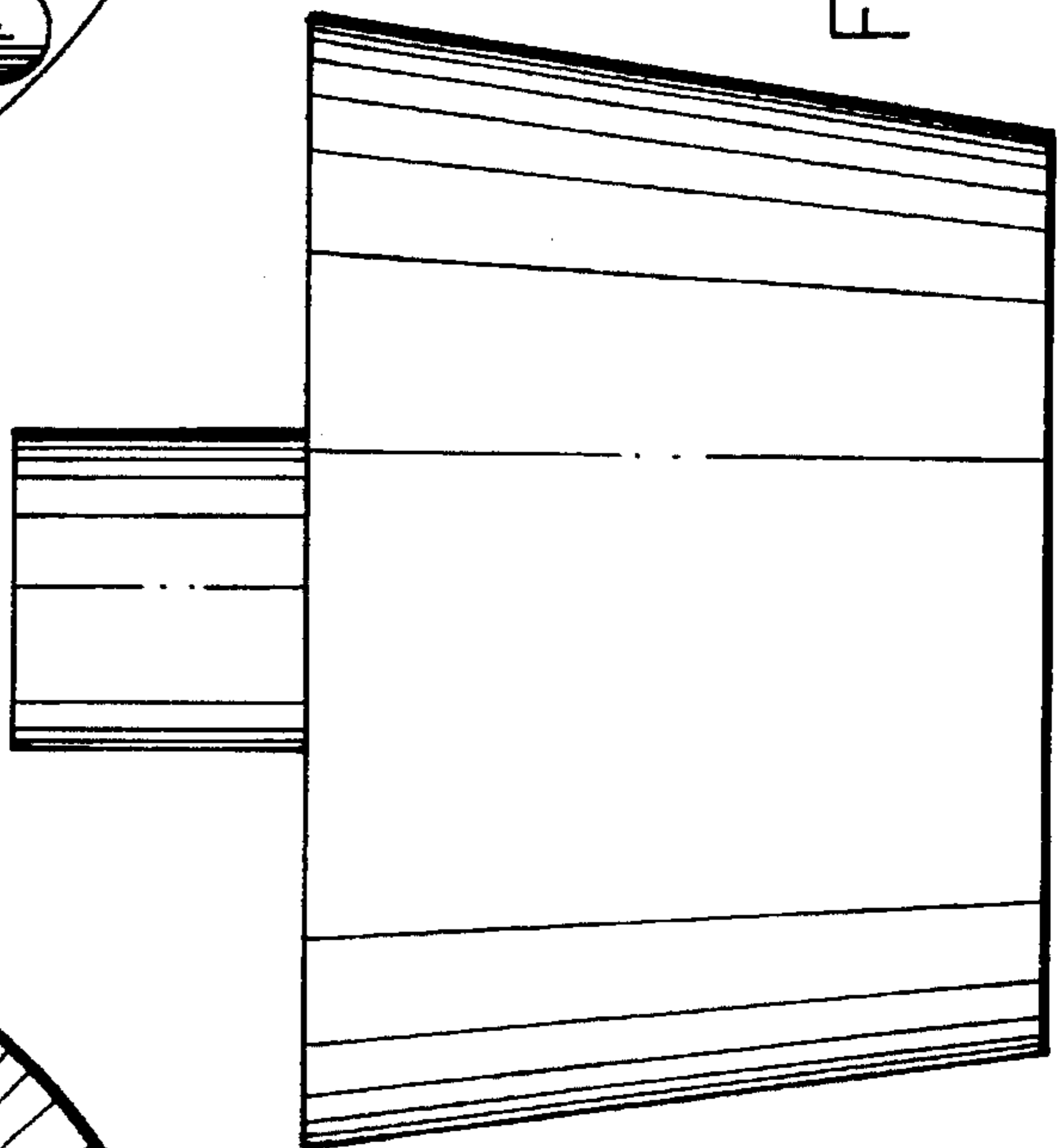
