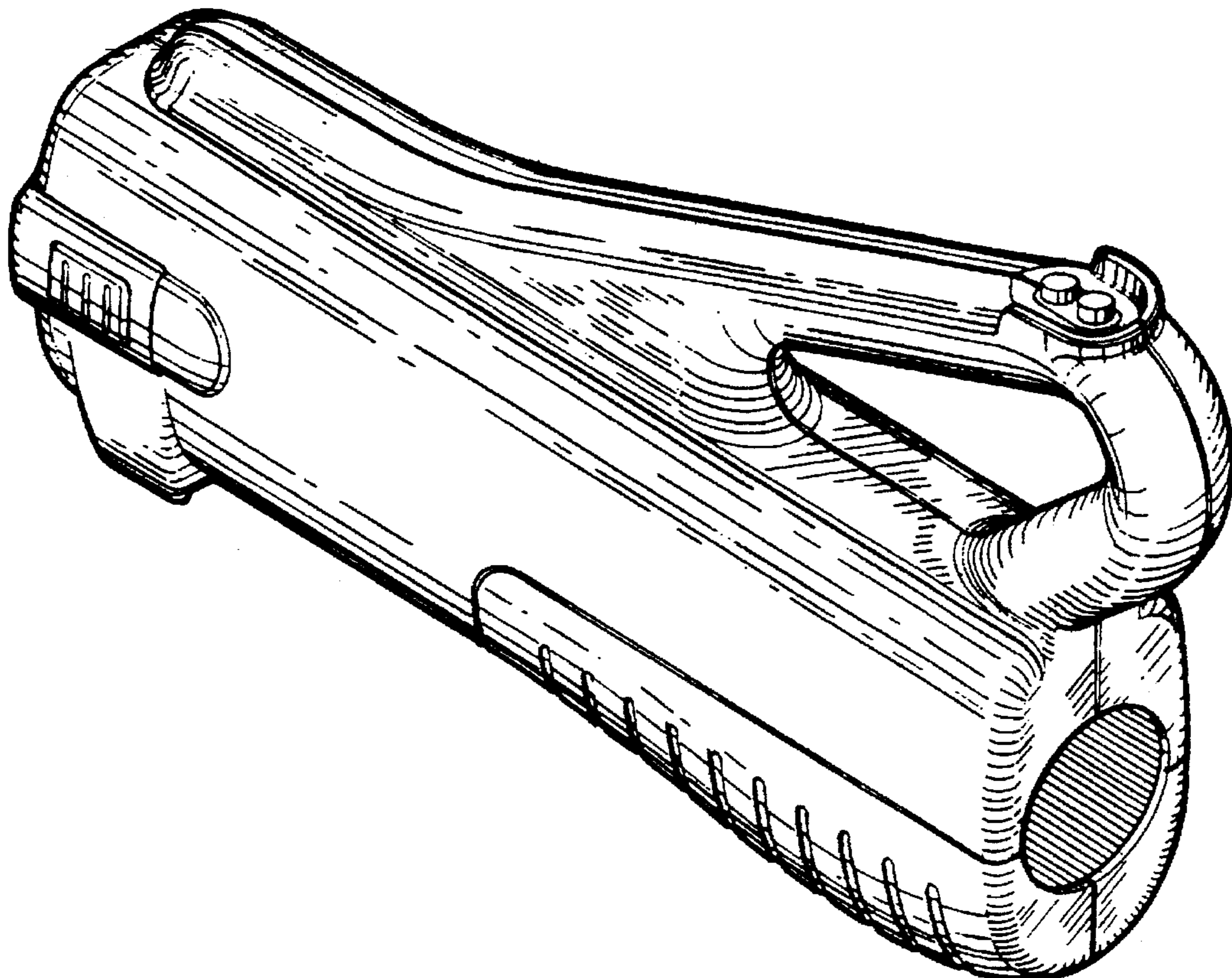
[57] **CLAIM**

The ornamental design for a portable crimper, as shown.

DESCRIPTION

FIG. 1 is a top front left perspective view of the portable crimper showing the design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front elevational view thereof; and,
FIG. 7 is a rear elevational view thereof.
The broken line showing of a crimper head is for illustrative purposes only and forms no part of the claimed design.

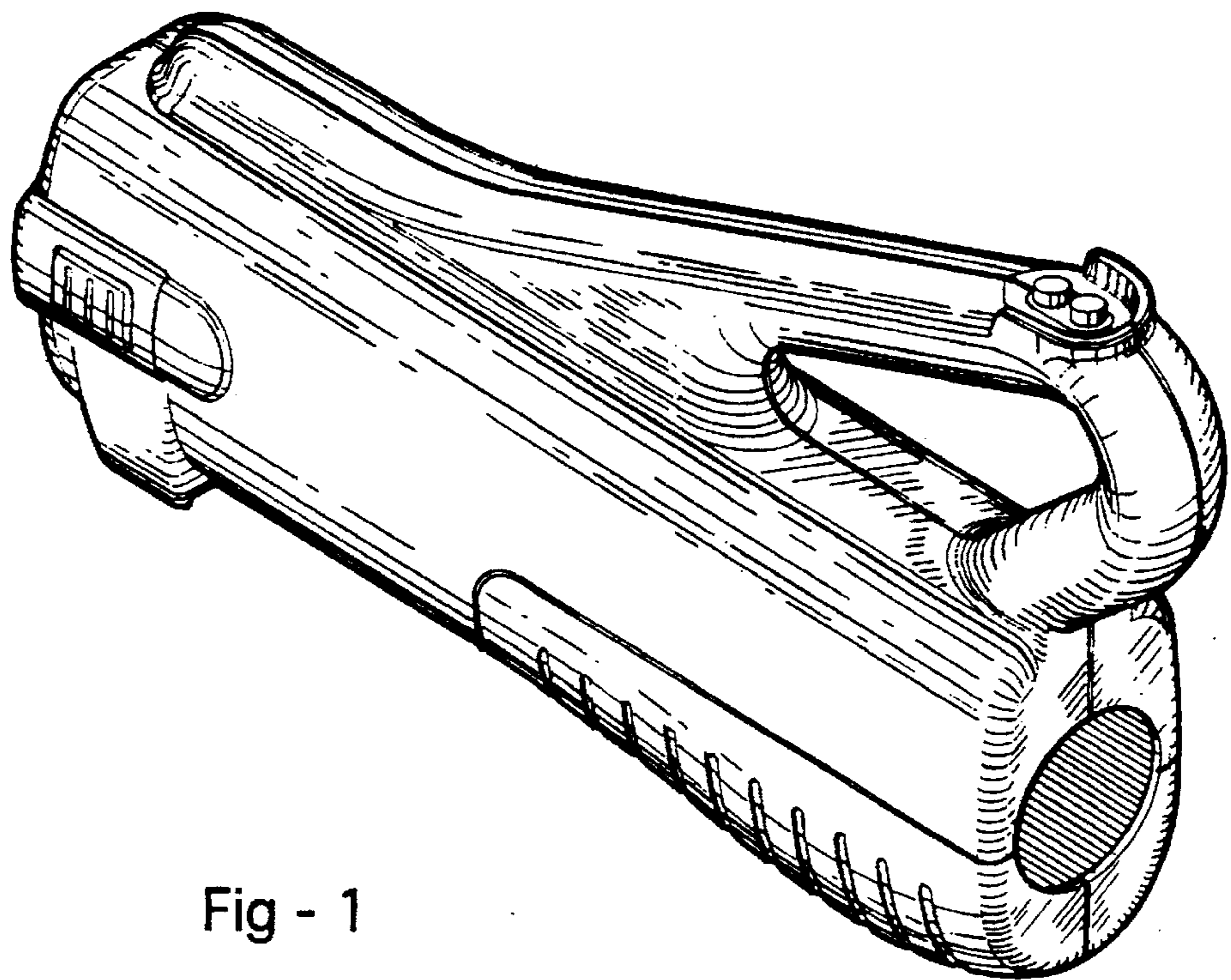

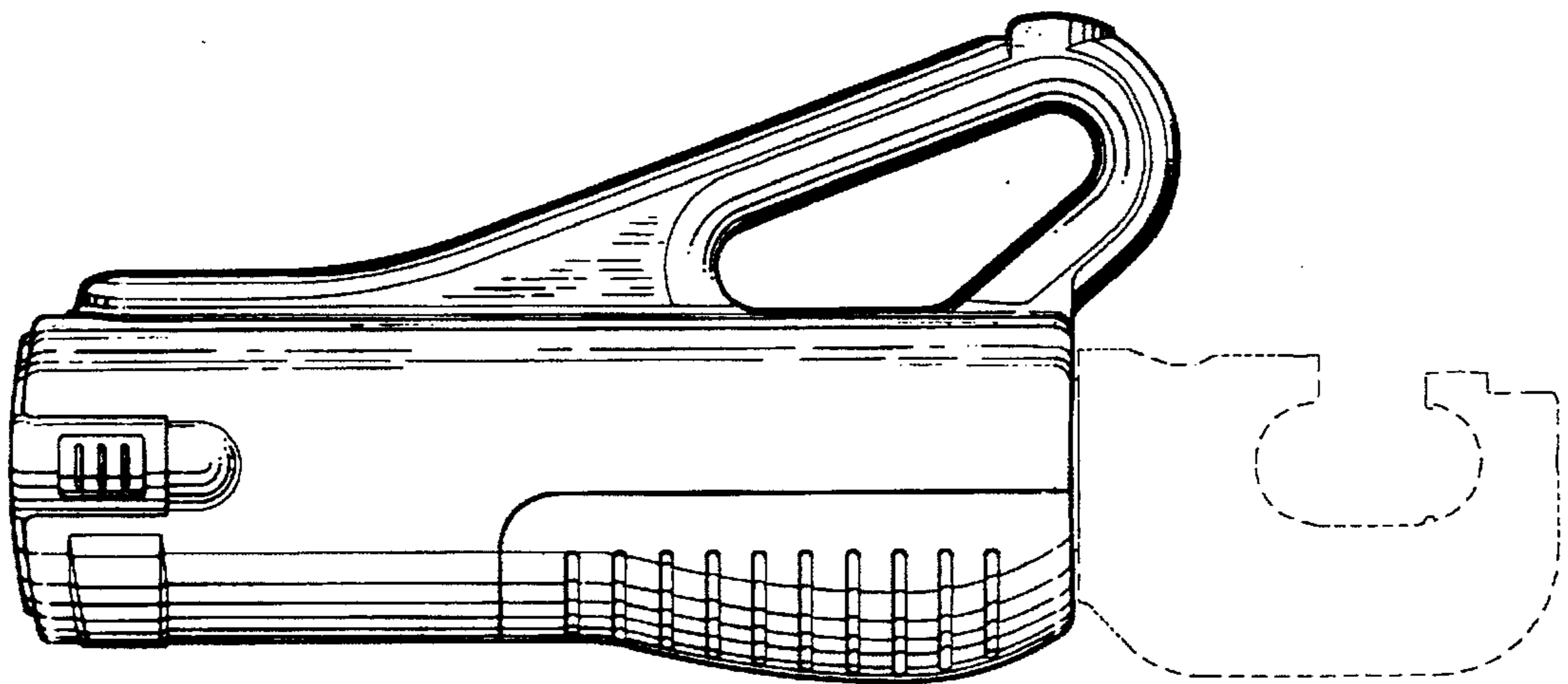

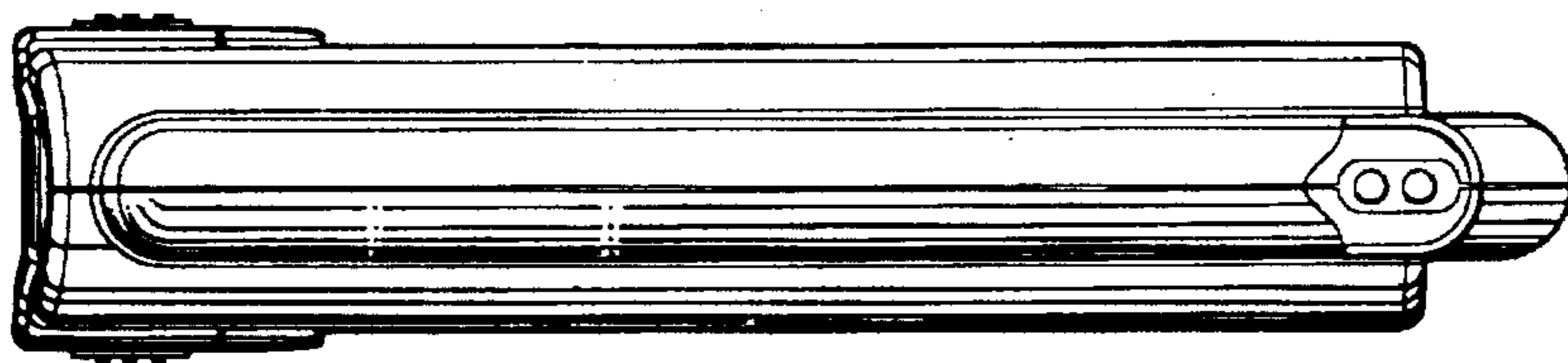

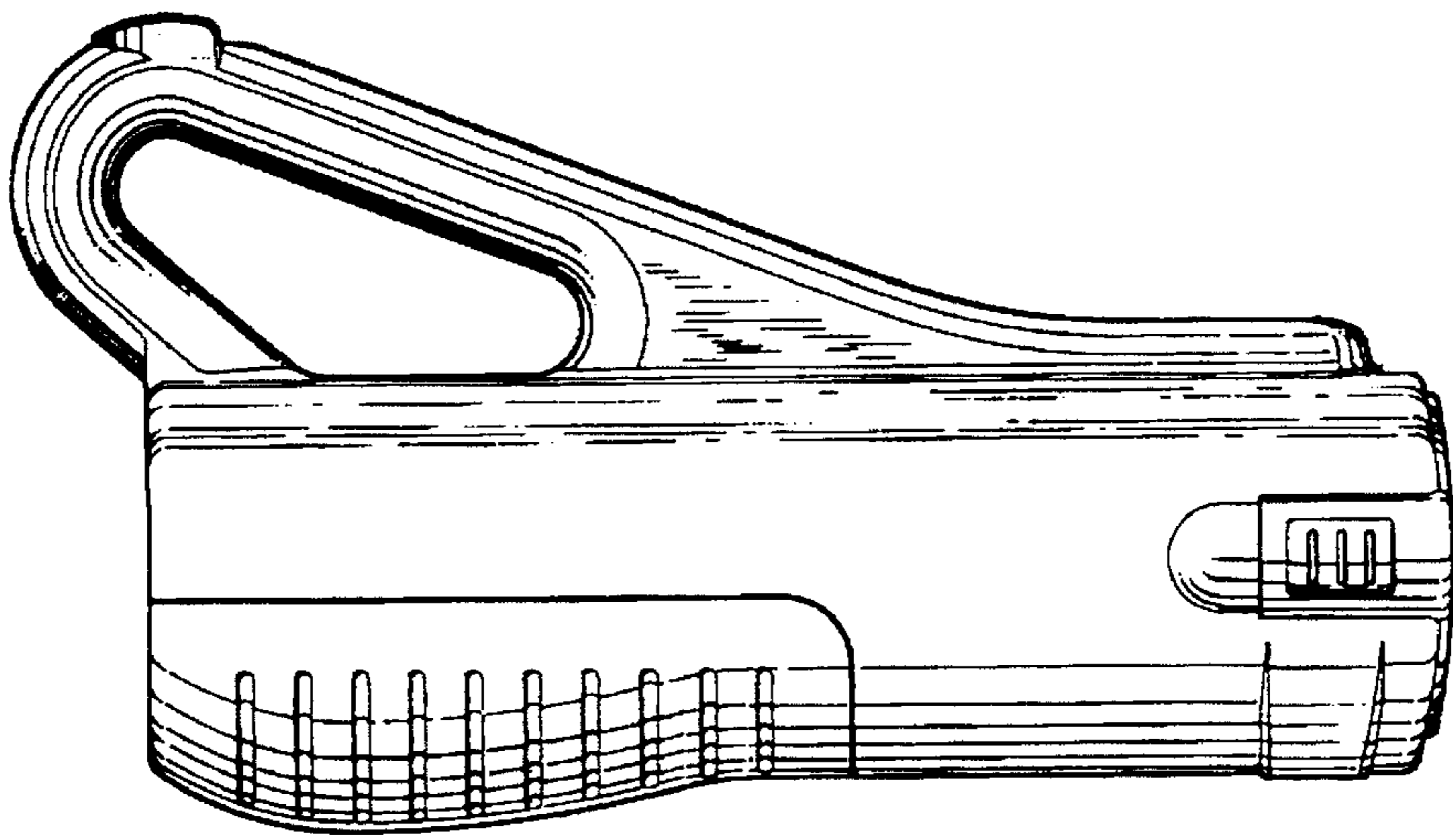

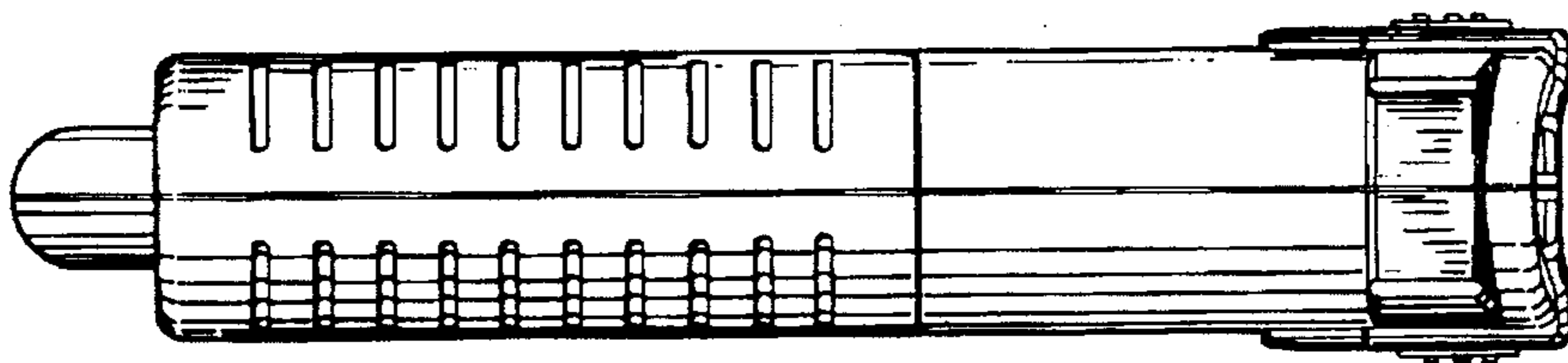

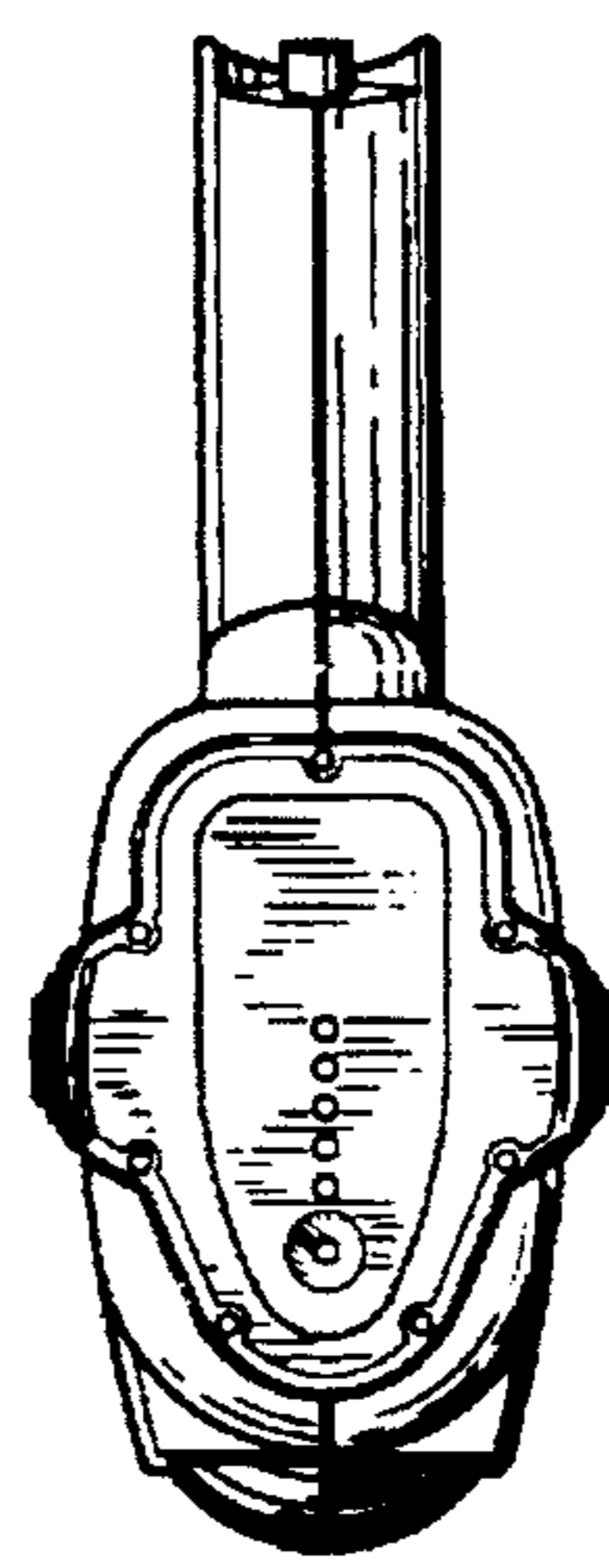
