[57] **CLAIM**

The ornamental design for a medical fluid drip container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a medical fluid drip container showing my new design;
FIG. 2 is a front elevational view of the drip container;
FIG. 3 is a left side elevational view of the drip container; the right side elevational view being identical;
FIG. 4 is a rear elevational view of the drip container;
FIG. 5 is a top plan view of the drip container; and,
FIG. 6 is a bottom plan view of the drip container.

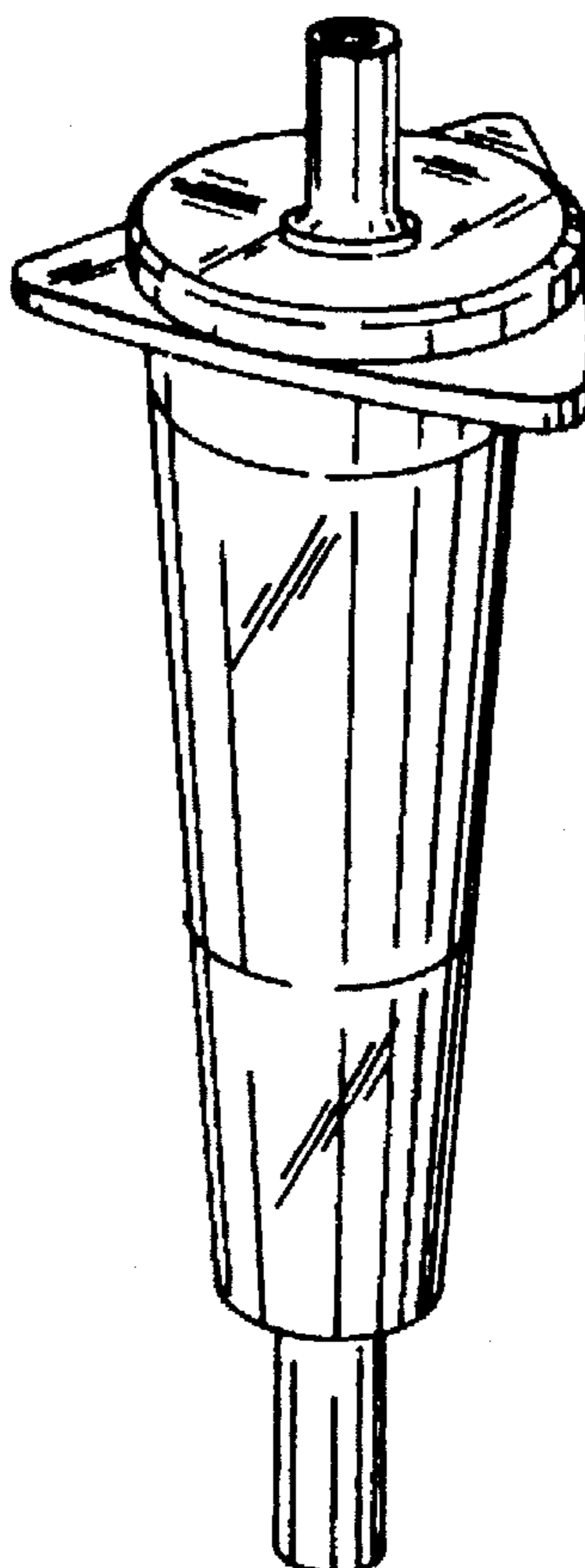

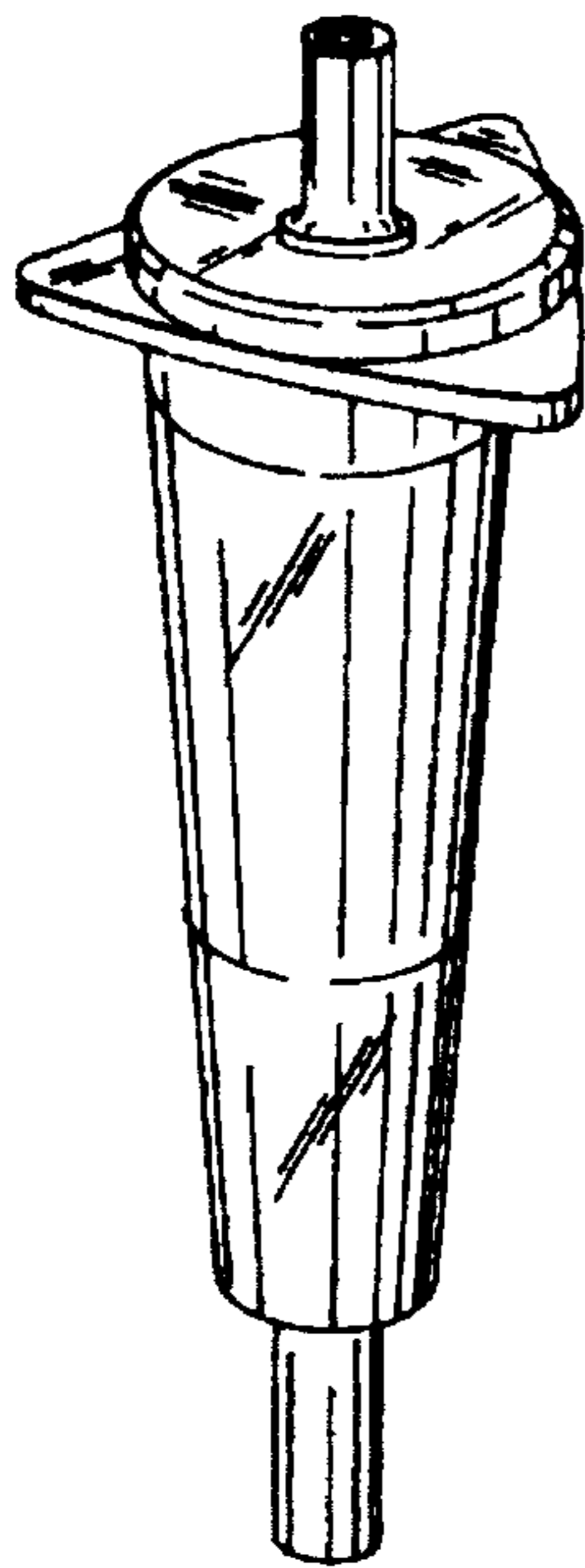

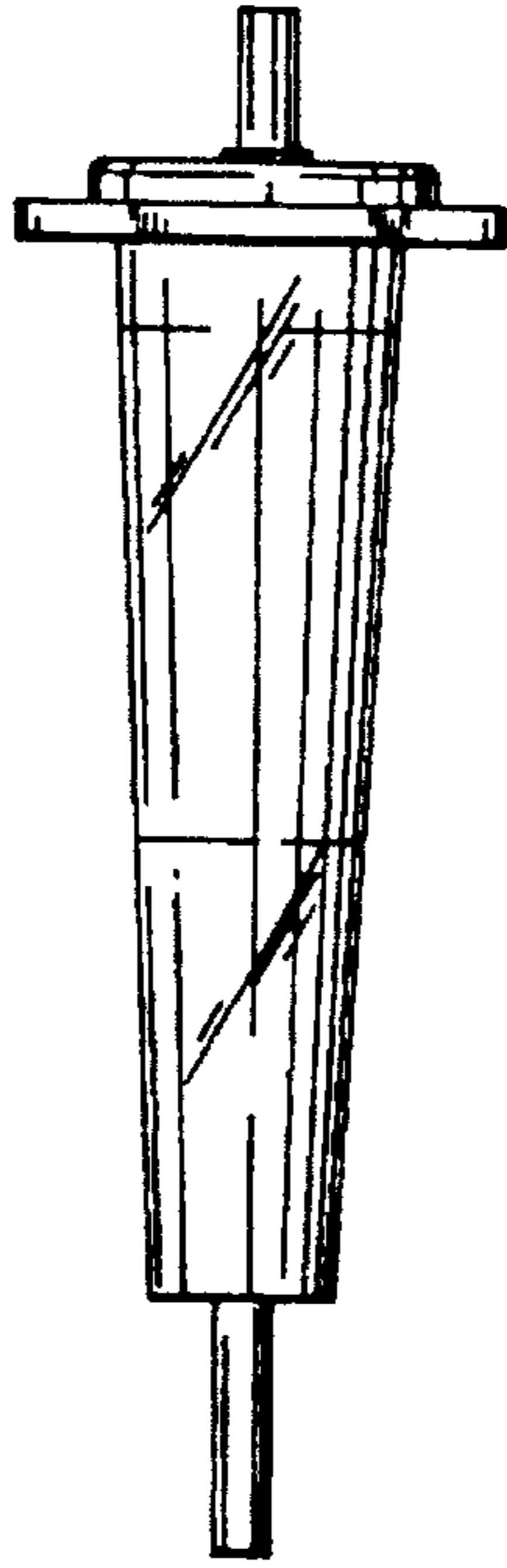

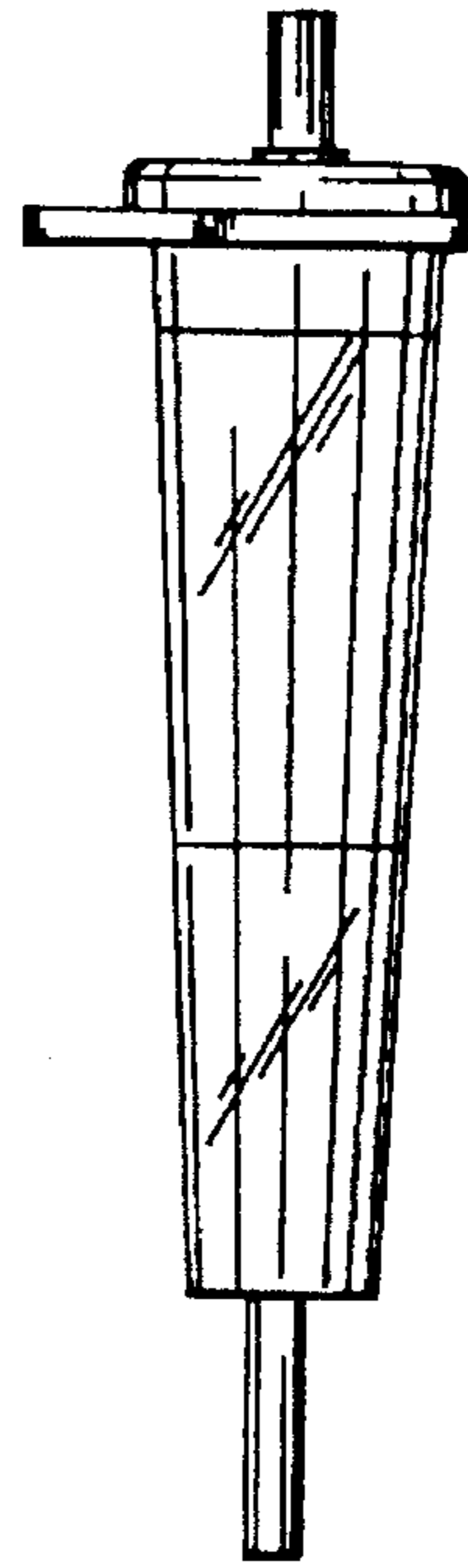

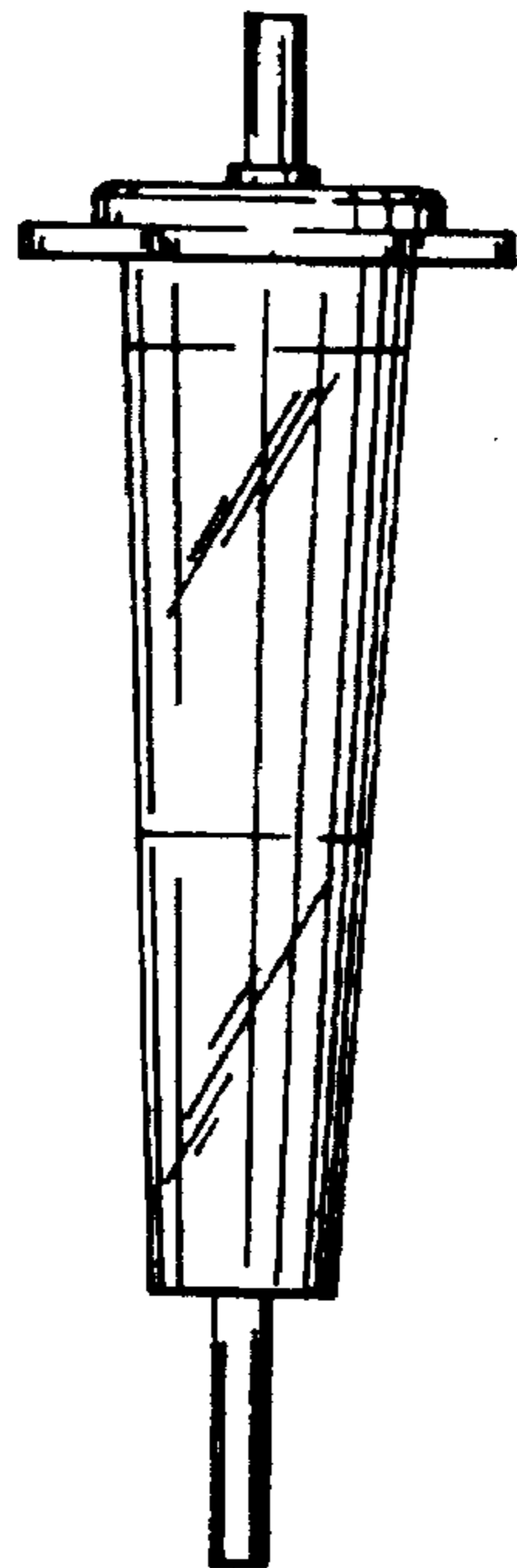

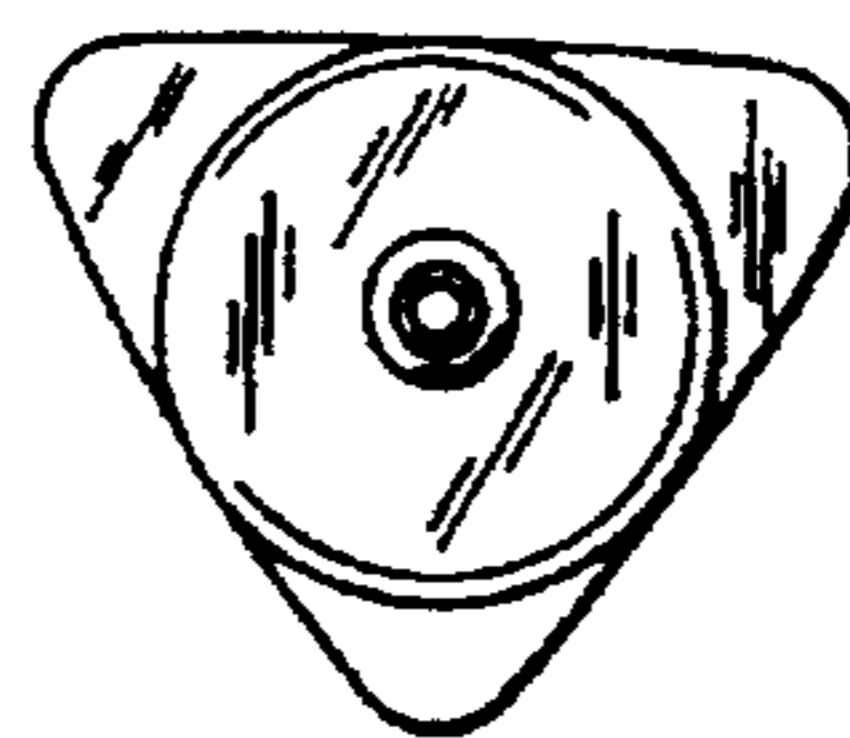
