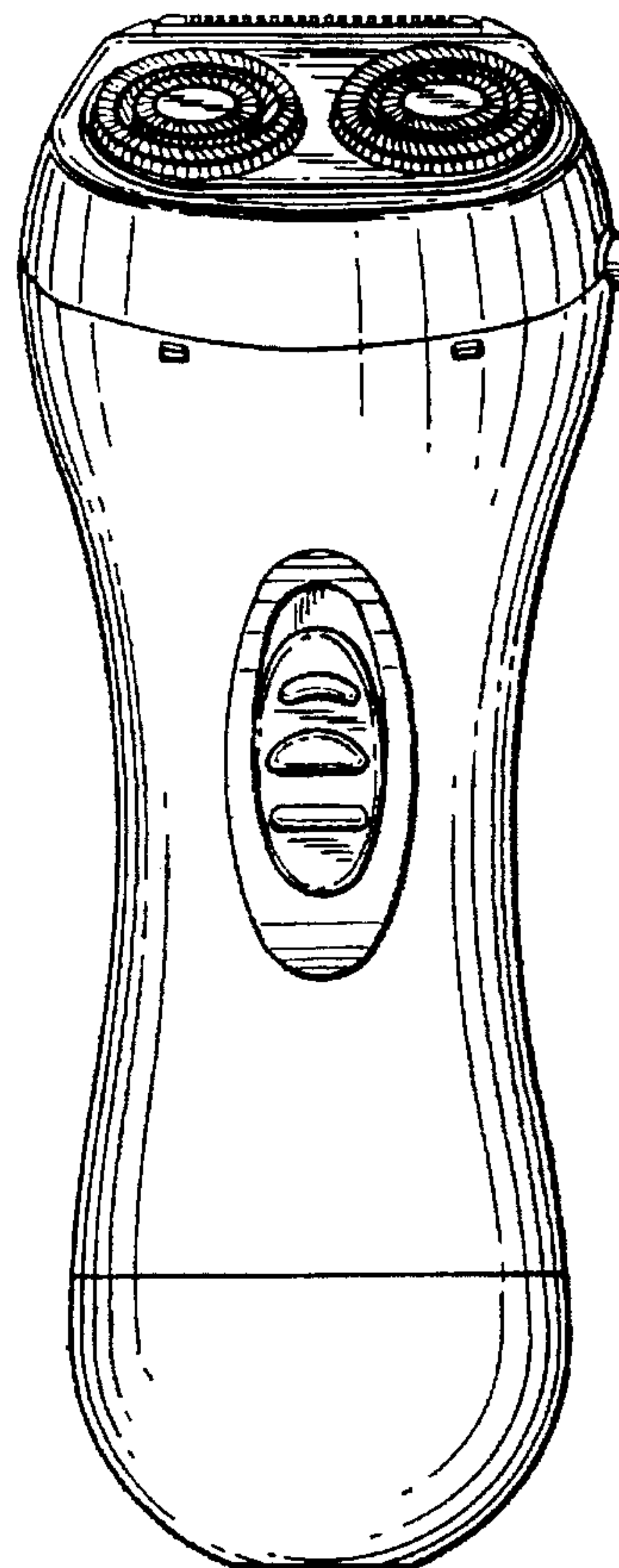
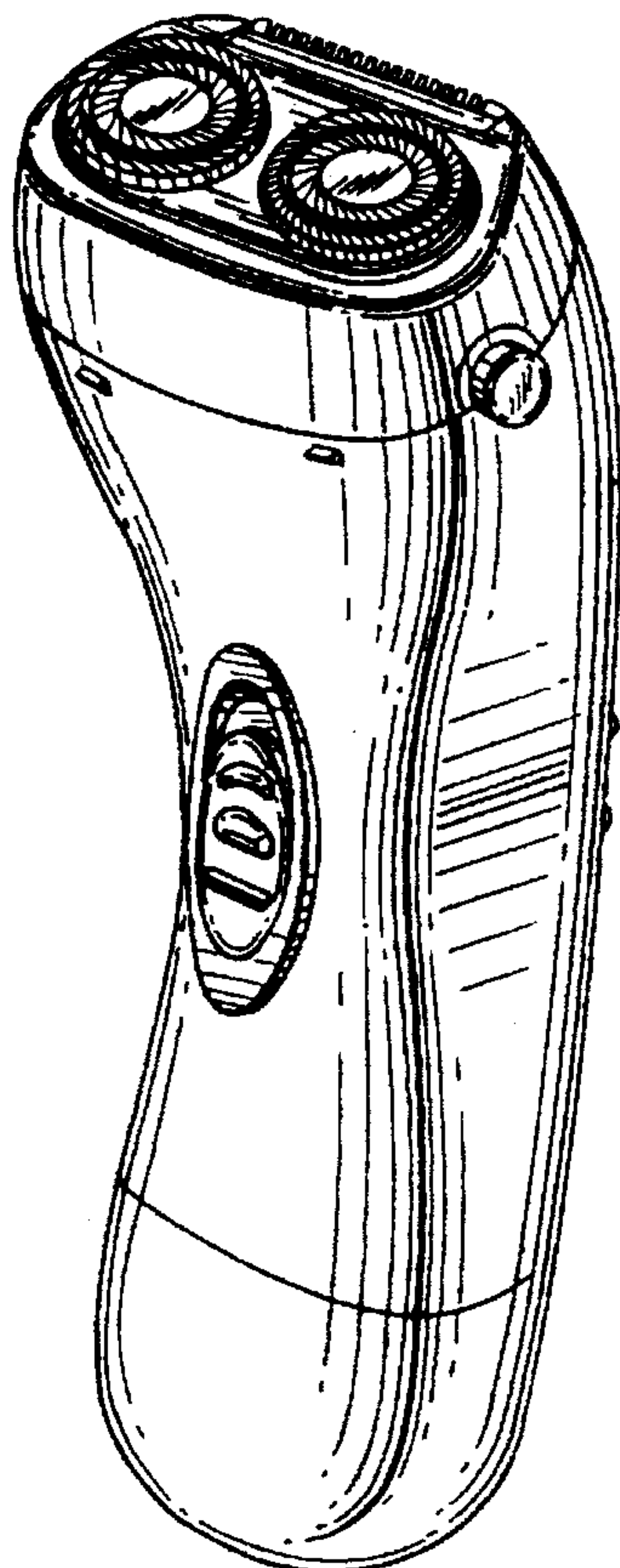
[57] **CLAIM**

The ornamental design for a ladies' rotary shaver, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the ladies' rotary shaver showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a side elevational view, looking from the right side of FIG. 3;  
 FIG. 5 is a side elevational view, looking from the left side of FIG. 3;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a front elevational view of an alternate embodiment of the ladies' rotary shaver showing my new design;  
 FIG. 9 is a side elevational view, looking from the right side of FIG. 8;

 FIG. 11 is a rear elevational view thereof; and,

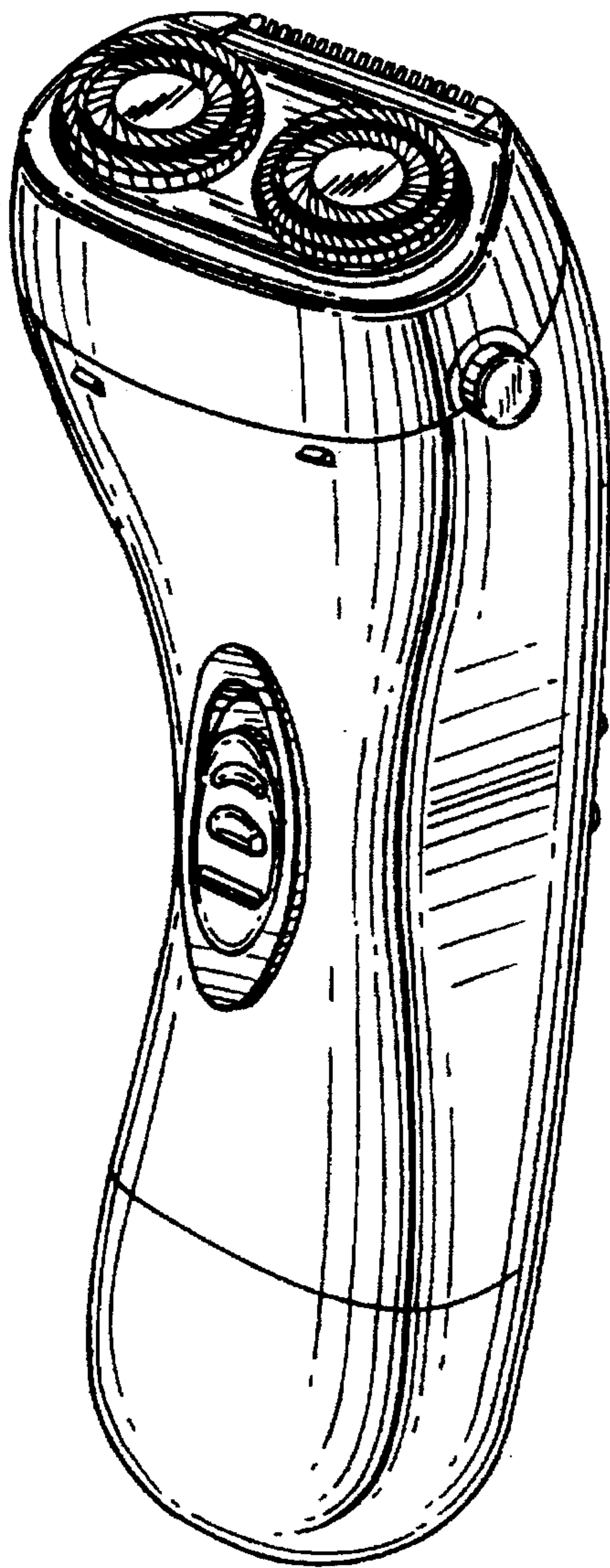

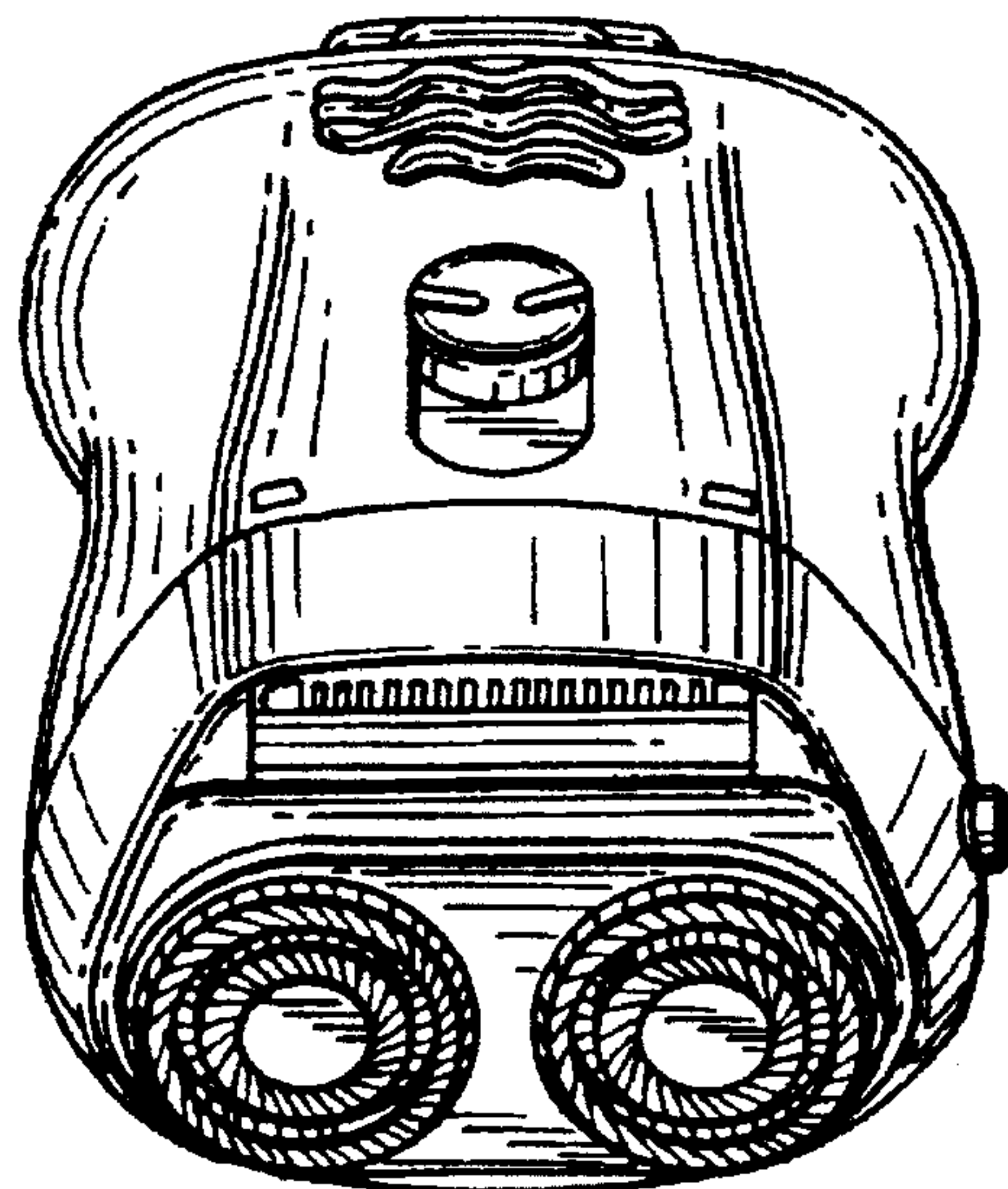

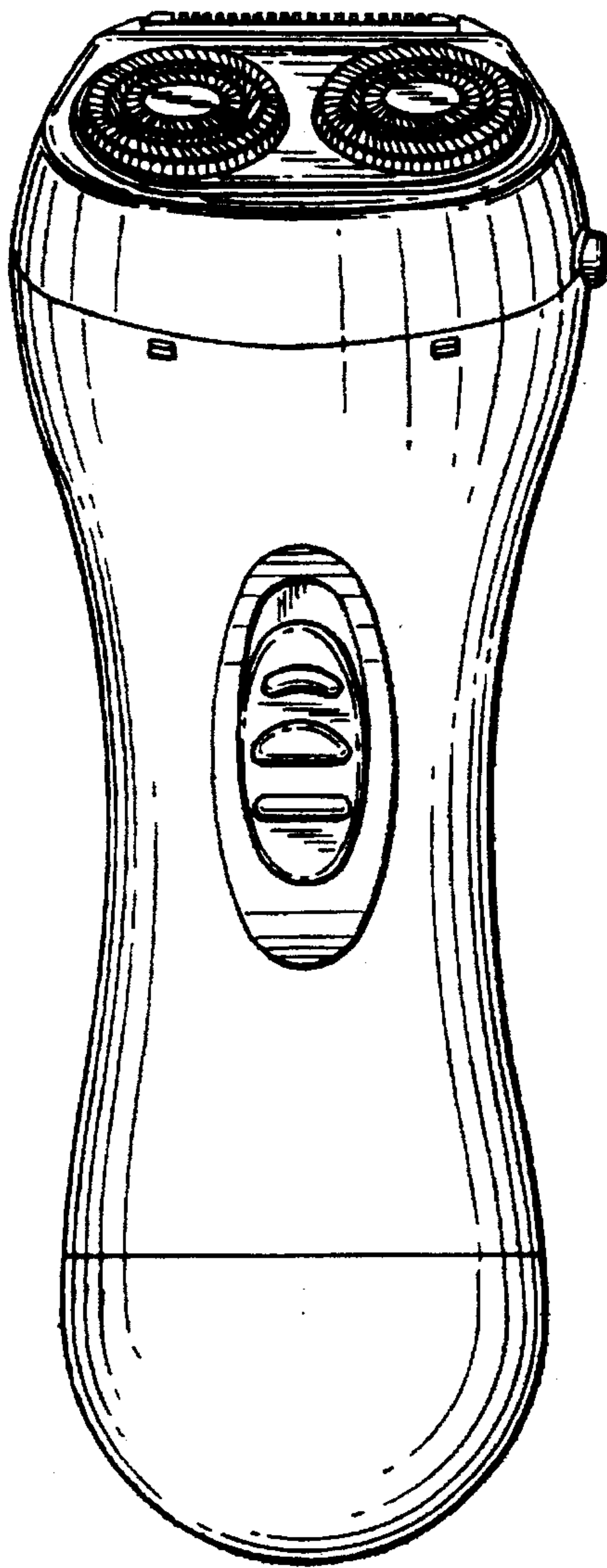

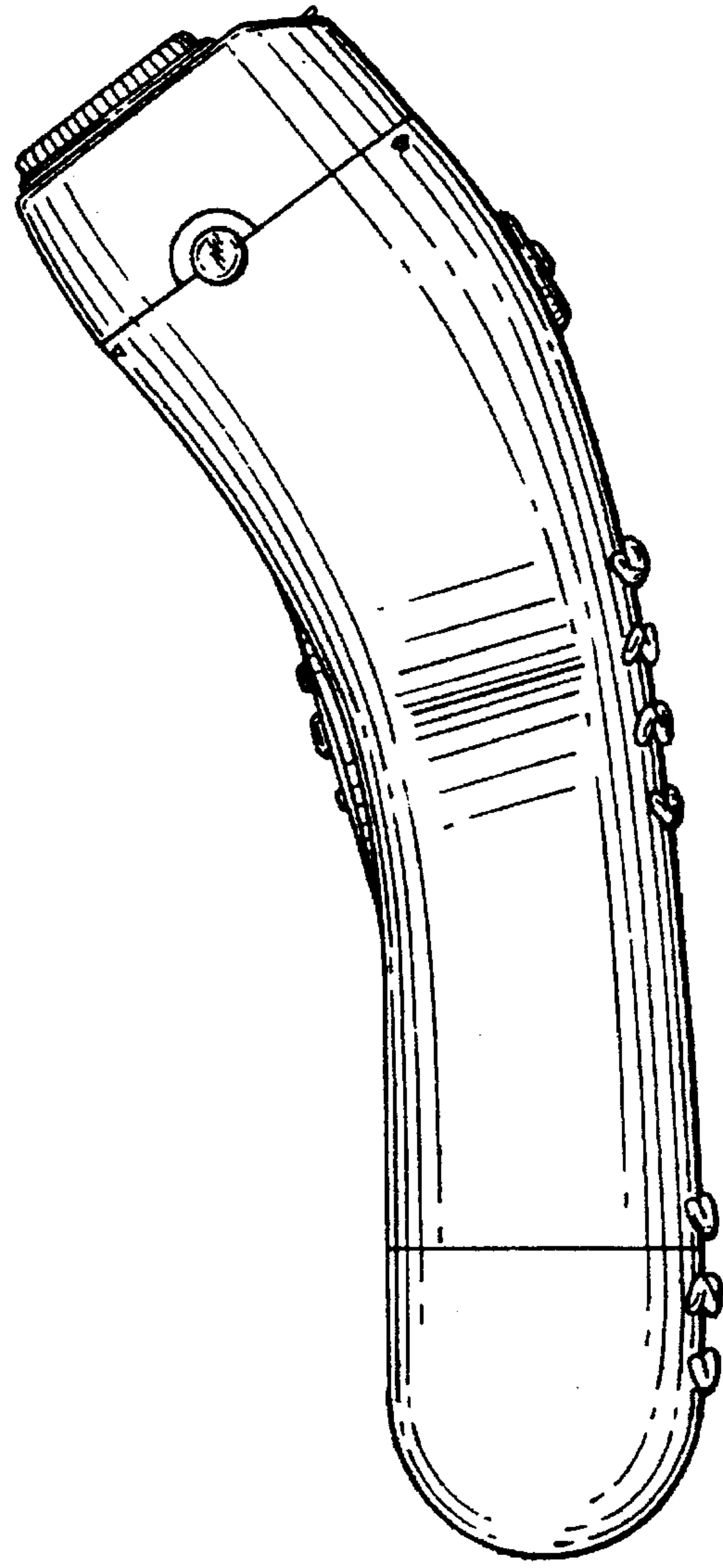

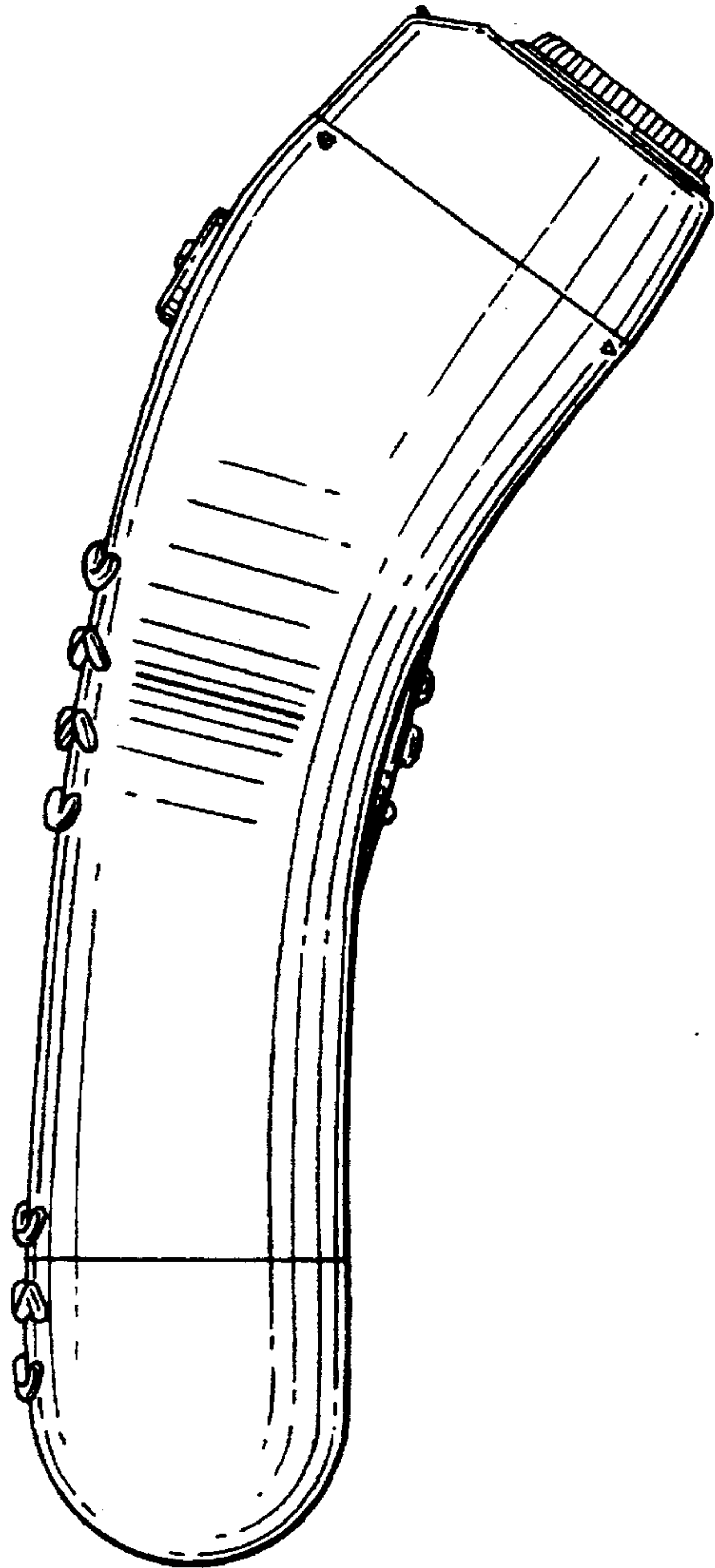

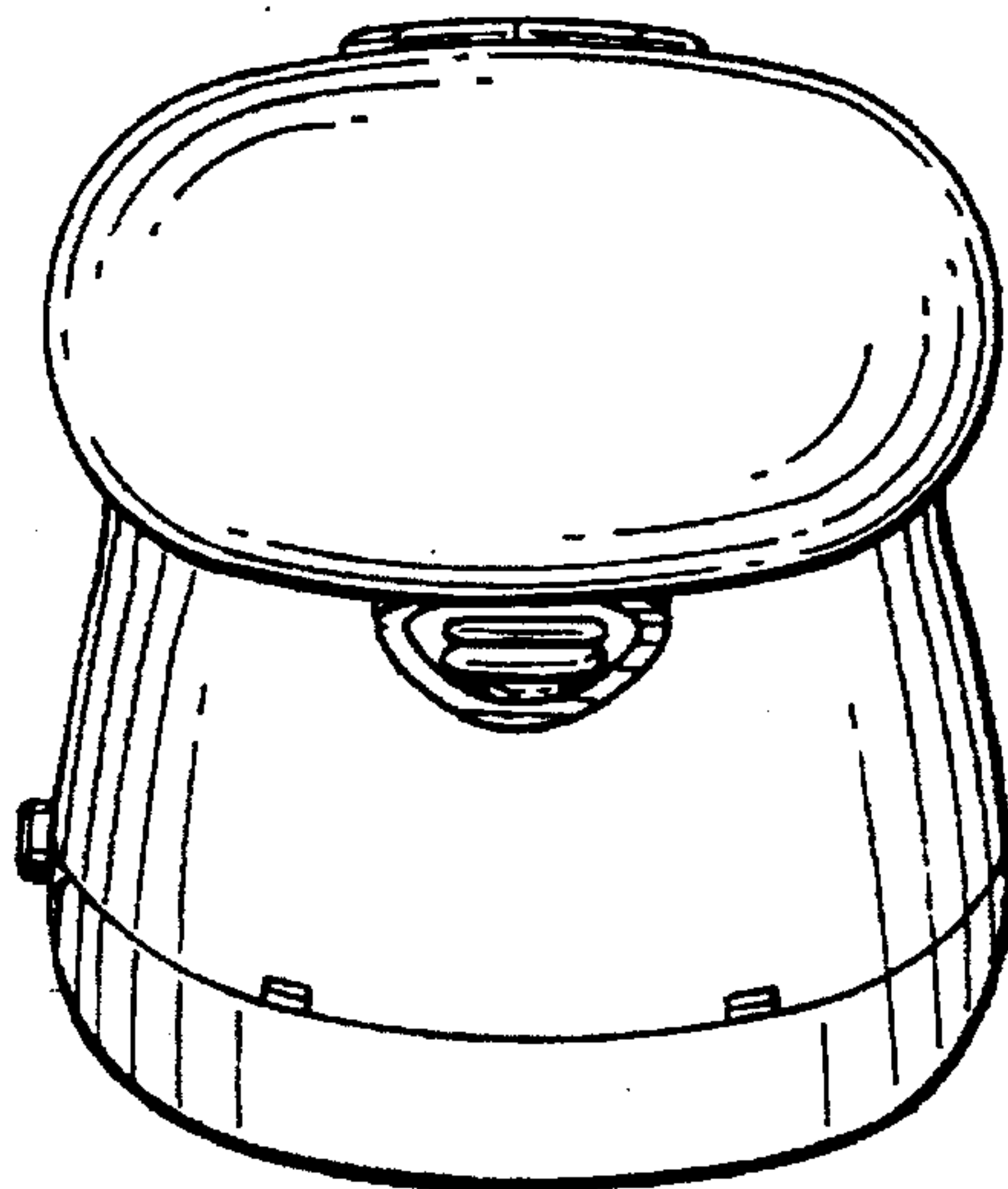
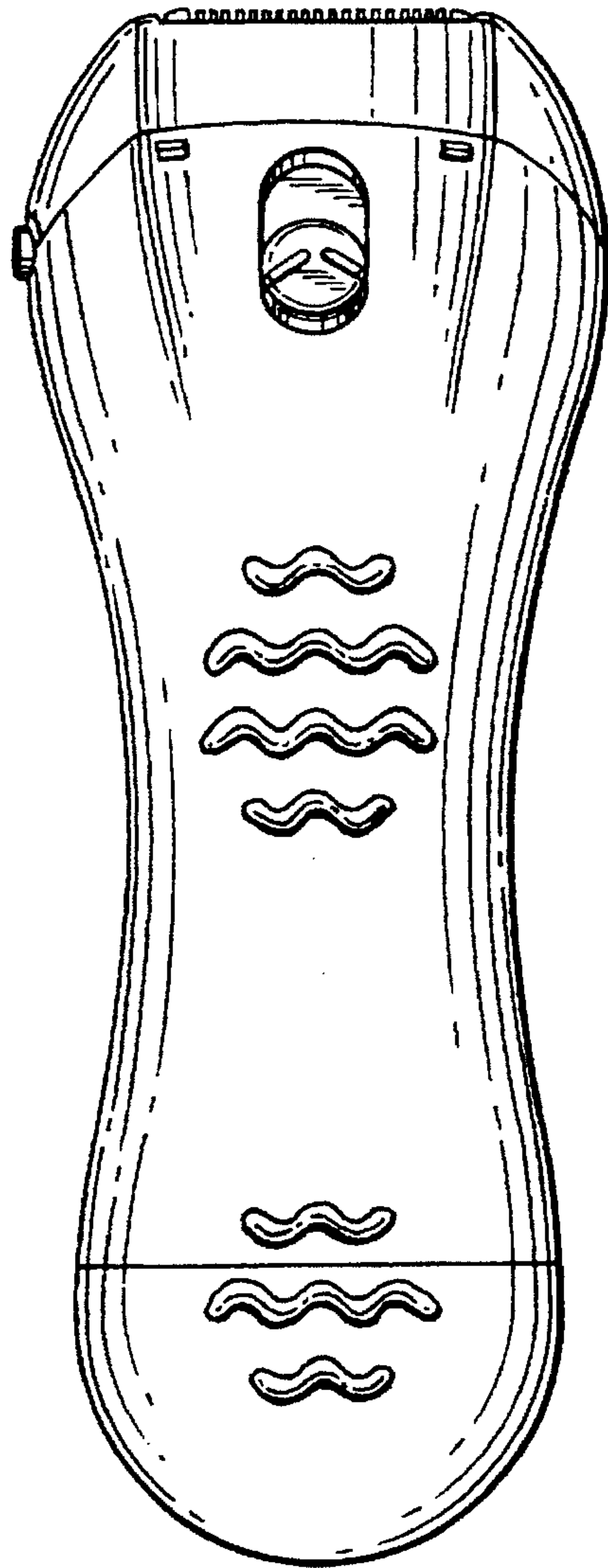

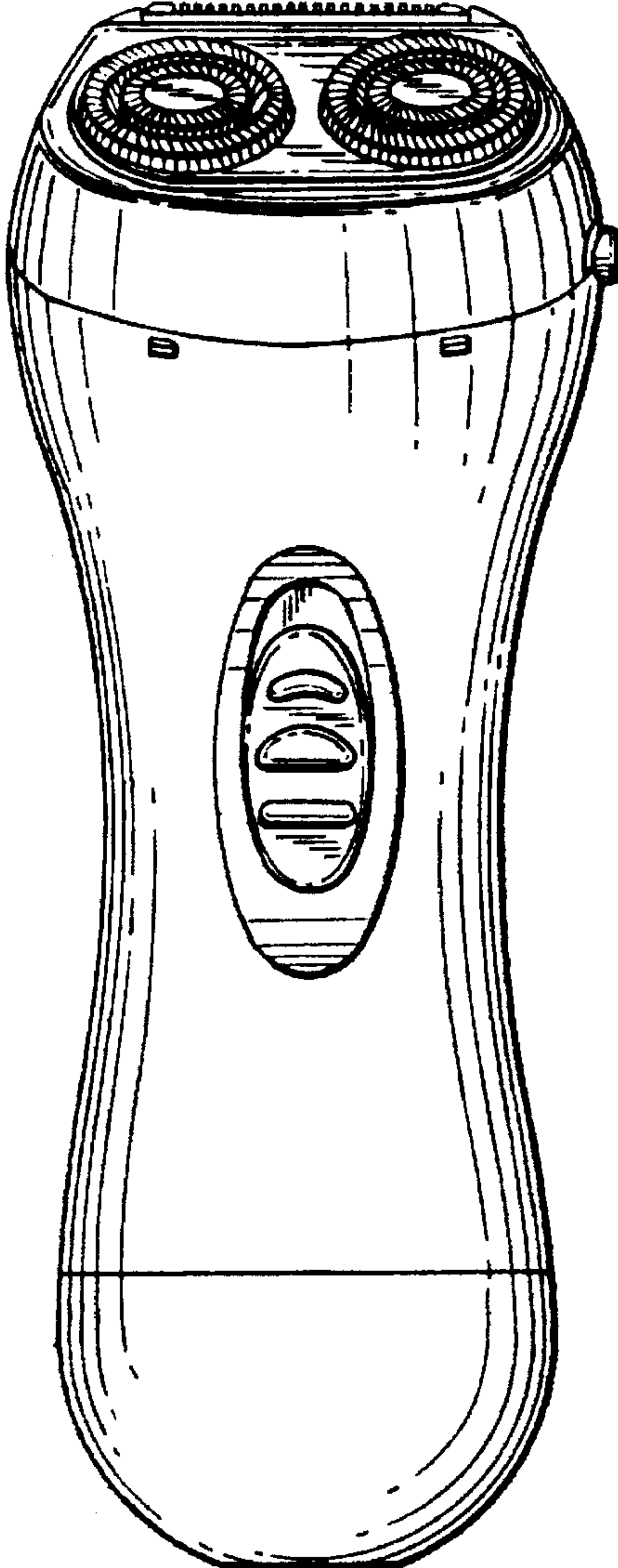

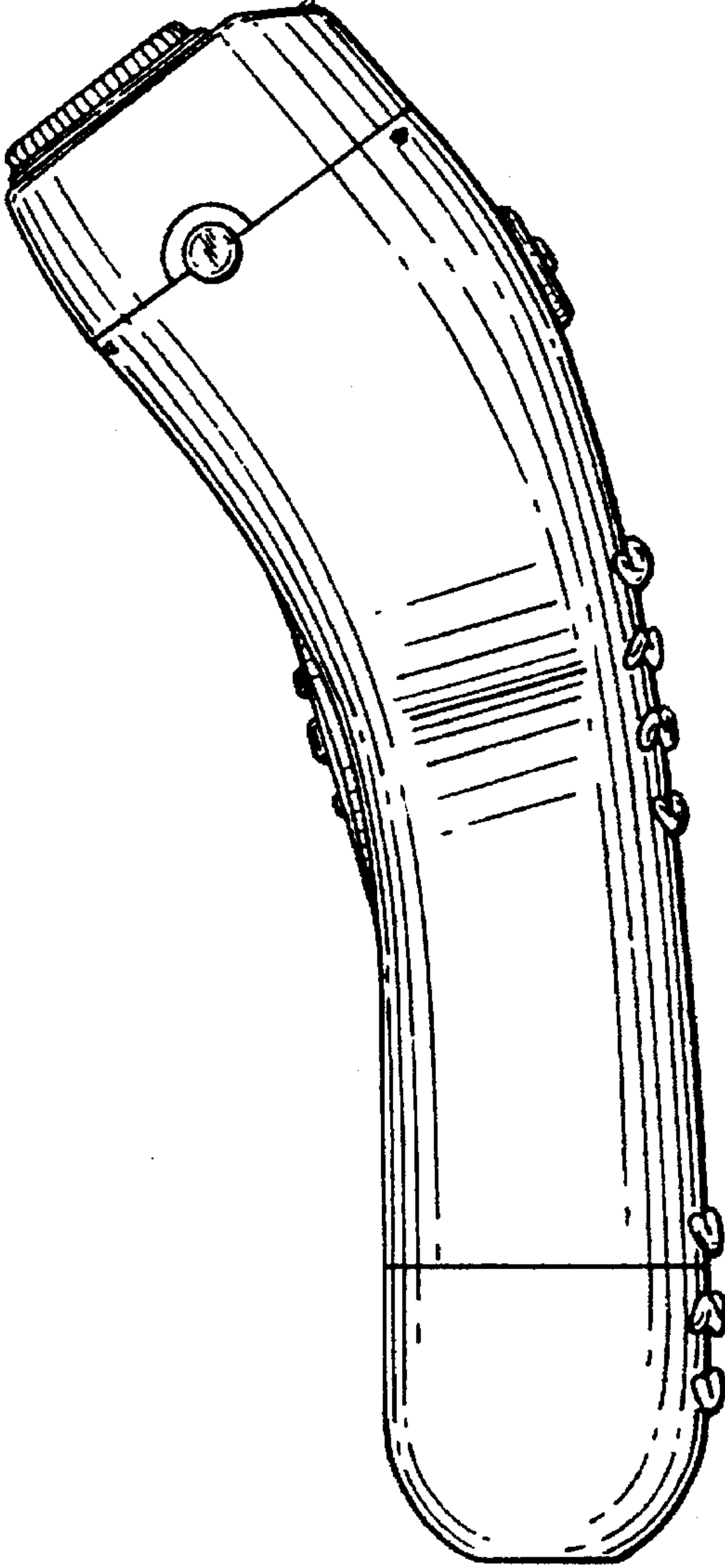

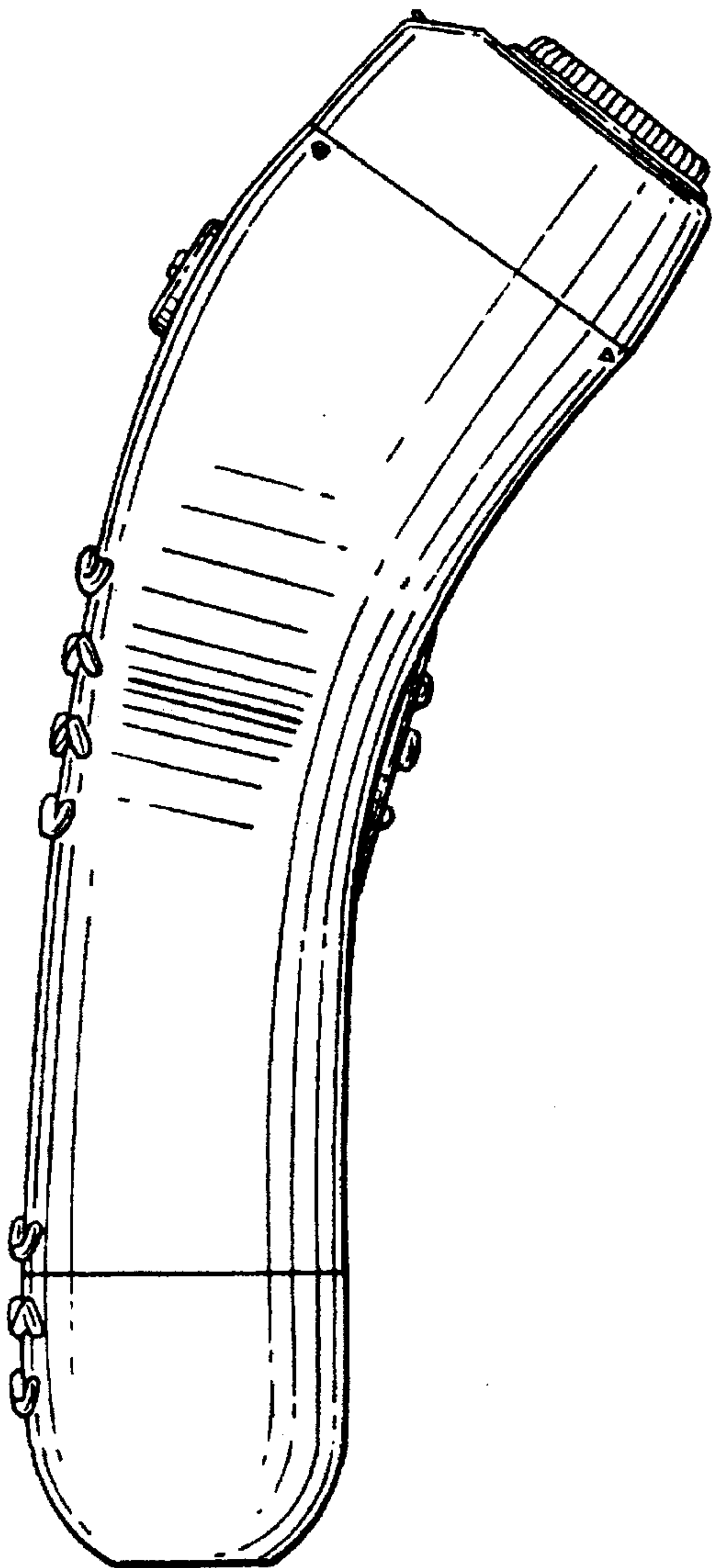

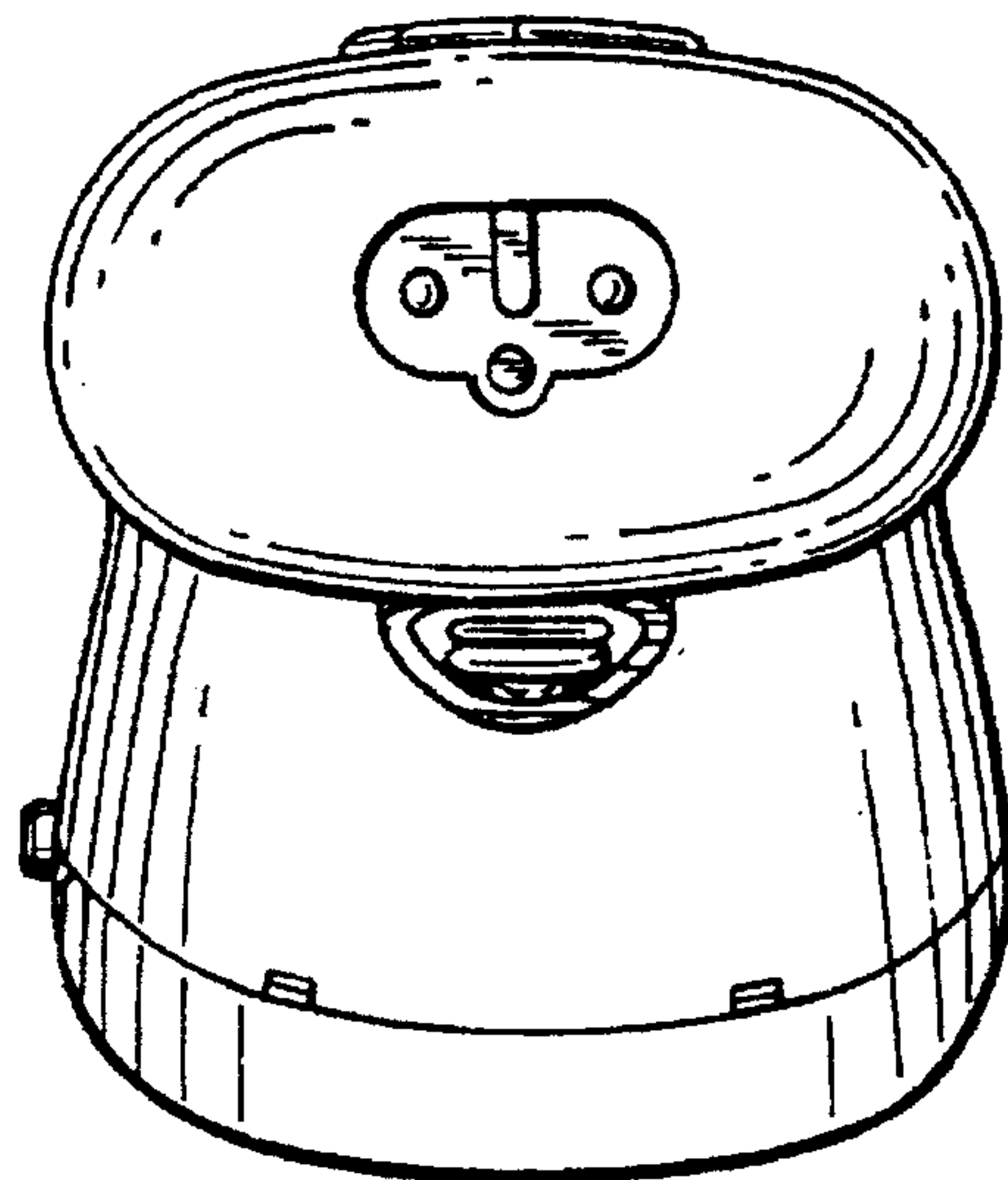
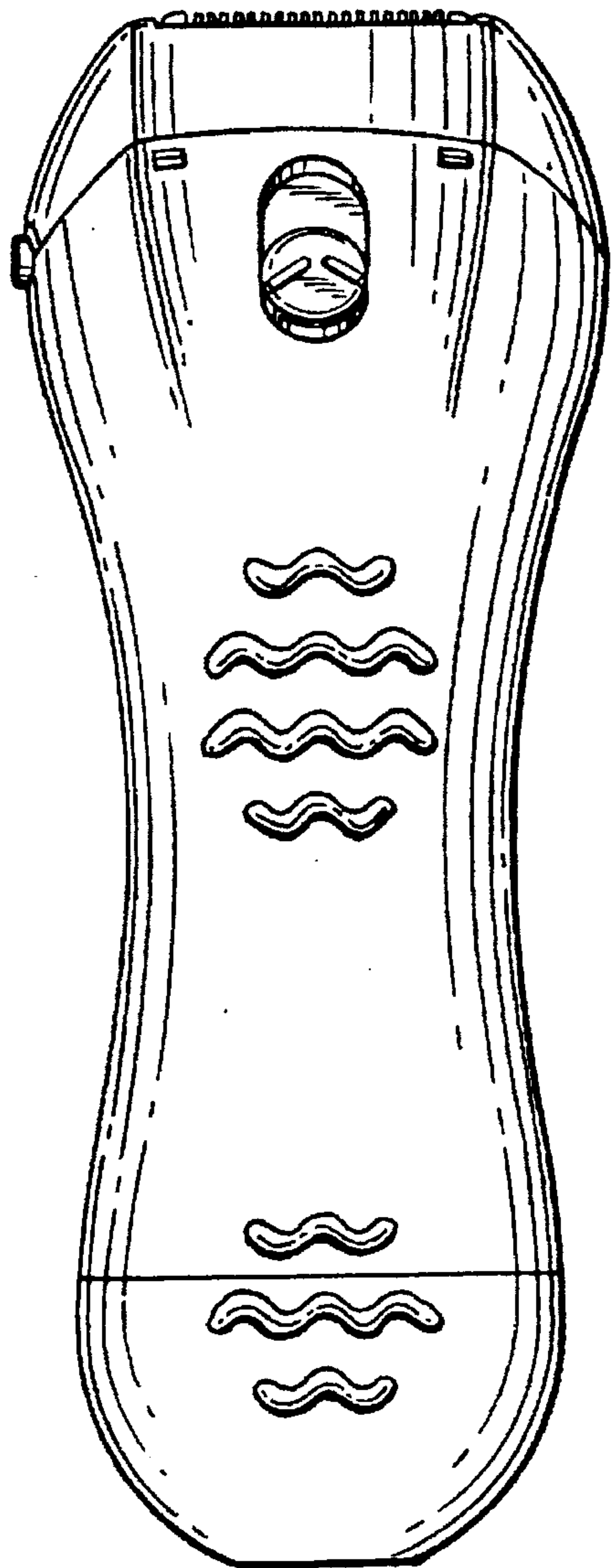
