FIG. 3 is a plan view thereof;

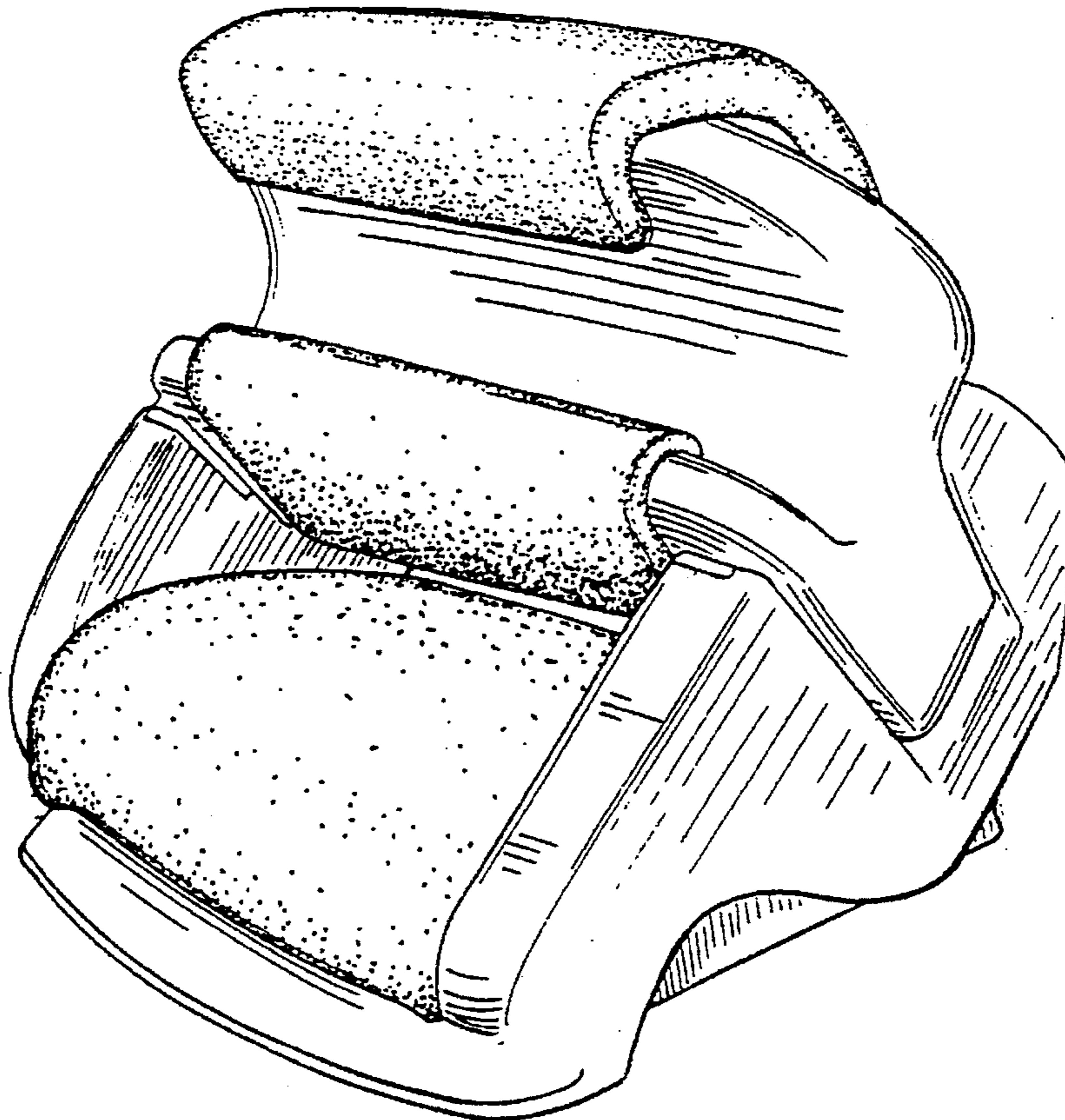
FIG. 4 is a bottom view thereof;

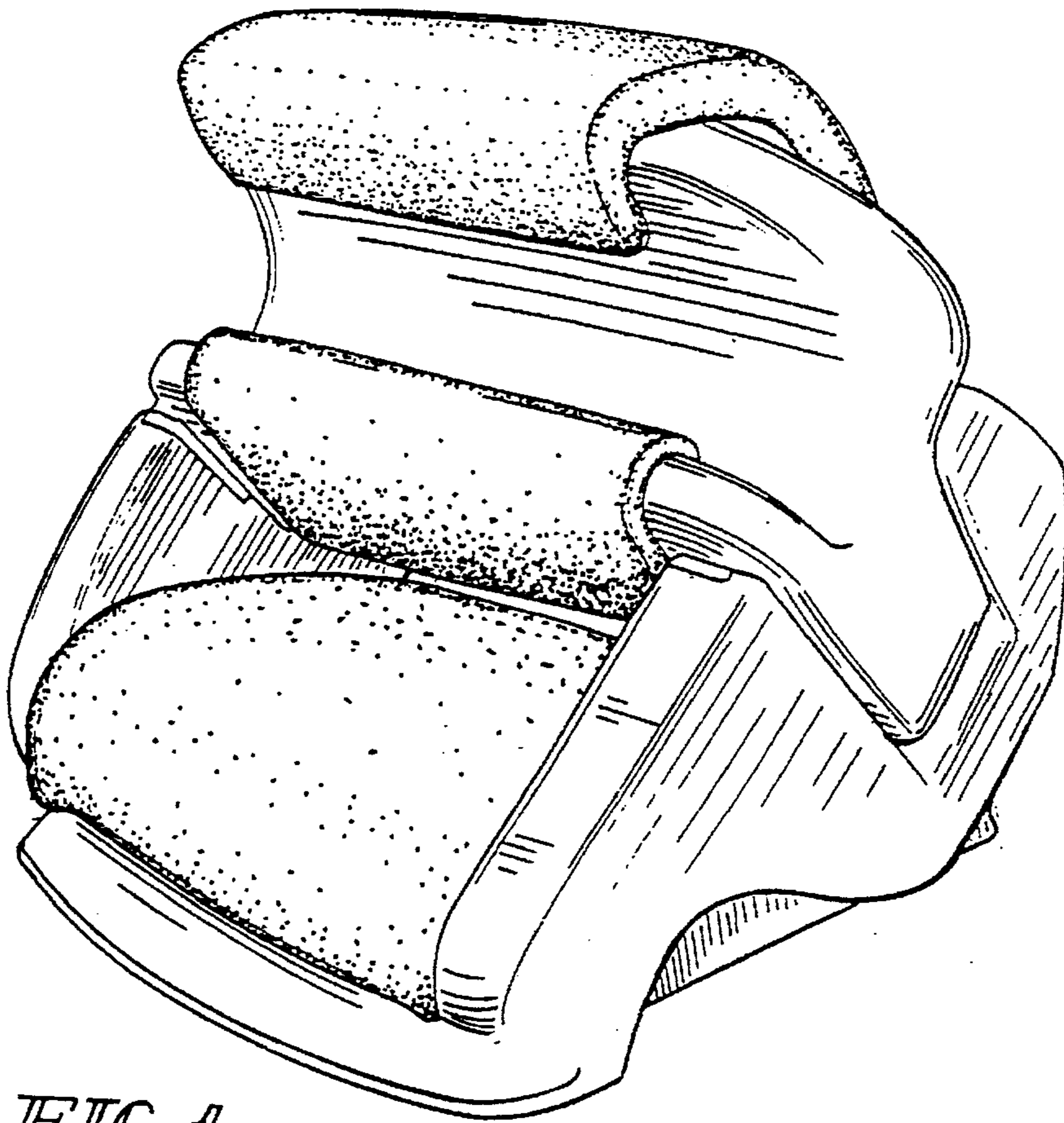

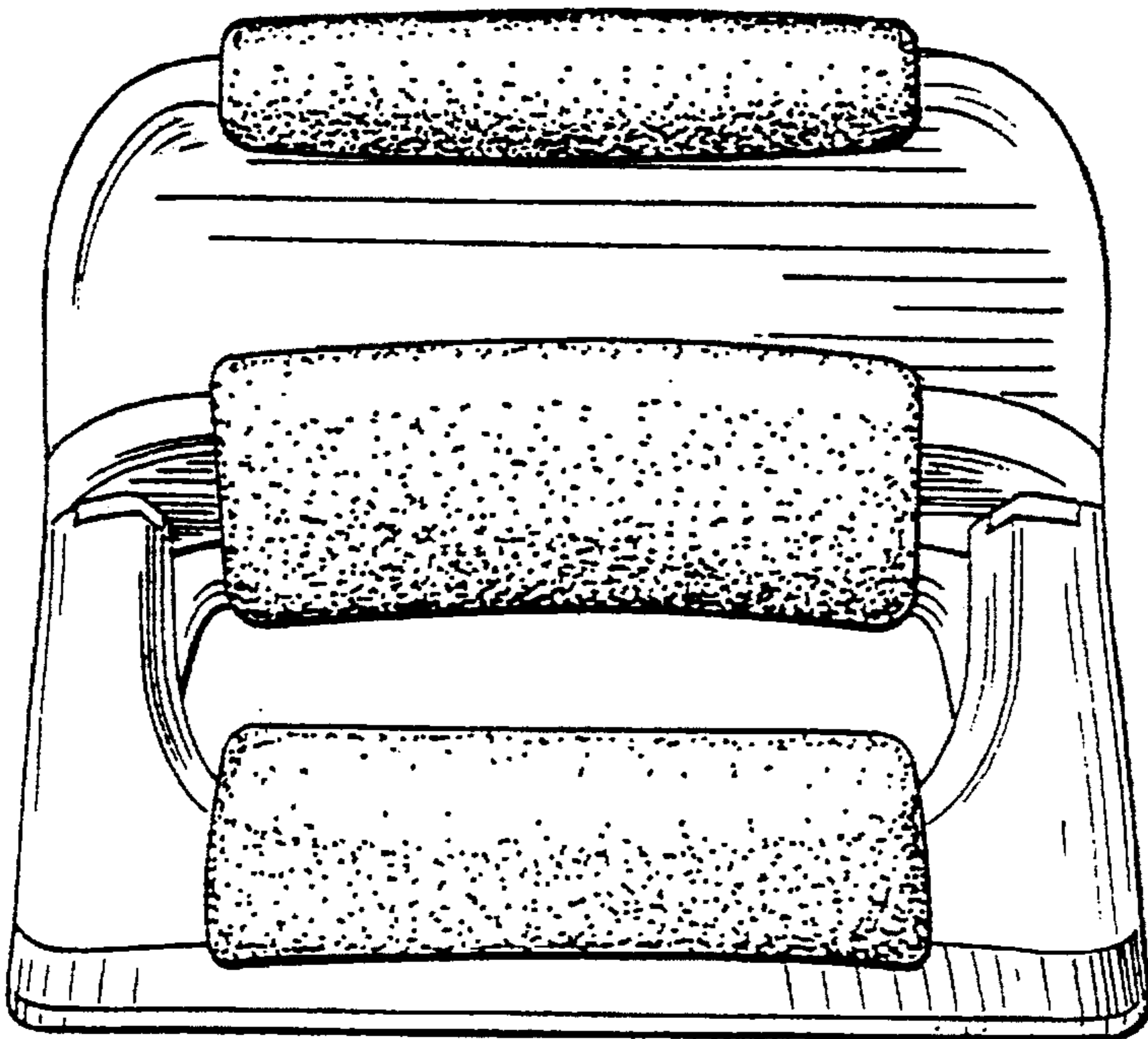

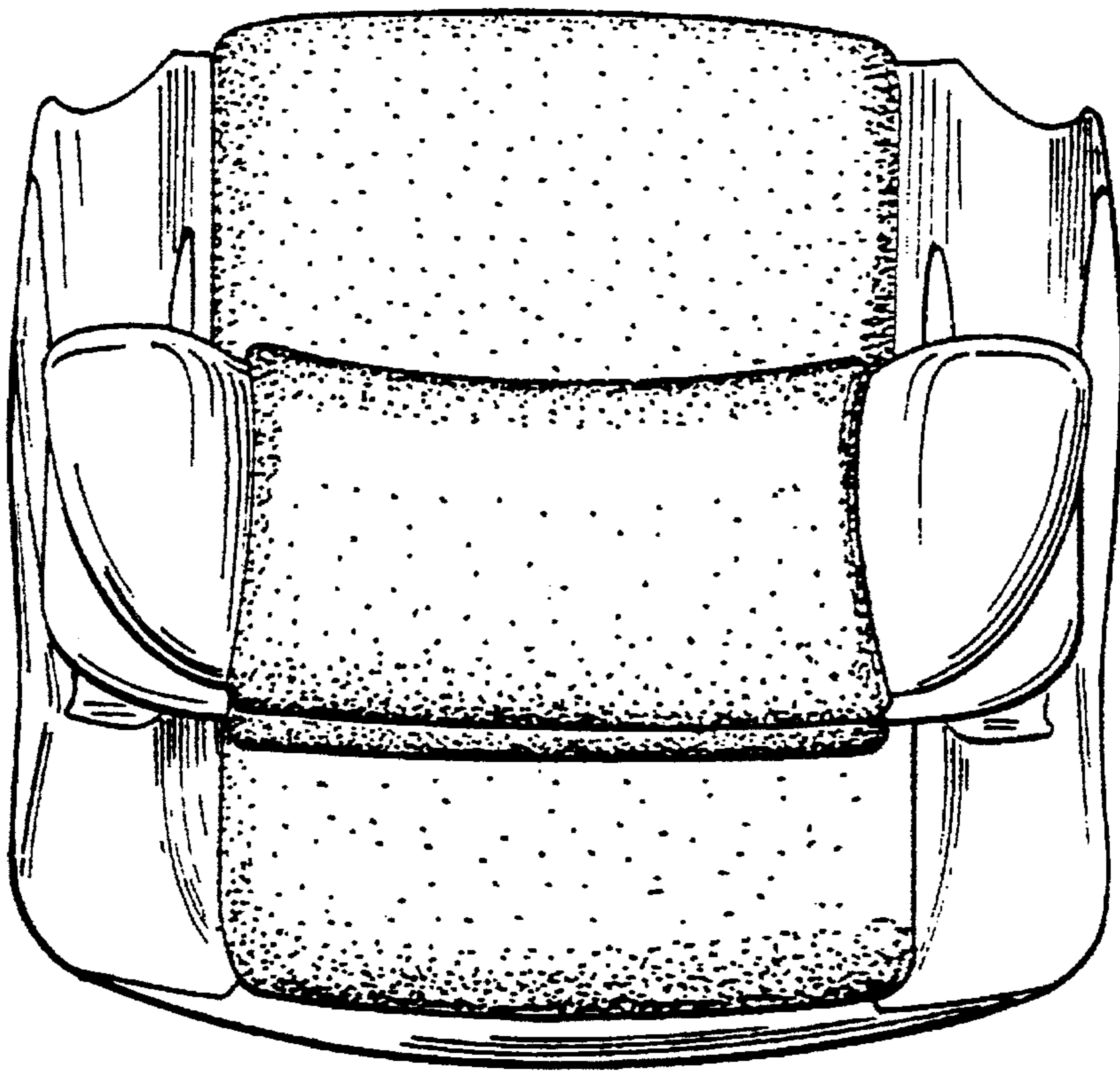

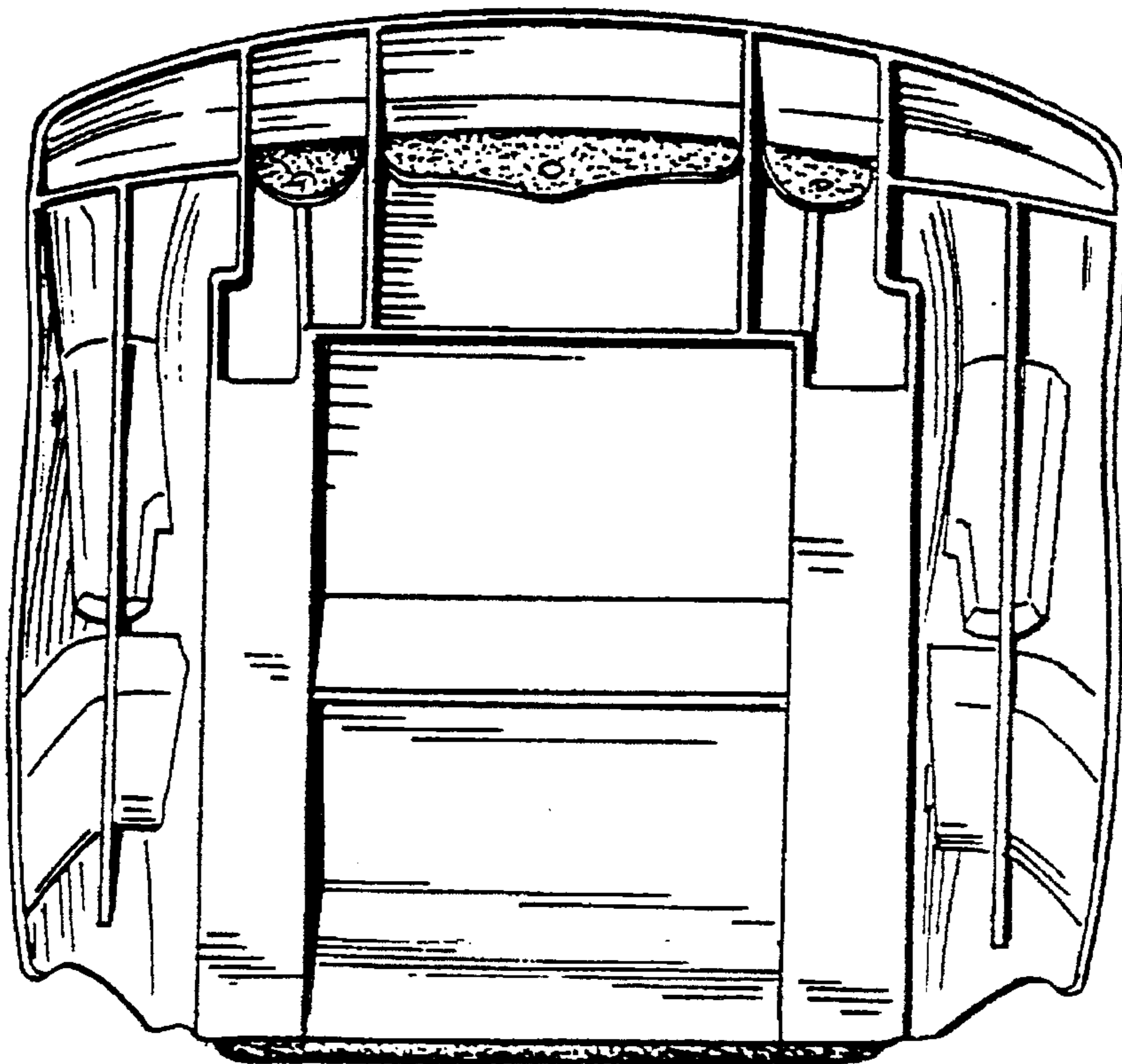

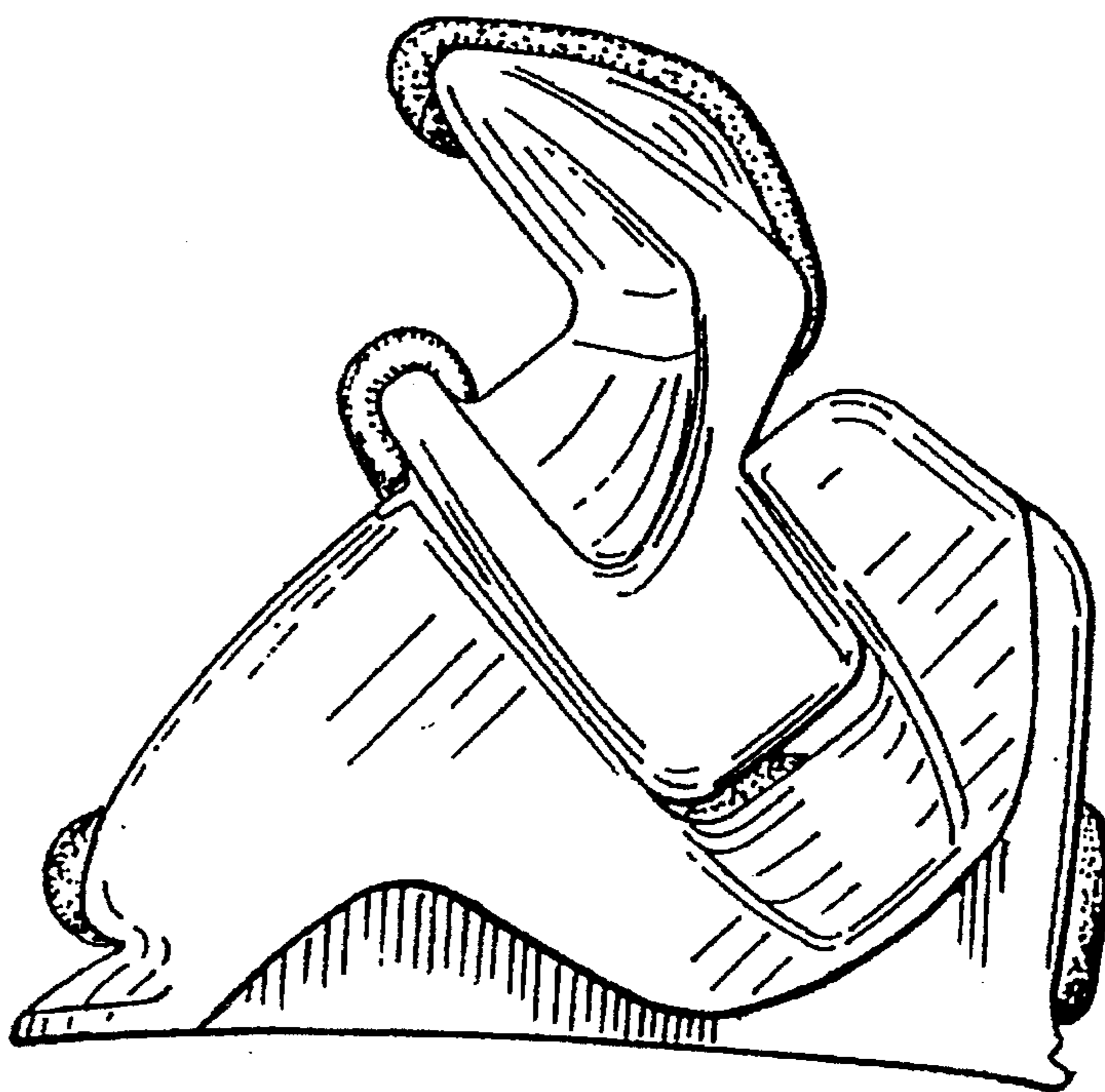

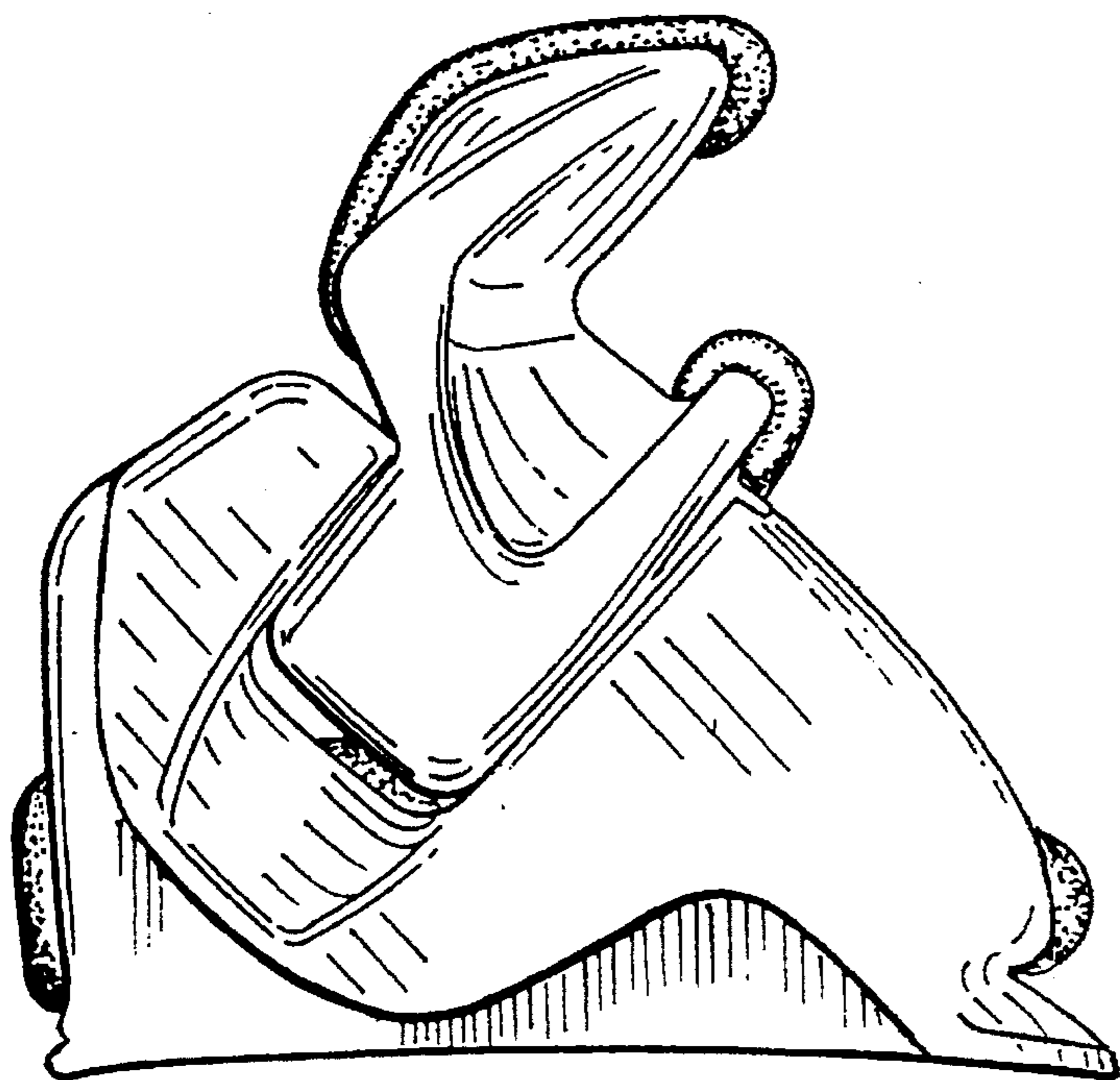

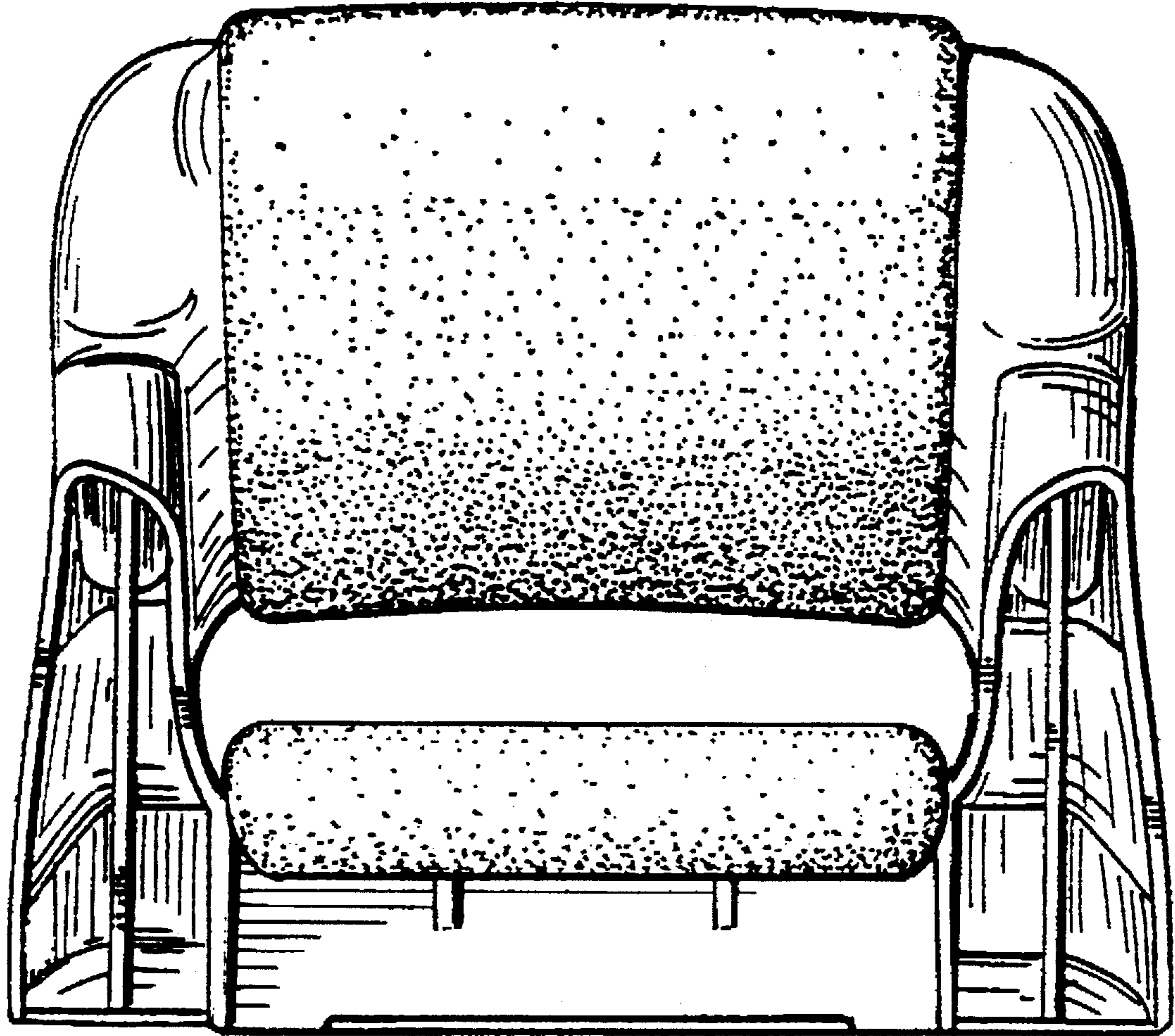
