The ornamental design for a couch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the couch looking down from the top;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left end elevational view thereof, the right end being a mirror image thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

The broken lines shown in the drawing represent stitching.

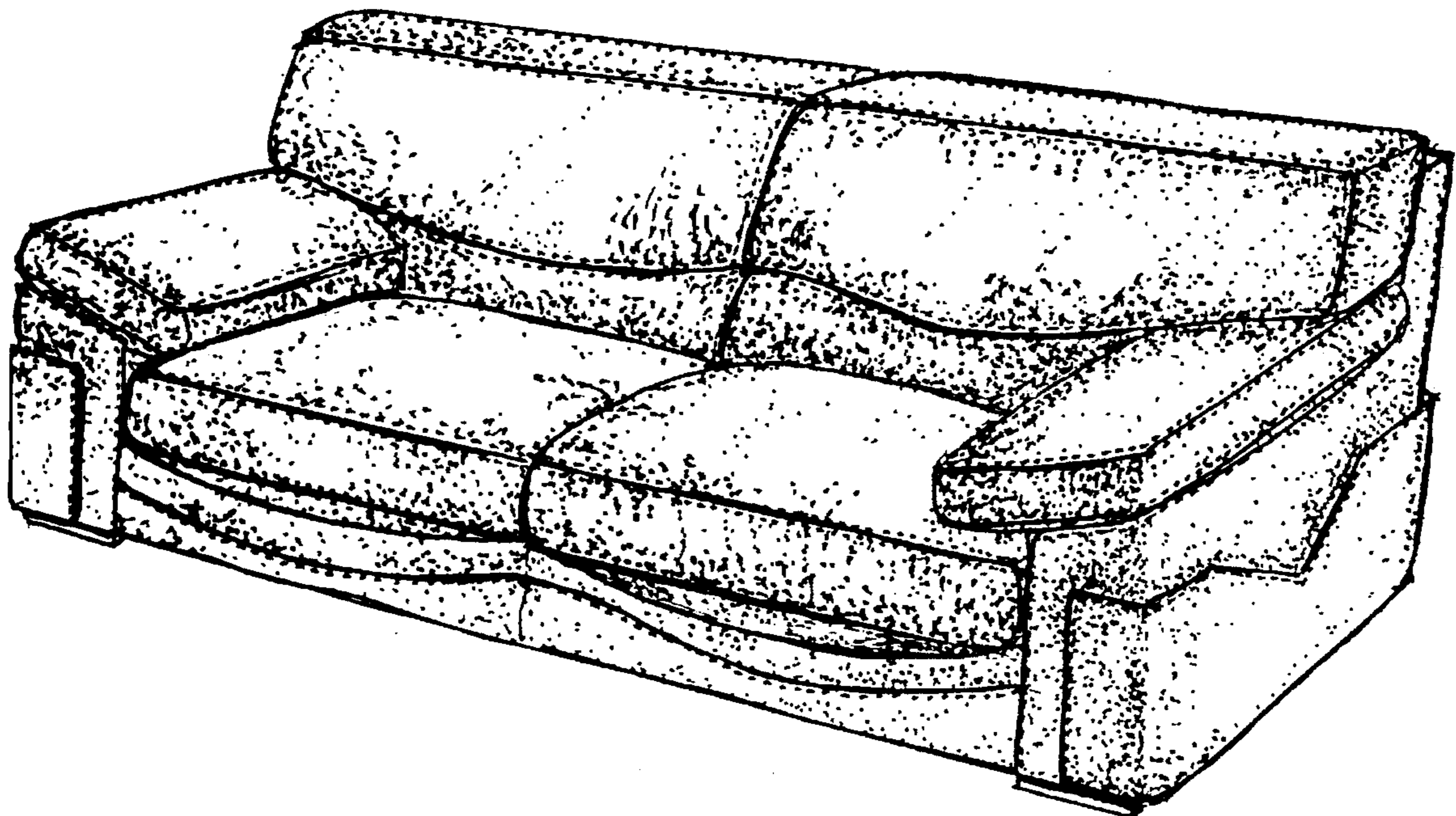

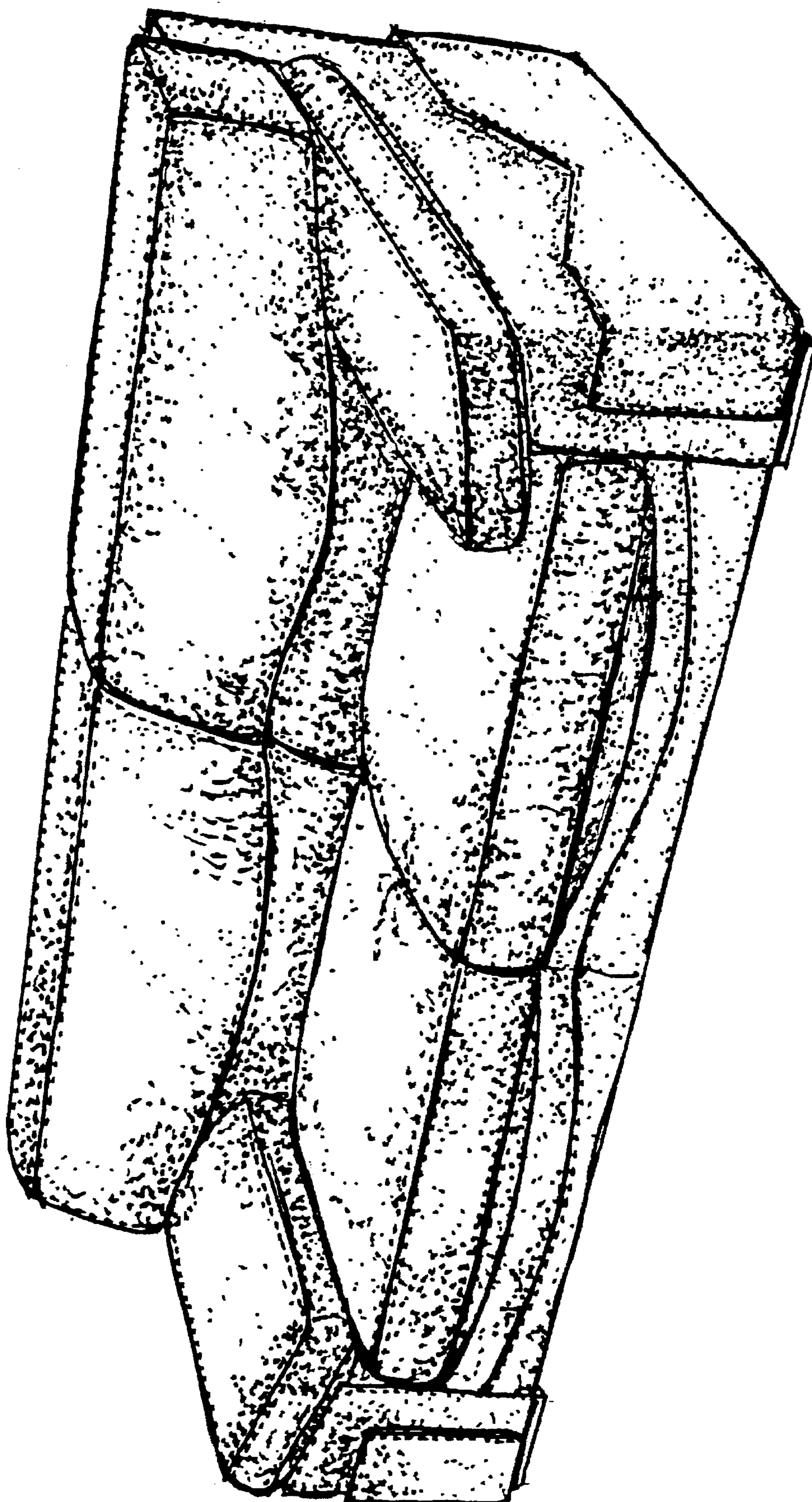

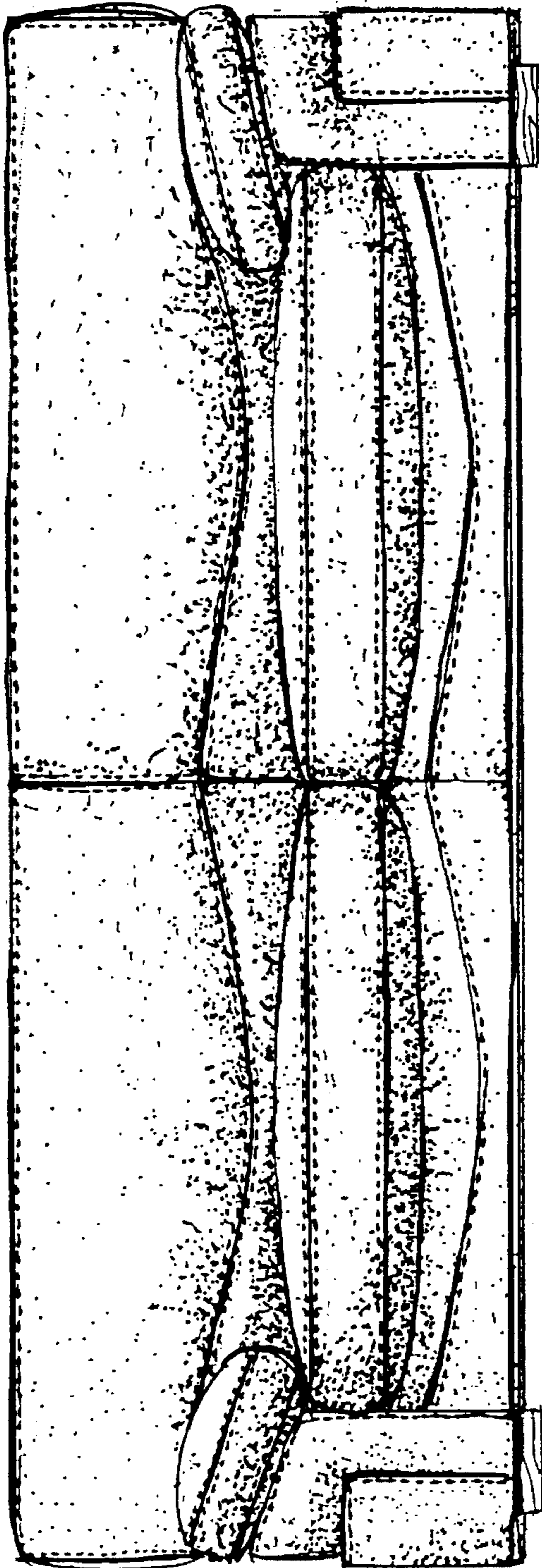

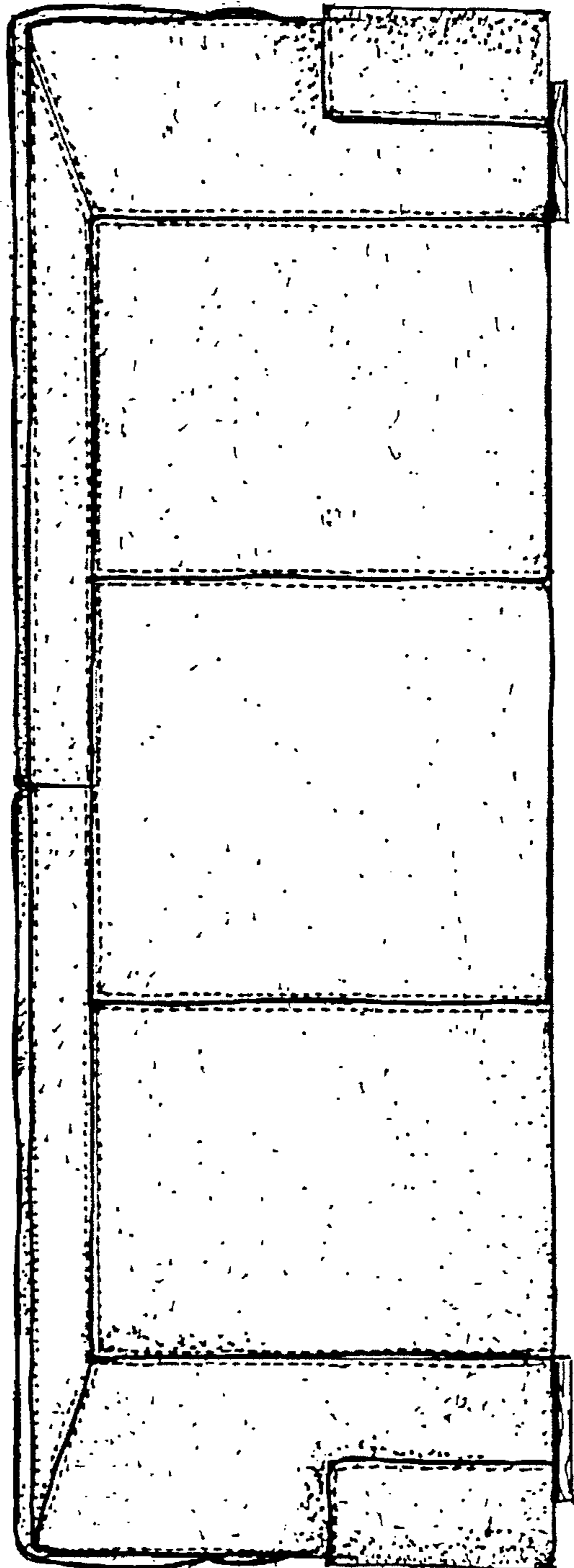

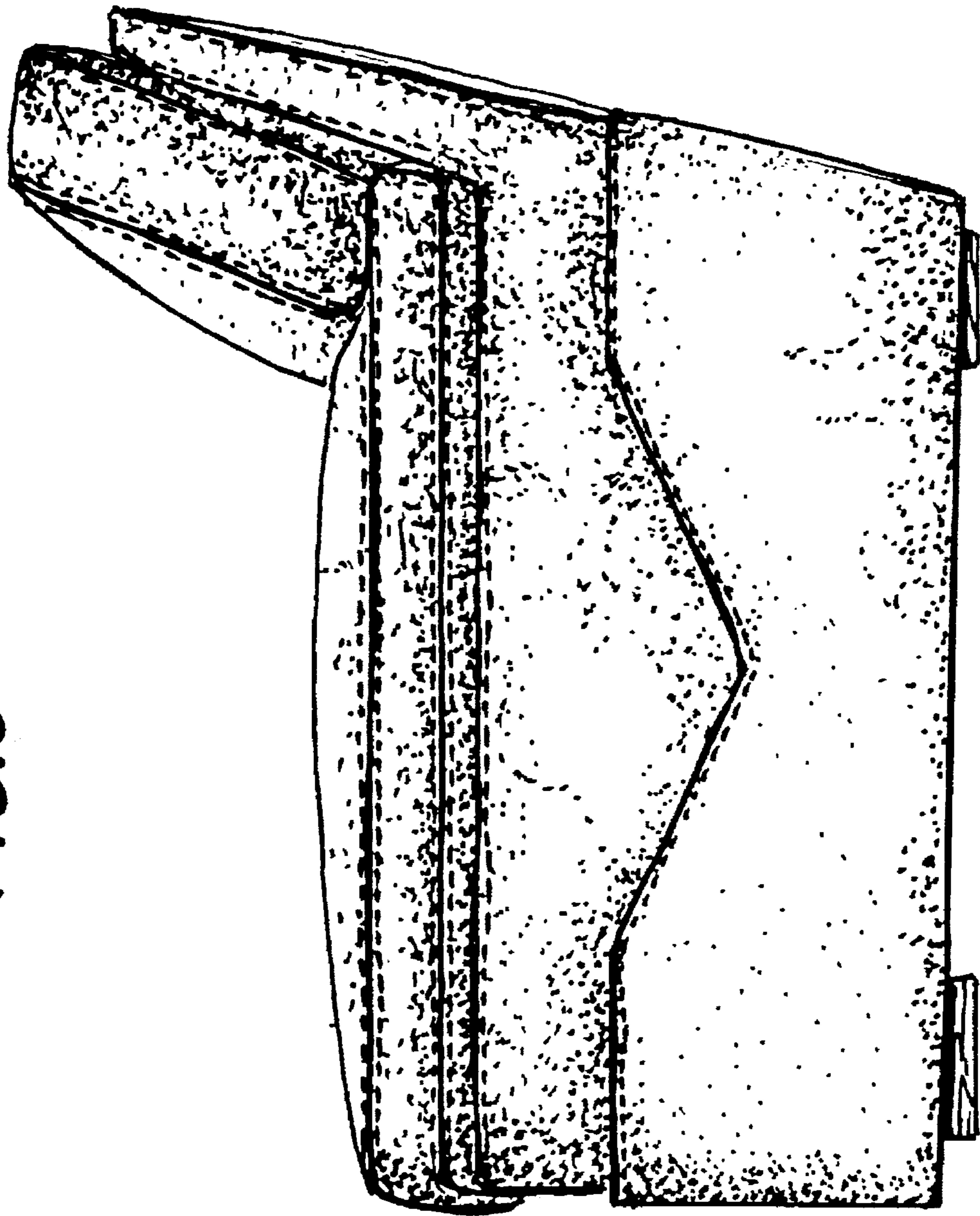

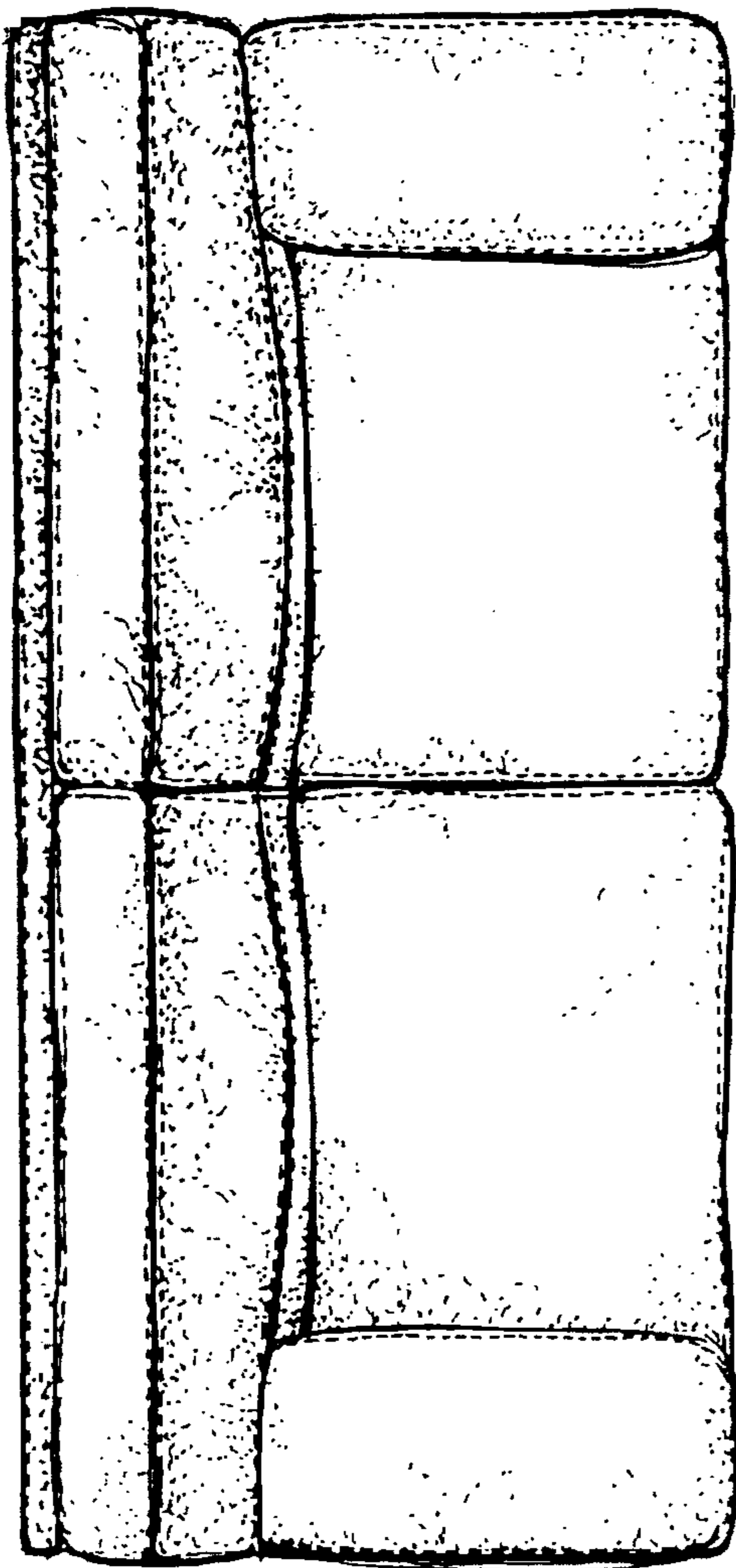
