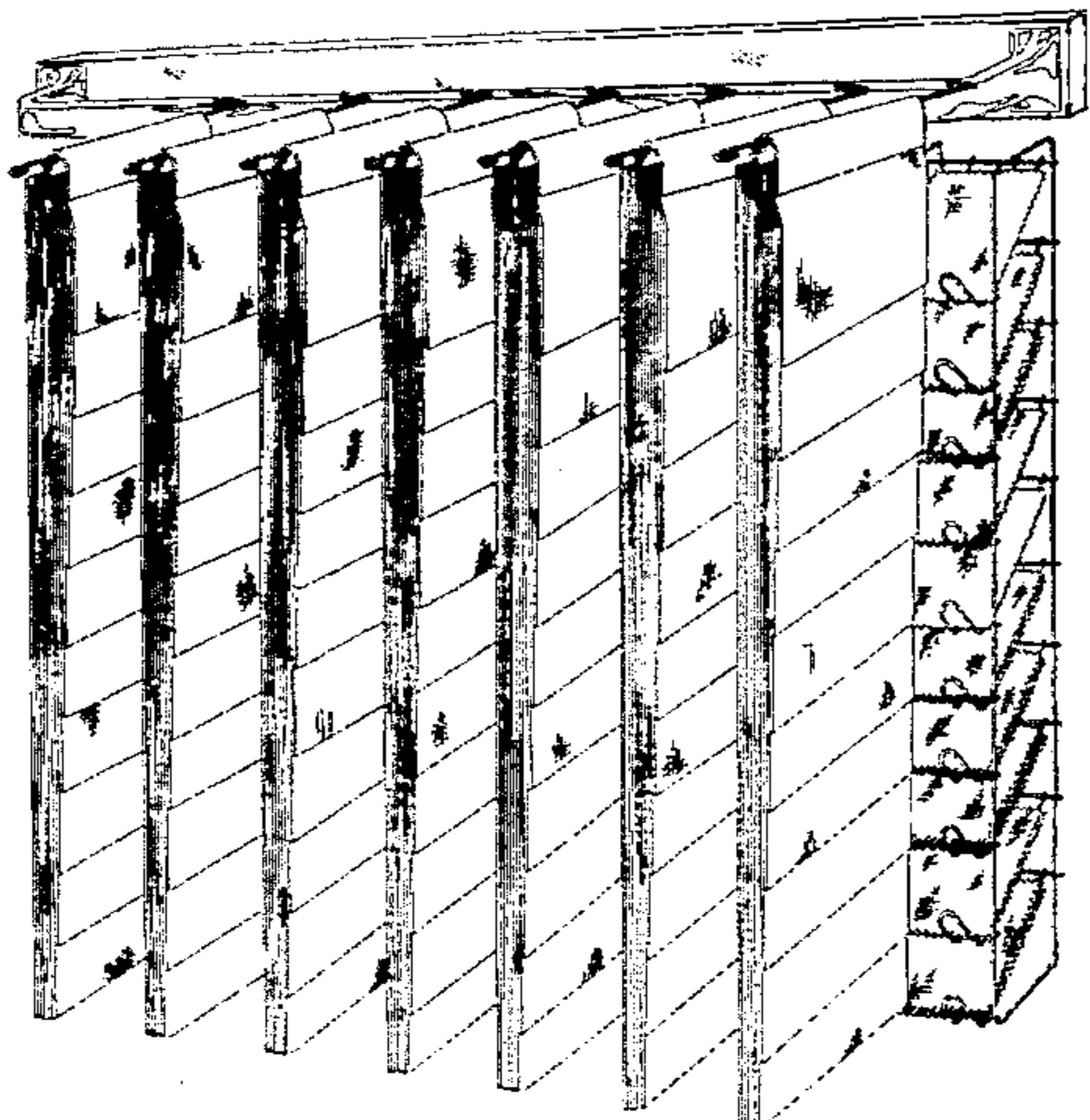
[57] CLAIM

The ornamental design for a combination of sampled goods,
display hanger, and display rack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combination of
sampled goods display hanger, and display rack according to
my new design;
FIG. 2 is a top plan view;
FIG. 3 is a bottom plan view;
FIG. 4 is a rear elevational view;
FIG. 5 is a left side elevational view; and,
FIG. 6 is a right side elevational view.

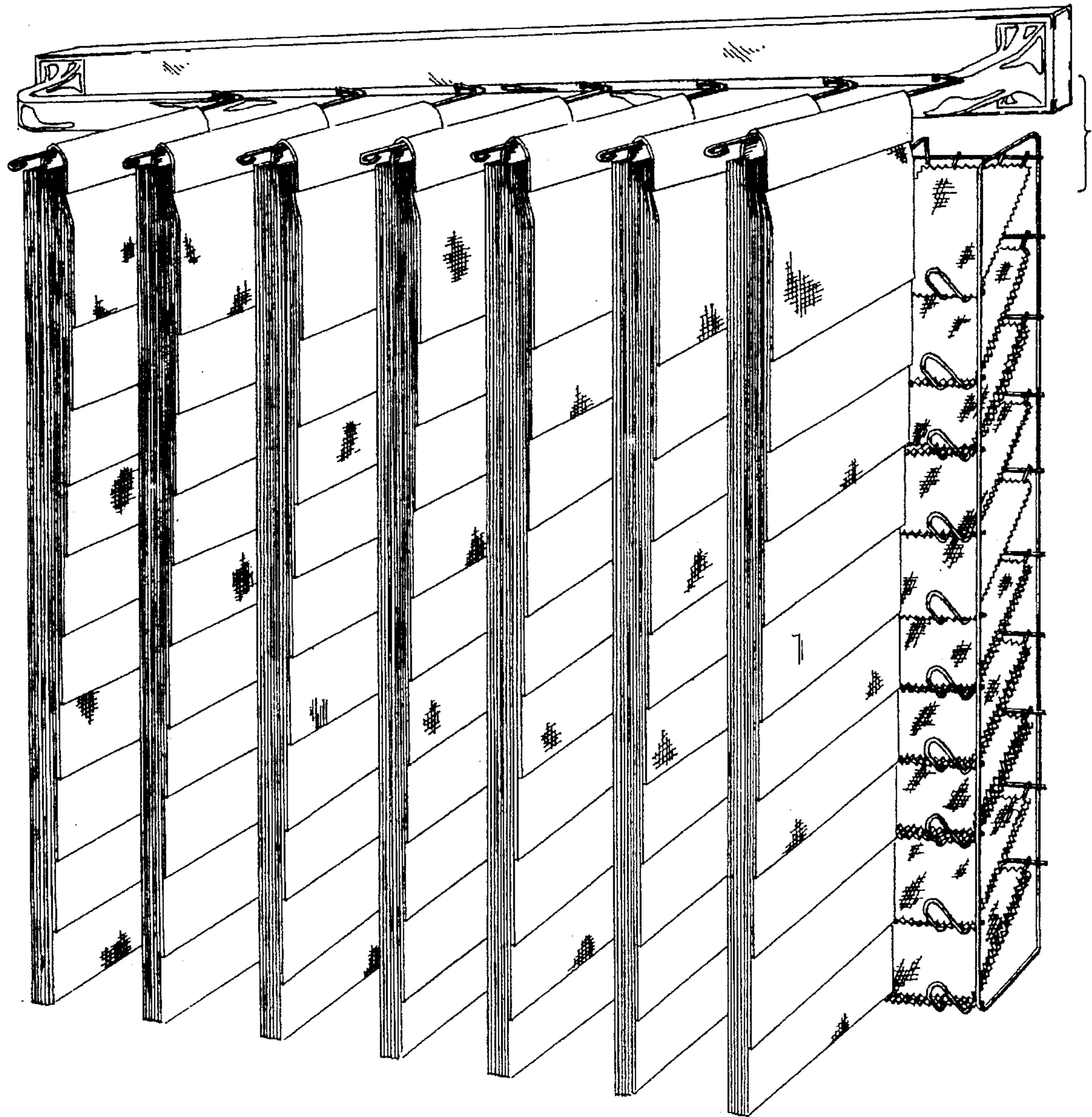

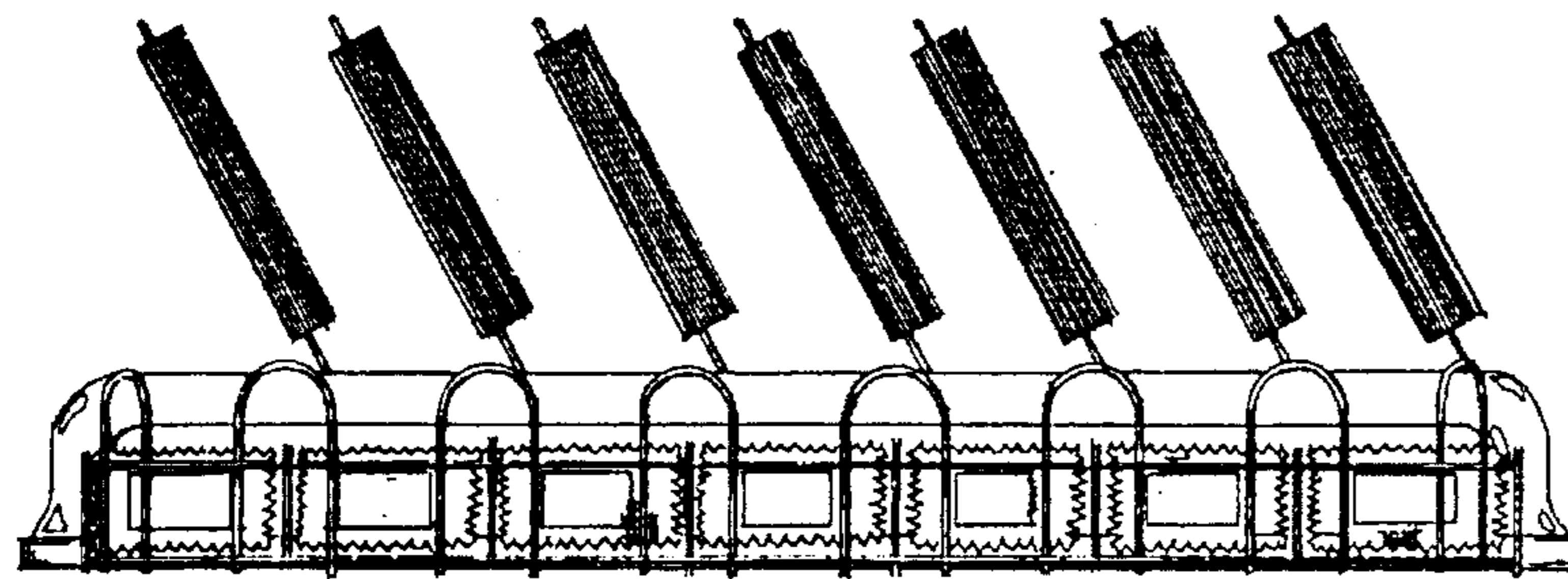
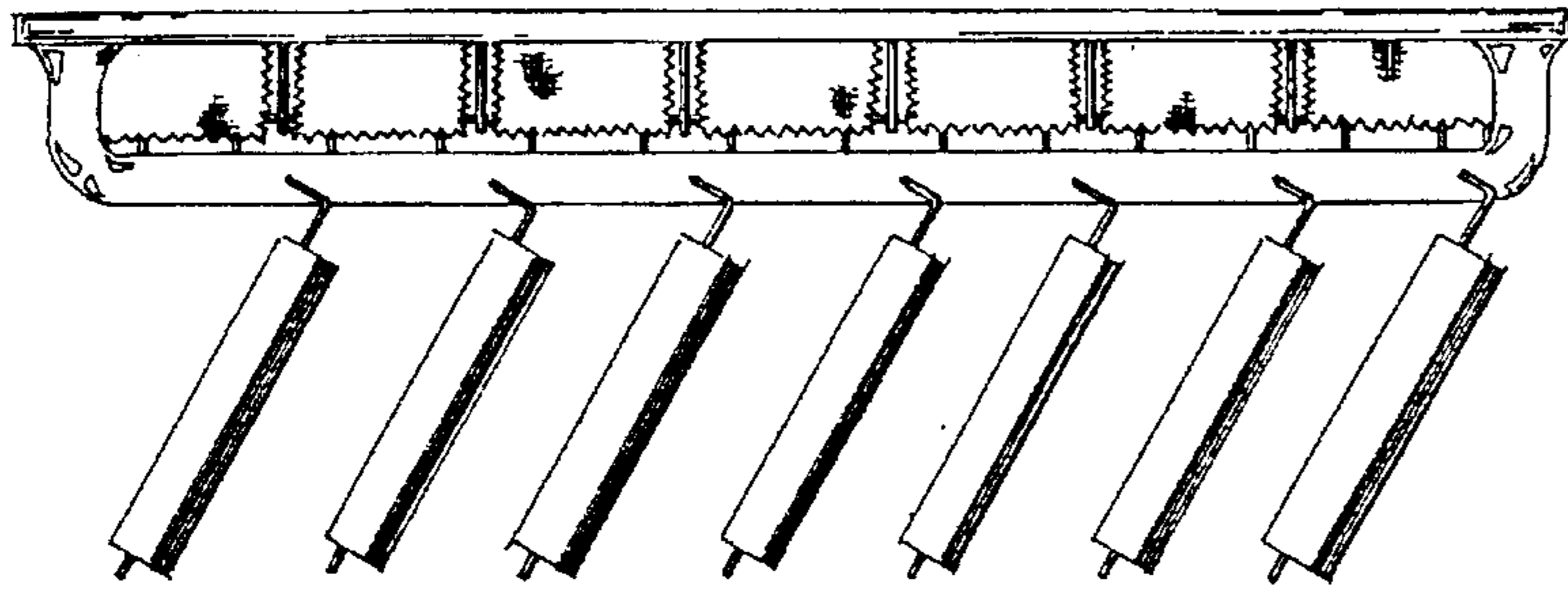

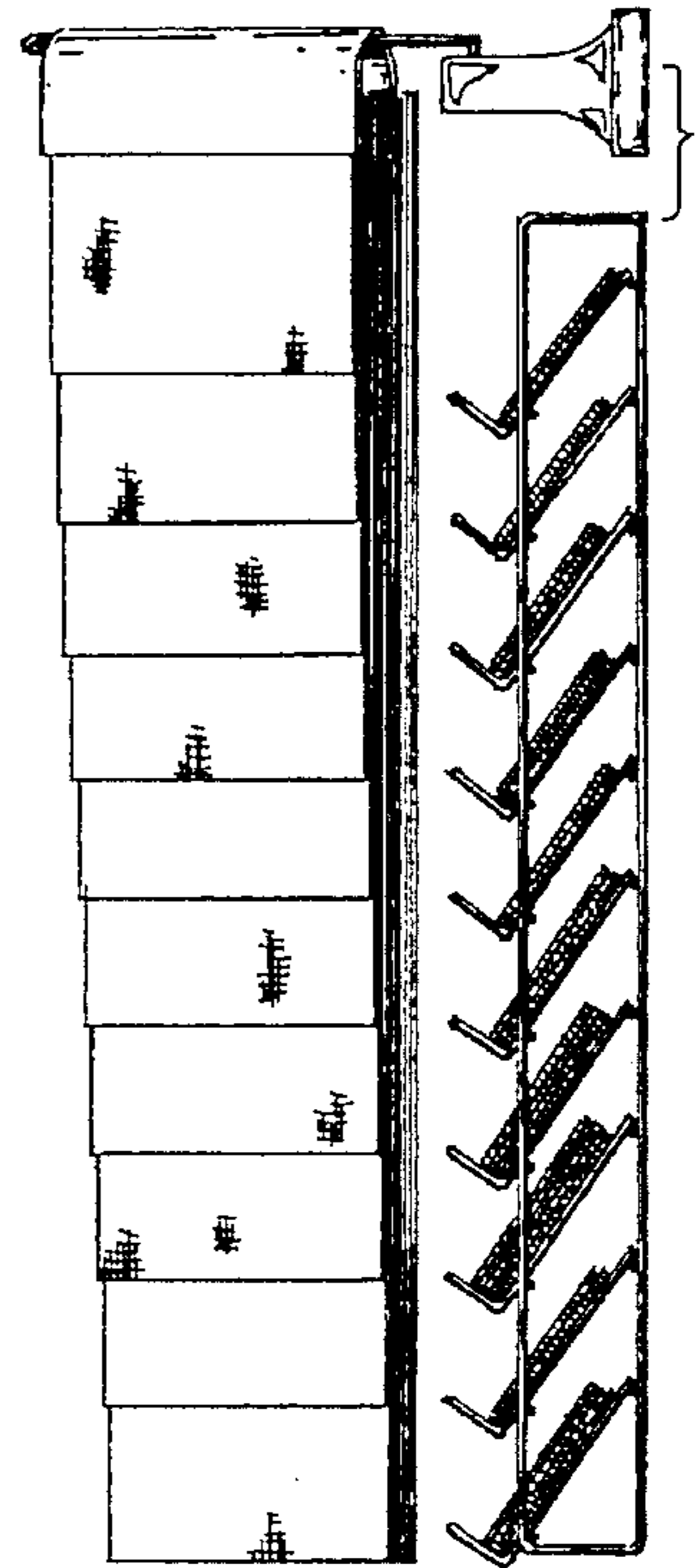

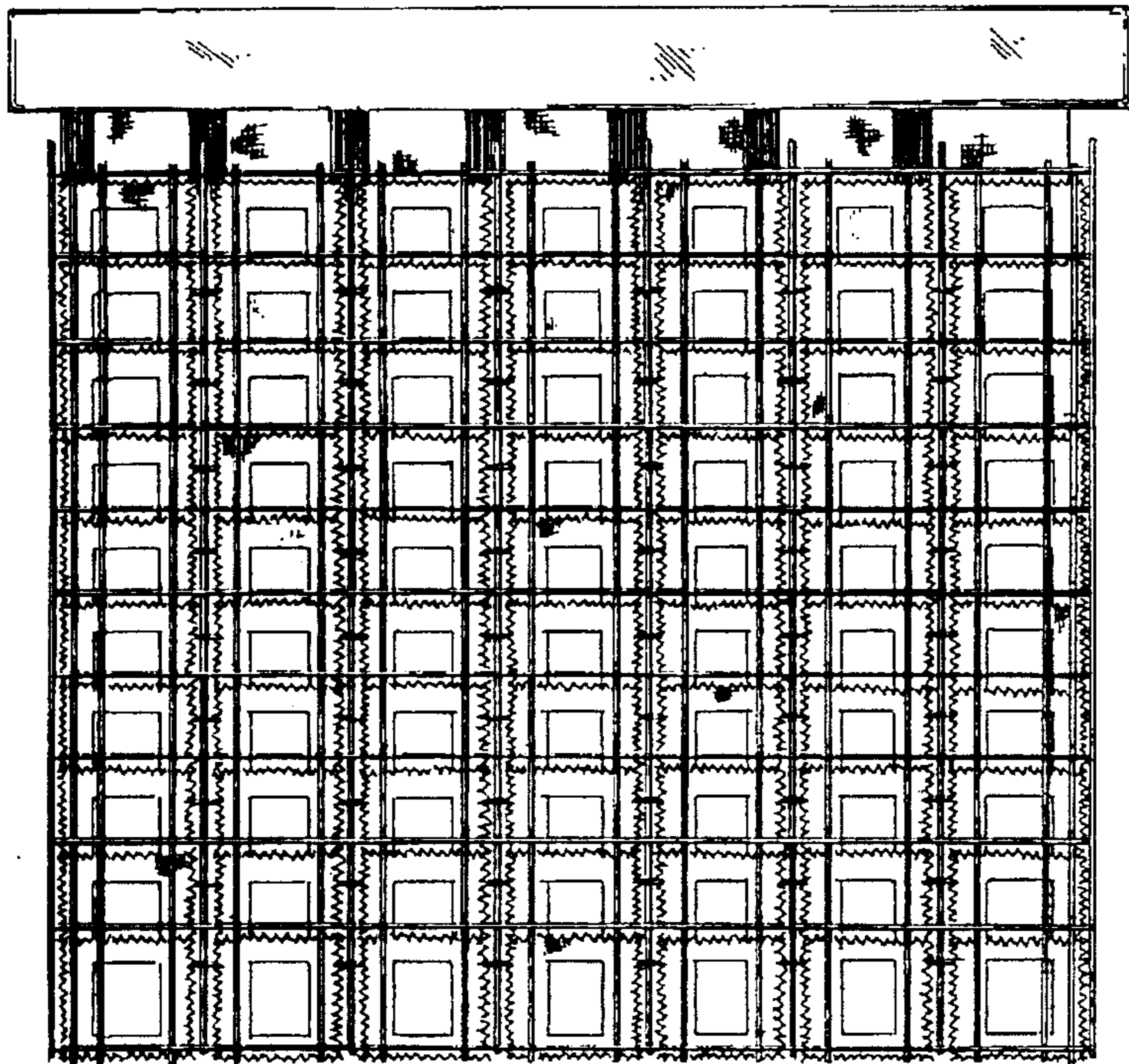

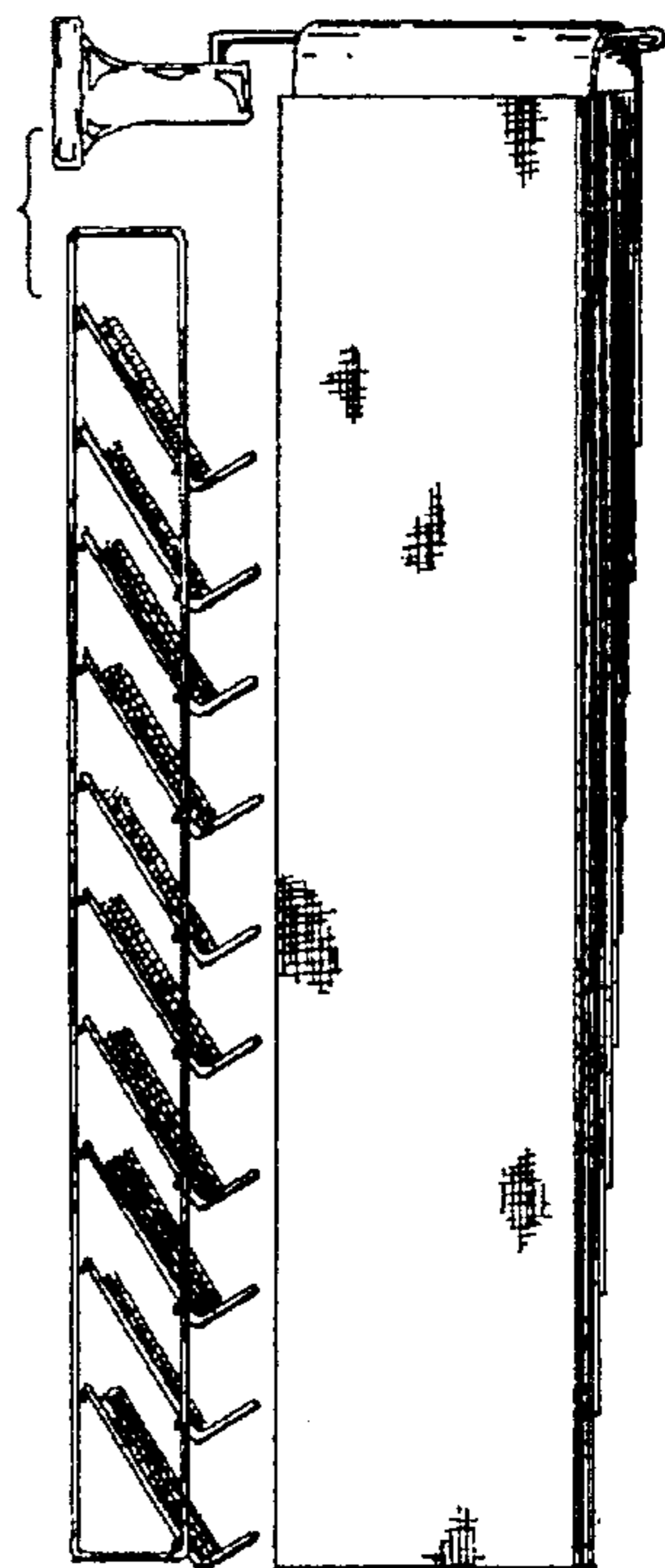
