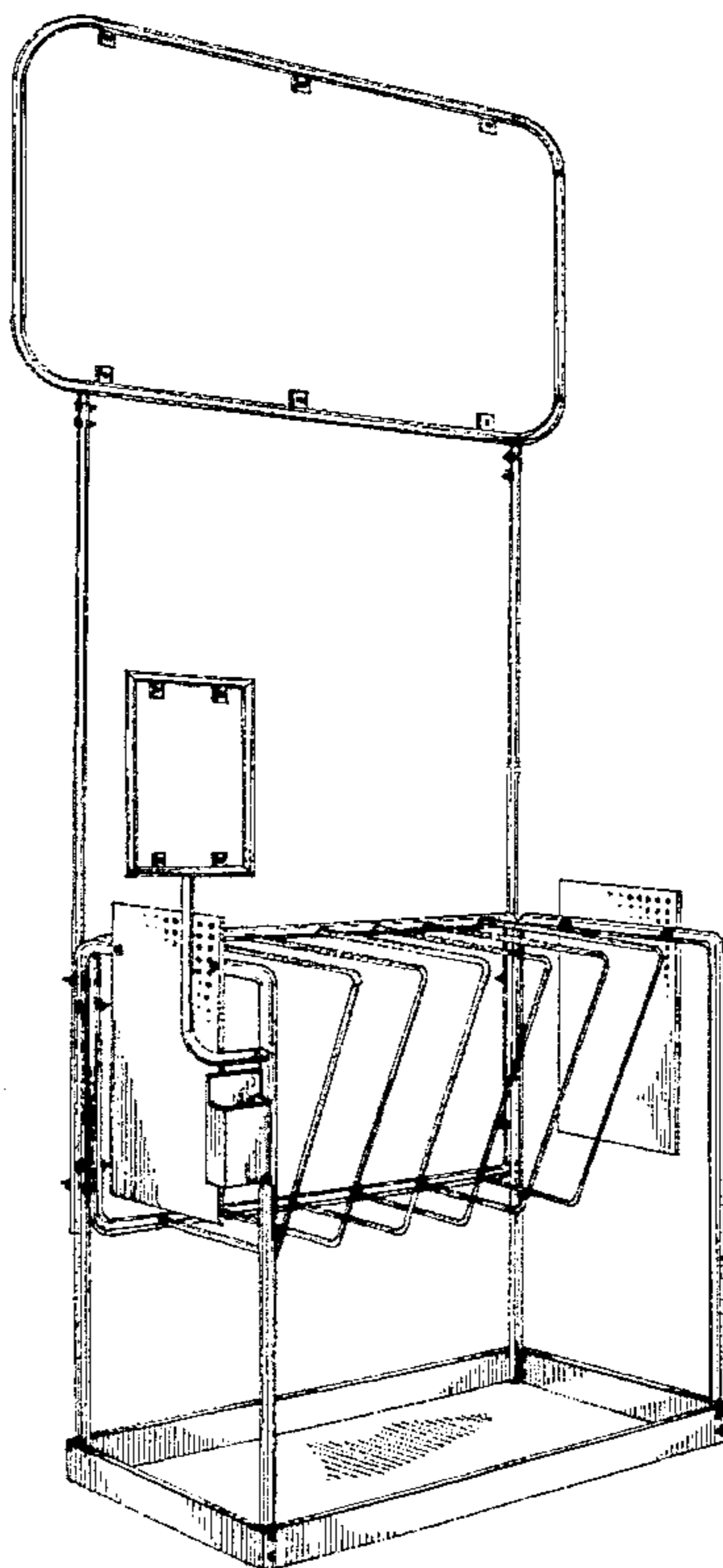
### [57] **CLAIM**

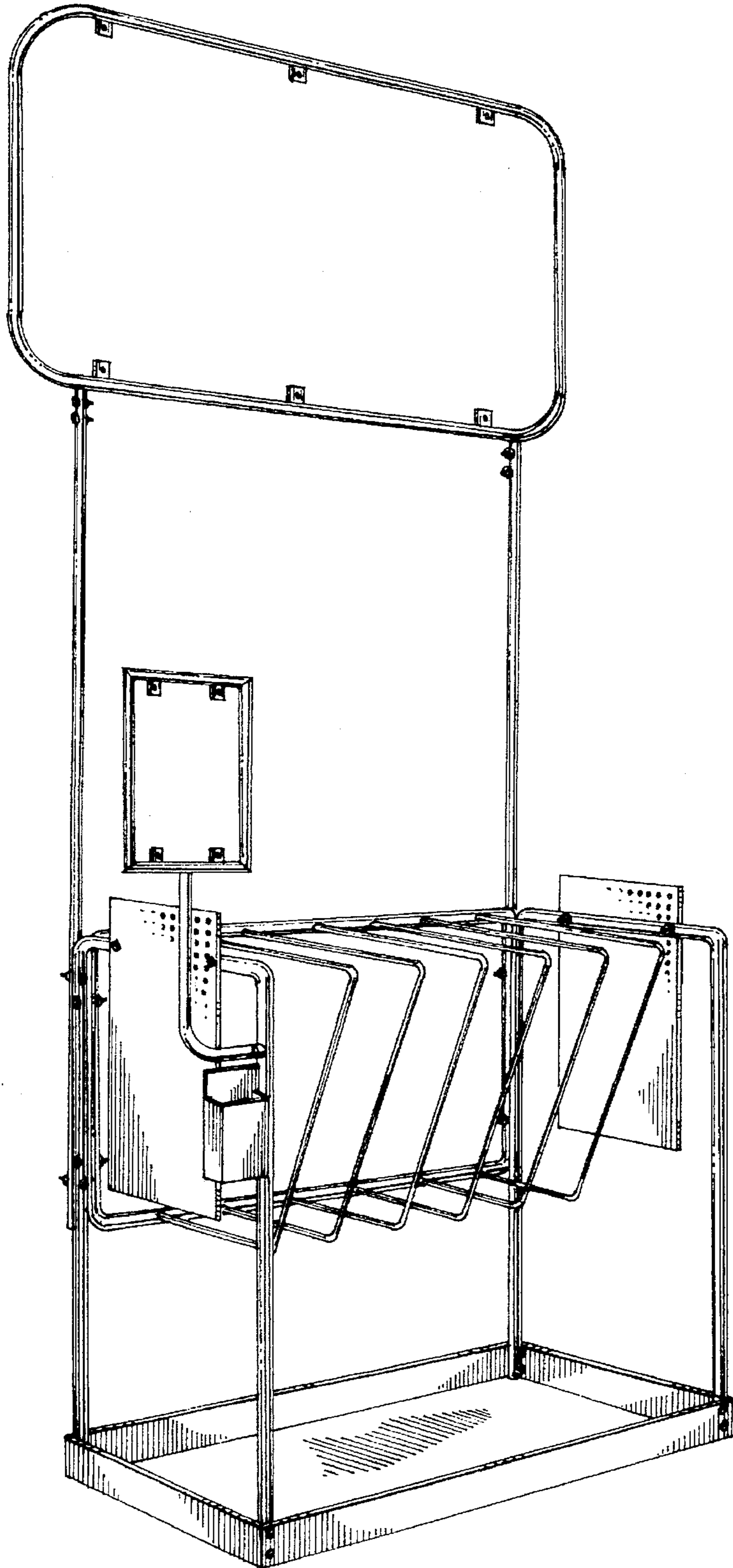
The ornamental design of a ladder rack, as shown and described.

### **DESCRIPTION**

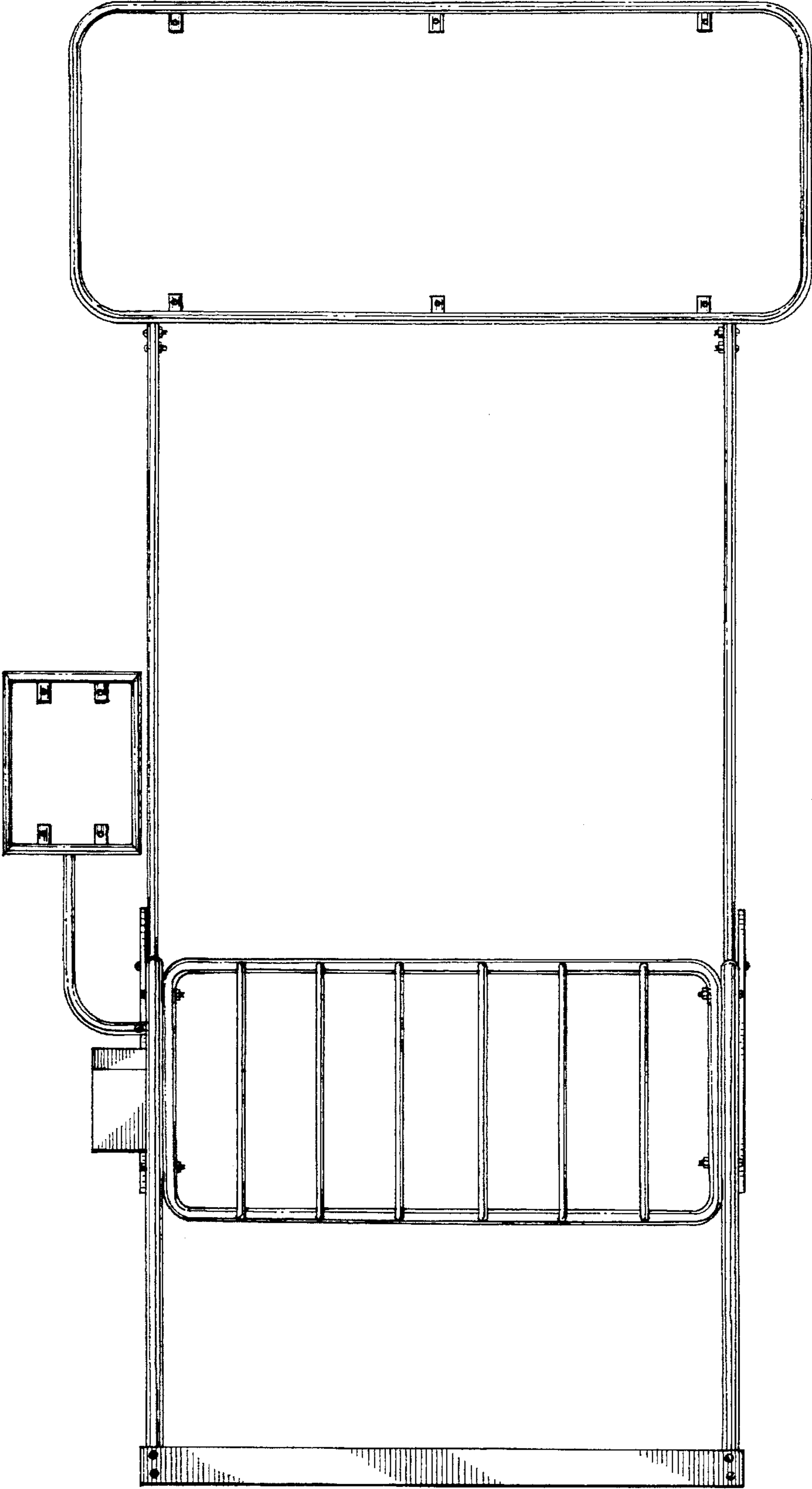
FIG. 1 is a front perspective view of a ladder rack according to our new design;  
 FIG. 2 is an enlarged front elevational view thereof, with the six adjacent display frames in vertical position;  
 FIG. 3 is a top plan view of FIG. 2;  
 FIG. 4 is a side elevational view, from the left in FIG. 2;  
 FIG. 5 is a rear elevational view of FIG. 2;  
 FIG. 6 is a side elevational view, from the right in FIG. 2; and,  
 FIG. 7 is a bottom plan view of FIG. 2.  
 The circular apertures shown along part of the surface of the side panels in FIGS. 1, 4, and 6 are understood to repeat uniformly along the entire surface of the side panels.

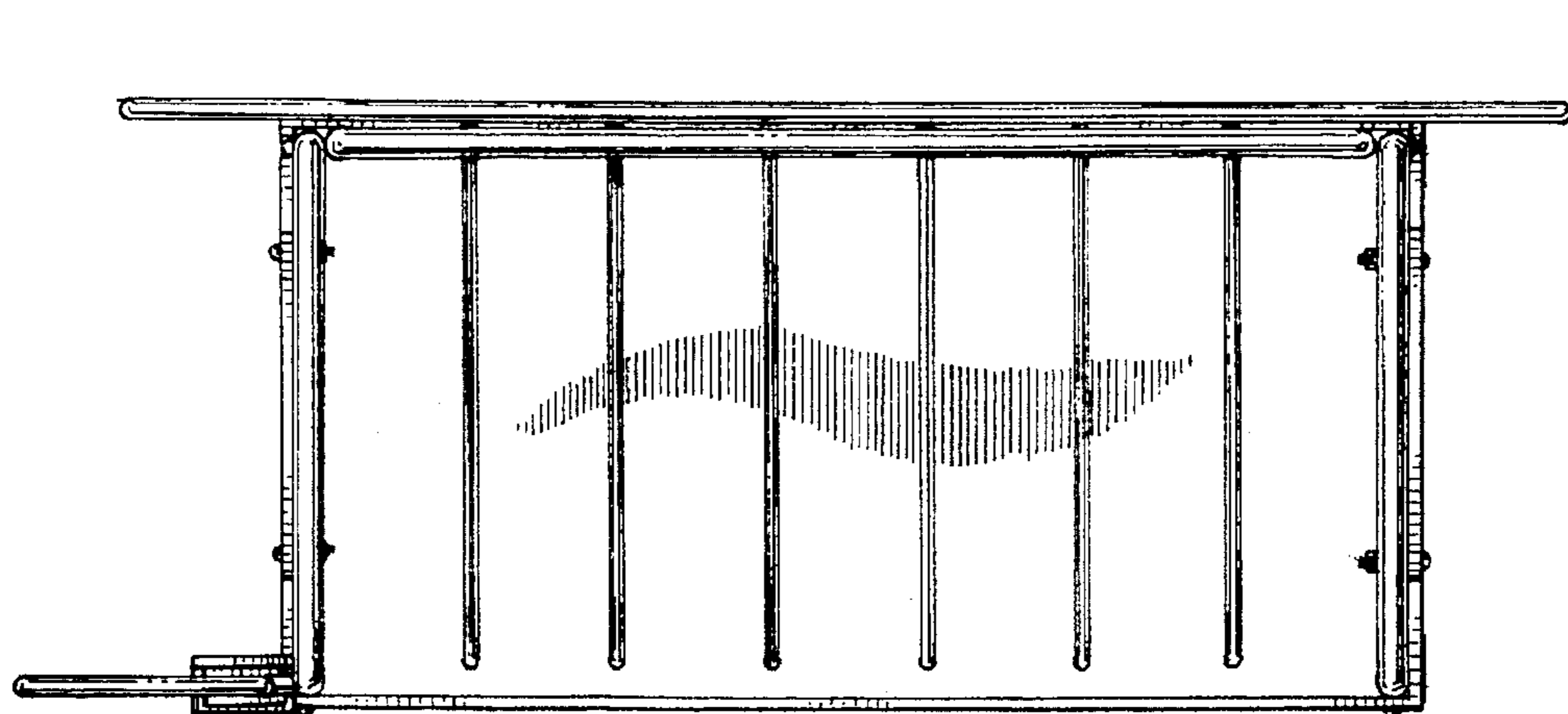




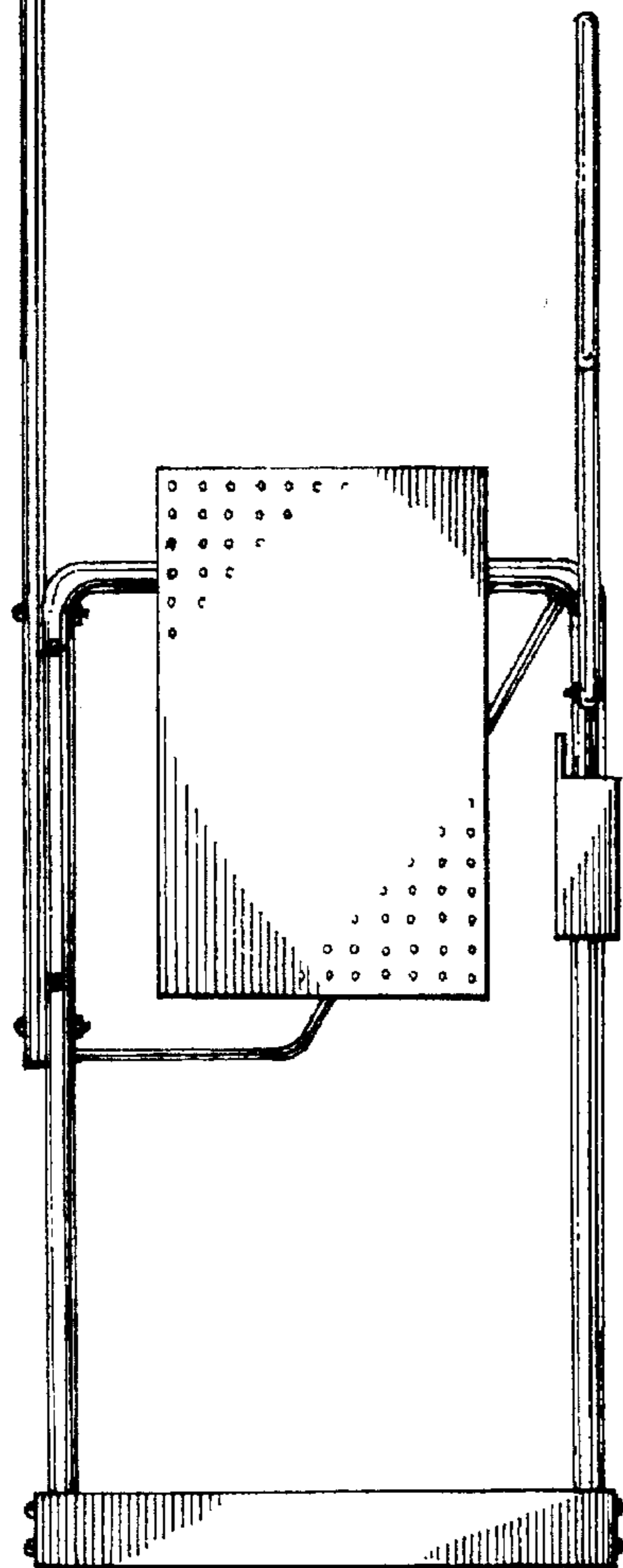

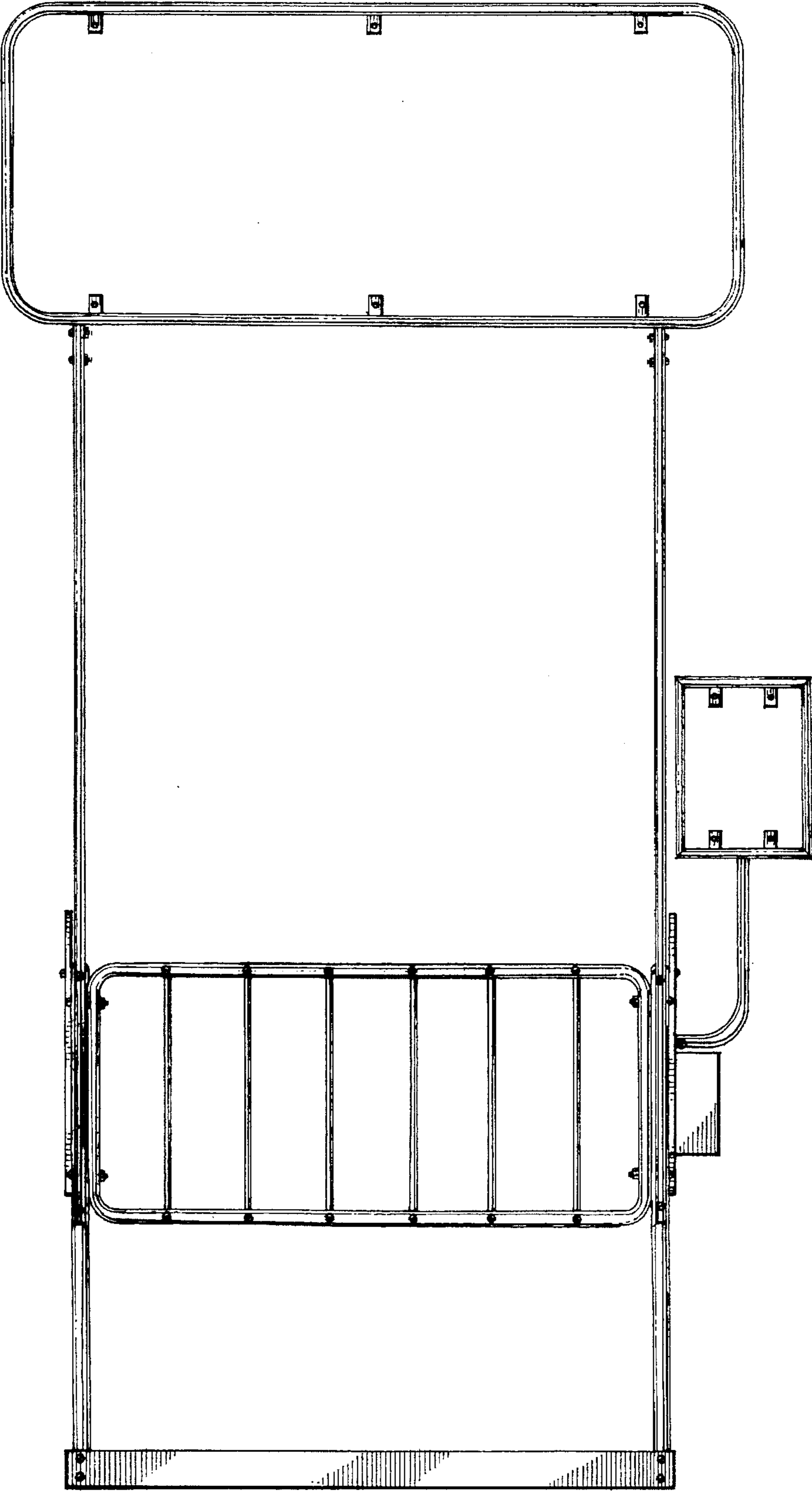

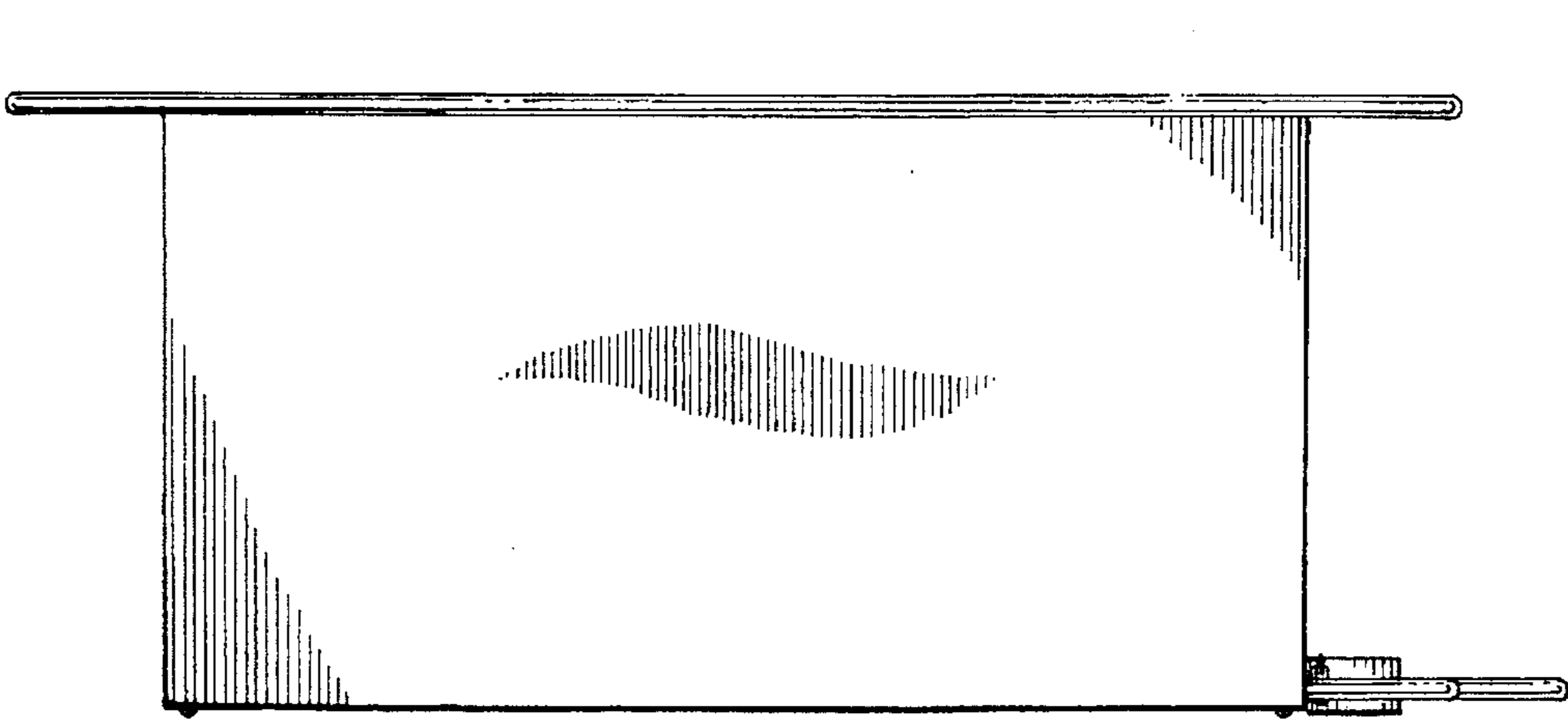

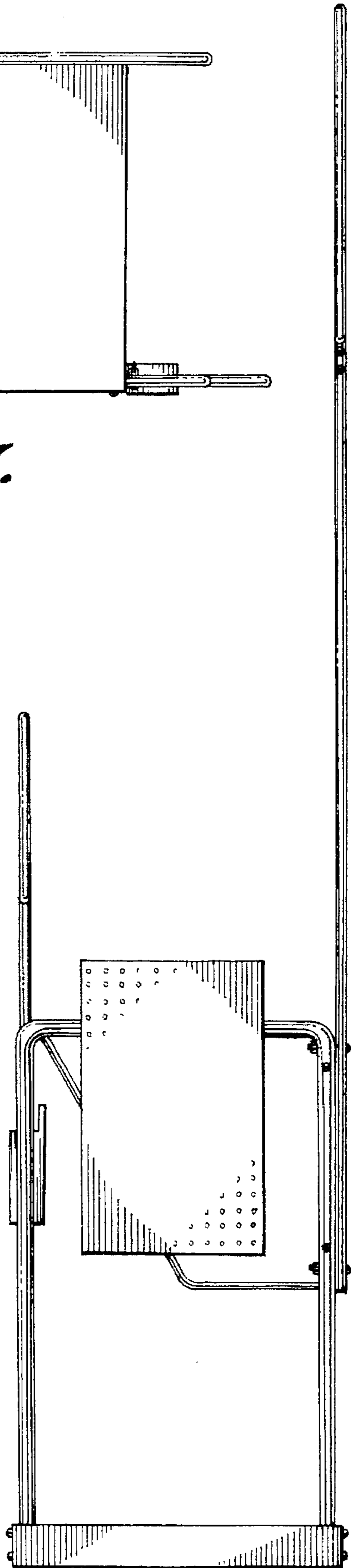
