FIG. 2 is a top plan view thereof;

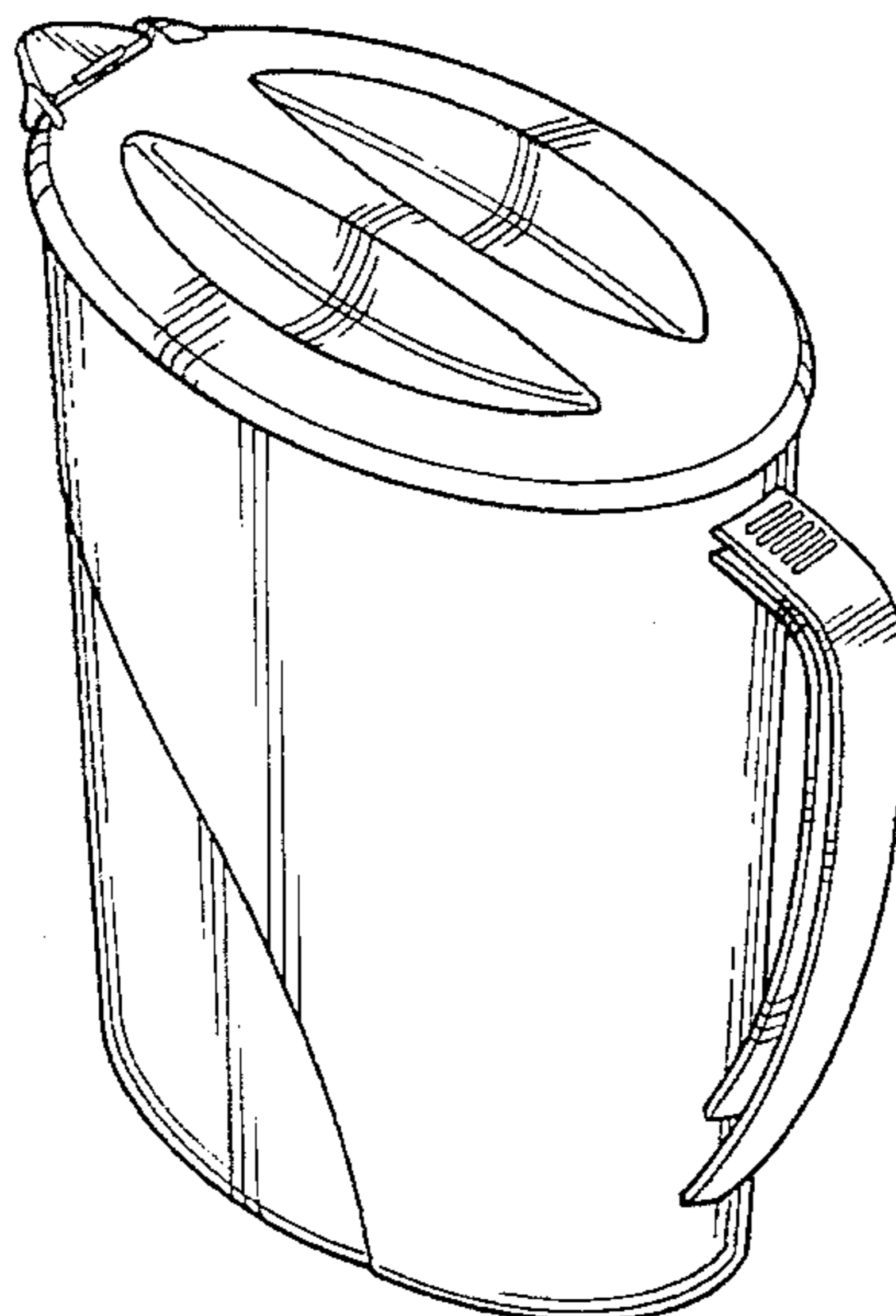
FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image;

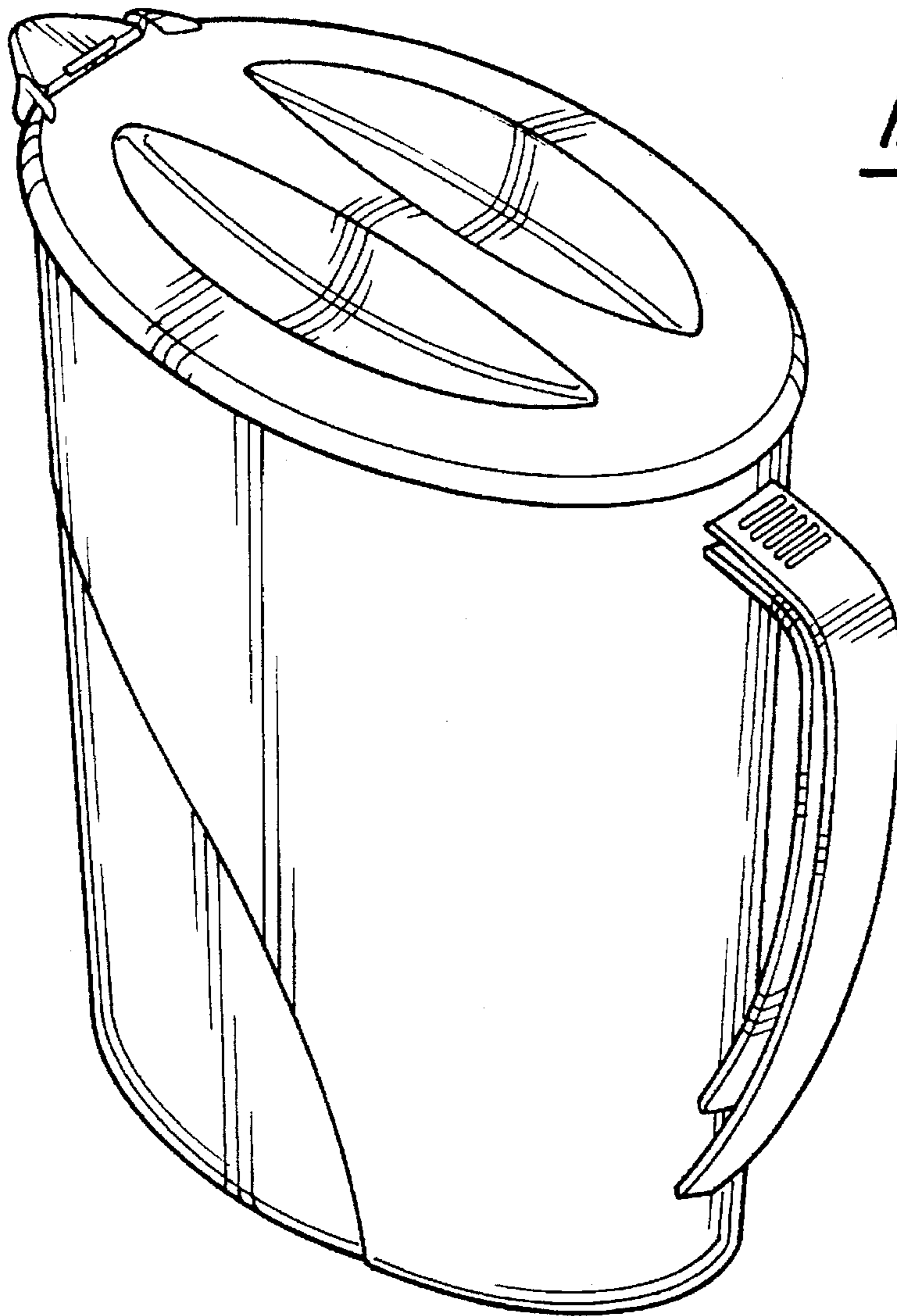
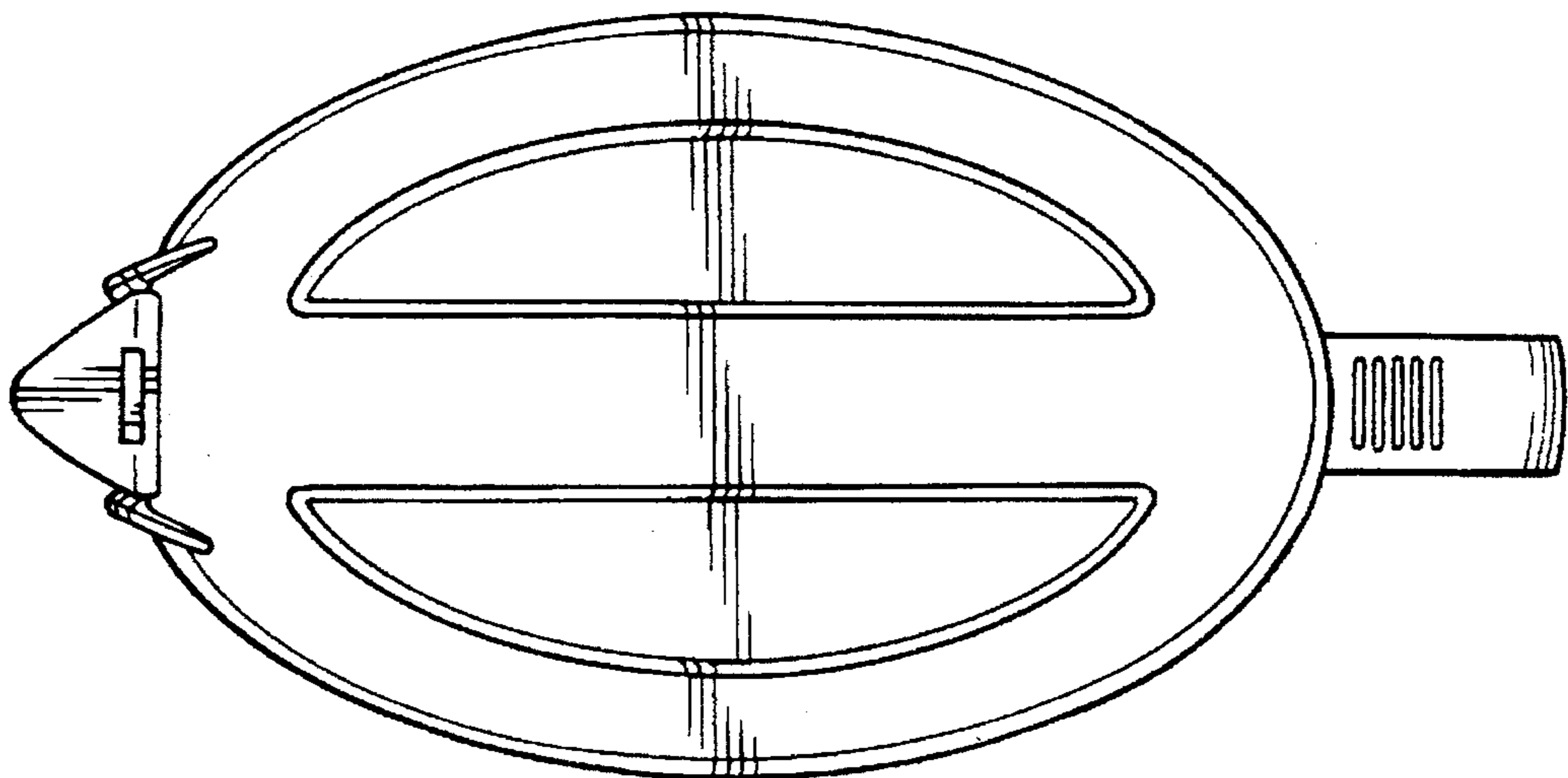

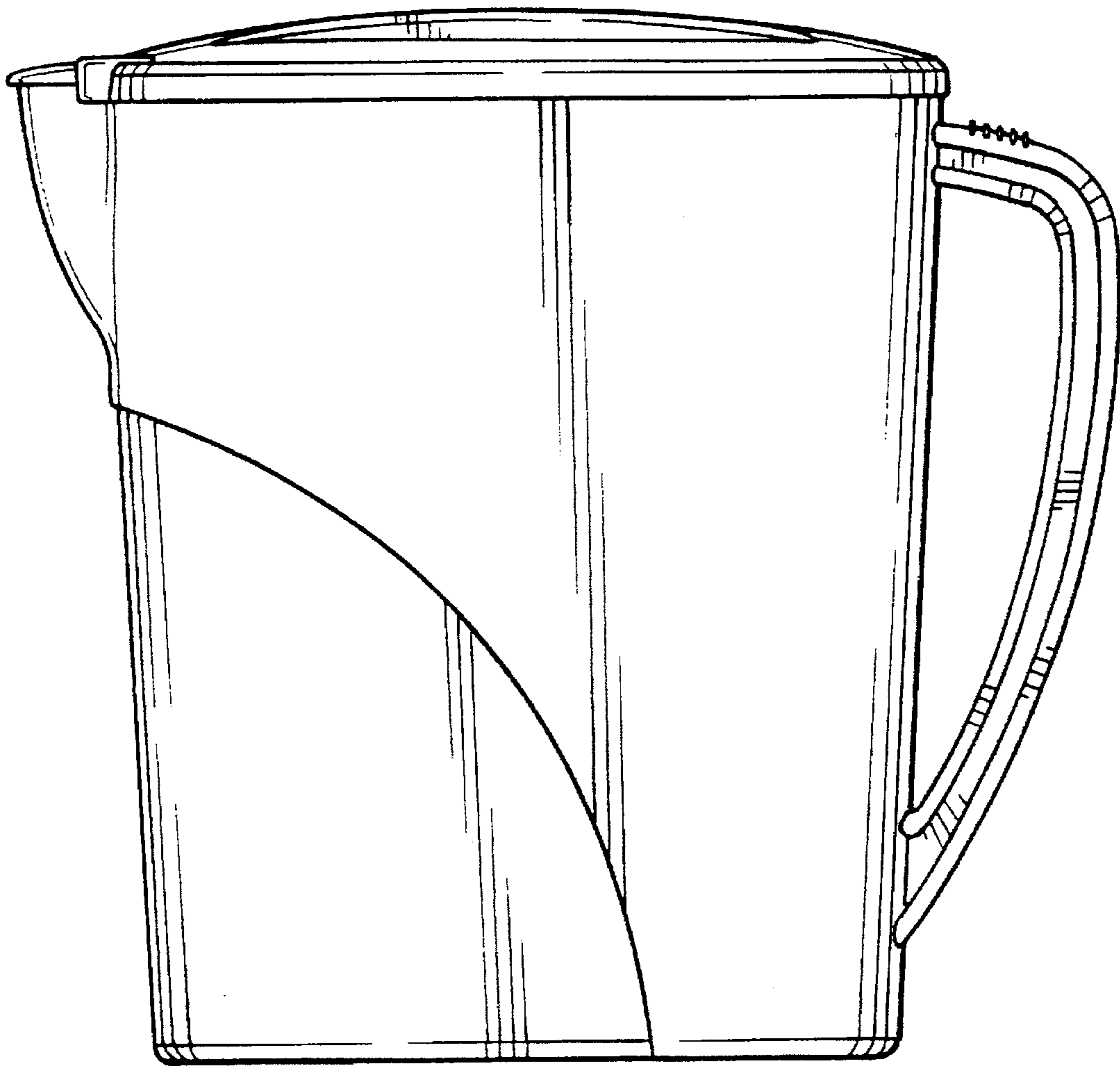
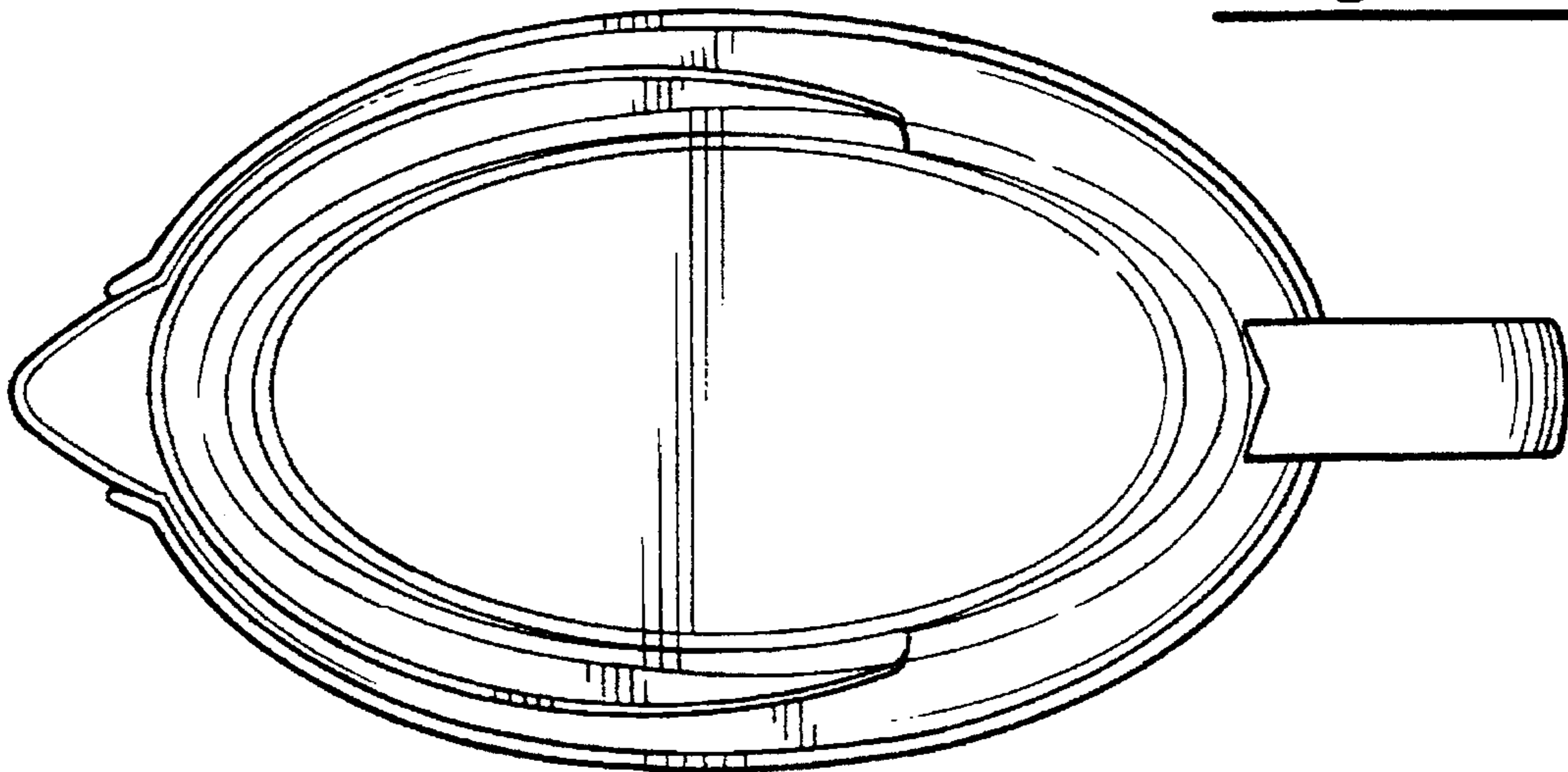

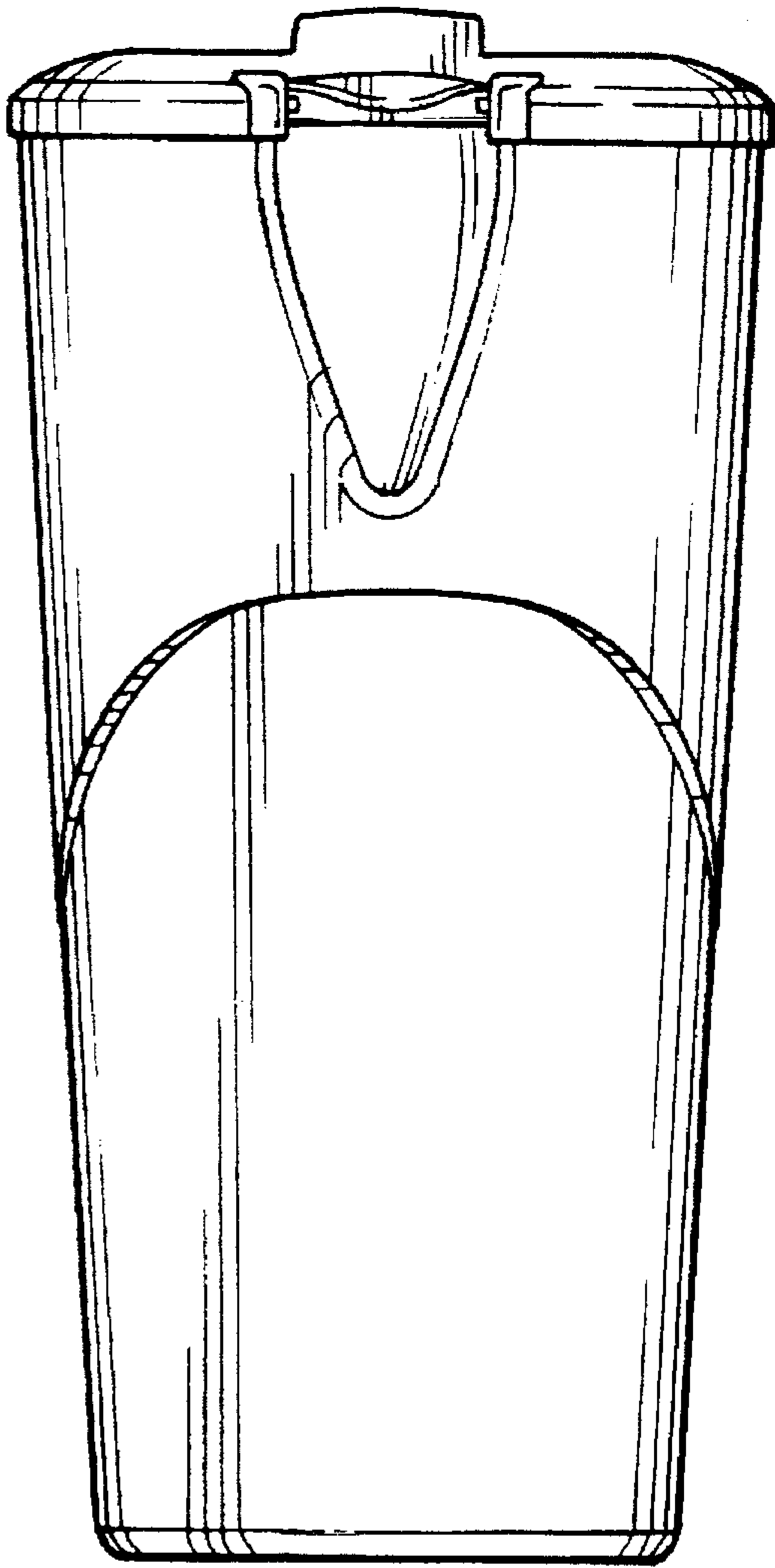

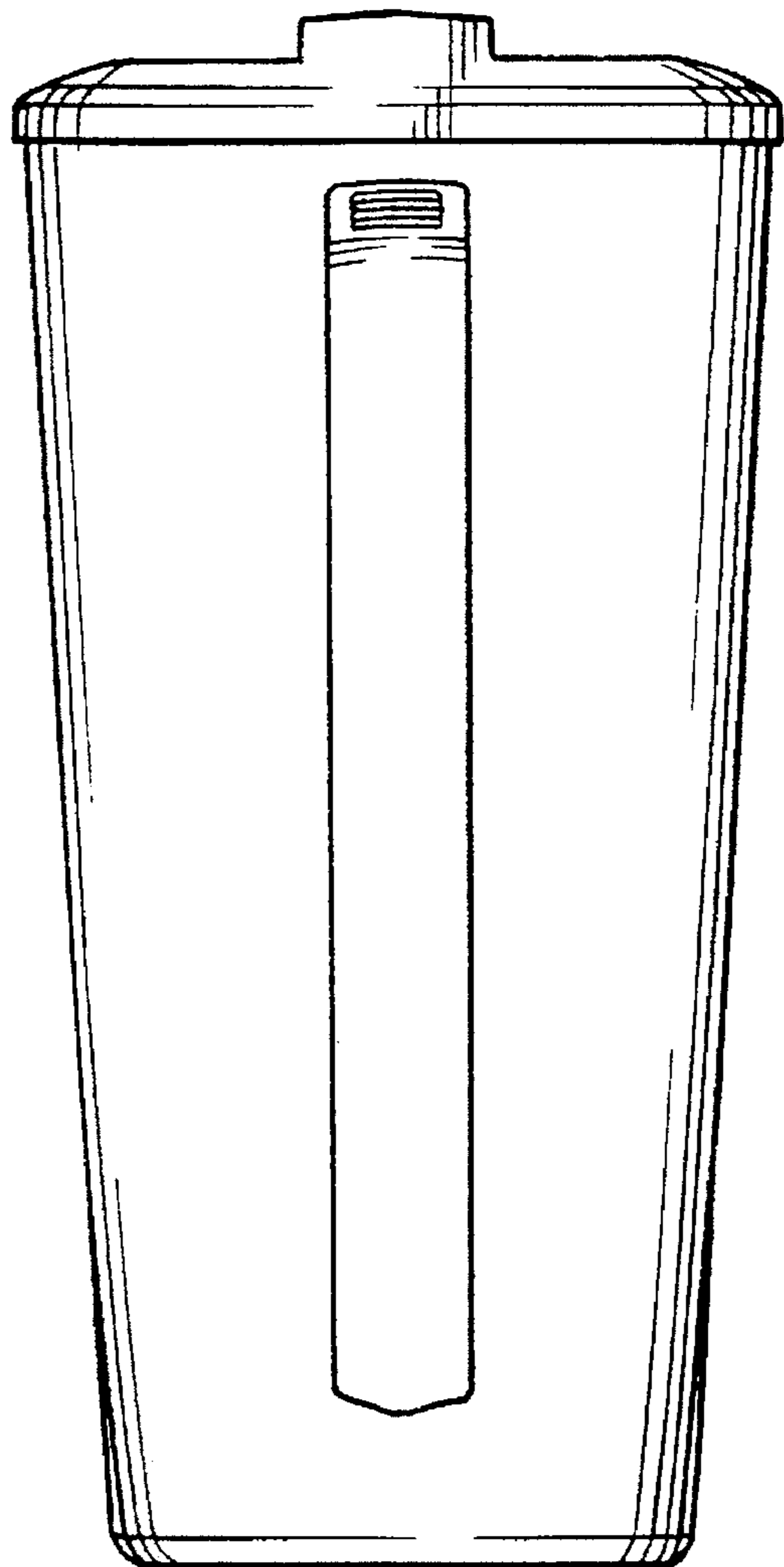
