[57] CLAIM

The ornamental design for a food grill and catch pan for use in conventional ovens, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the food grill and catch pan for use in conventional ovens showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a right view thereof; FIG. 4 is a left view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is an exploded perspective view thereof.

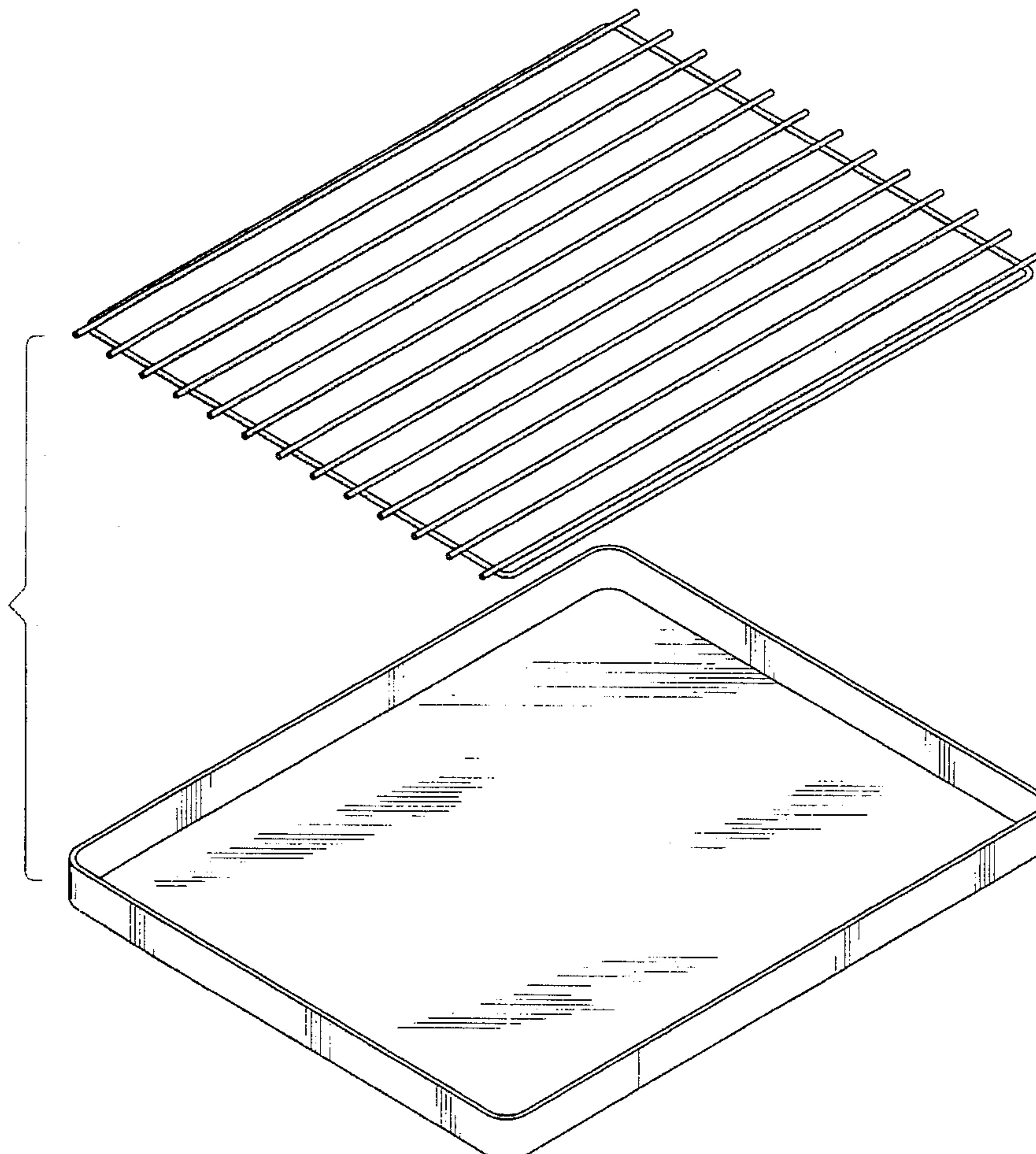

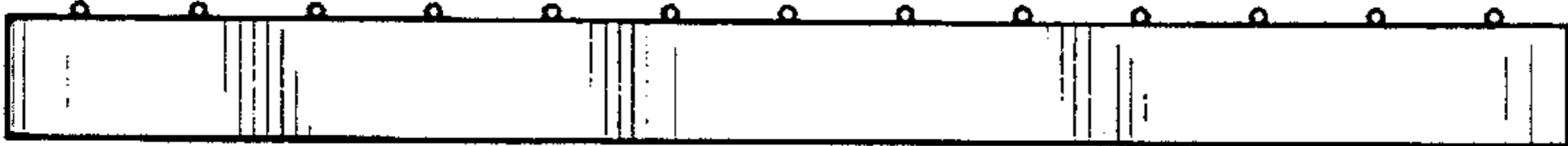

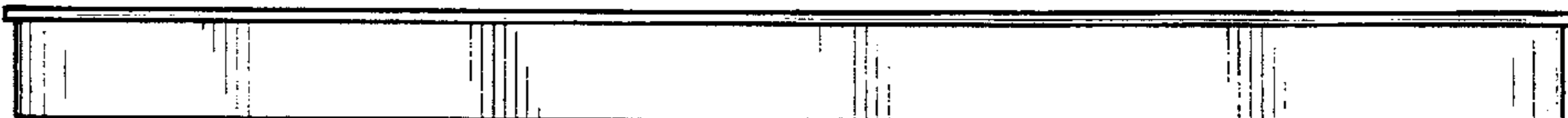

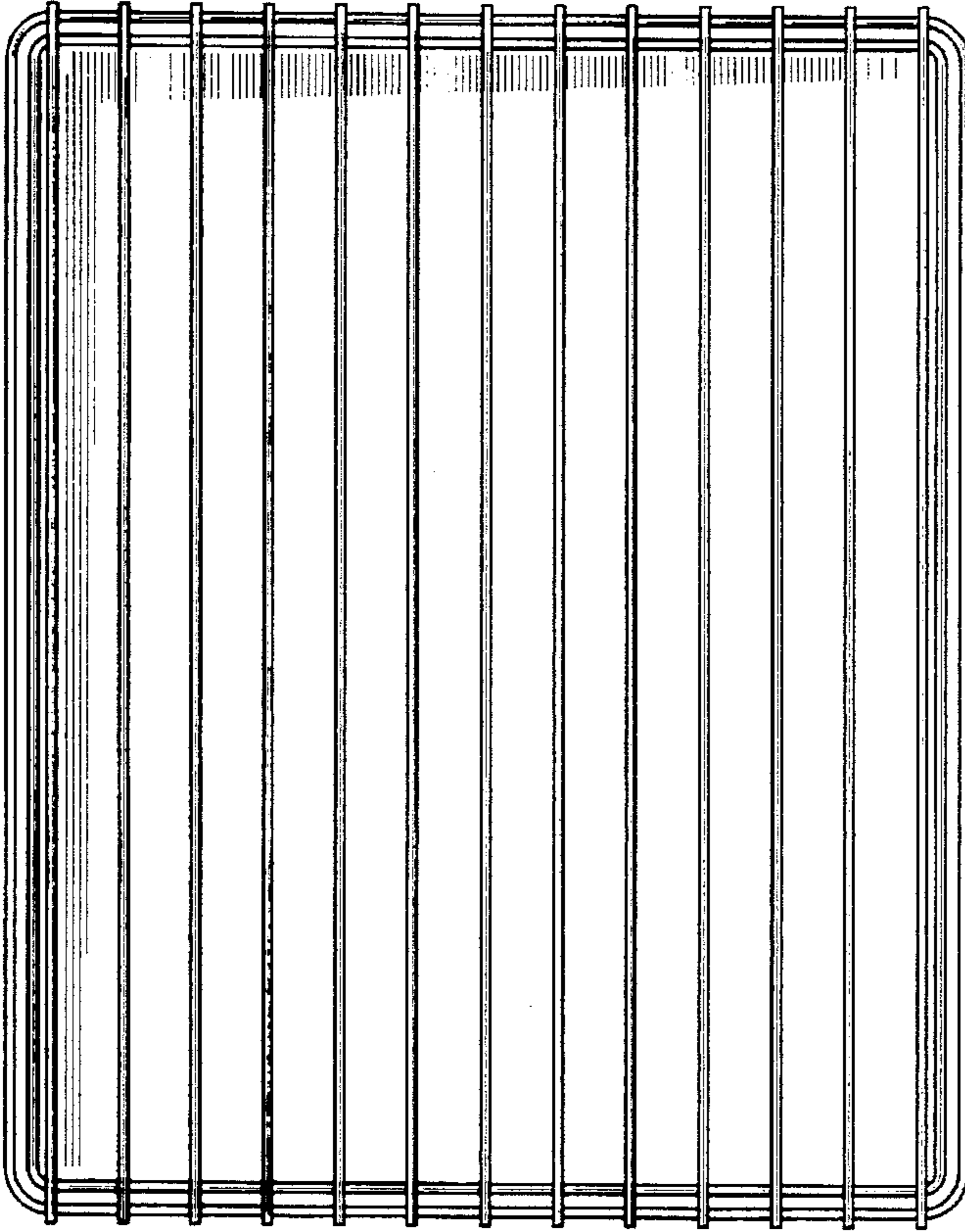

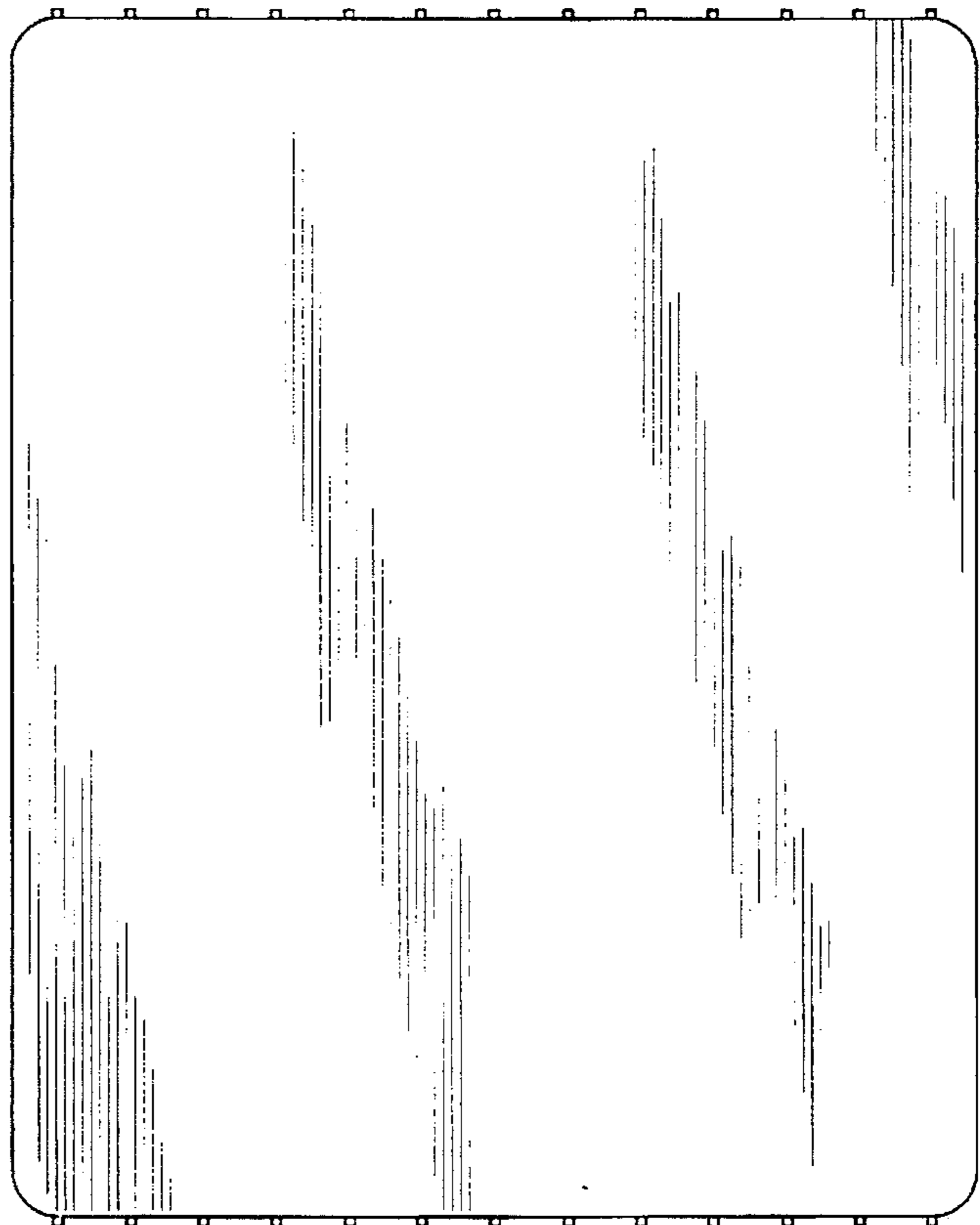
