[57] **CLAIM**

The ornamental design for a combined spray bottle and hull, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a spray bottle showing my new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a left side elevation view thereof, the opposite side being a mirror image;

FIG. 4 is a front elevation view of a combined spray and hull;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a right side elevation view thereof, the opposite side being a mirror image;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a perspective view thereof;

FIG. 10 is a front elevation view of the hull shown separately for clarity of illustration;

FIG. 11 is a rear elevation view thereof;

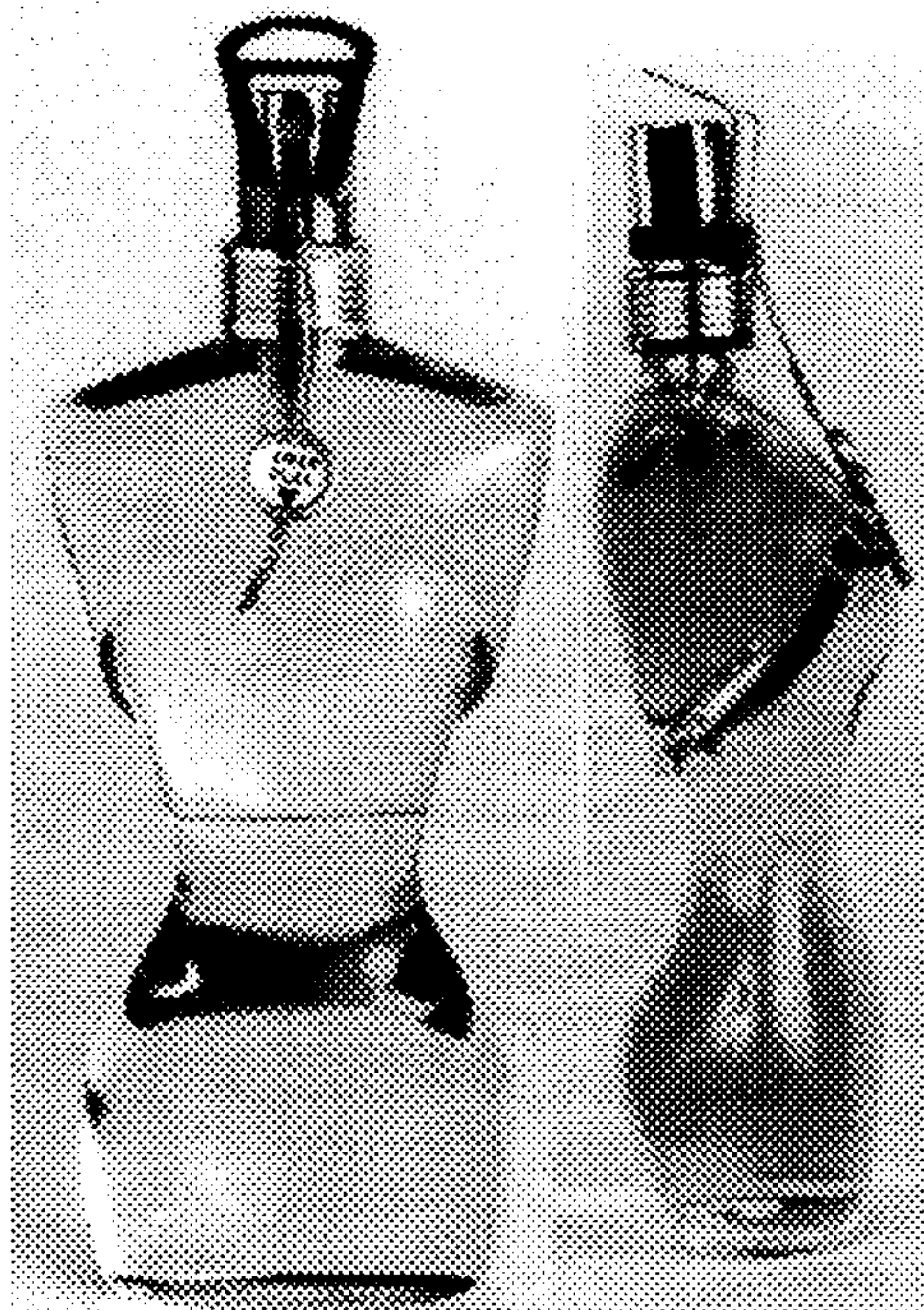
FIG. 12 is a left side elevation view thereof, the opposite side being a mirror image;

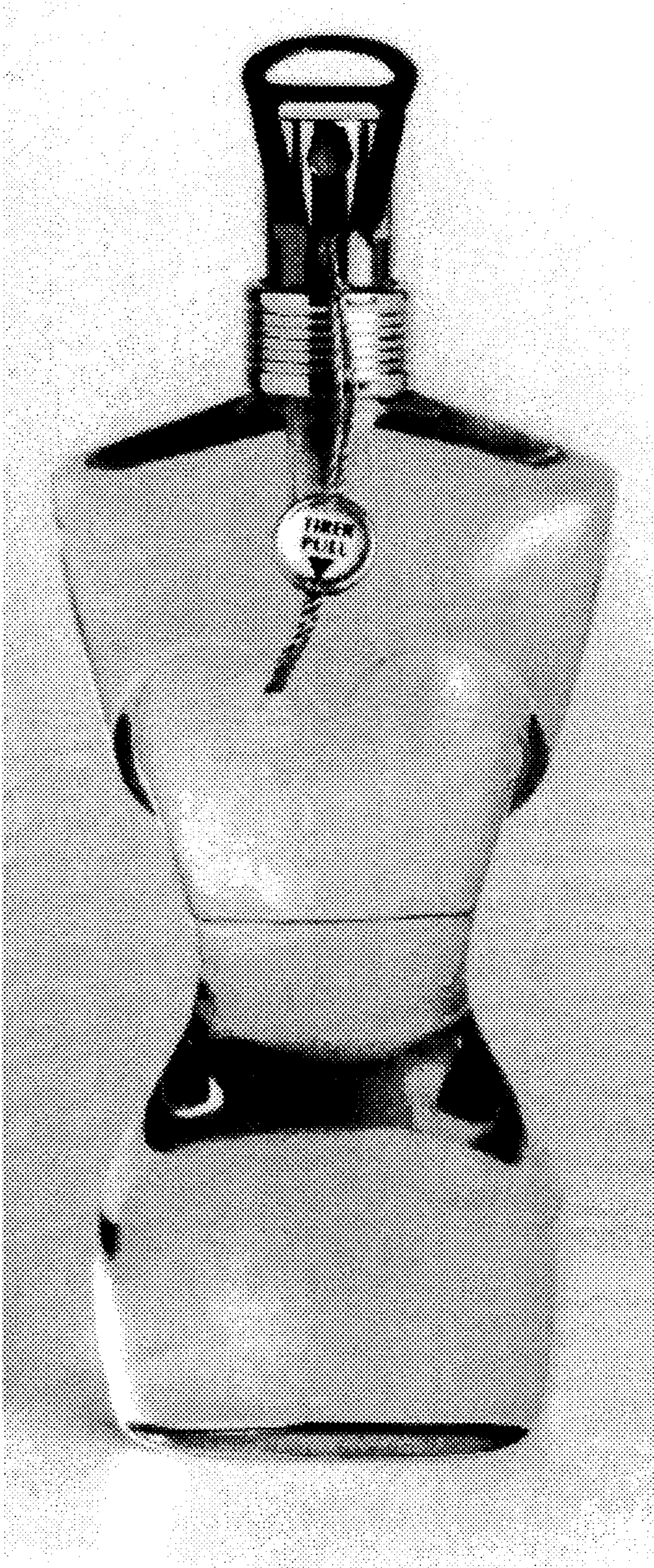

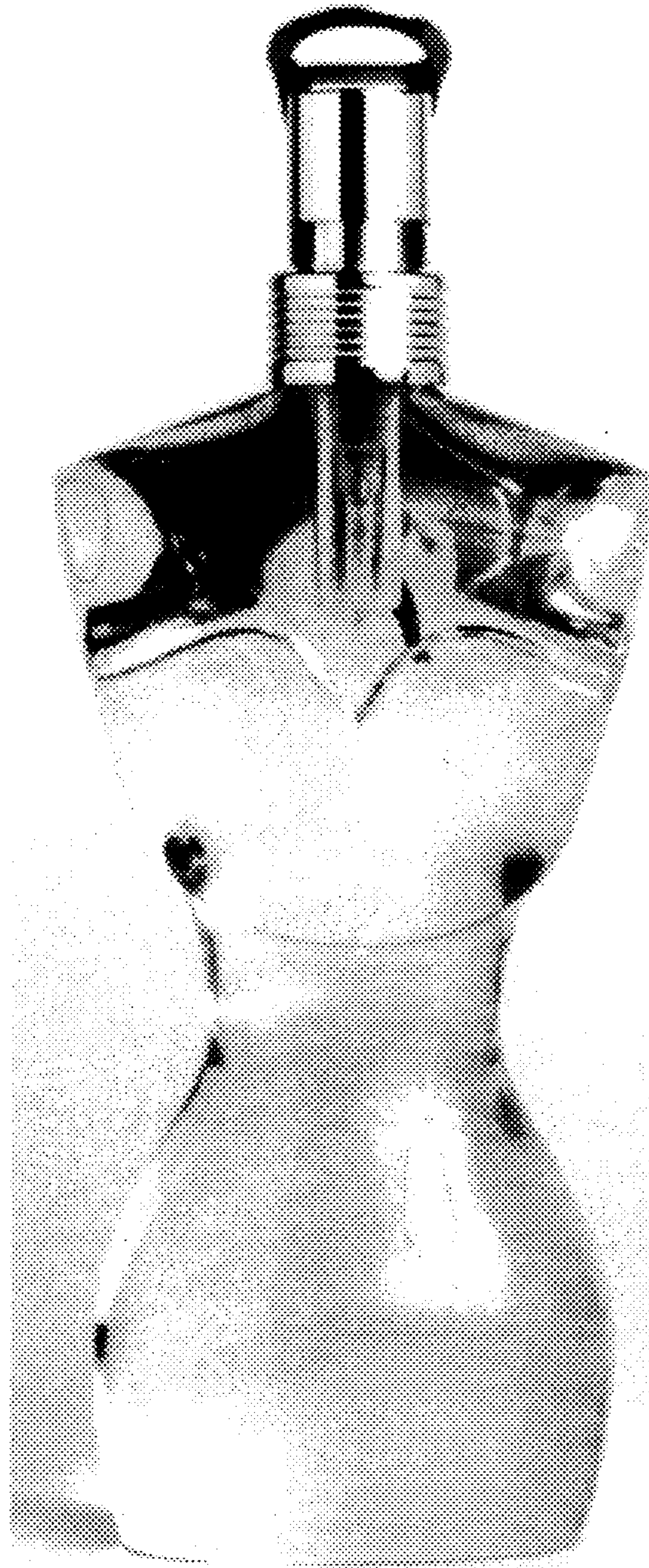

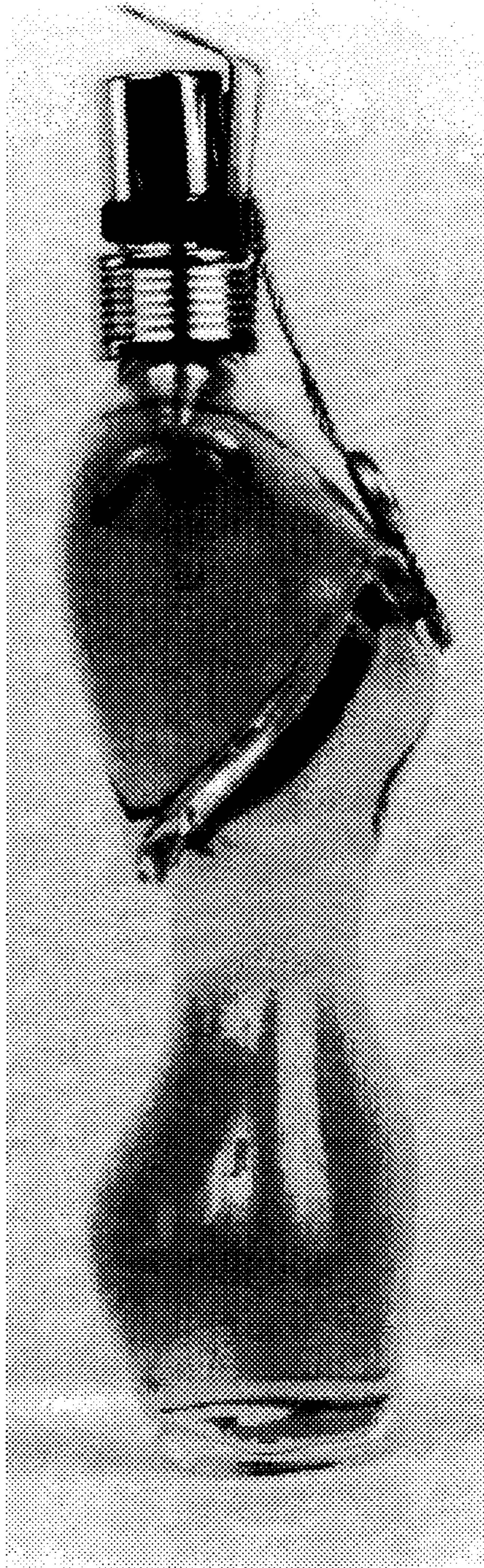

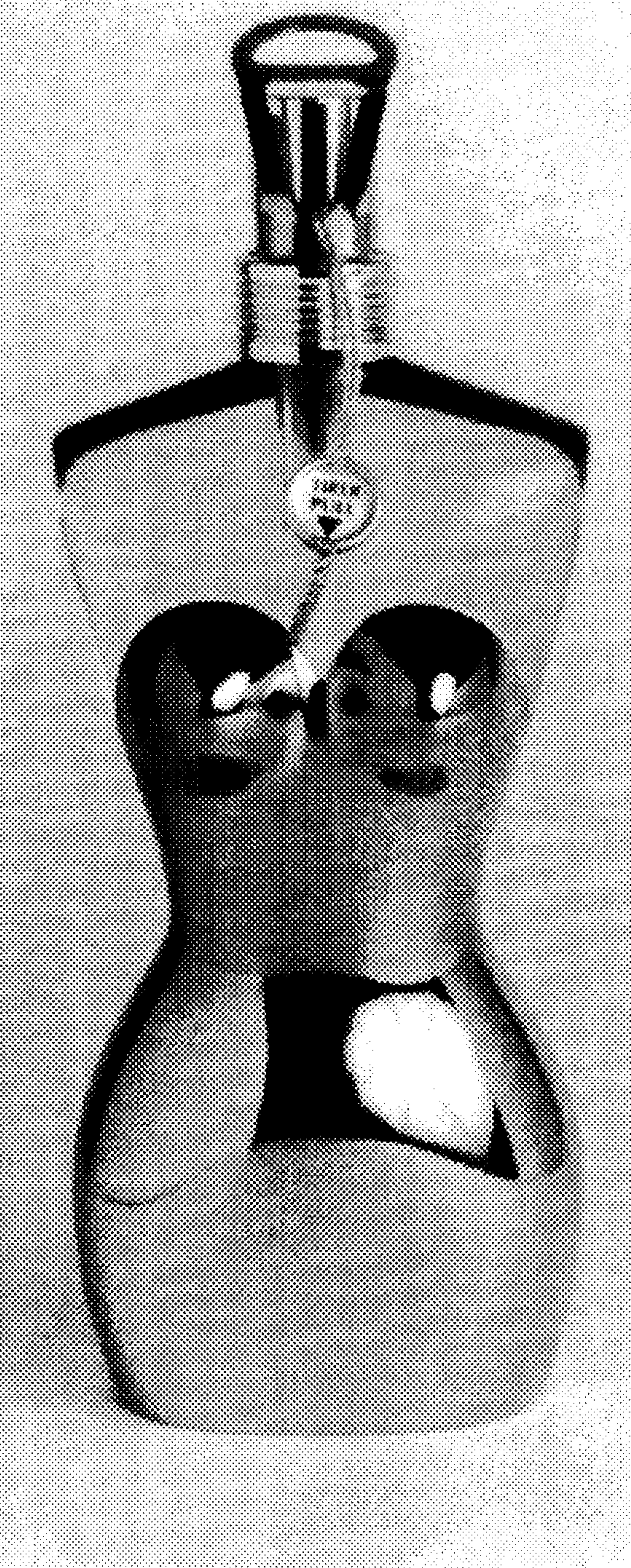

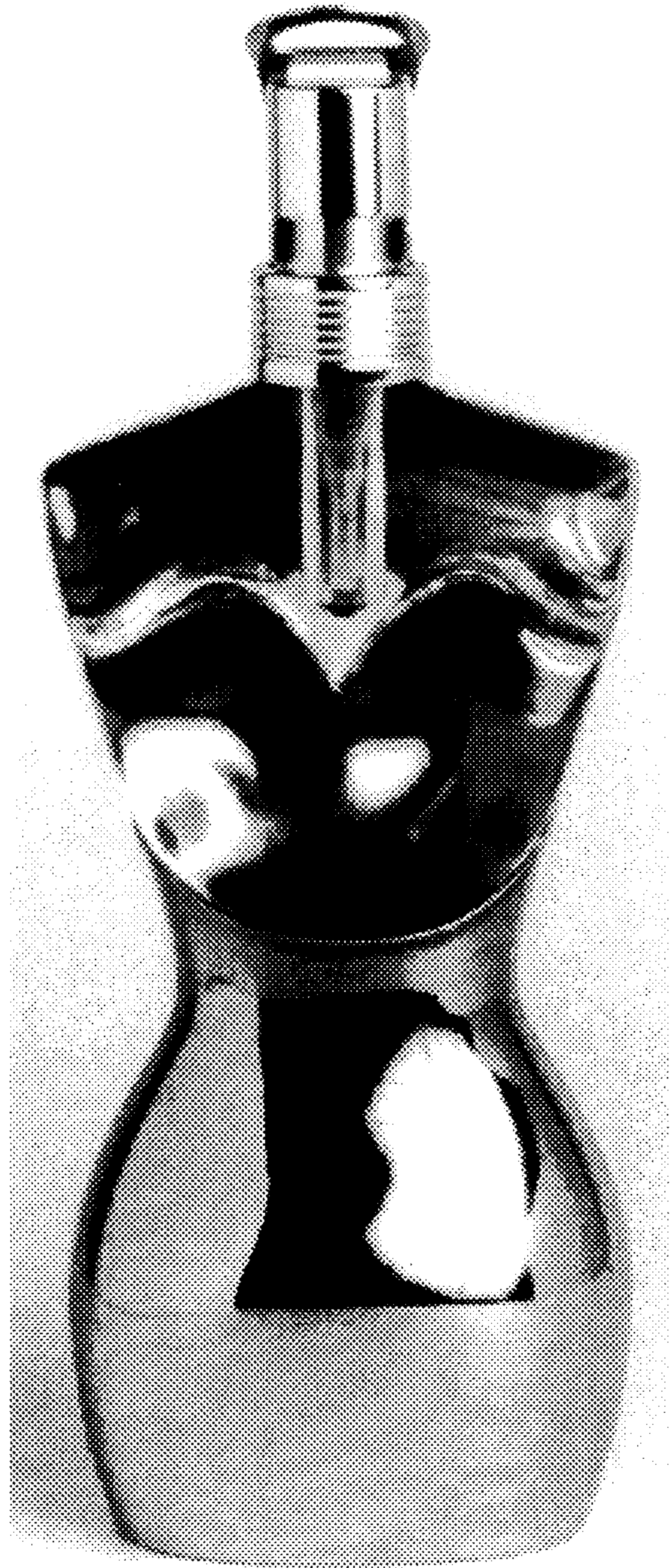

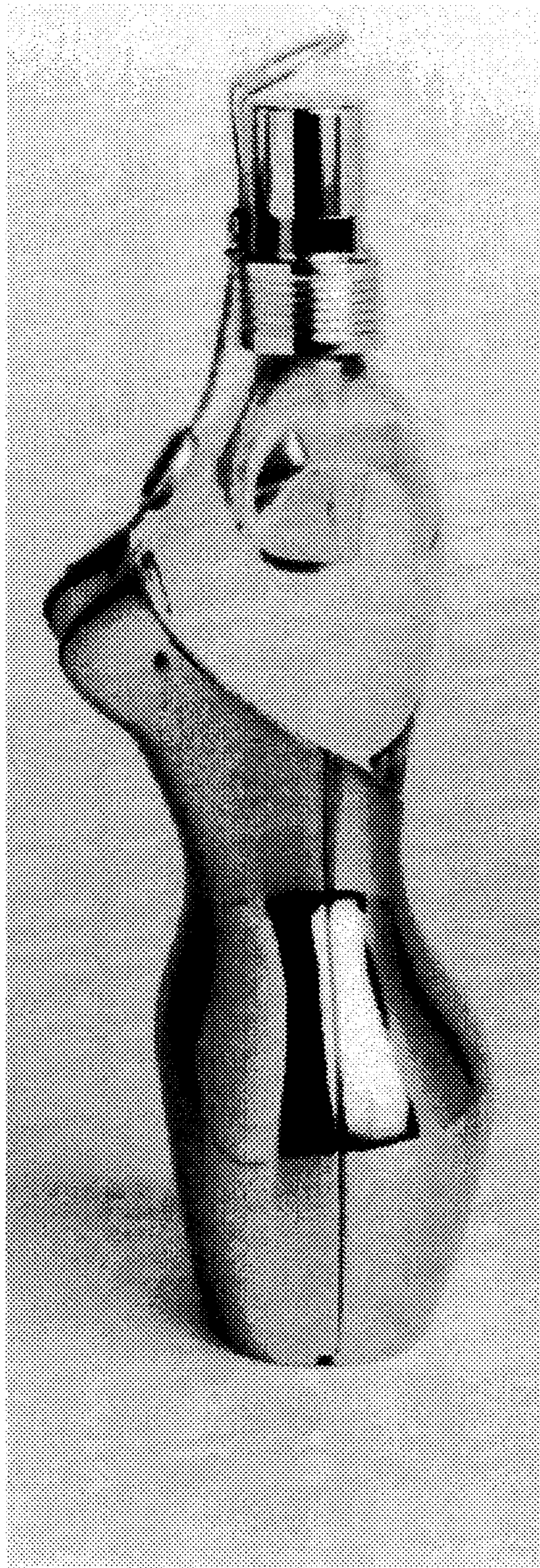

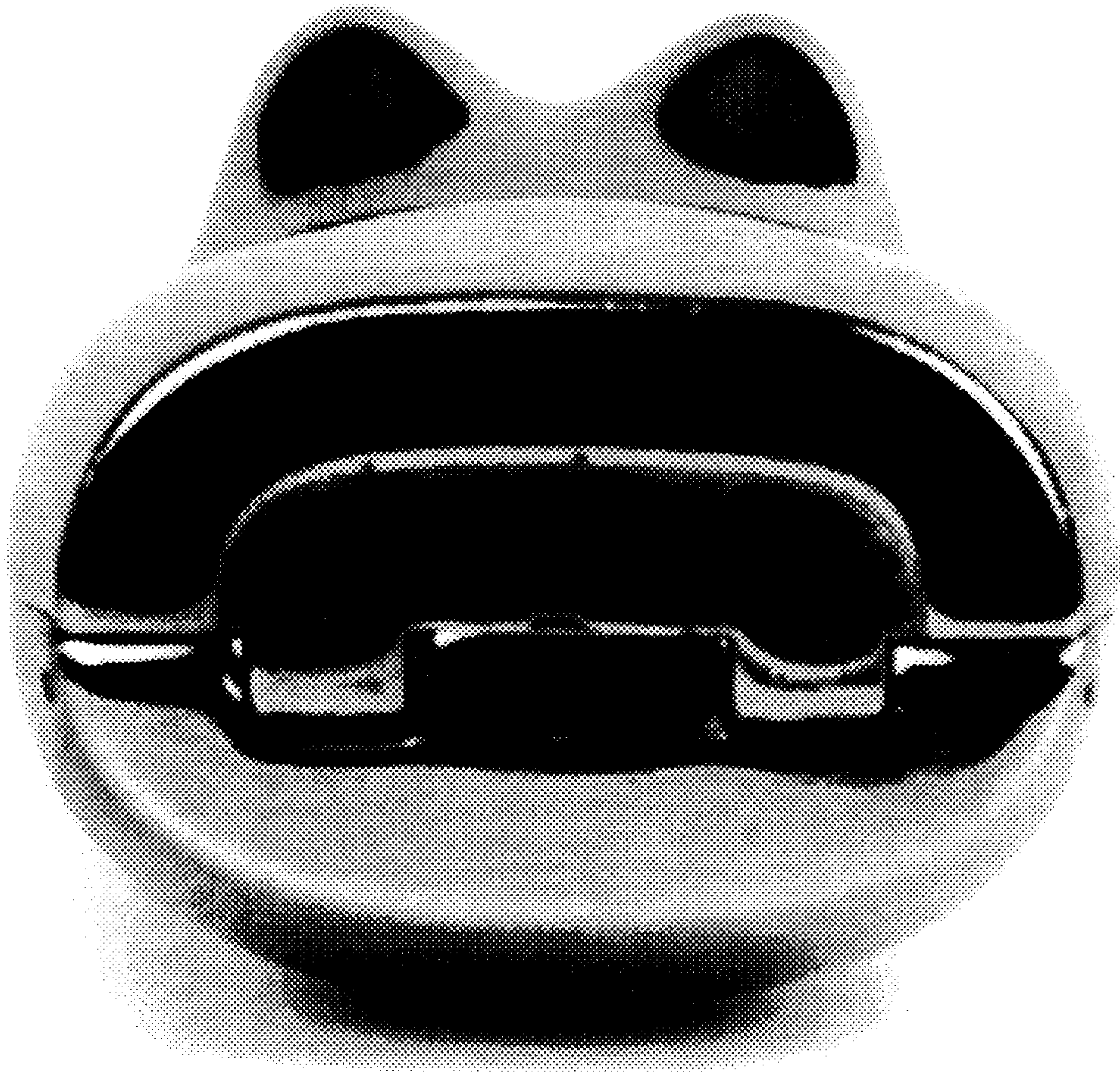

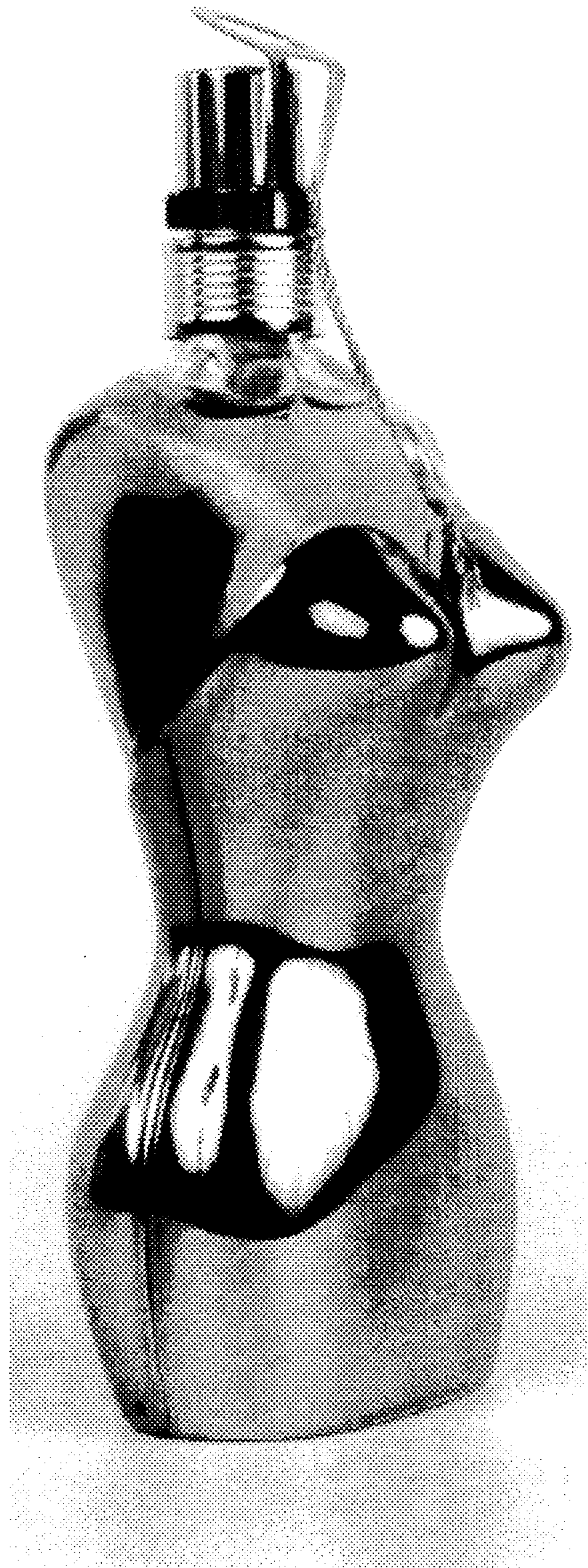

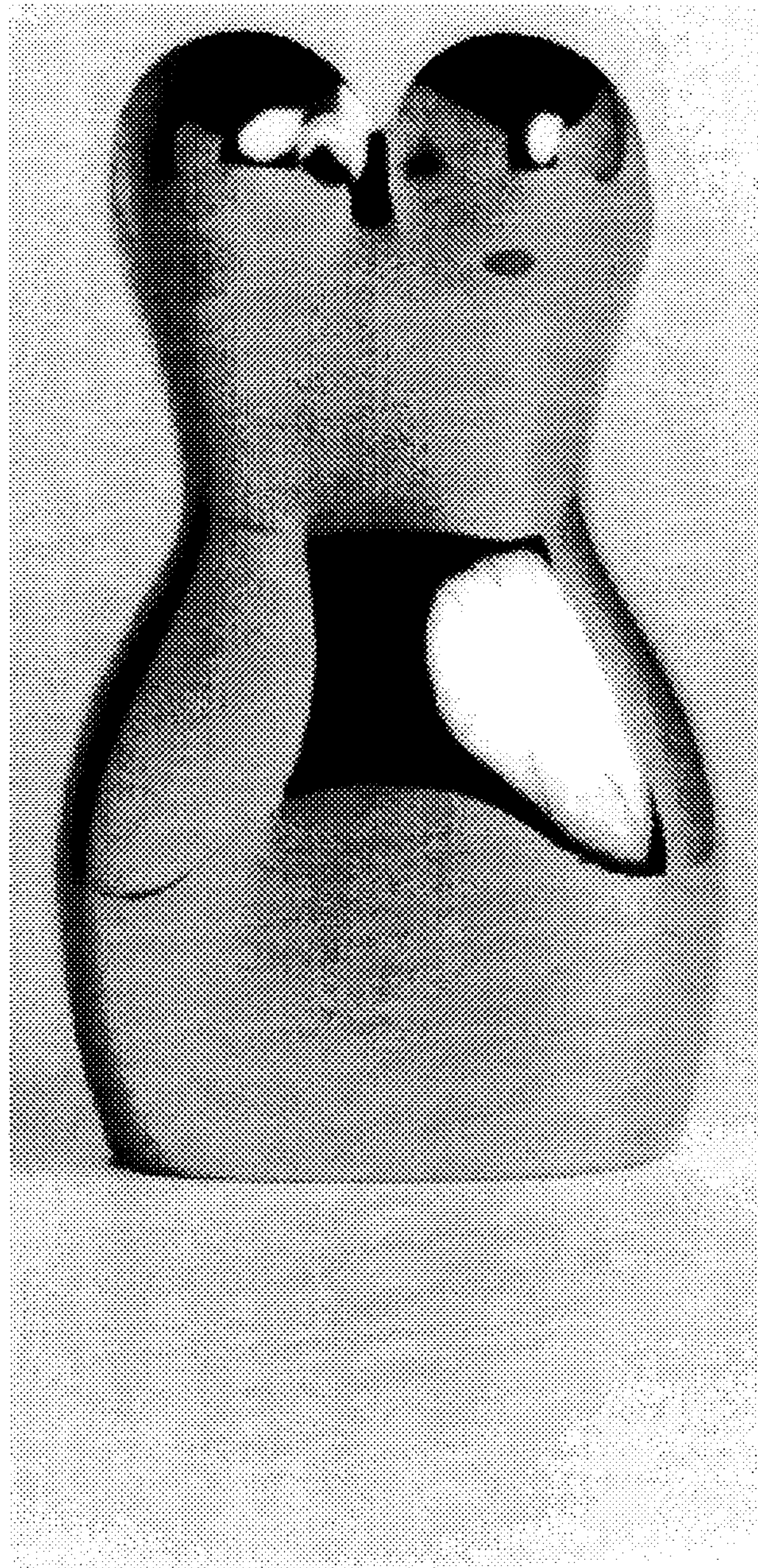

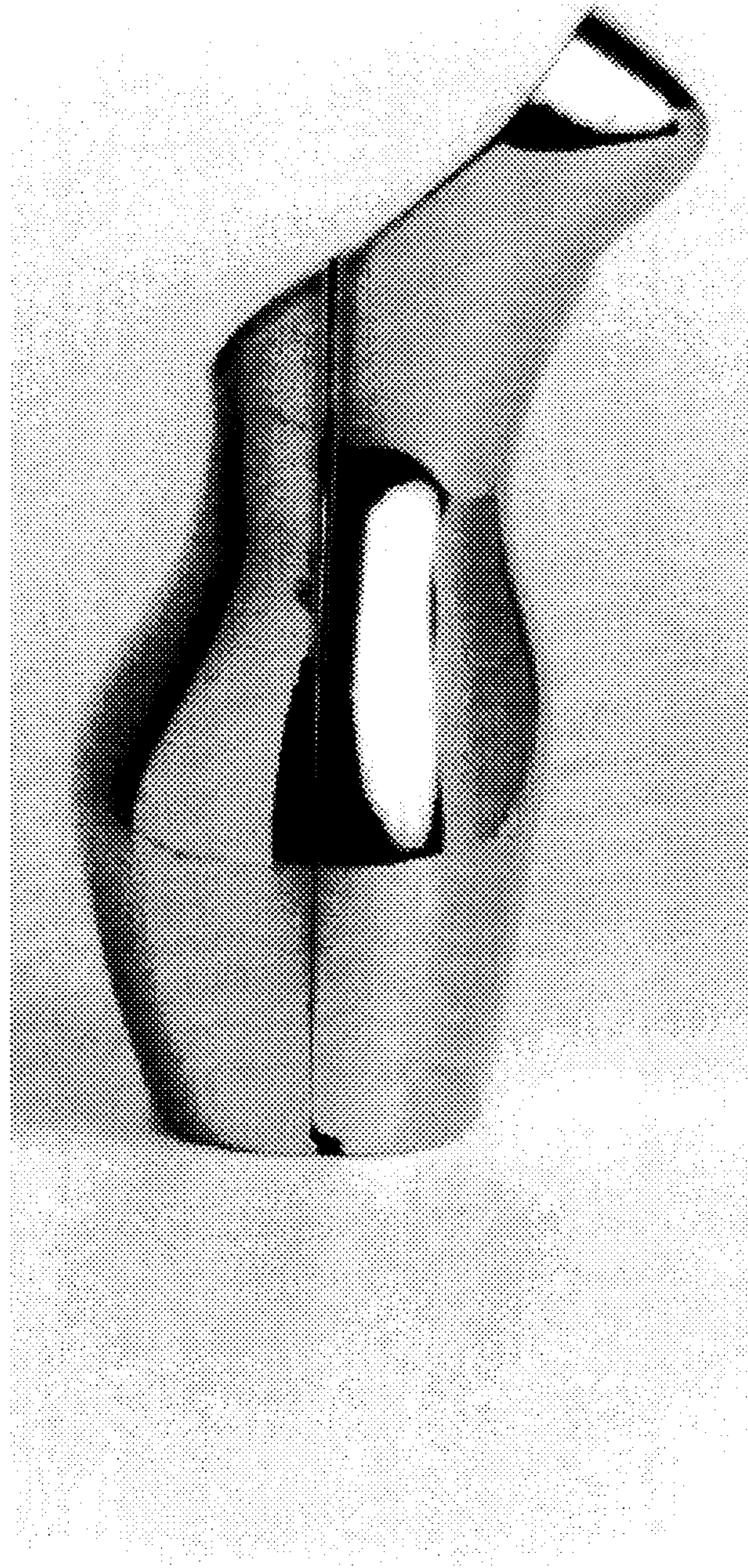

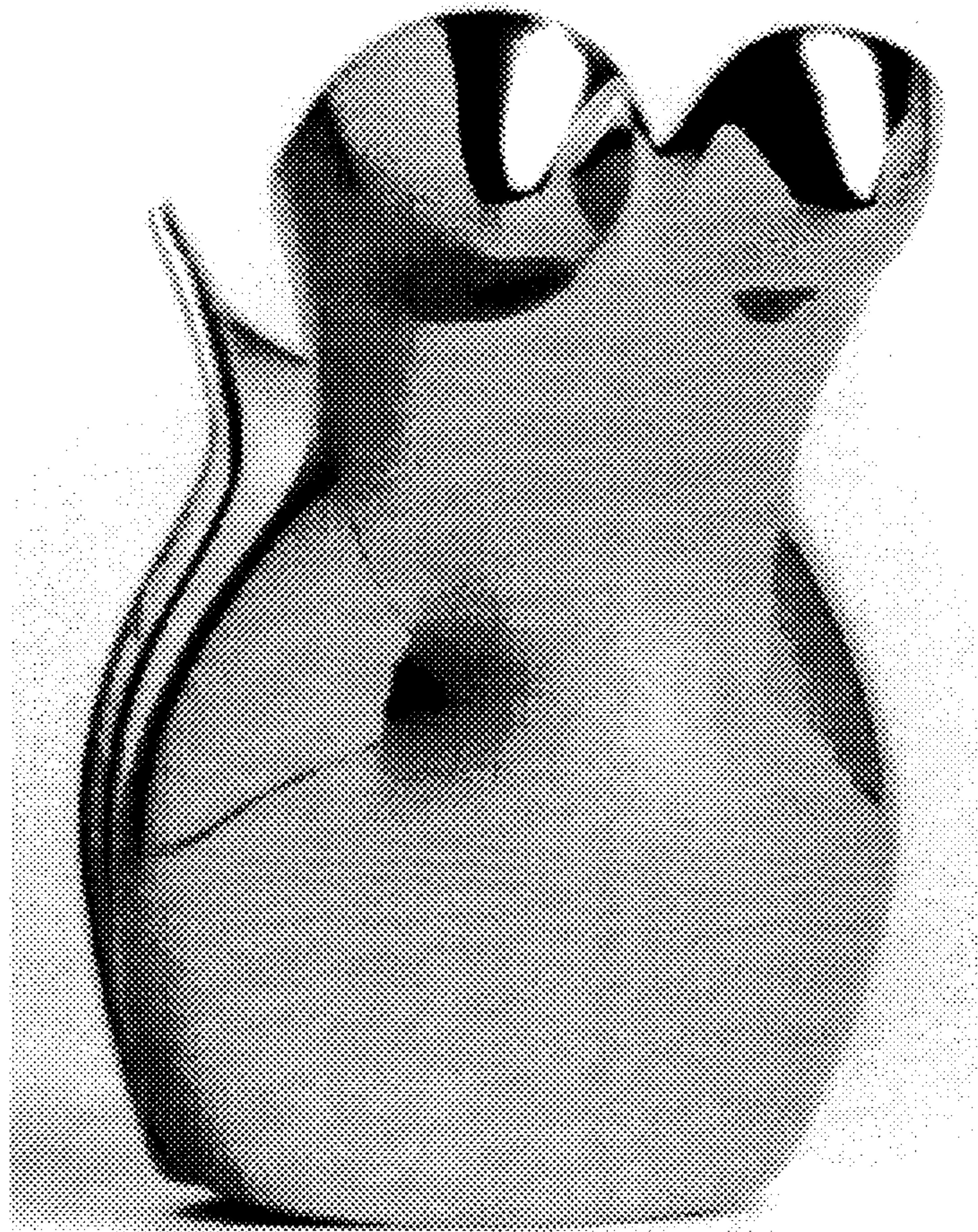

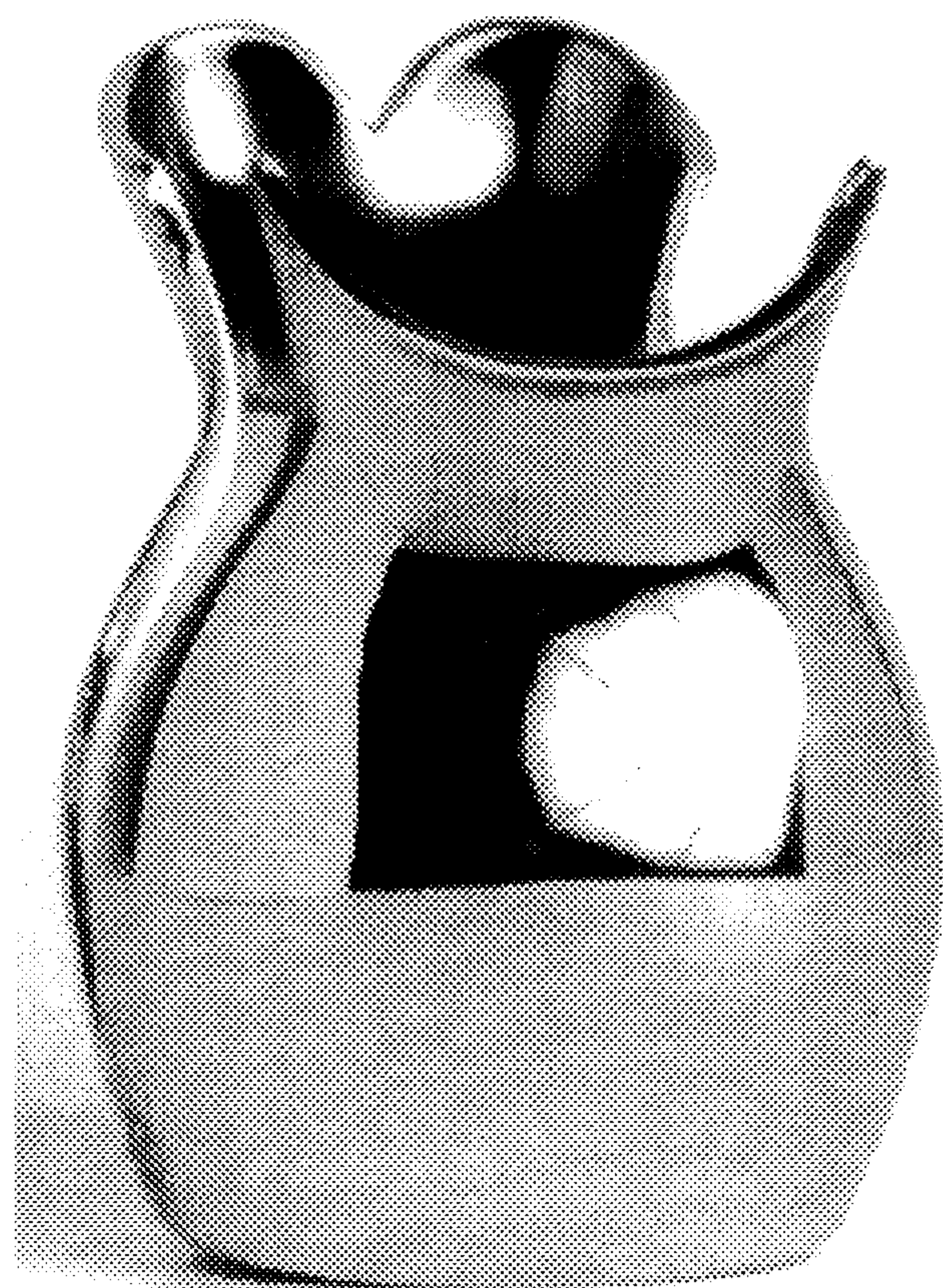

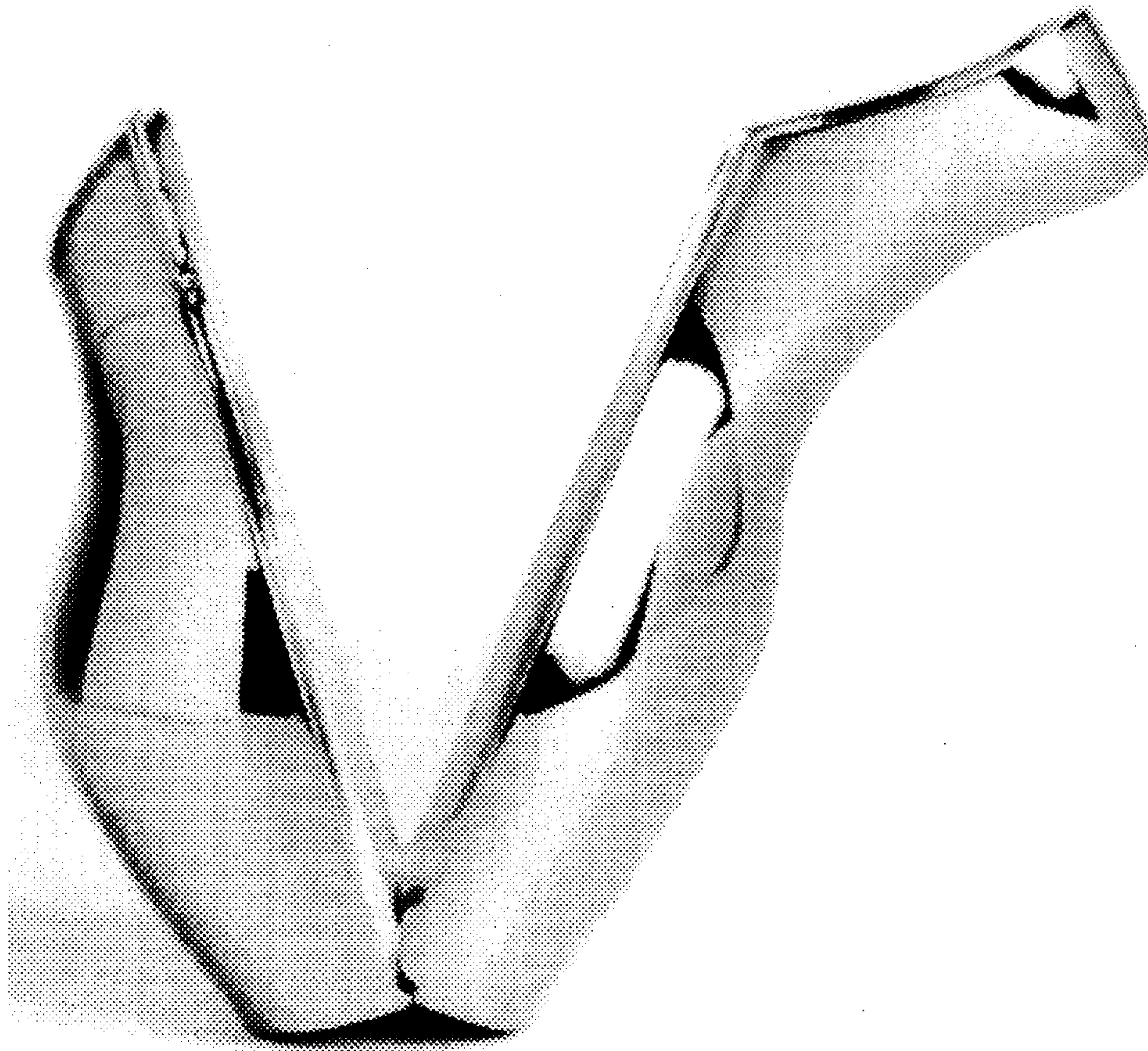
