The ornamental design for a battery eliminator housing for a portable radio, as shown and described.

DESCRIPTION

FIG. 1 is a back elevational view of a battery eliminator housing in accordance with our new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a bottom, right, and back isometric view thereof; and,
 FIG. 8 is a top, left, and front isometric view thereof.

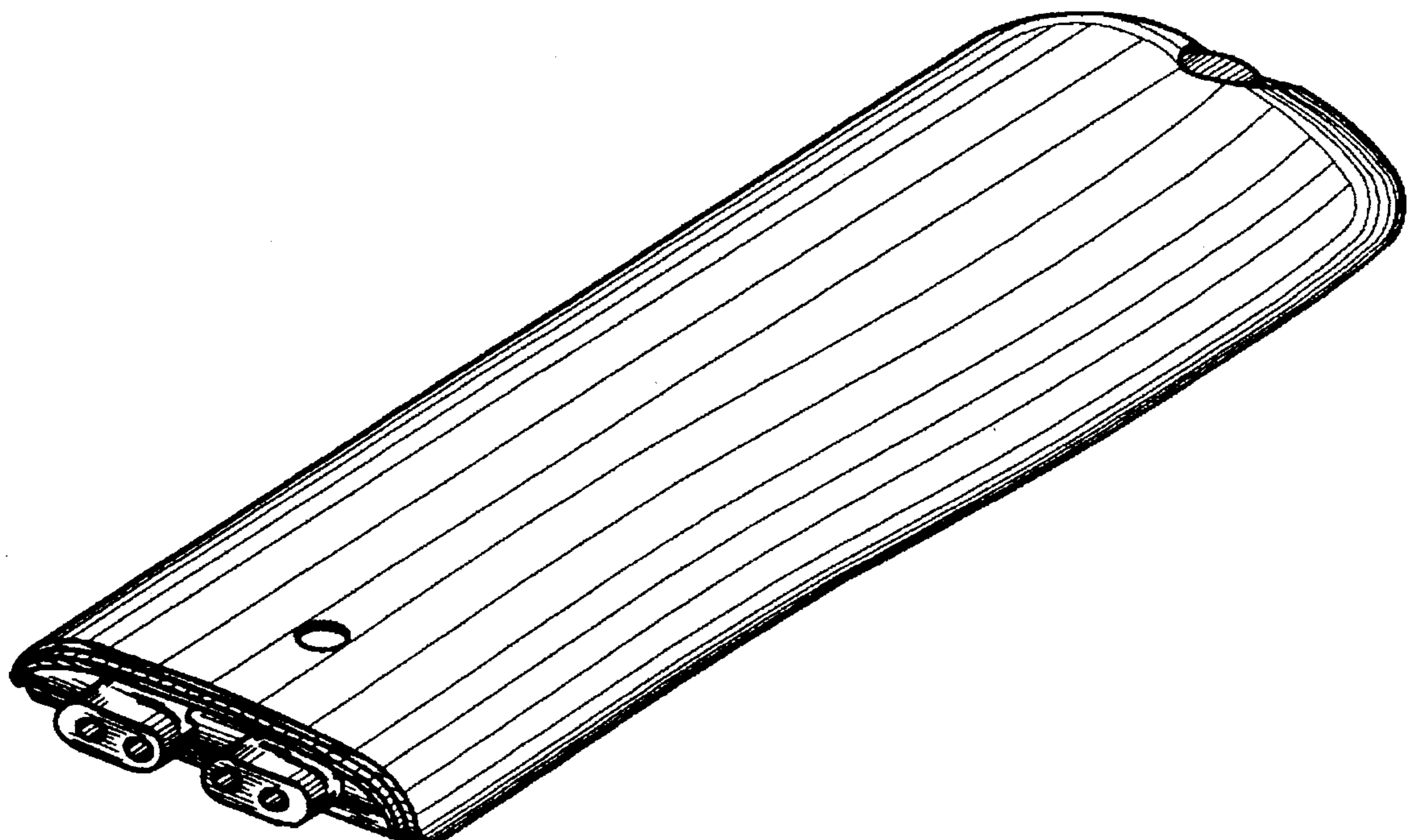

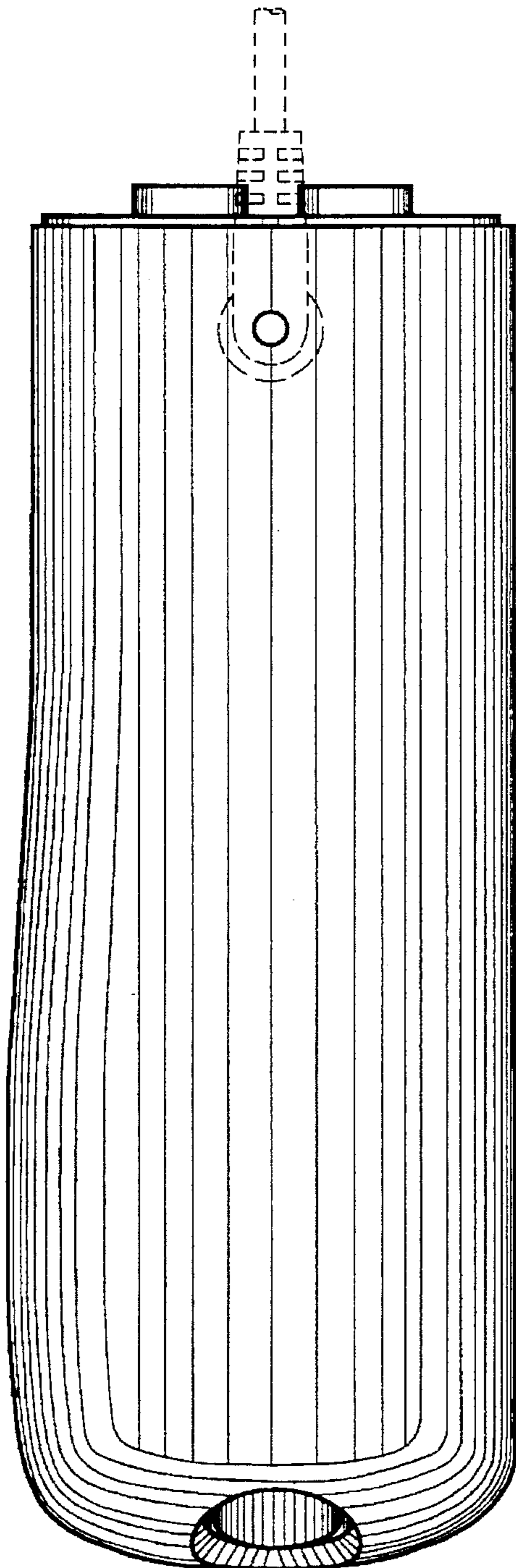

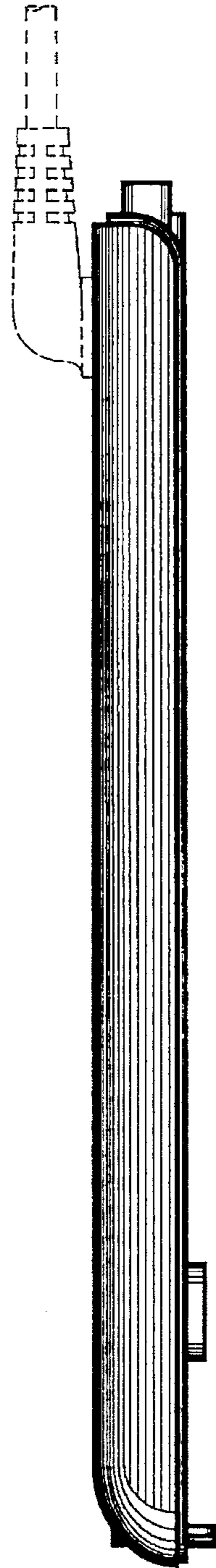

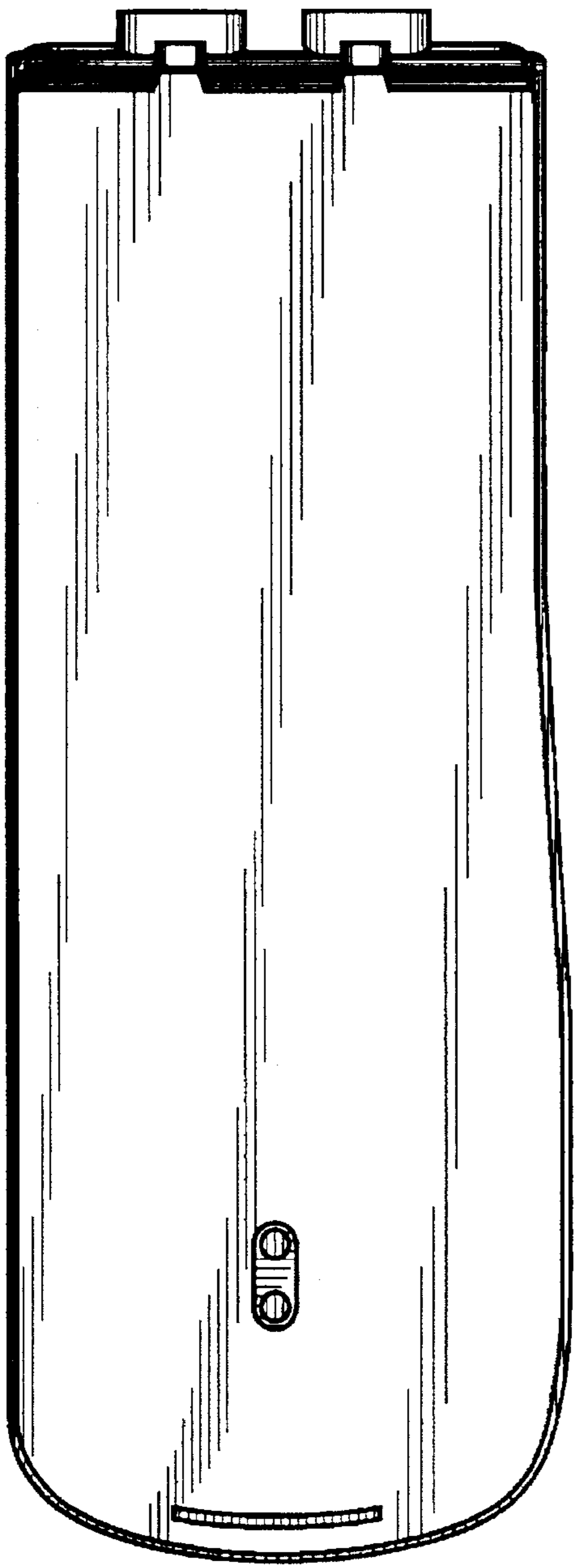

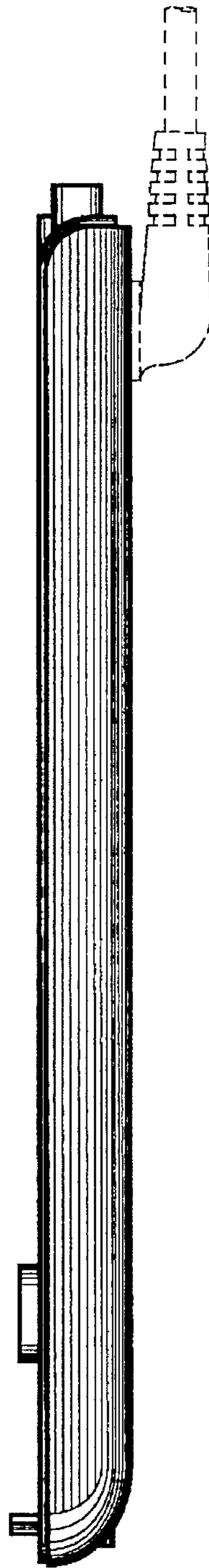

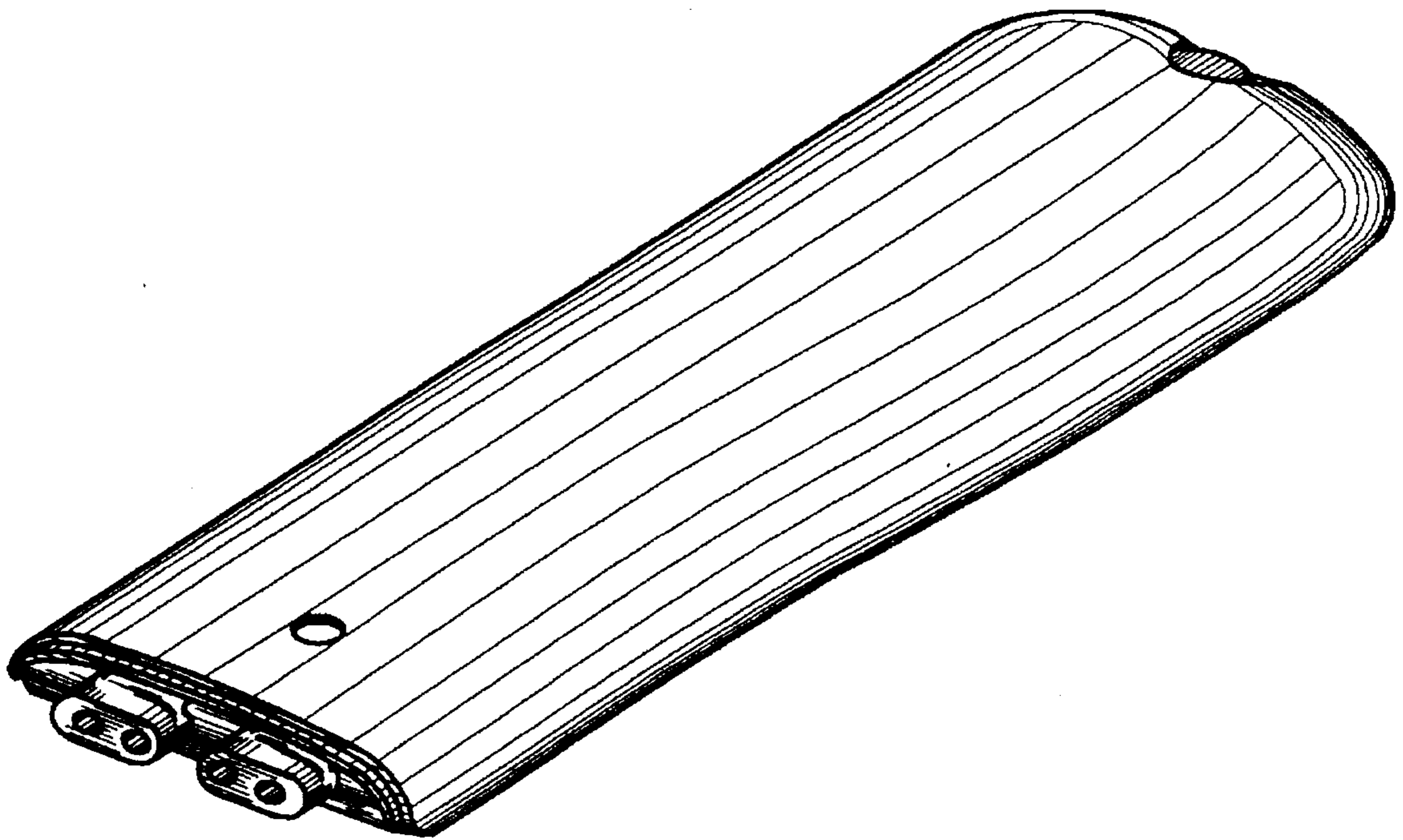

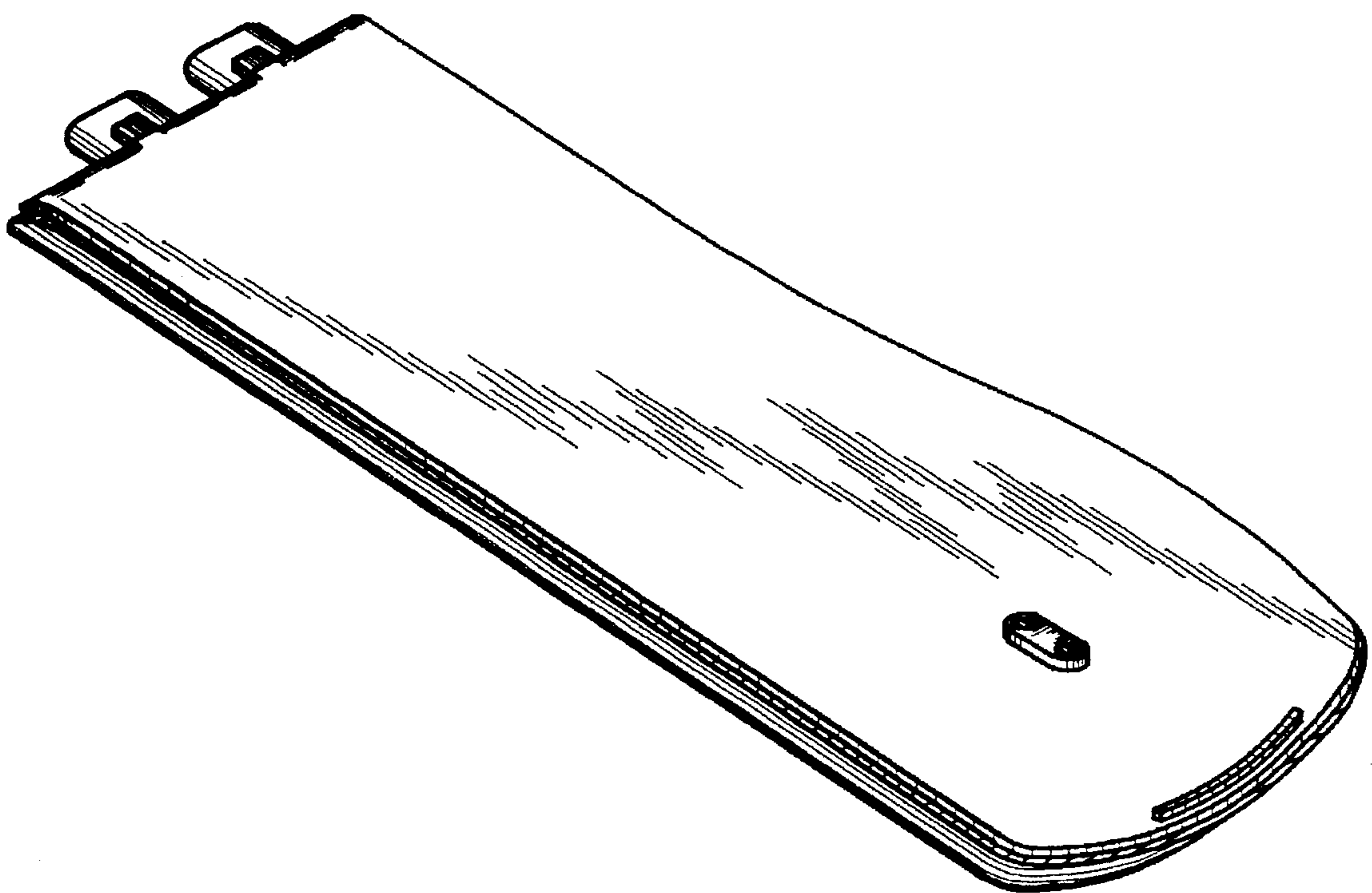
