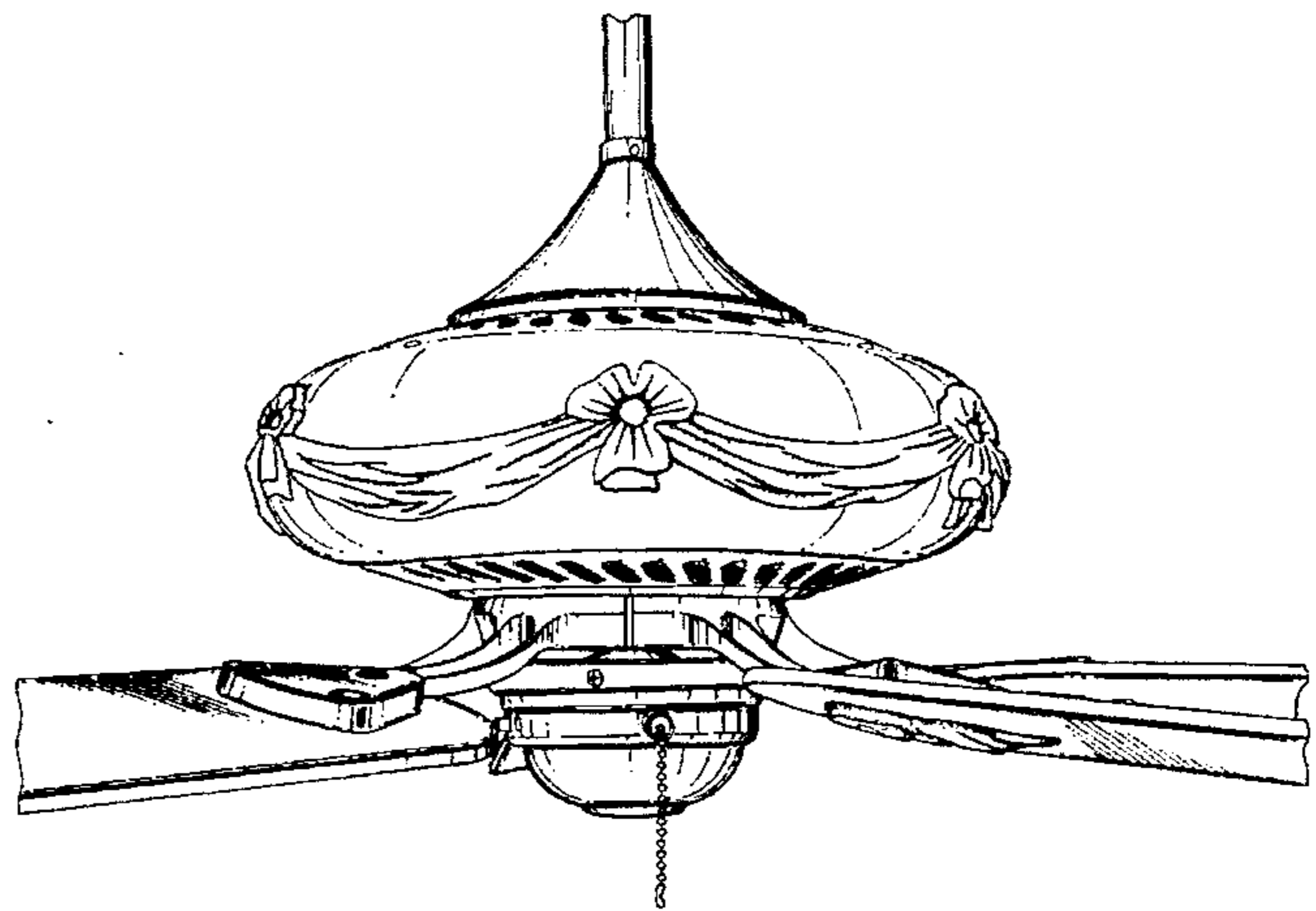
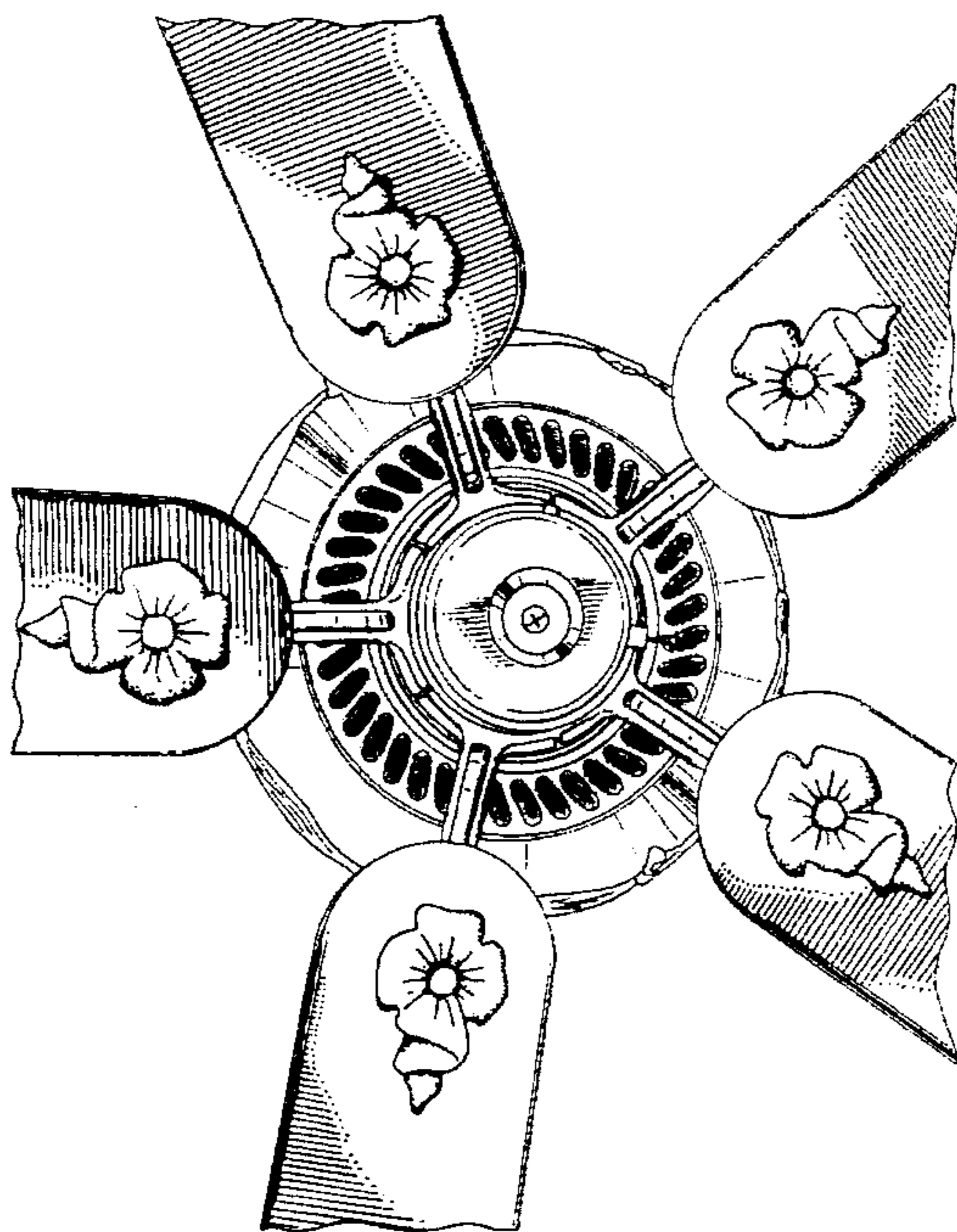
The support rod has been shown broken away to indicate indeterminate length. The cross-hatching represents screening and is understood to extend uniformly throughout the areas represented.

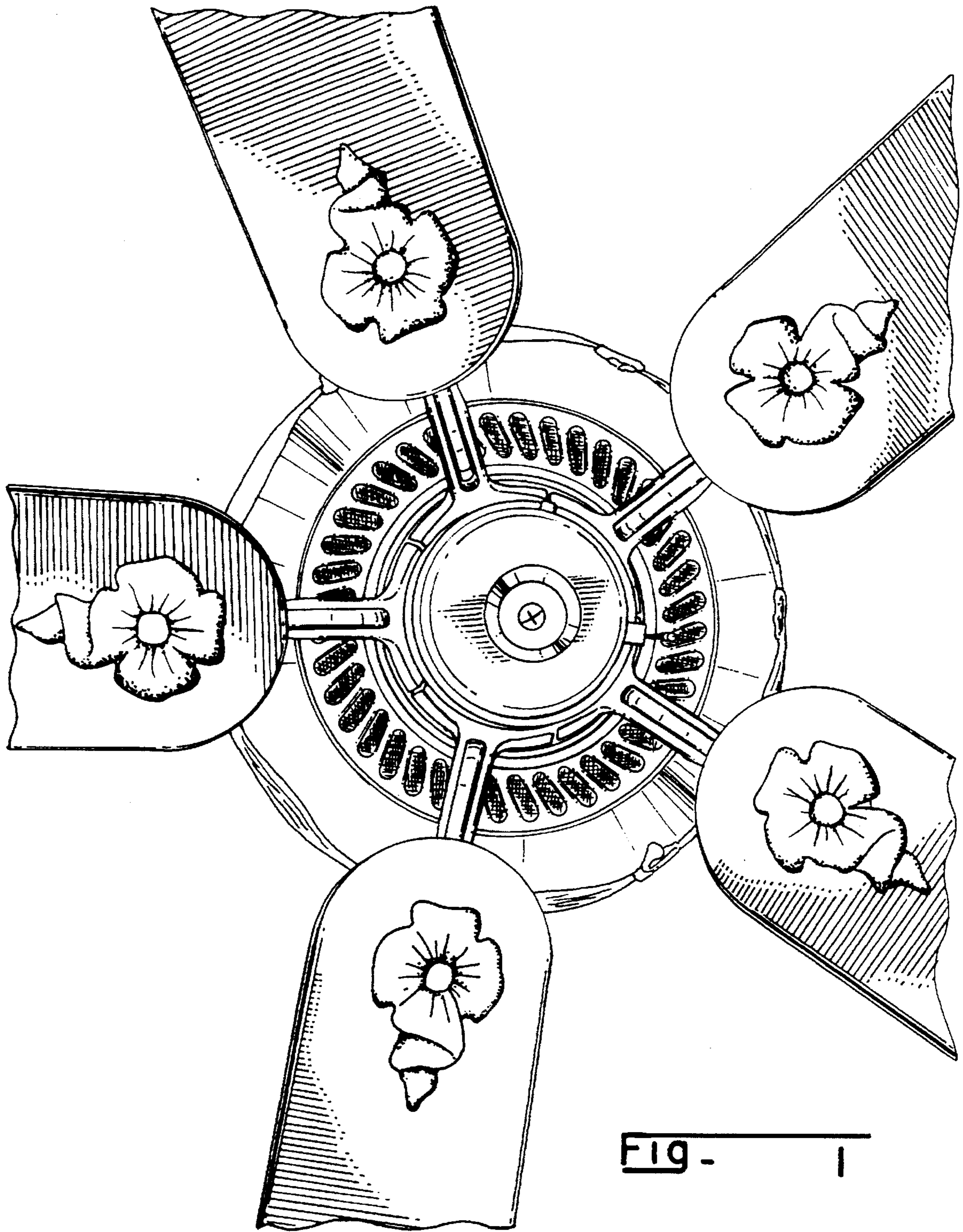
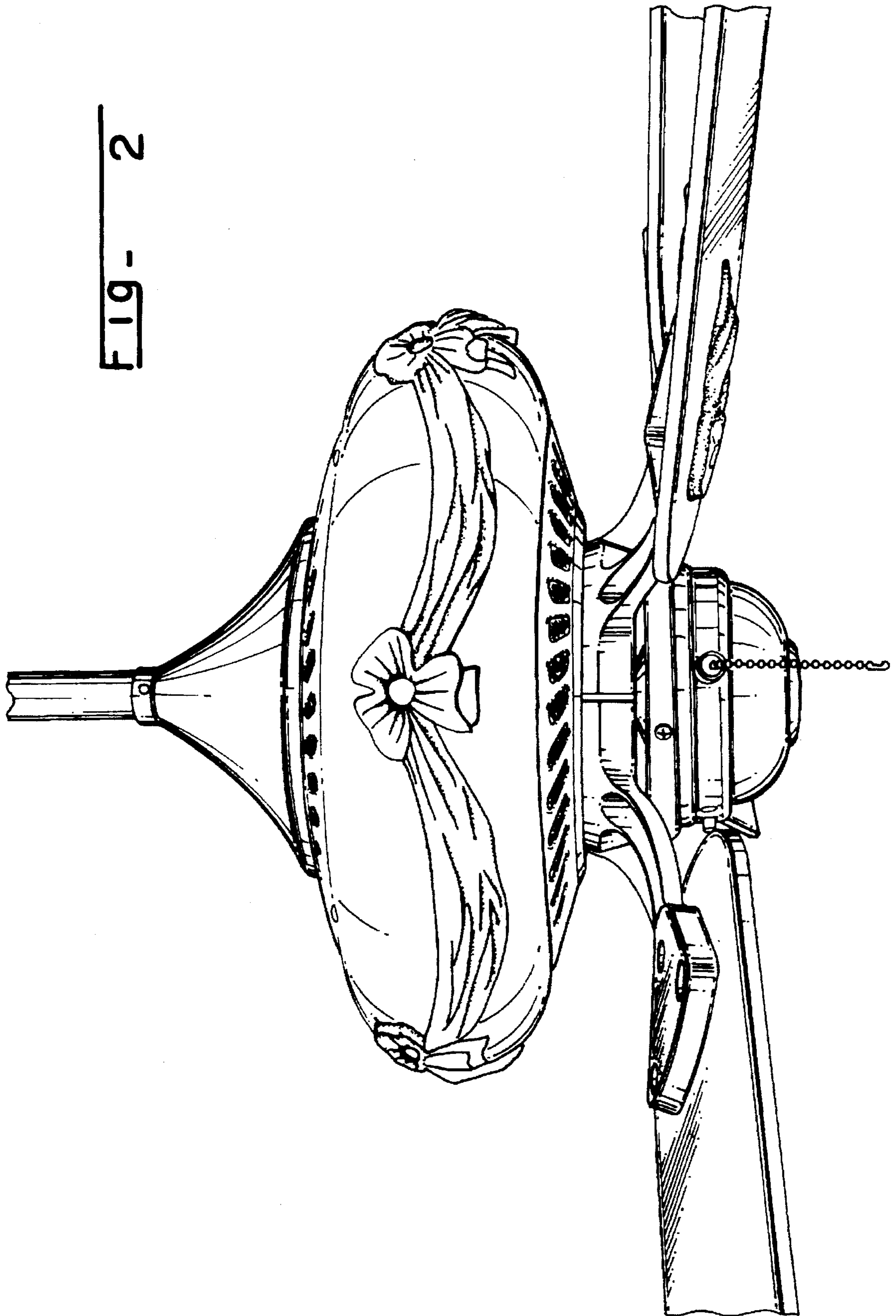

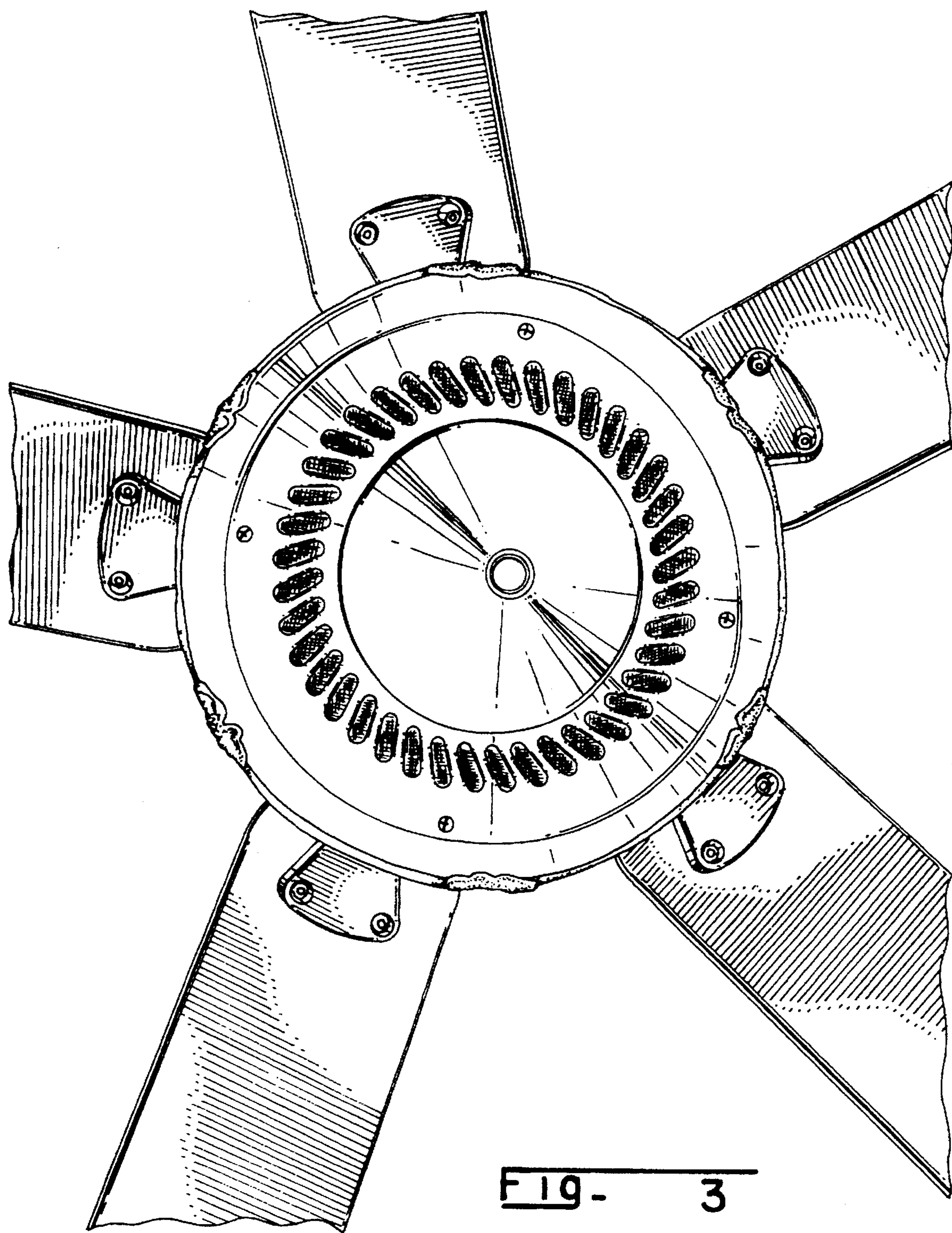
