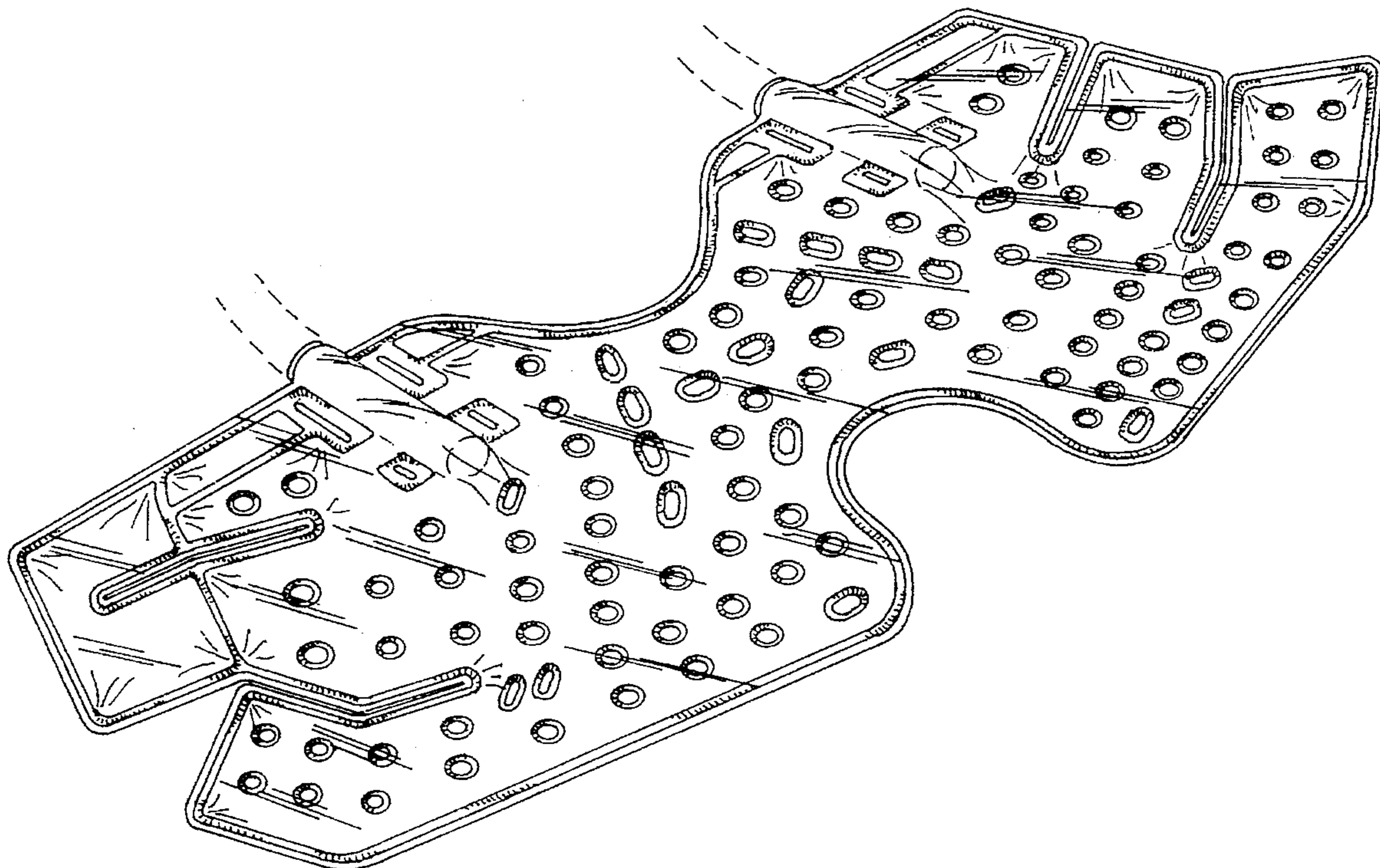

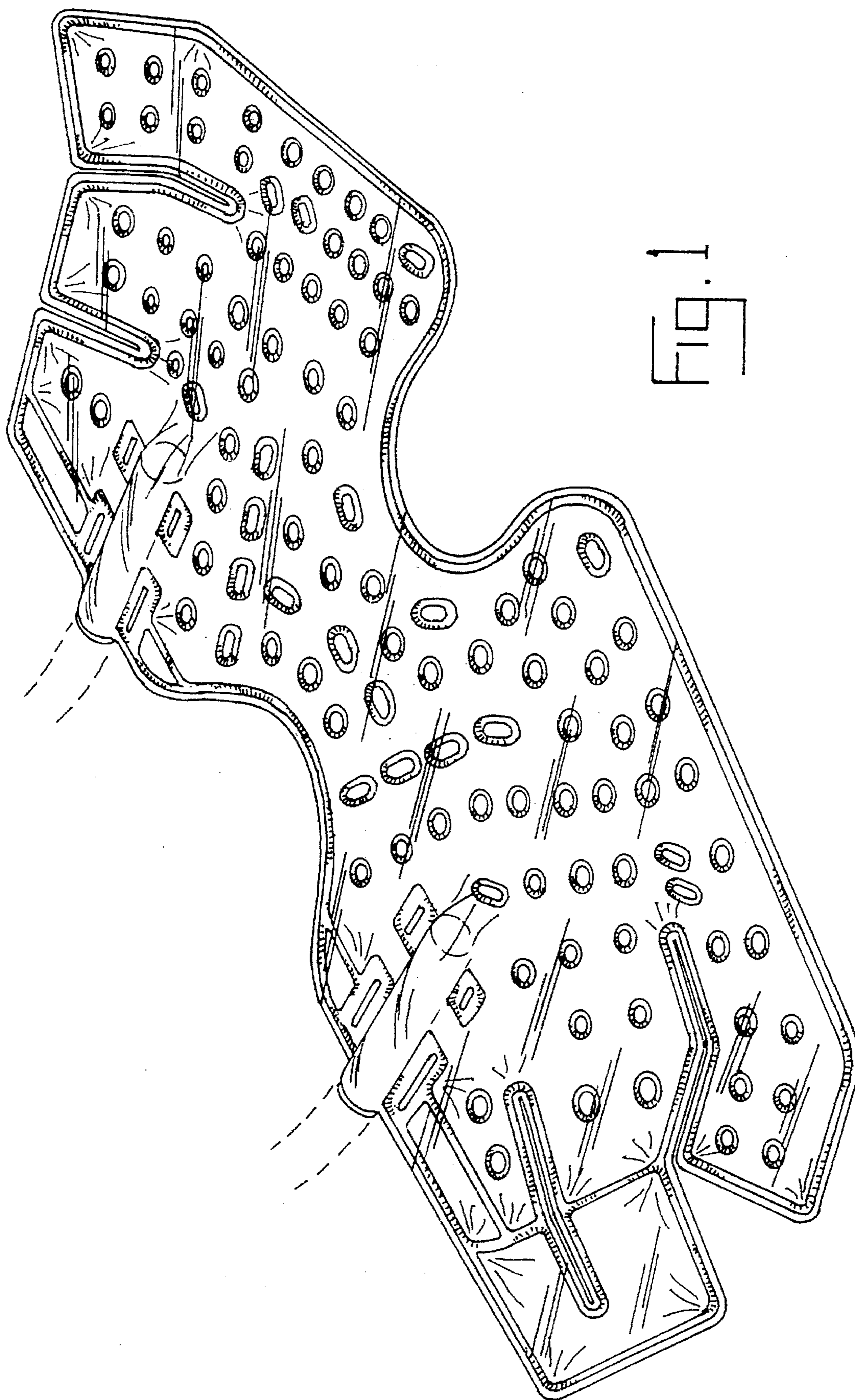
The ornamental design for a liquid therapy pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a liquid therapy pad illustrating our new design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a top elevational view thereof;  
FIG. 4 is a bottom elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;

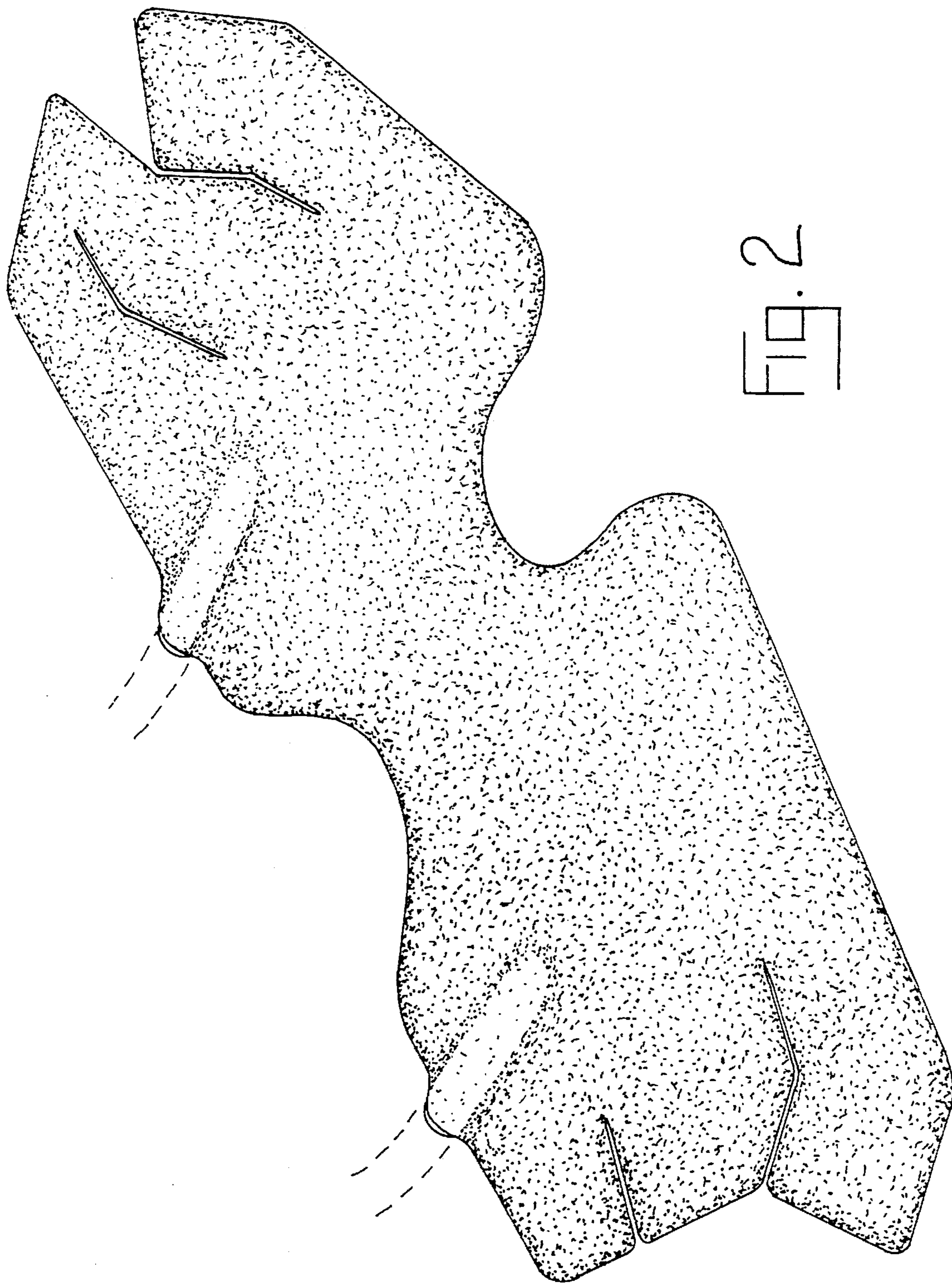

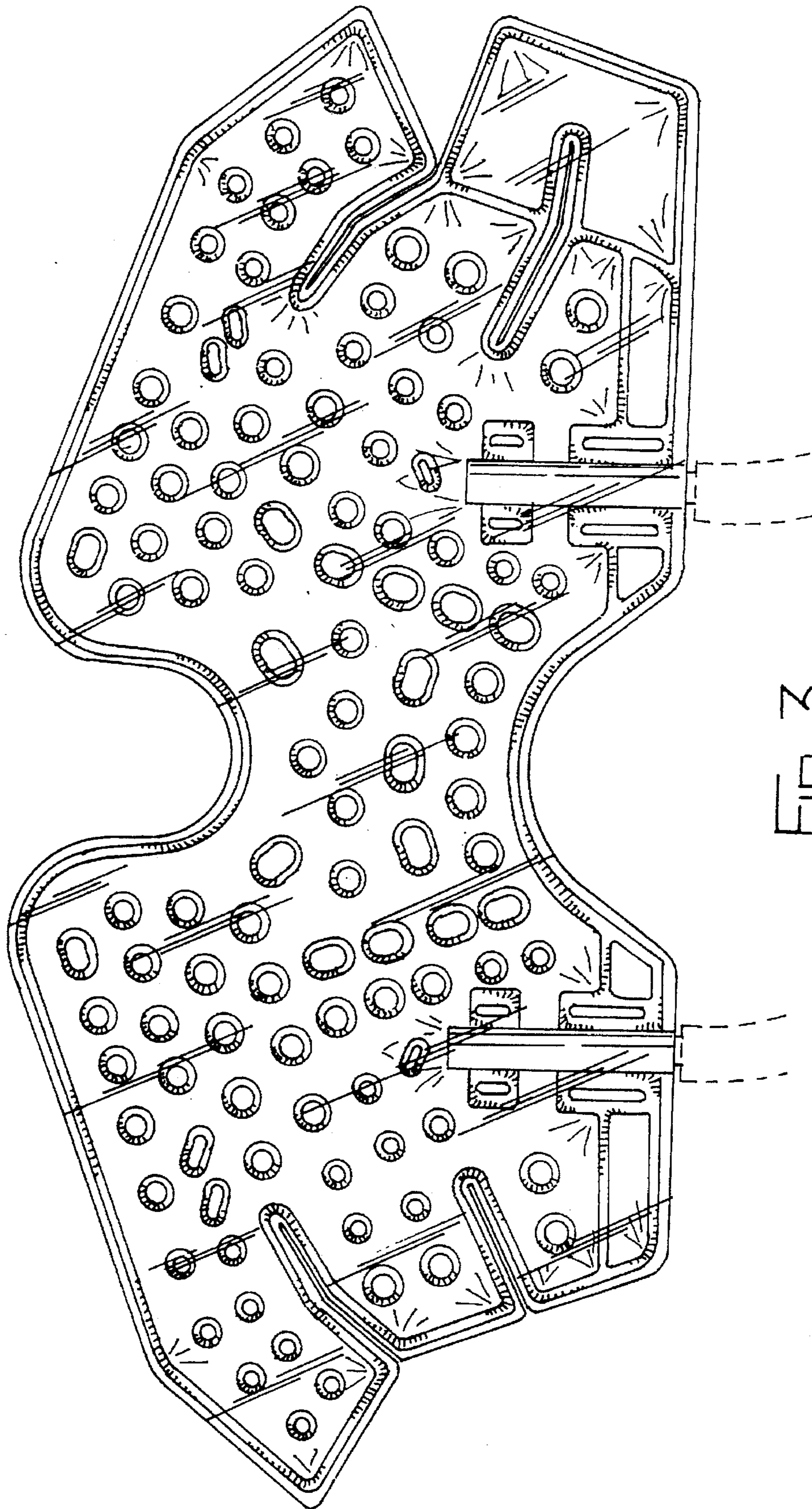

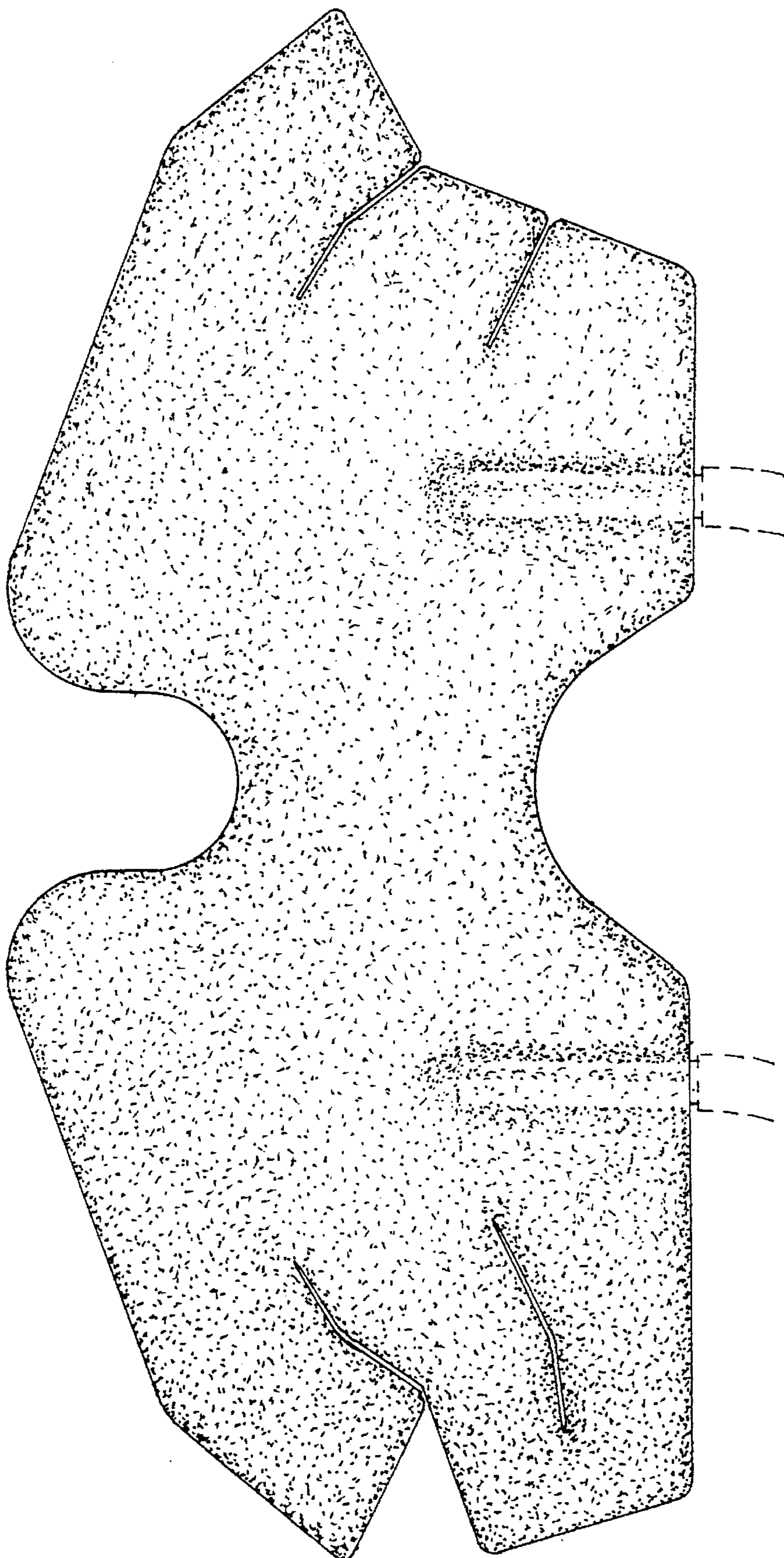

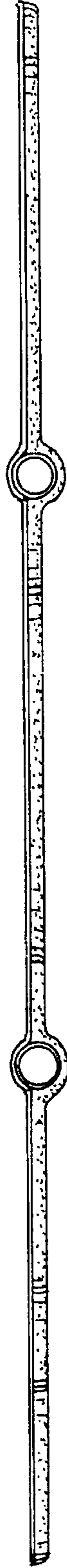

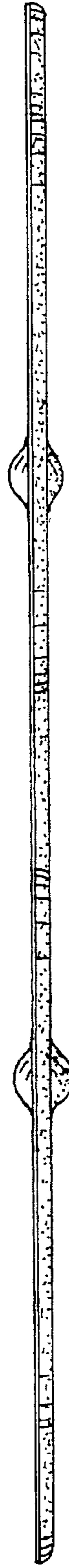
