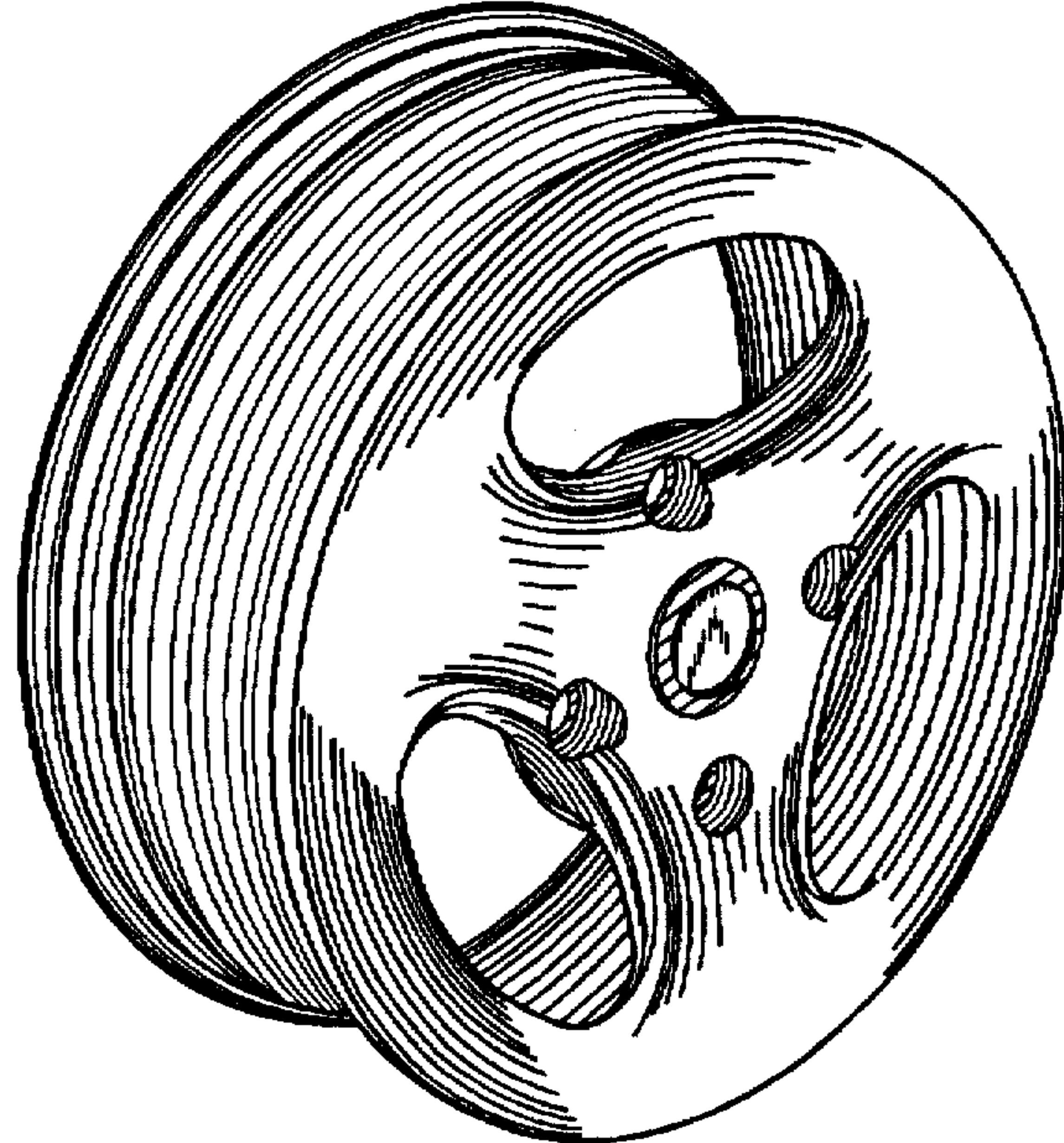
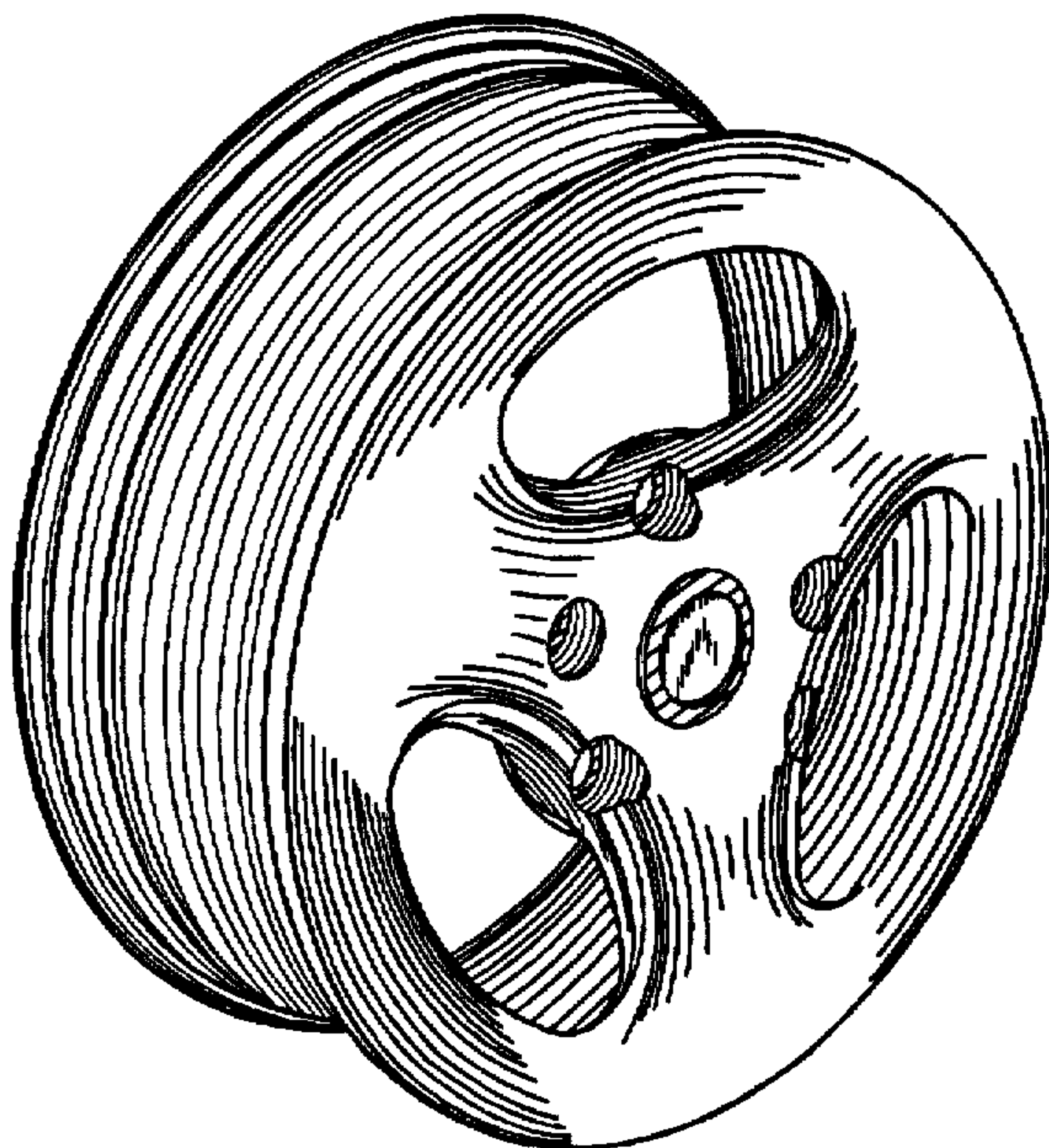
## [57] CLAIM

## DESCRIPTION

FIG. 1 is a front perspective view of a five bolt hole wheel  
for vehicles showing an embodiment of the new design;  
FIG. 2 is a front view of FIG. 1;  
FIG. 3 is a side view thereof;  
FIG. 4 is a front perspective view of a four bolt hole wheel  
for vehicles showing an embodiment of the new design;  
FIG. 5 is a front view of FIG. 5; and,

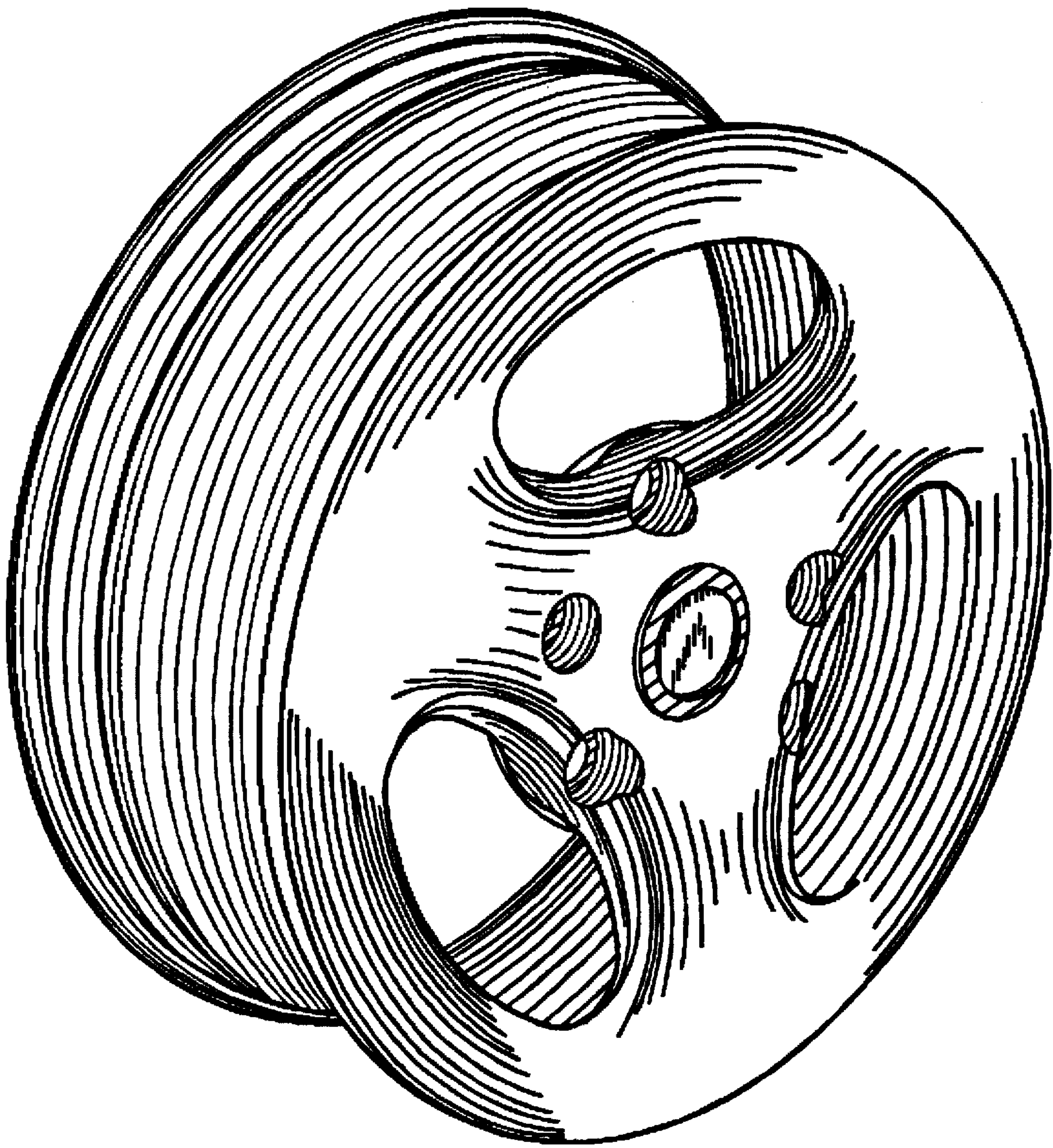

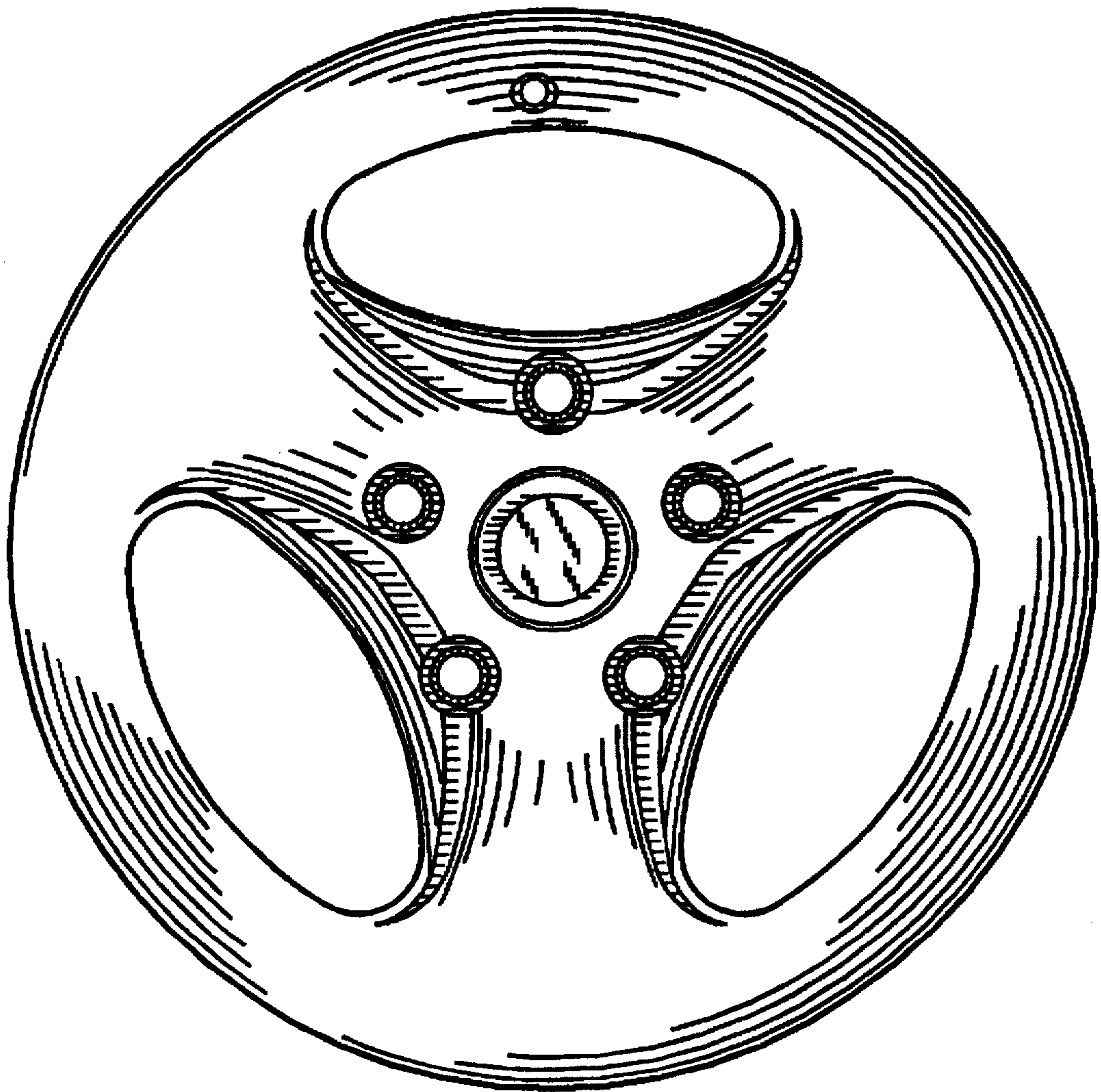

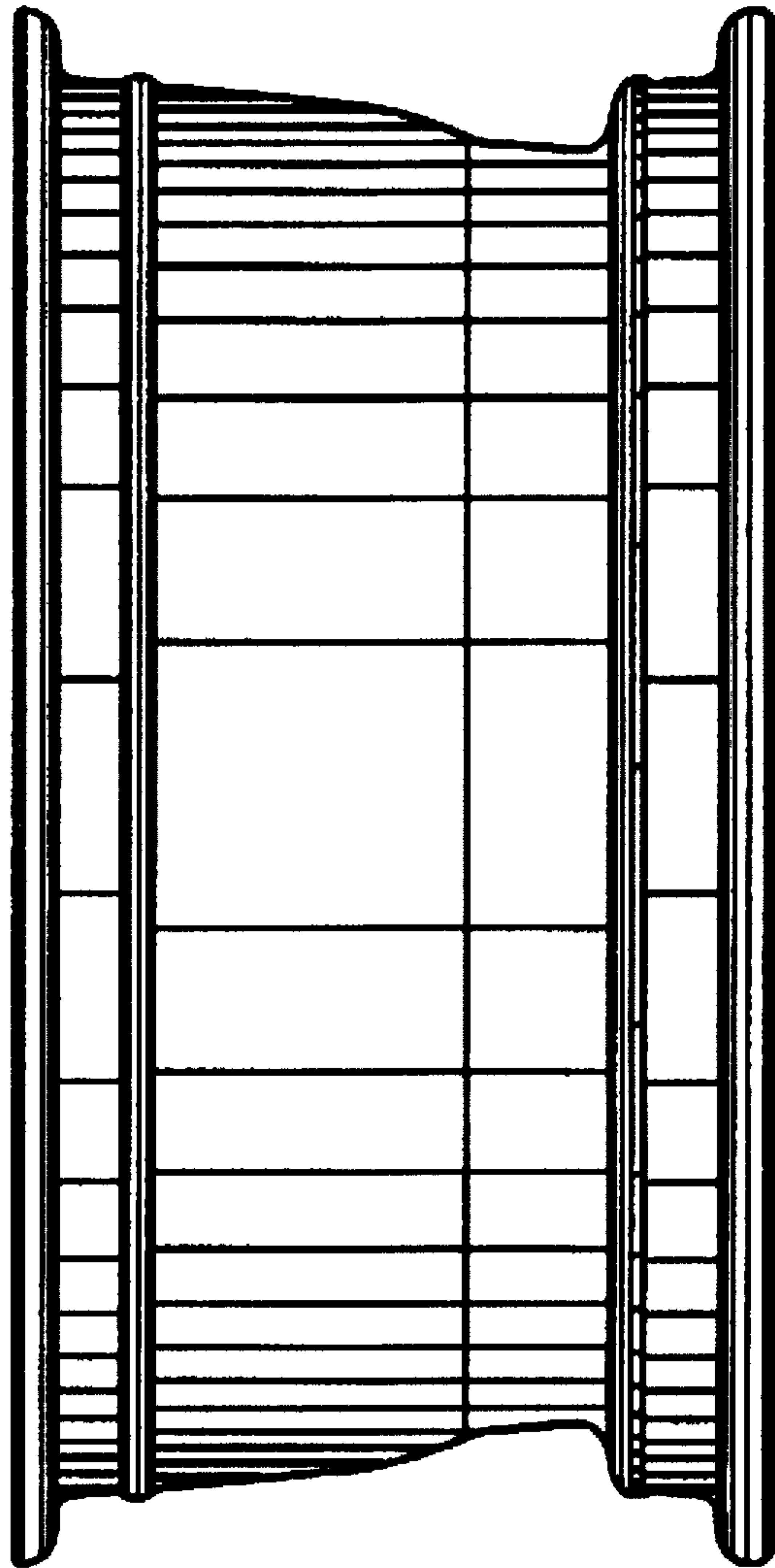

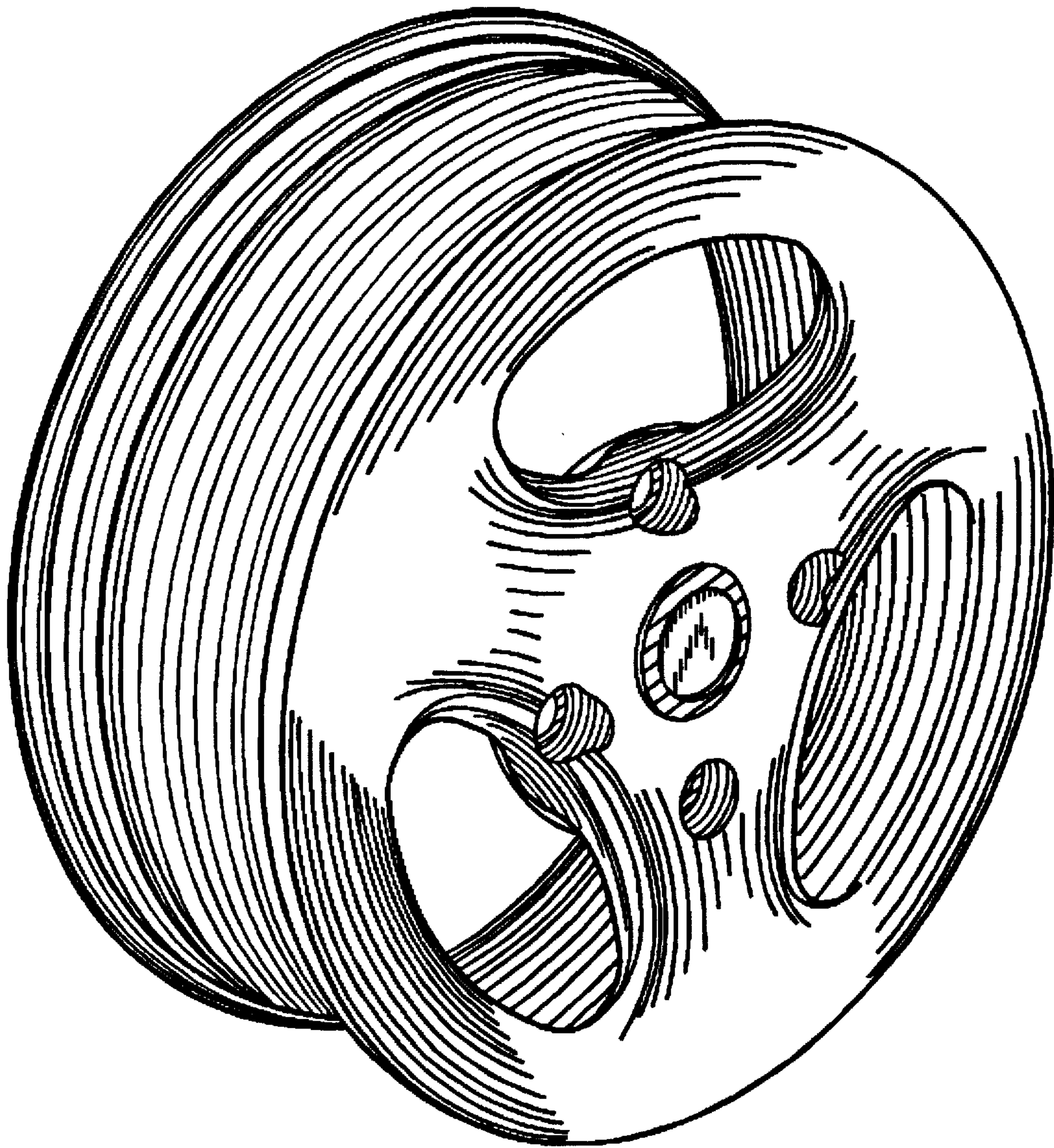

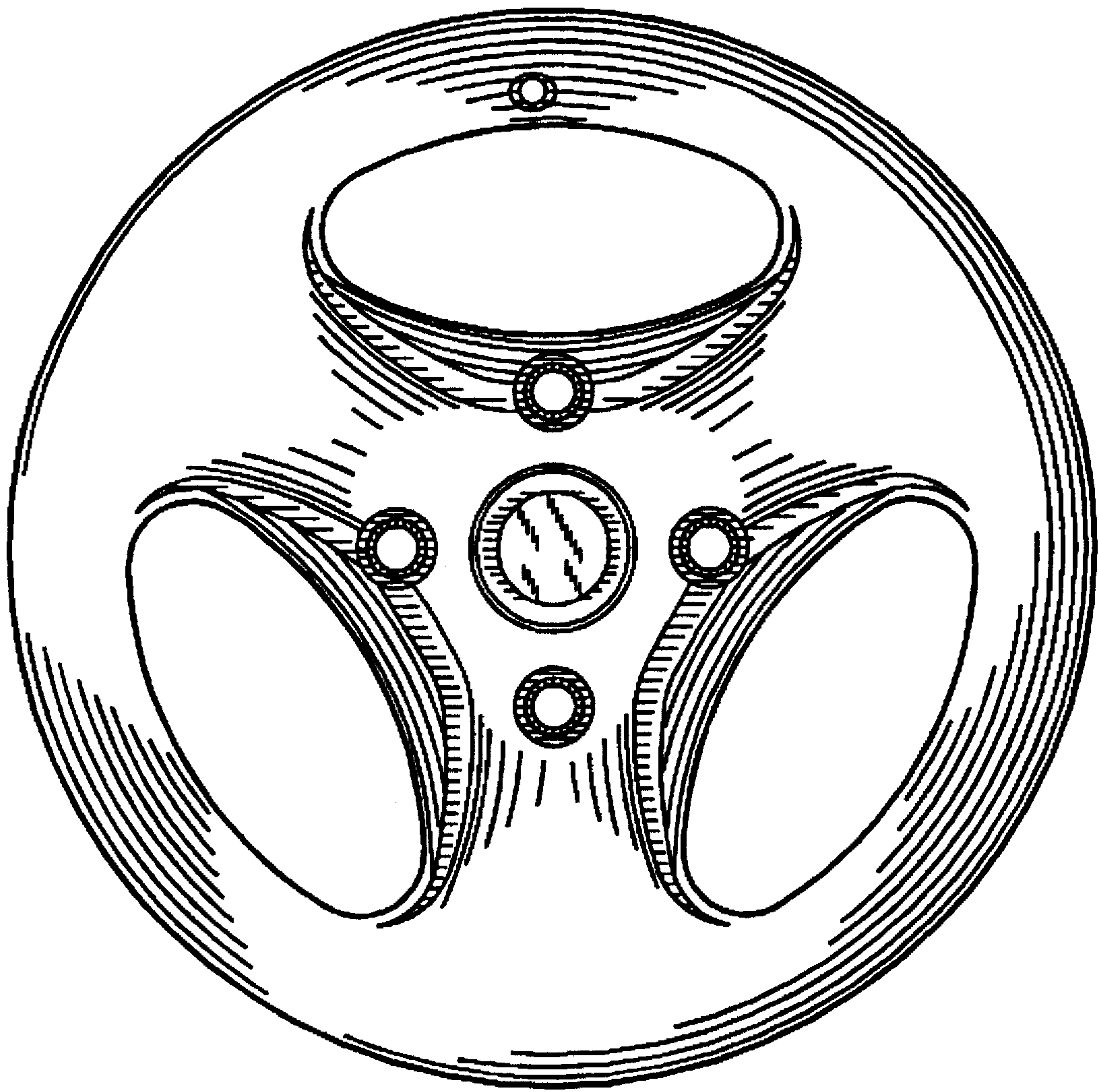

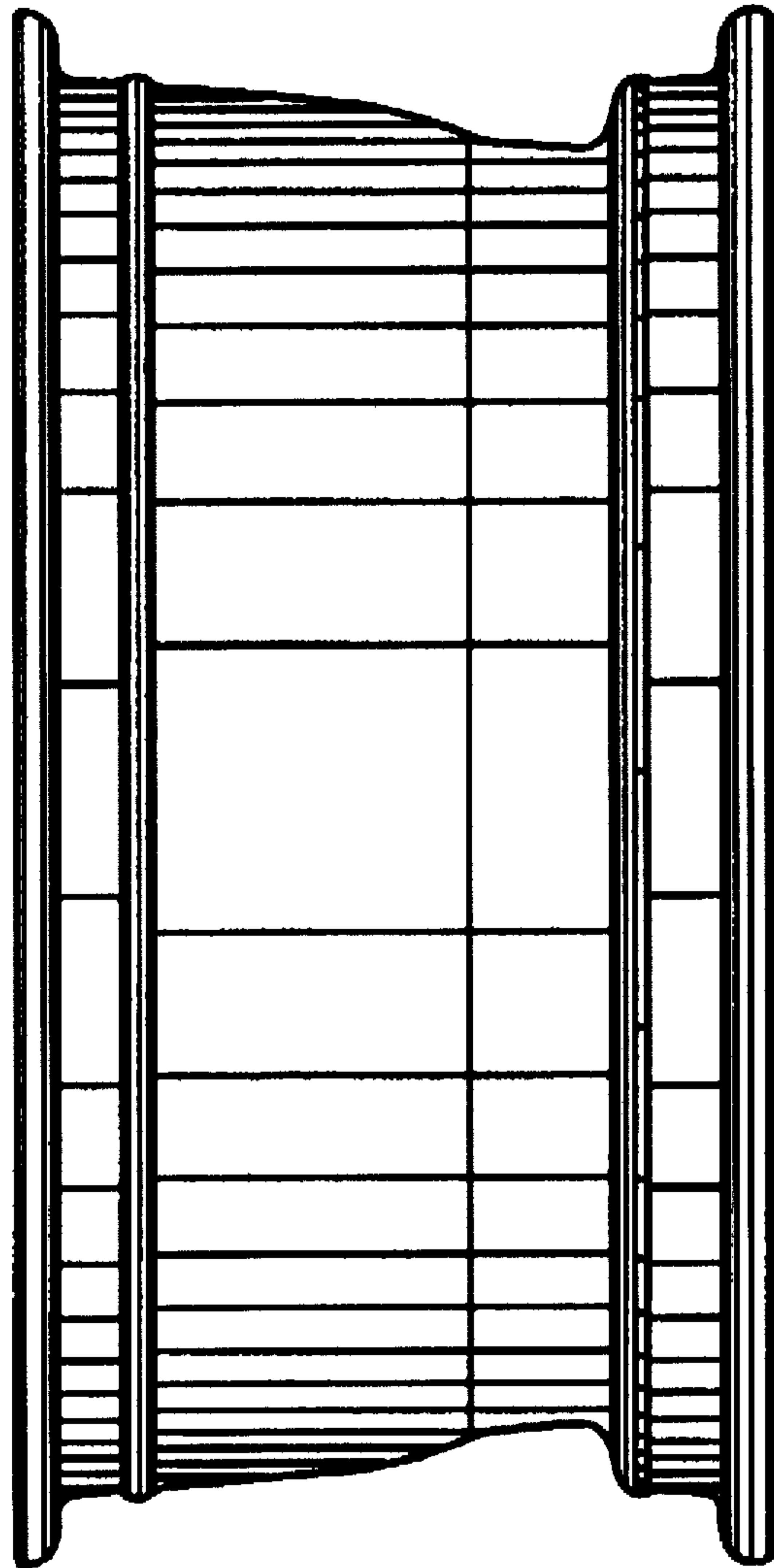
