[57] **CLAIM**

The ornamental design for the stand for a golf bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the stand for a golf bag showing my new design;

FIG. 2 is a right side elevational view including the curved push rod;

FIG. 3 is a right side view, with the stand in an open extended position;

FIG. 4 is a bottom plan view;

FIG. 5 is a top plan view;

FIG. 6 is a rear elevational view;

FIG. 7 is a left side elevational view, including the curved push rod;

FIG. 8 is a front elevational view;

FIG. 9 is a front perspective view of a second embodiment;

FIG. 10 is a front perspective view of a third embodiment;

FIG. 11 is a right side elevational view of the second embodiment;

FIG. 12 is a right side view of the second embodiment, with the stand in an open extended position;

FIG. 13 is a bottom plan view of the second embodiment;

FIG. 14 is a top plan view thereof;

FIG. 15 is a rear elevational view thereof;

FIG. 16 is a left side elevational view thereof;

FIG. 17 is a front elevational view thereof;

FIG. 18 is a right side elevational view of a third embodiment;

FIG. 19 is a right side view thereof, with the stand in an open extended position;

FIG. 20 is a bottom plan view thereof;

FIG. 21 is a top plan view thereof;

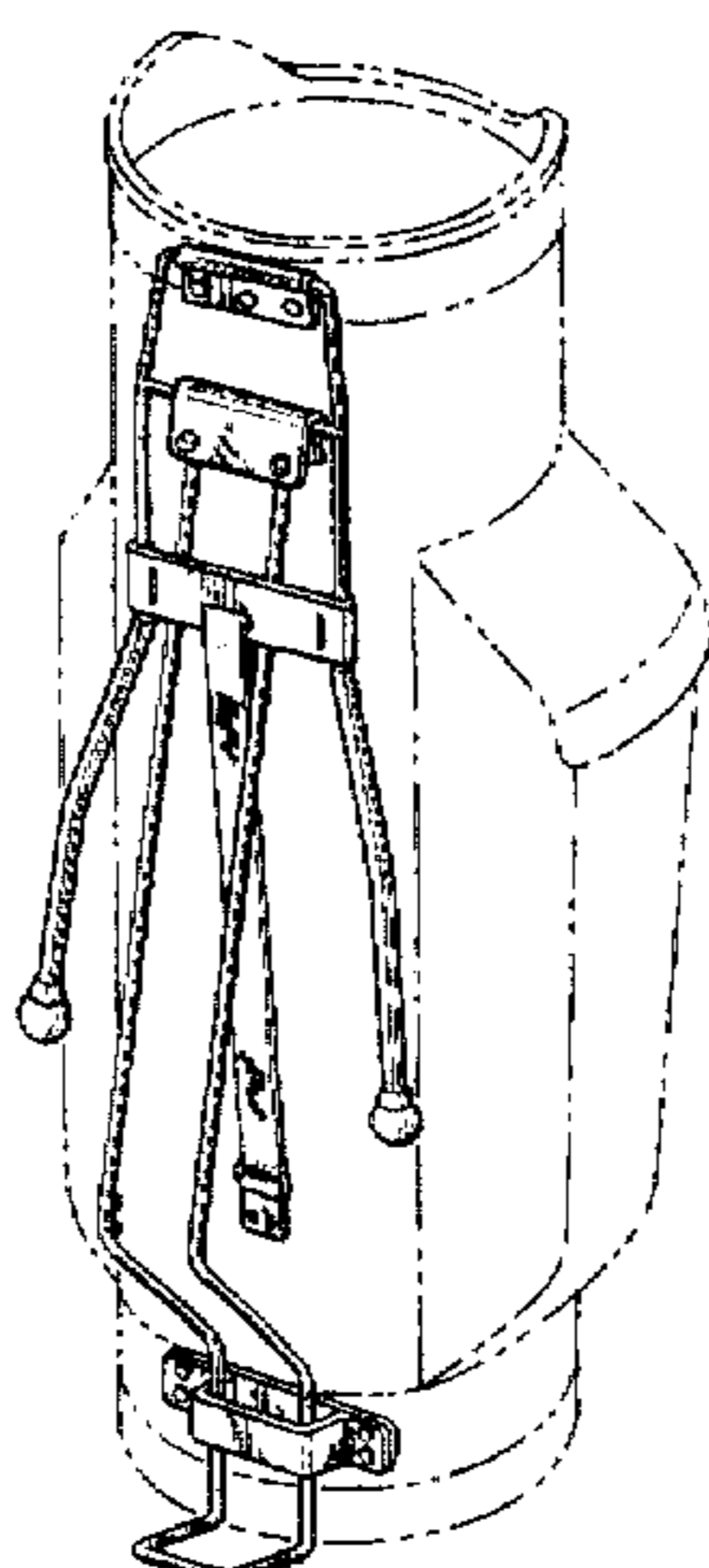
FIG. 22 is a rear elevational view thereof;

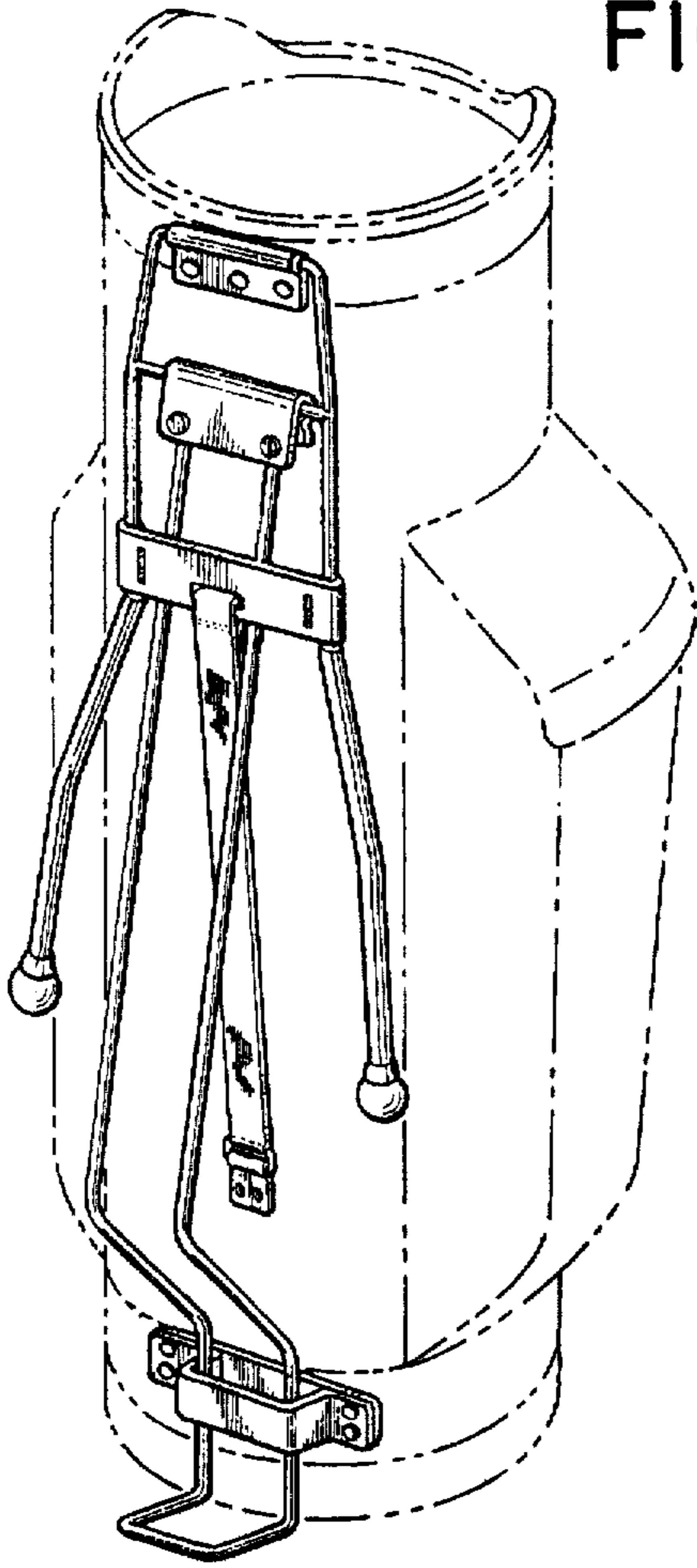

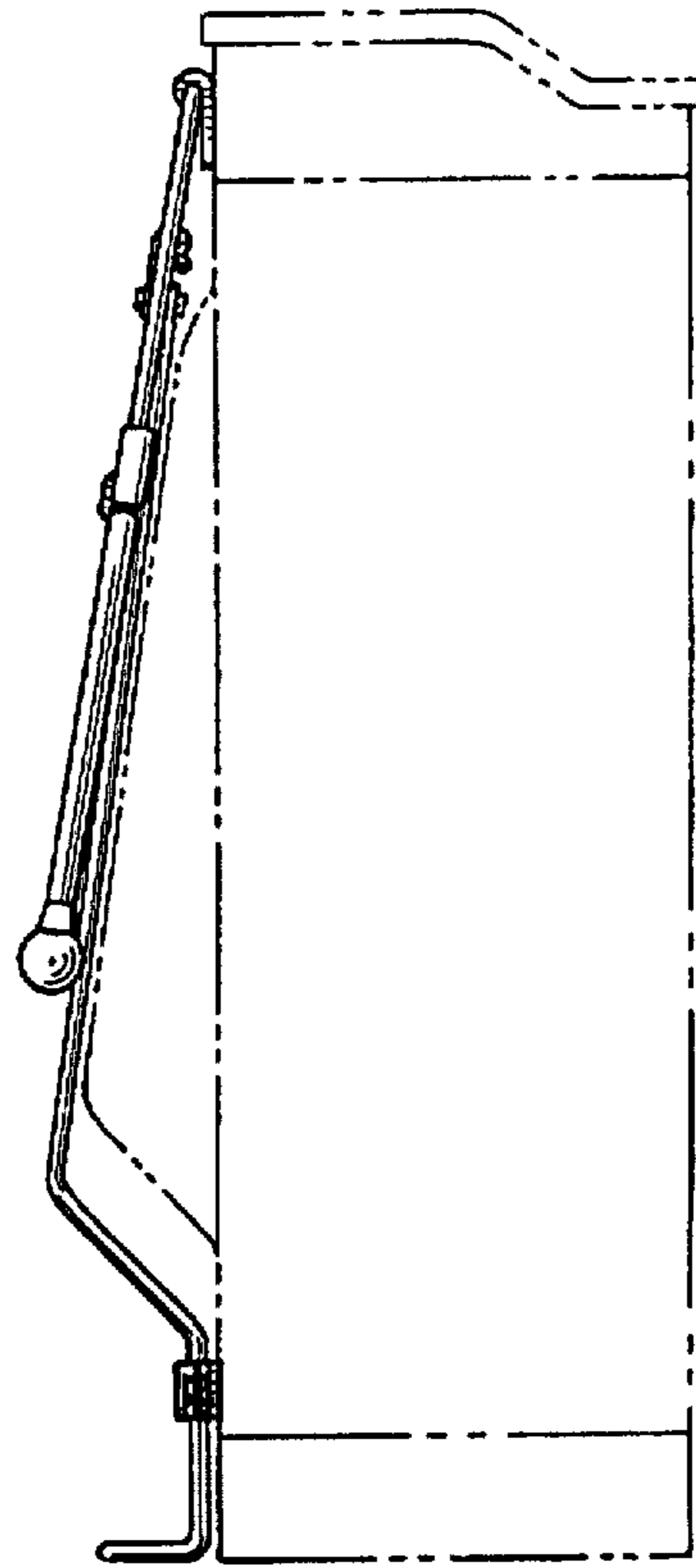

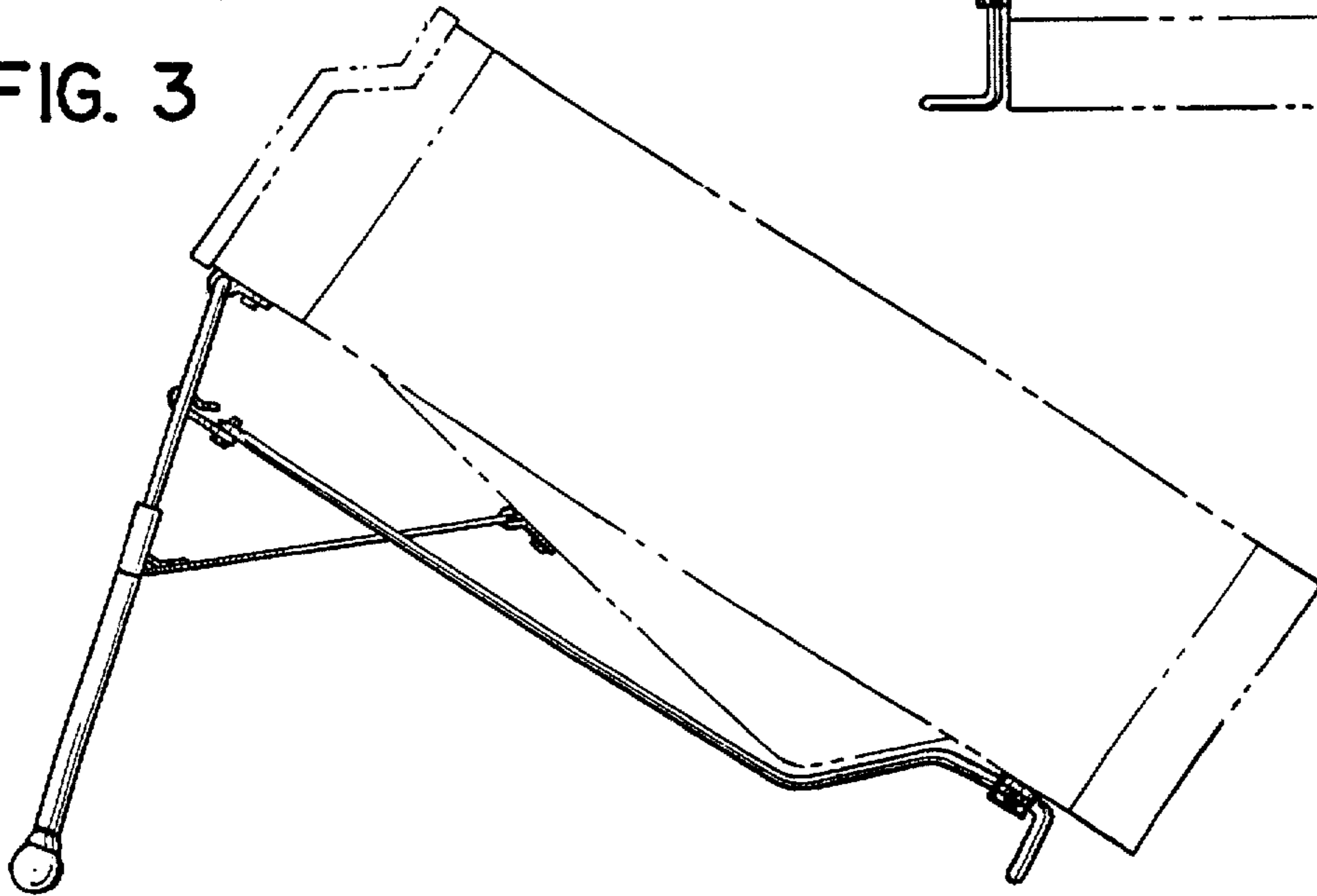

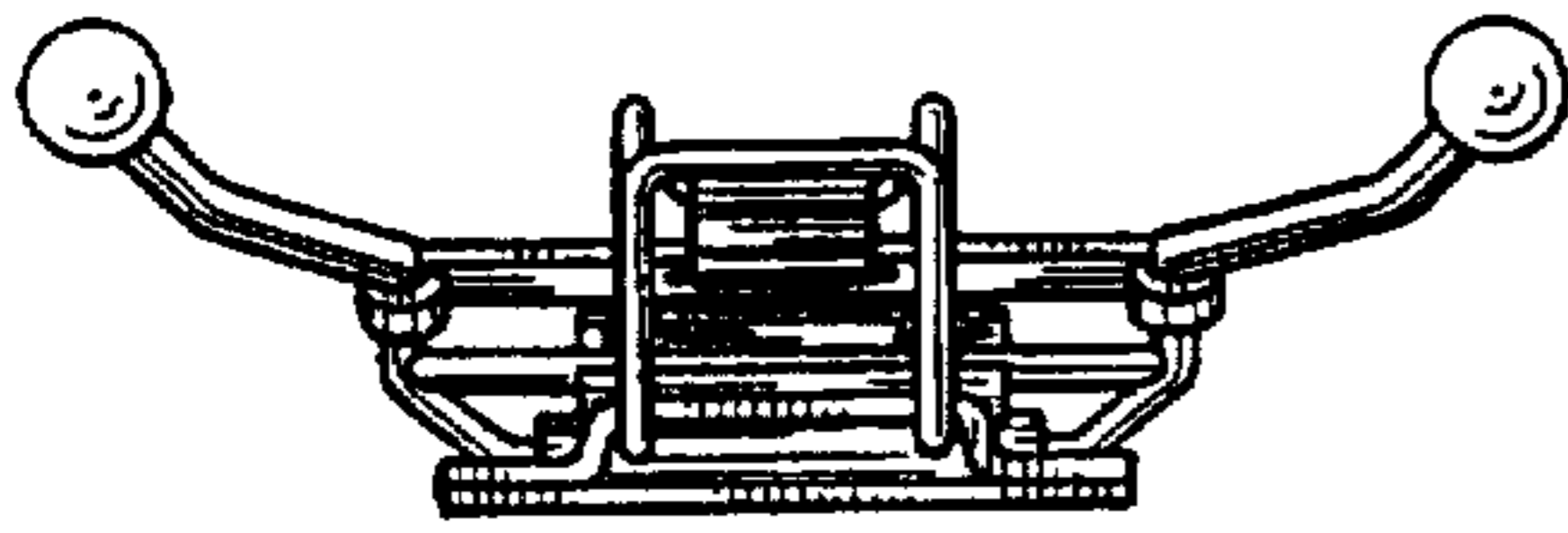

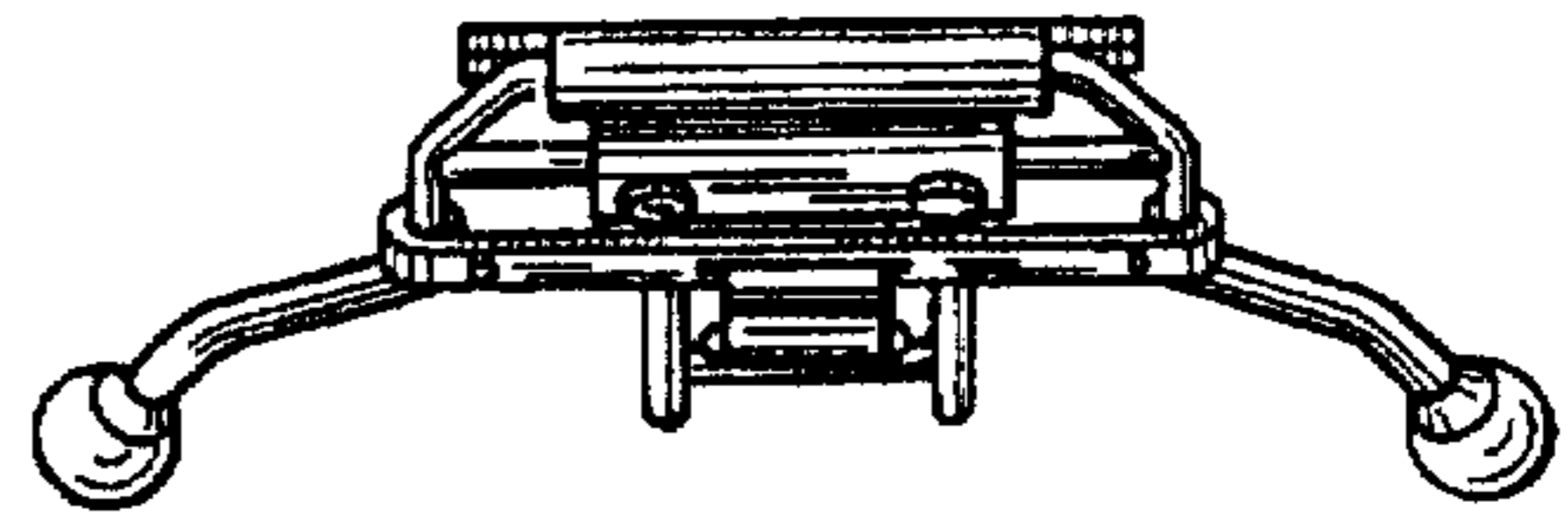

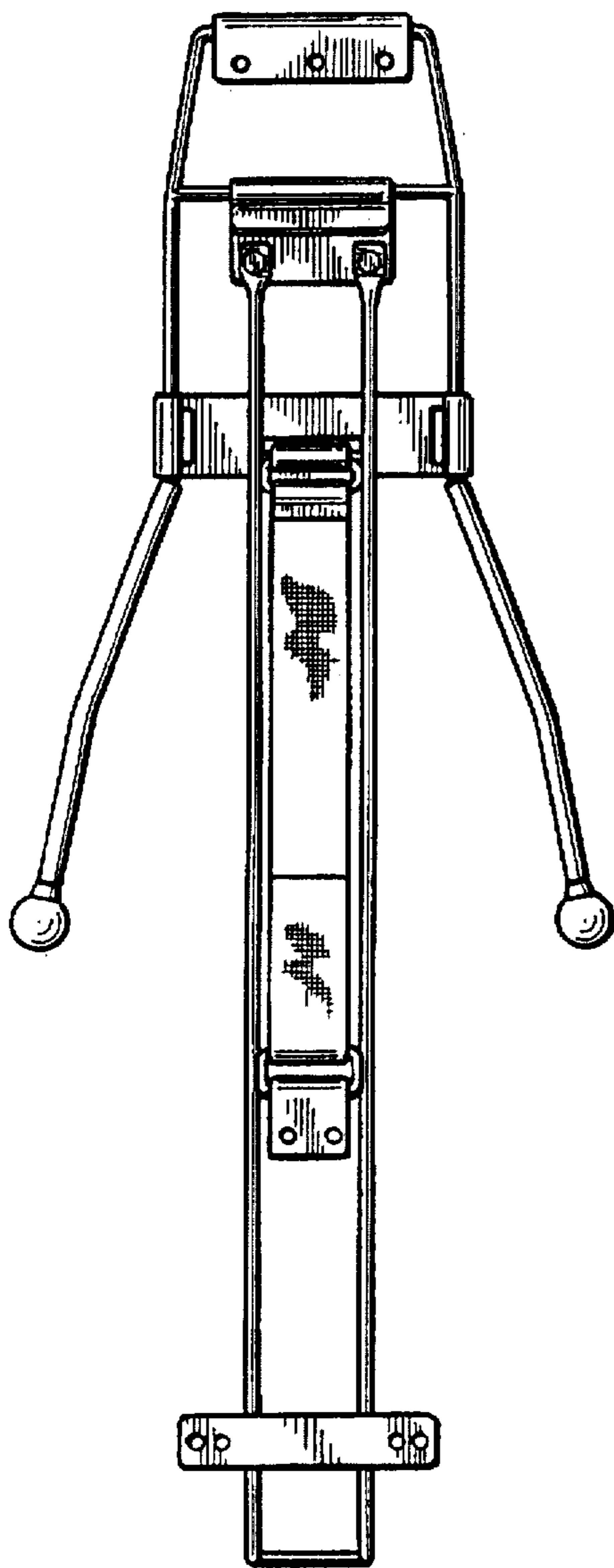

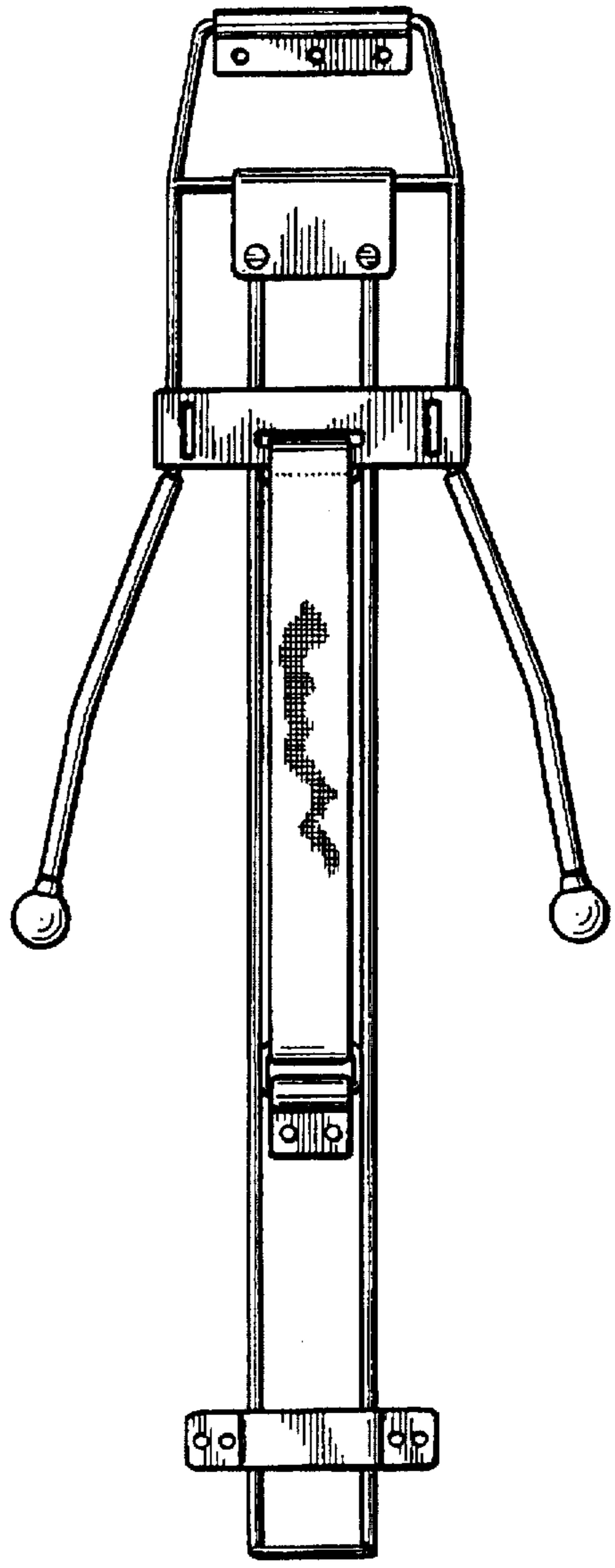

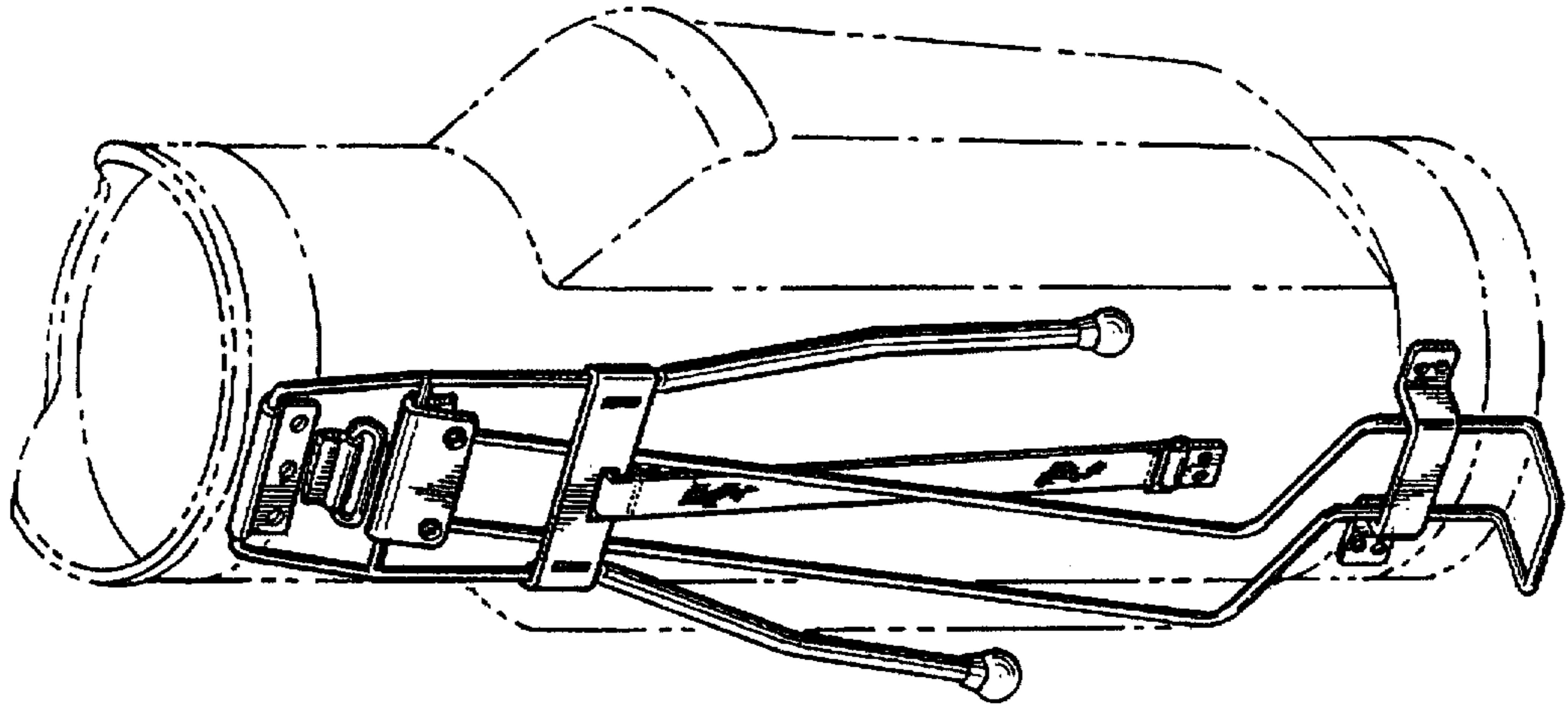

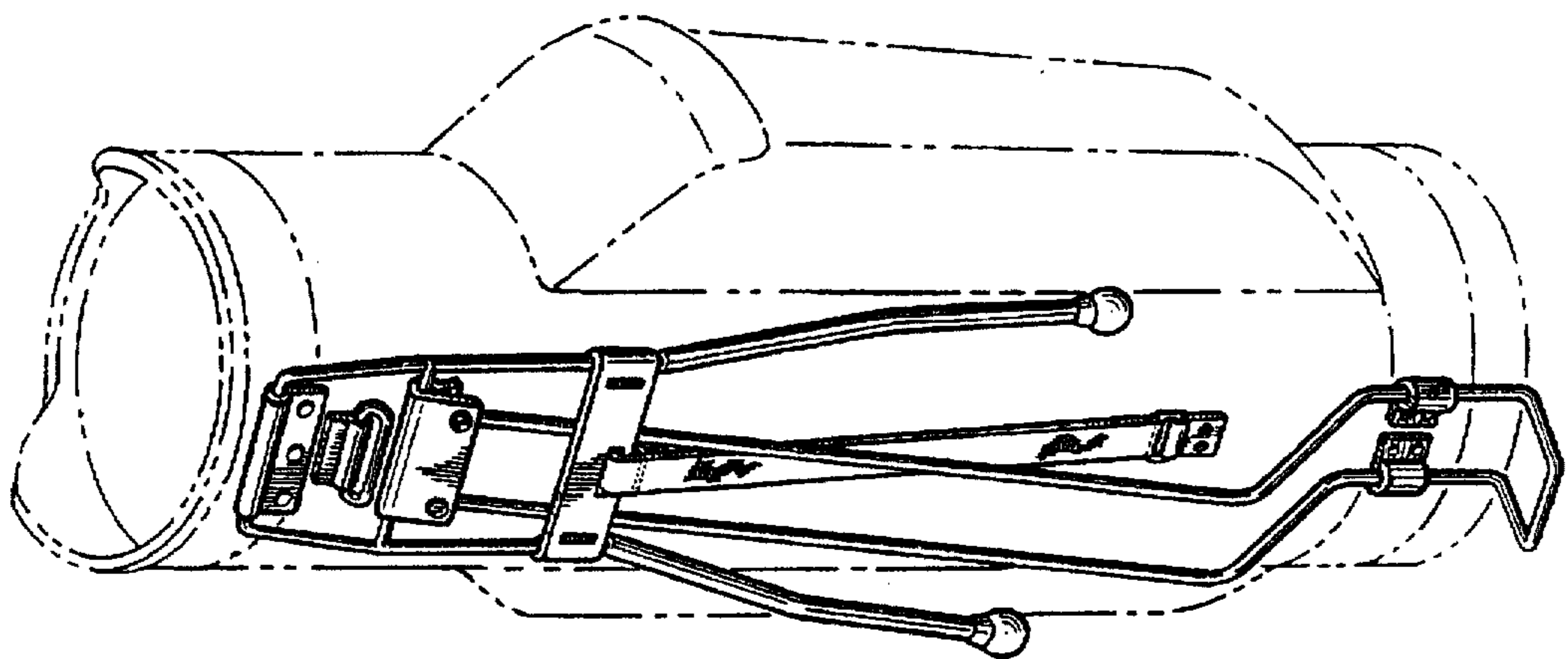

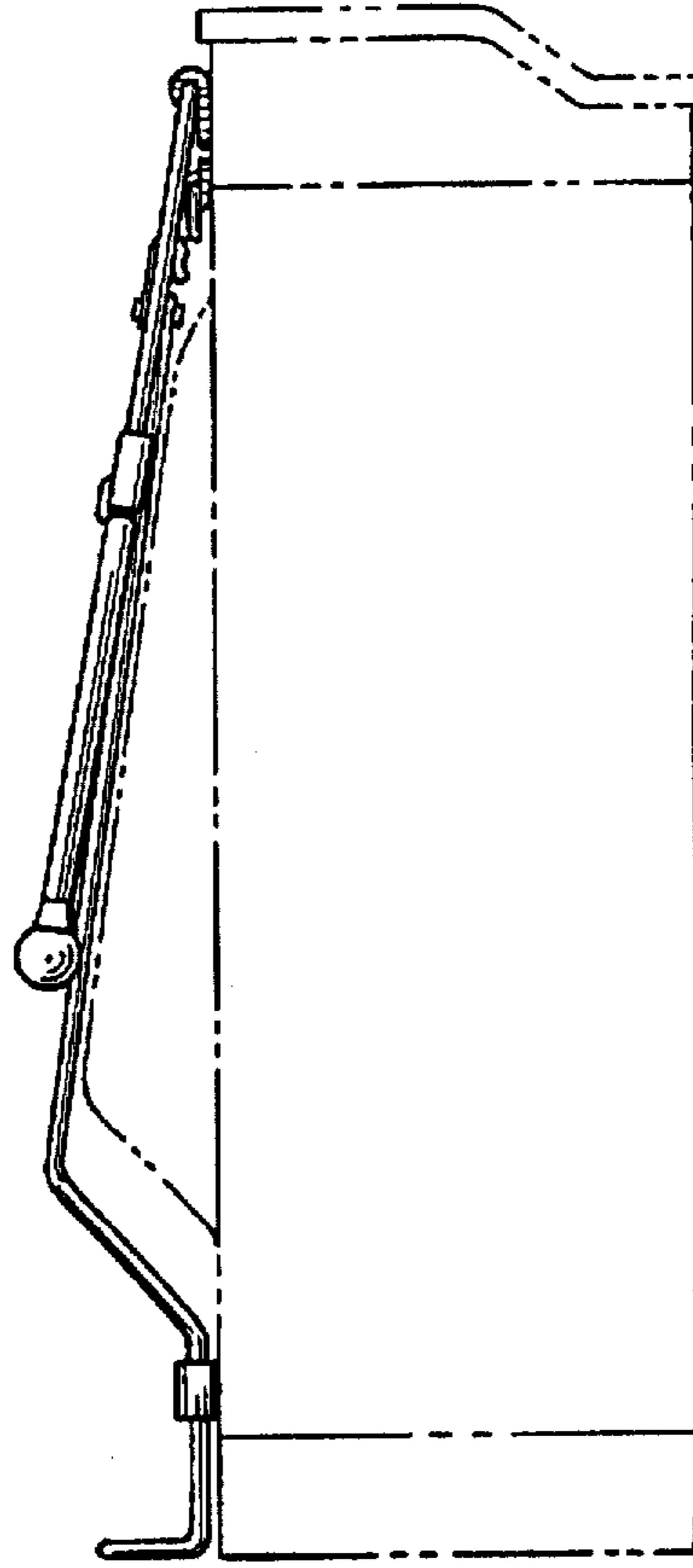

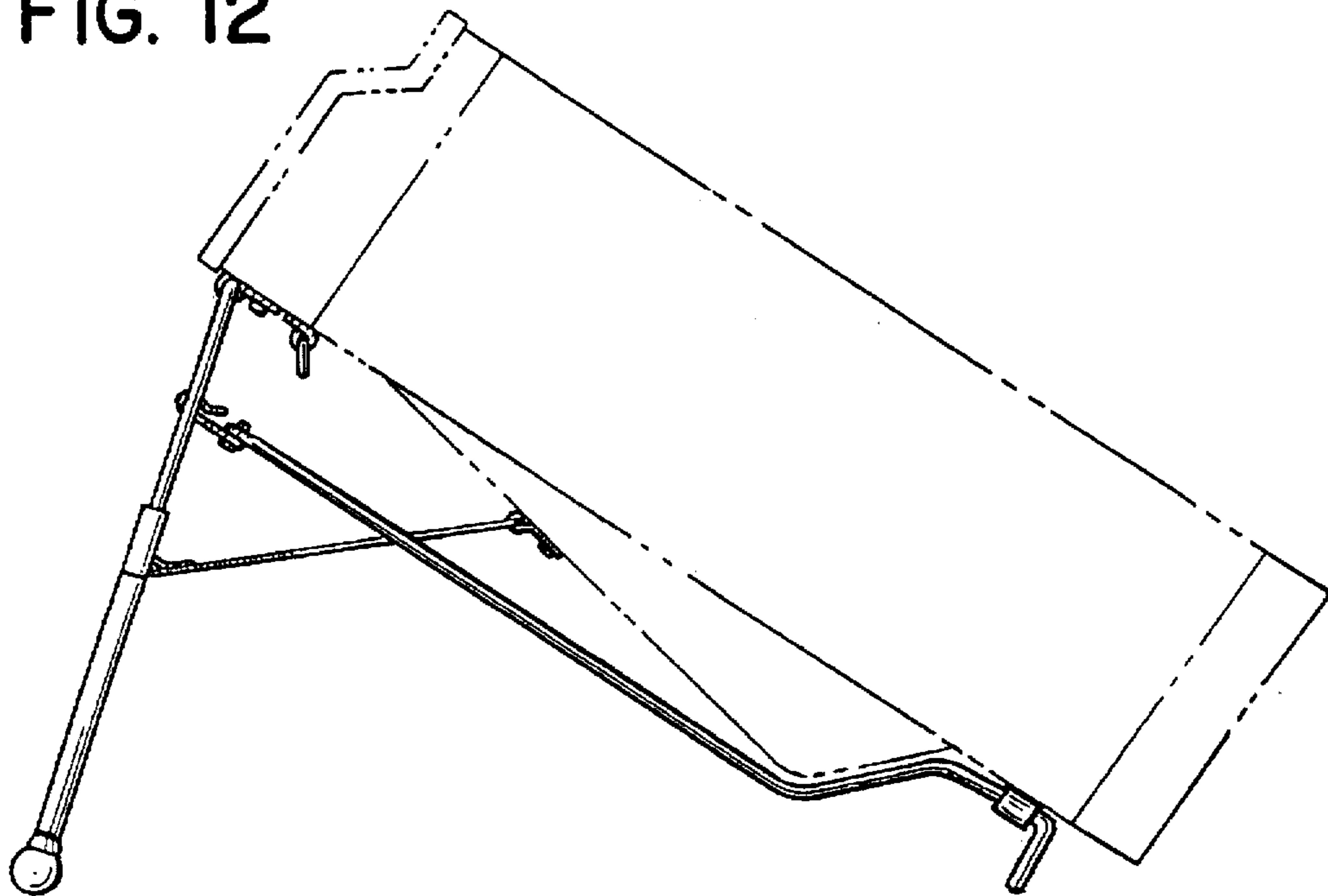

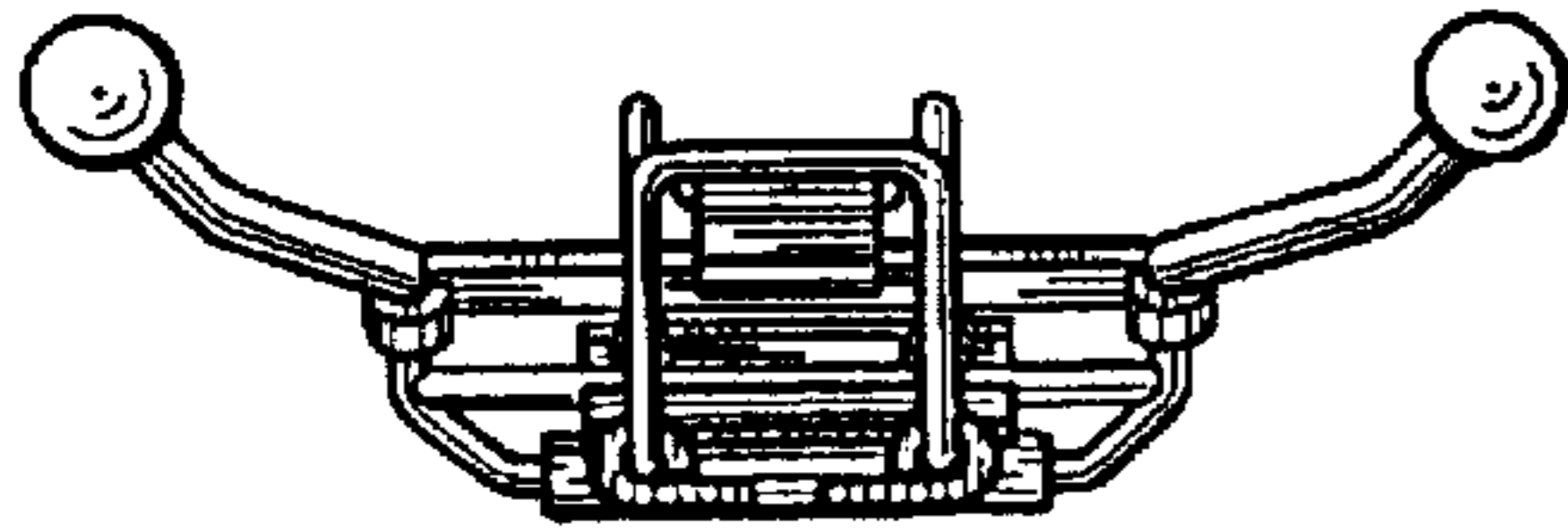

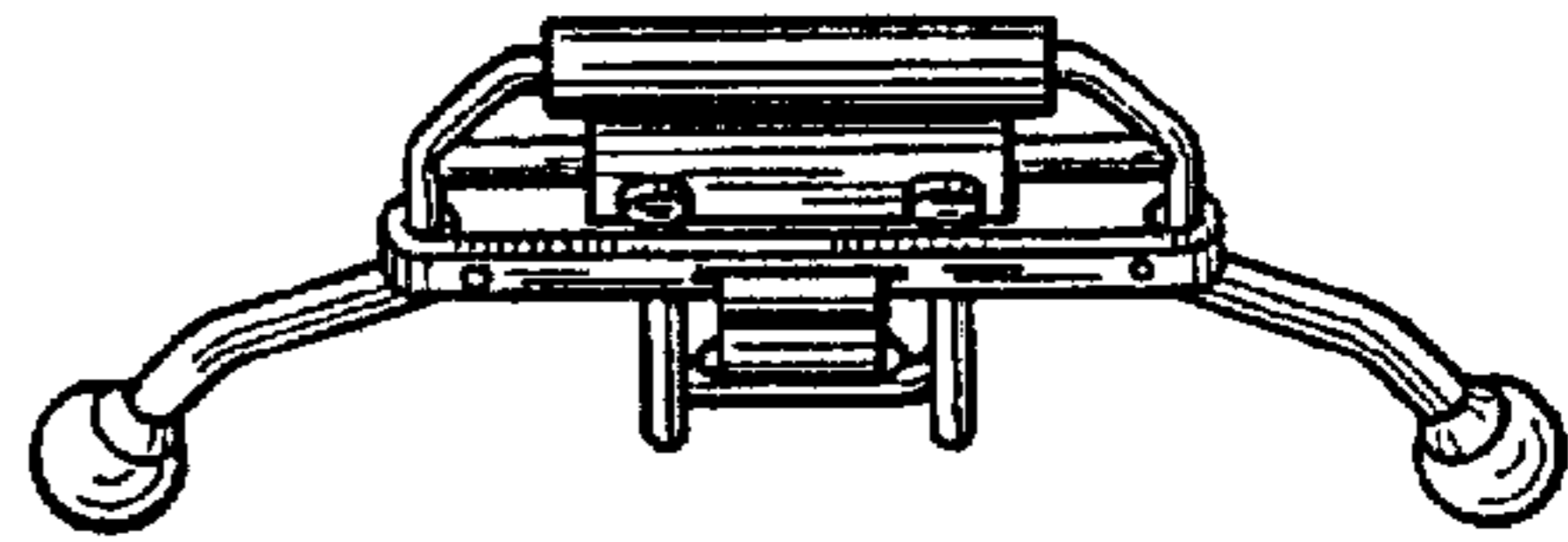

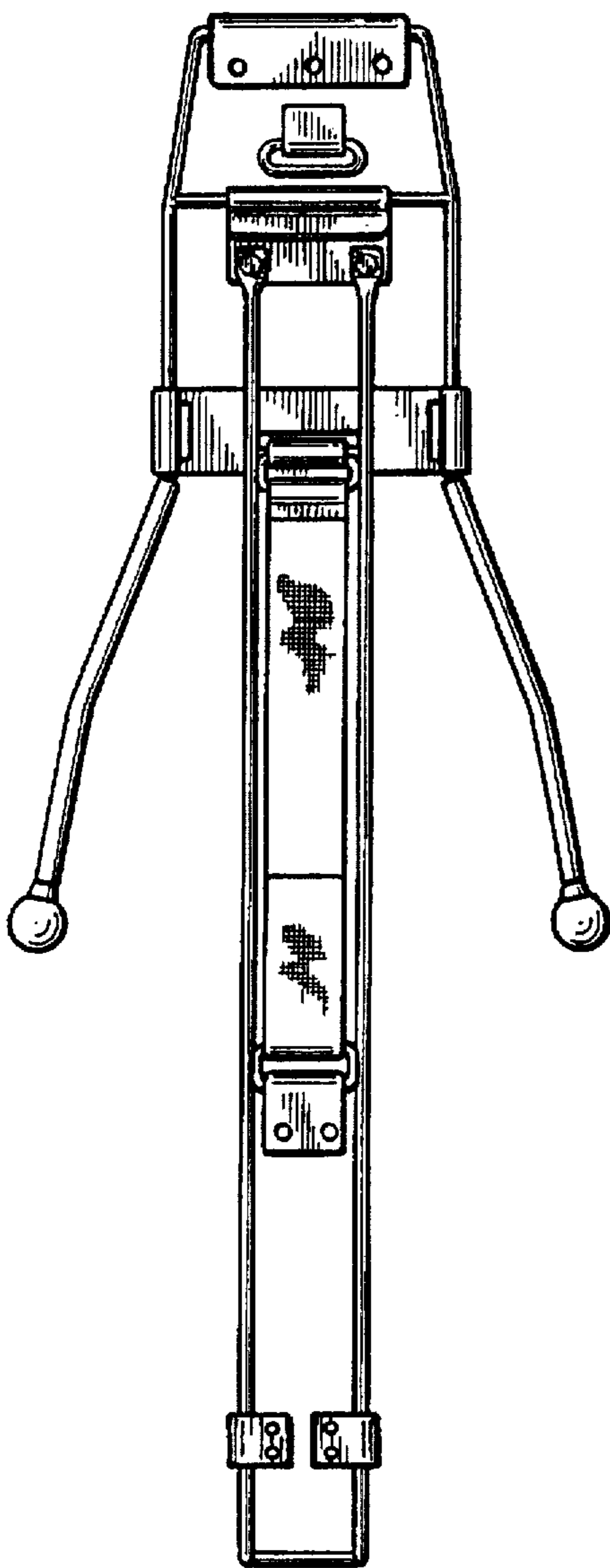

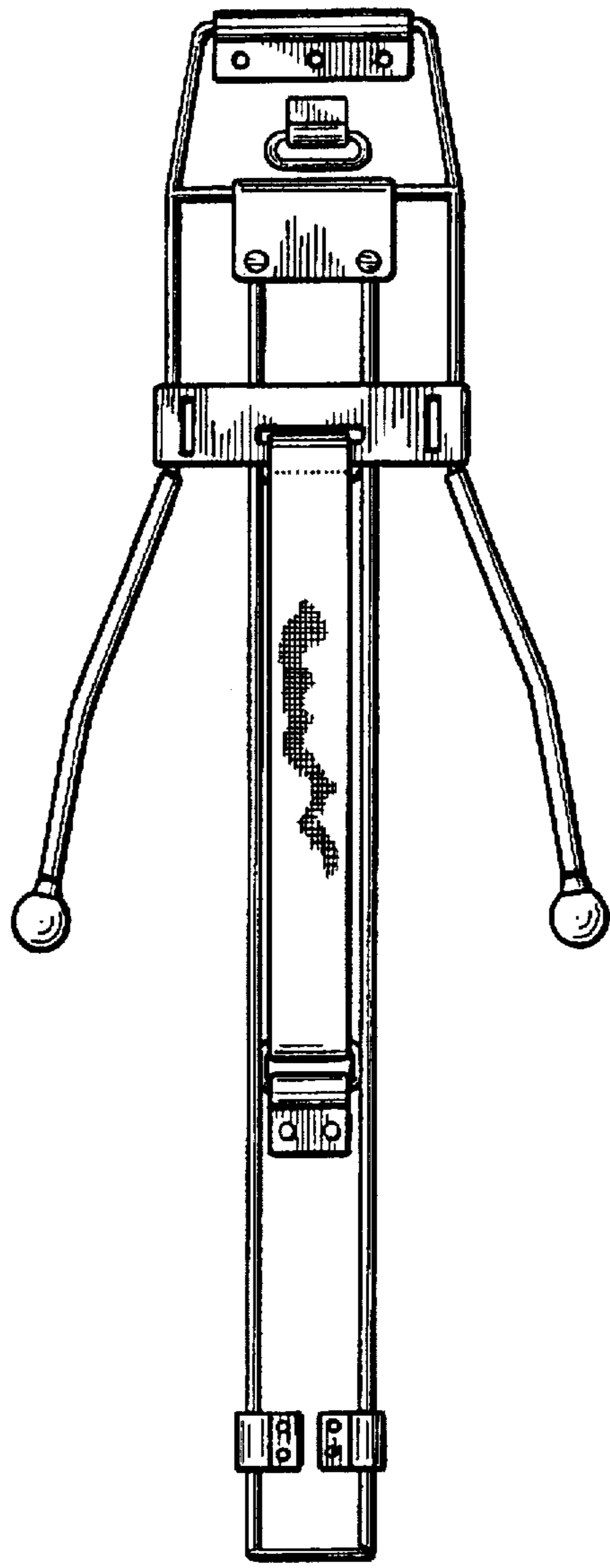

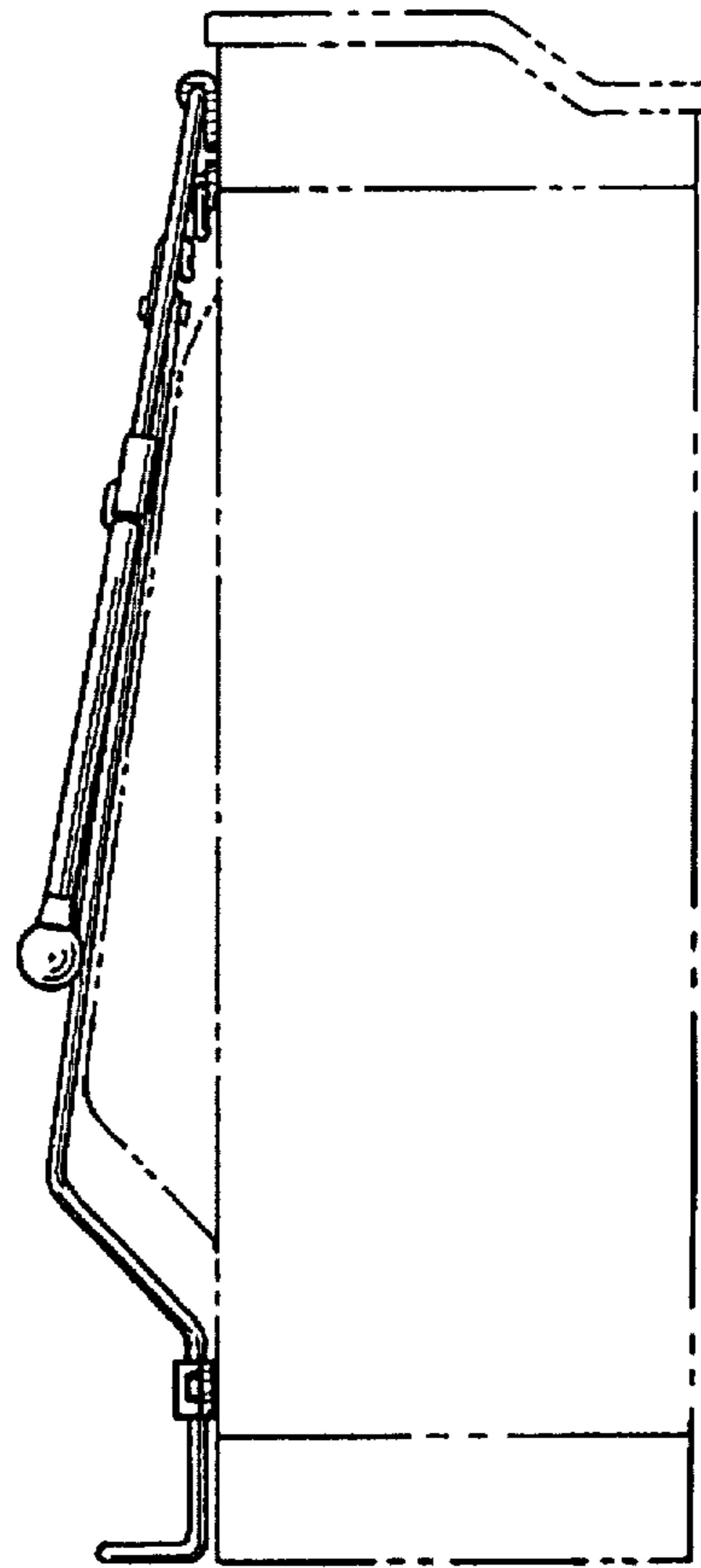

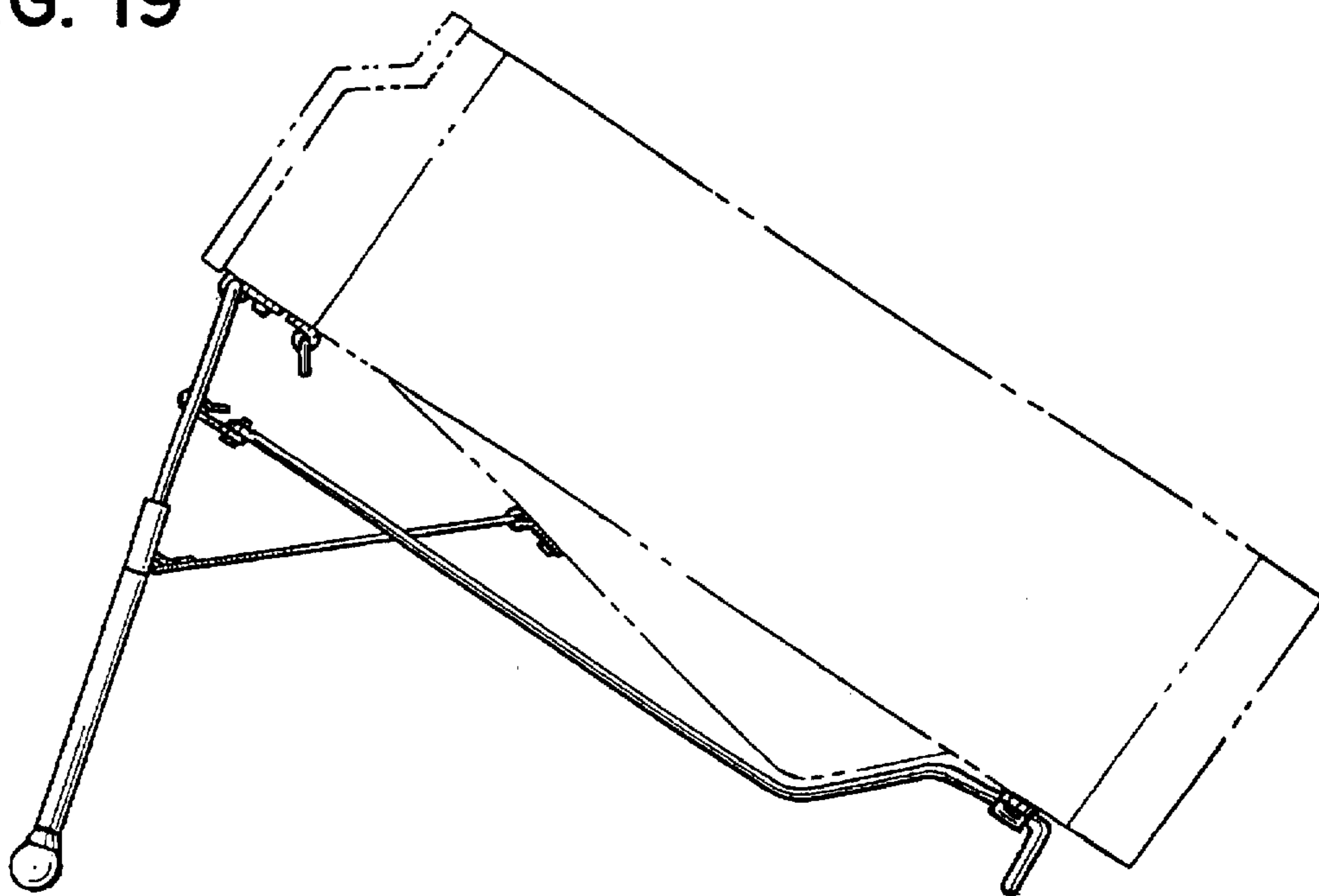

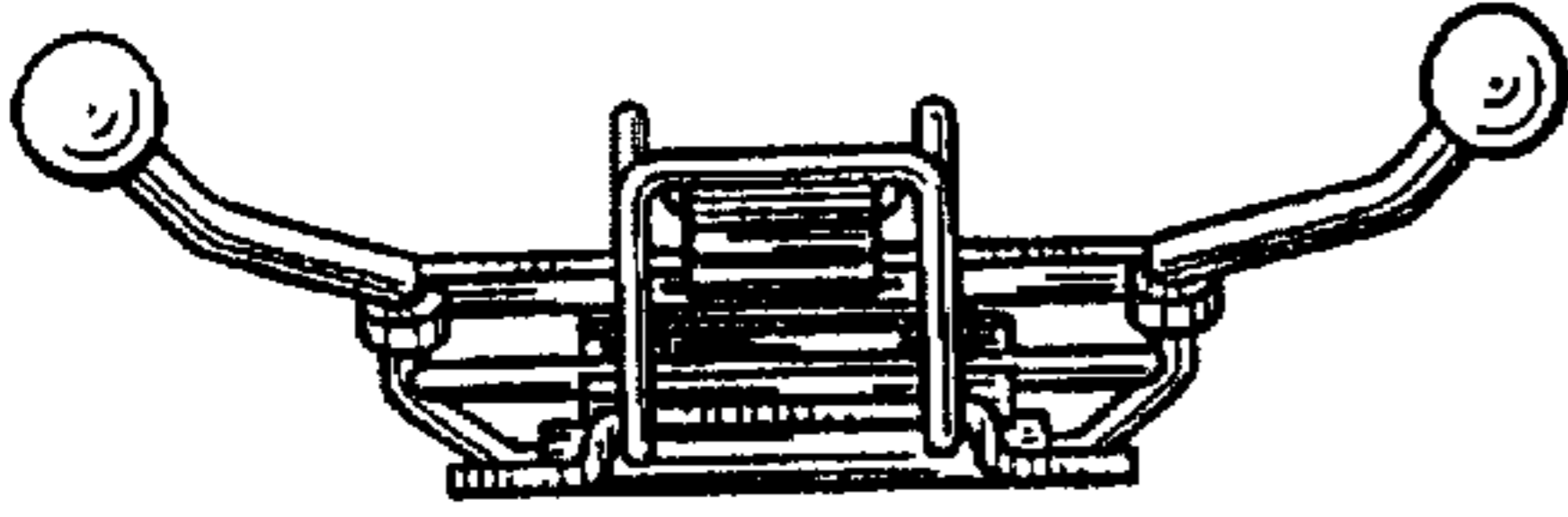

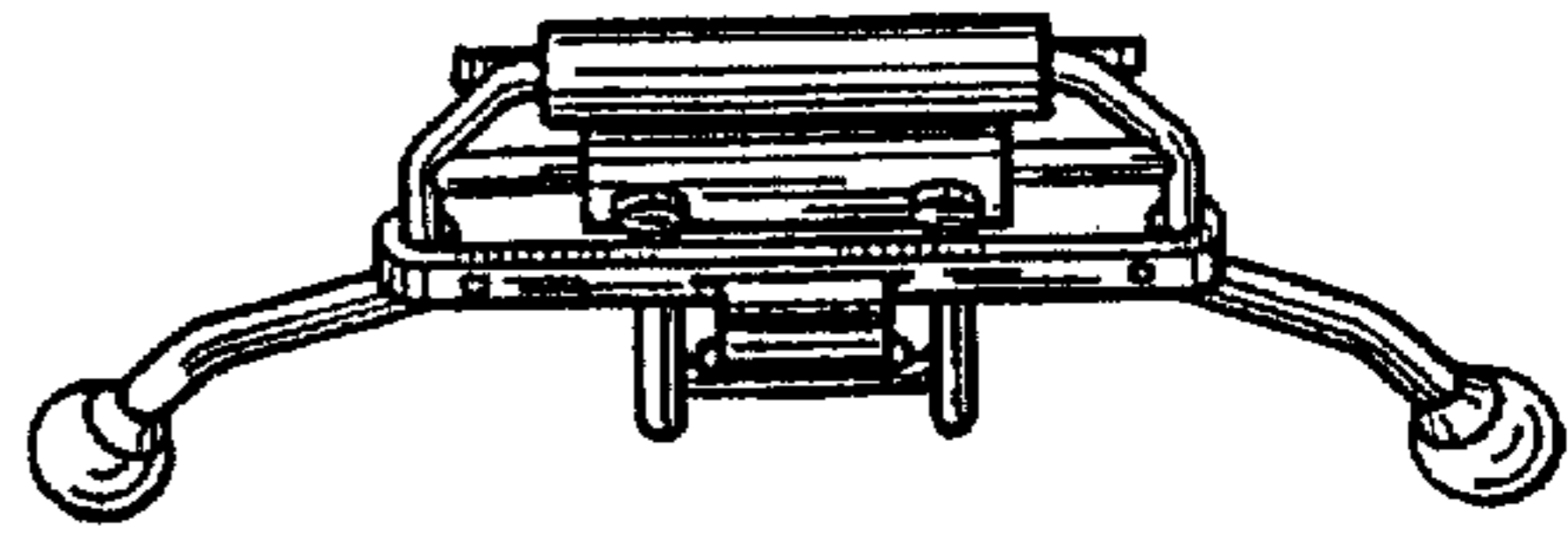

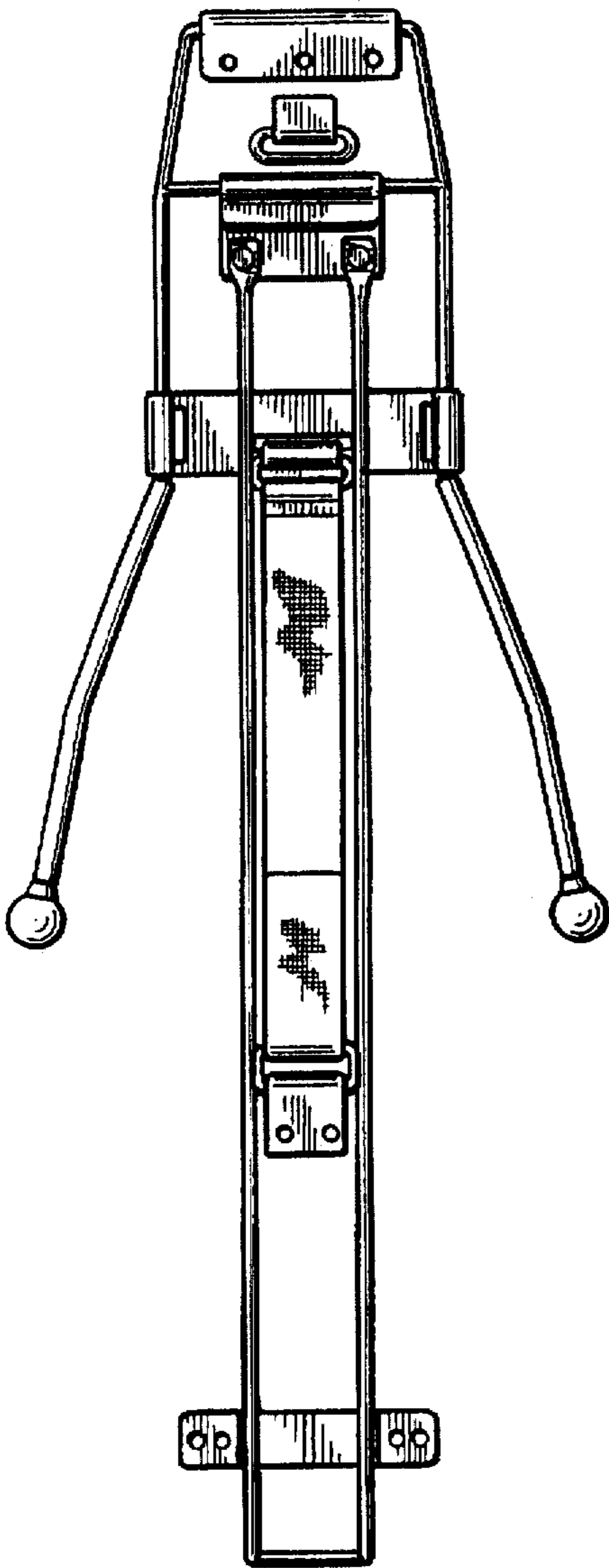
