DESCRIPTION

FIG. 1 is a side elevational view of a side element of a shoe upper showing my new design;

FIG. 5 is a side elevational view of a side element of a shoe upper showing a further embodiment my new design;

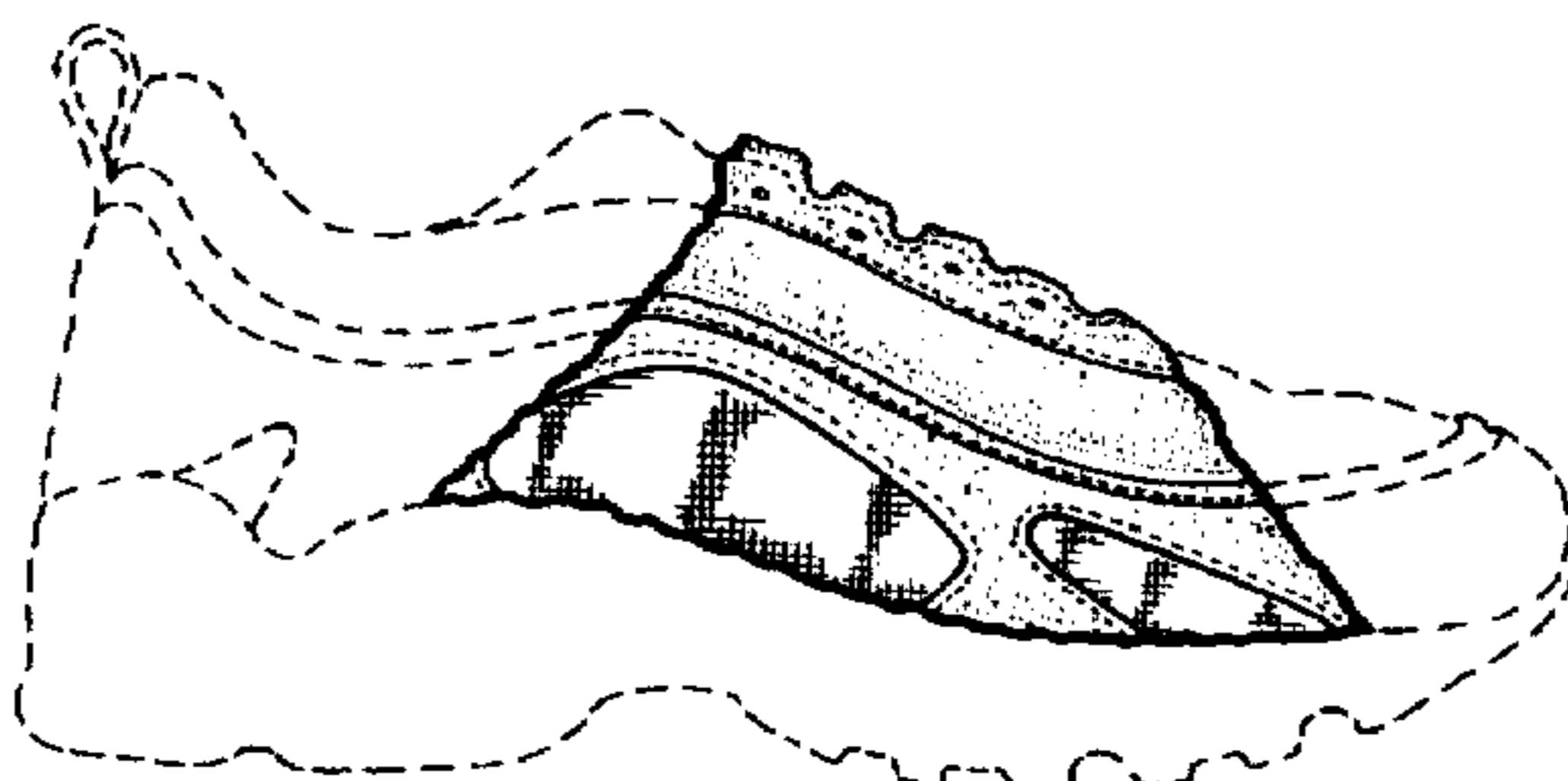
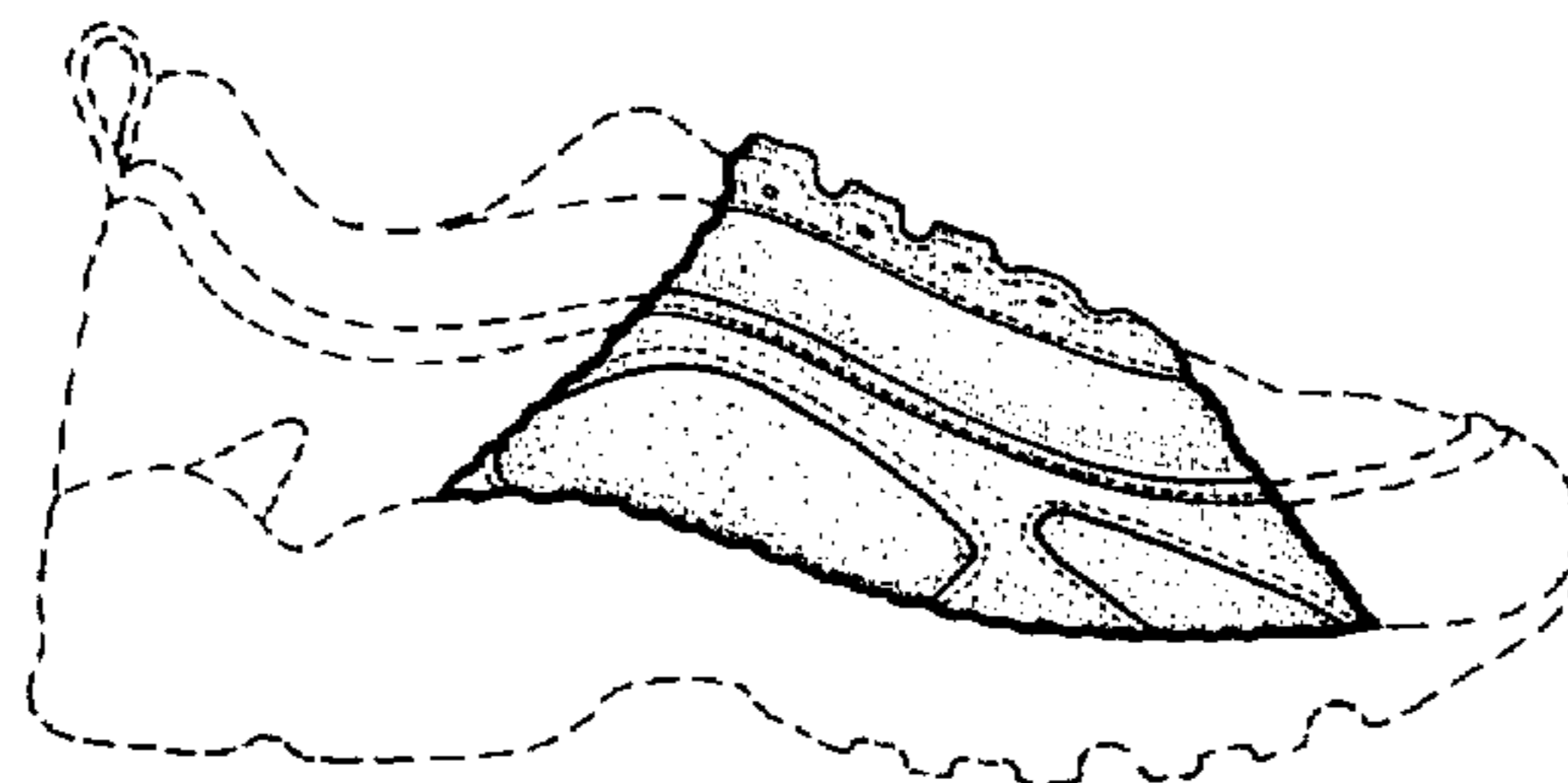
FIG. 6 is a front elevational view thereof;

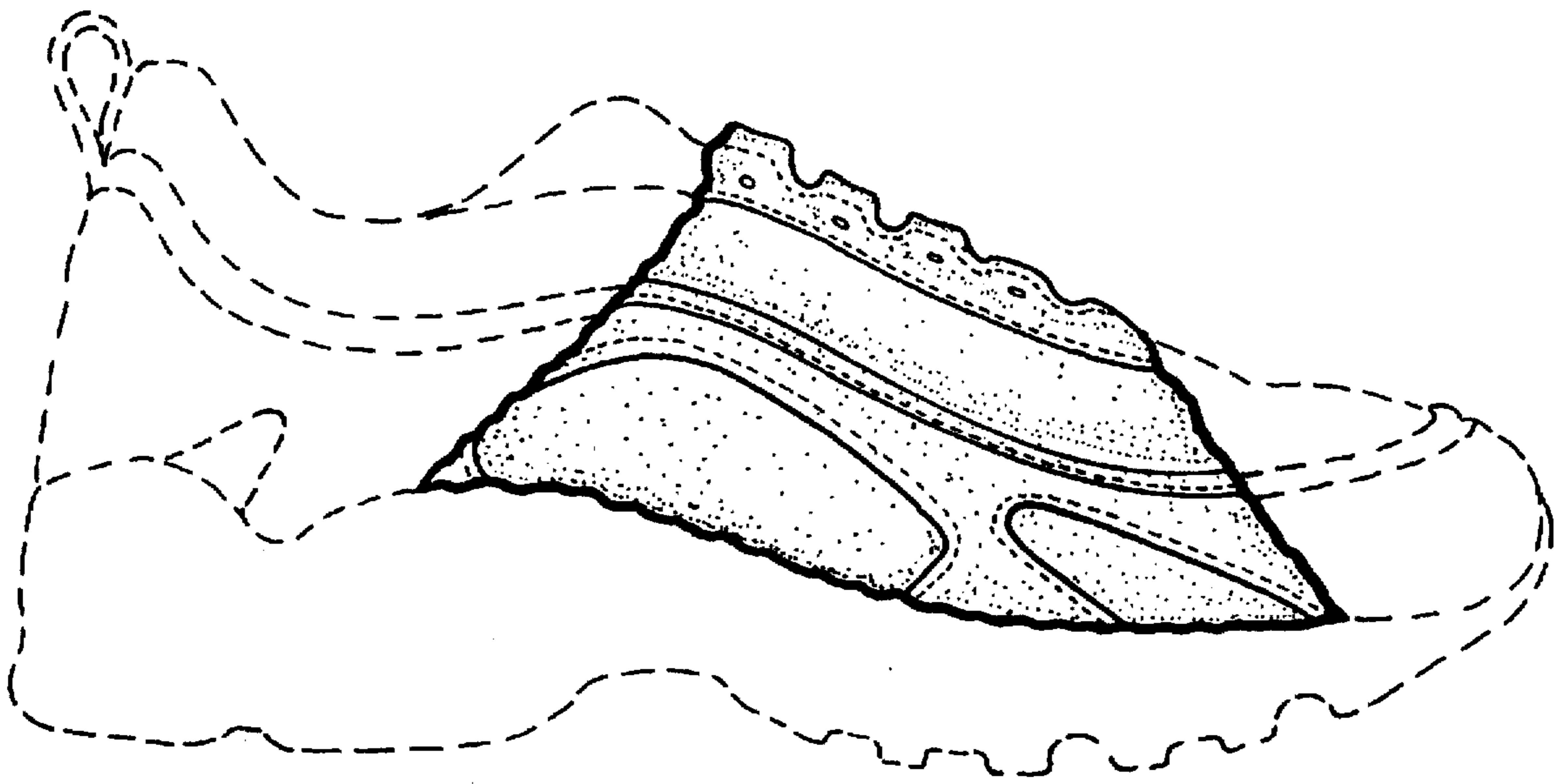

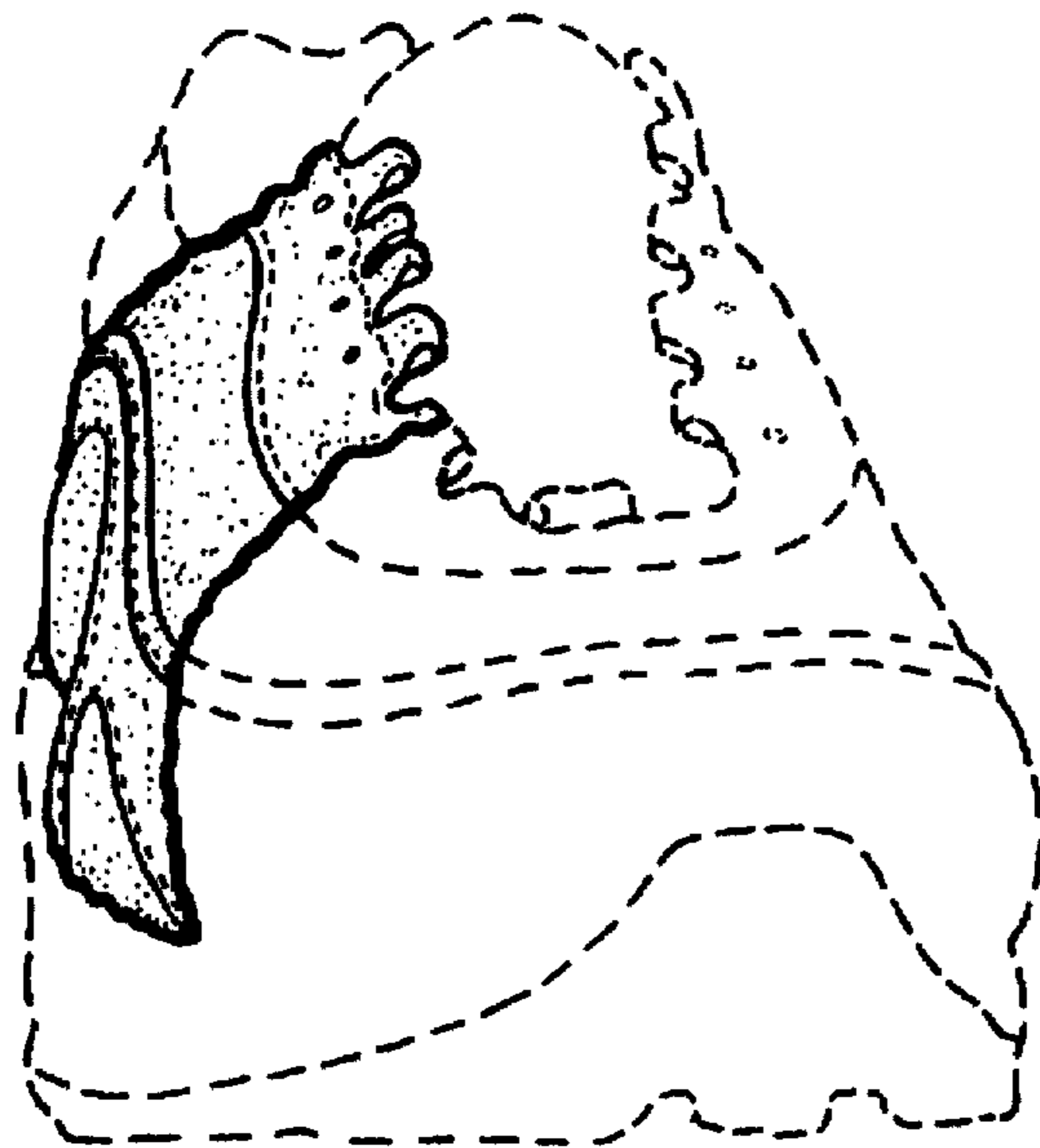

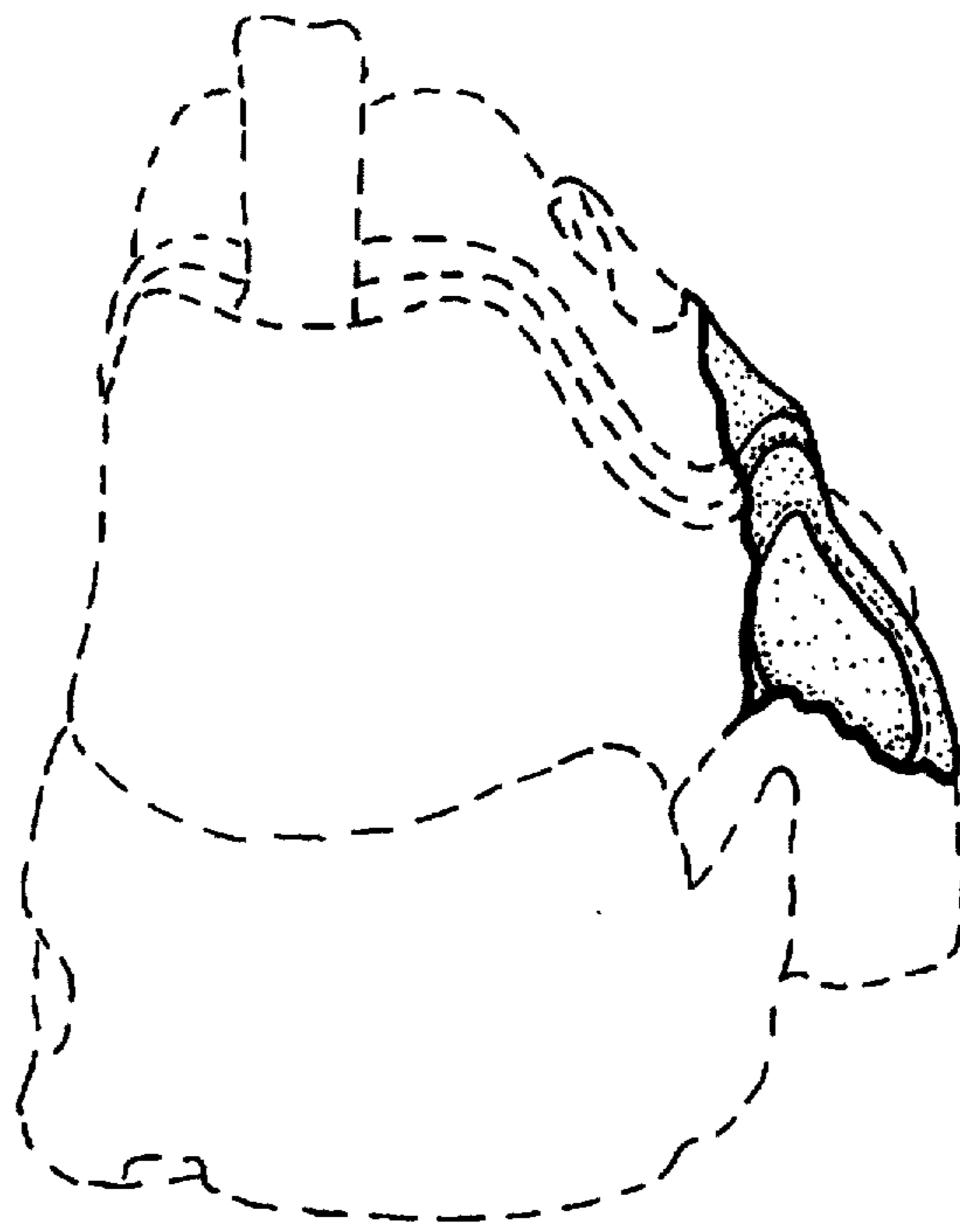

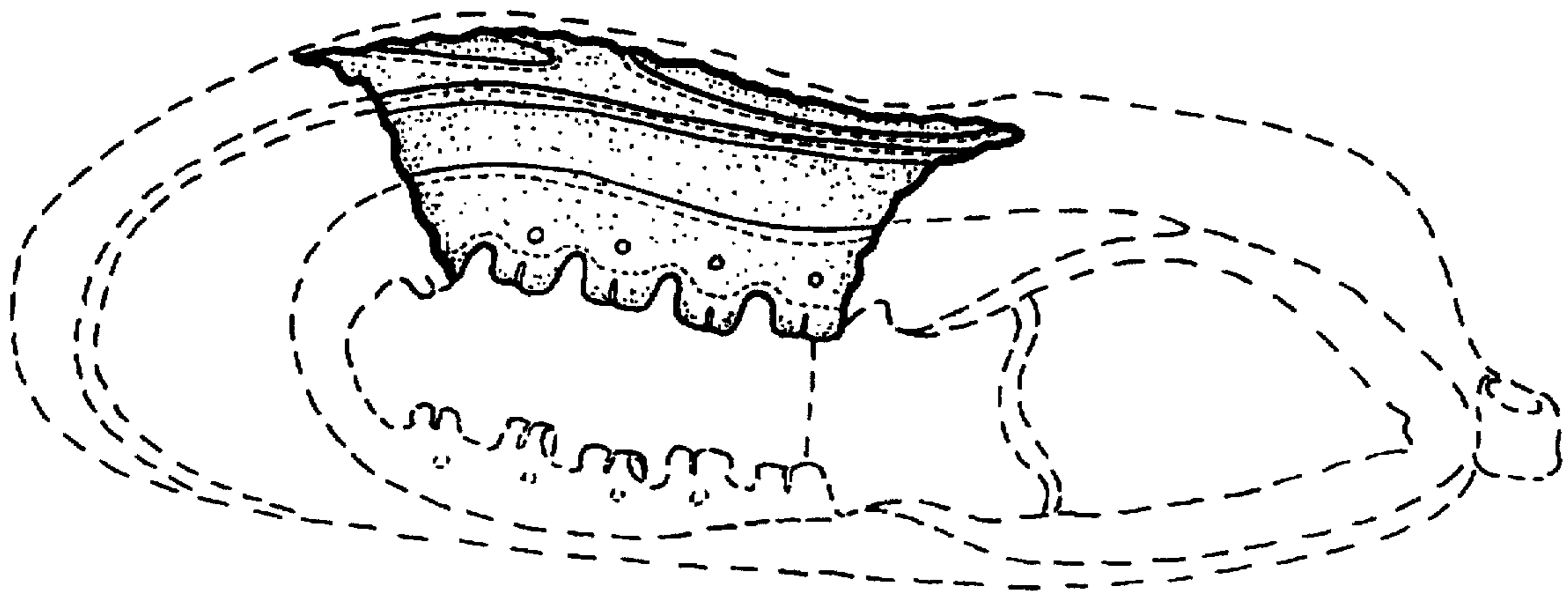

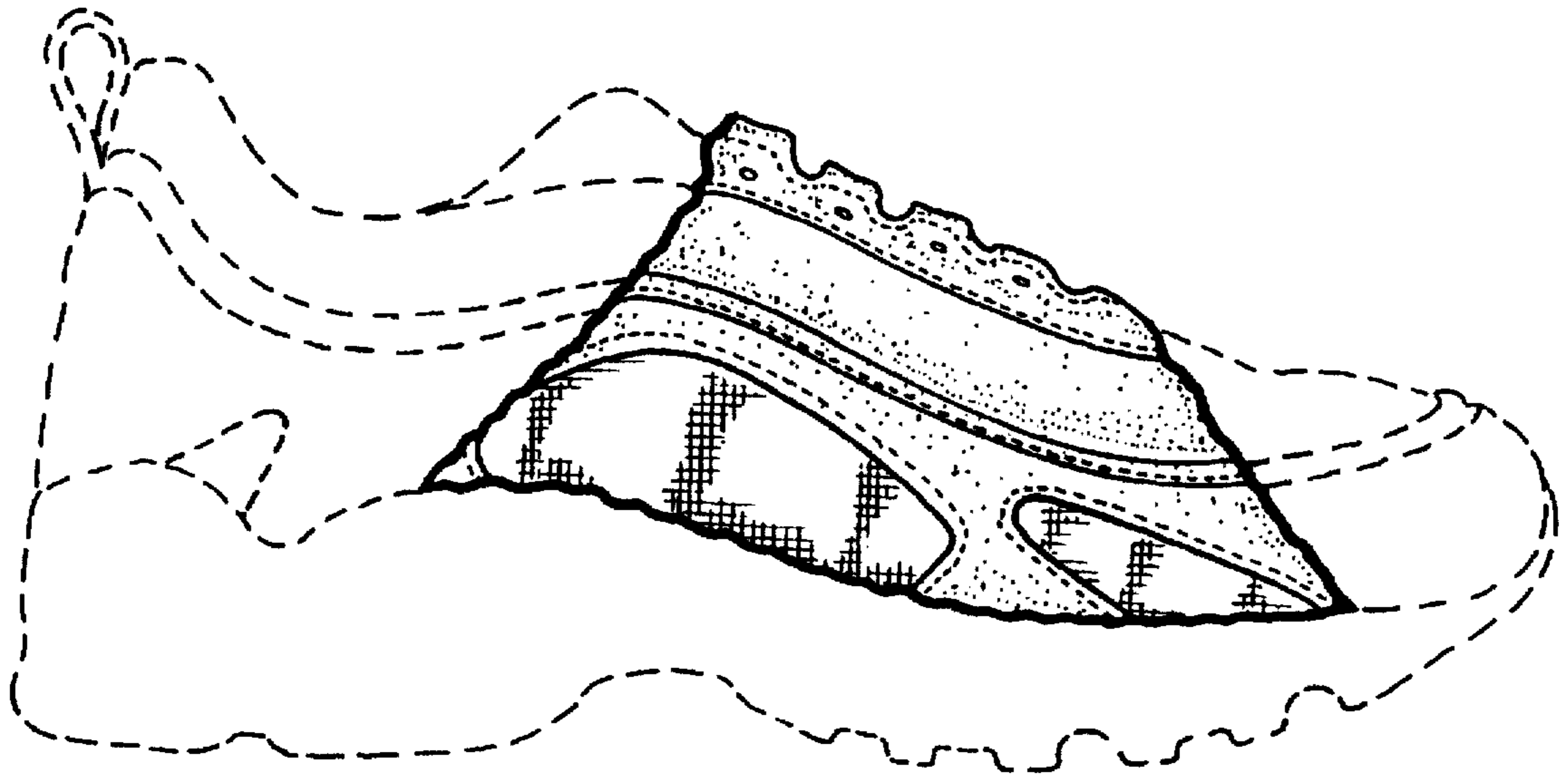

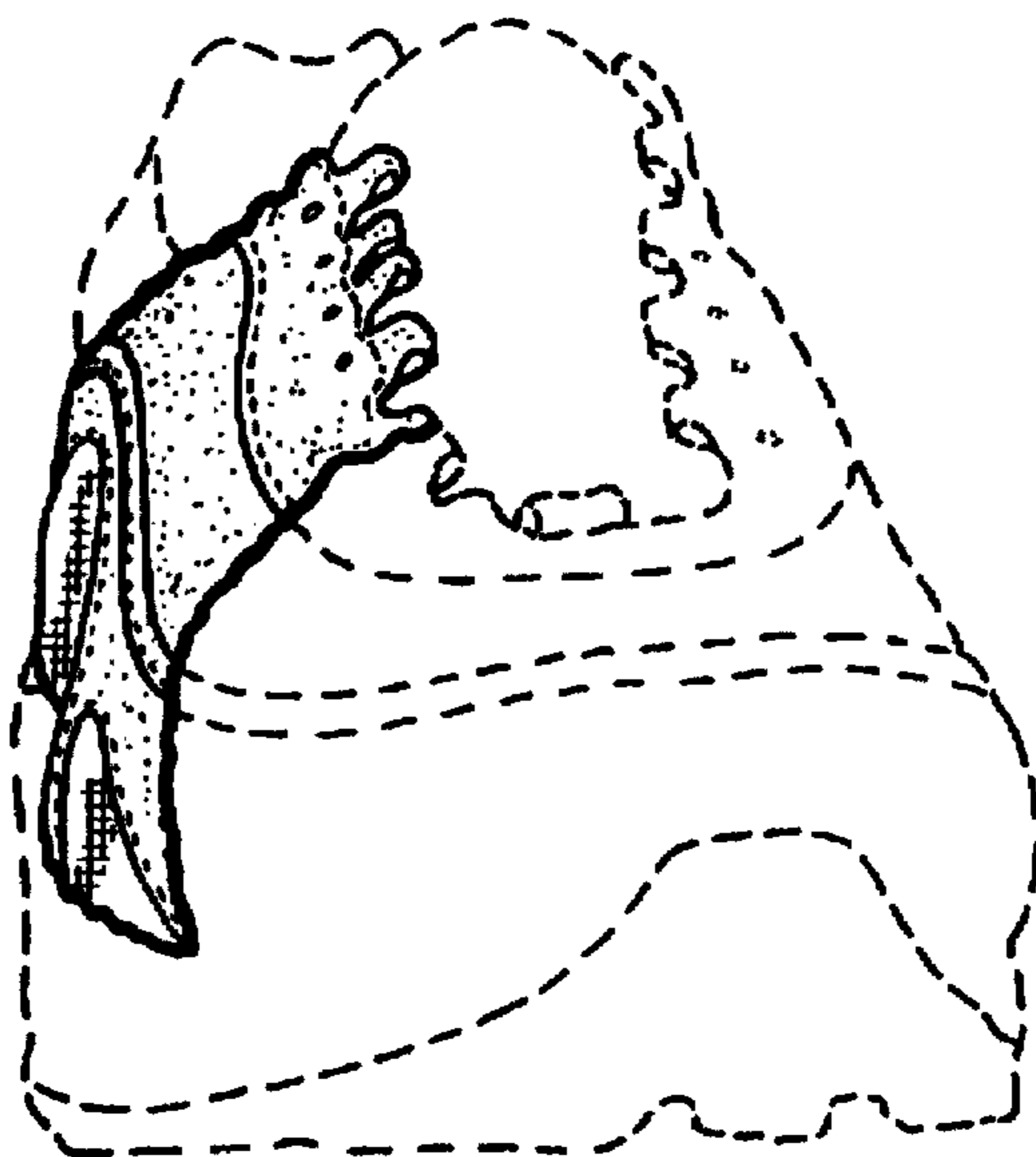

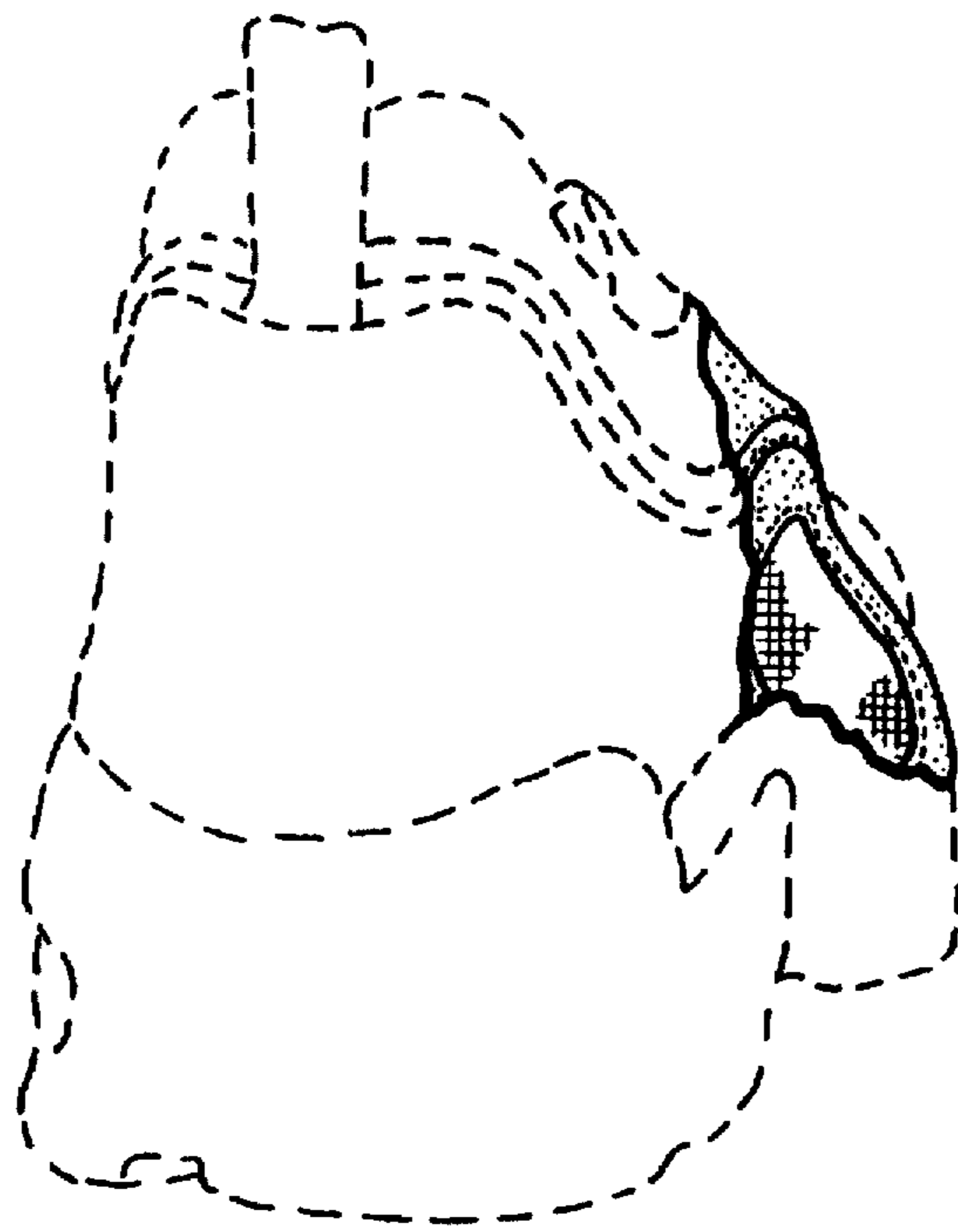

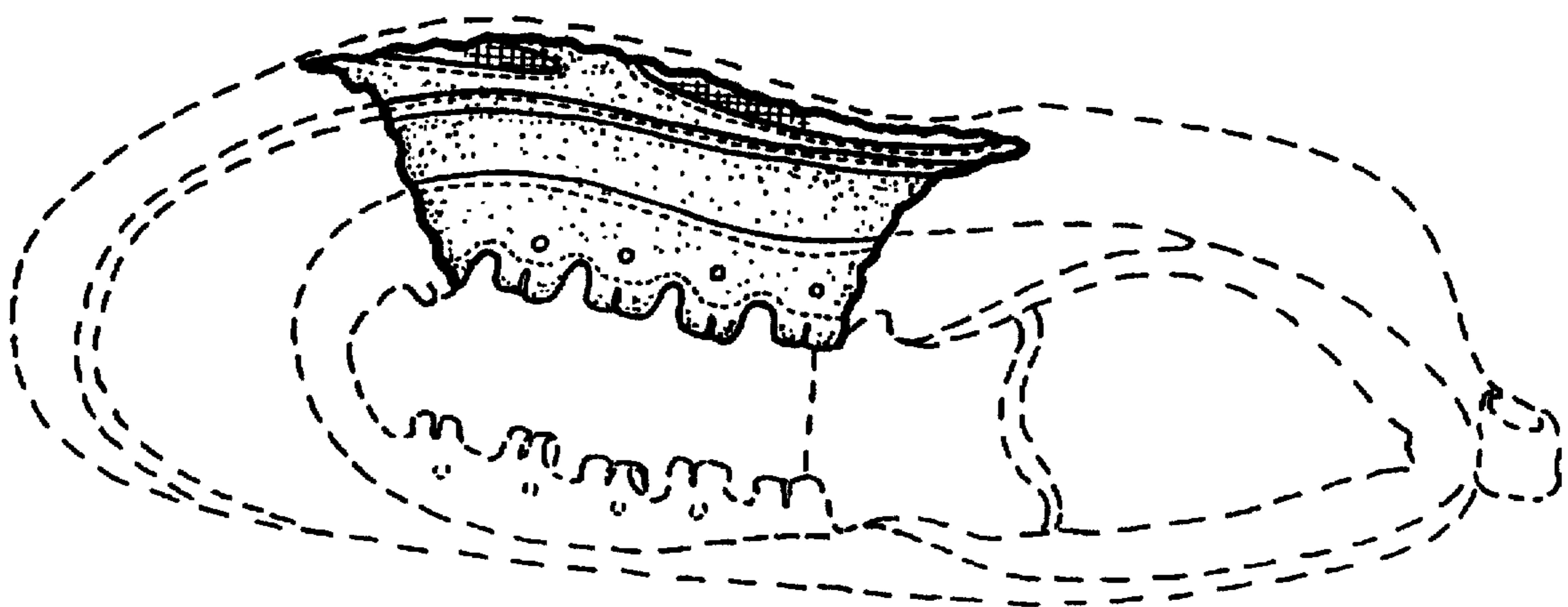
