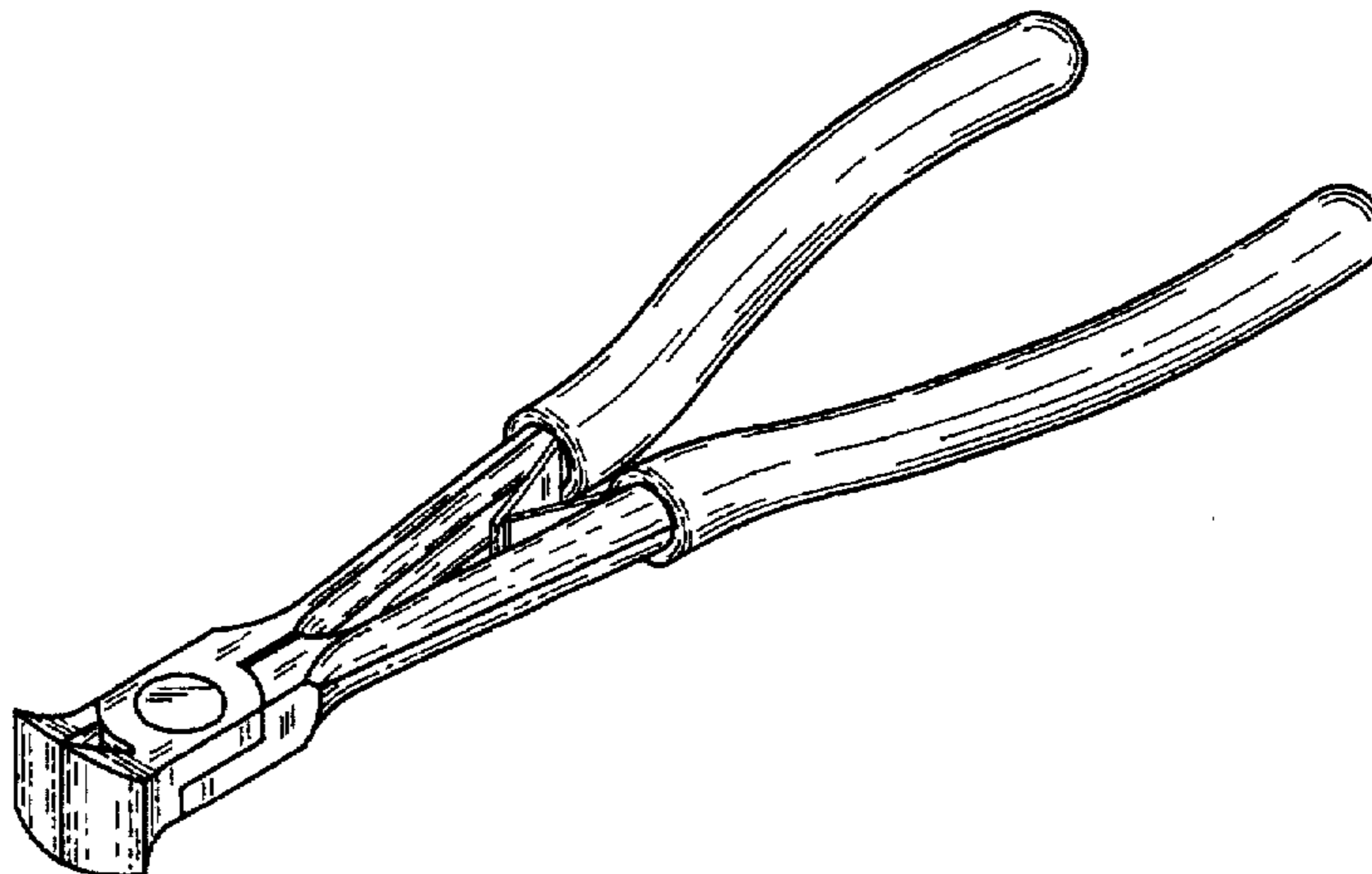
[57] **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of the hand tool showing my new design;

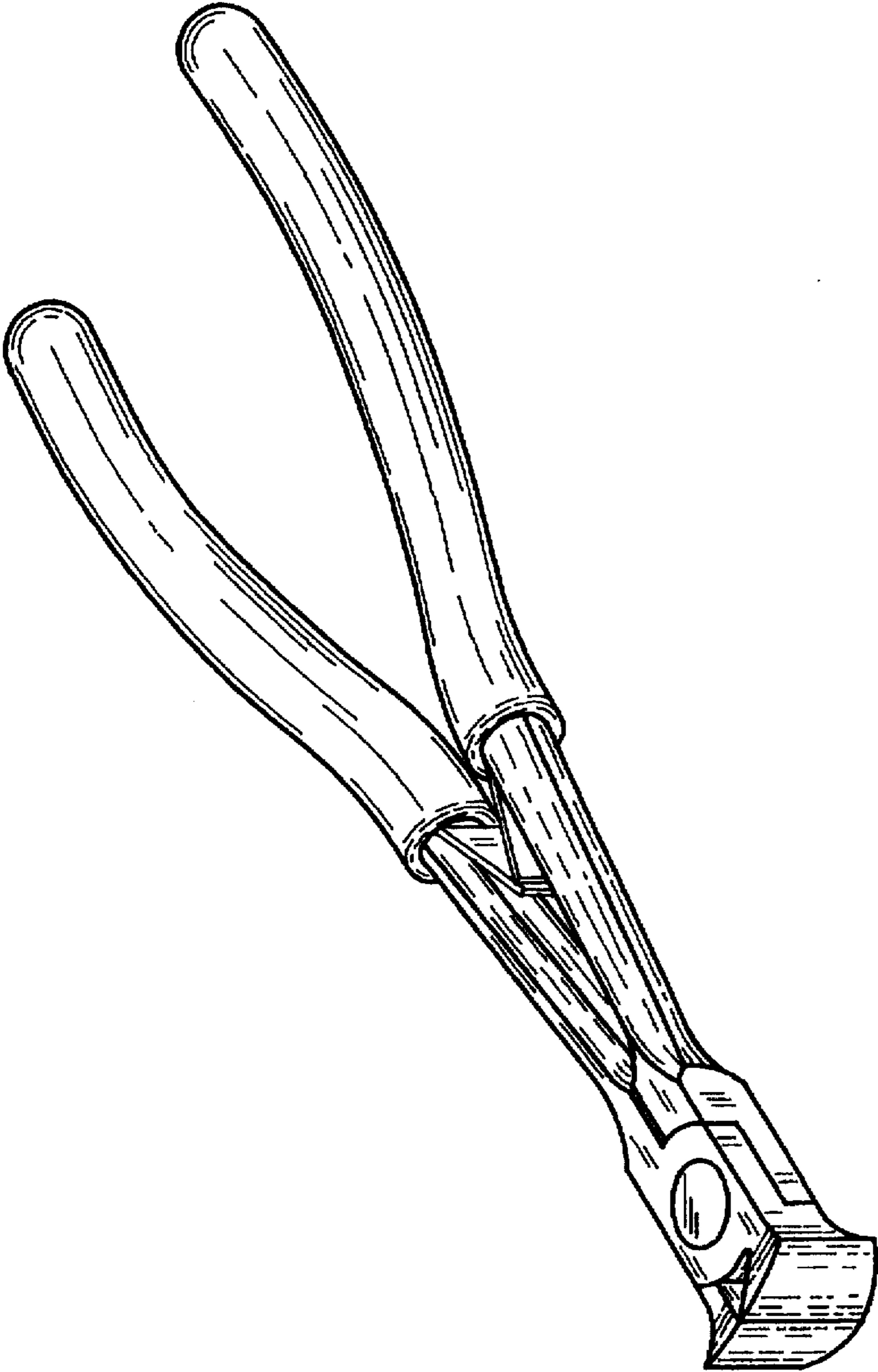

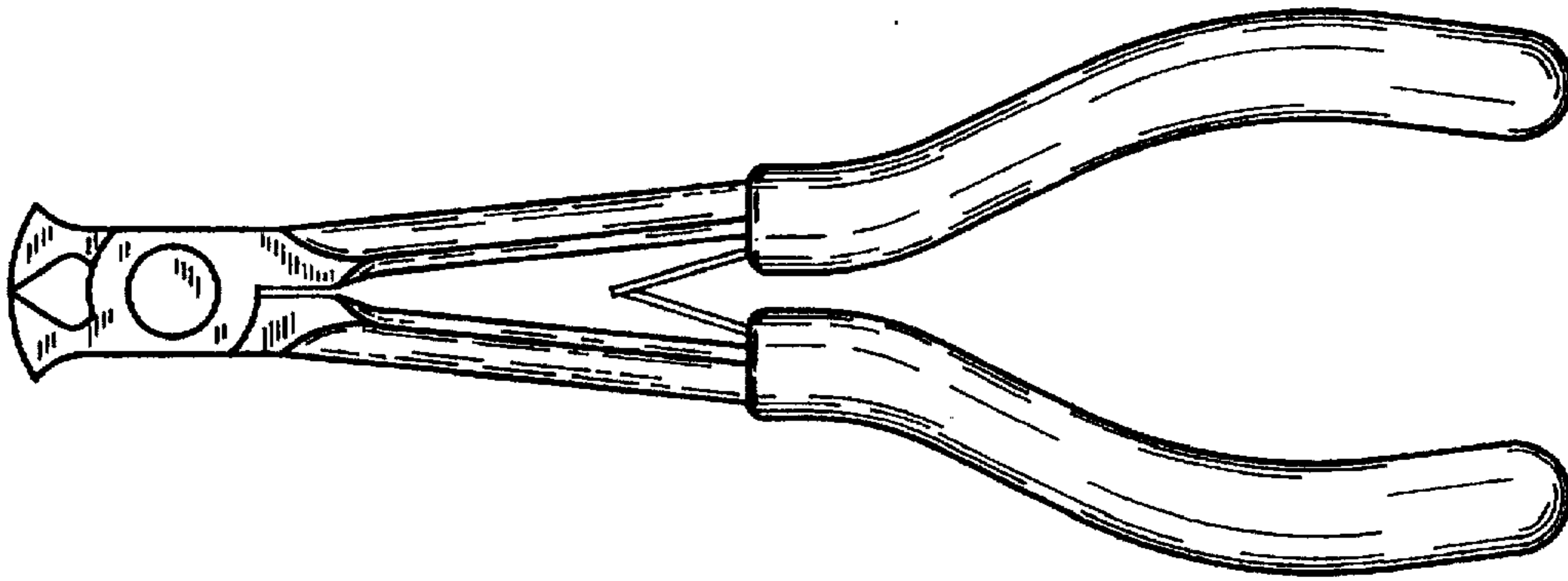

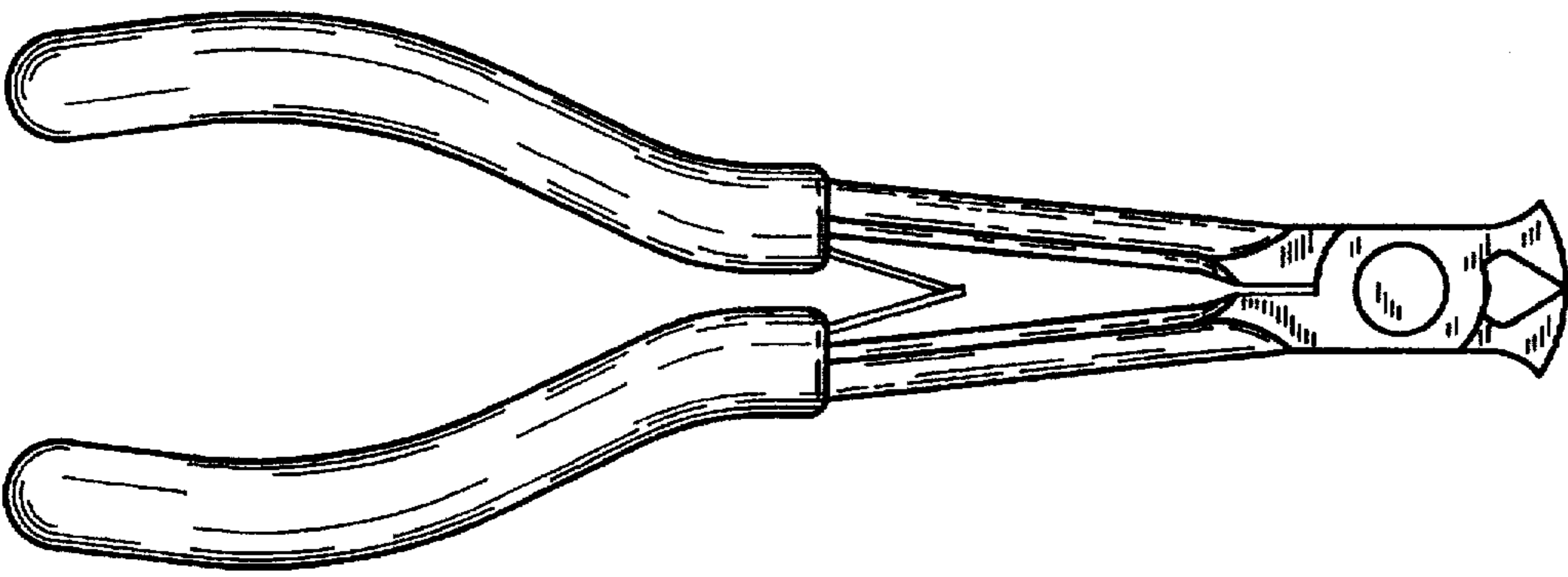

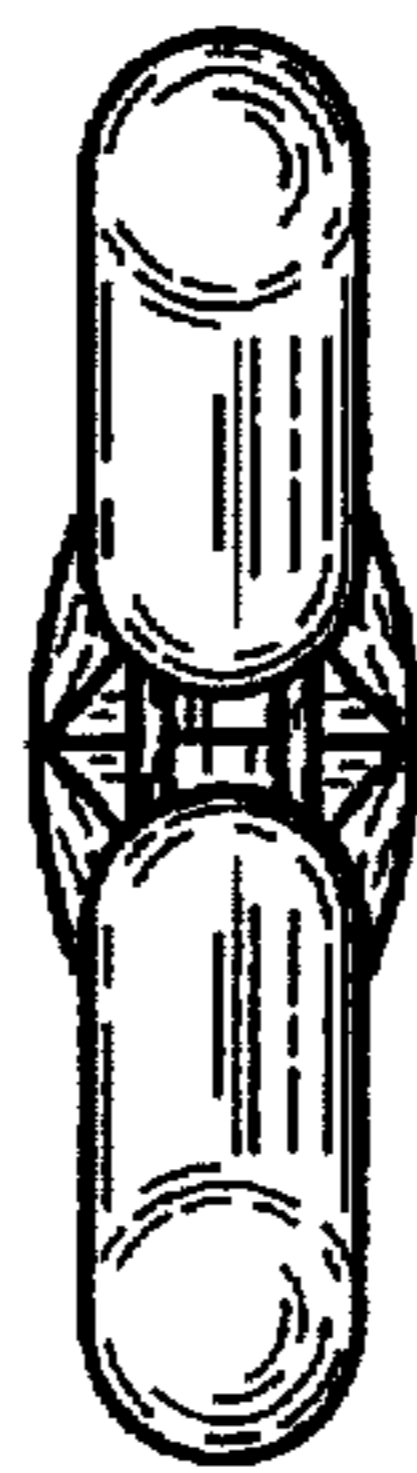

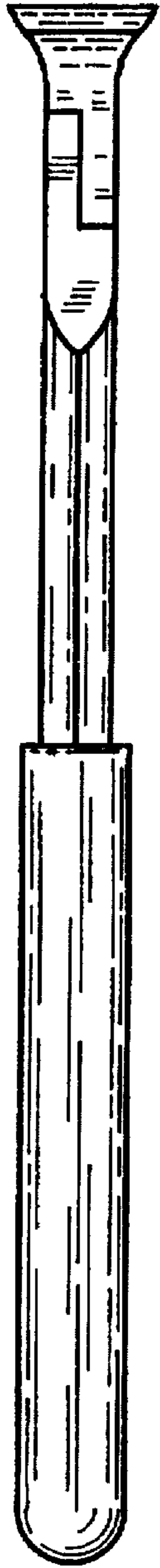

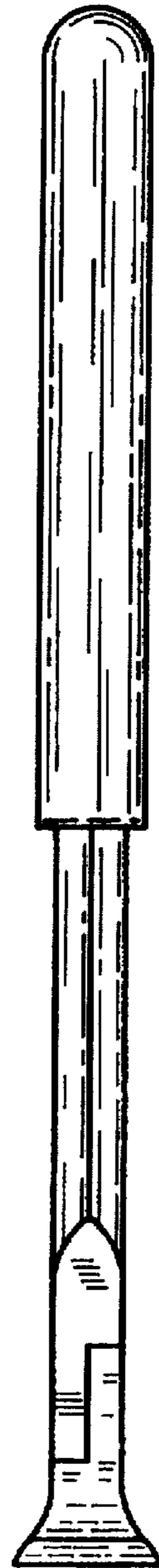
