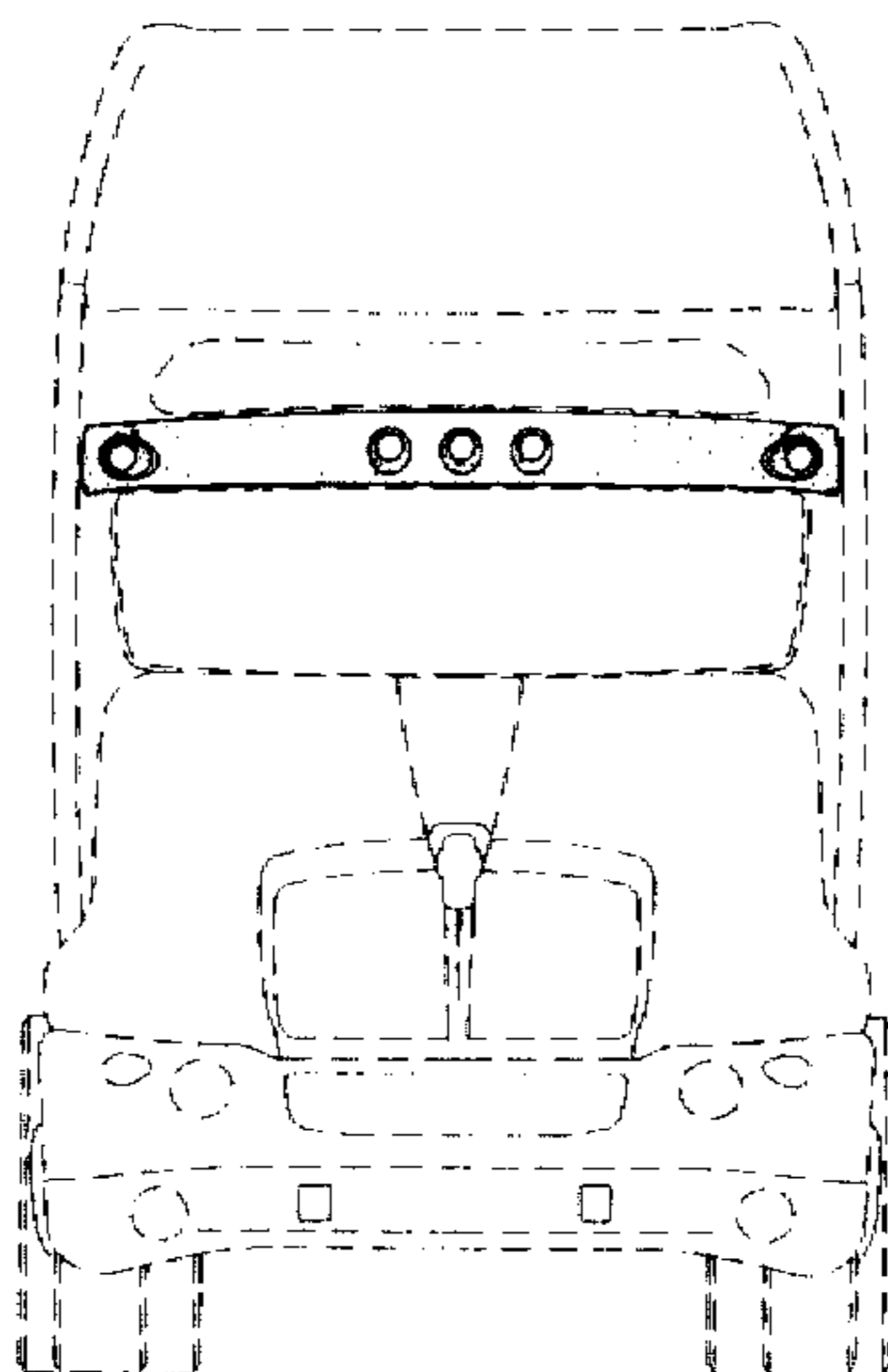
The ornamental design for truck sun visor, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a truck sun visor showing our new design;
 FIG. 2 is a side view thereof;
 FIG. 3 is a side view thereof, shown in an enlarged scale;
 FIG. 4 is a side view thereof, the opposite side being a mirror image thereof;
 FIG. 5 is a front view thereof;
 FIG. 6 is a rear view thereof;
 FIG. 7 is a top view thereof;
 FIG. 8 is a bottom view thereof;
 FIG. 9 is a side view of a second embodiment of a truck sun visor showing our new design, the opposite side being a mirror image thereof;
 FIG. 10 is a front view thereof;
 FIG. 11 is a rear view thereof;
 FIG. 12 is a top view thereof; and,
 FIG. 13 is a bottom view thereof.

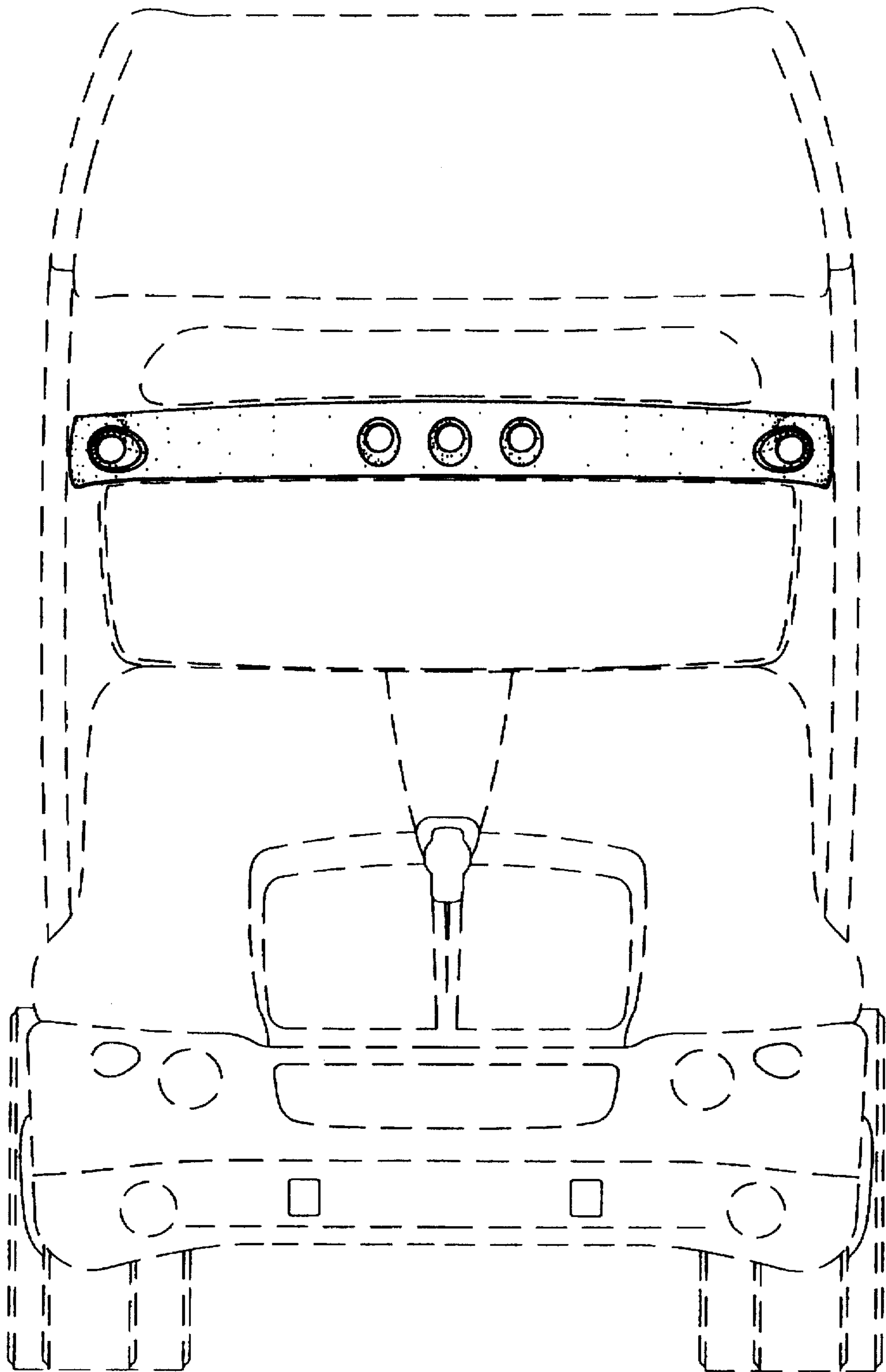
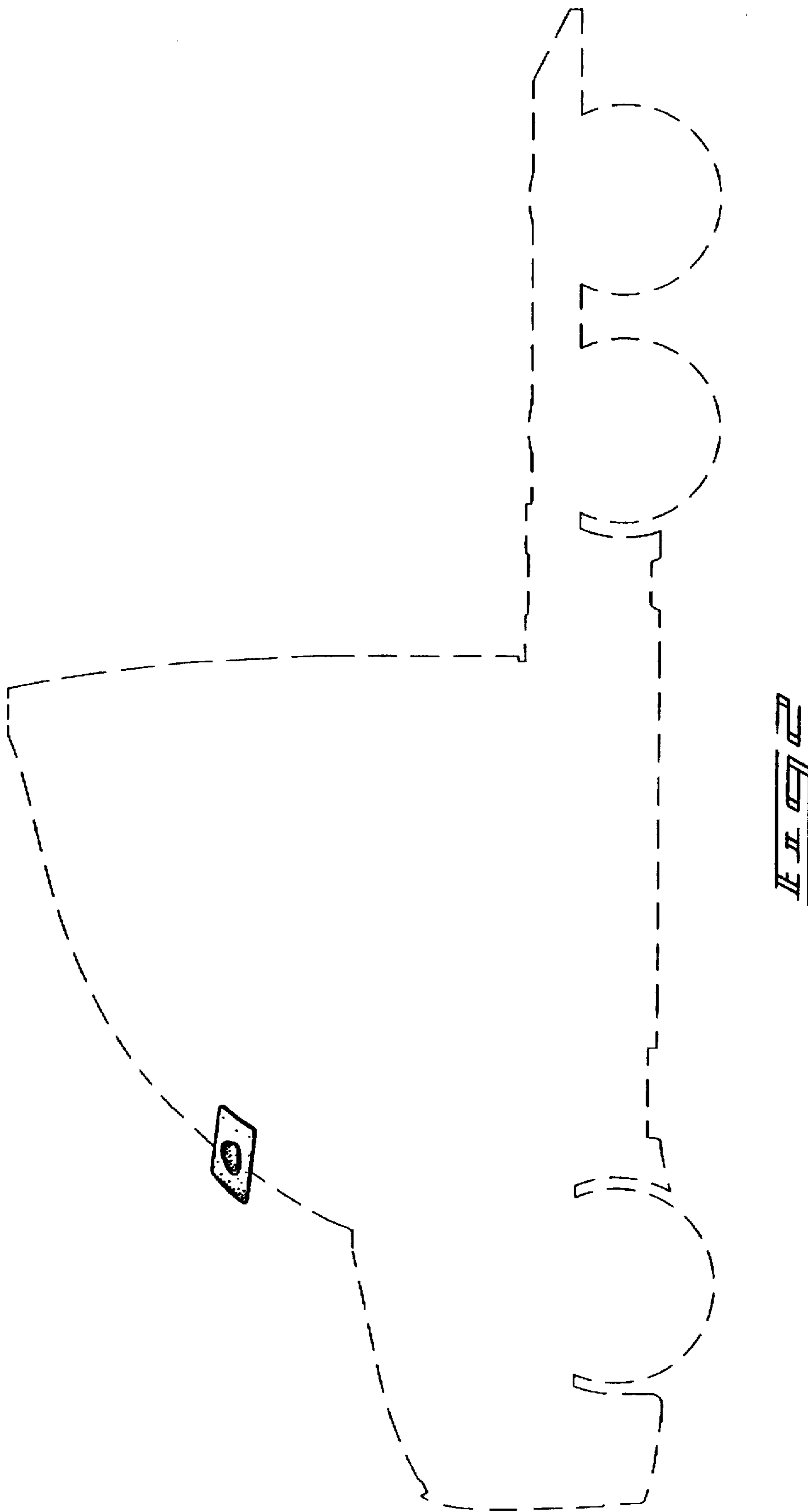

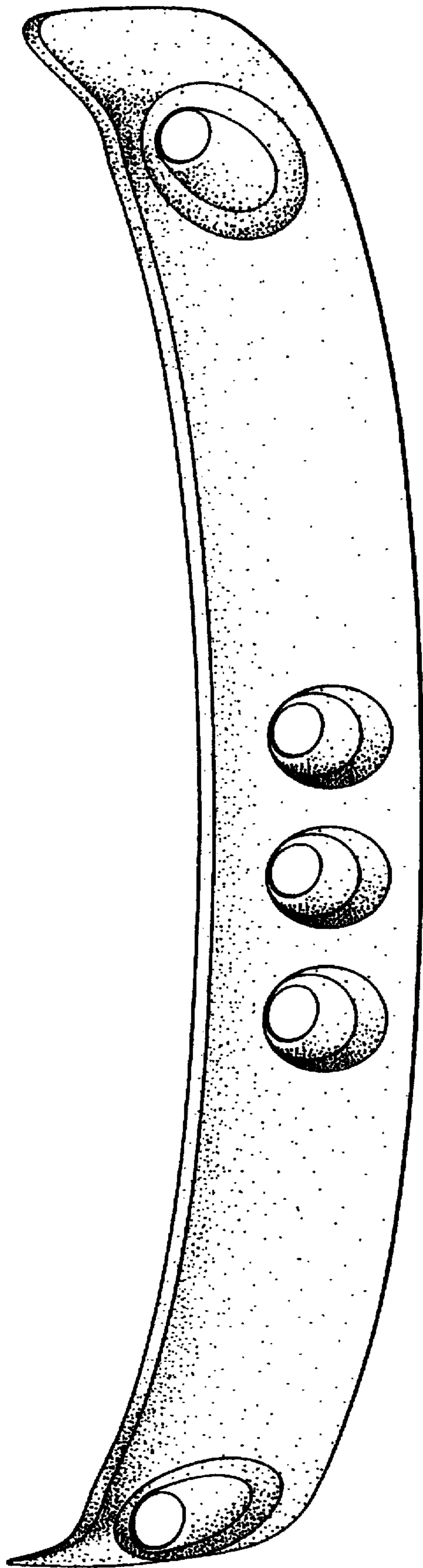

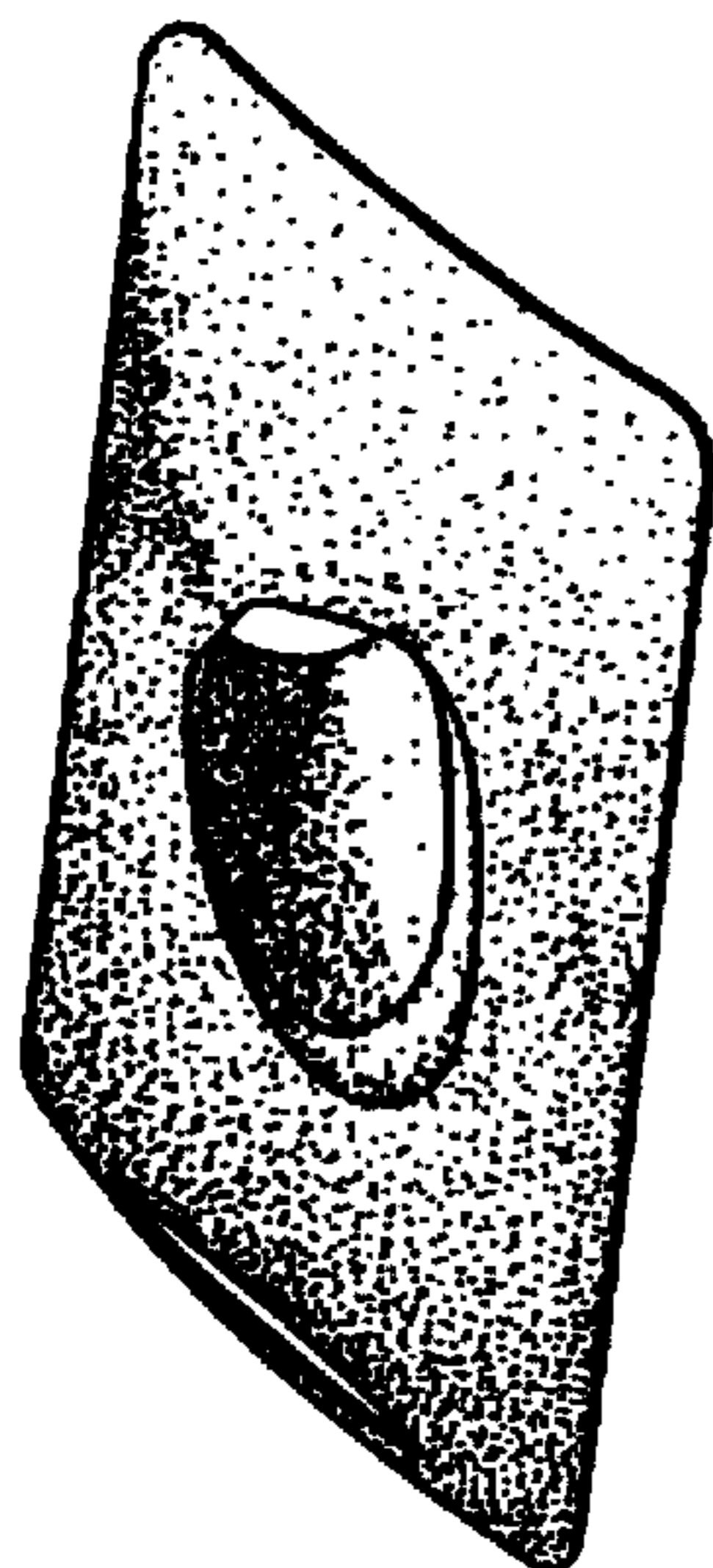

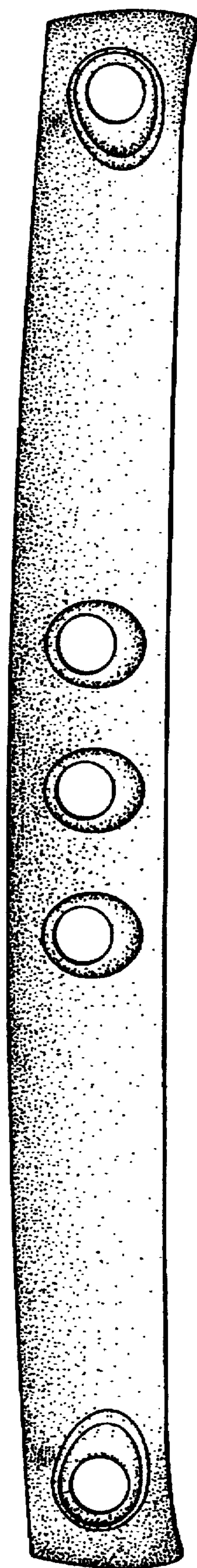

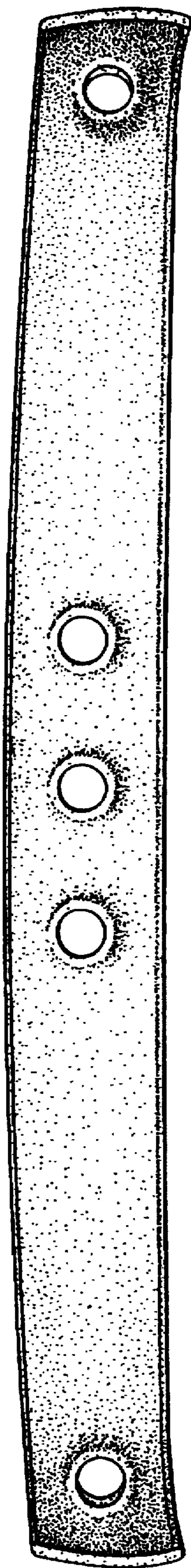

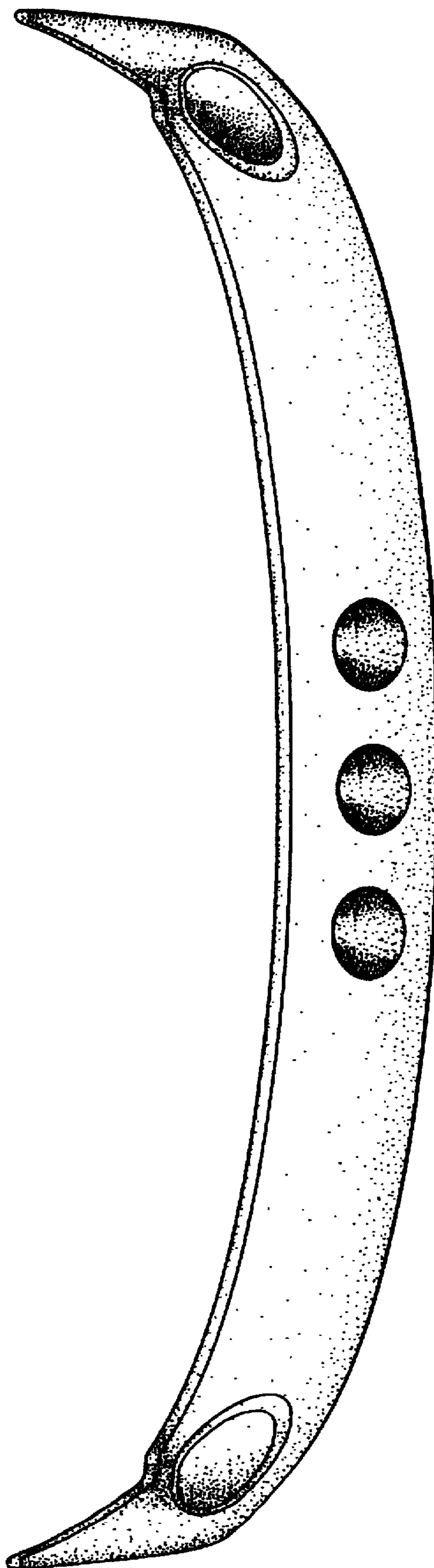

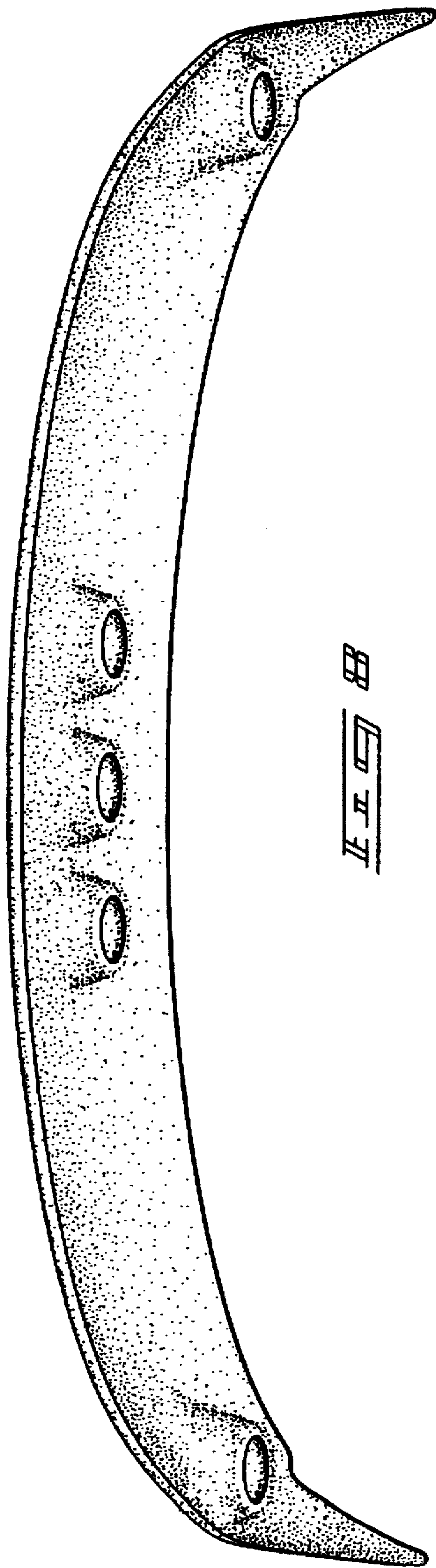

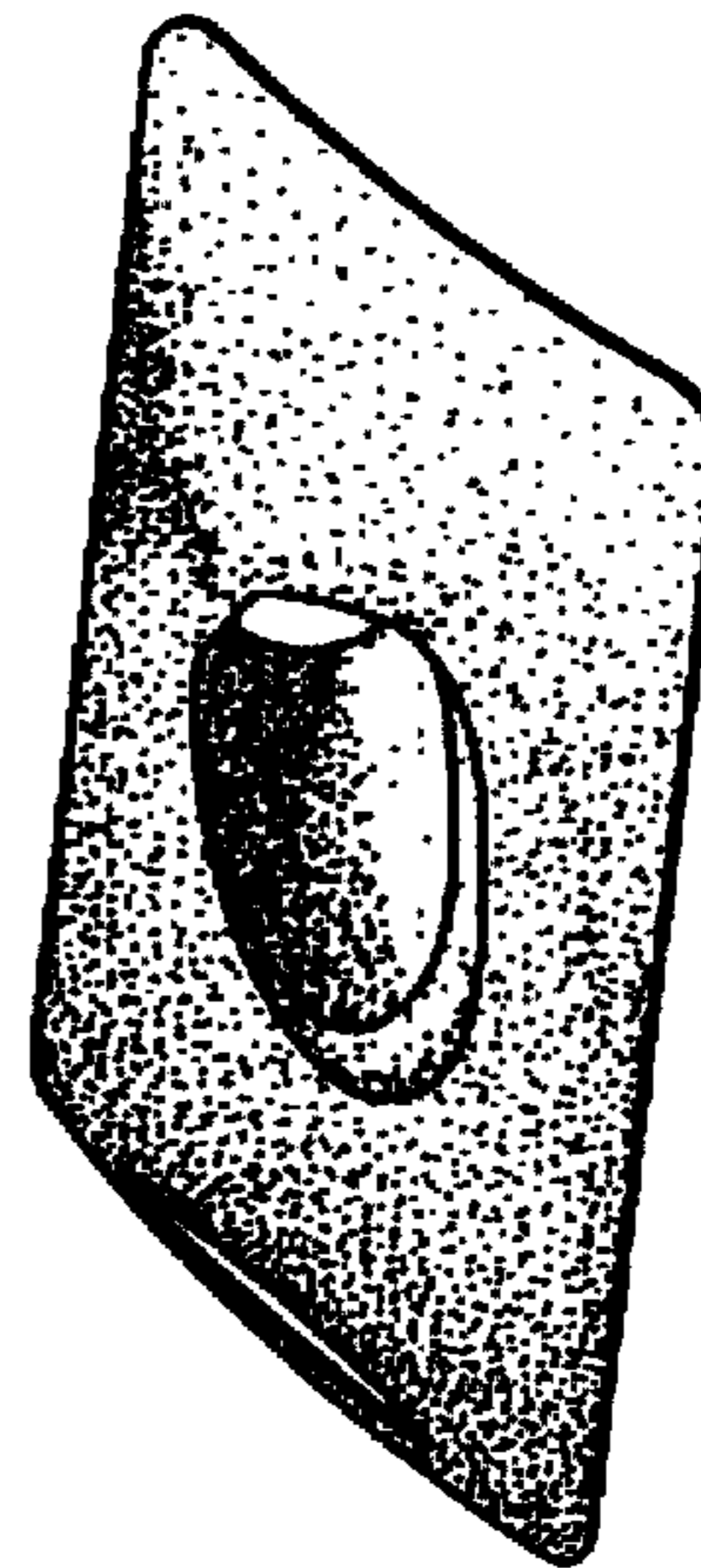

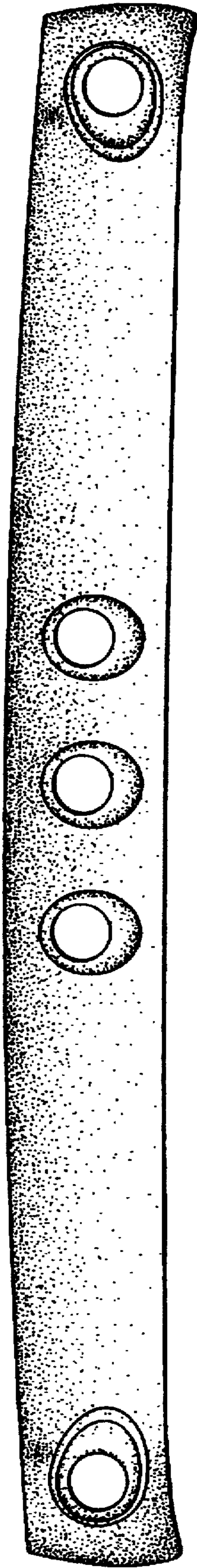

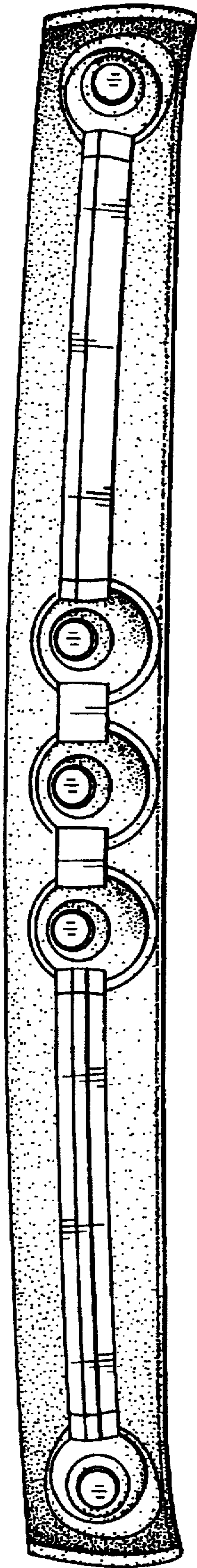
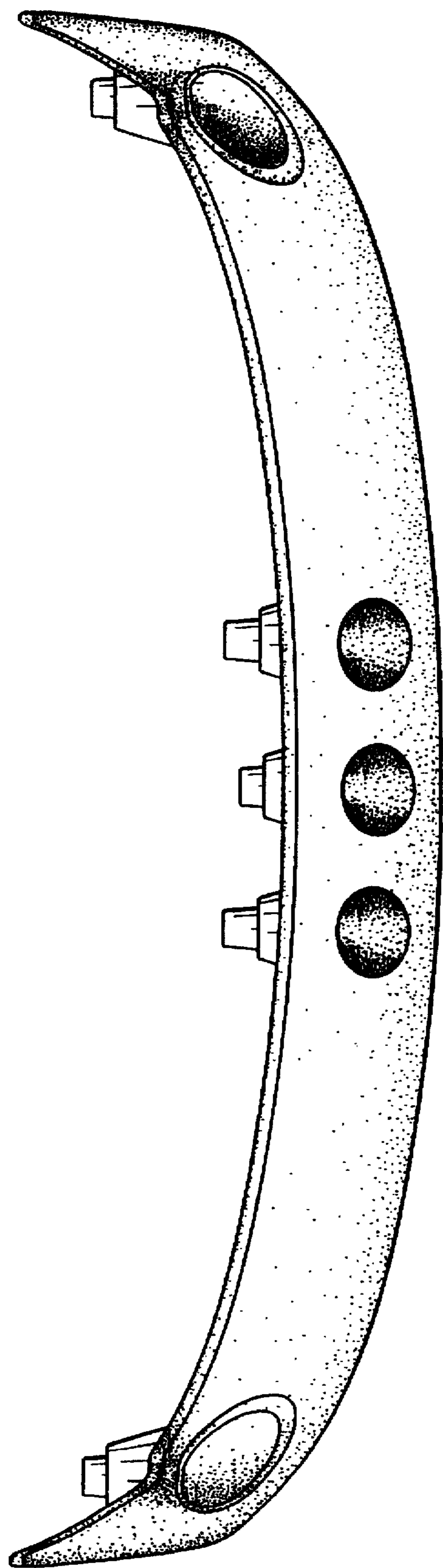
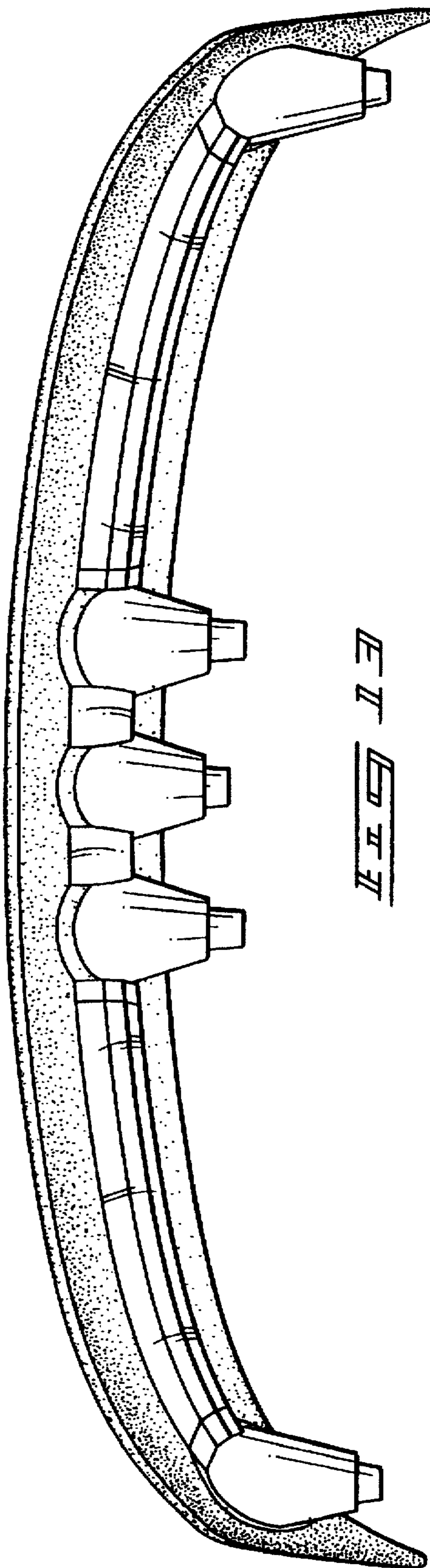
