### [57] CLAIM

The ornamental design for a microphone holder, as shown and described.

### DESCRIPTION

FIG. 1 is an orthogonal projection view of an embodiment of the microphone holder of the present invention;

FIG. 2 is a top plan view of the embodiment of the microphone holder of FIG. 1;

FIG. 3 is a front elevation view of the embodiment of the microphone holder of FIG. 1;

FIG. 4 is a bottom plan view of the embodiment of the microphone holder of FIG. 1;

FIG. 5 is a rear elevation view of the embodiment of the microphone holder of FIG. 1; and,

FIG. 6 is a side view of the embodiment of the microphone holder of FIG. 1, the opposite side being a mirror image.

The broken line showing of the microphones and wires on FIG. 1, is for illustrative purposes only and forms no part of the claimed design.

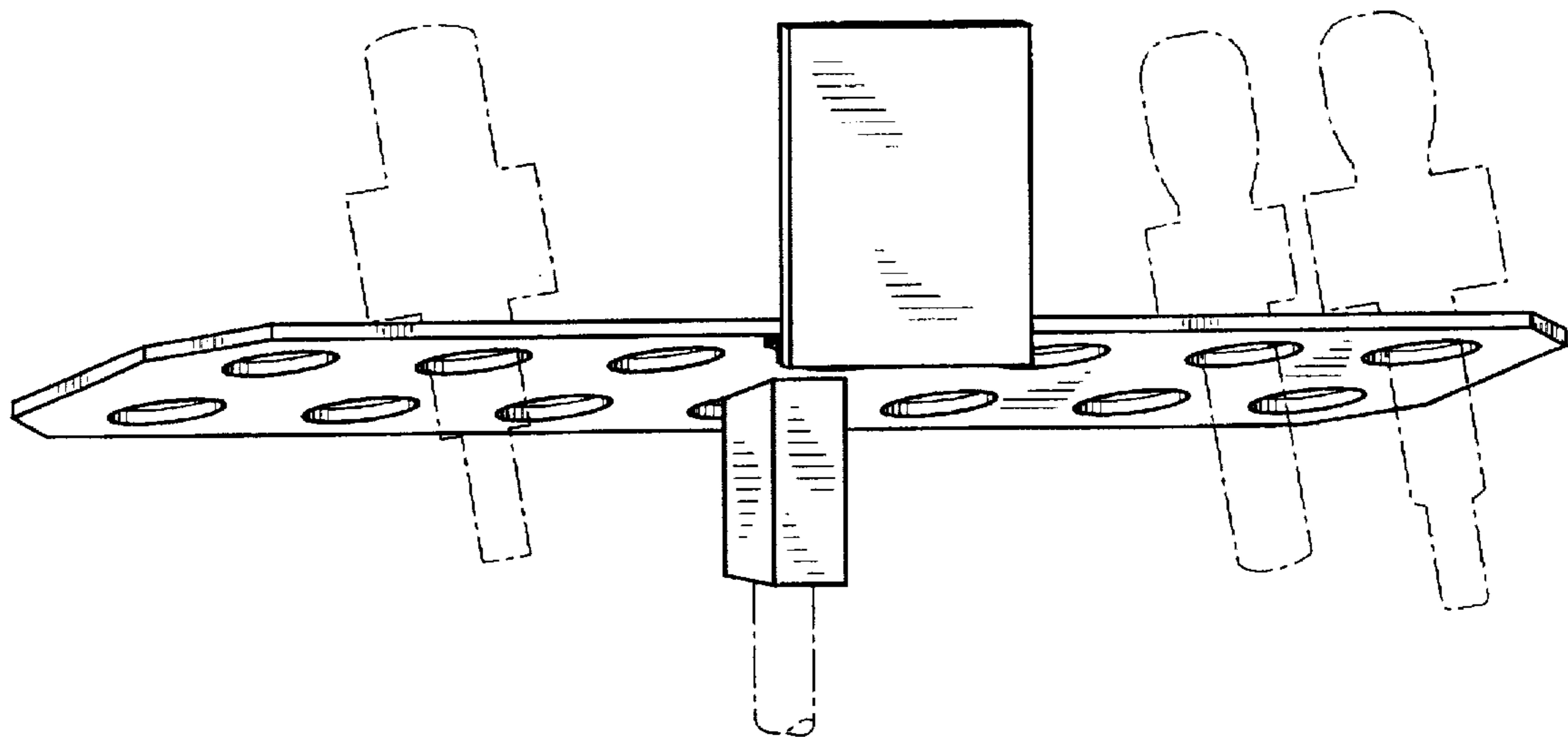

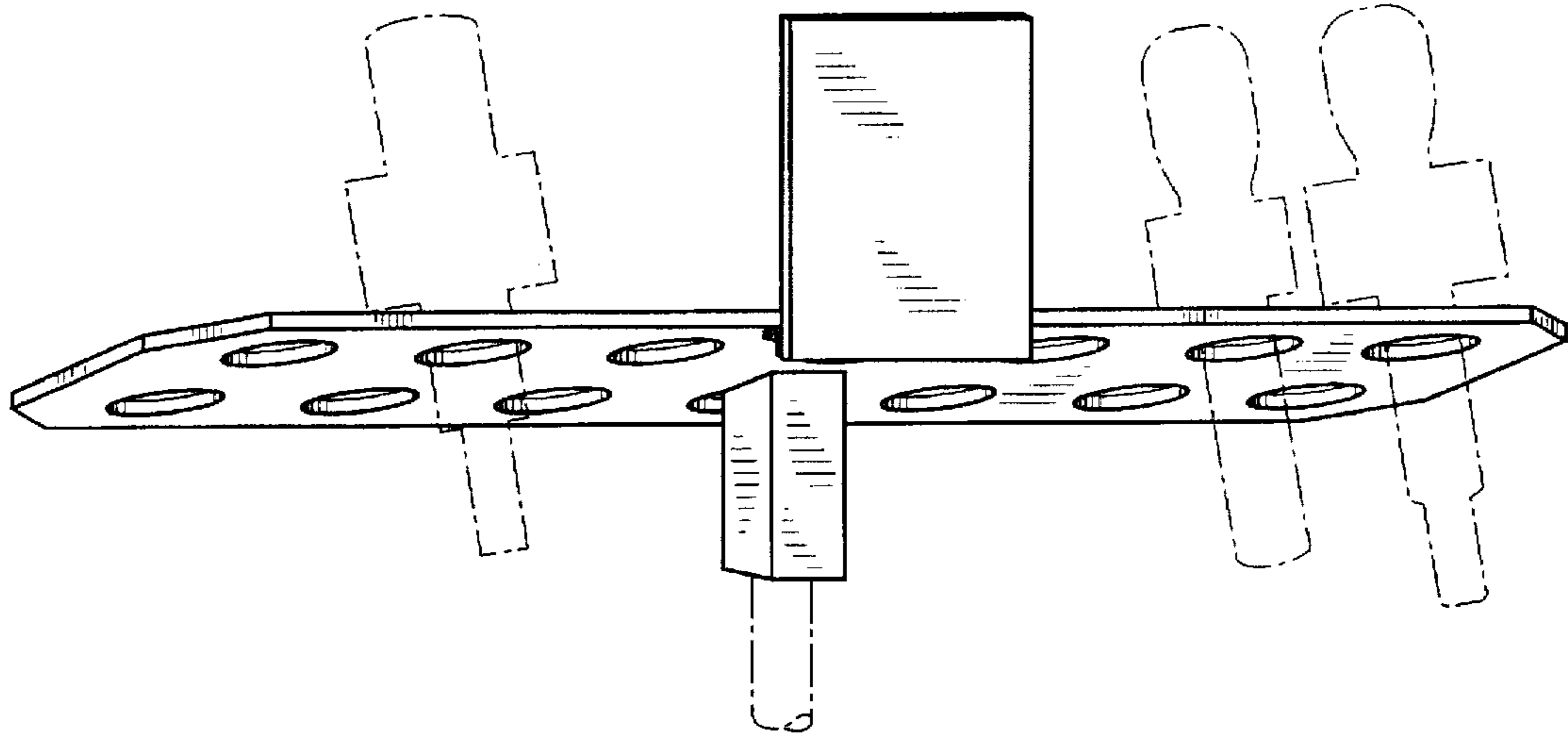

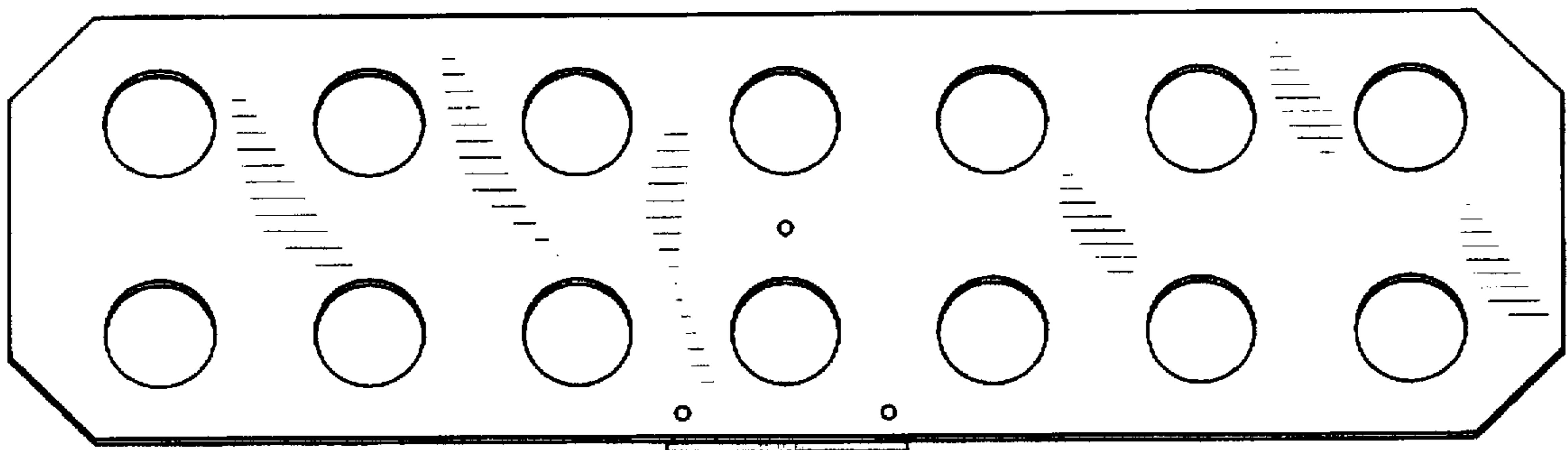

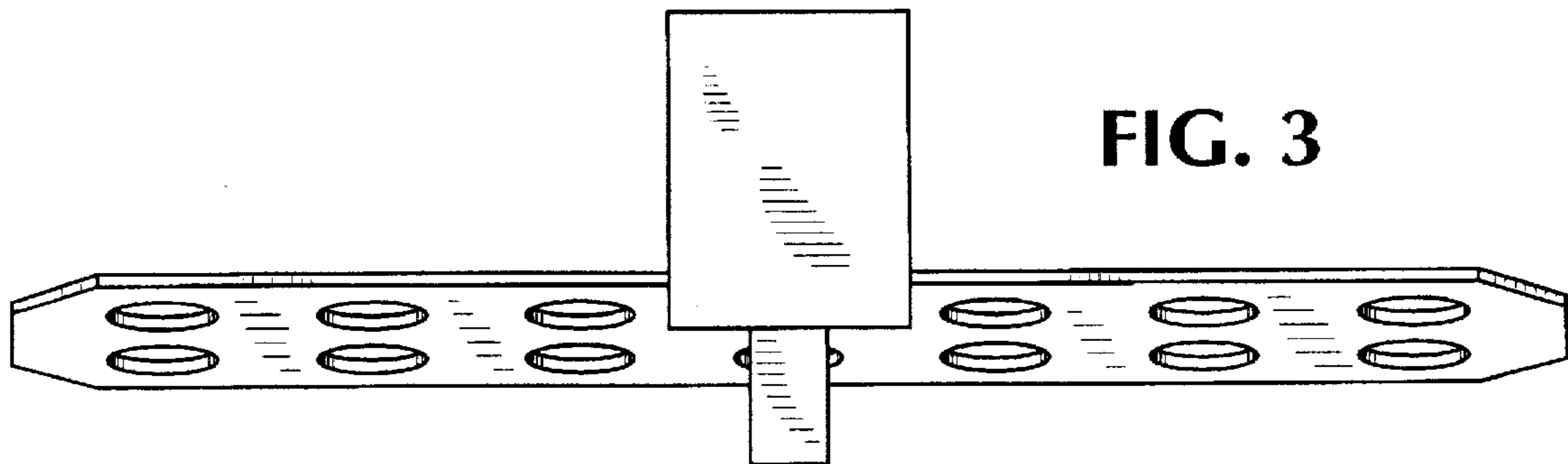

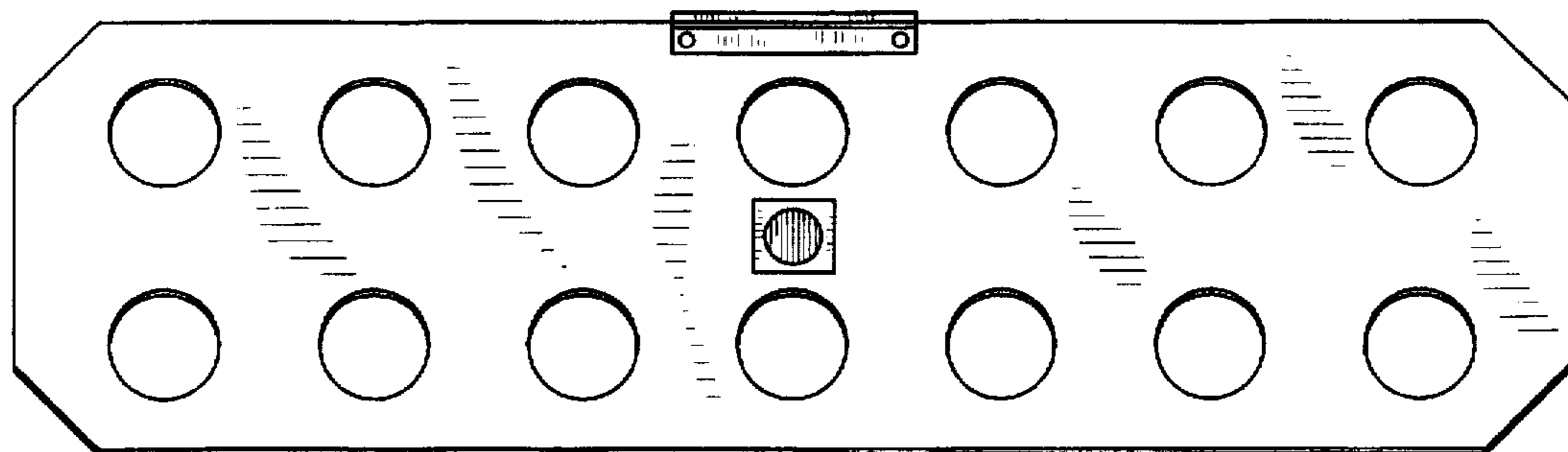

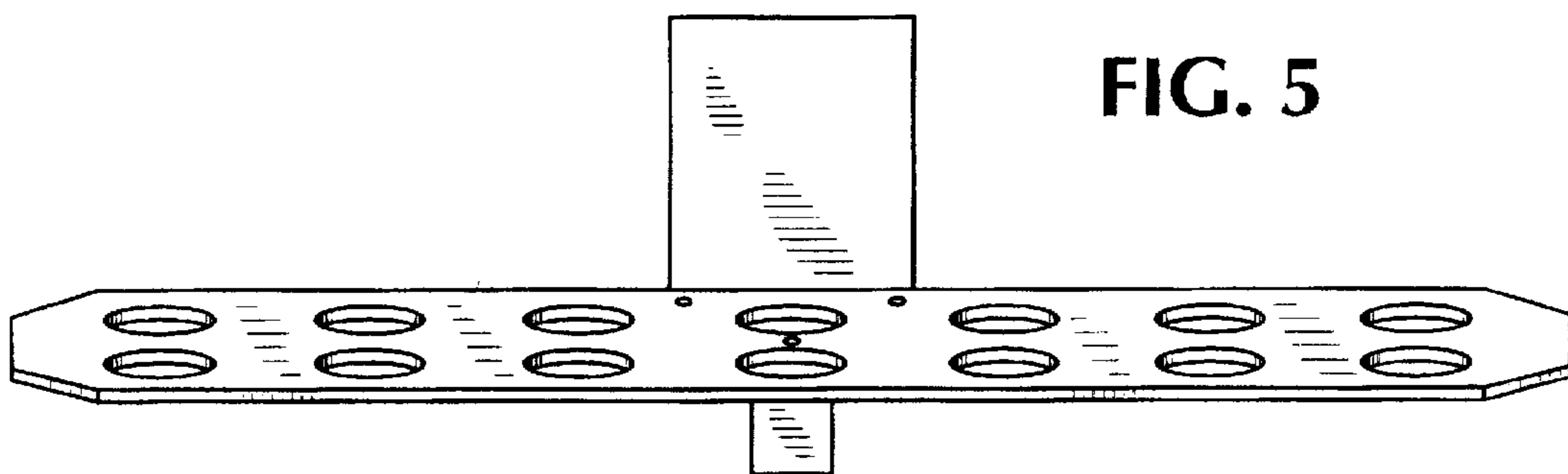
