FIG. 11 is a bottom plan view of FIG. 7; and,

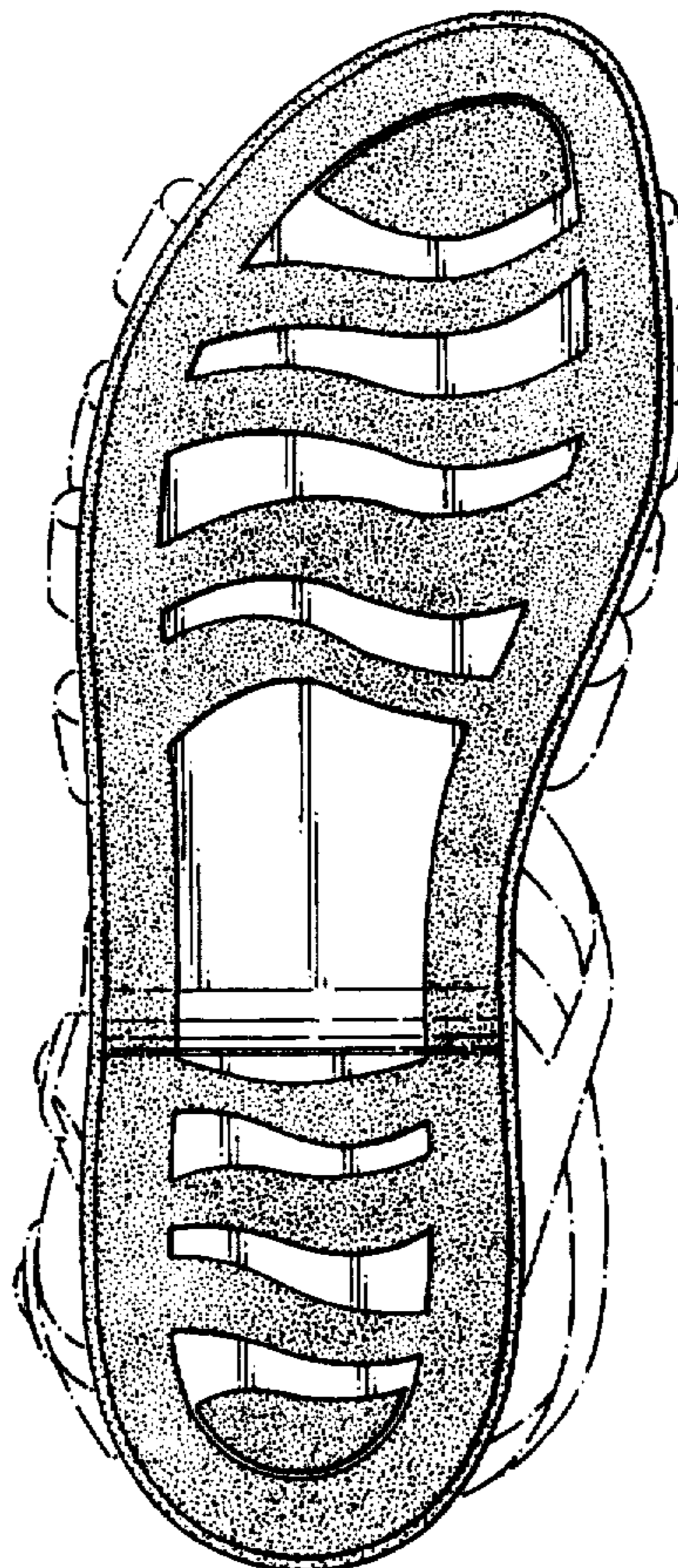
FIG. 12 is a left side elevational view of FIG. 7.

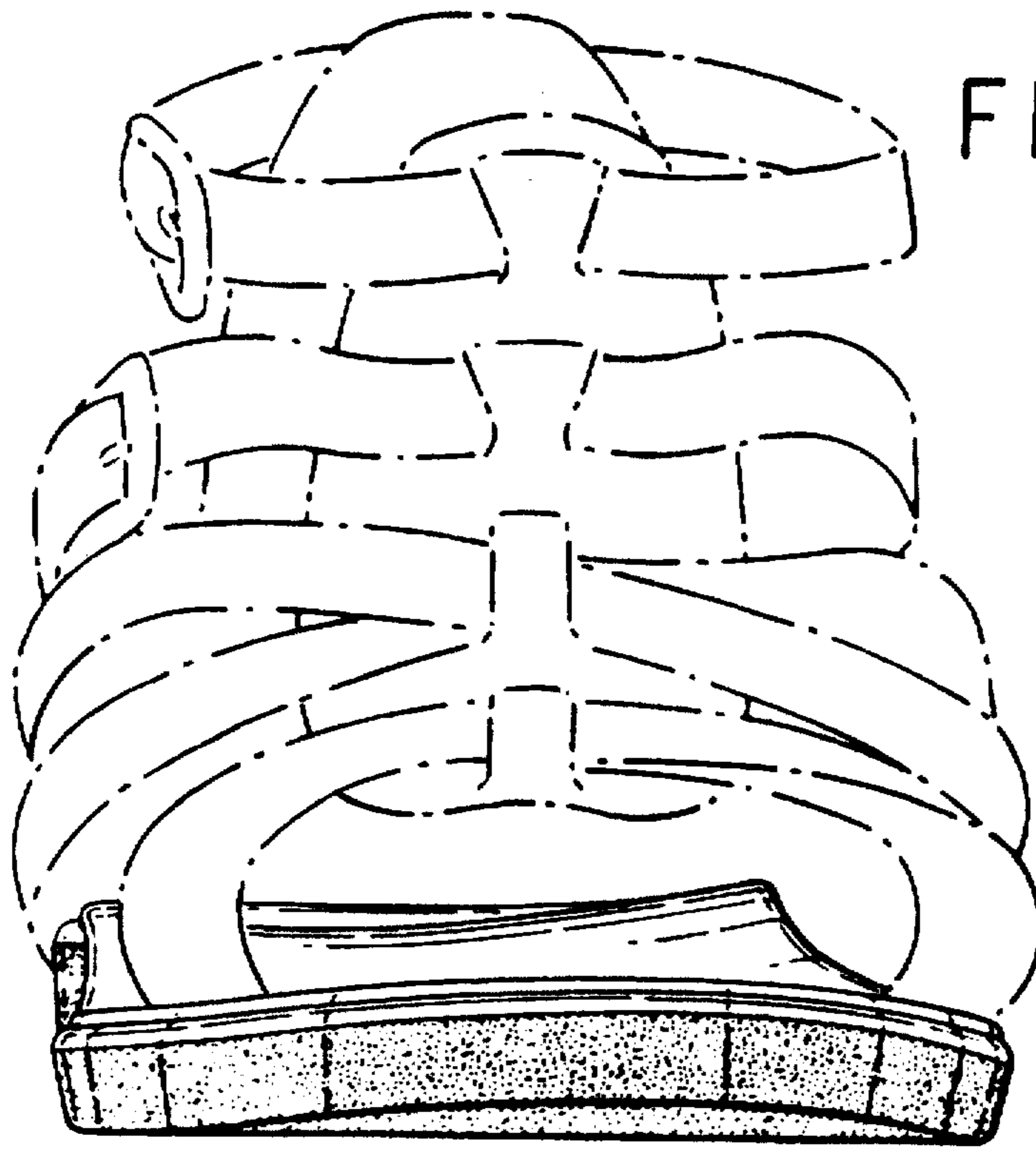

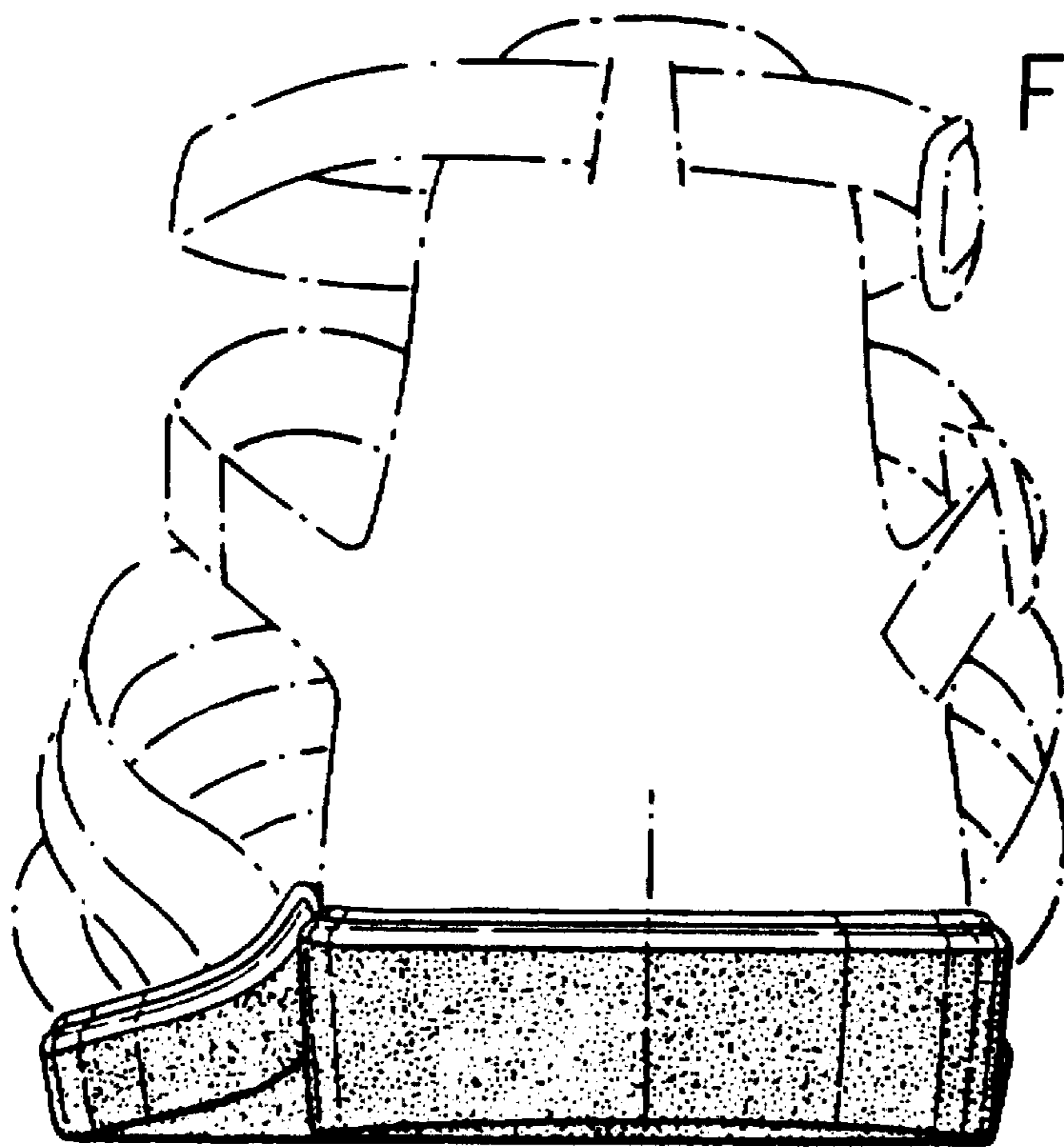

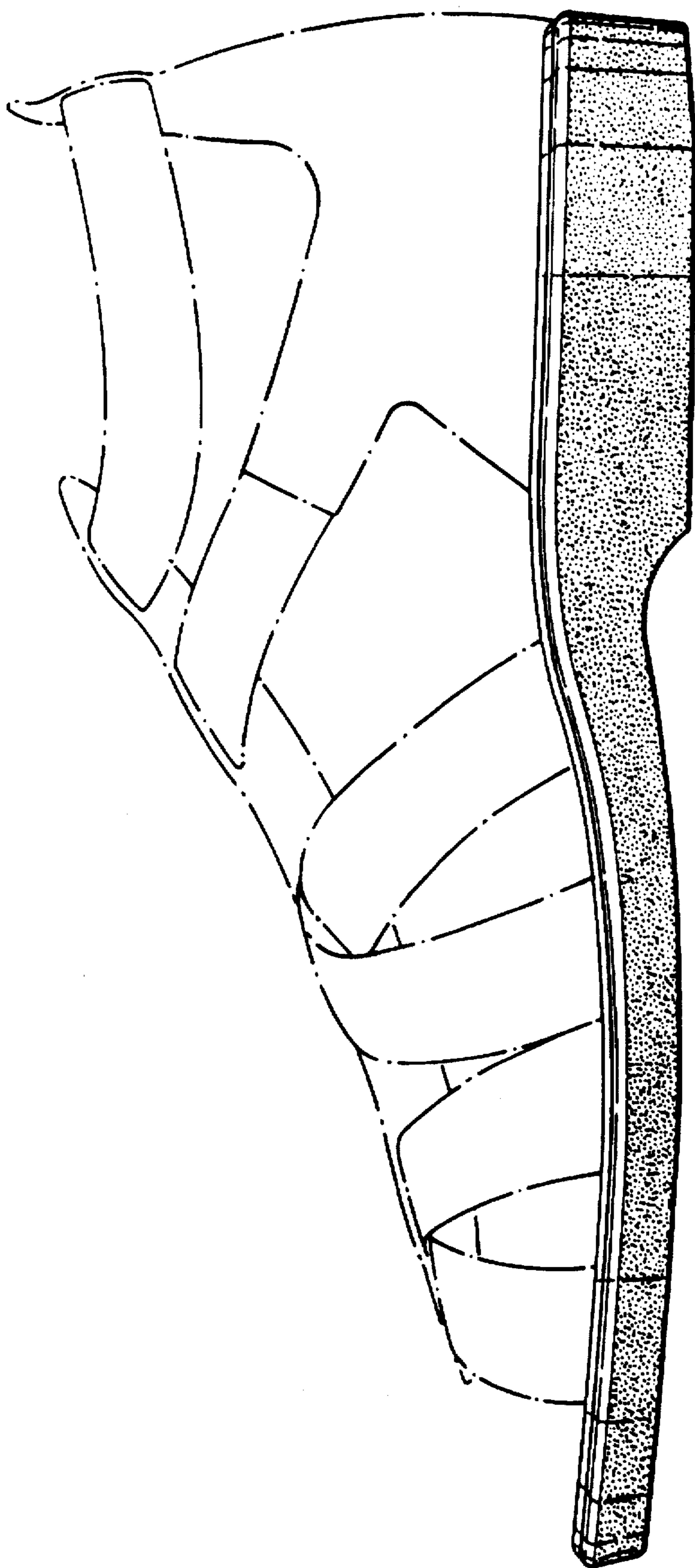

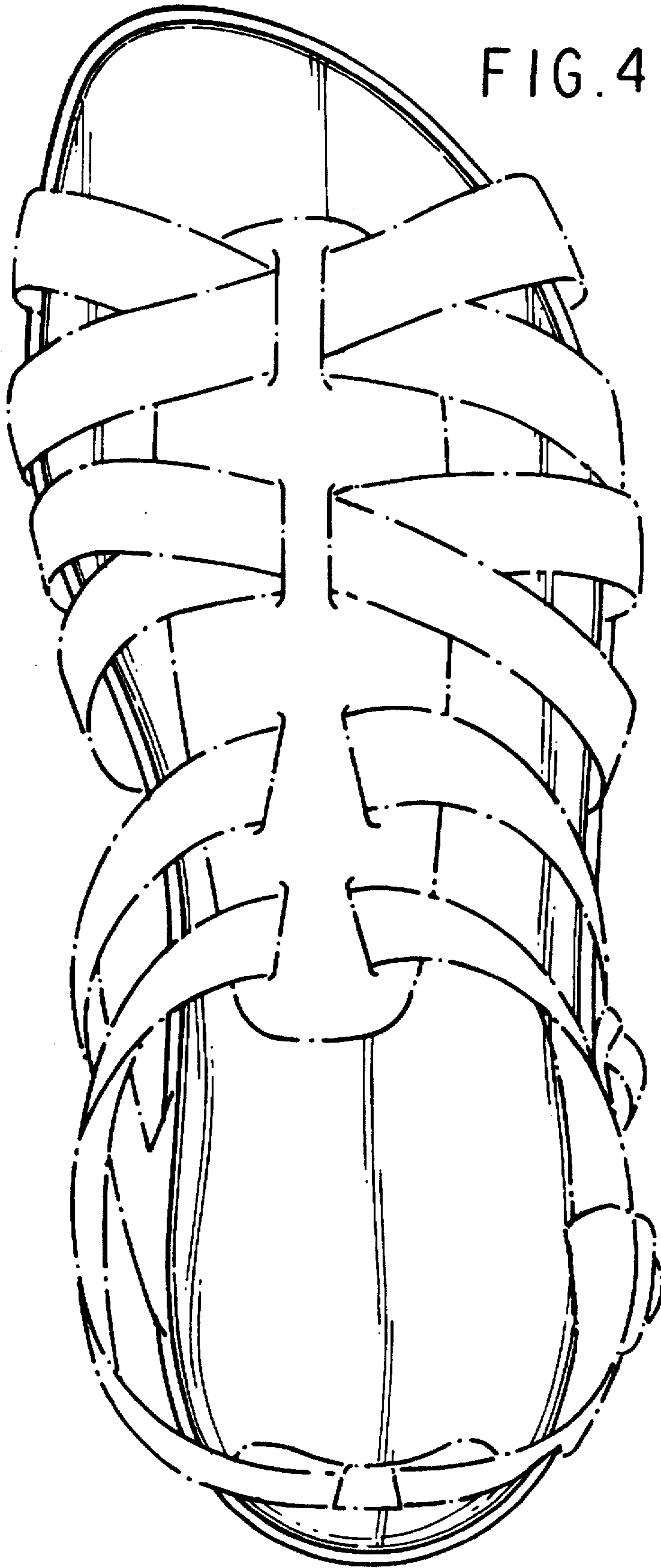
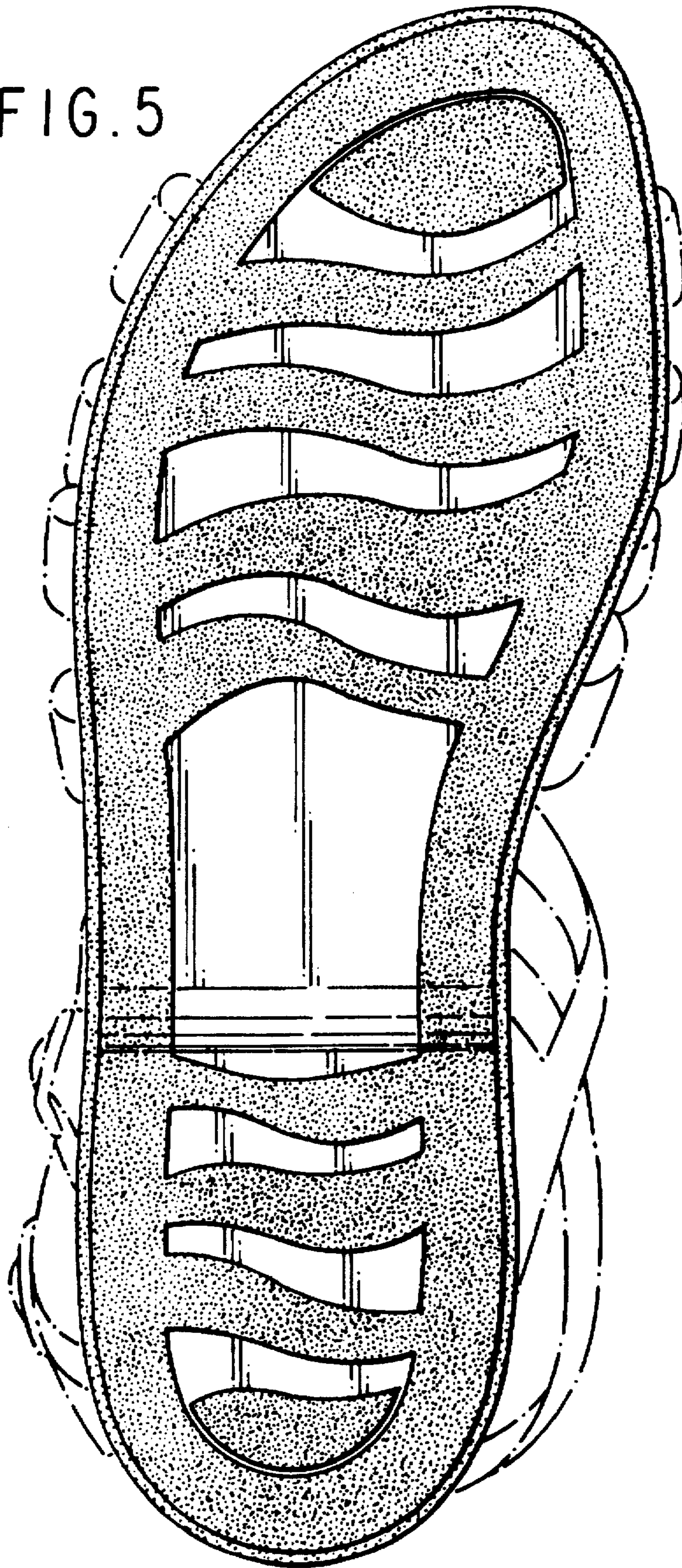

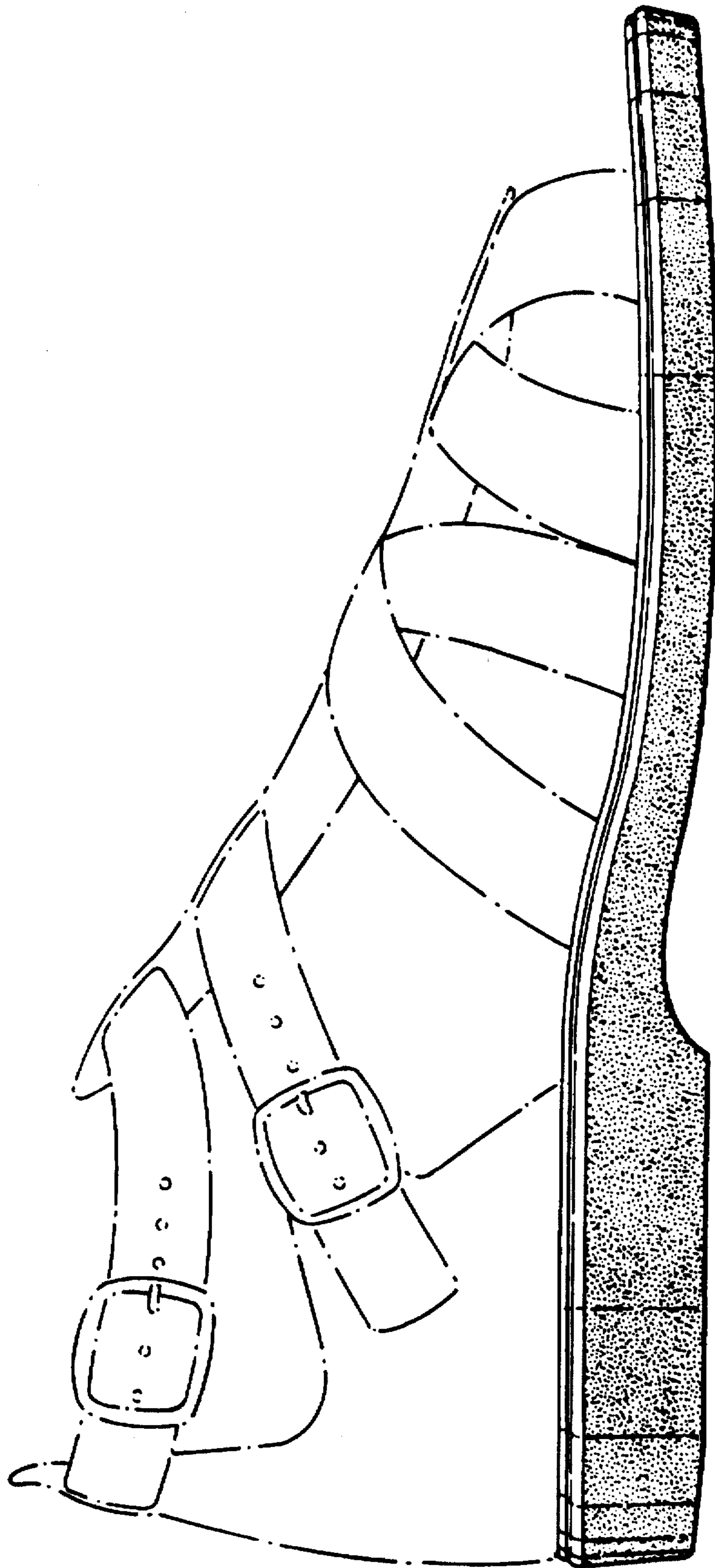

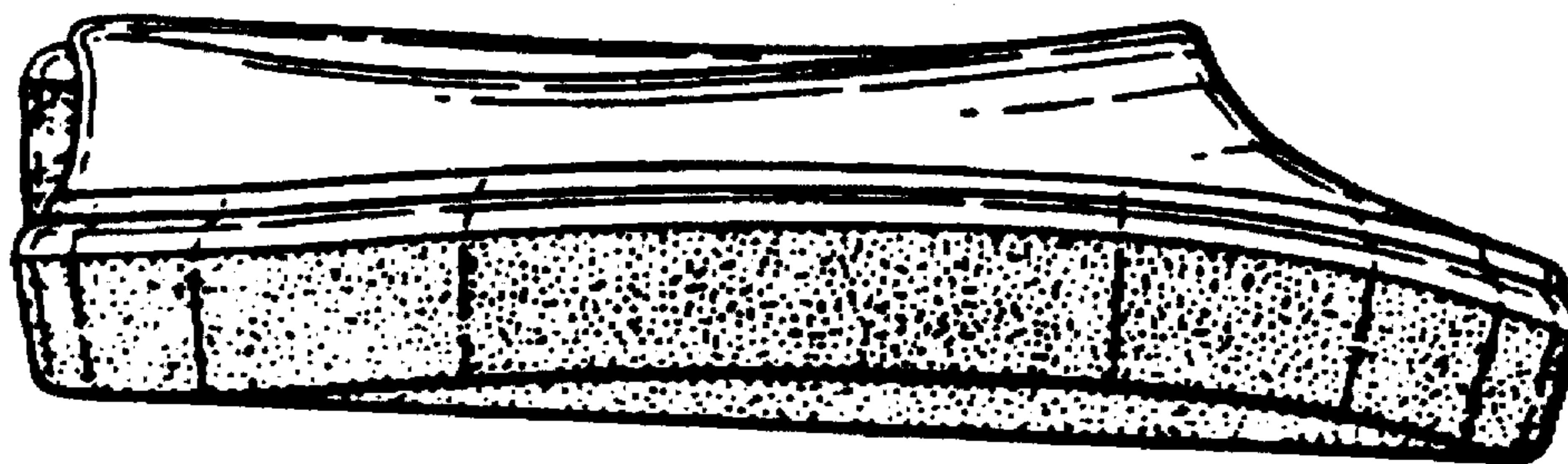

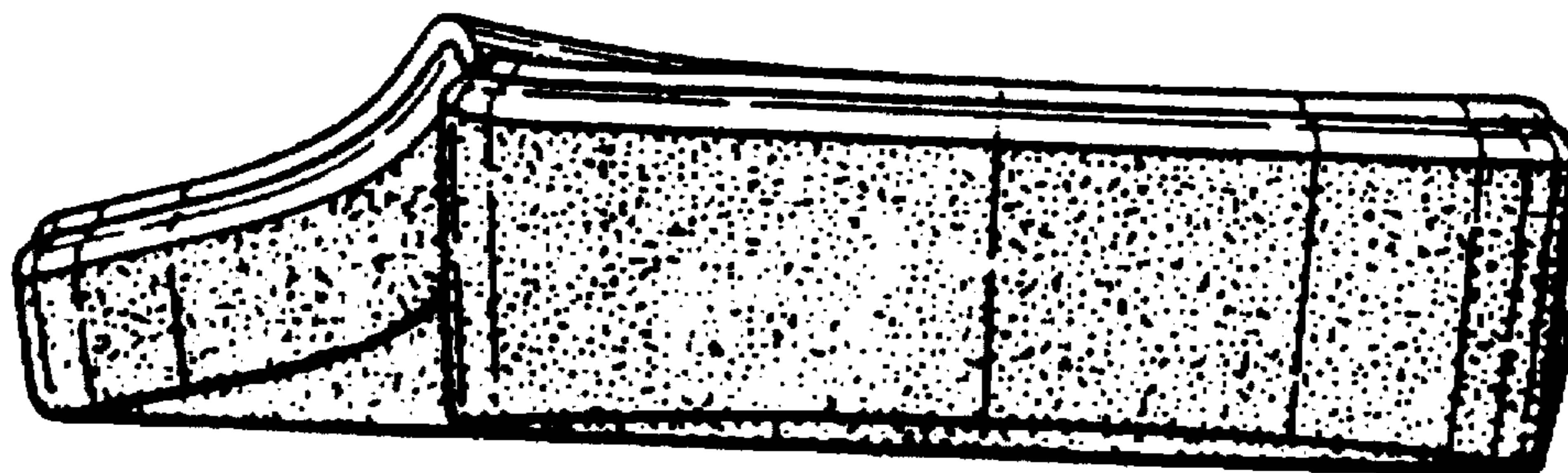

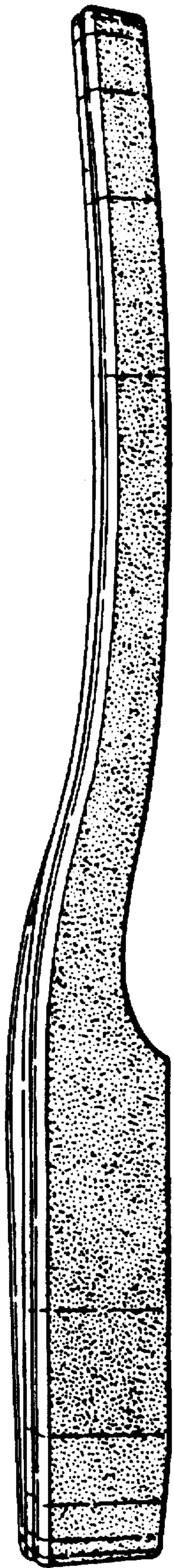

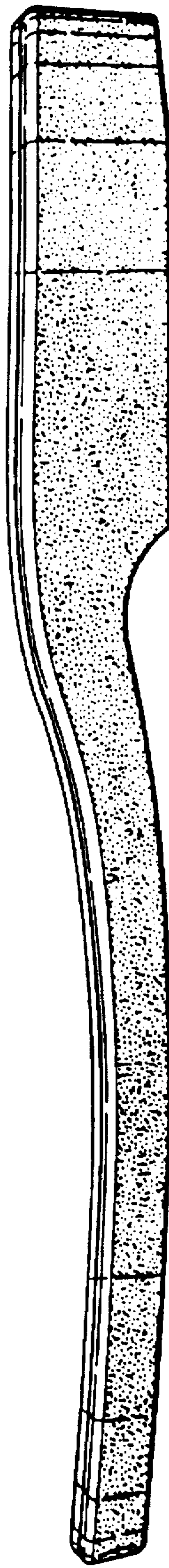

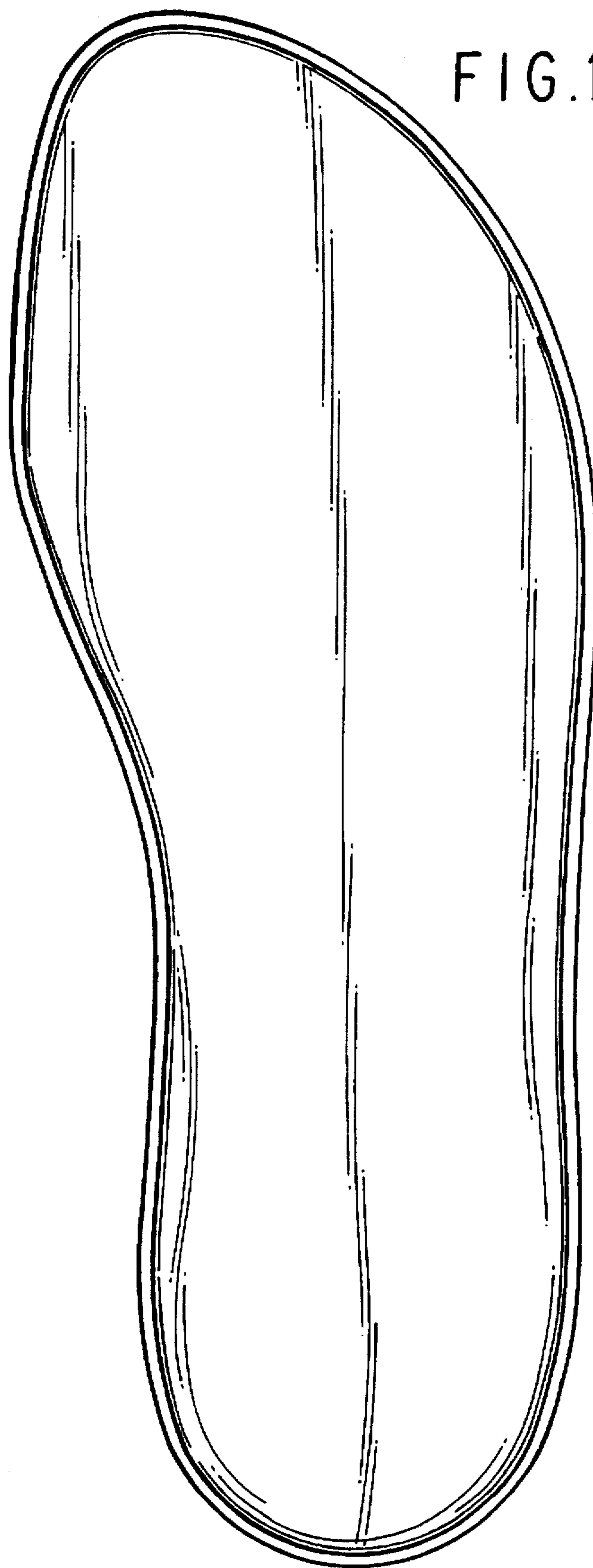
