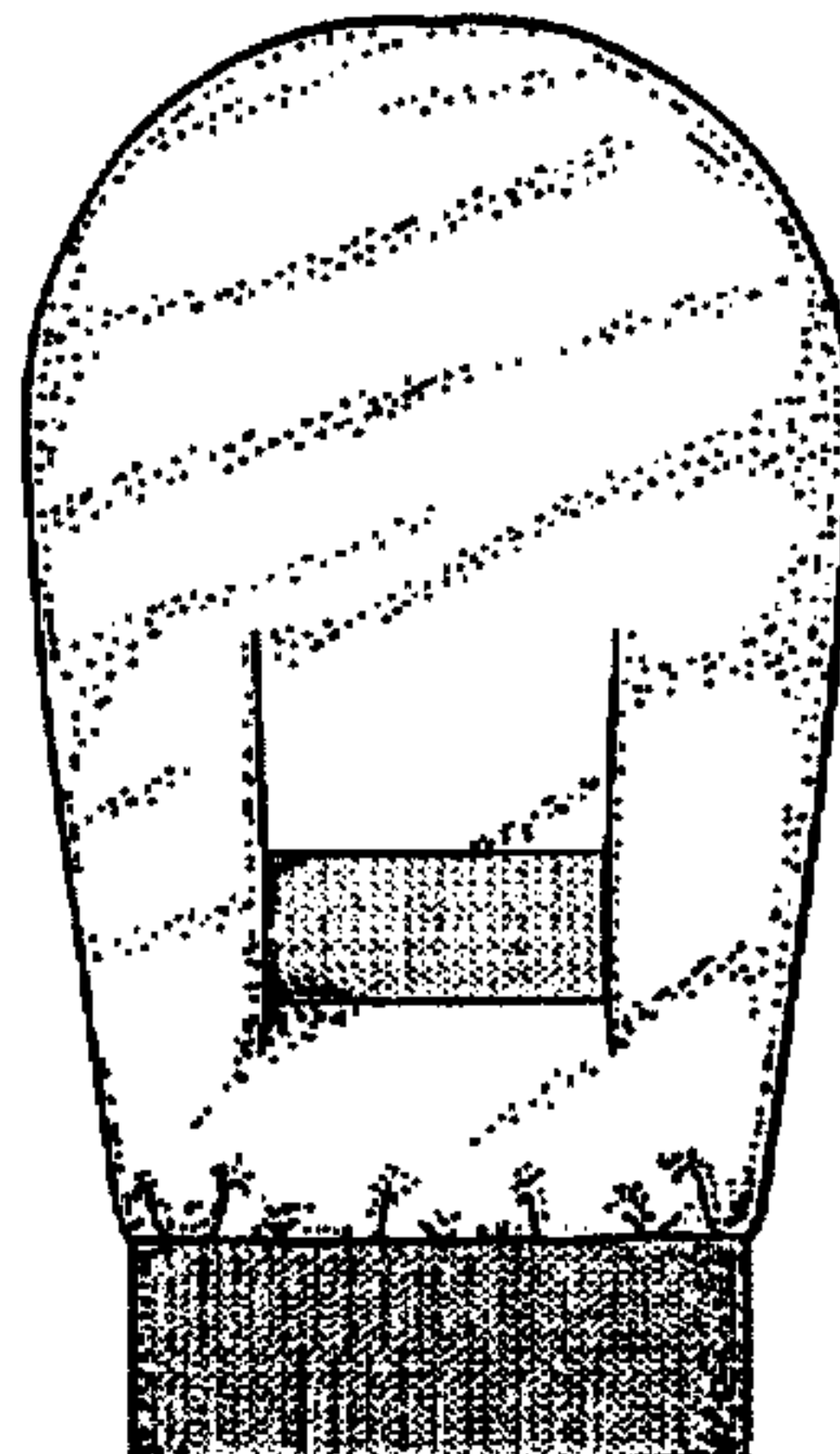
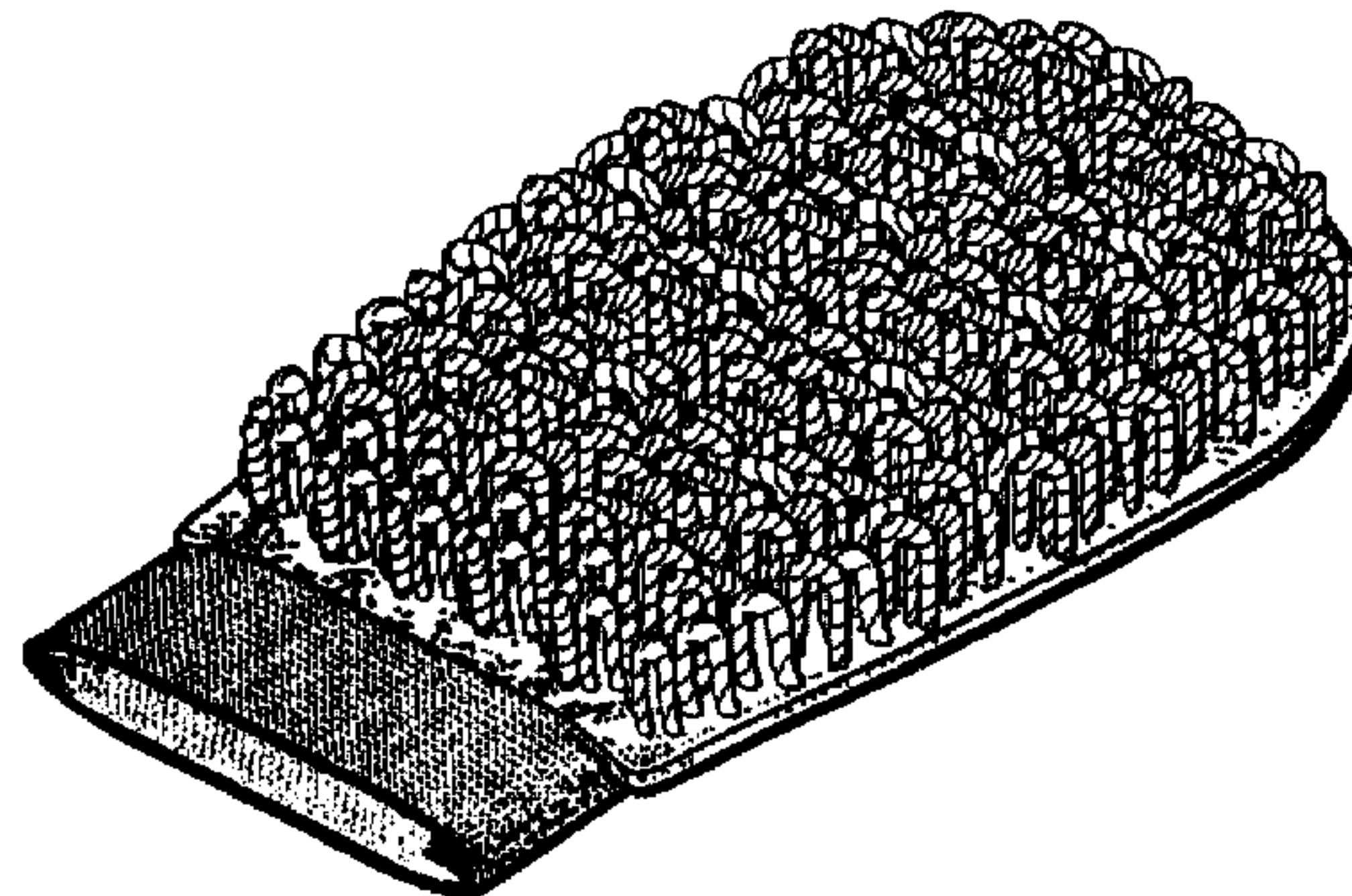
[57] CLAIM

The ornamental design for a mitt for applying paint, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mitt for applying paint, showing my new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;

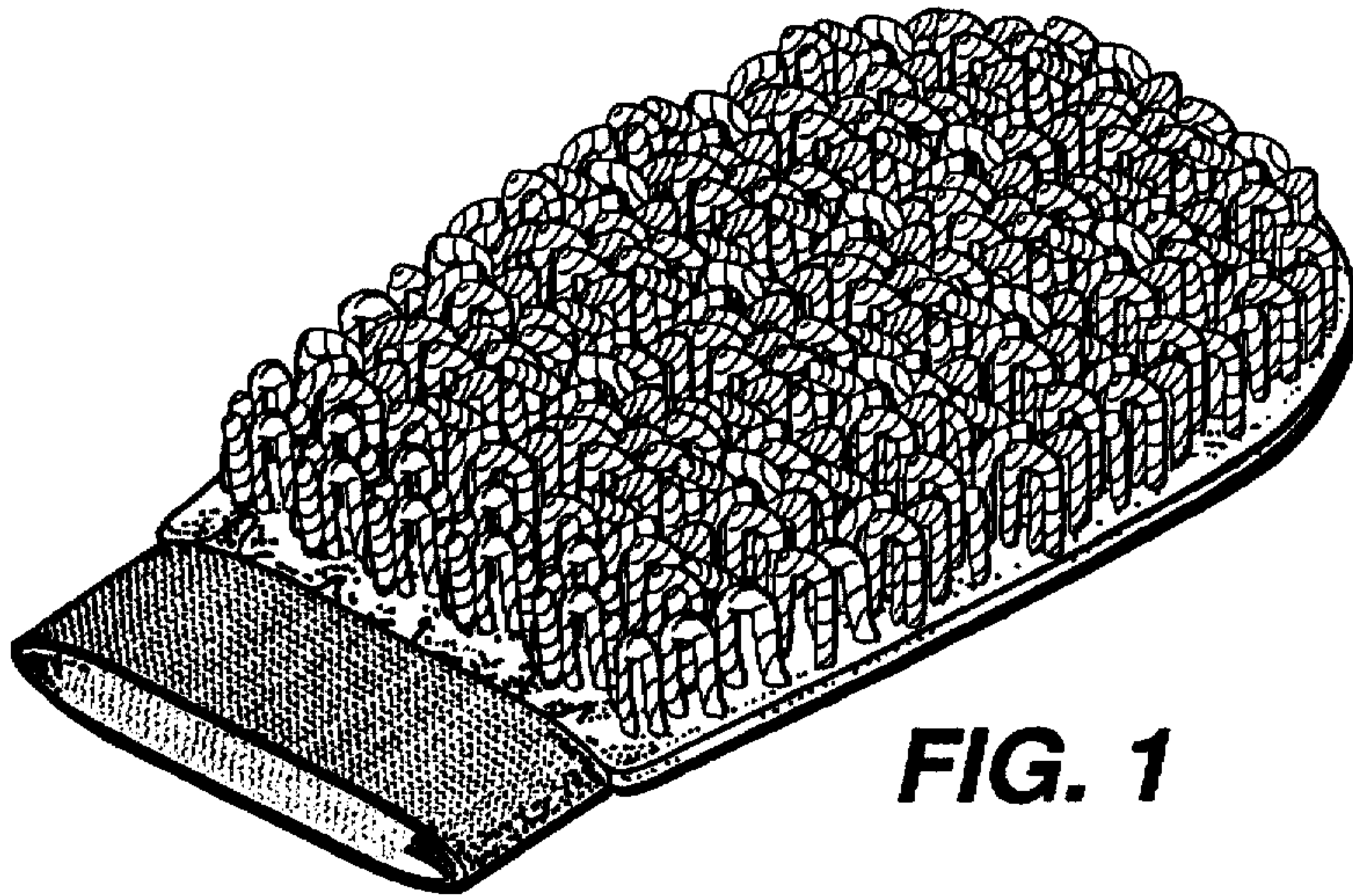

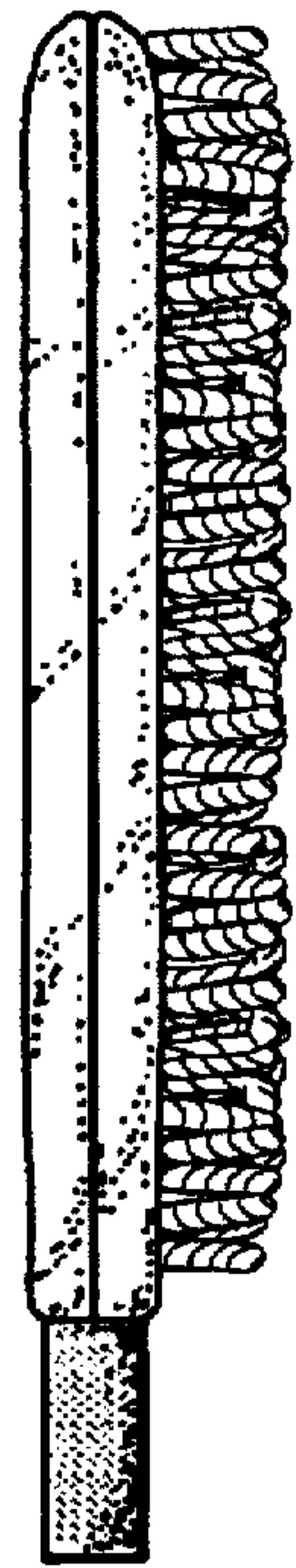

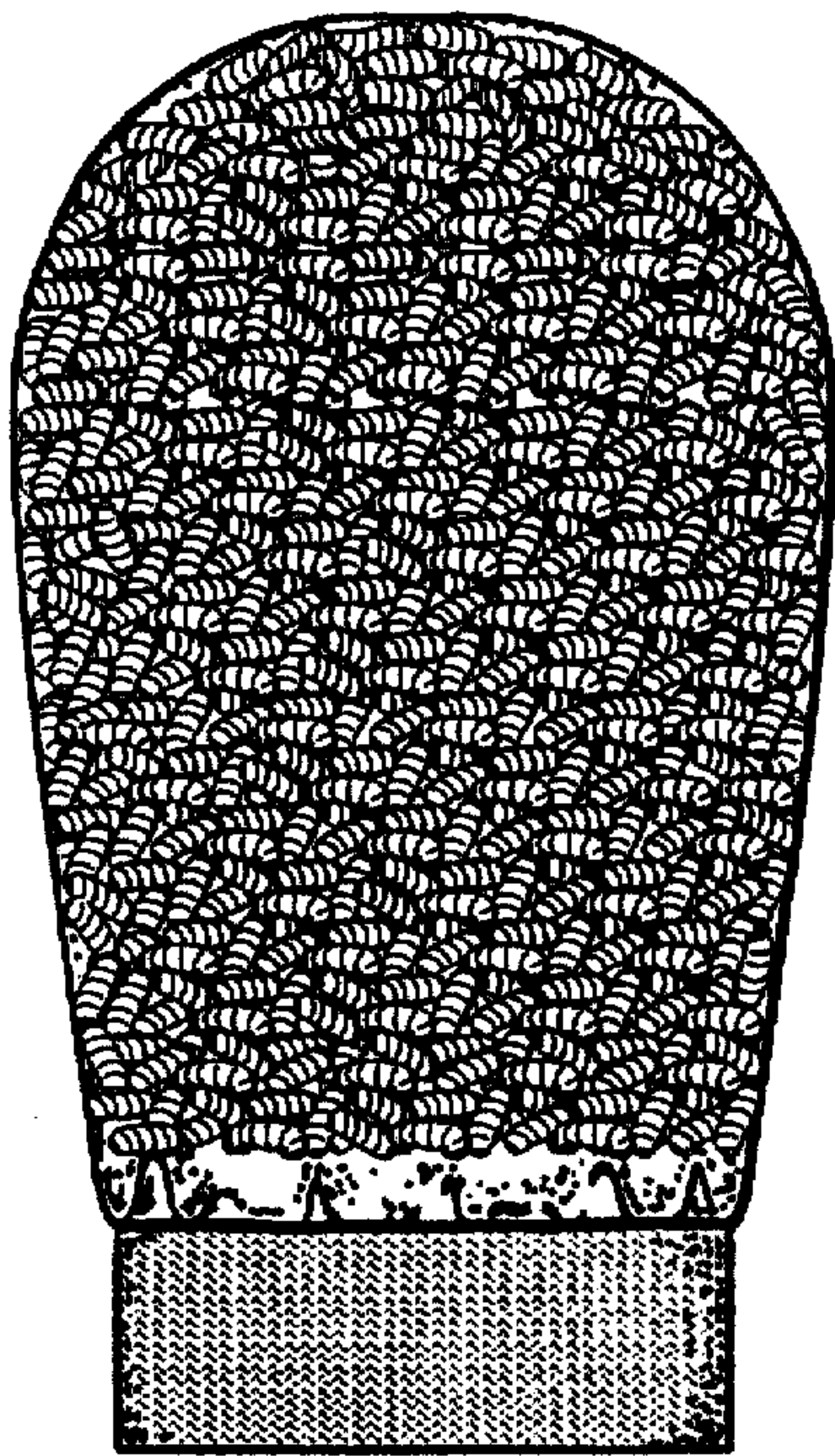

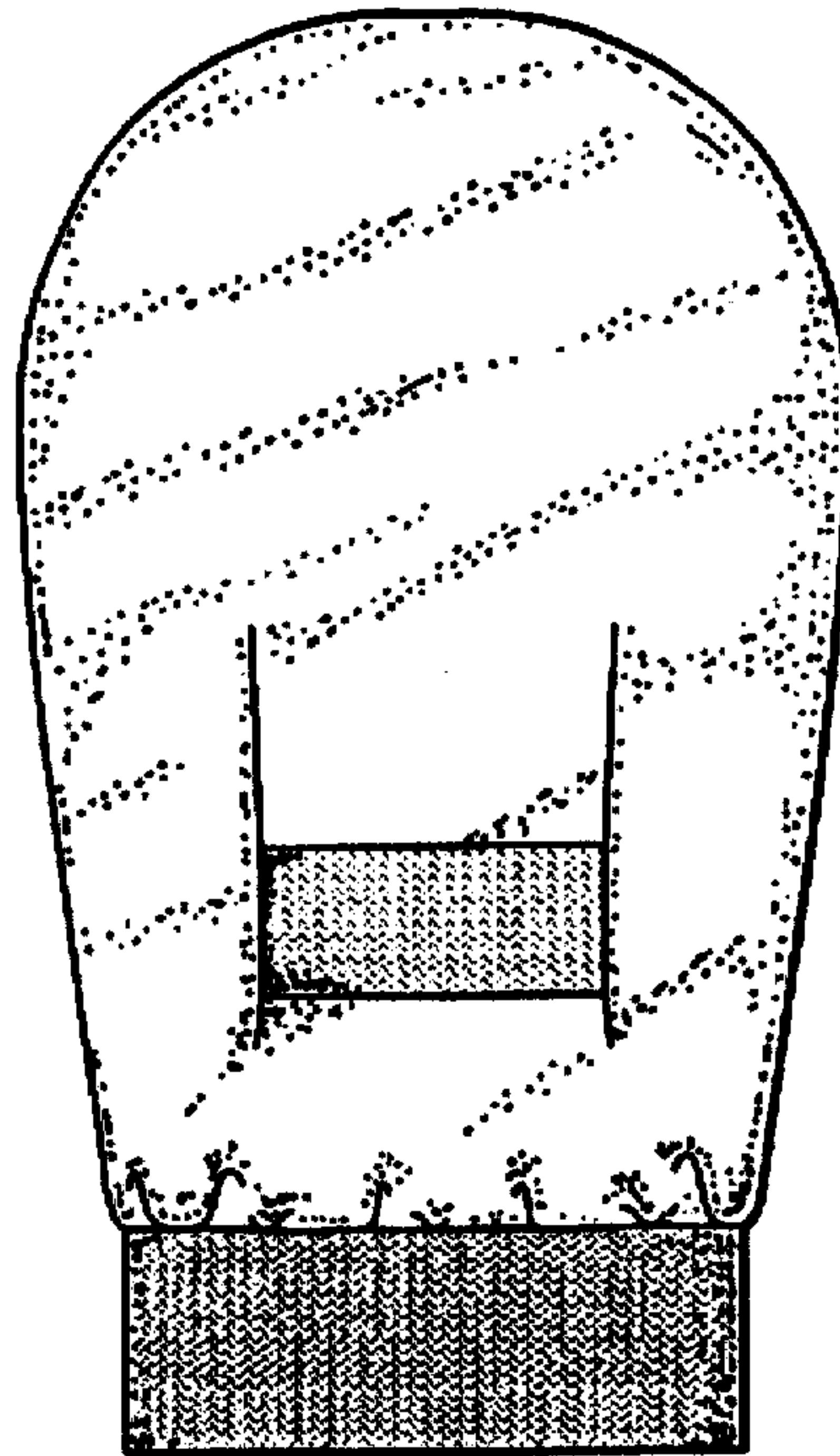

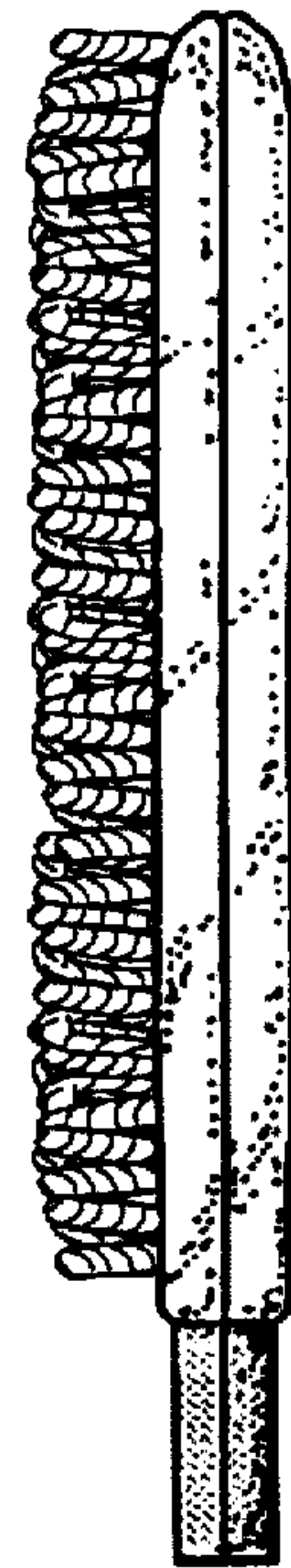

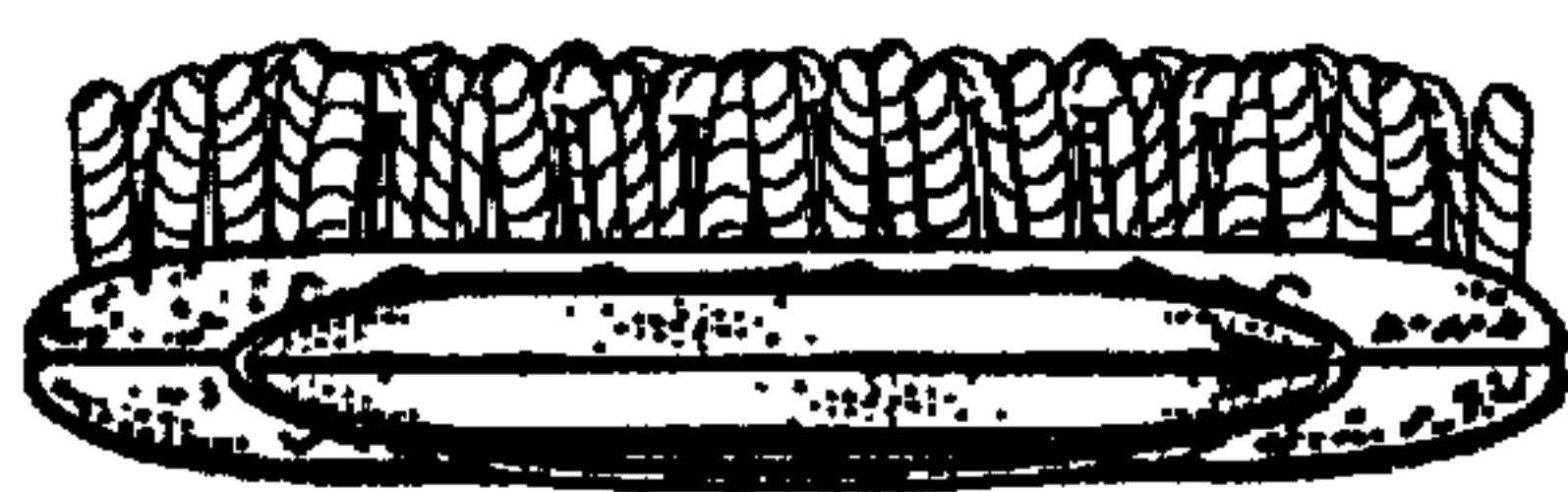

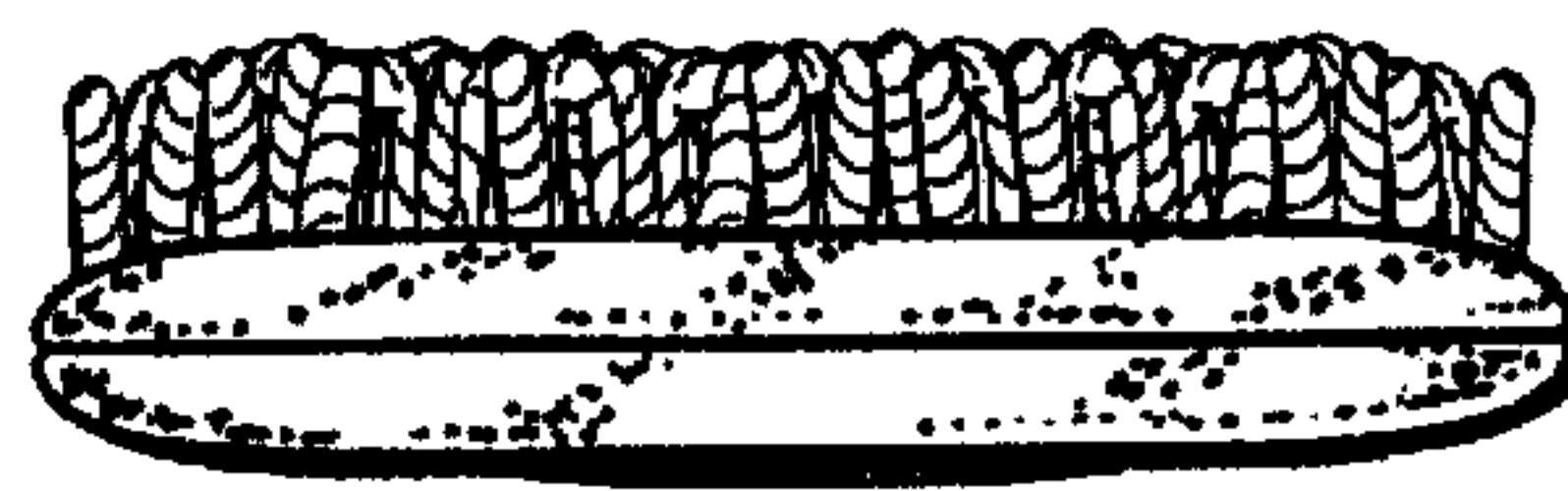
