### DESCRIPTION

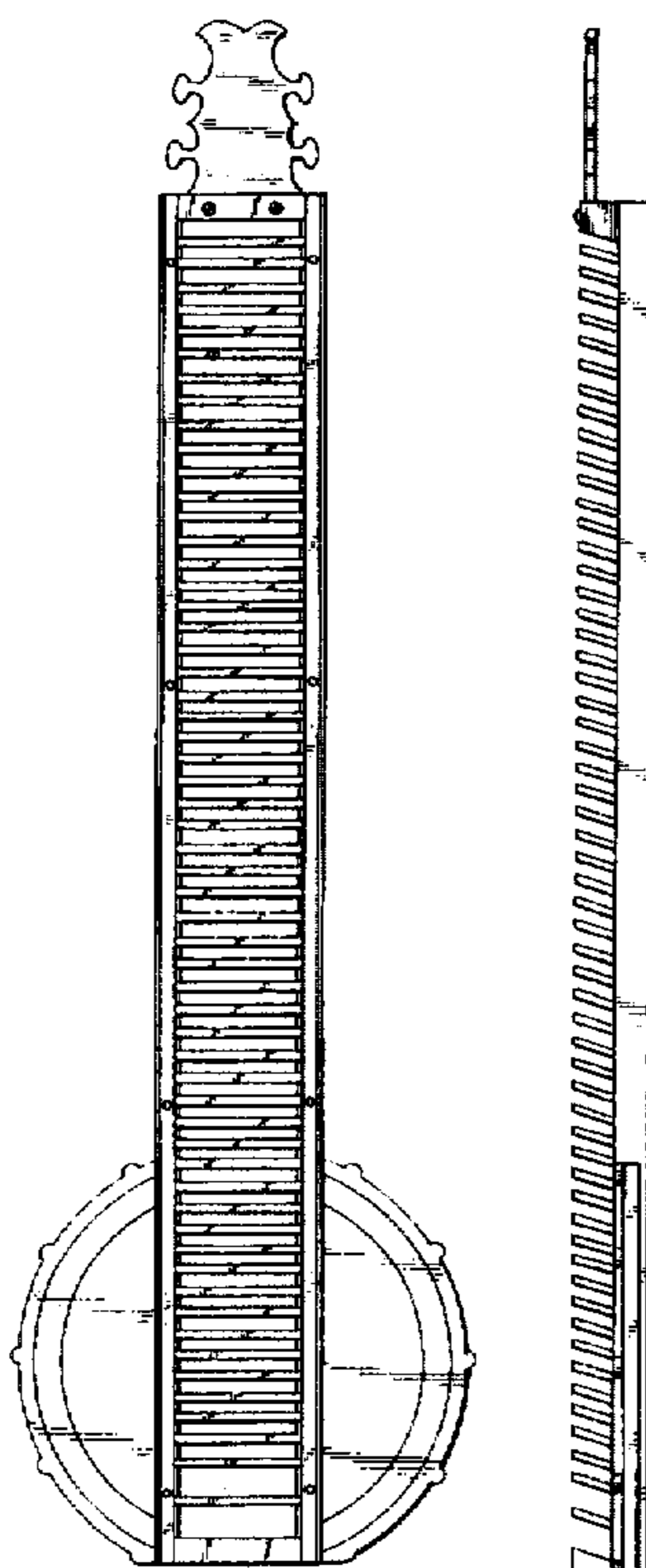

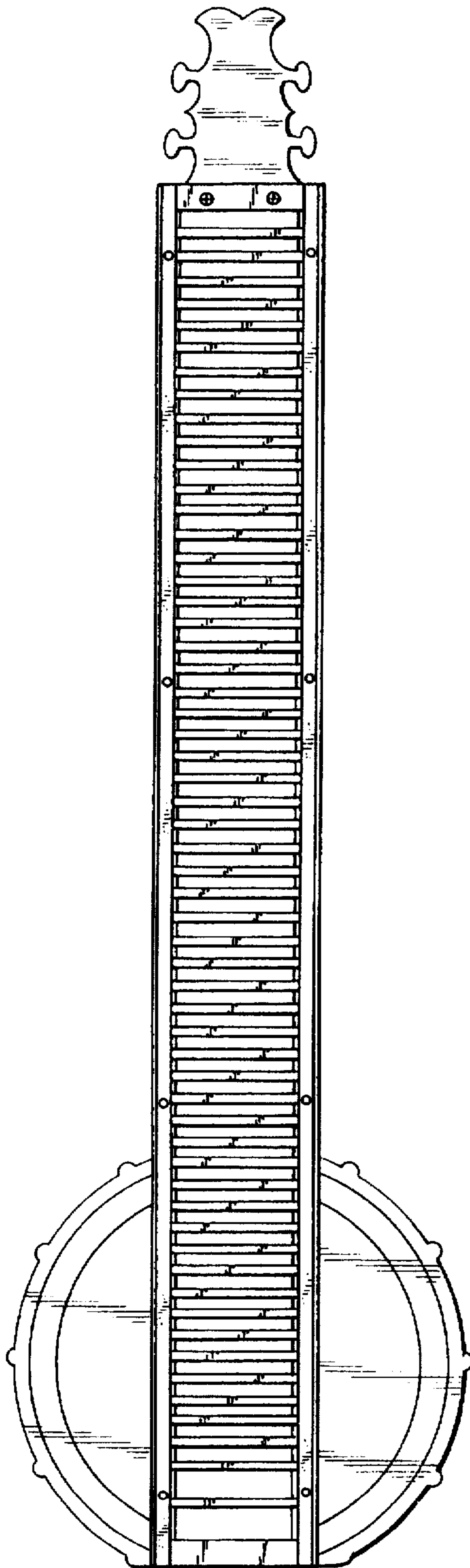

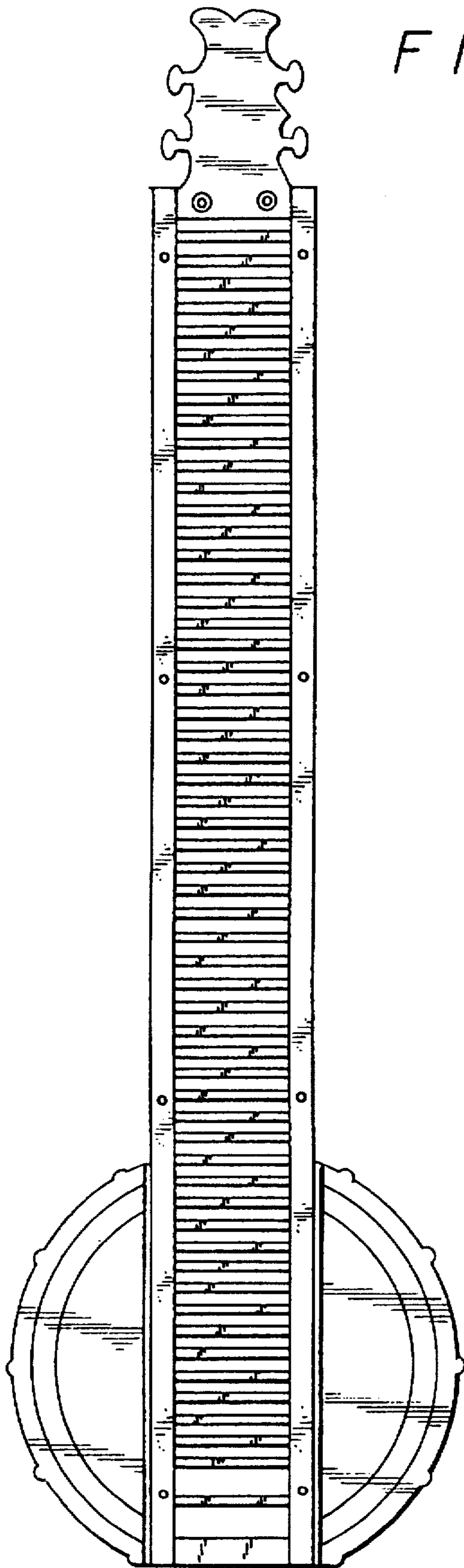

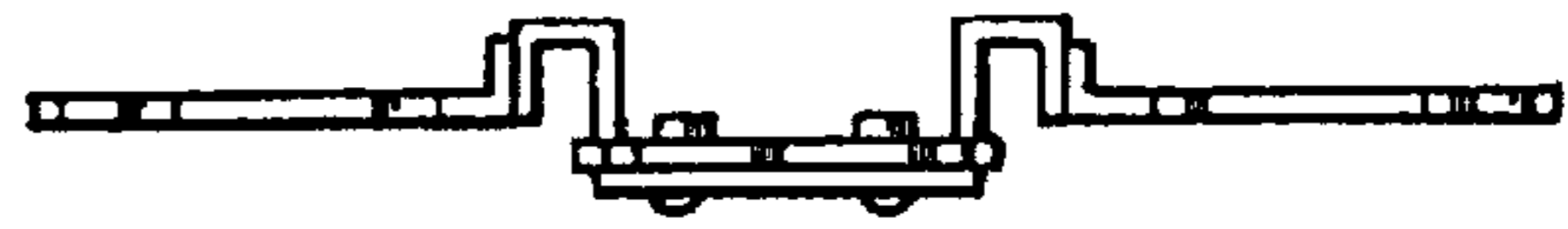

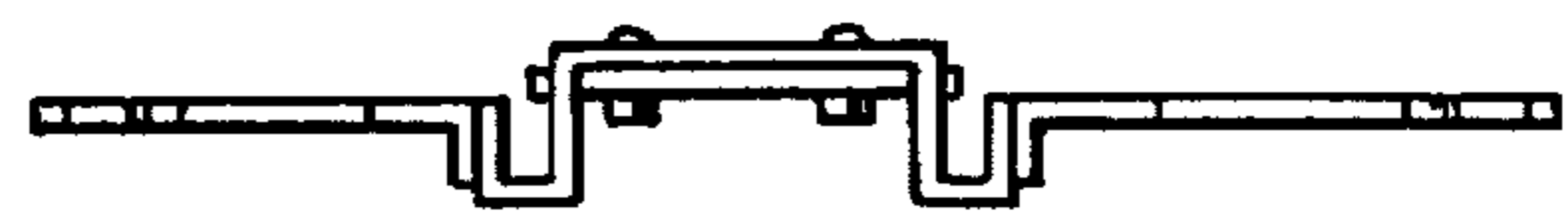
