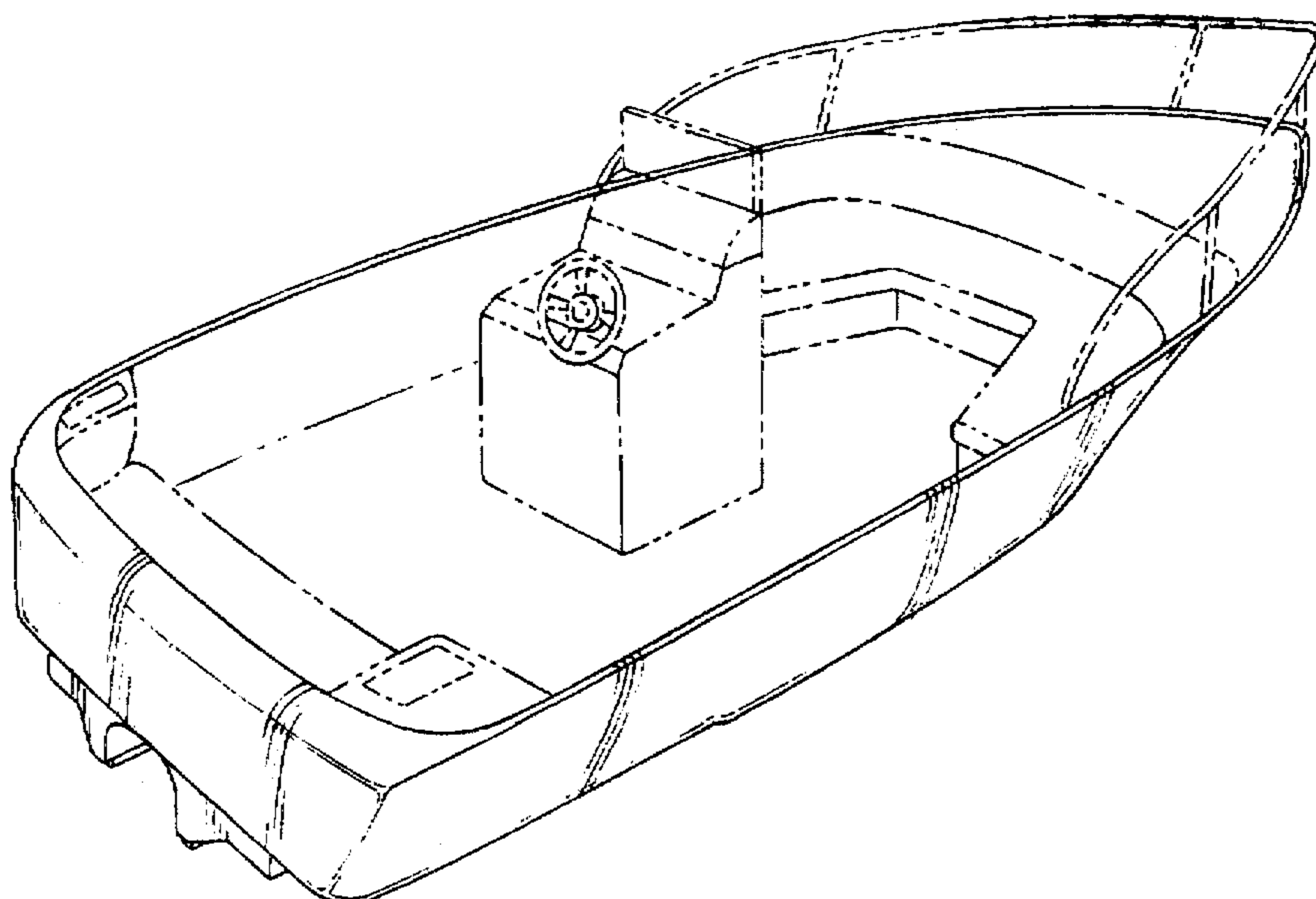
## [57] CLAIM

The ornamental design for a boat hull, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a boat hull showing my new design;  
 FIG. 2 is a side view thereof, the opposite side being a mirror image of the side shown;  
 FIG. 3 is a top view thereof;  
 FIG. 4 is a bottom view thereof;  
 FIG. 5 is a front view thereof;  
 FIG. 6 is a rear view thereof;  
 FIG. 7 is a cross-sectional view taken along lines 7—7 of FIG. 2;  
 FIG. 8 is a cross-sectional view taken along lines 8—8 of FIG. 2; and,  
 FIG. 9 is a cross-sectional view taken along lines 9—9 of FIG. 2.  
 The broken lines shown in FIGS. 1 through 6 are for illustrative purposes only and form no part of the claimed design.

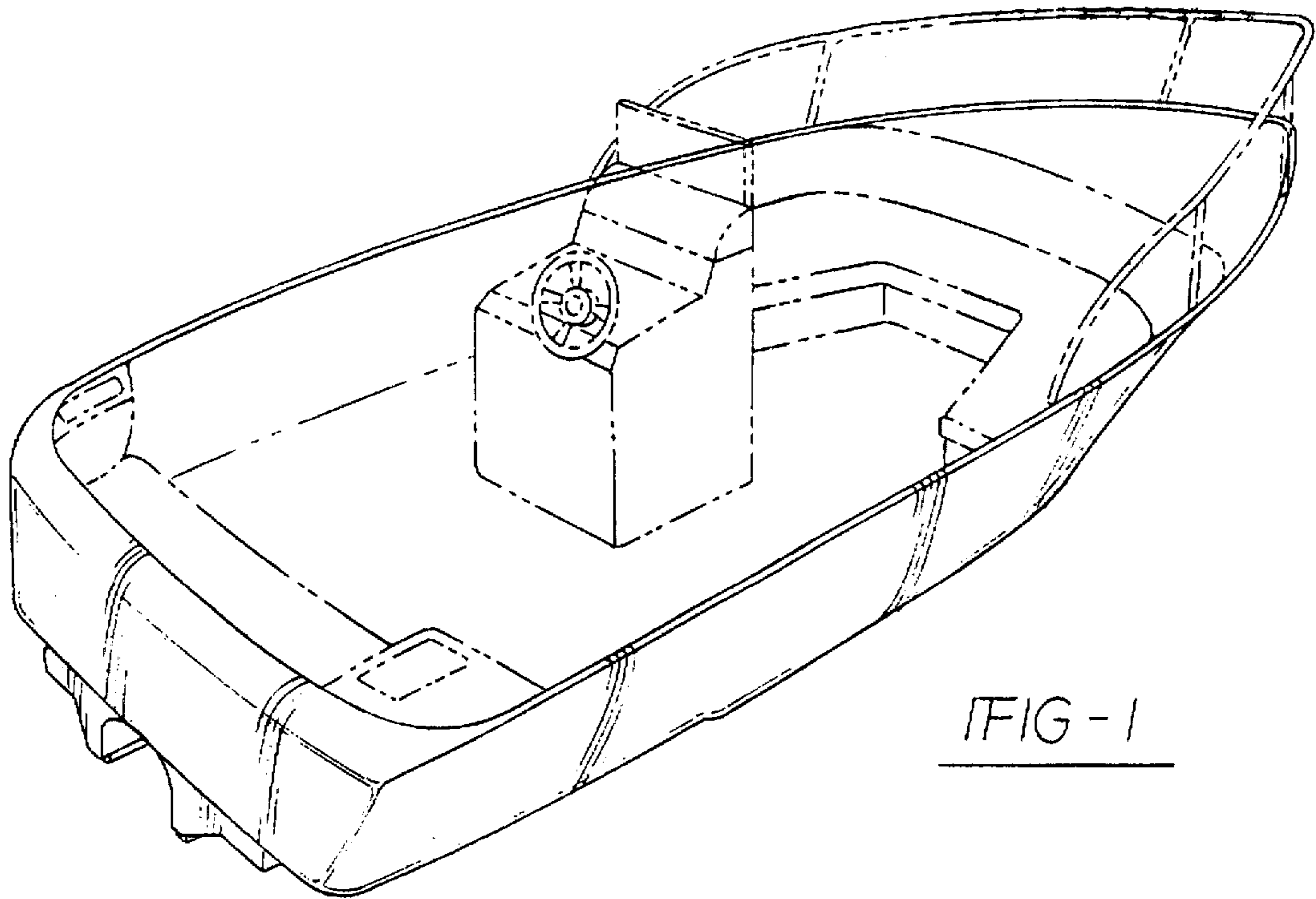

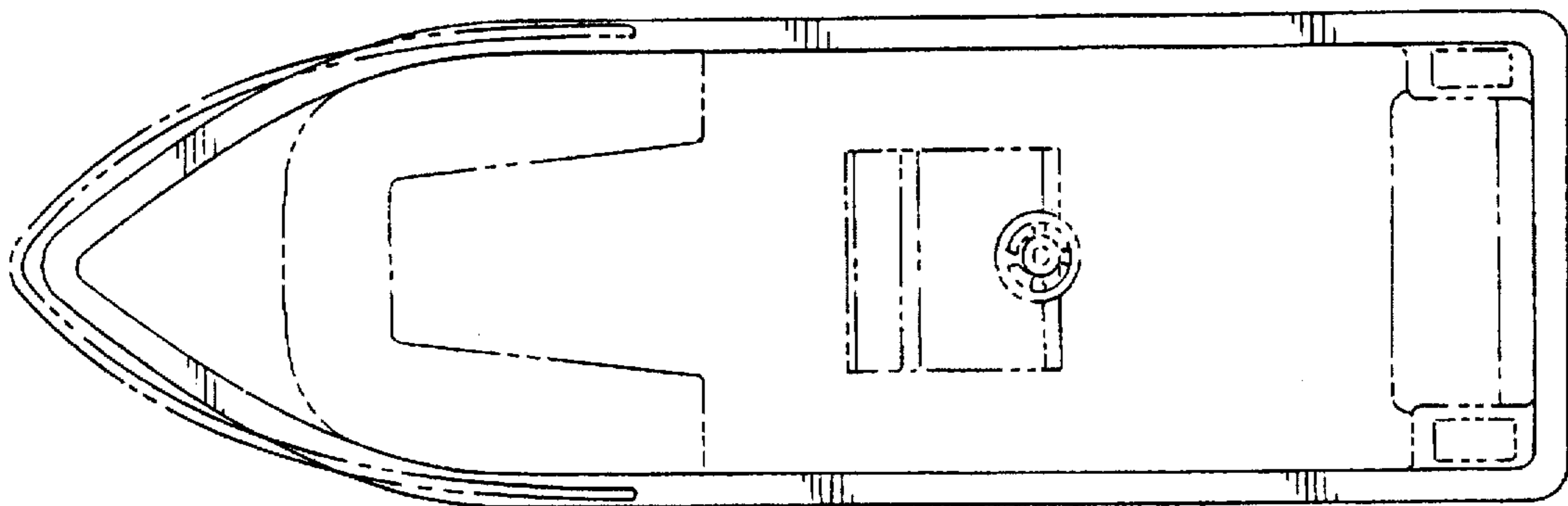
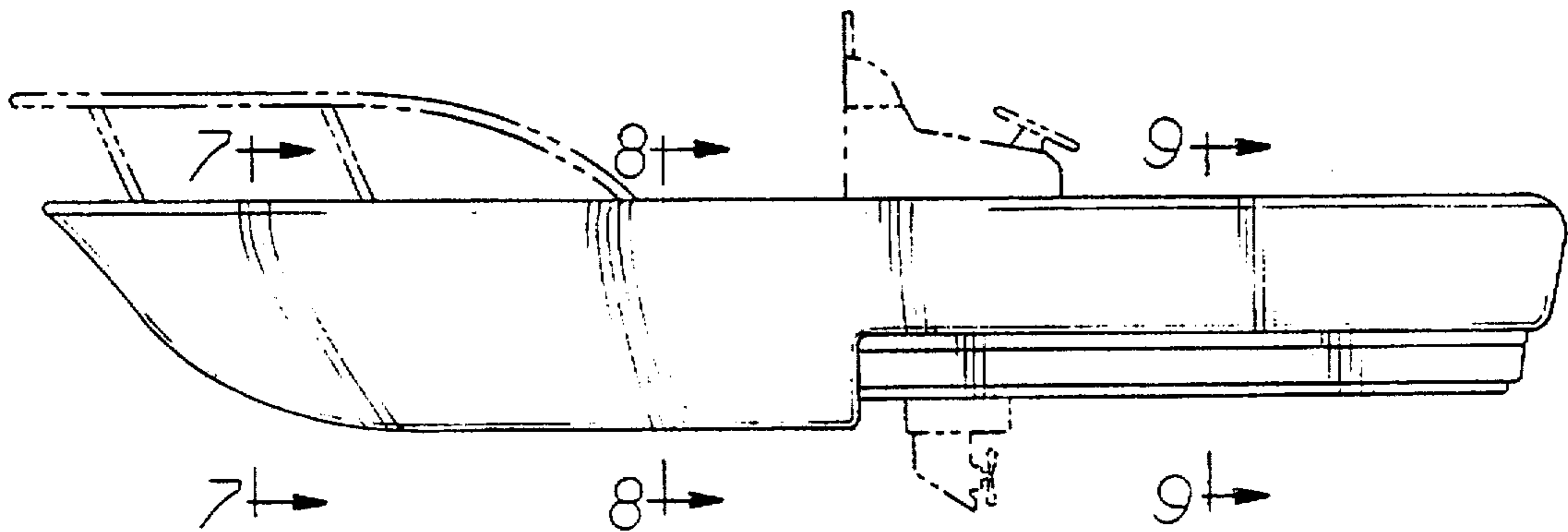

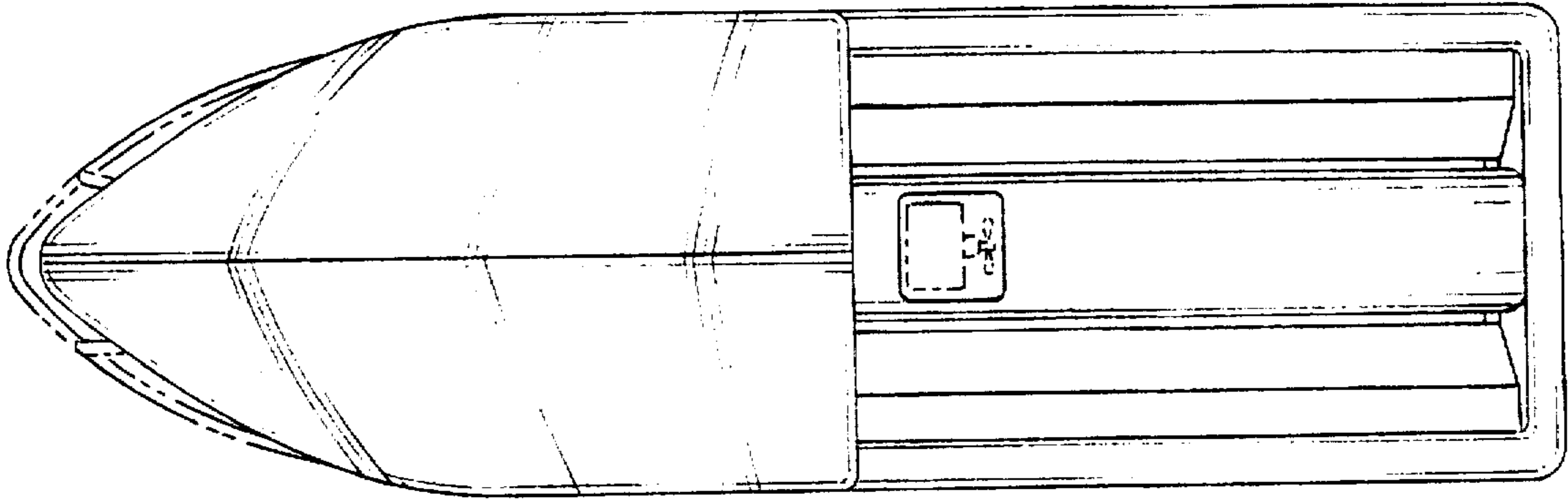

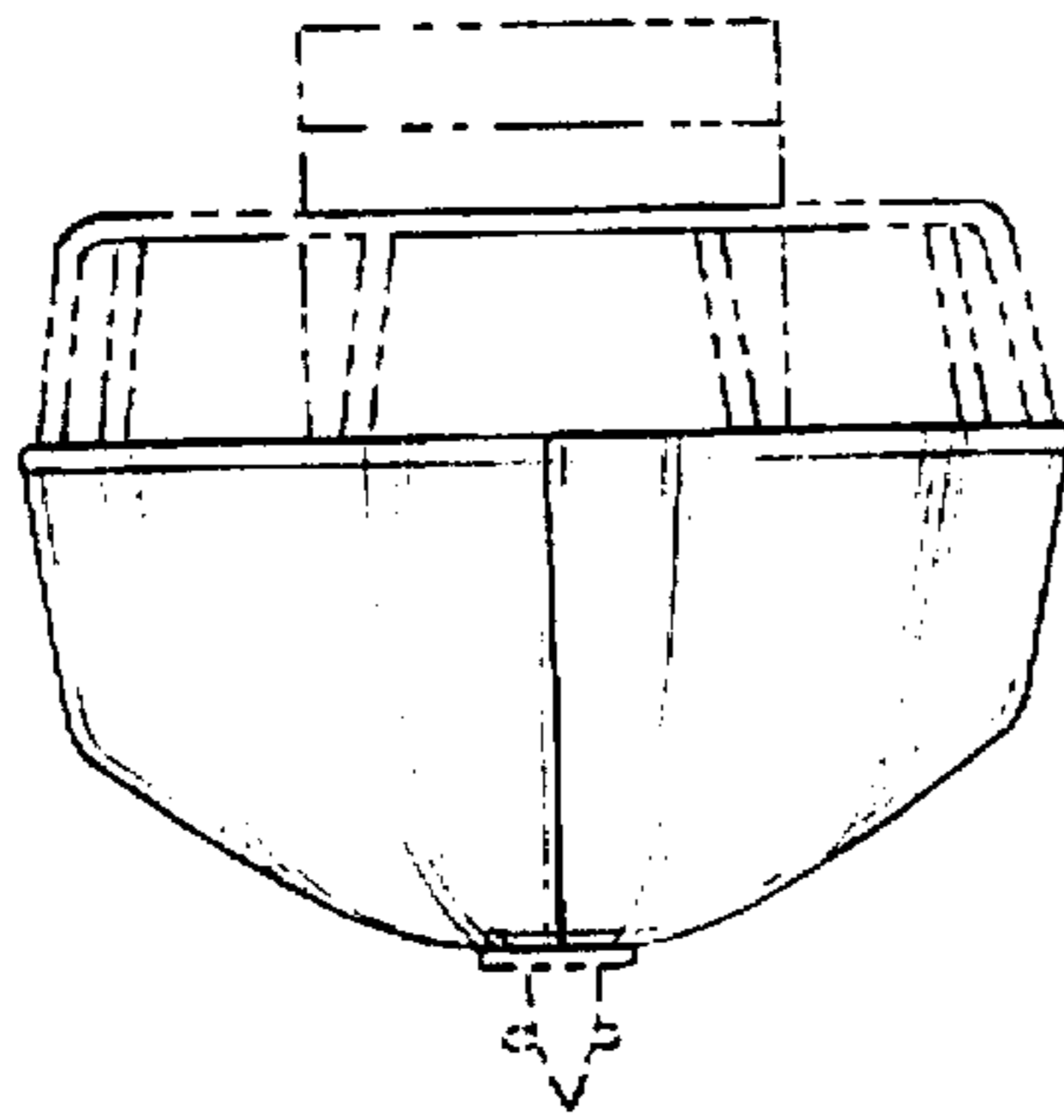

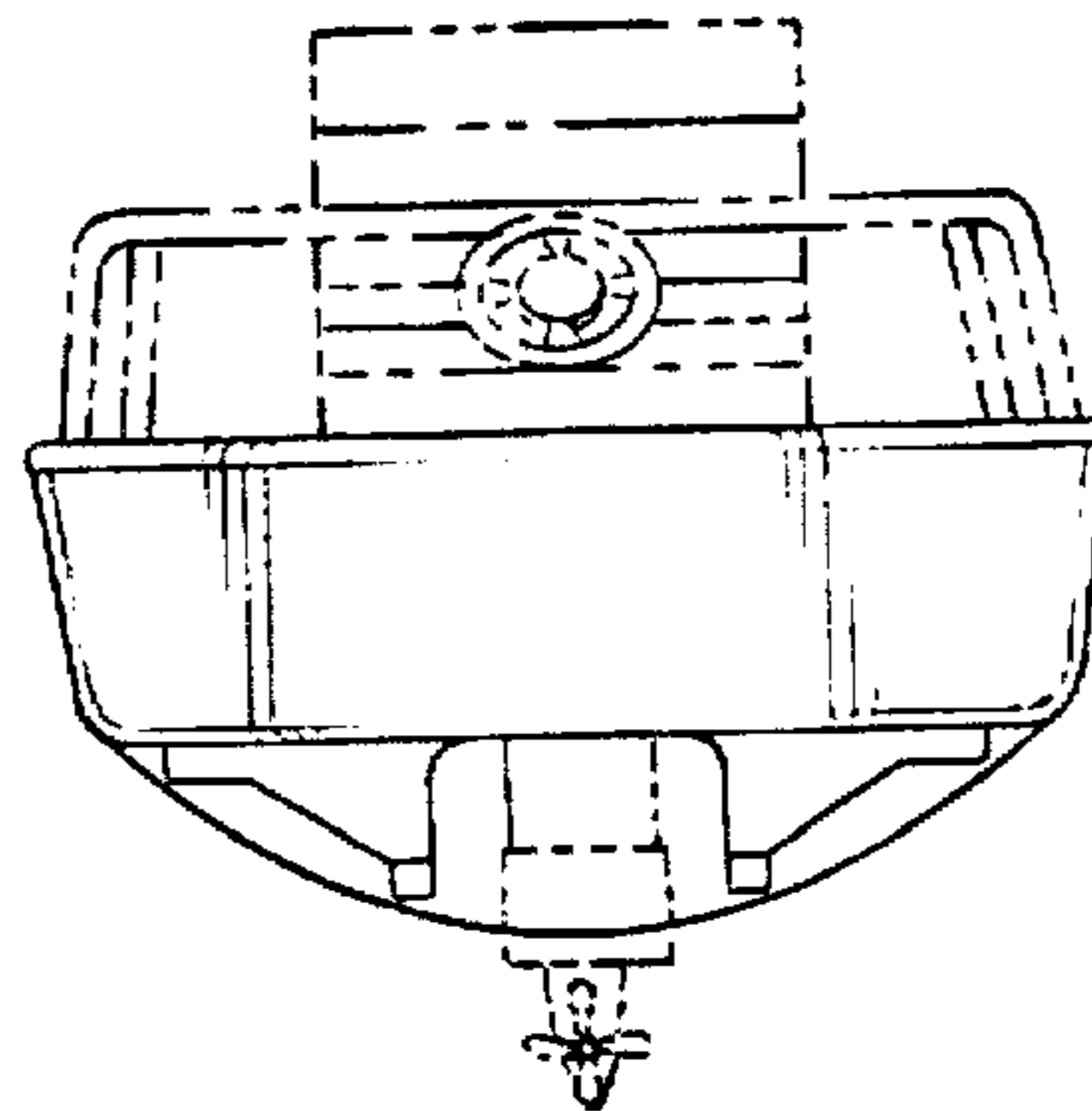

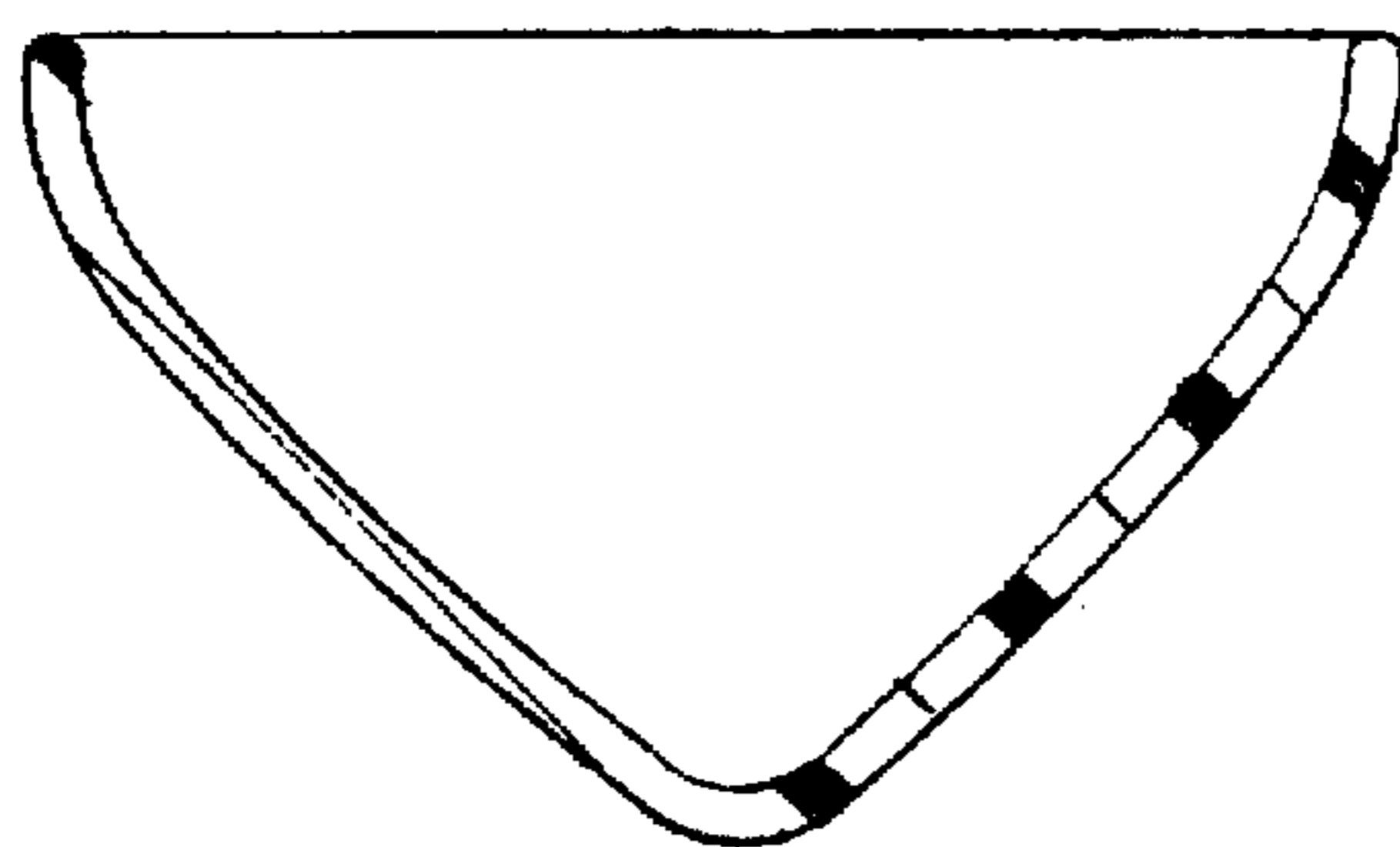

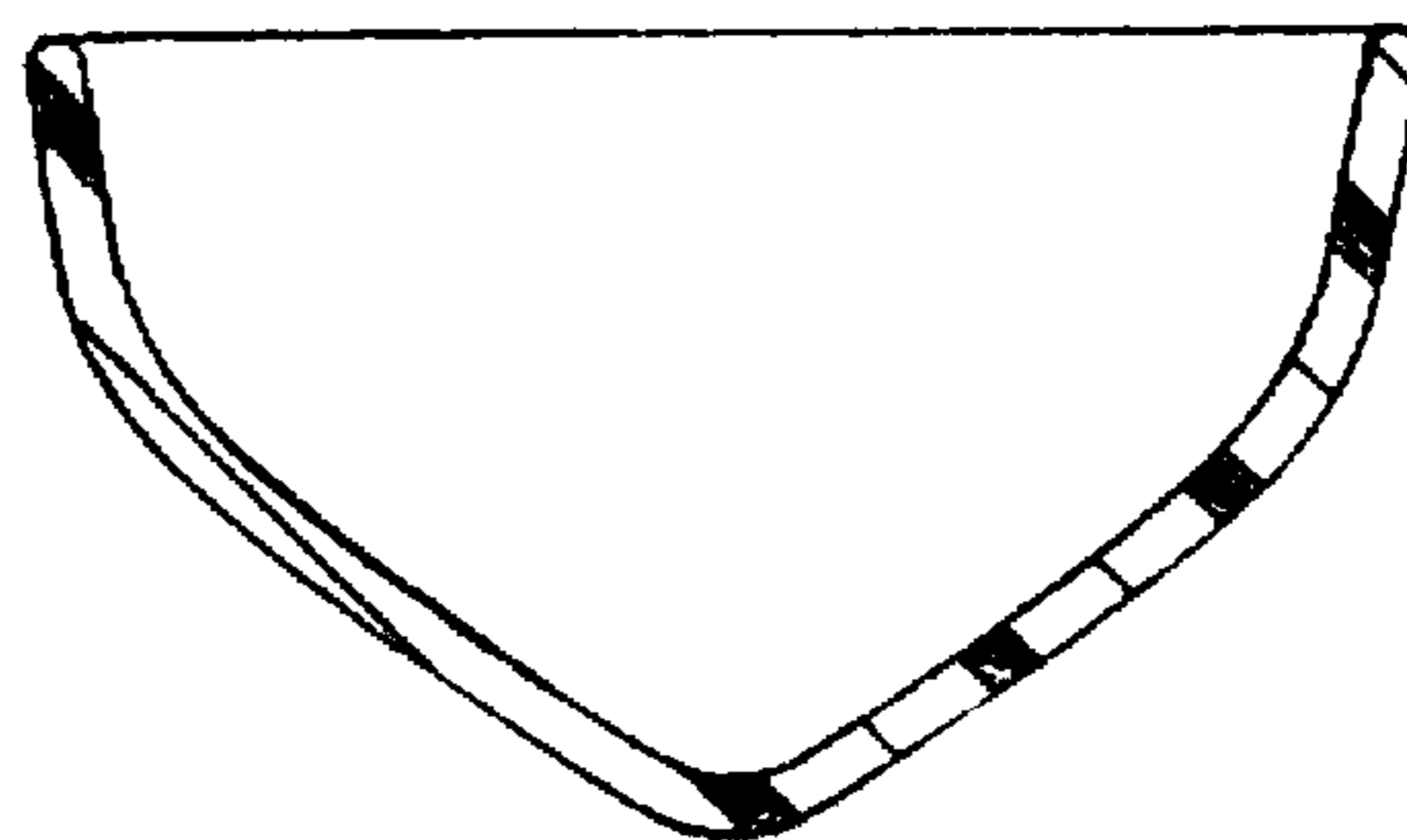

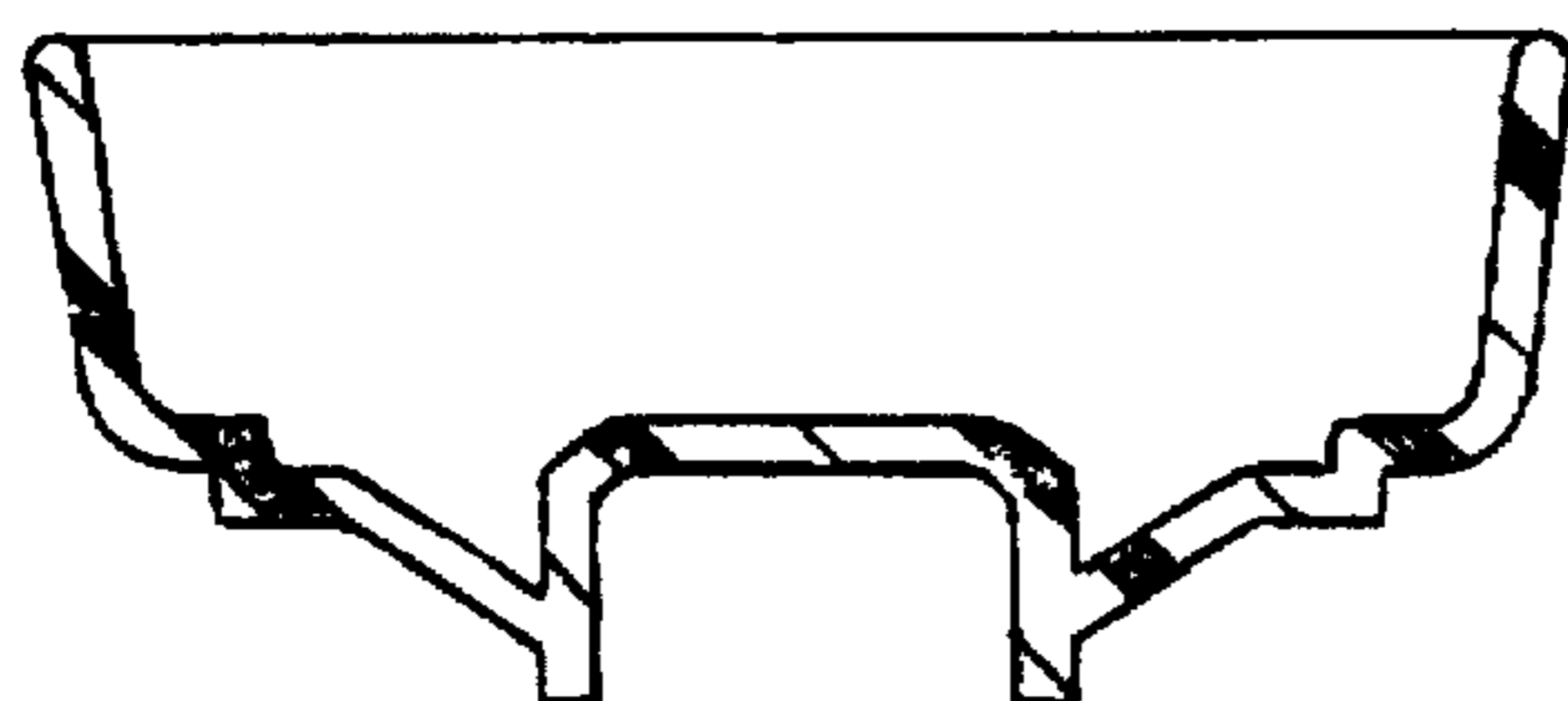
