[57] **CLAIM**

The inventors claim the ornamental design of the flexible jumper, as shown in the eight figures and described.

**DESCRIPTION**

FIG. 1 is a left side view of the flexible jumper in its straightened configuration;

FIG. 2 is a top view of the straightened flexible jumper showing our new design;

FIG. 3 is a right side view of our new design;

FIG. 4 is a bottom view of the straightened flexible jumper showing our new design;

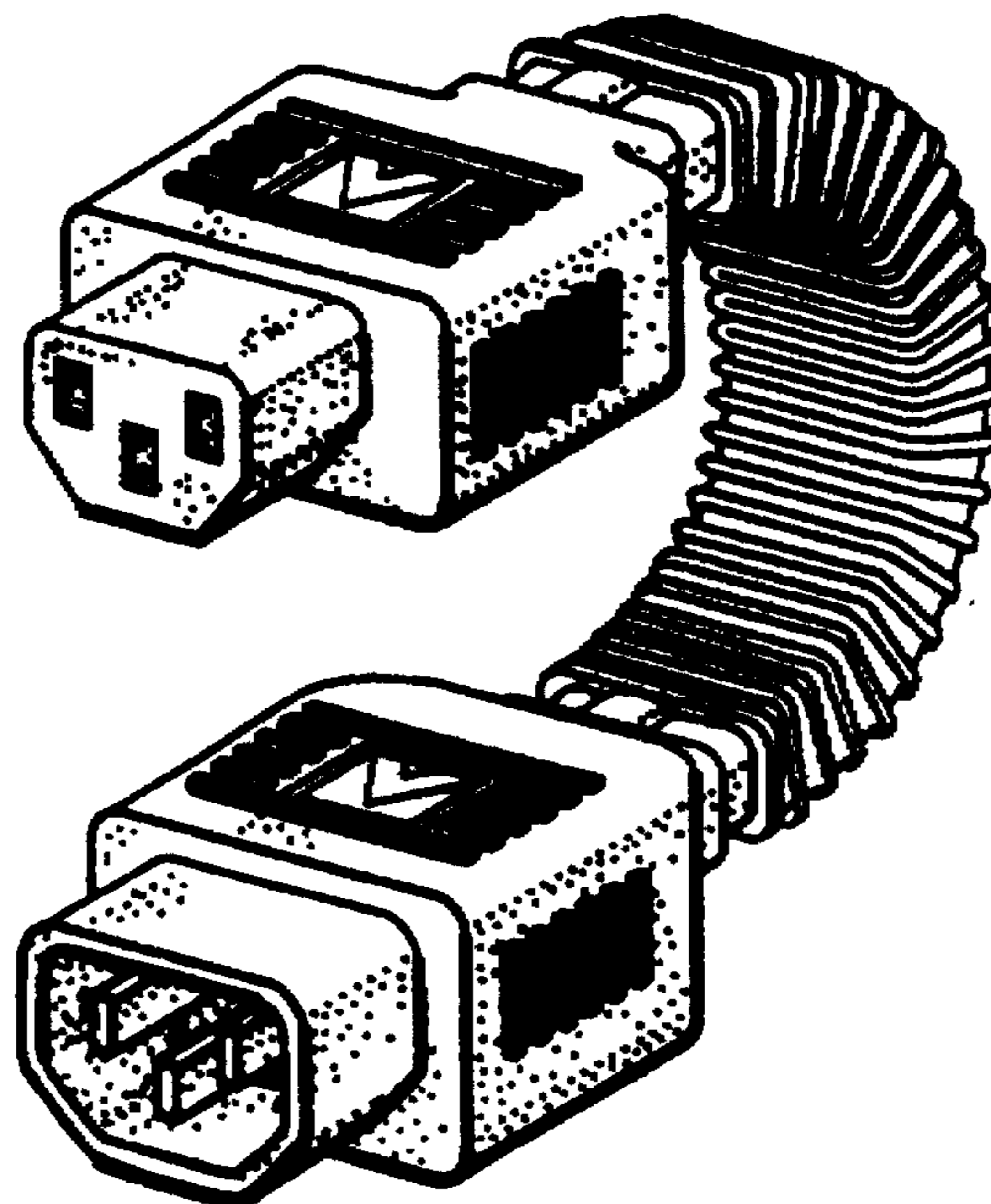
FIG. 5 is one end view of our new design showing the female end of the flexible jumper;

FIG. 6 is a trimetric view of our flexible jumper in its curved, mostly used configuration;

FIG. 7 is a trimetric view of our flexible jumper in its straightened configuration; and,

FIG. 8 is the other end view of our new design showing the male end of the flexible jumper.

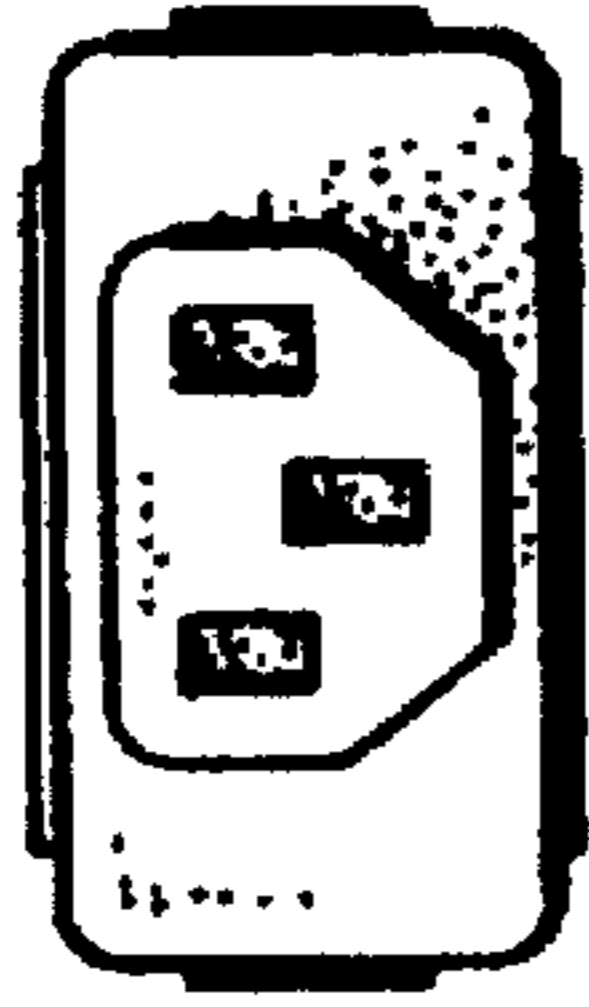

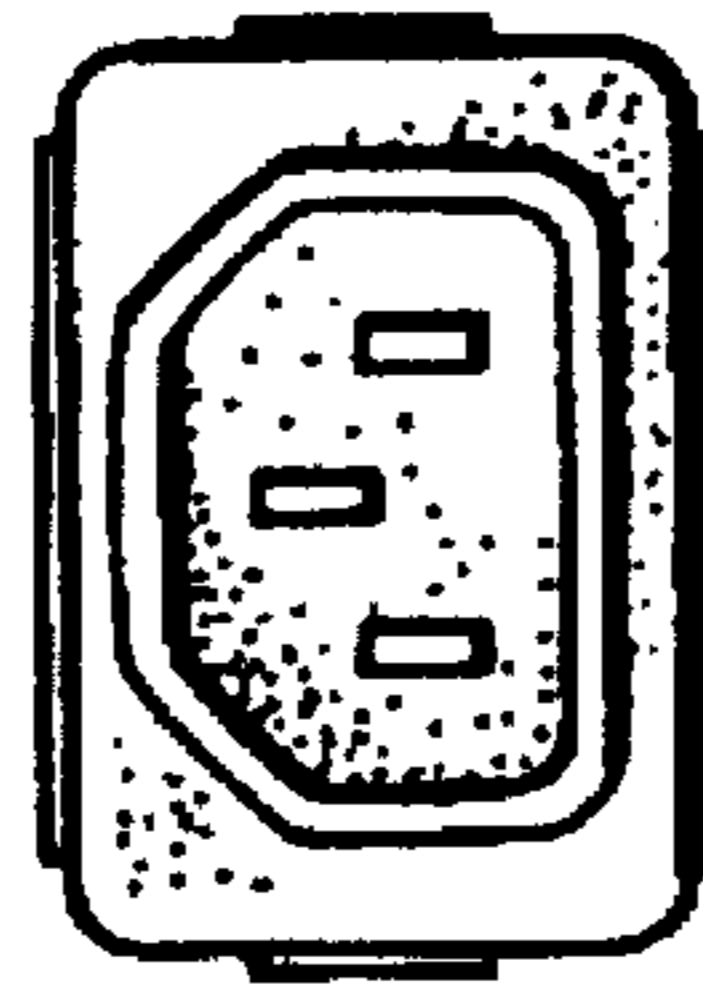

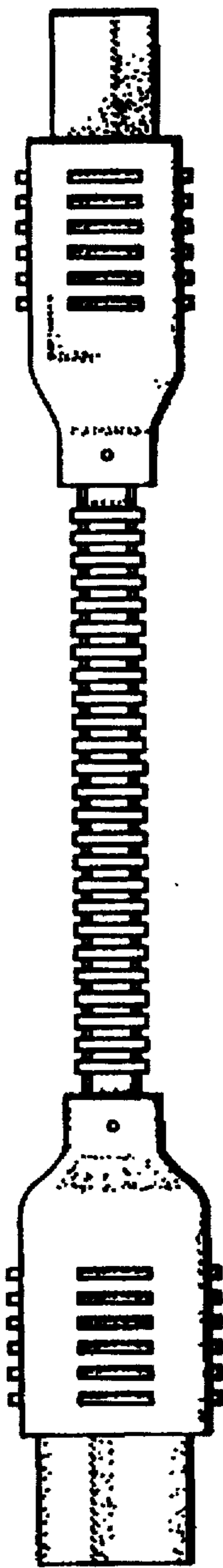

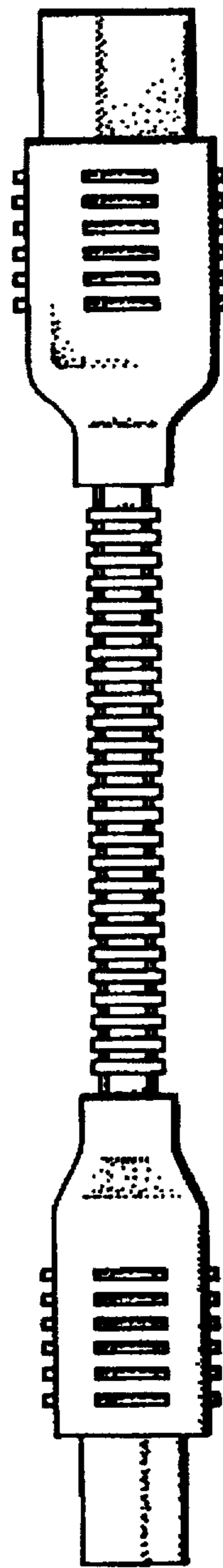

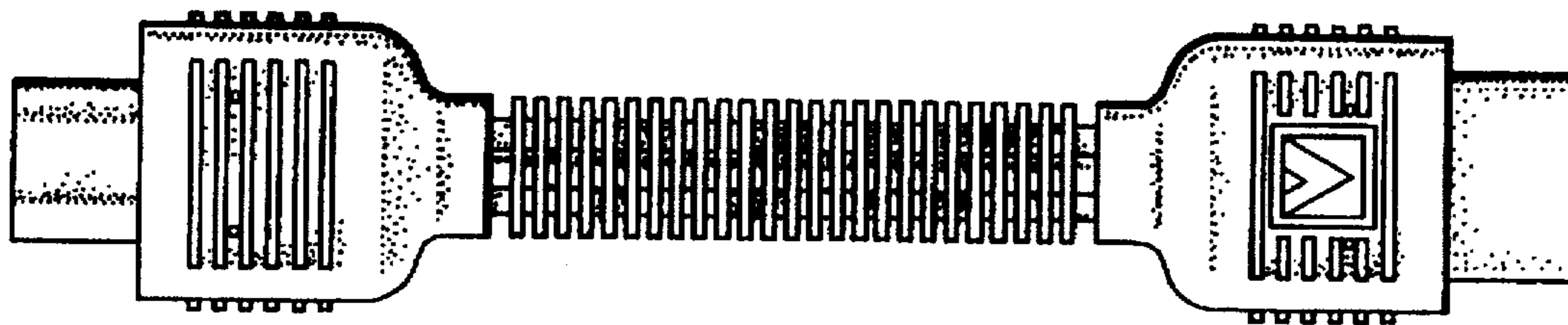

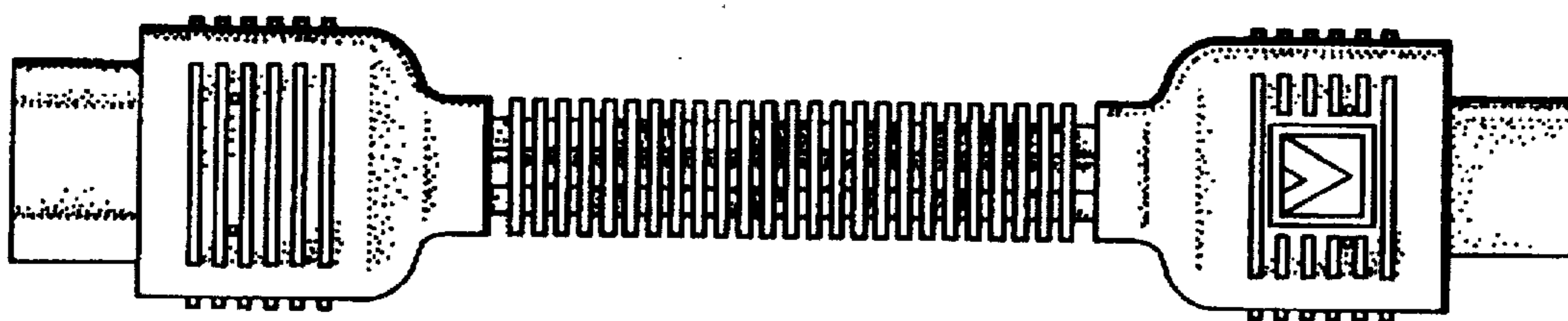

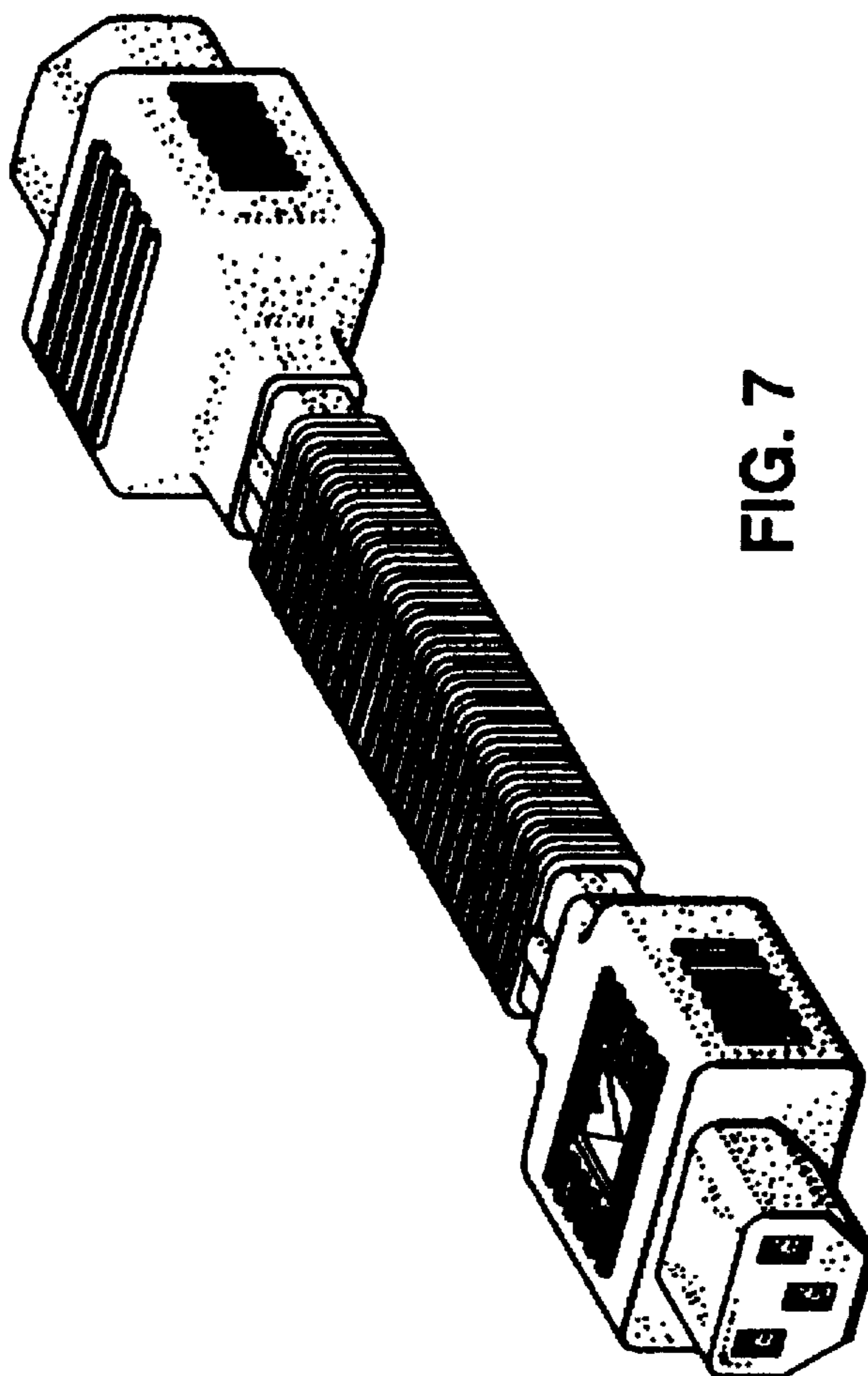

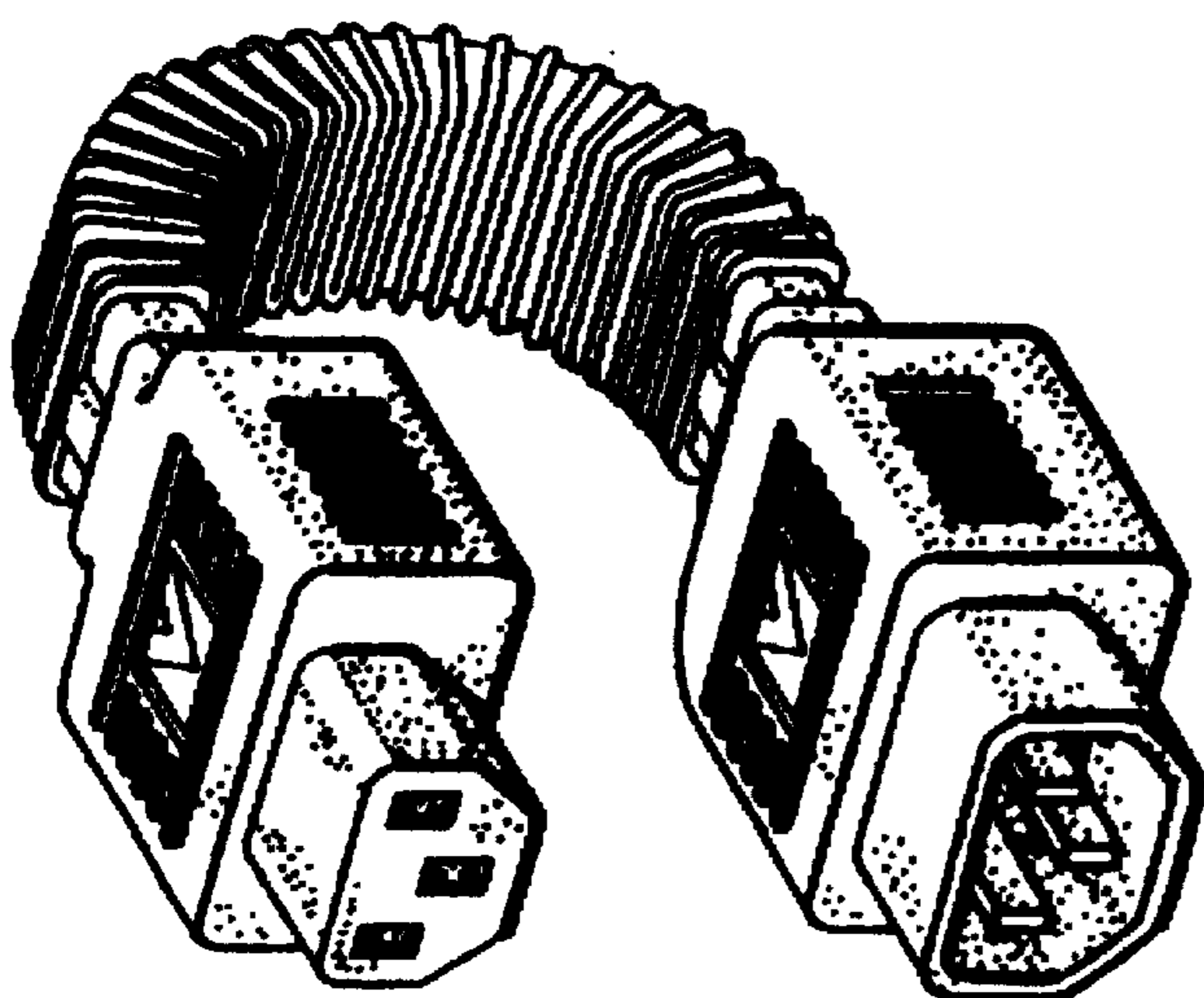
