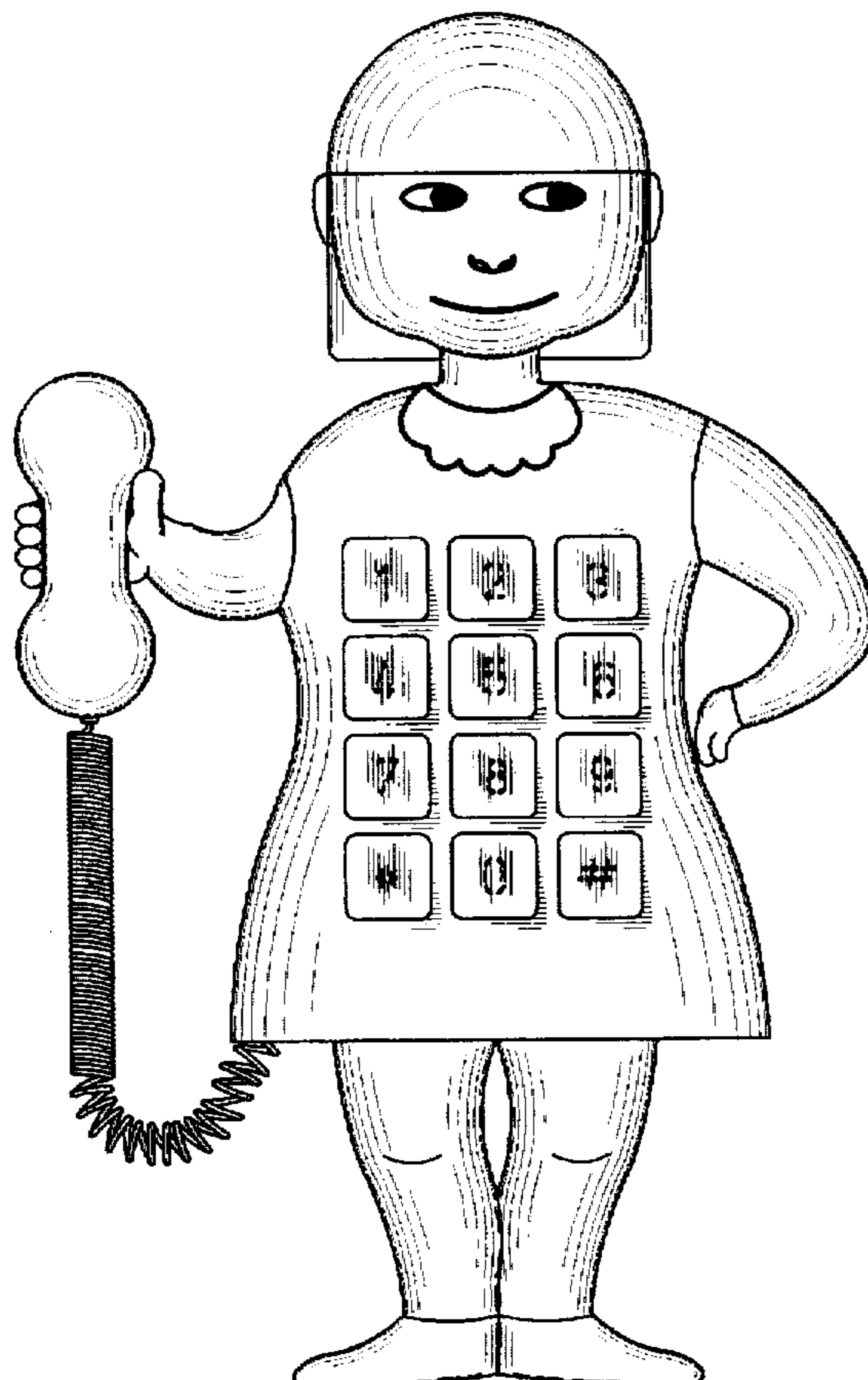
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a front elevational view of the child's telephone showing my new design;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a top plan view thereof; and,

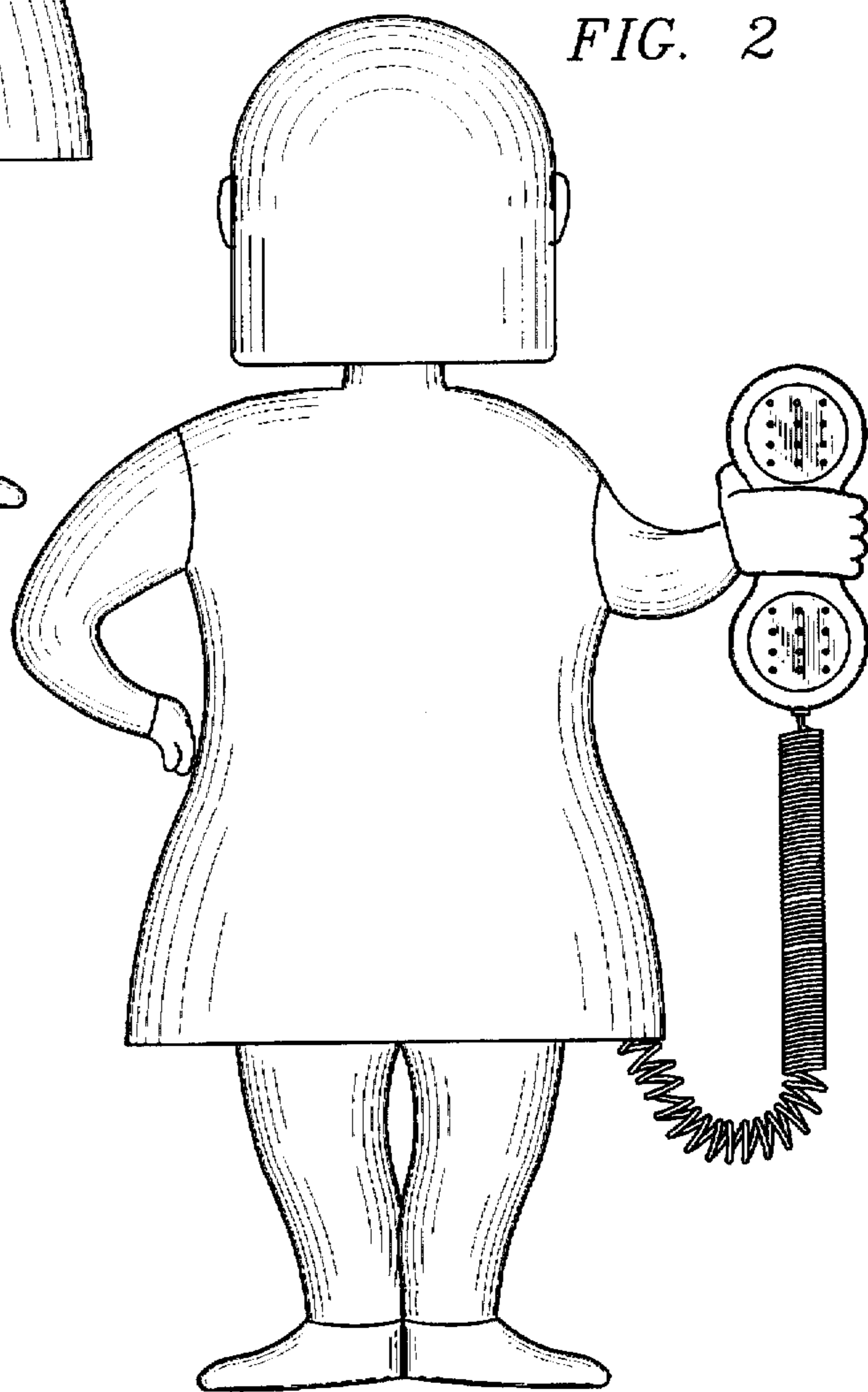
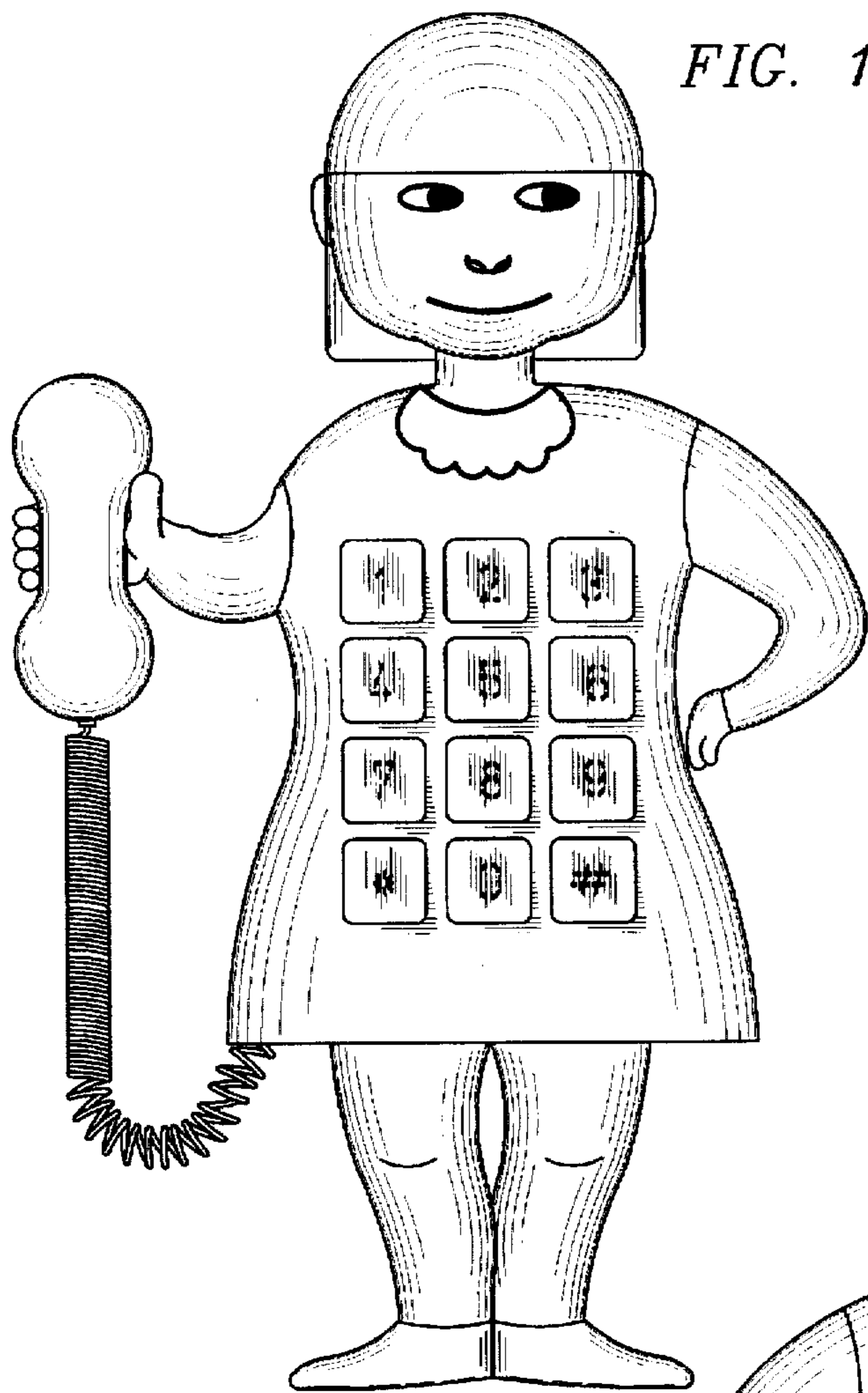

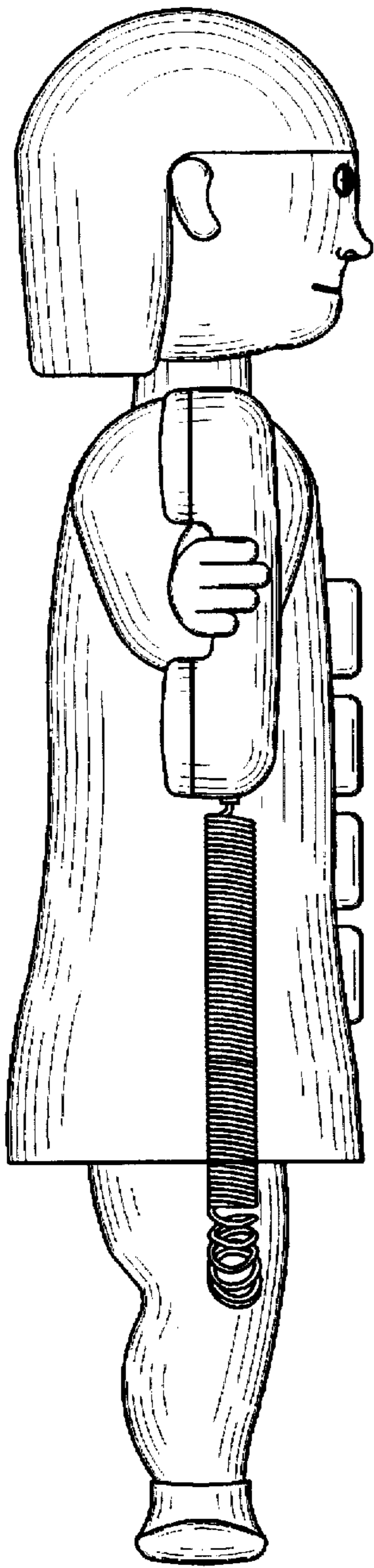
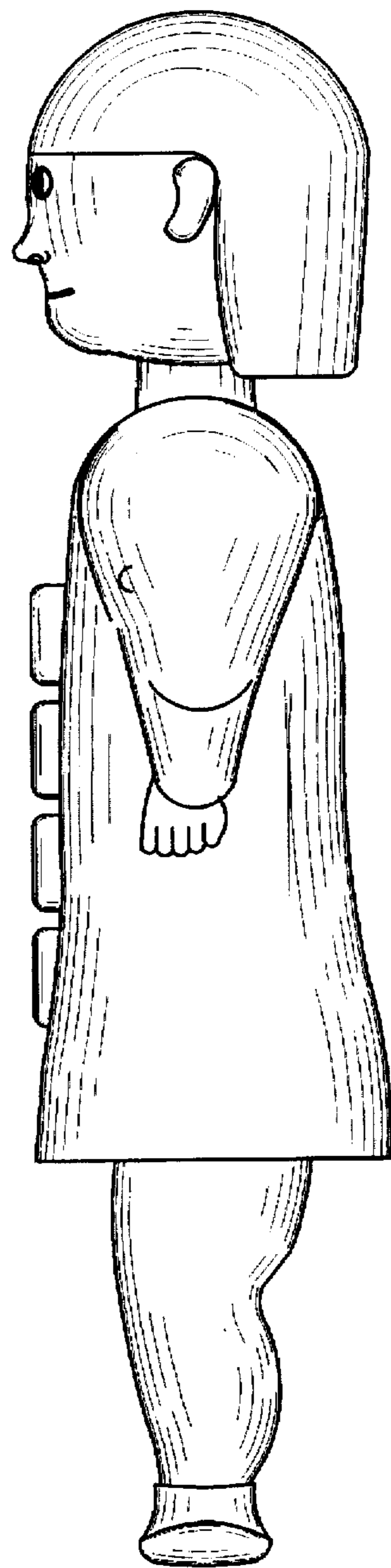
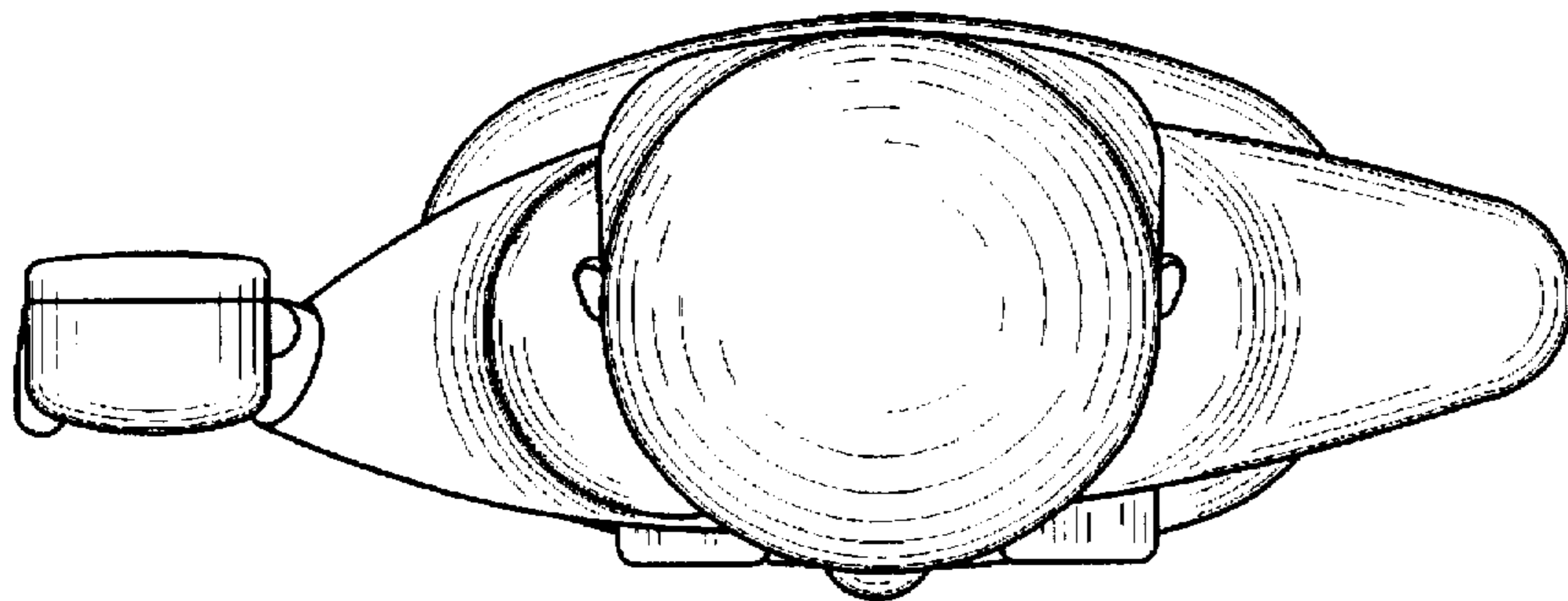
