FIG. 3 is a bottom view of a telephone showing my new design;

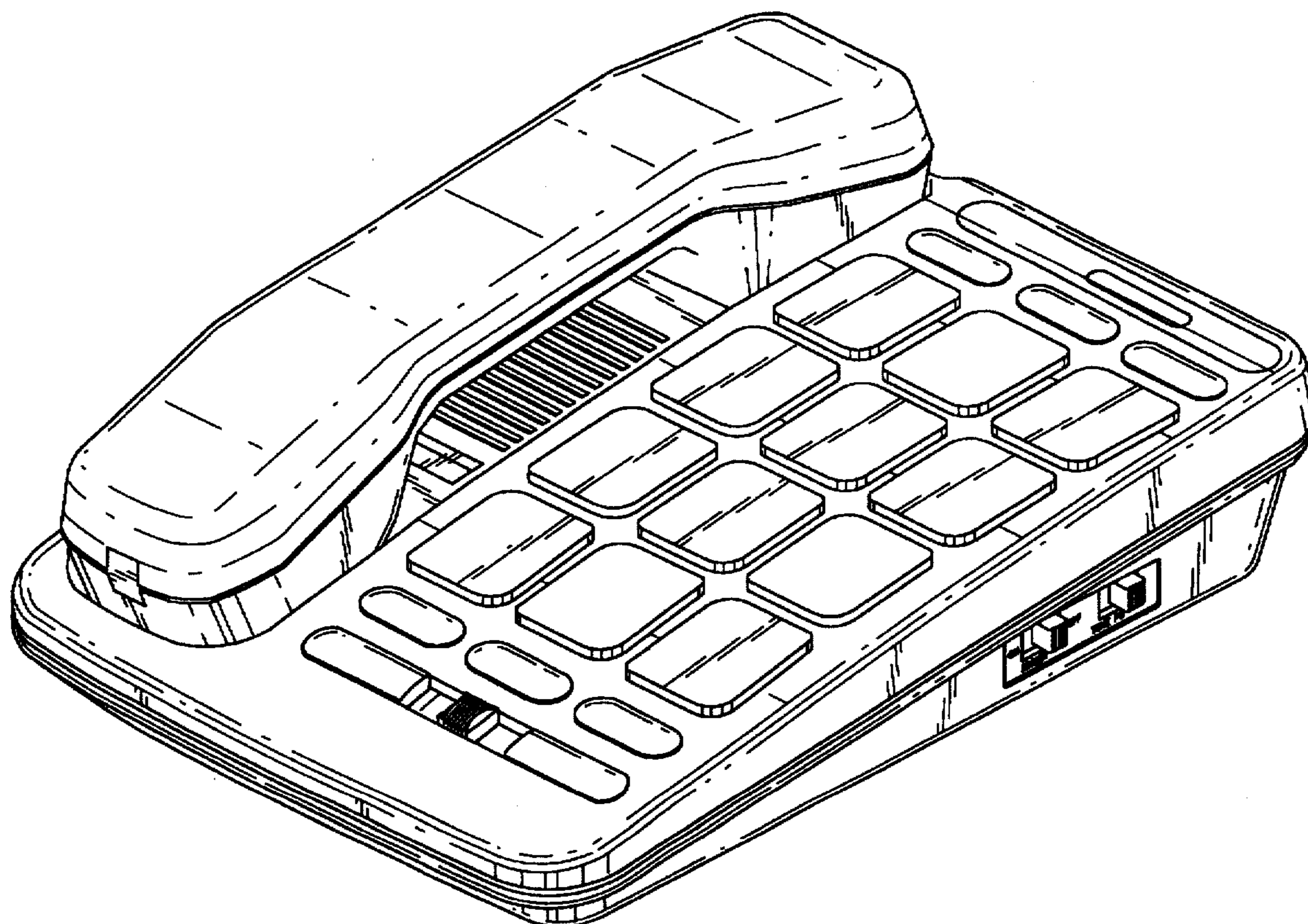
FIG. 4 is a front view of a telephone showing my new design;

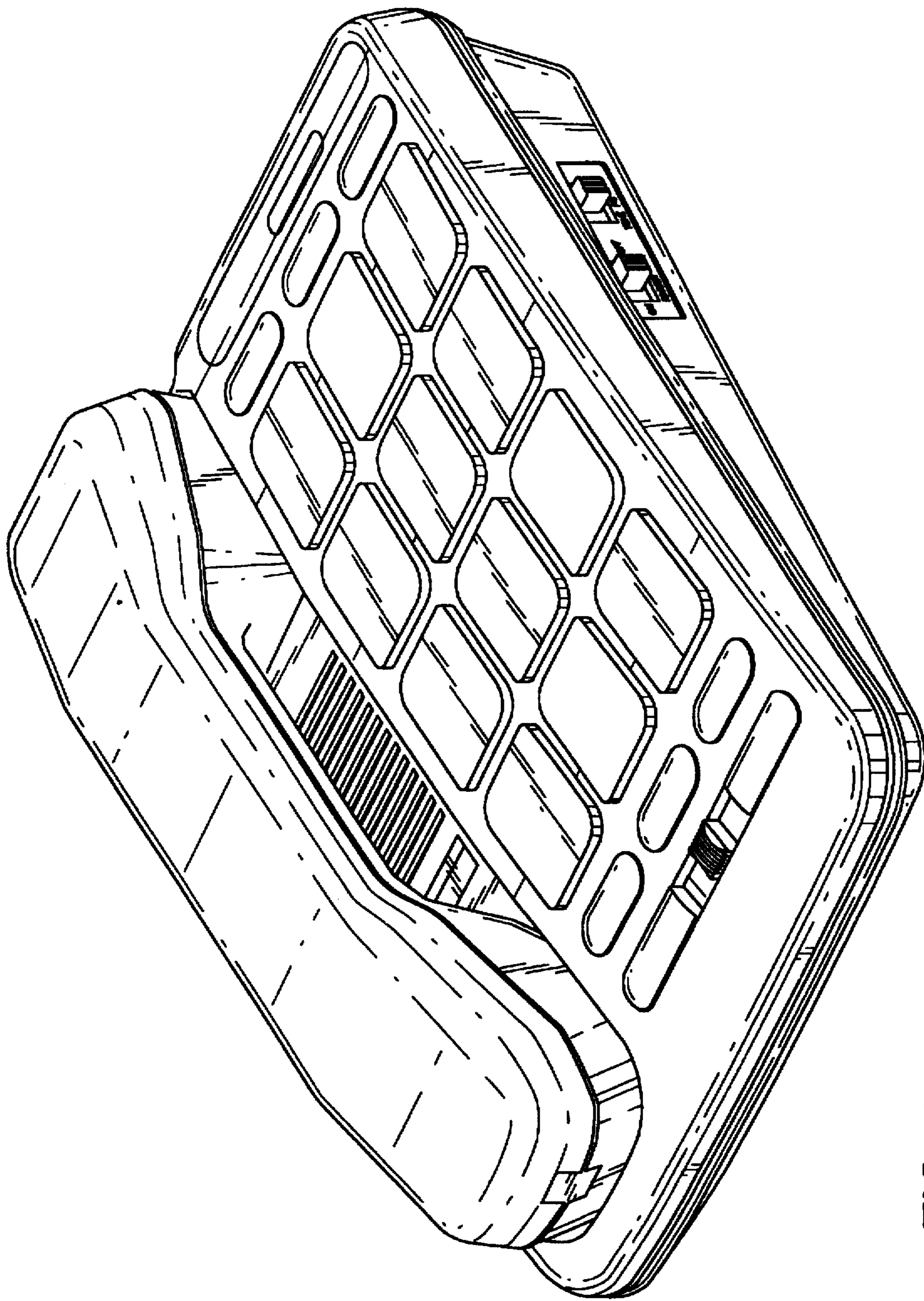
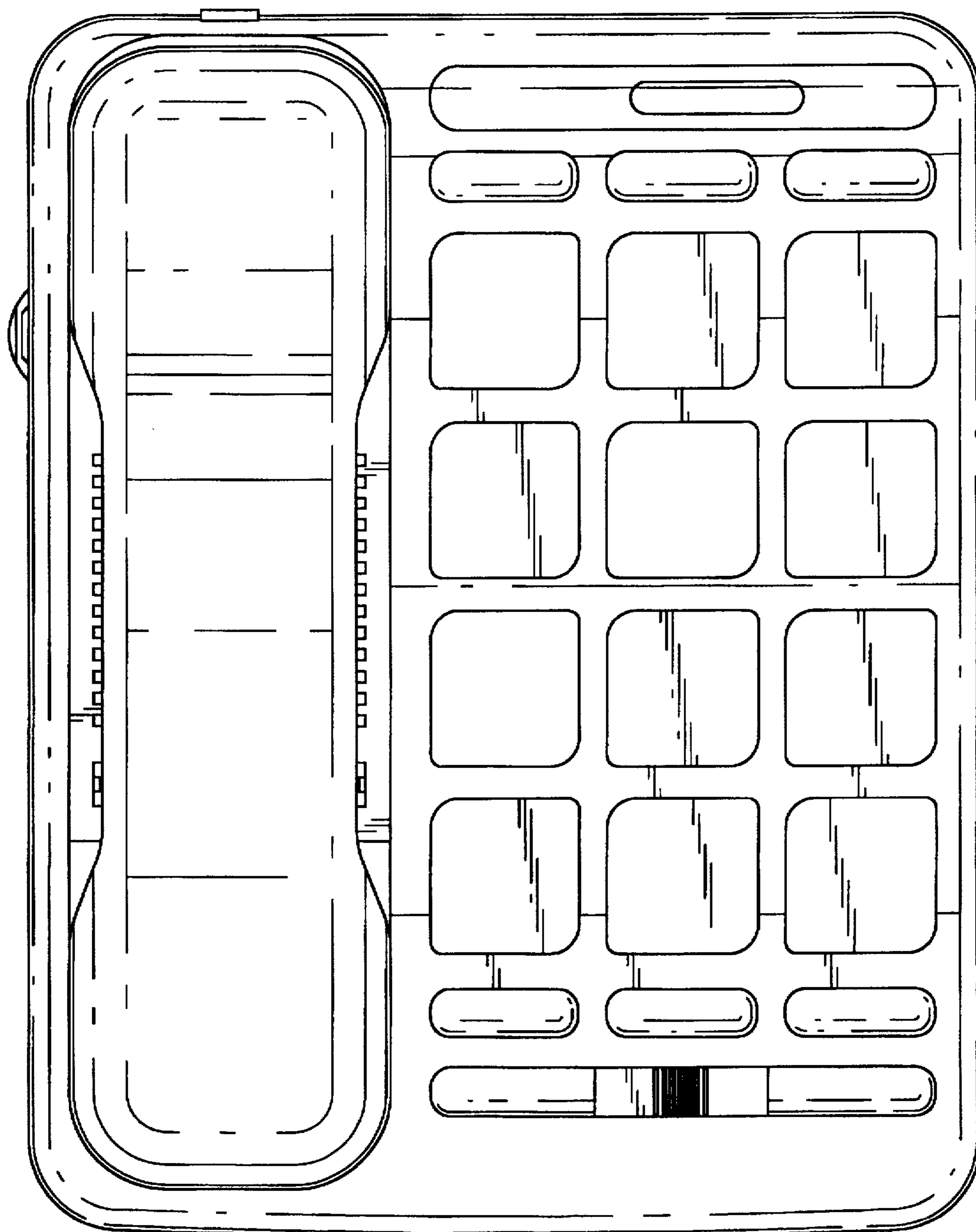
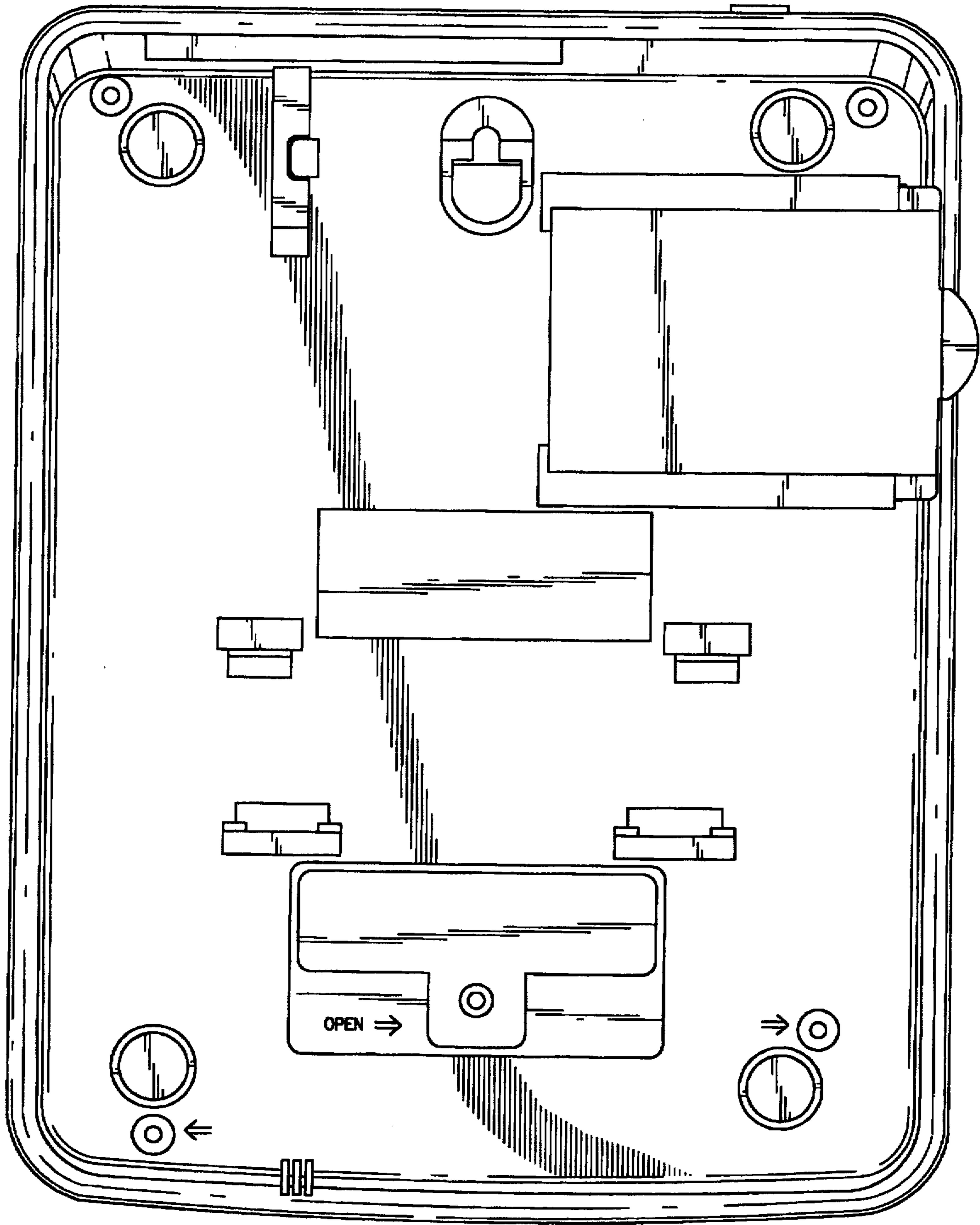


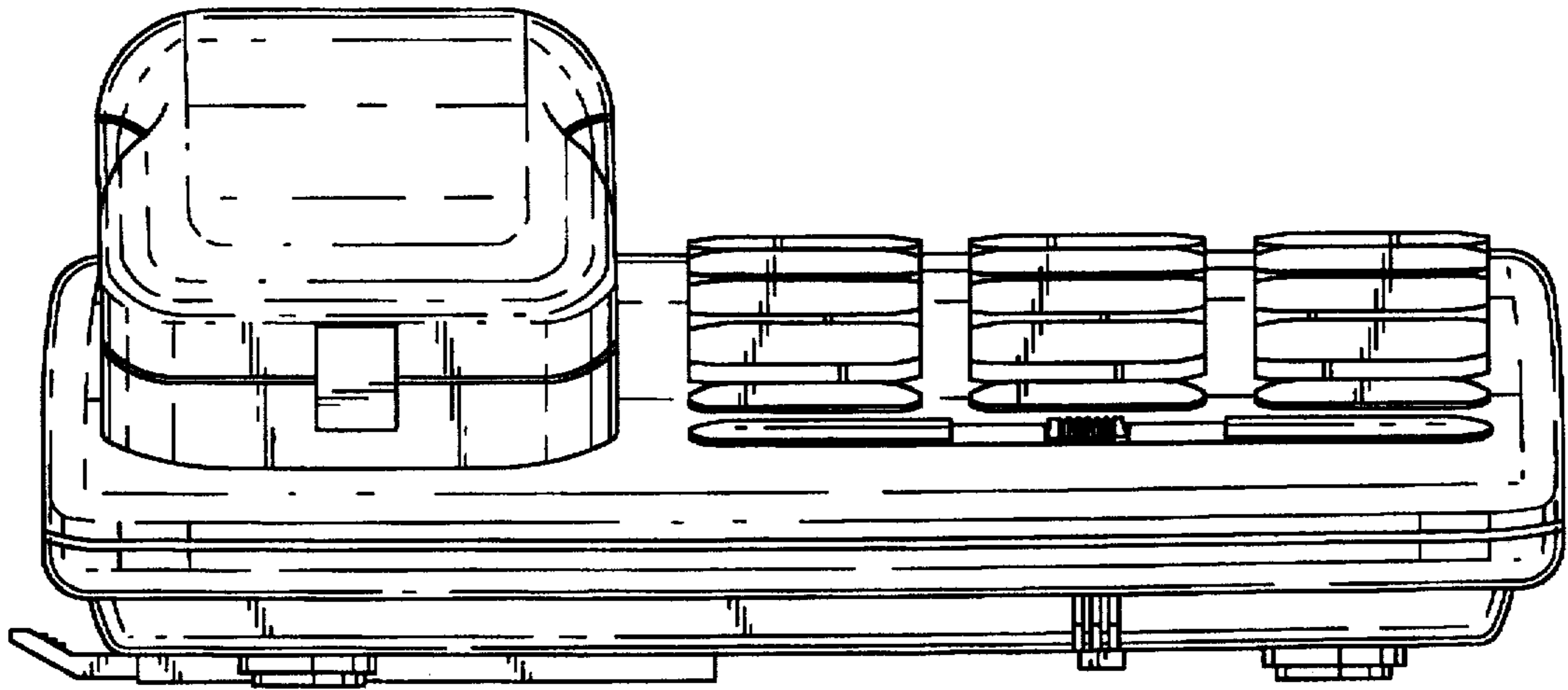

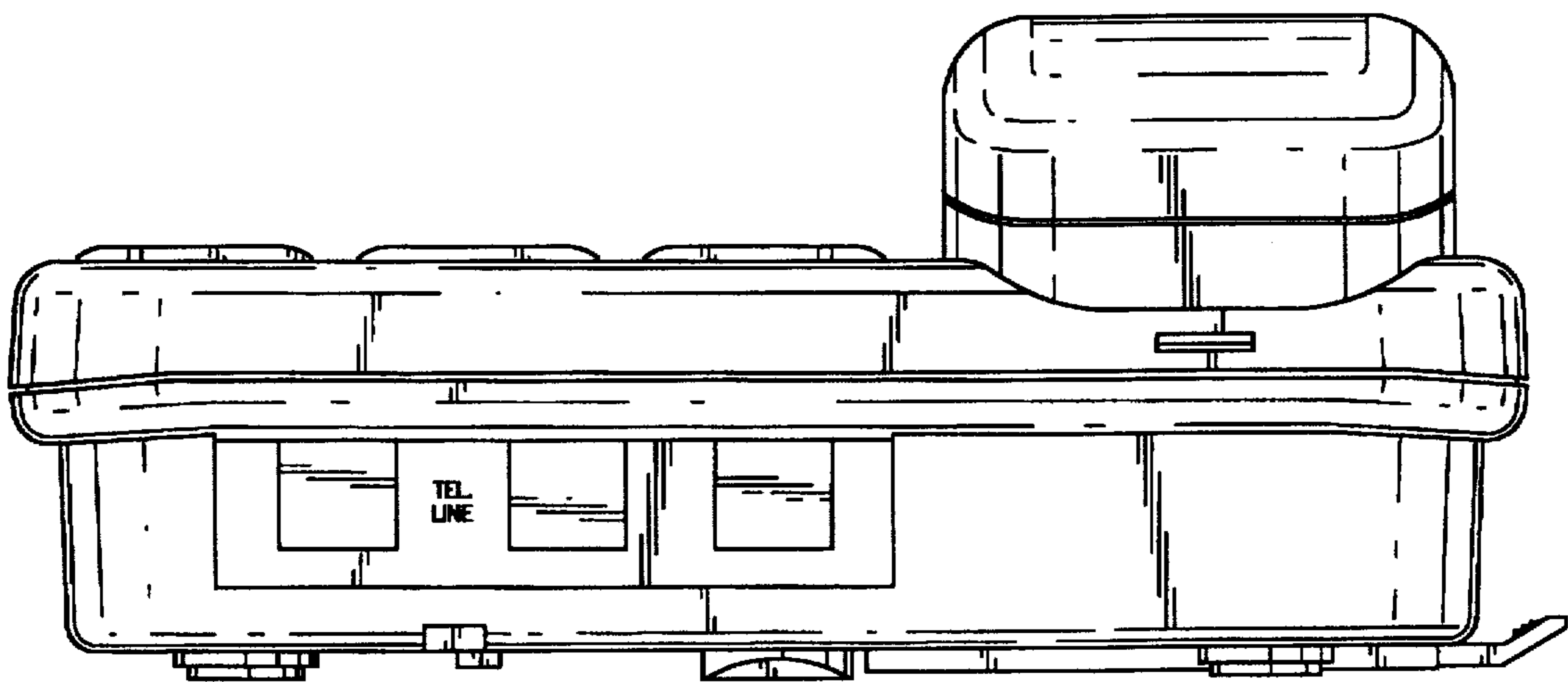

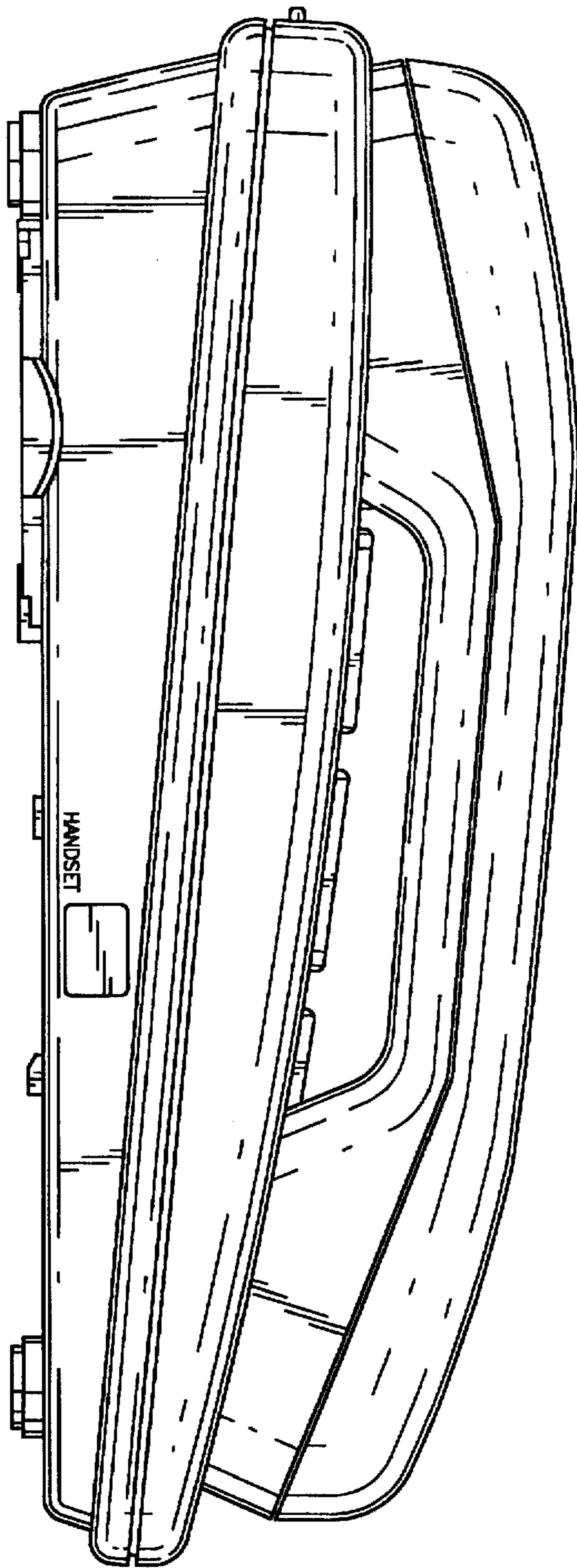

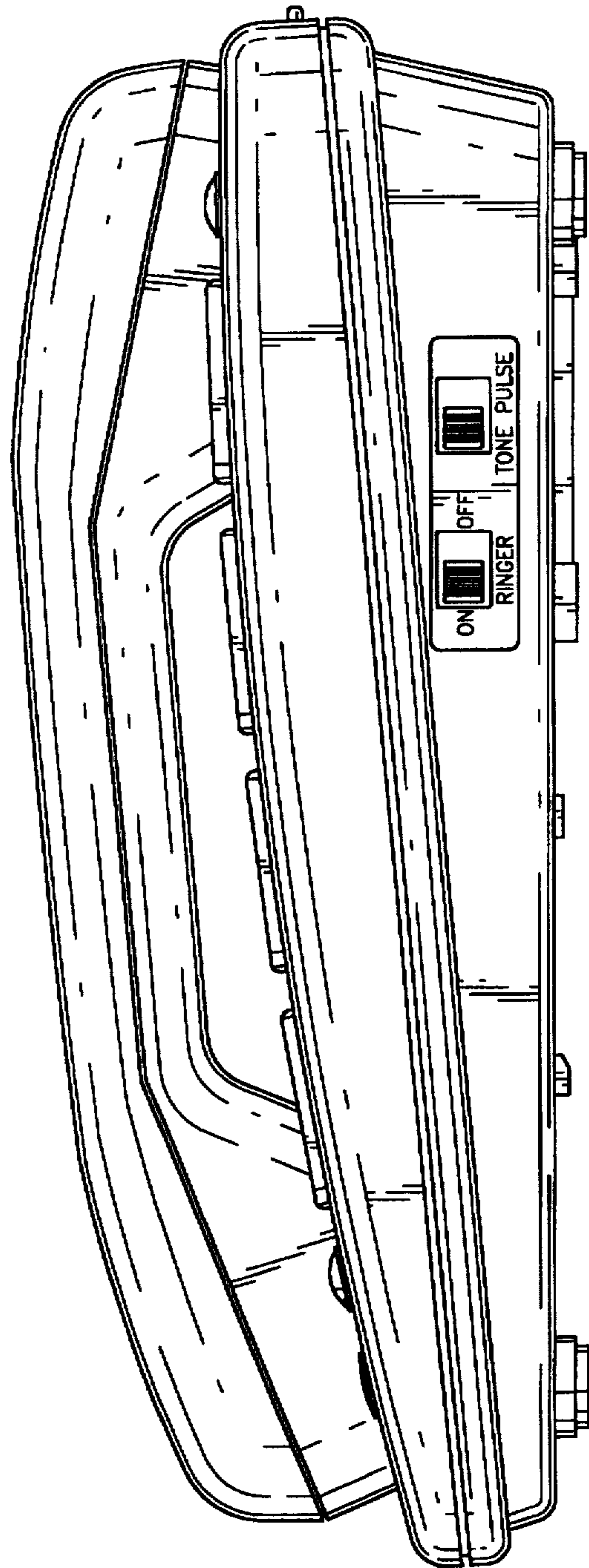
