[57] **CLAIM**

The ornamental design for a lavatory, as shown and described.

DESCRIPTION

FIG. 1 is a right, top, front perspective view of a lavatory embodying my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side elevational view for all embodiments being a mirror image of the left side shown;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a cross-sectional view taken along line 7—7 of FIG. 2;
FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 2;
FIG. 9 is a top plan view of a second embodiment;
FIG. 10 is a front elevational view thereof;
FIG. 11 is a rear elevational view thereof; and,
FIG. 12 is a top plan view of a third embodiment, identical to the second, but for the top surface.
The broken line representations of holes and countertop in FIG. 1 are for purposes of illustration only, and form no part of the claimed design.

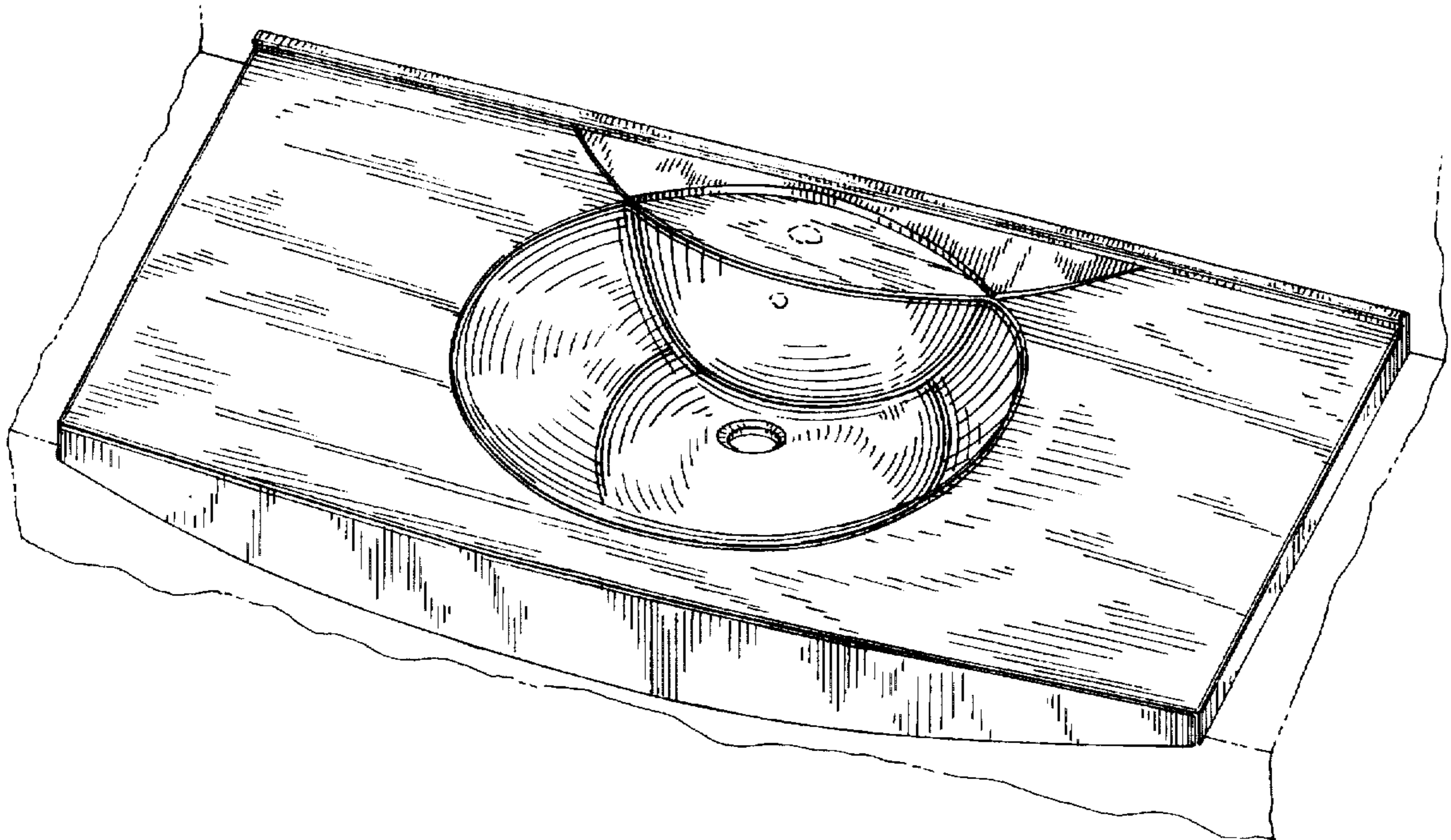

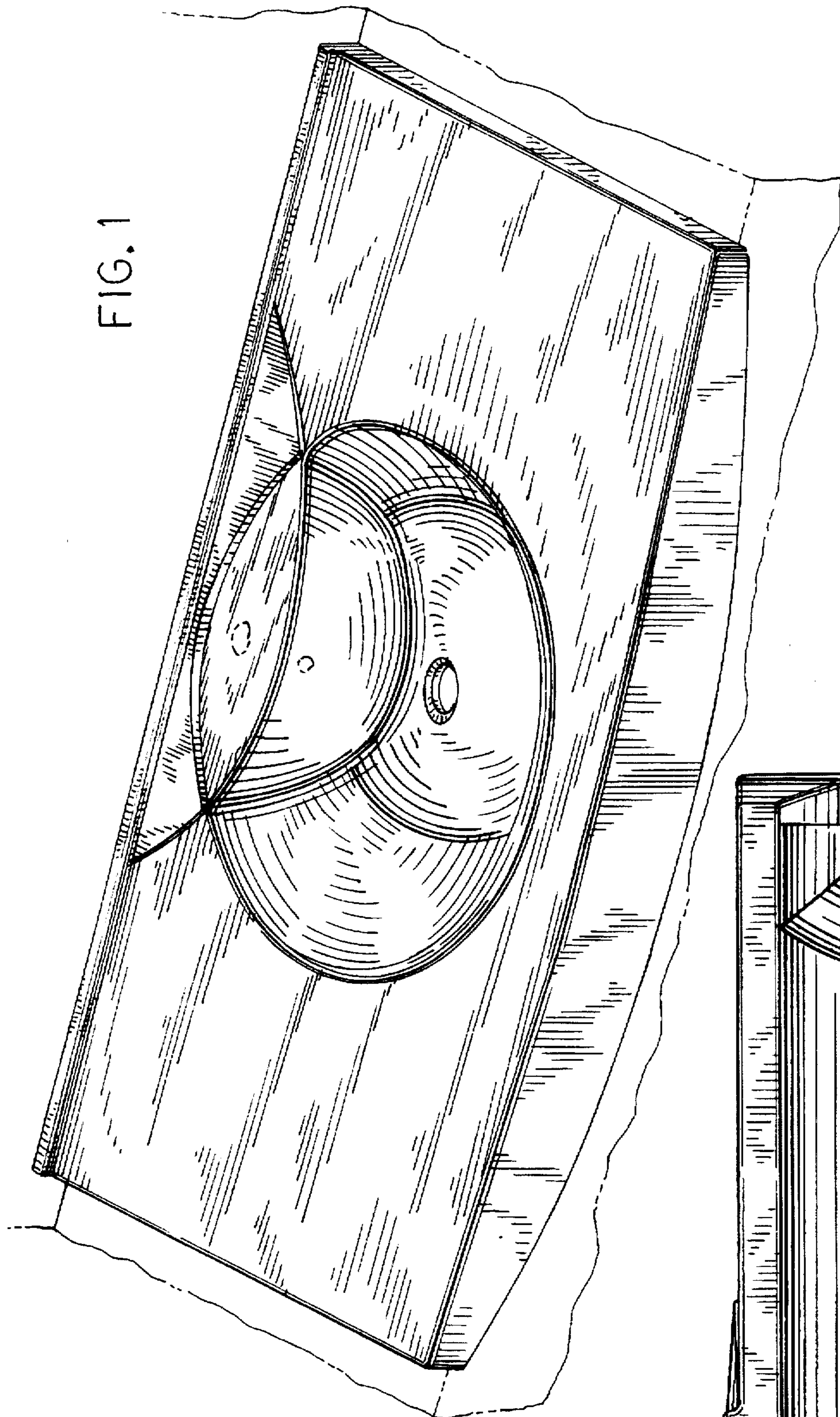
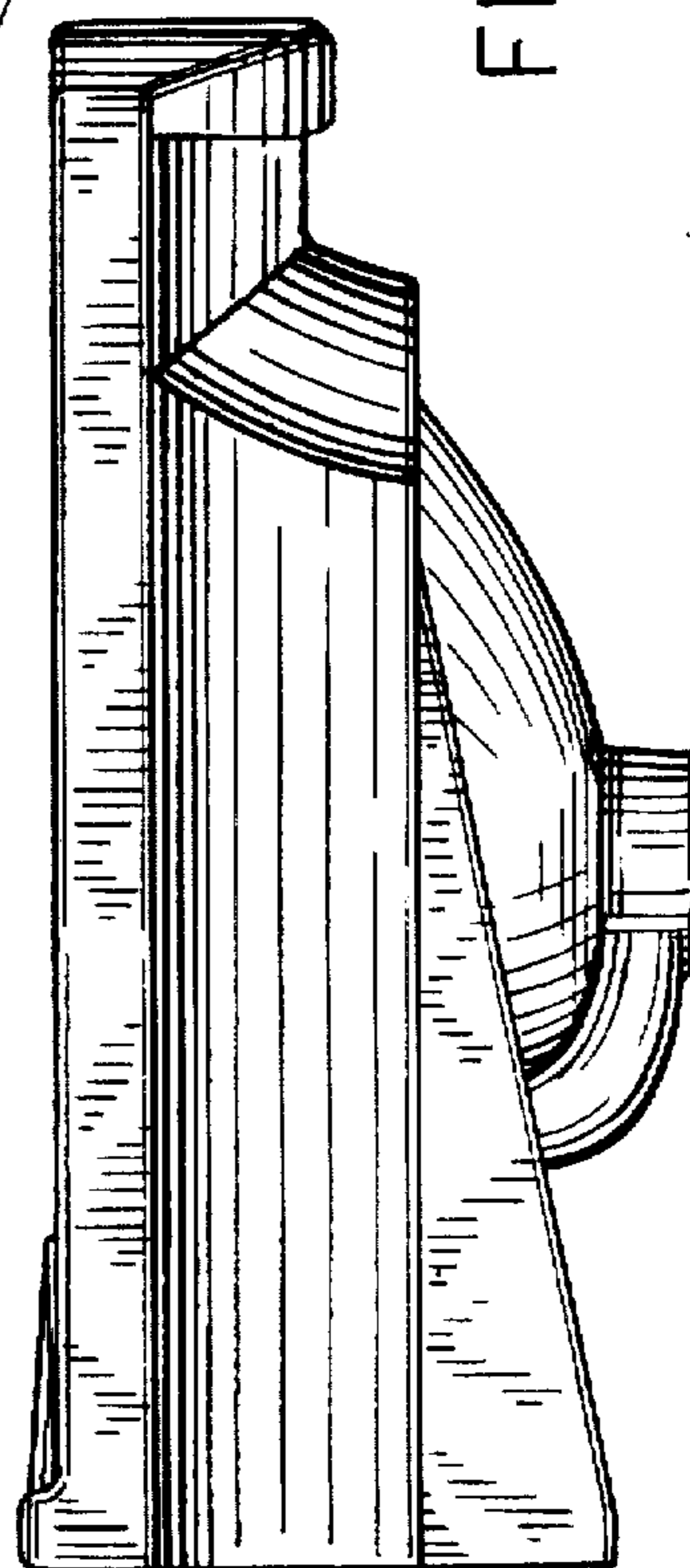

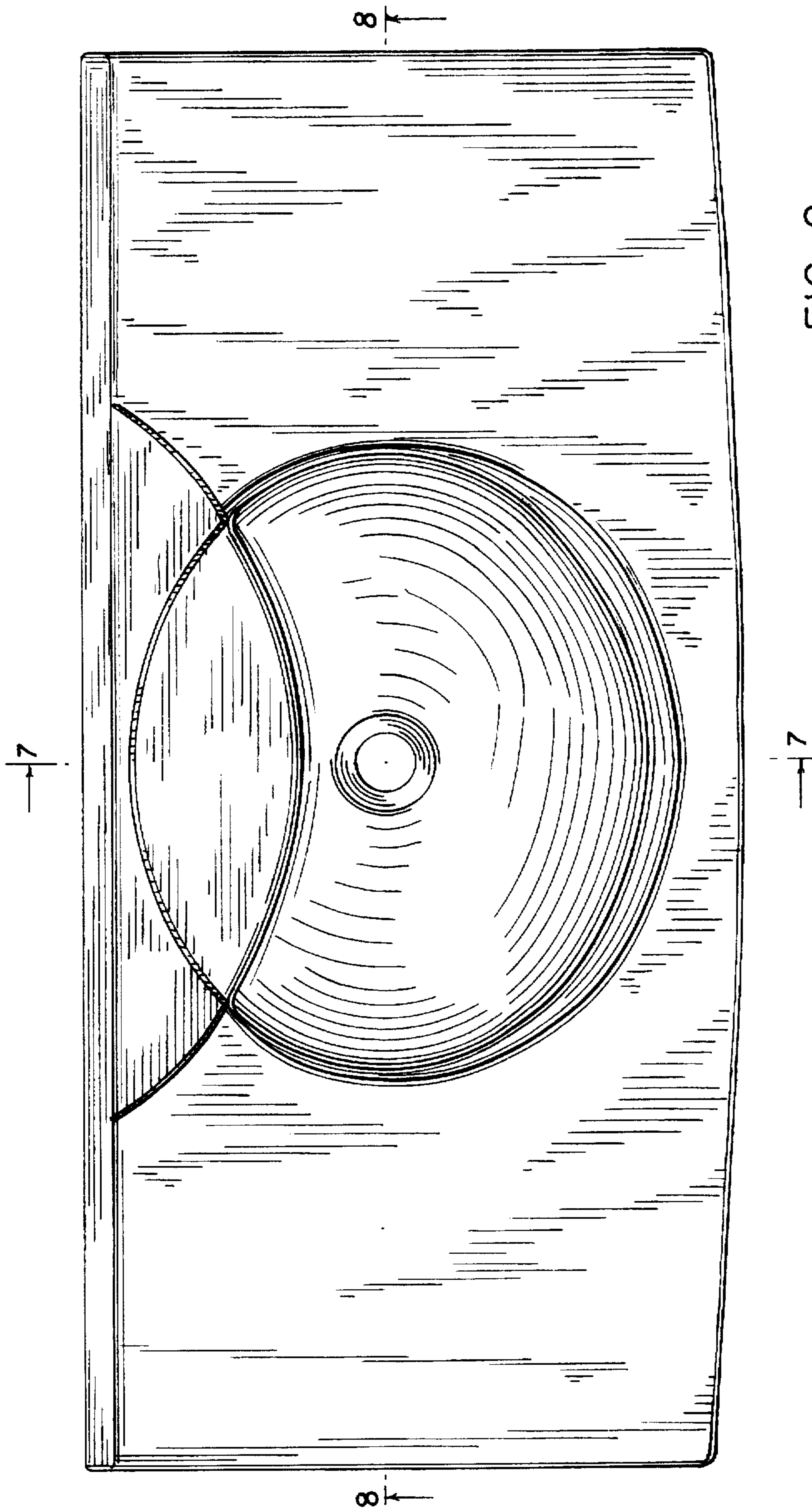

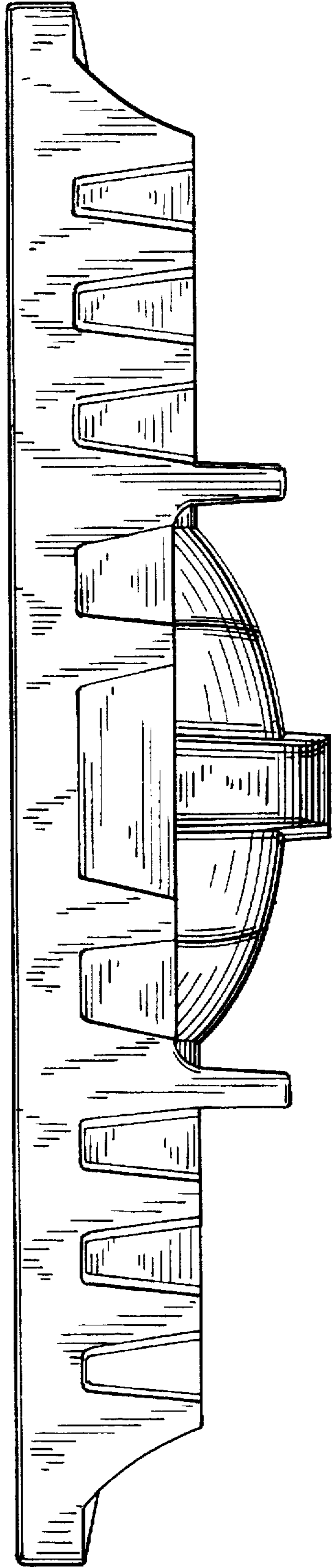
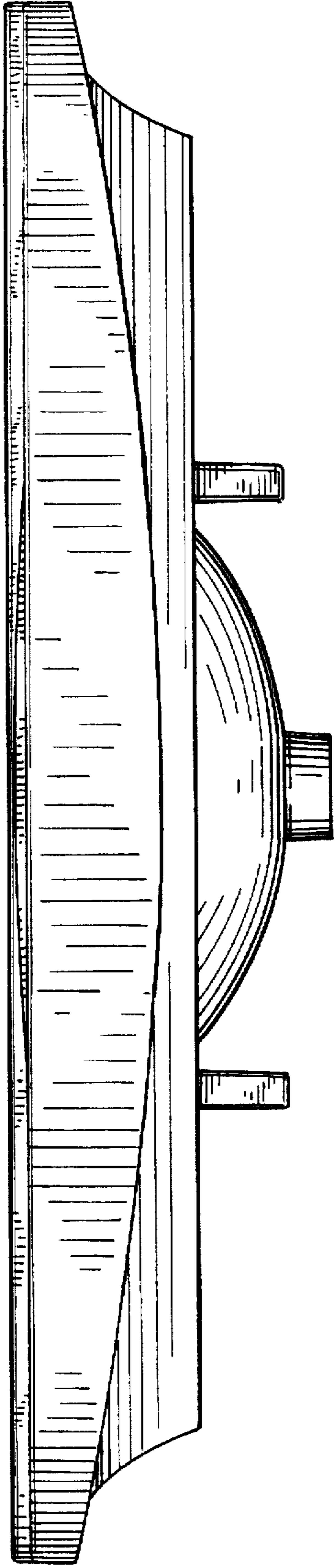

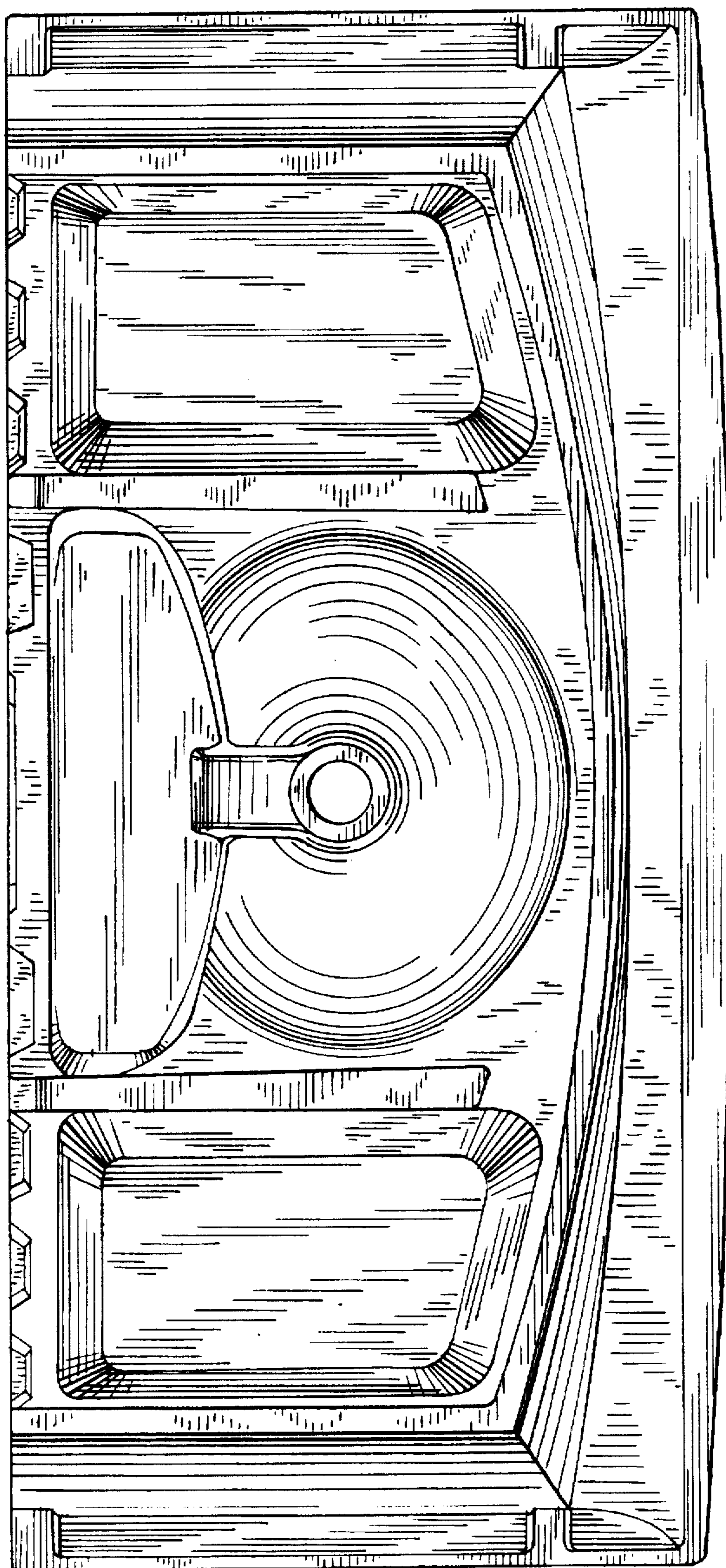

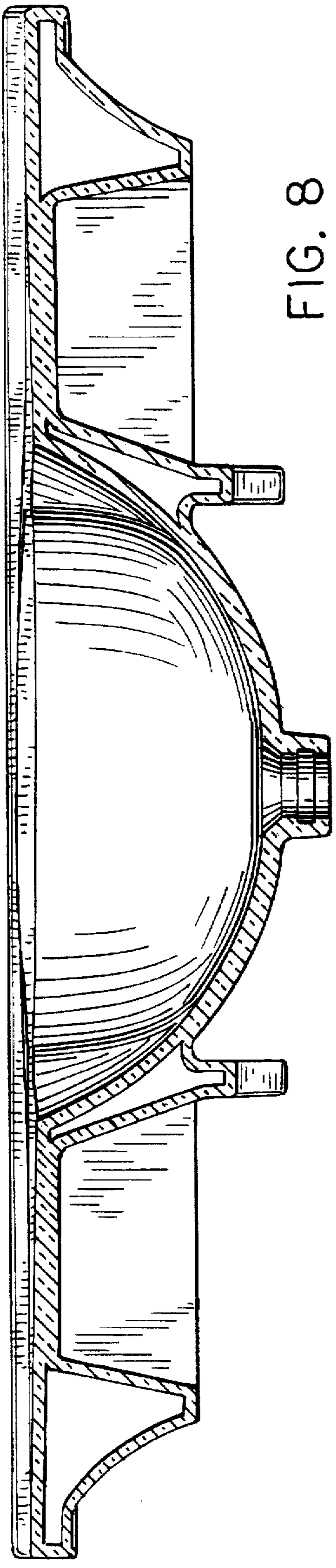

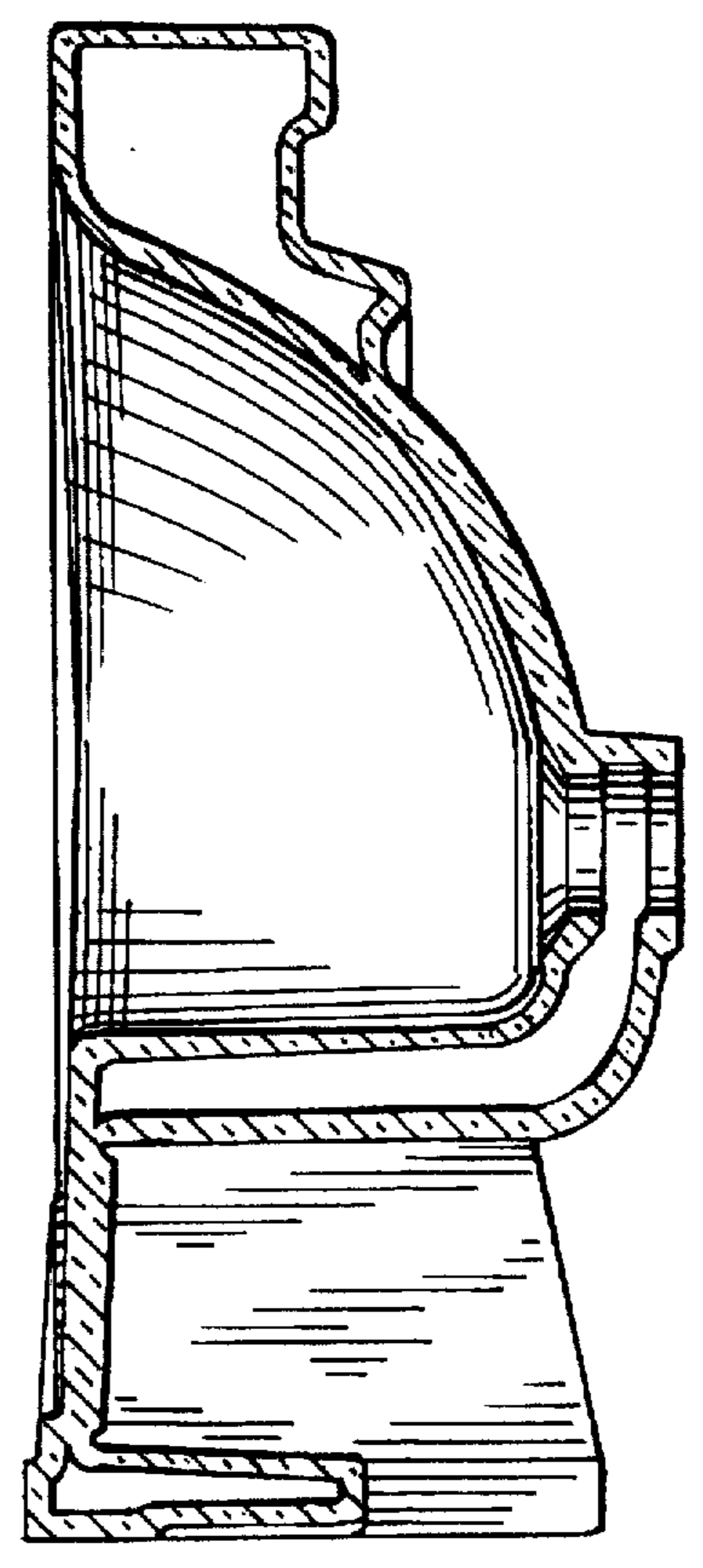

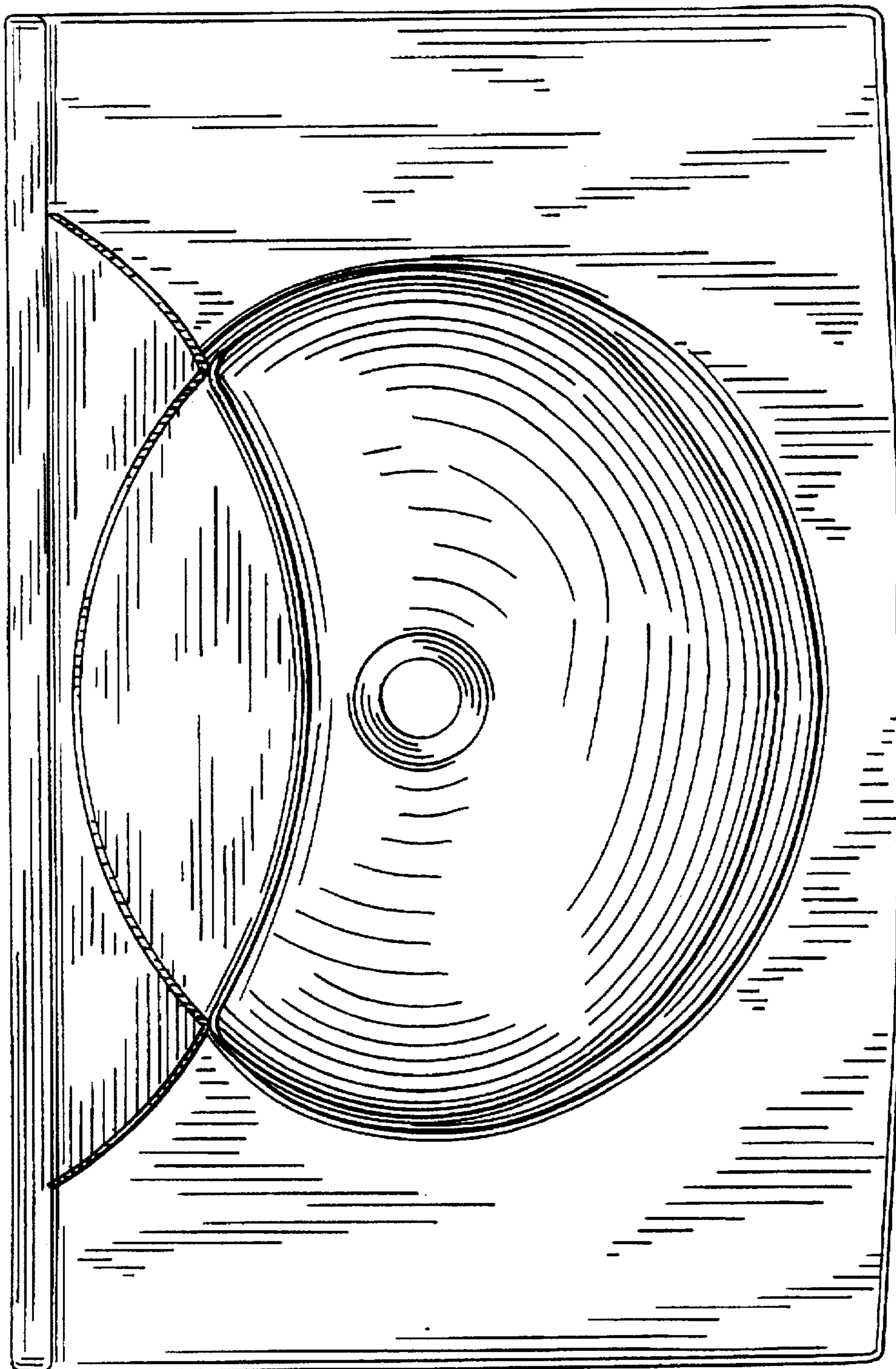

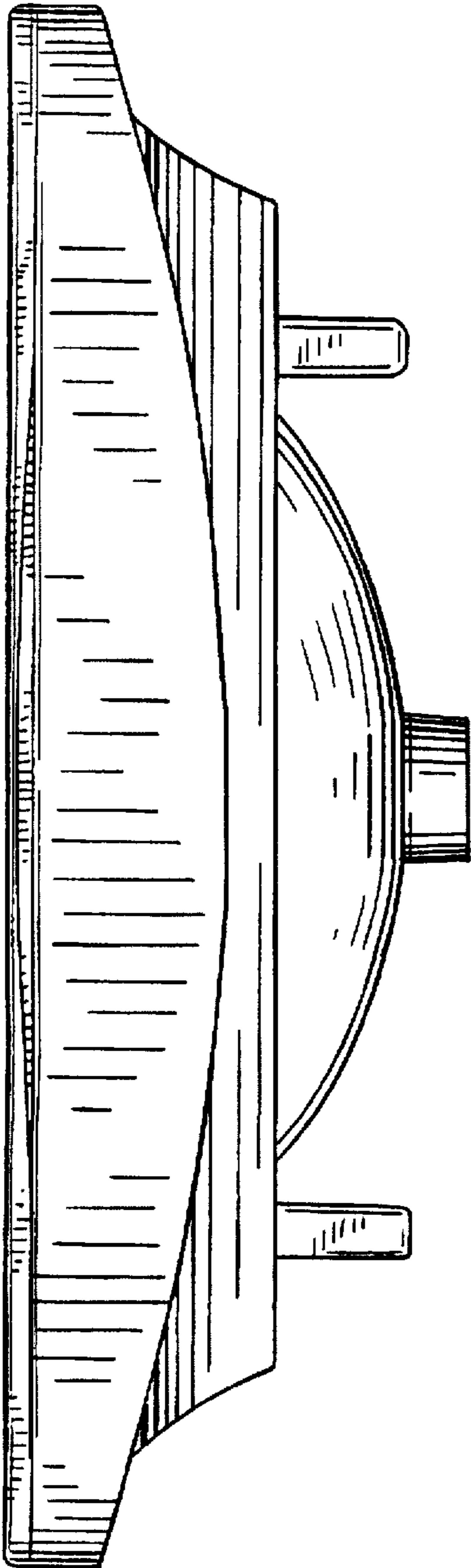
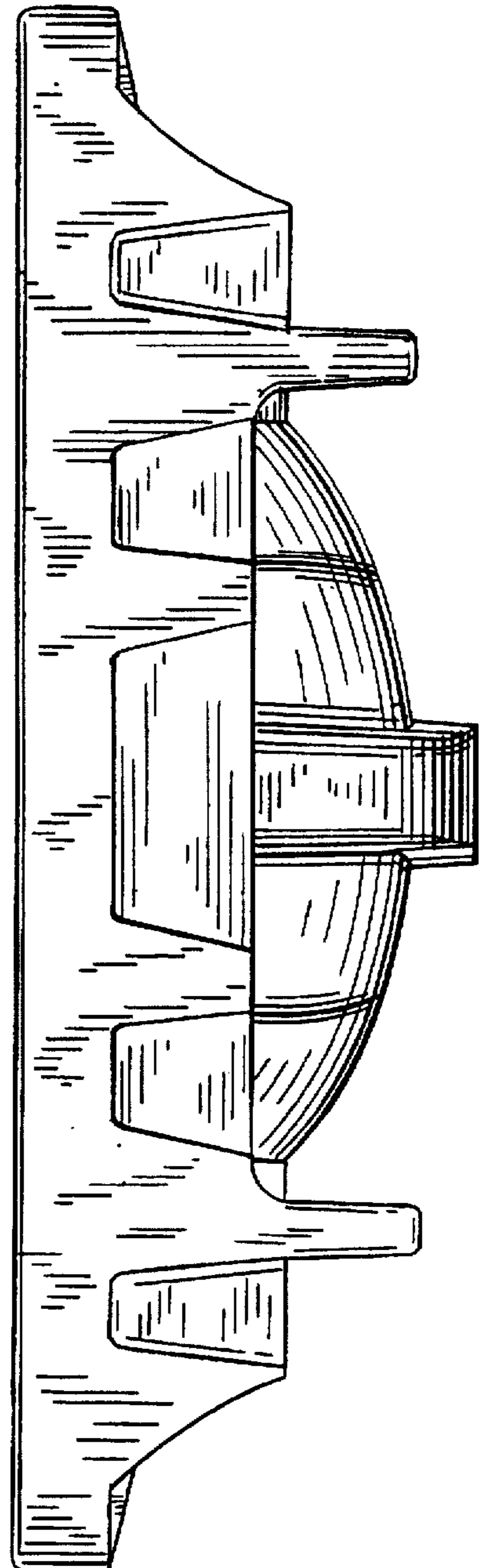

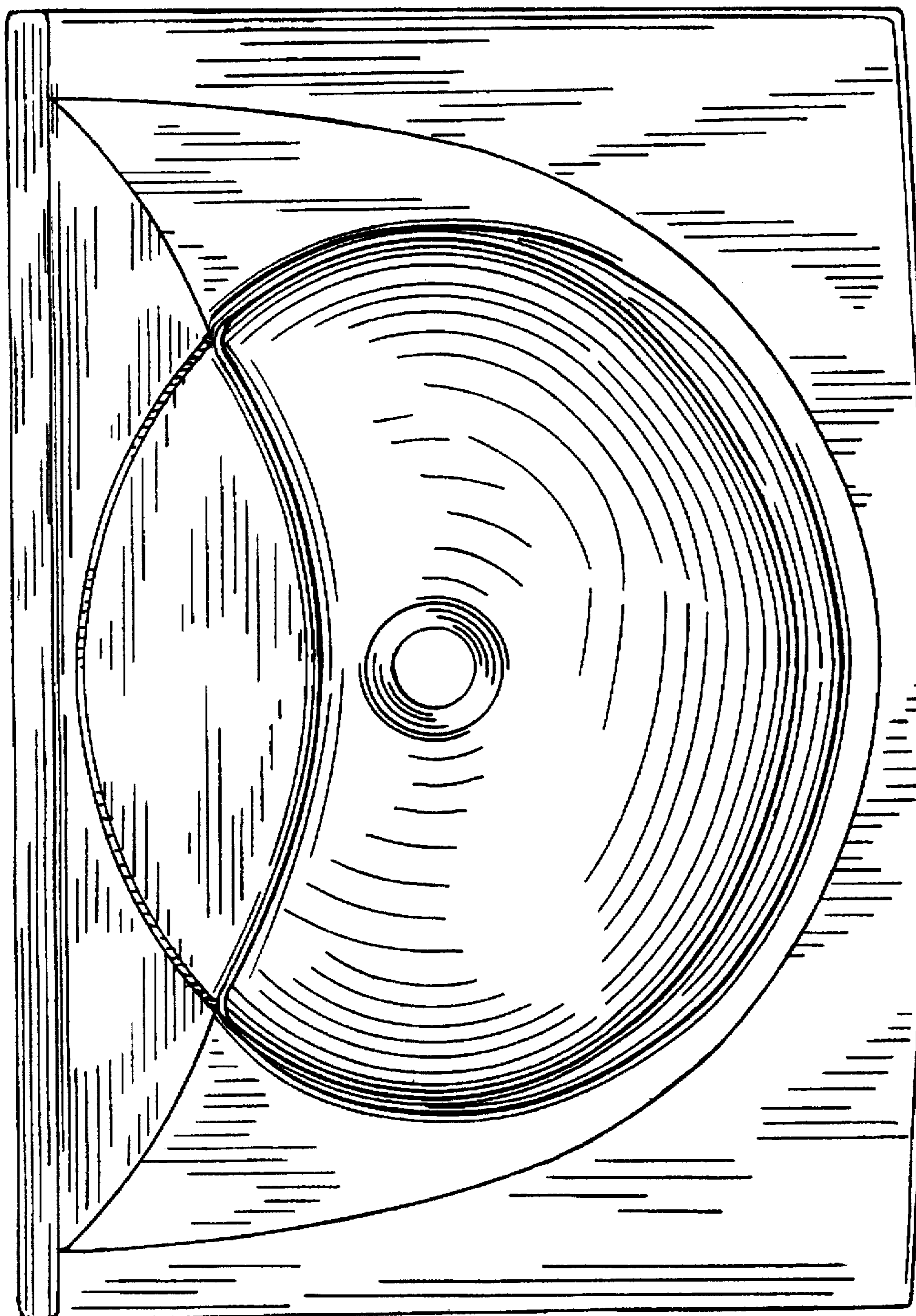
