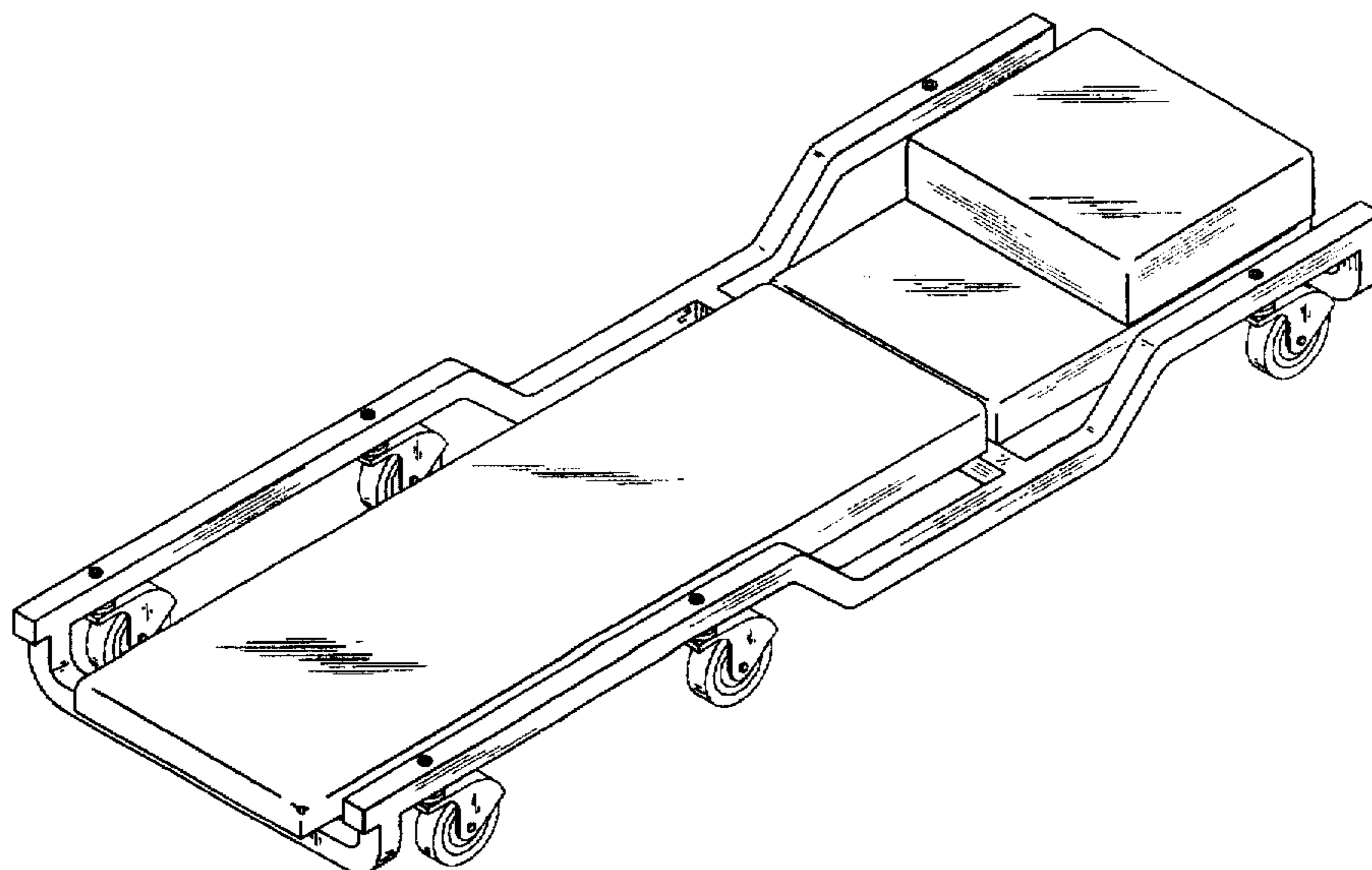
[57] CLAIM

The ornamental design for a drop shoulder creeper with T-bar support and tilting headrest, as shown and described.

DESCRIPTION

FIG. 1 is a front elevated view of the drop shoulder creeper with T-bar support and tilting headrest;
 FIG. 2 is a front view of the drop shoulder creeper with T-bar support and tilting headrest;
 FIG. 3 is a rear view of the drop shoulder creeper with T-bar support and tilting headrest;
 FIG. 4 is a side view of the drop shoulder creeper with T-bar support and tilting headrest;
 FIG. 5 is a mirror side view of the drop shoulder creeper with T-bar support and tilting headrest as shown in FIG. 4;
 FIG. 6 is a top view of the drop shoulder creeper with T-bar support and tilting headrest;
 FIG. 7 is a bottom view of the drop shoulder creeper with T-bar support and tilting headrest; and,
 FIG. 8 is a side view of the drop shoulder creeper with T-bar support and tilting headrest, illustrating the tilting headrest in a tilted position.

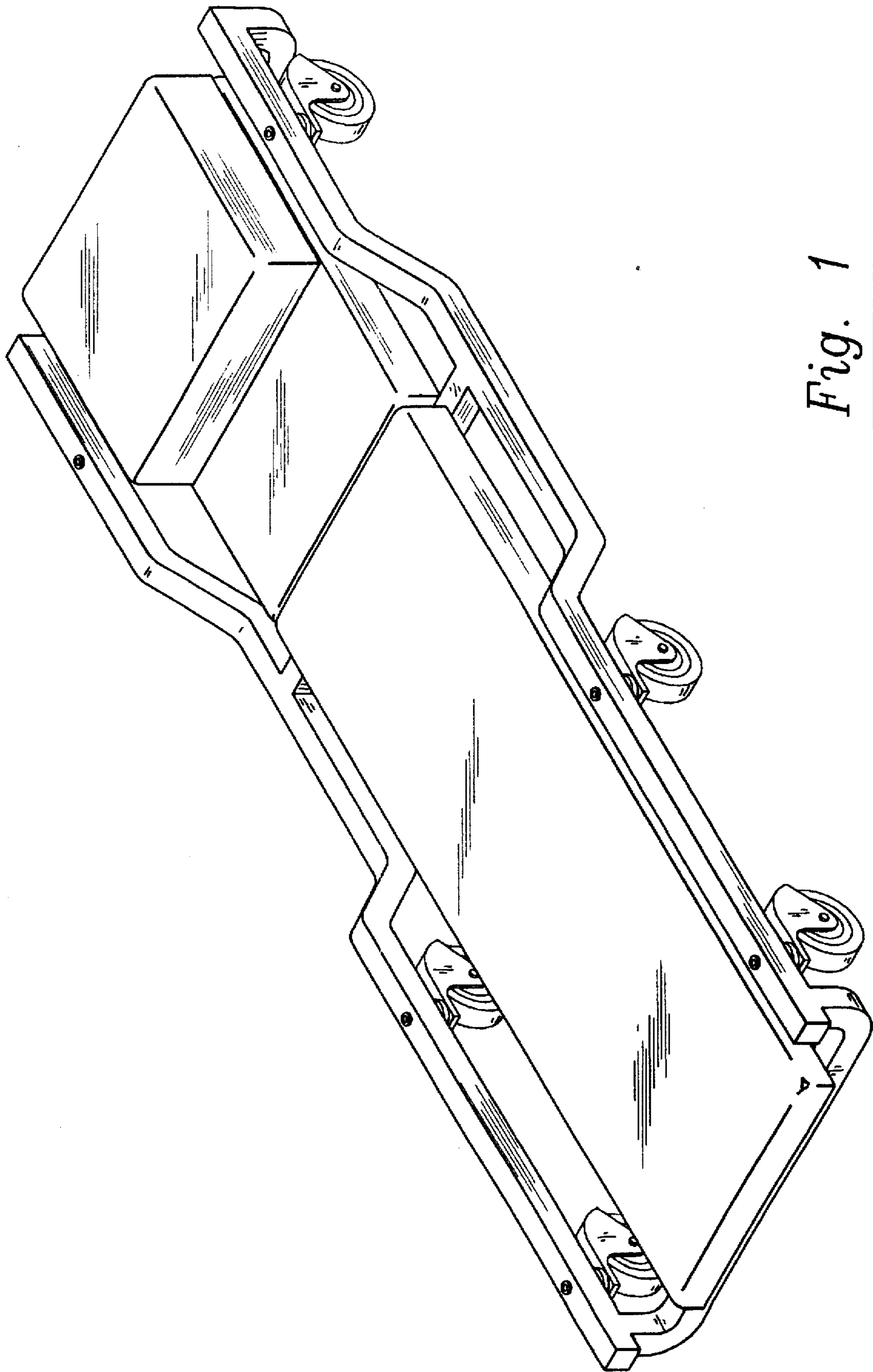

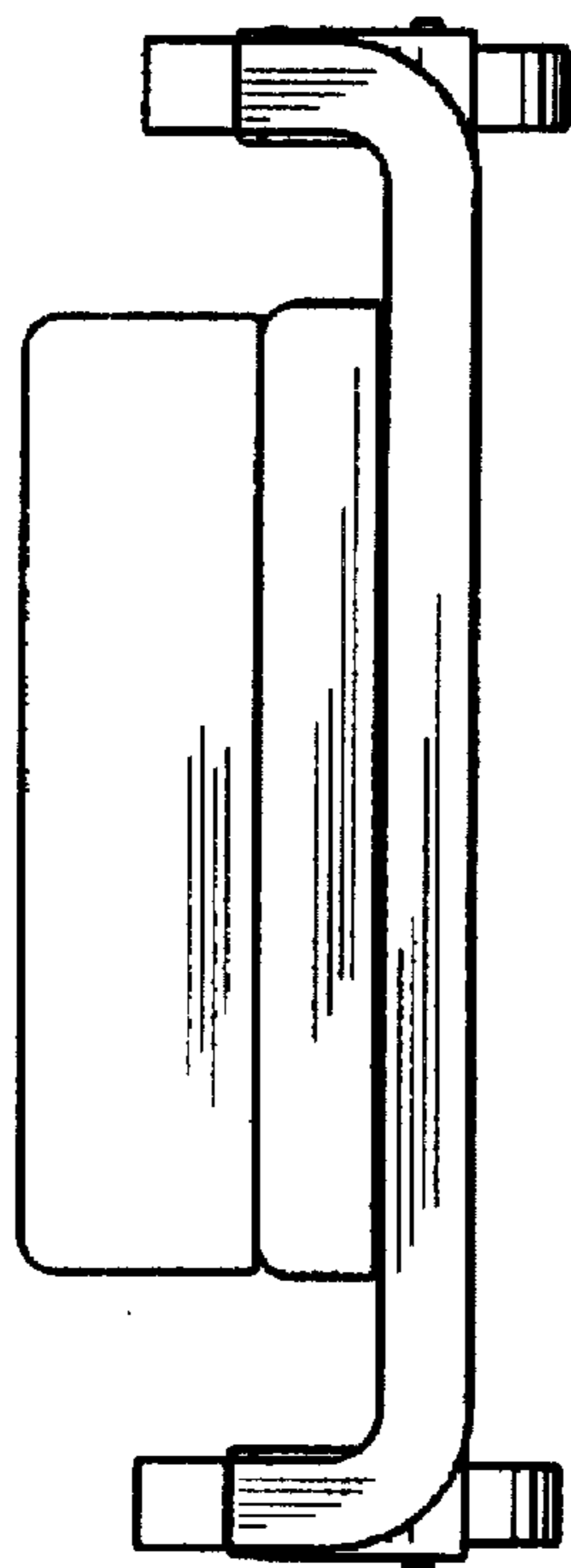

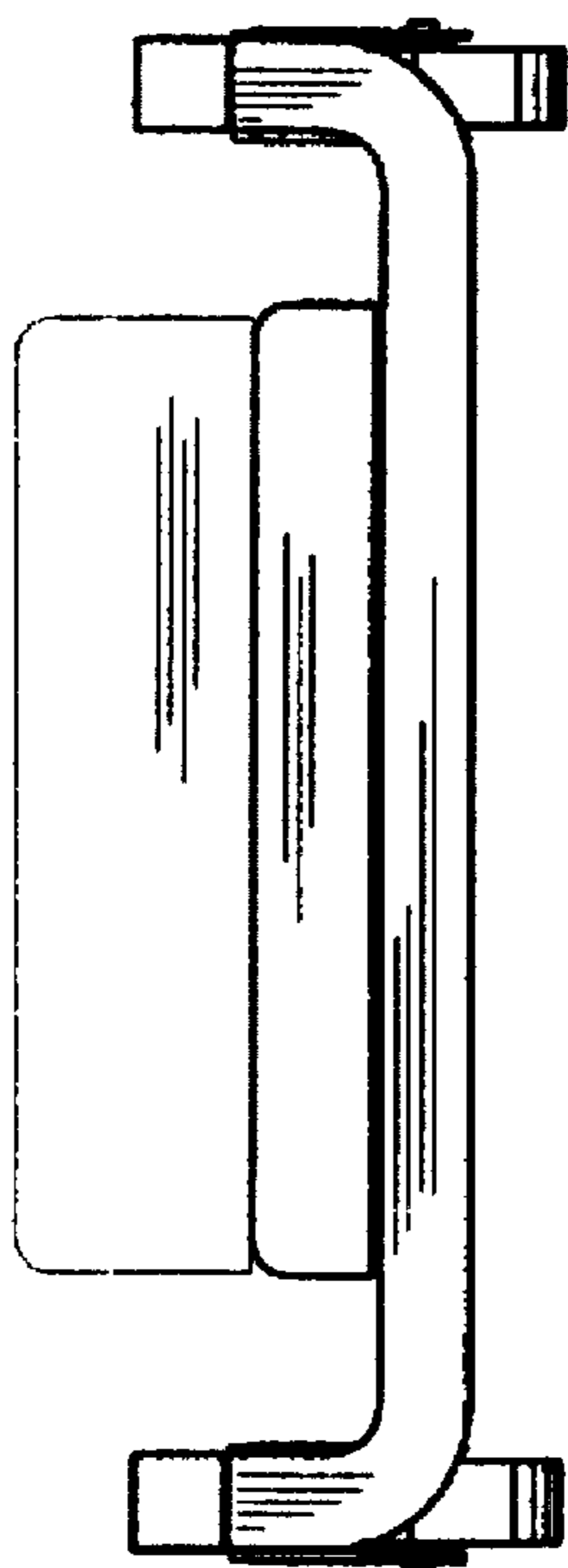

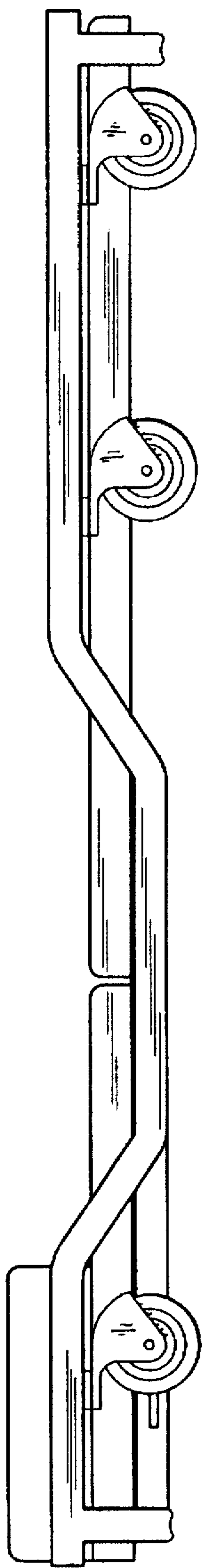

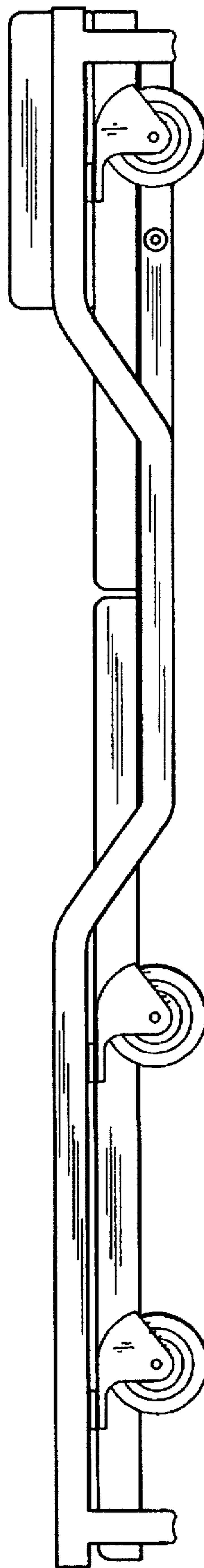

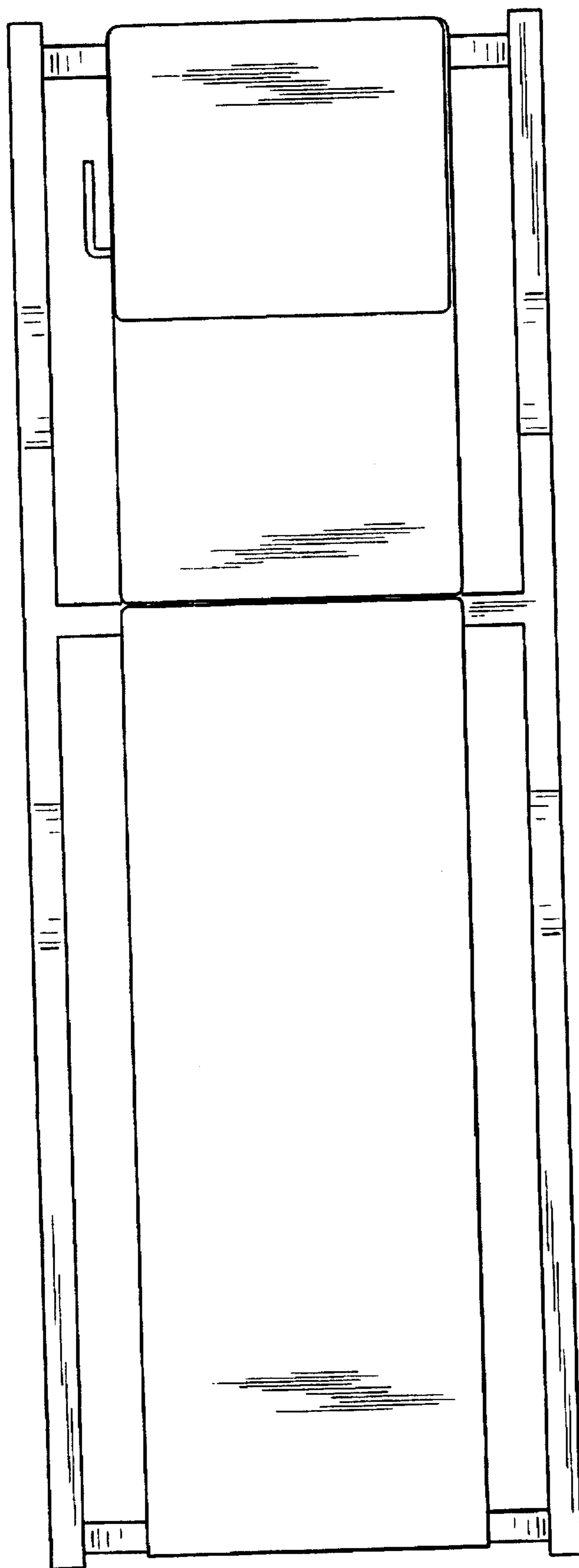

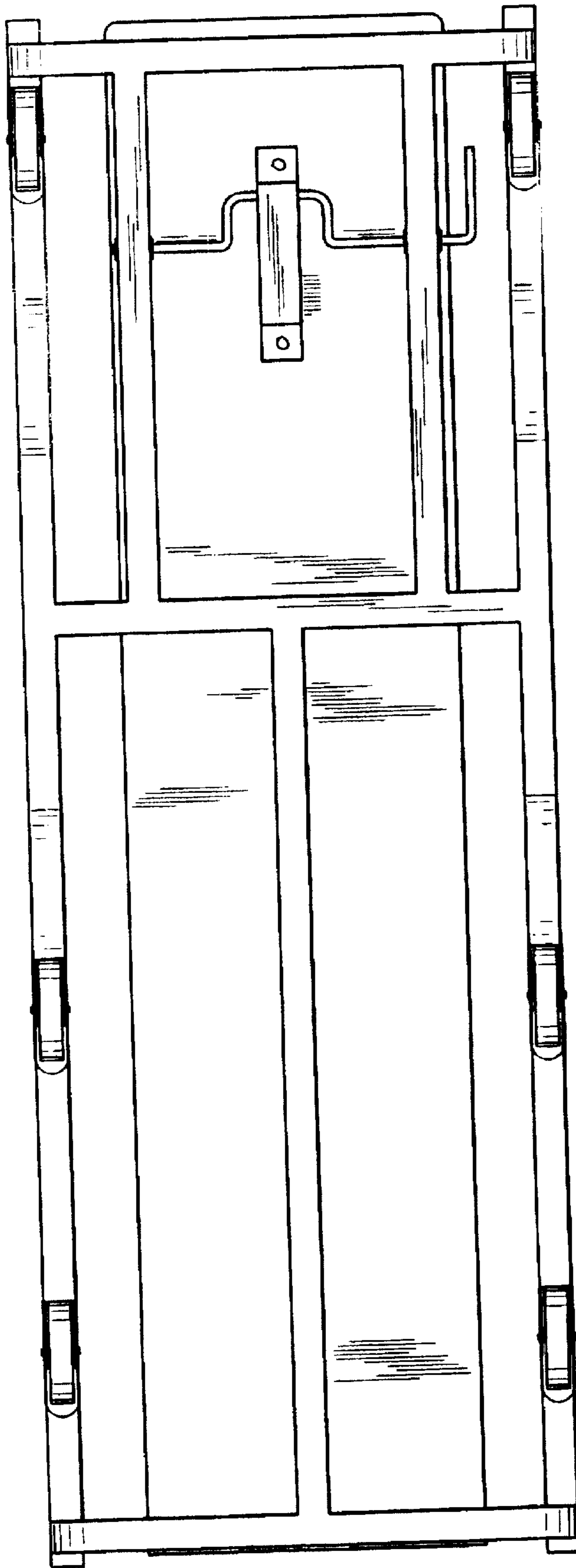

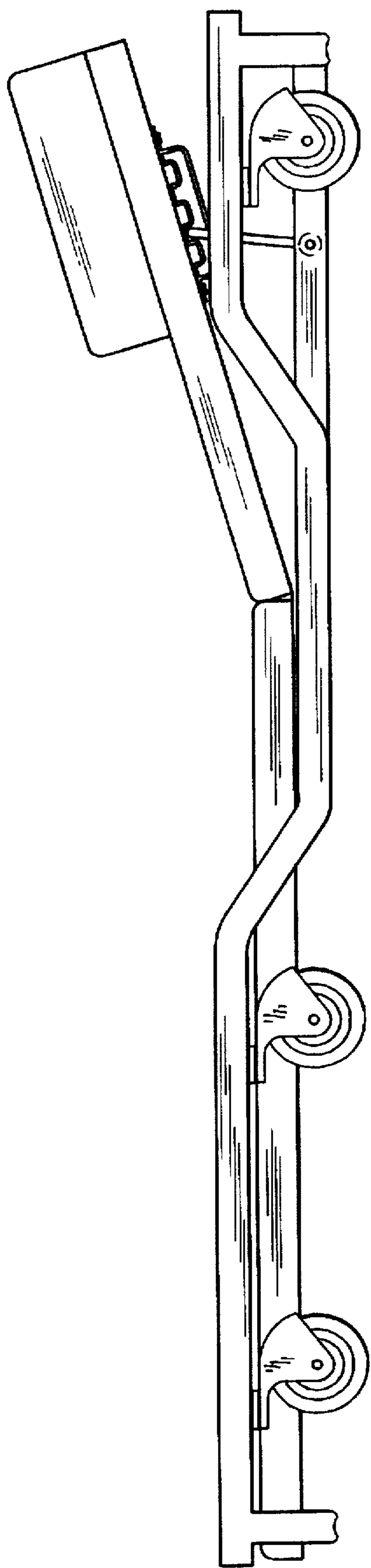
