[57] CLAIM

The ornamental design for conveyor track, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a conveyor track showing our new design. The rear elevational view of FIG. 1 is identical to FIG. 1;

FIG. 2 is a left side elevational view of FIG. 1. The right side elevational view of FIG. 1 is identical to FIG. 2;

FIG. 3 is a top plan view of FIG. 1;

FIG. 4 is a bottom plan view of FIG. 1;

FIG. 5 is a front elevational view of a conveyor track showing our new design. The rear elevational view of FIG. 5 is identical to FIG. 5. The top plan view of FIG. 5 is identical to FIG. 3. The bottom plan view of FIG. 5 is identical to FIG. 4; and,

FIG. 6 is a left side elevational view of FIG. 5. The right side elevational view of FIG. 5 is identical to FIG. 6.

The conveyor track is shown broken away in FIGS. 2, 3, 4, and 6 to represent a continuation of the design uniformly along any length.

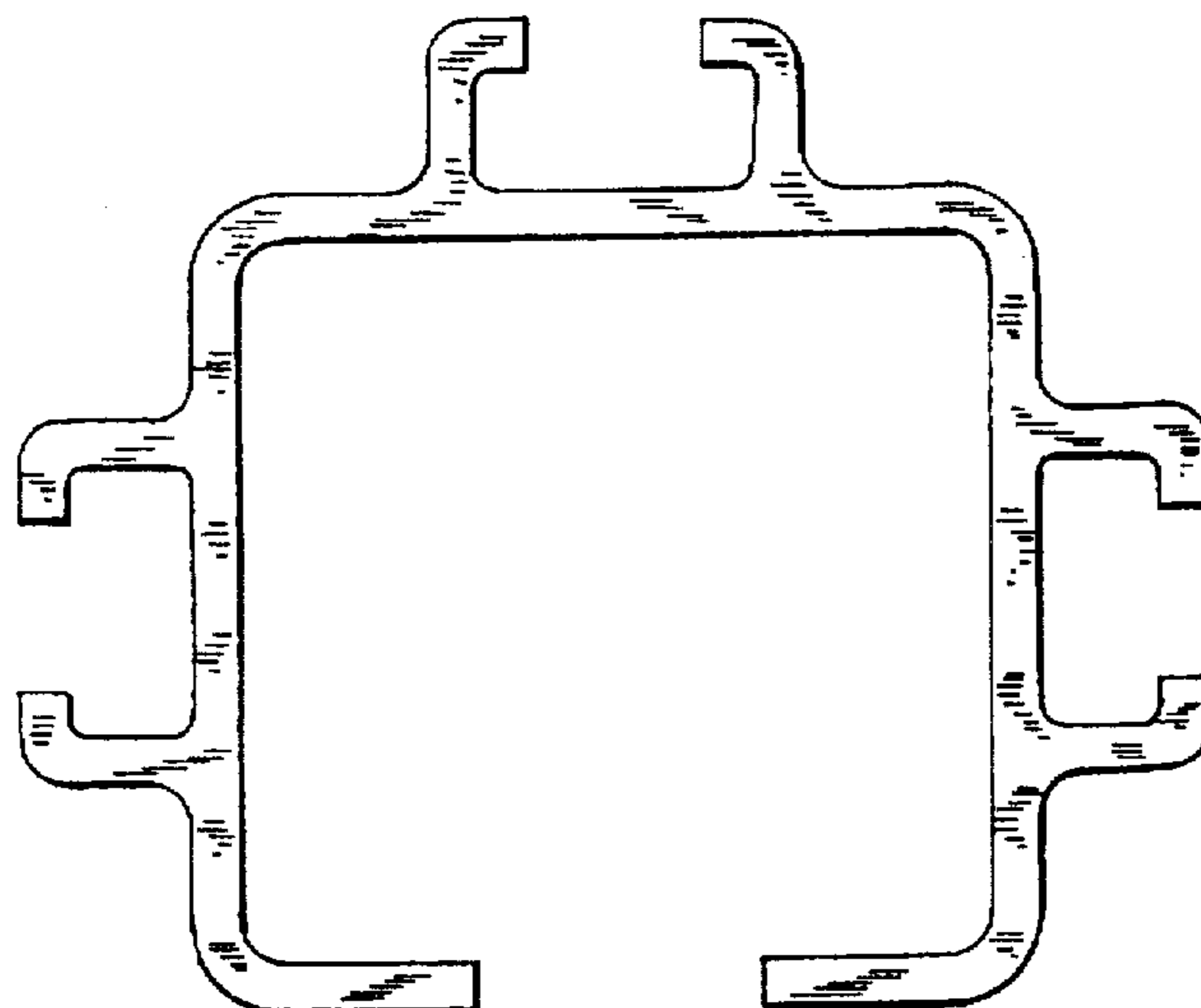

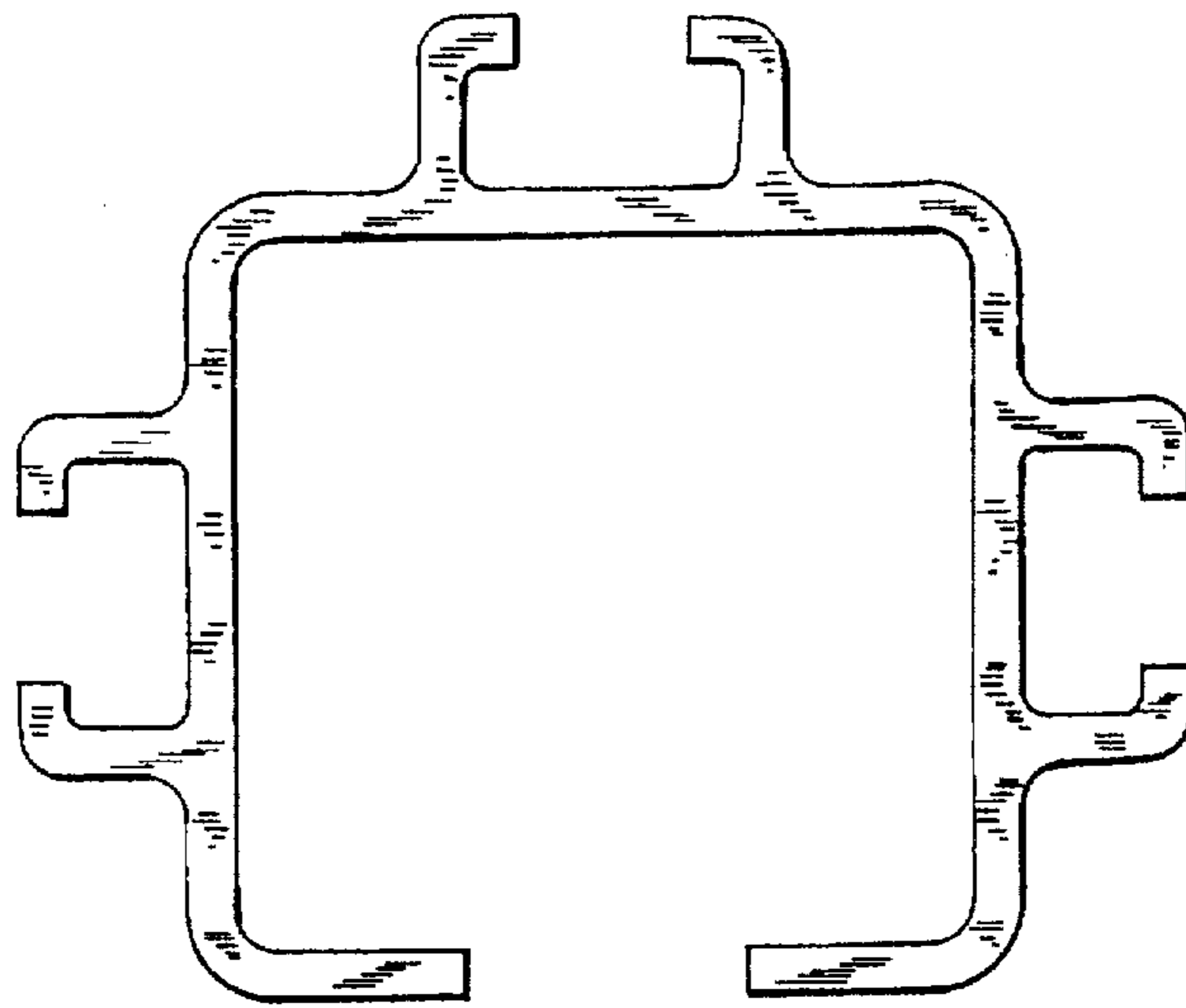

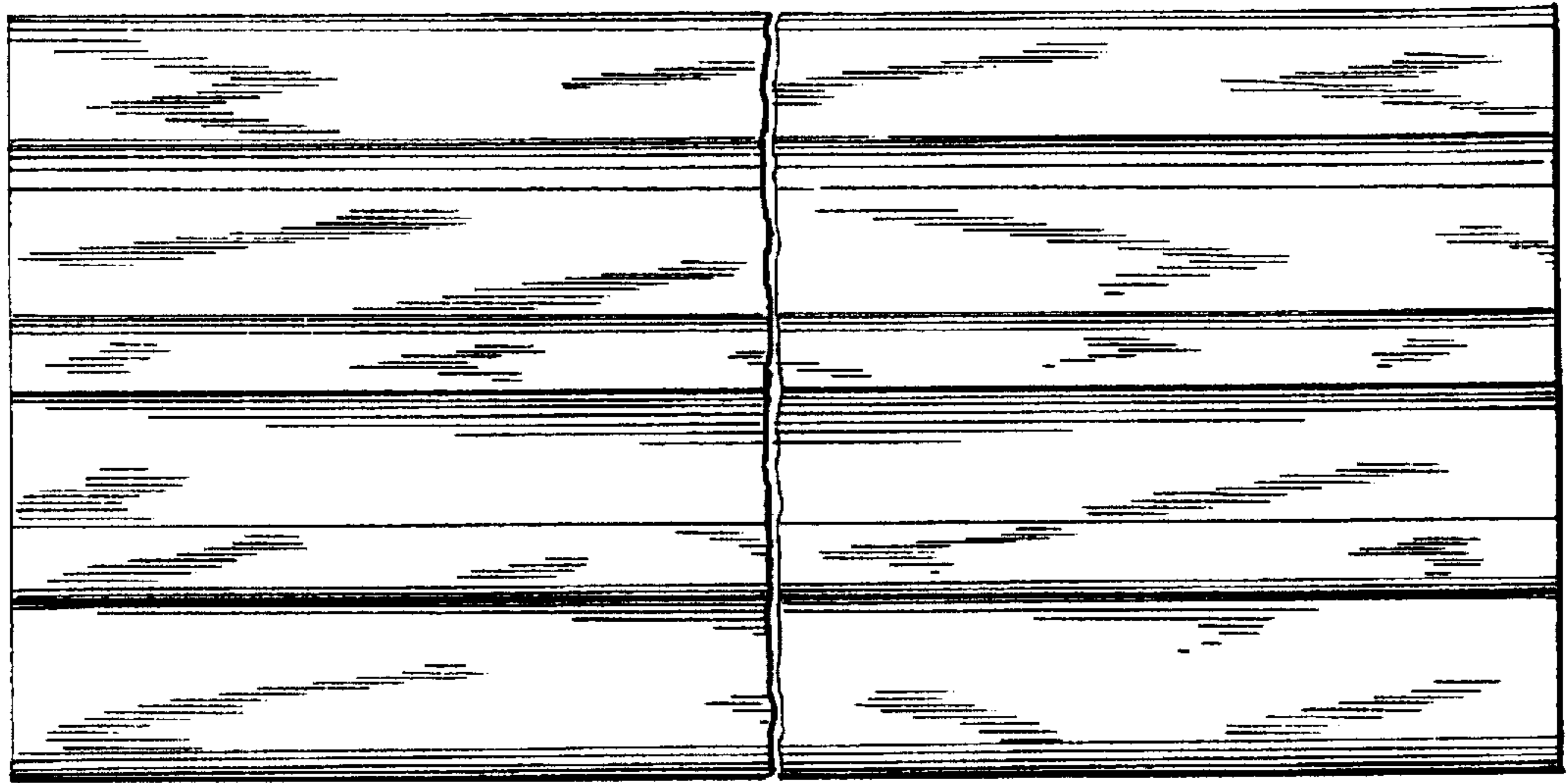

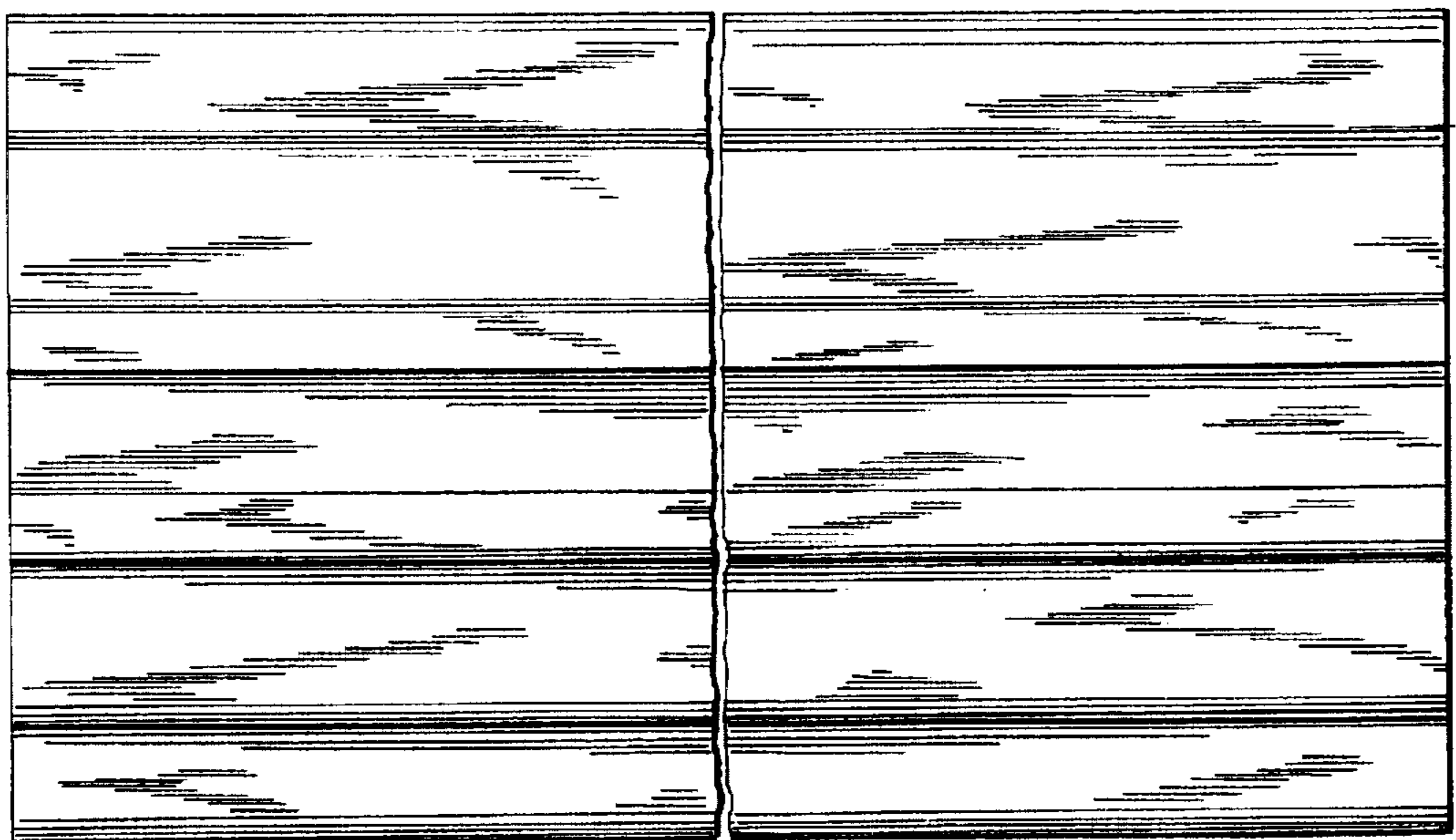

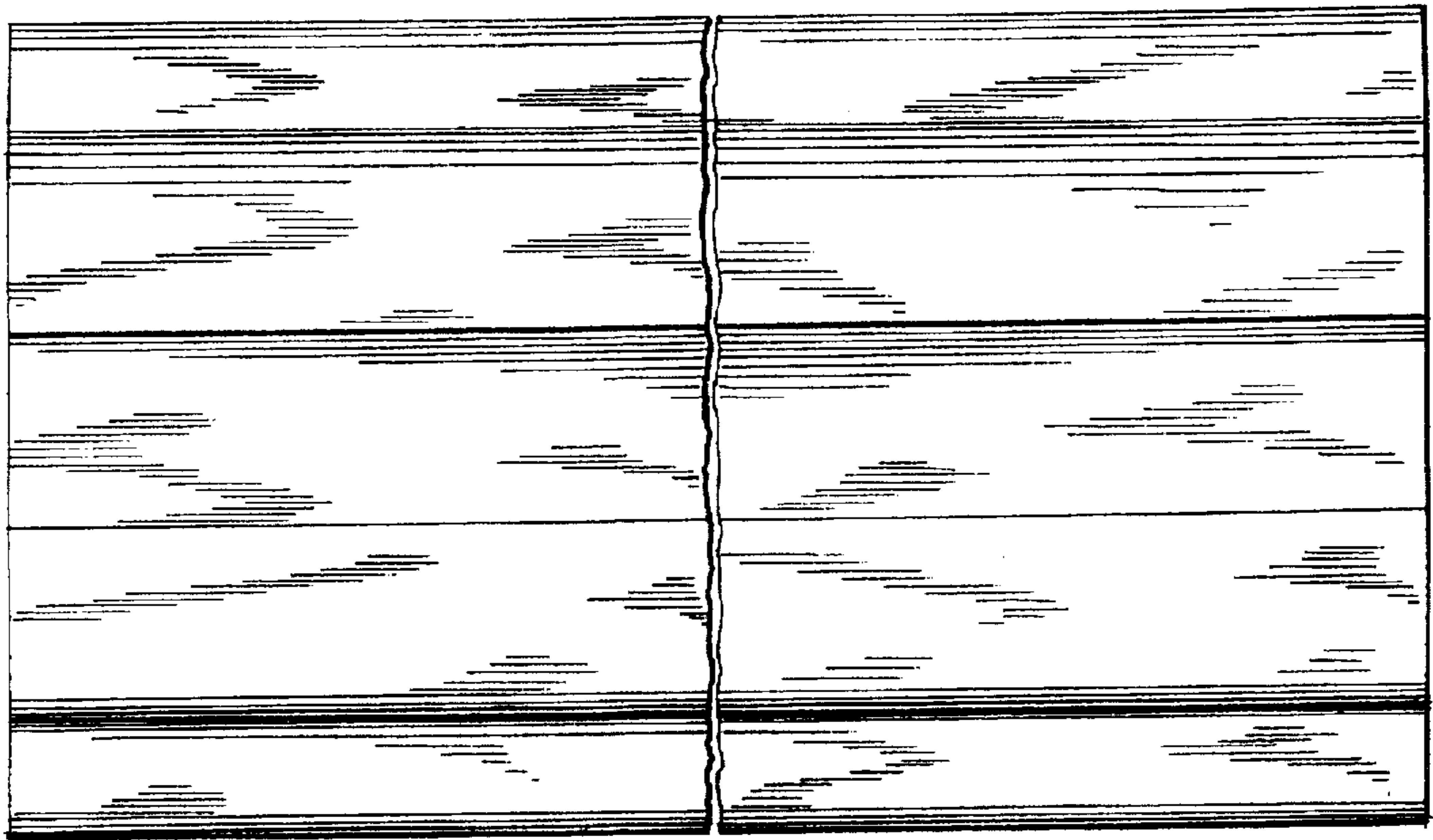

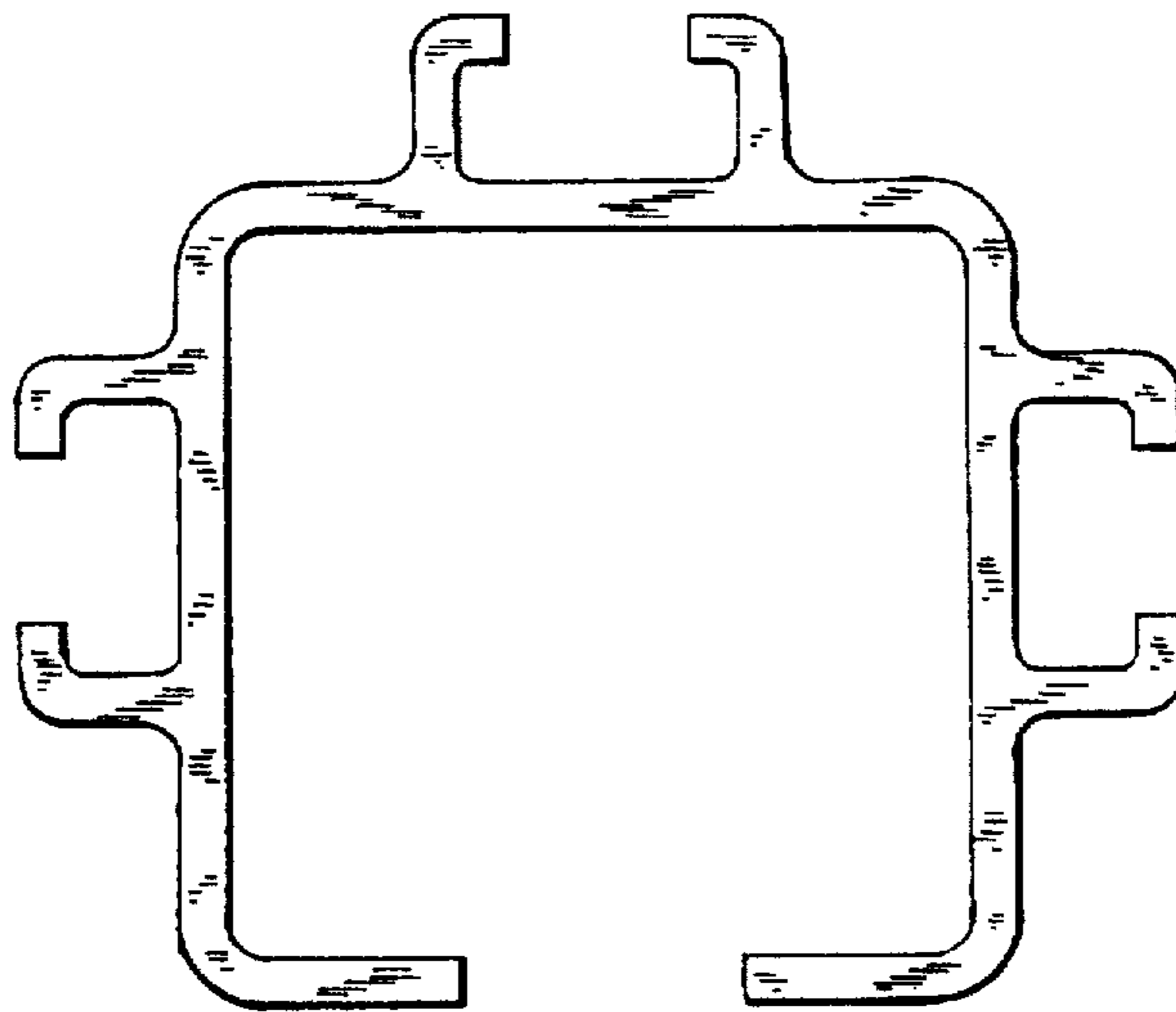
