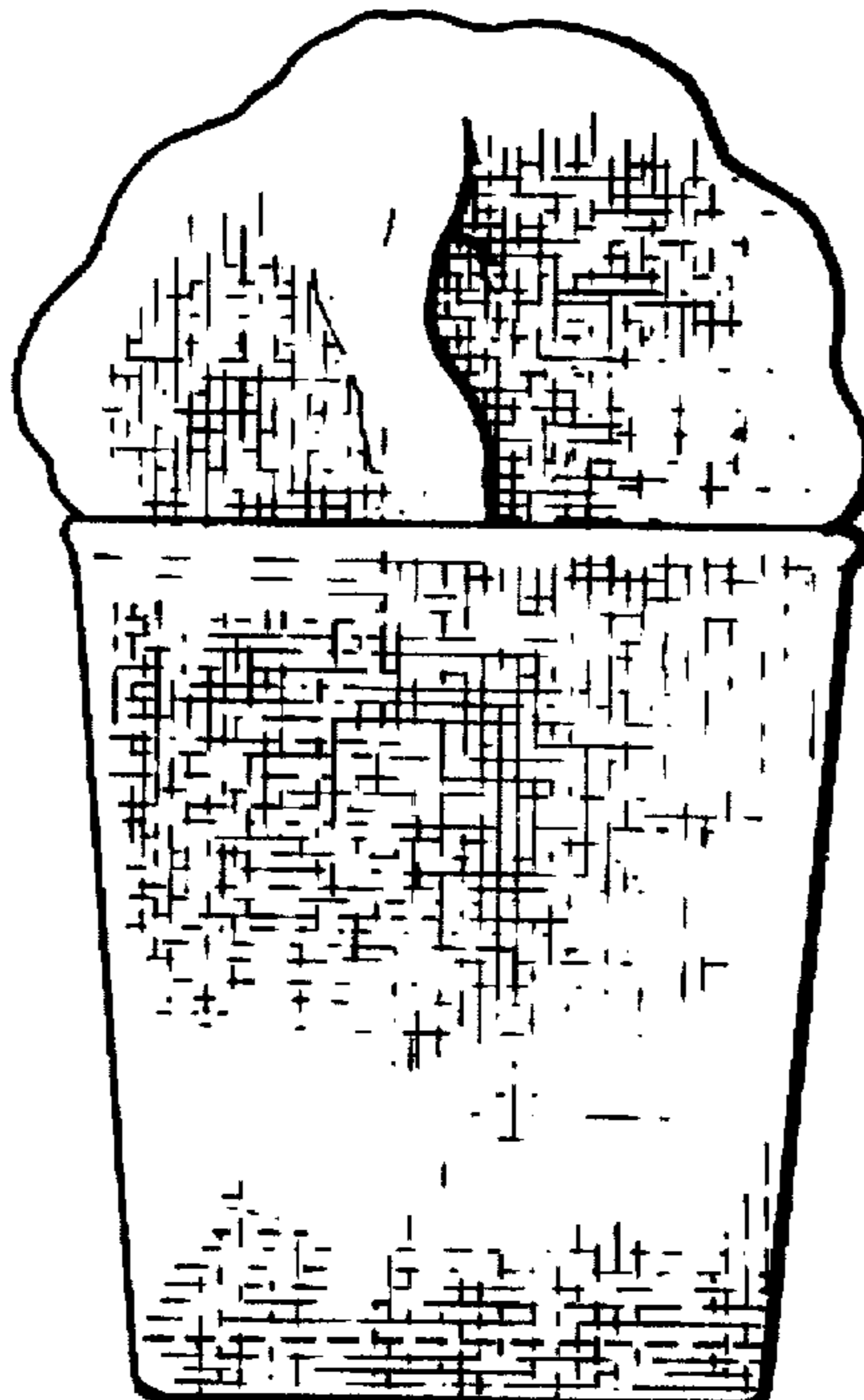
[57] **CLAIM**

The ornamental design for a pocket handkerchief, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a pocket handkerchief showing my new design;
 FIG. 2 is a side elevational view thereof;
 FIG. 3 is an opposite side elevational view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a rear elevational view thereof; and
 FIG. 7 is a front elevational view of a second embodiment of a pocket handkerchief showing my new design the opposite side is a mirror image;
 FIG. 8 is a front elevational view of a third embodiment of a pocket handkerchief showing my new design the opposite side is a mirror image;
 FIG. 9 is a front elevational view of a fourth embodiment of a pocket handkerchief showing my new design the opposite side is a mirror image;
 FIG. 10 is a front elevational view of a fifth embodiment of a pocket handkerchief showing my new design, the opposite side is a mirror image;
 FIG. 11 is a front elevational view of a sixth embodiment of a pocket handkerchief showing my new design, the opposite side is a mirror image;
 FIG. 12 is a front elevational view of a seventh embodiment of a pocket handkerchief showing my new design, the opposite side is a mirror image; and
 FIG. 13 is a front elevational view of an eighth embodiment of a pocket handkerchief showing my new design, the opposite side is a mirror image.

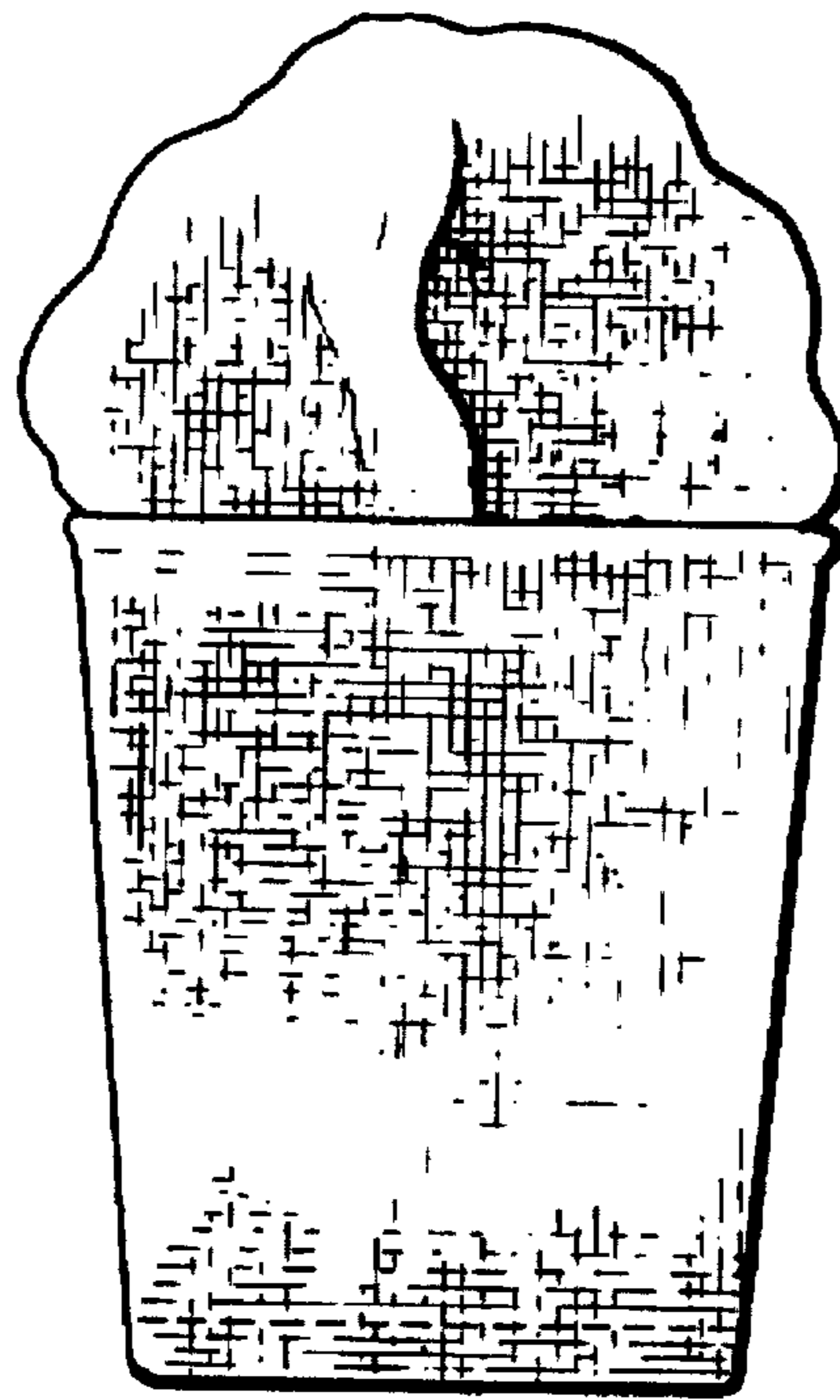

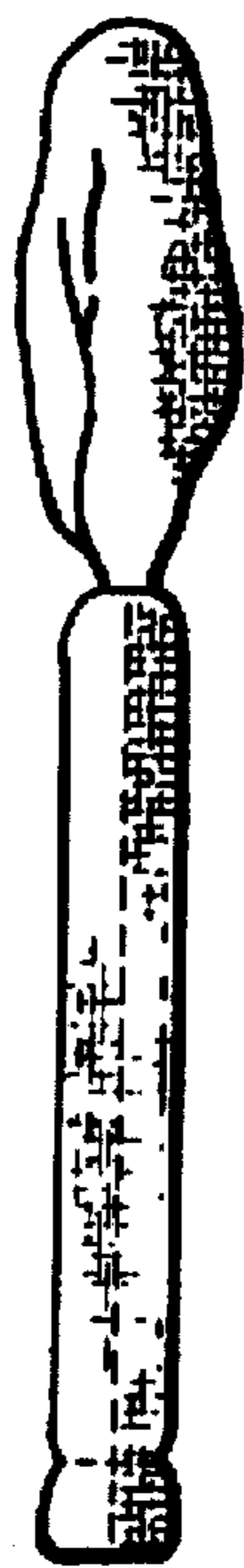

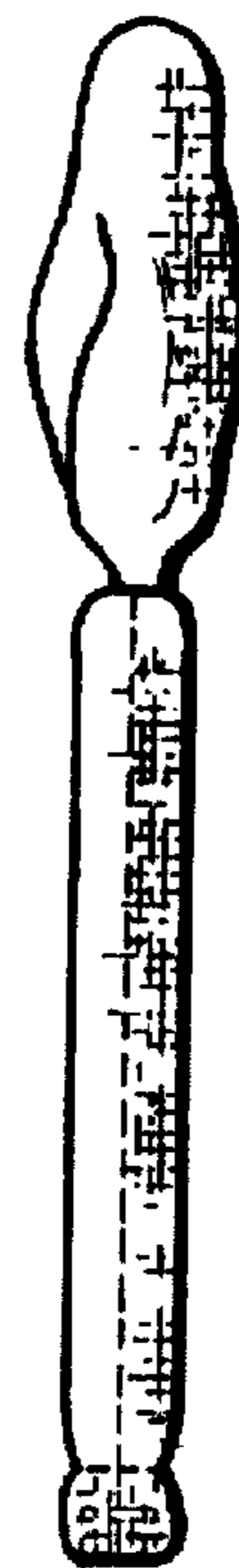

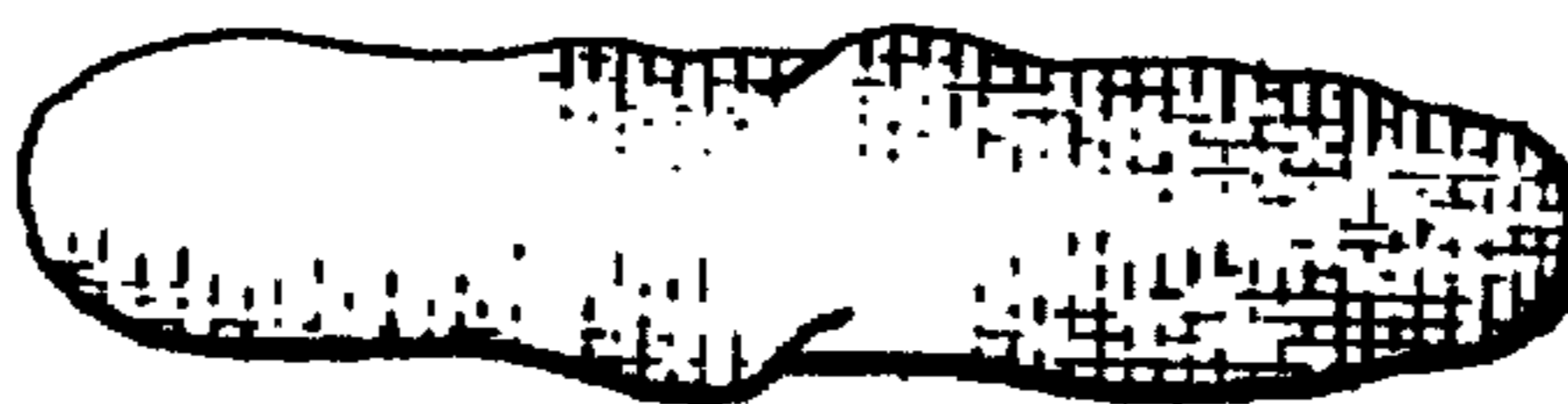

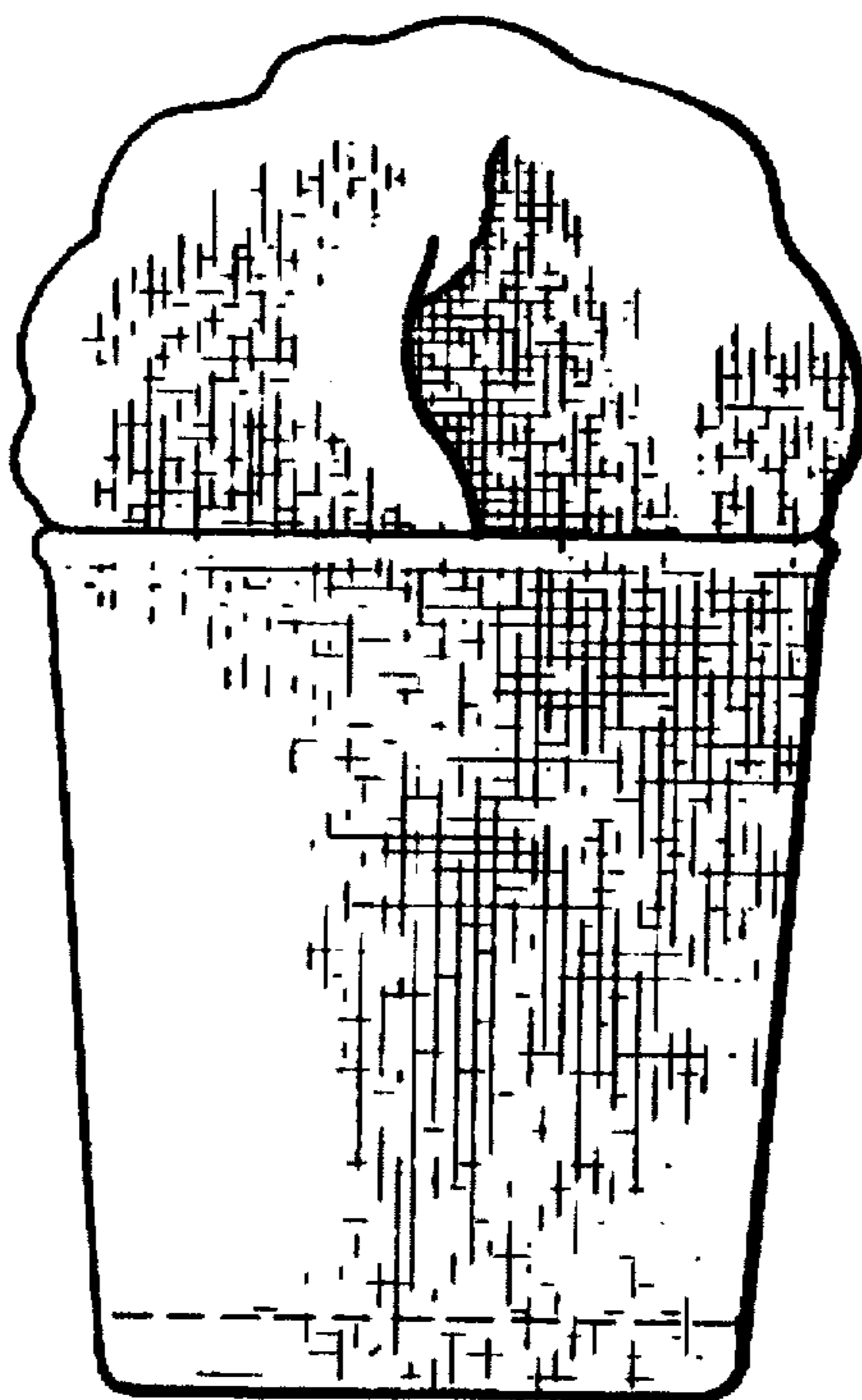

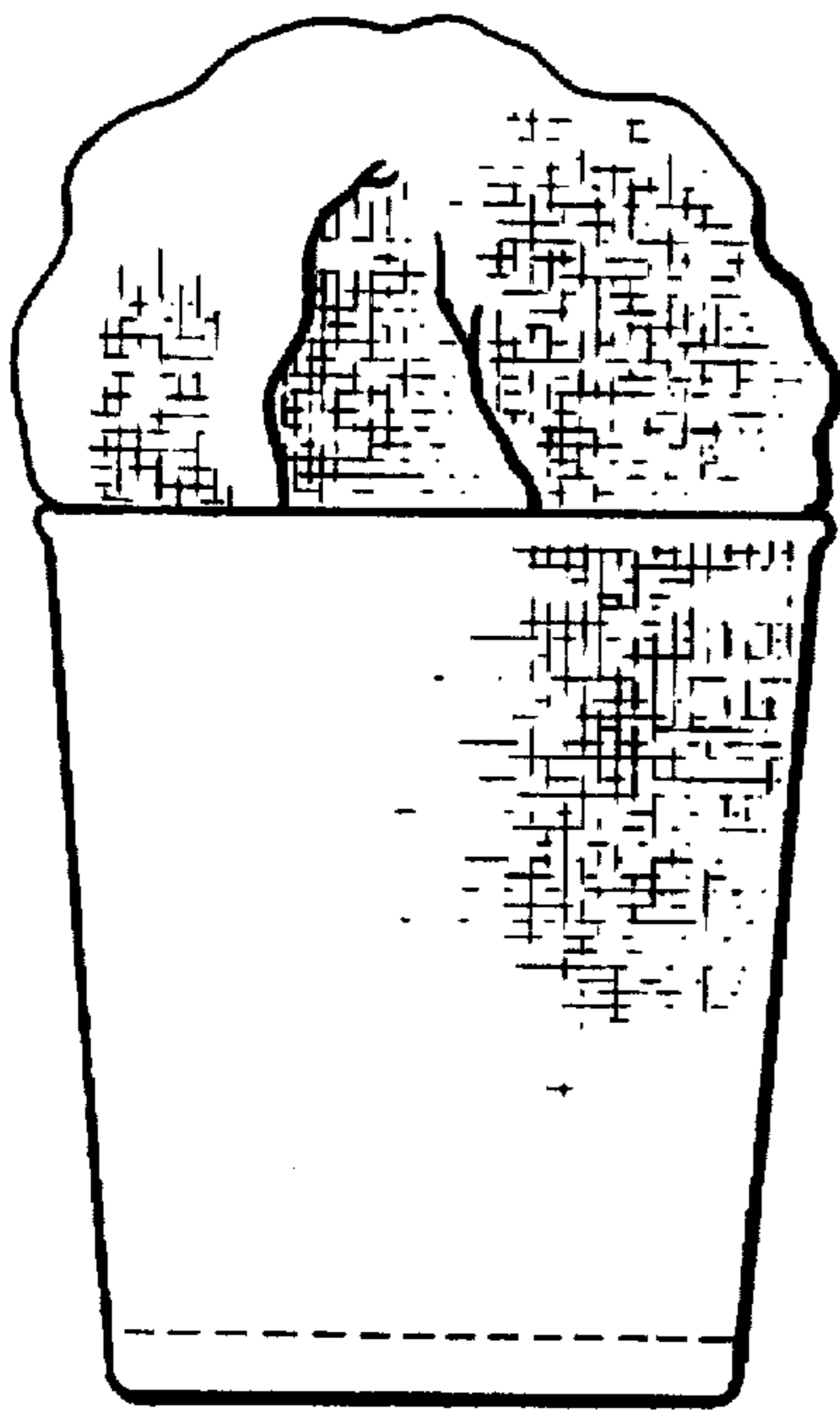

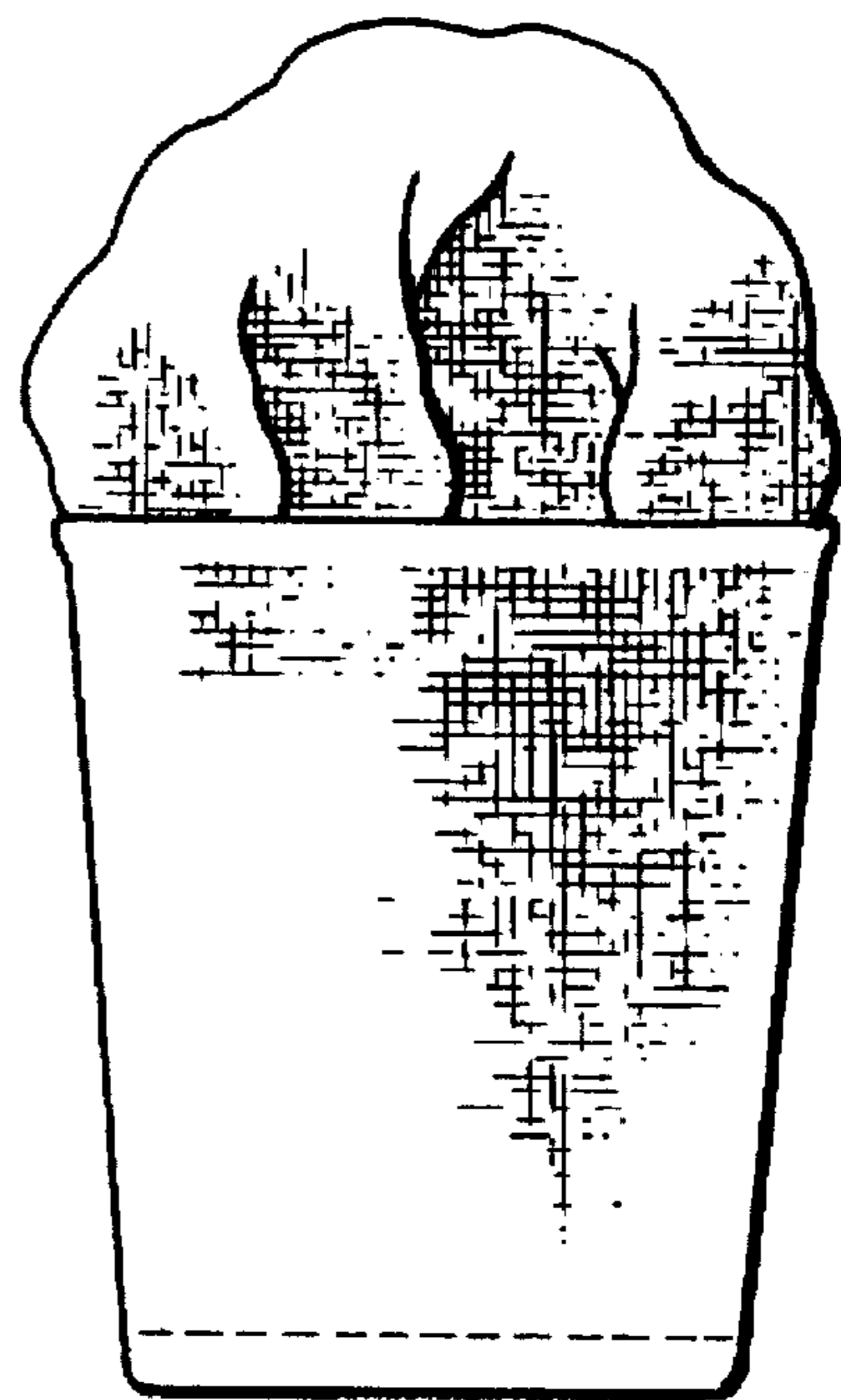

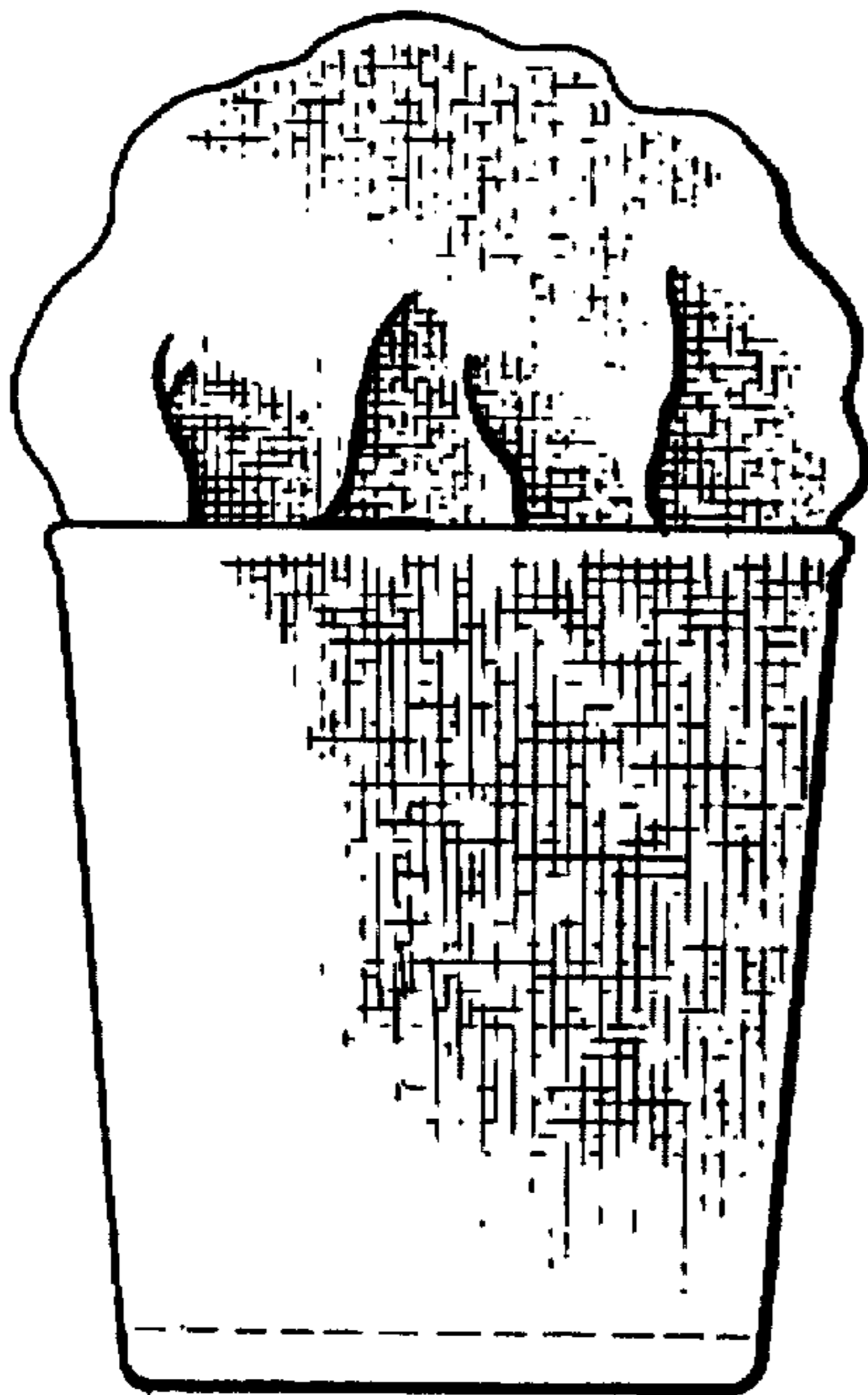

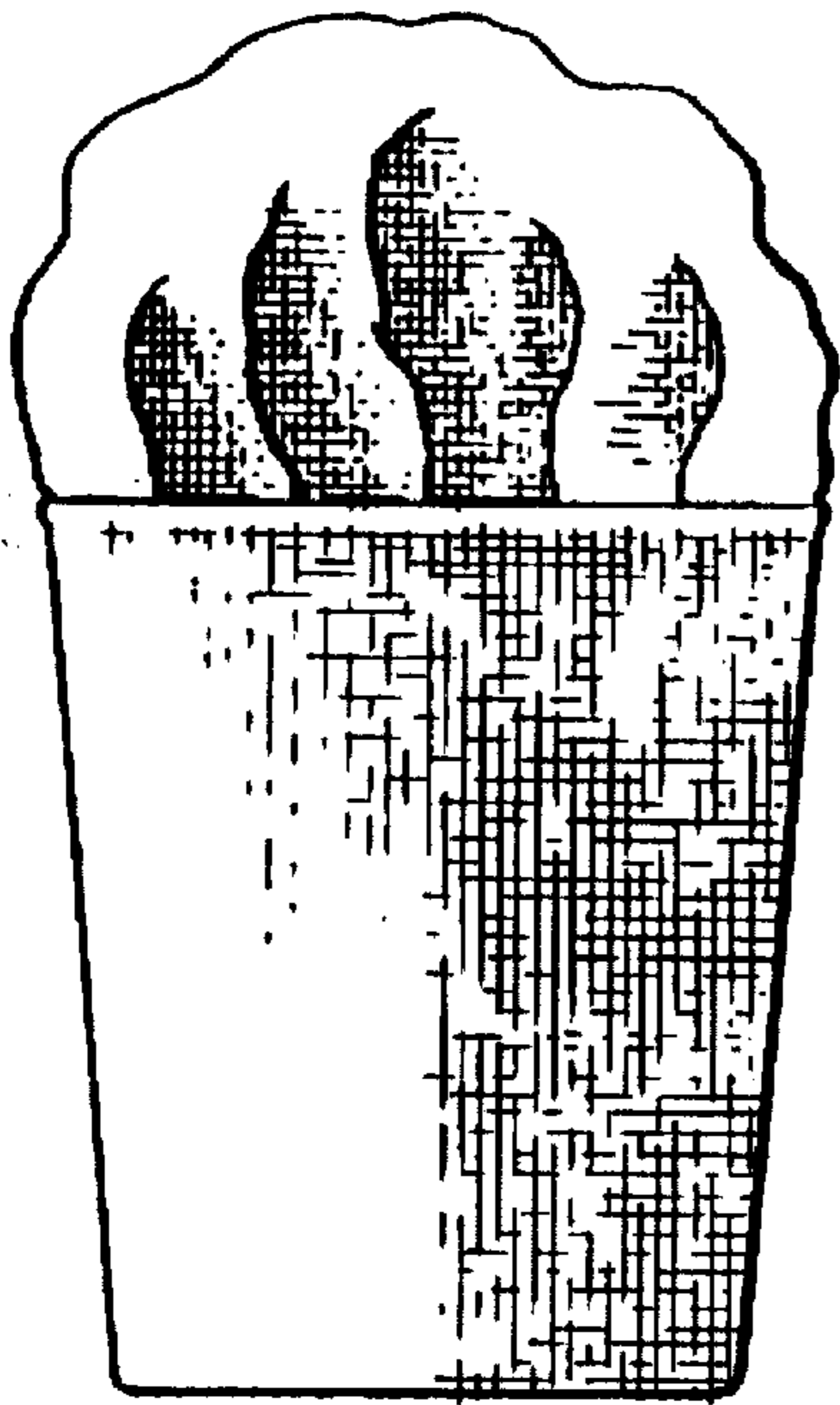

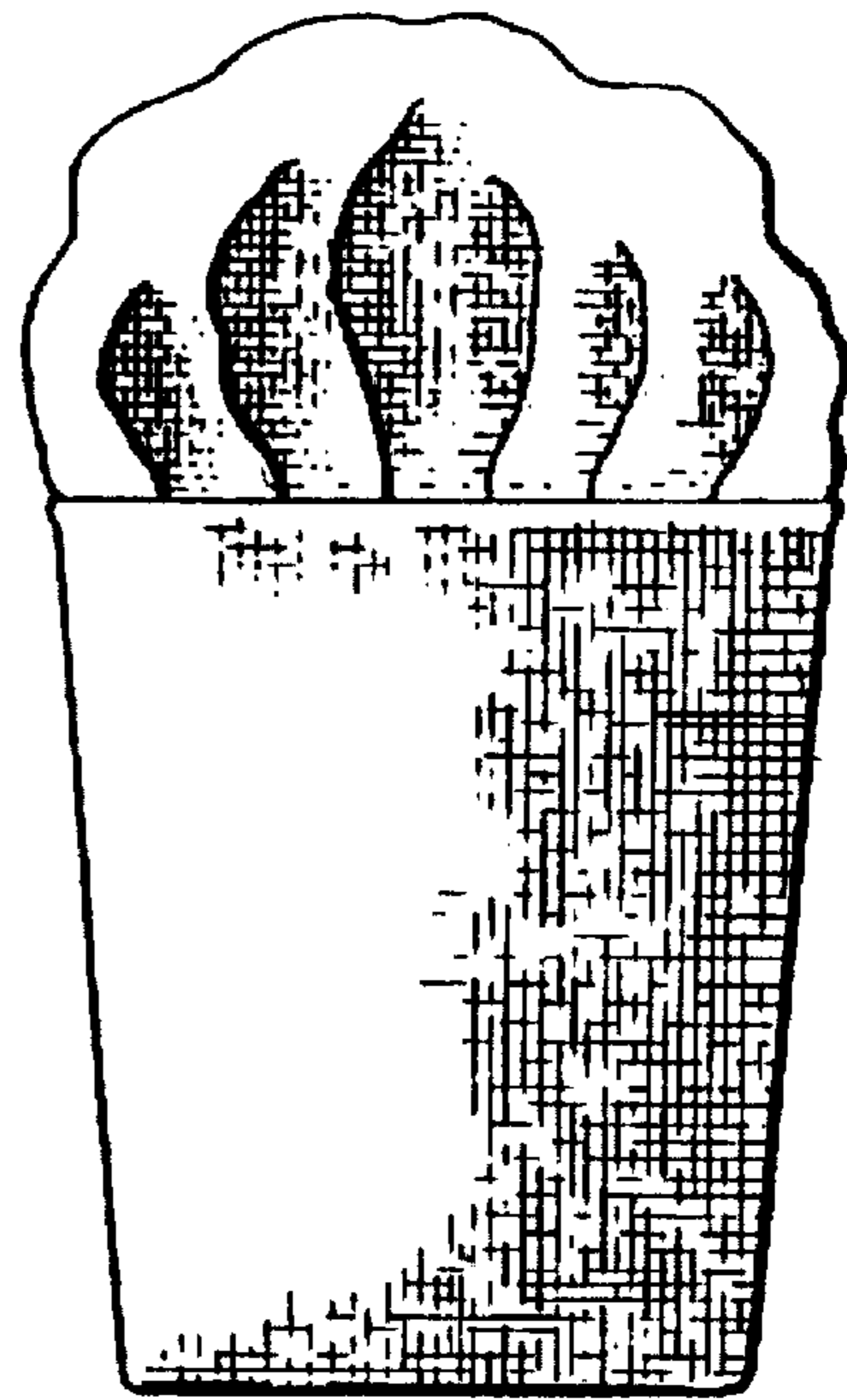

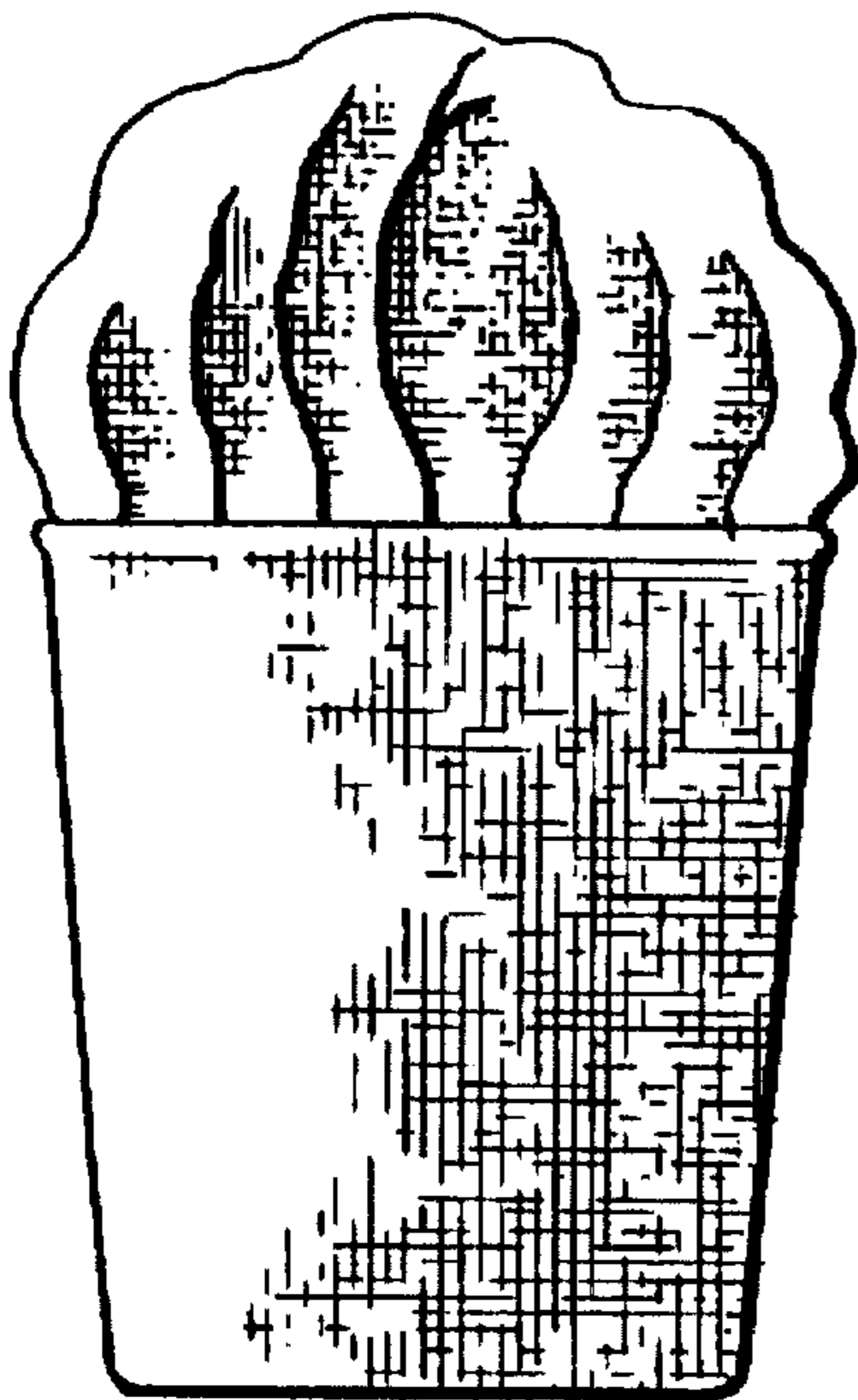

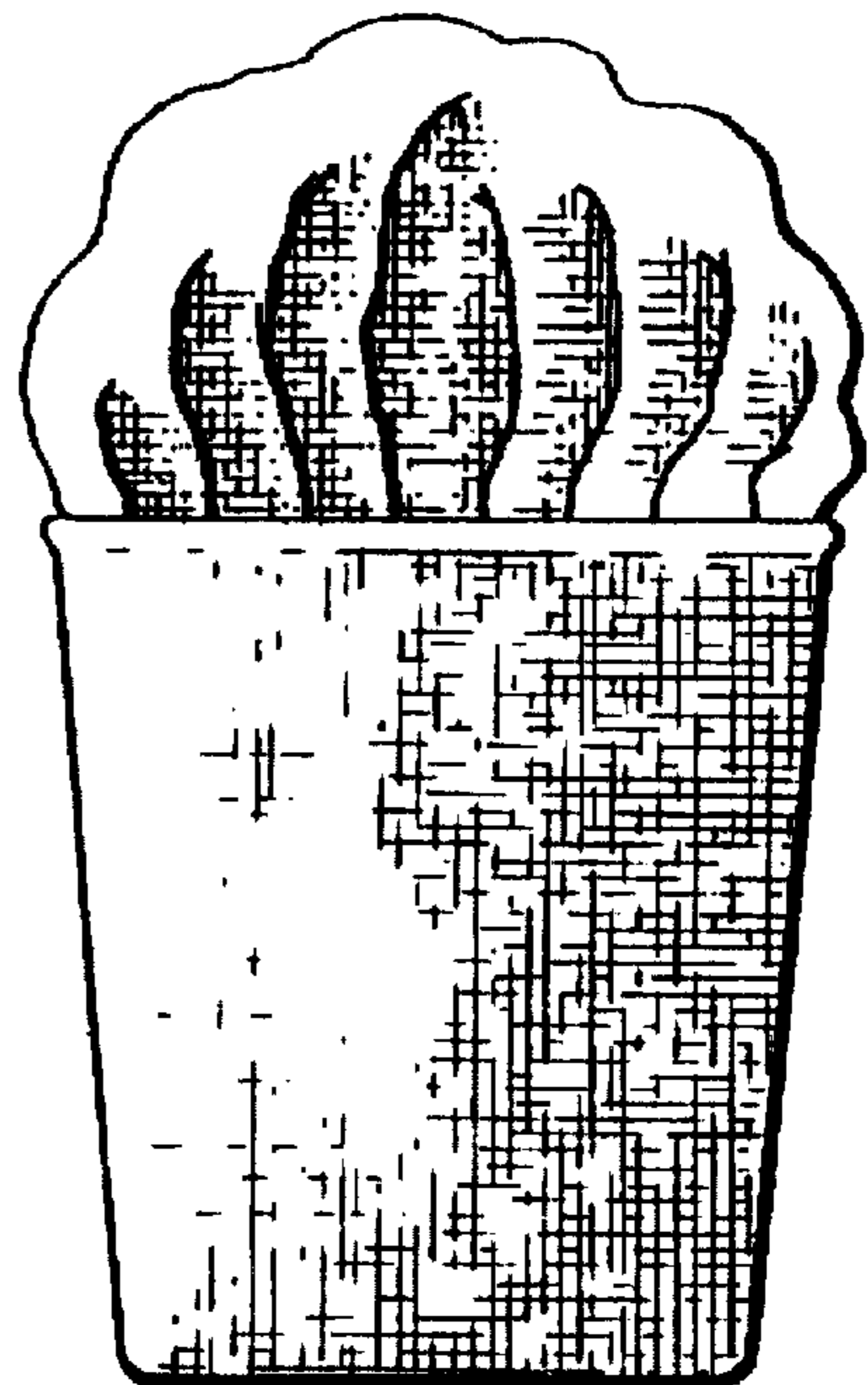
