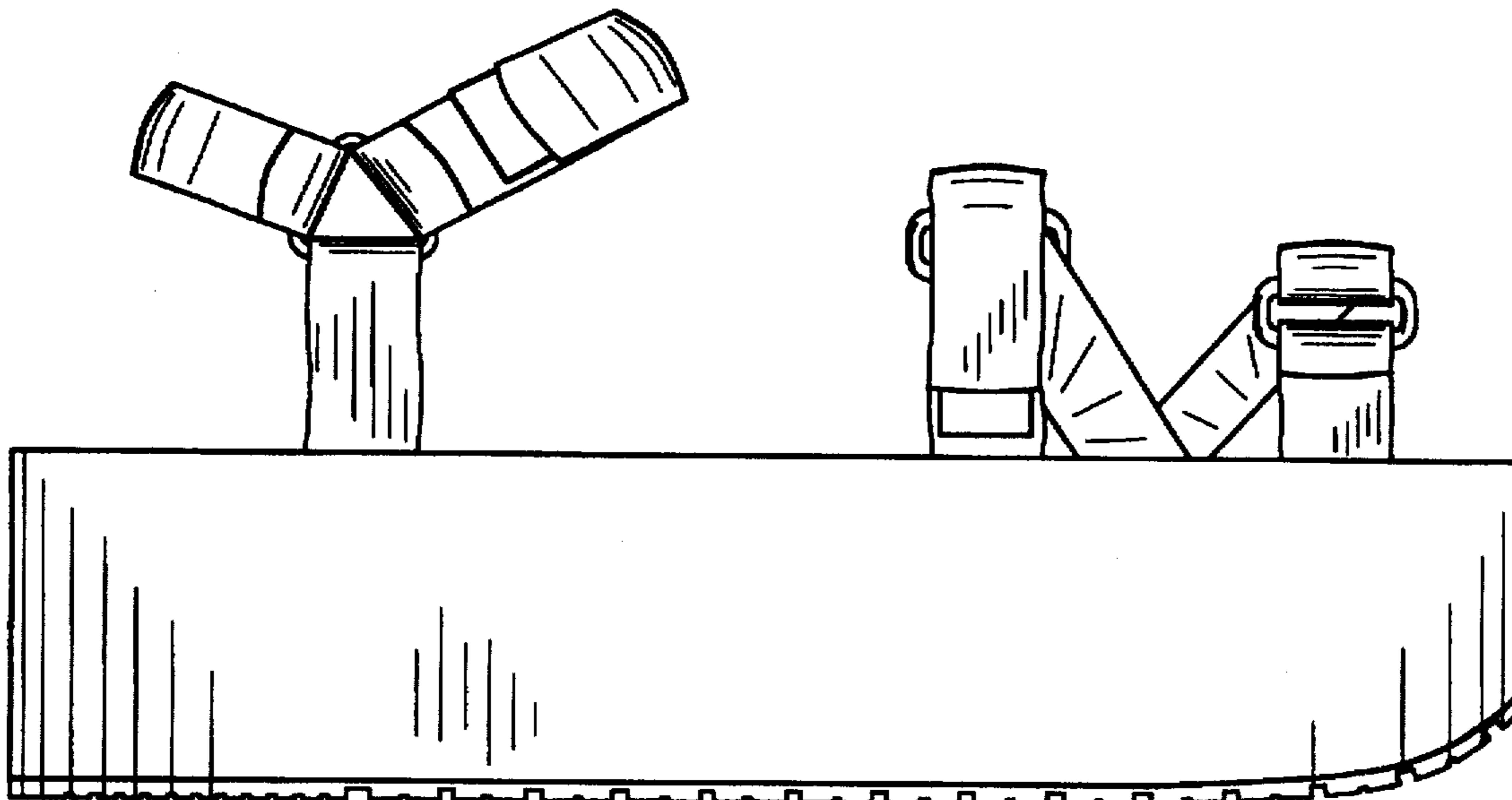
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom plan view of round toe platform sandal, showing my new design;

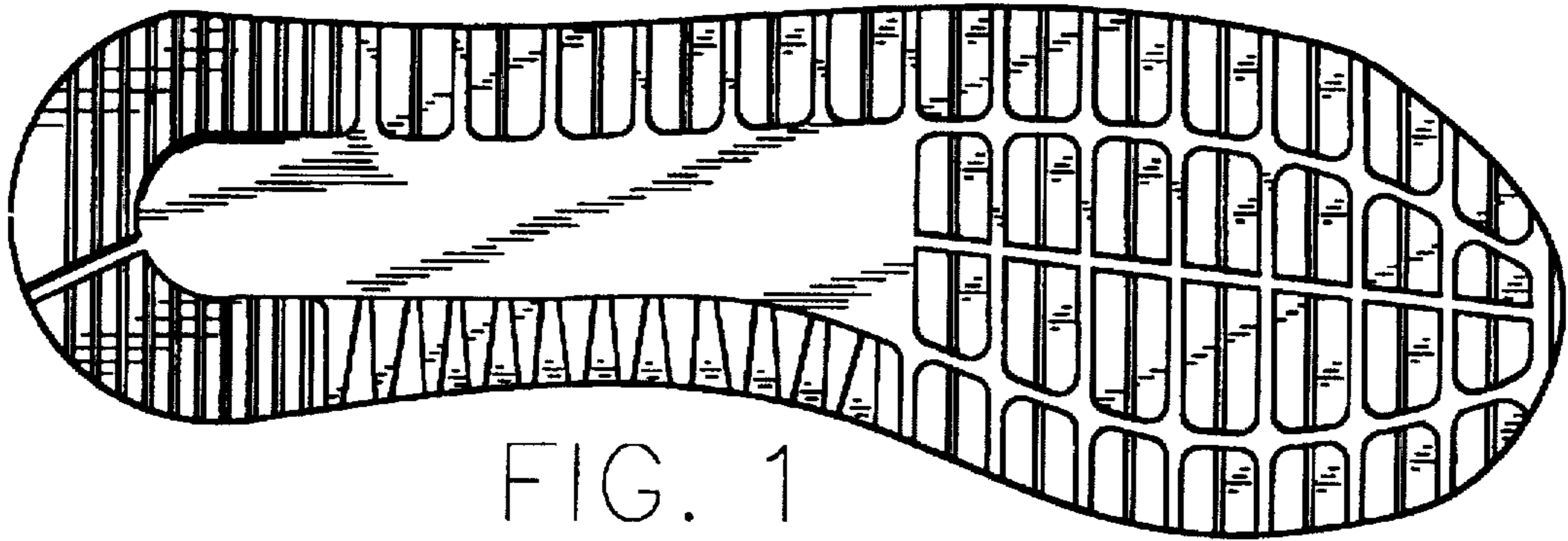

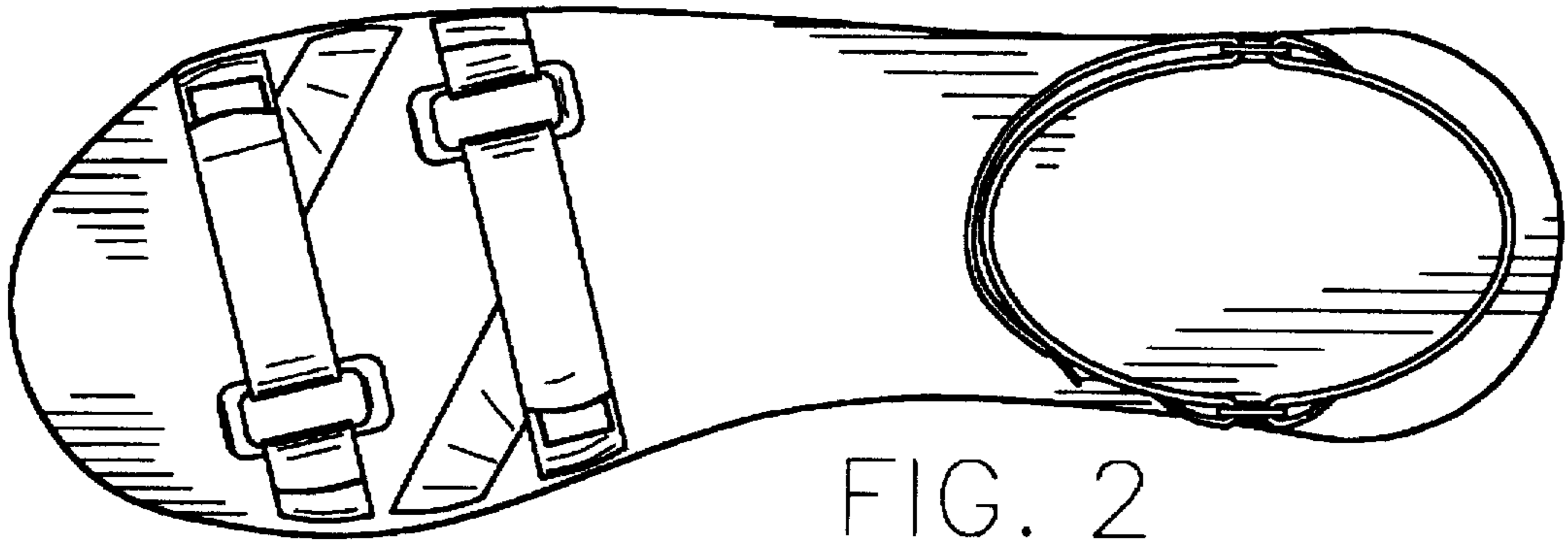

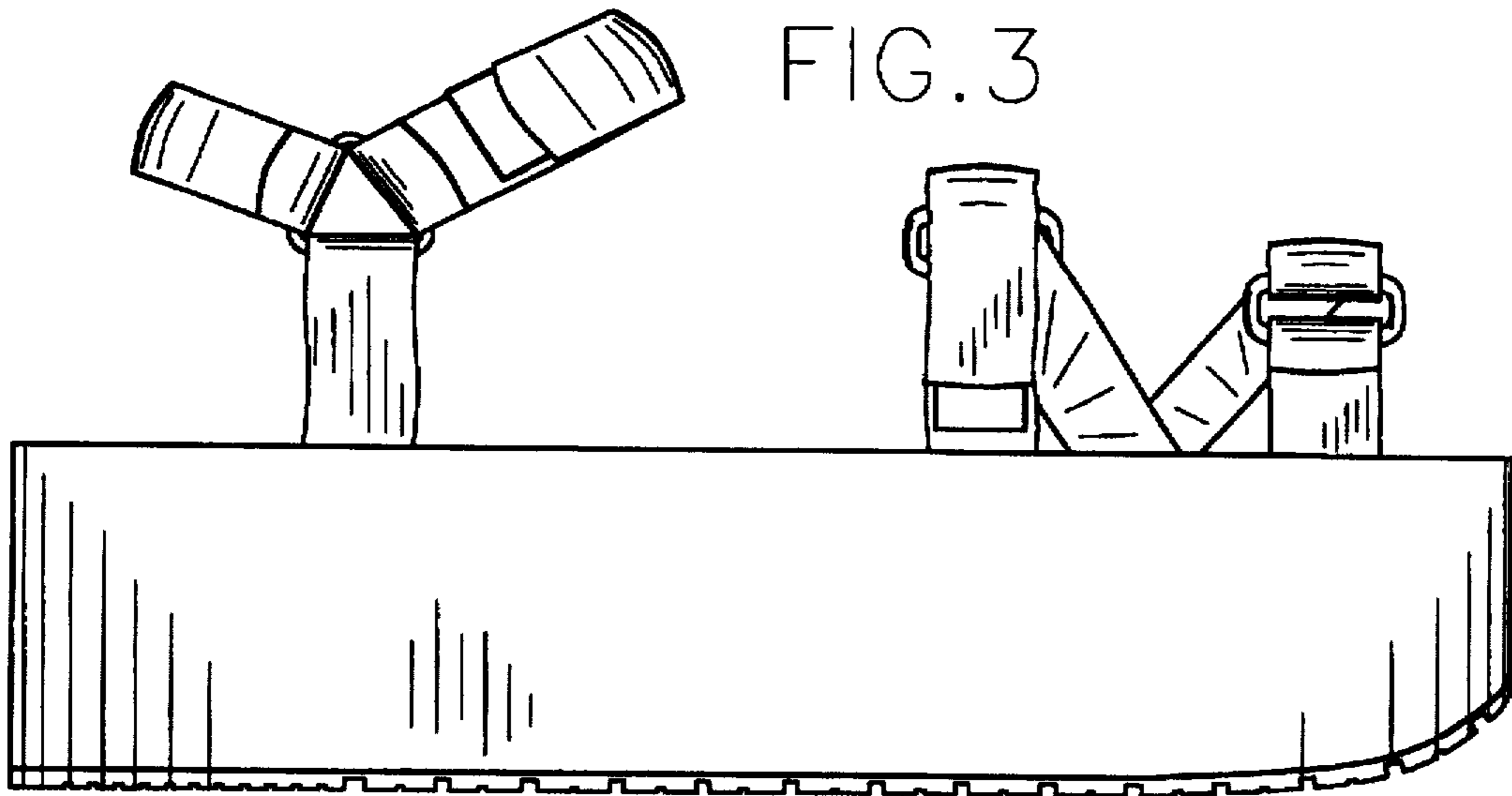

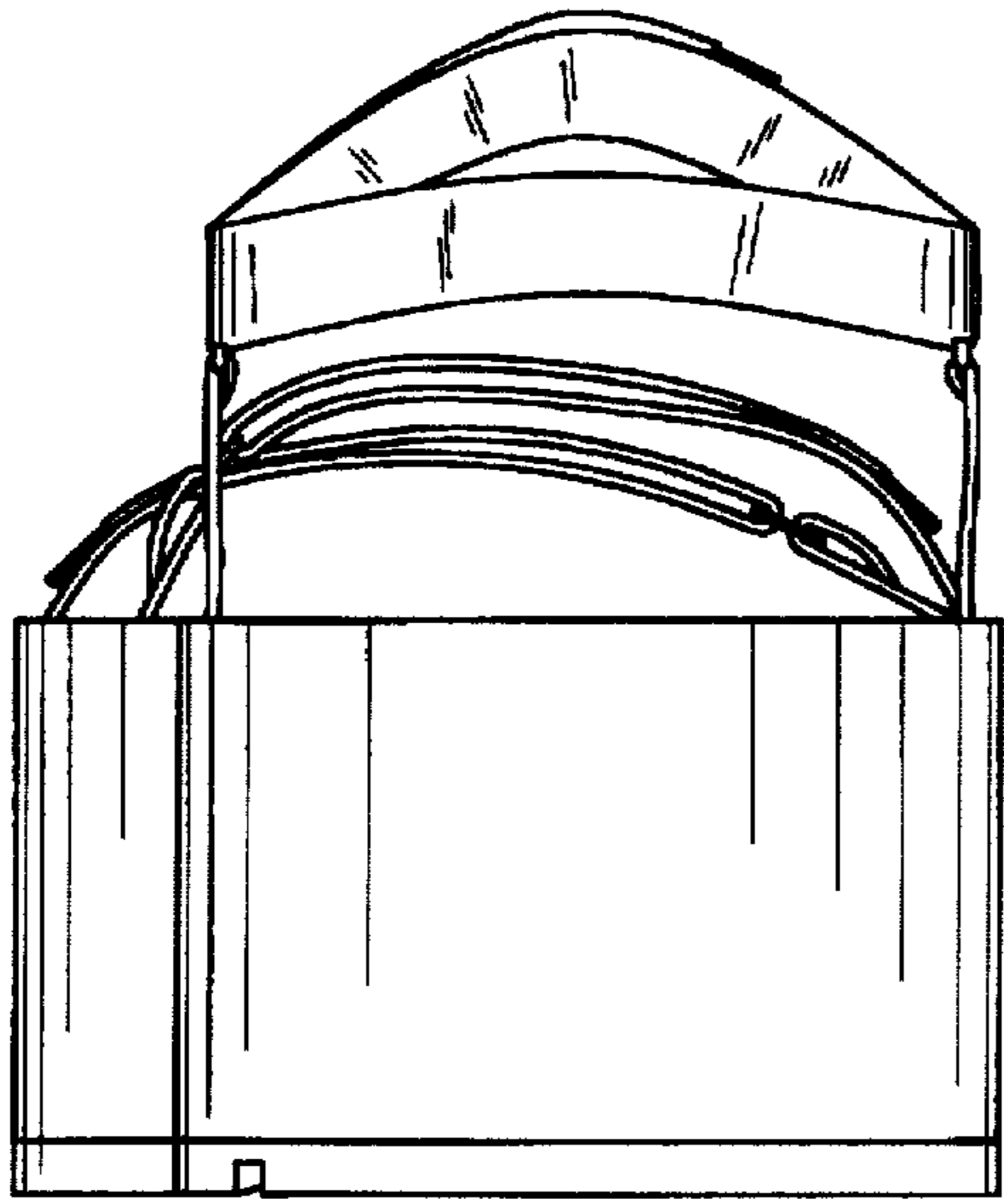

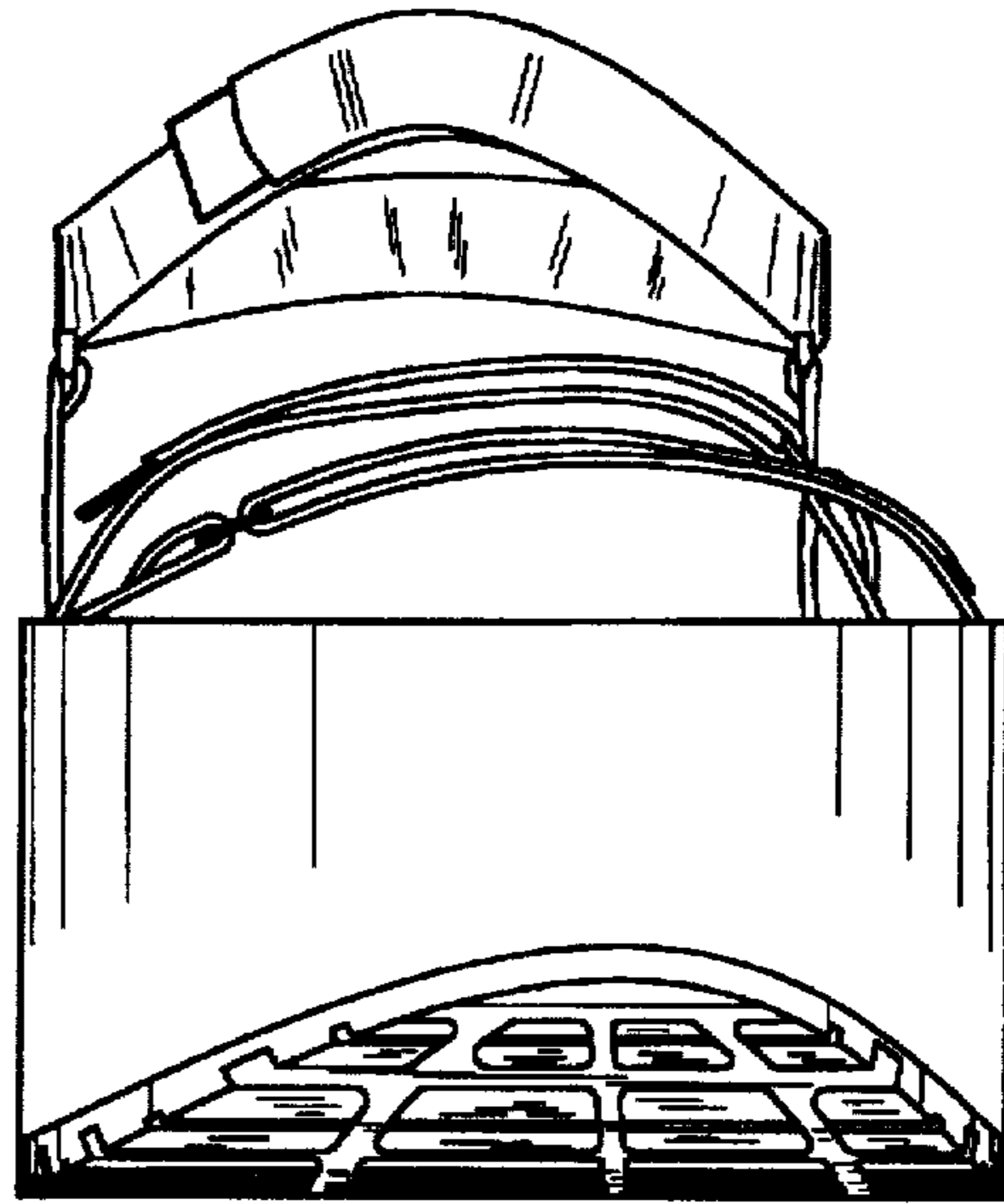
