[57] **CLAIM**

The ornamental design for a seat, as shown and described.  
**DESCRIPTION**

FIG. 1 is an enlarged, front perspective view of a first embodiment of a seat showing my new design;  
FIG. 2 is an enlarged, partial front perspective view of the seat arm thereof;  
FIG. 3 is an enlarged, partial front perspective view of the seat back thereof;  
FIG. 4 is an enlarged, side elevational view thereof, the opposite side elevational view being a mirror image;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a rear elevational view thereof;  
FIG. 8 is a front view of a second embodiment of the seat;  
FIG. 9 is a top plan view of the second embodiment;  
FIG. 10 is a rear view of the second embodiment;  
FIG. 11 is a front elevational view of a third embodiment of the seat;  
FIG. 12 is a top plan view of the third embodiment; and,  
FIG. 13 is a rear view of the third embodiment.  
The side views of the second and third embodiments are as shown in FIG. 4.  
The cross-hatching pattern shown on various trim is understood to be continuous throughout the designated areas.


























