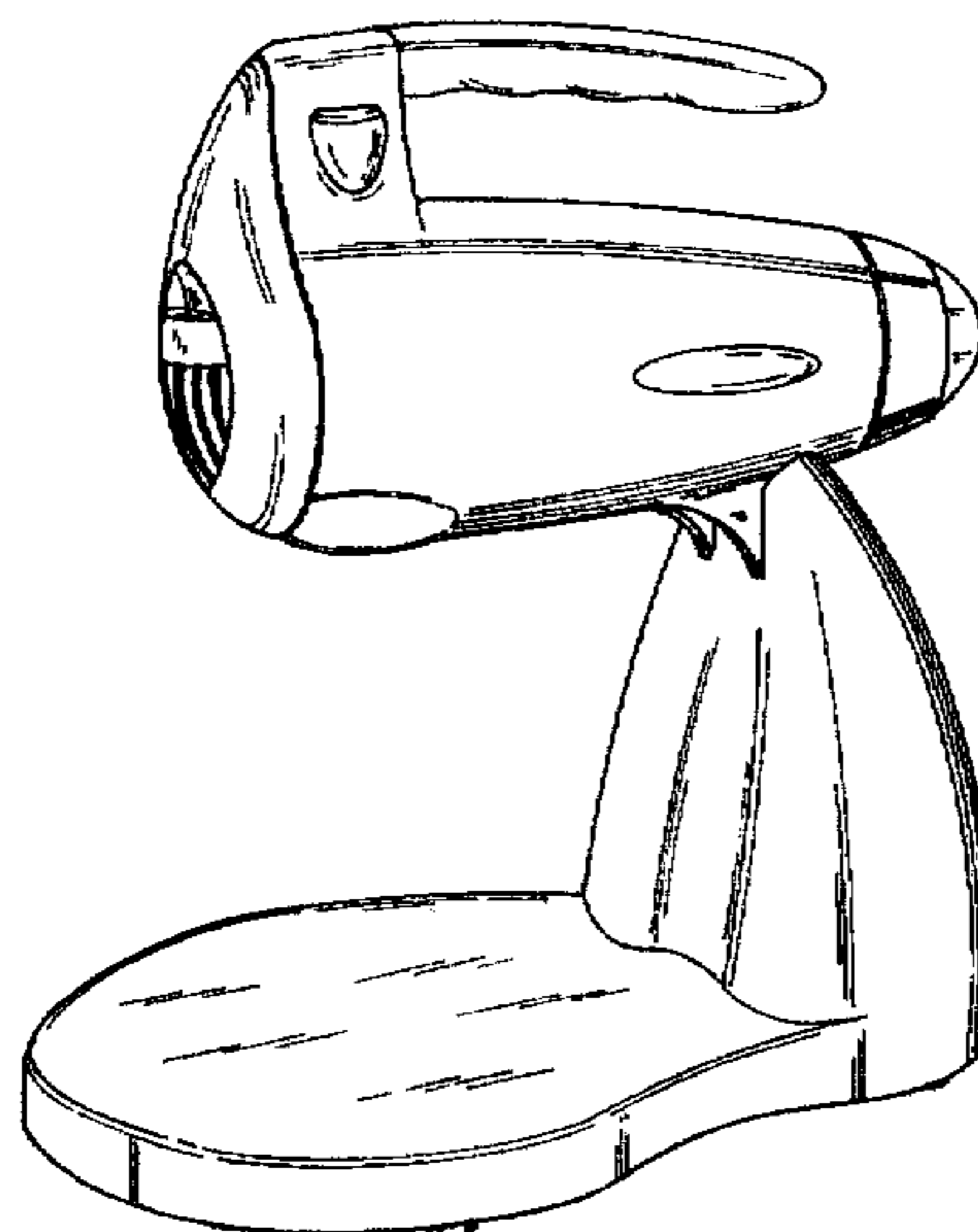
[57] **CLAIM**

The ornamental design for an electronic stand mixer, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the electronic stand mixer; FIG. 2 is a front elevation view of the mixer of FIG. 1; FIG. 3 is an elevation view of one side of the mixer of FIG. 1; FIG. 4 is an elevation view of the rear of the mixer of FIG. 1; FIG. 5 is an elevation view of that side of the mixer of FIG. 1 opposite the side shown in FIG. 3; FIG. 6 is a top plan view of the mixer of FIG. 1; and, FIG. 7 is a bottom plan view of the mixer of FIG. 1.

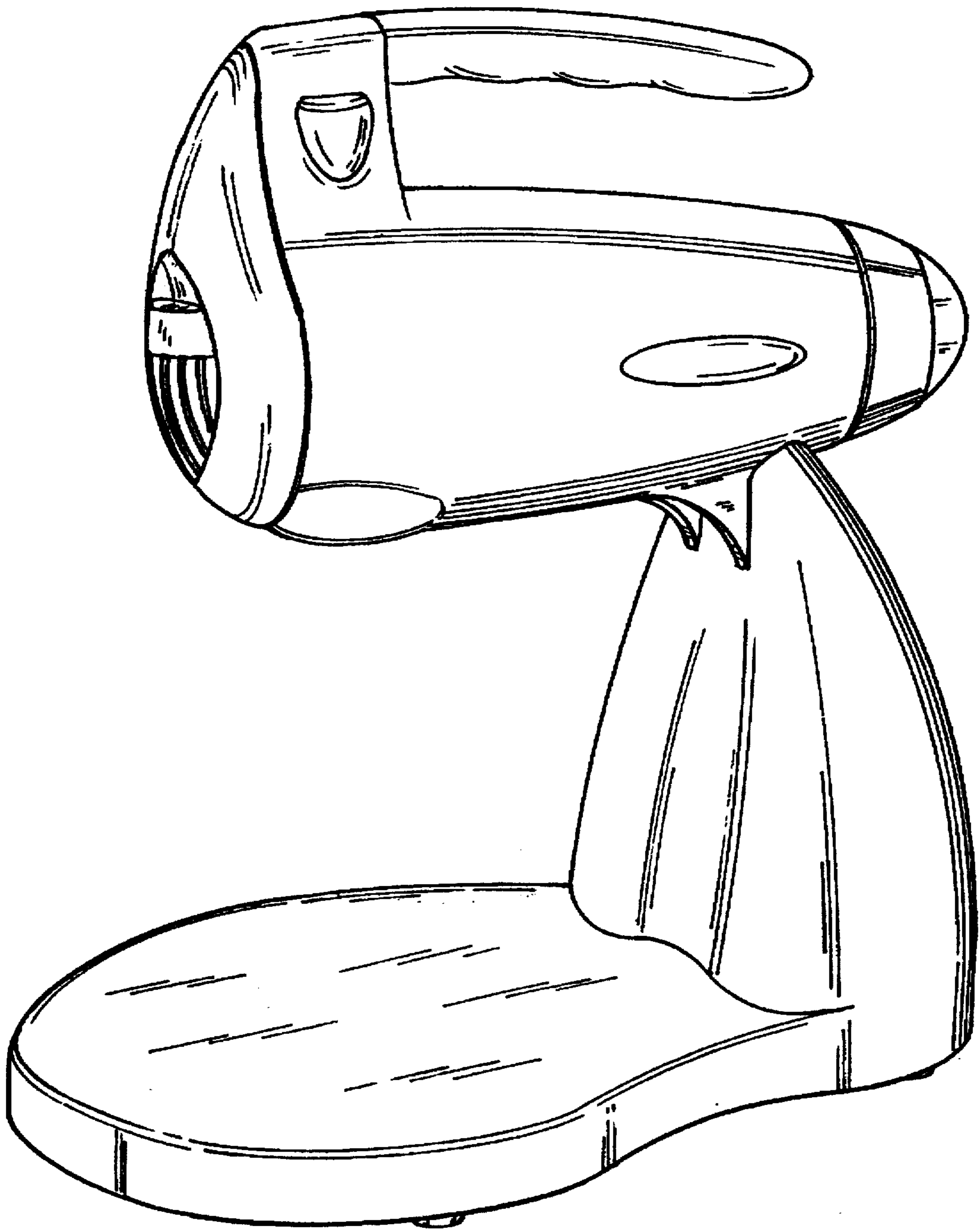

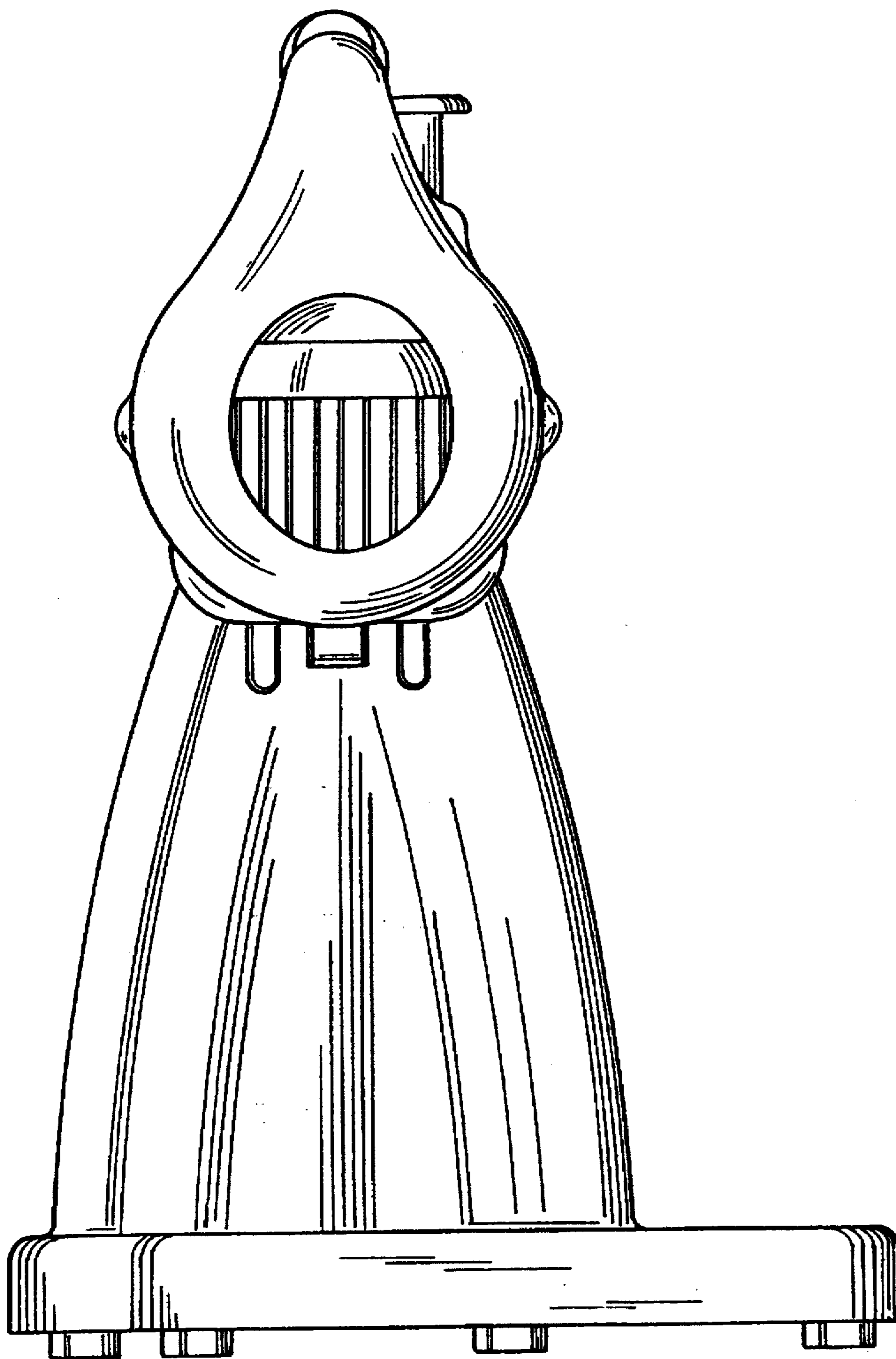

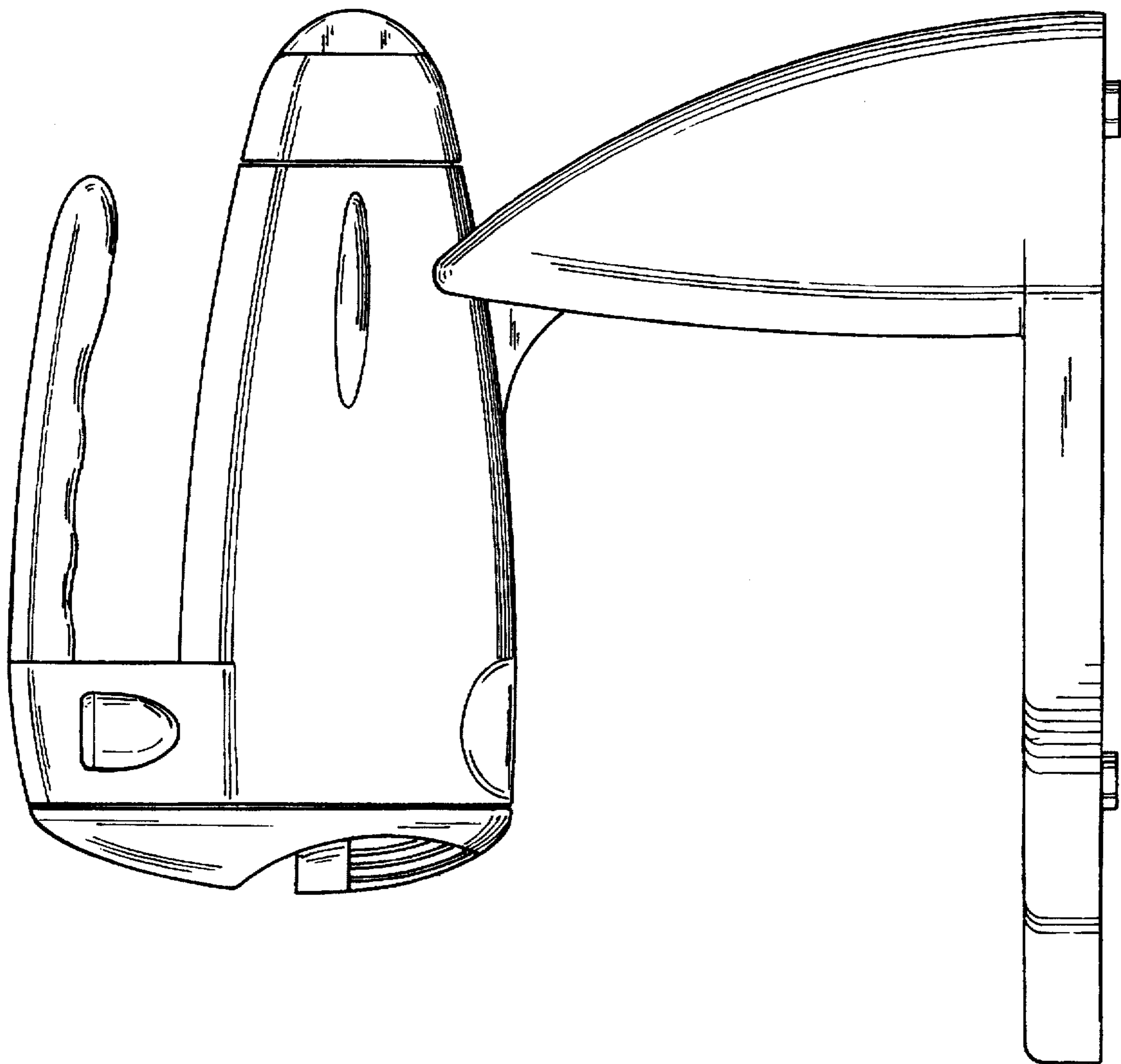

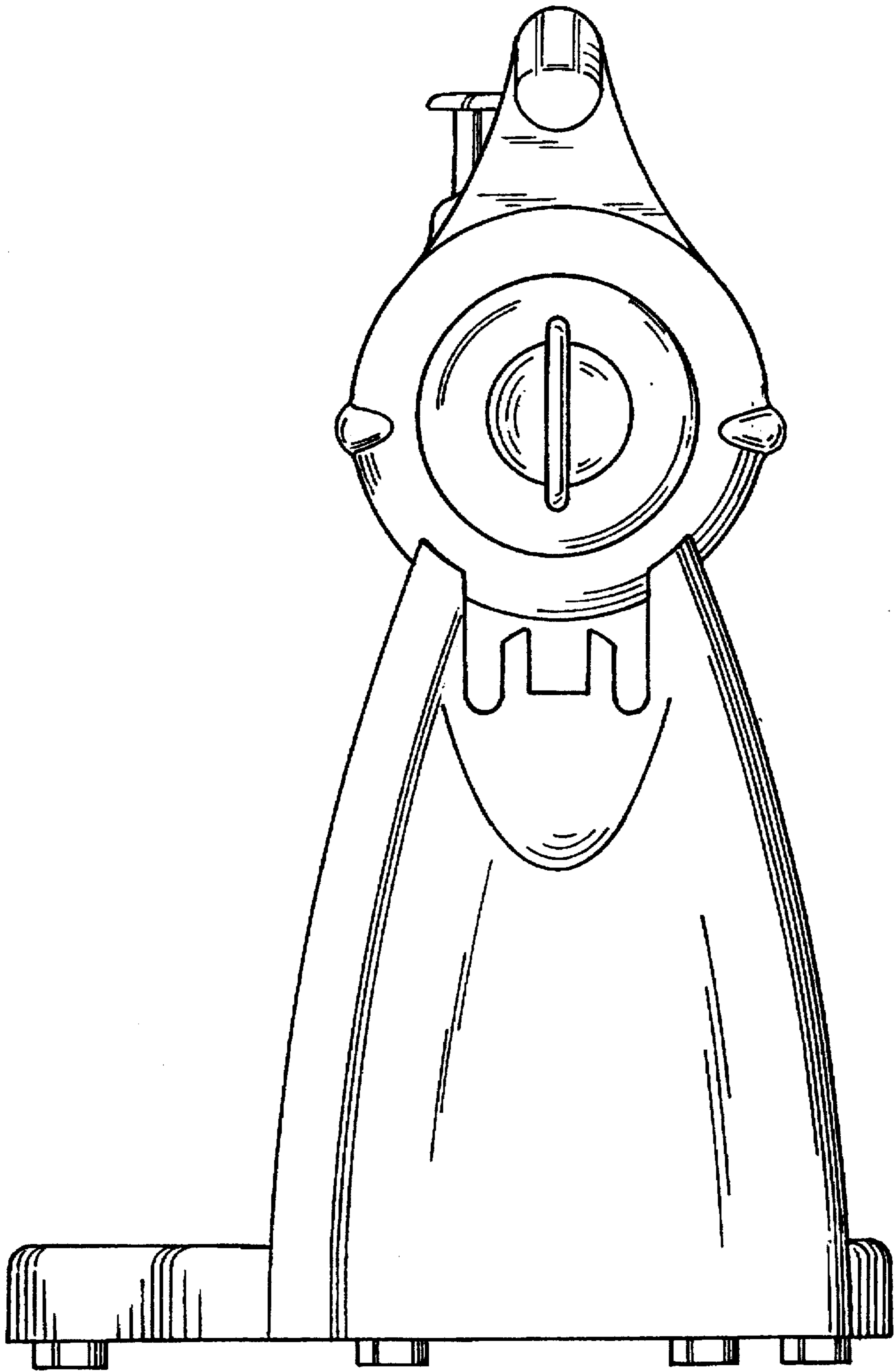

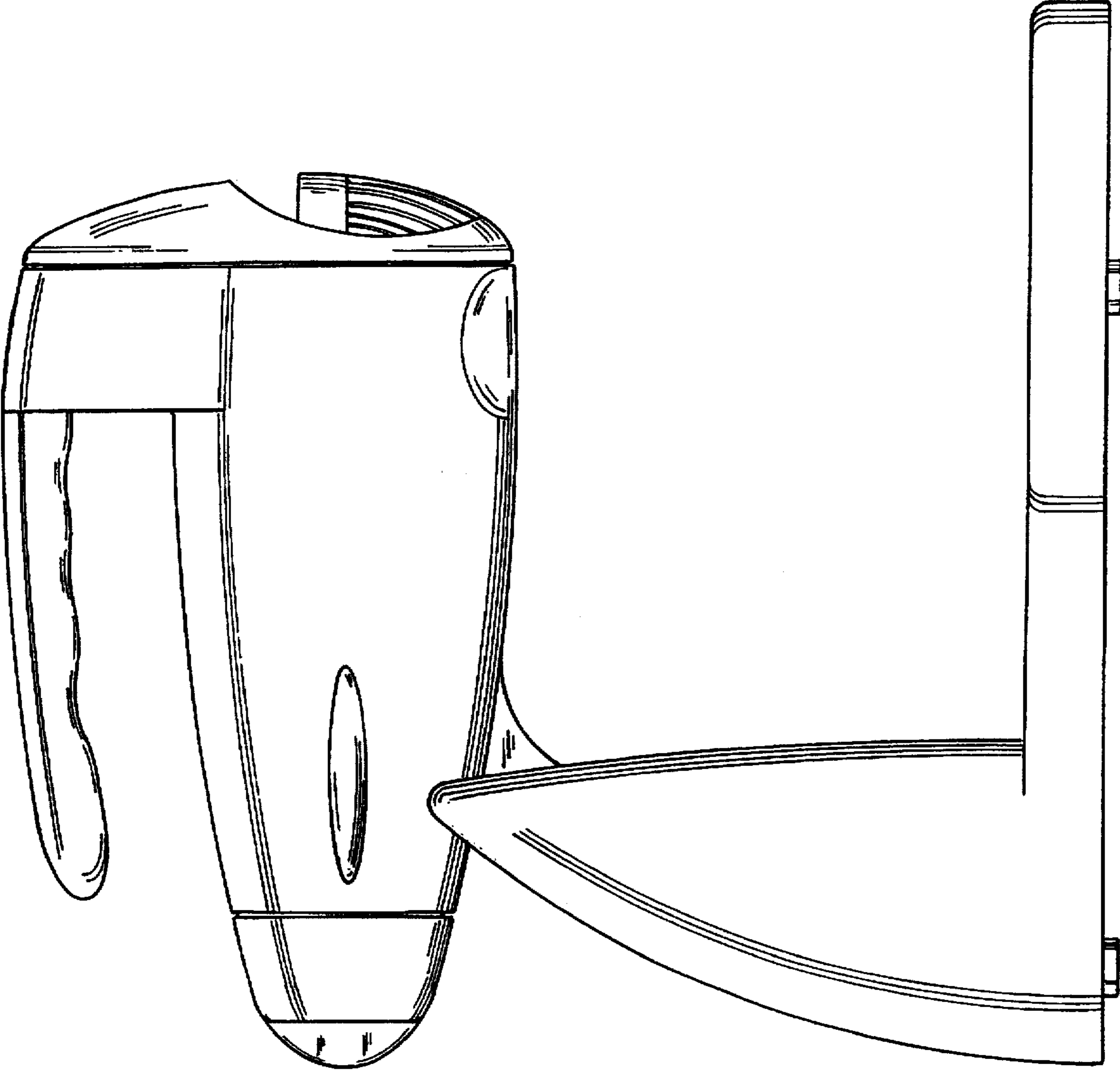

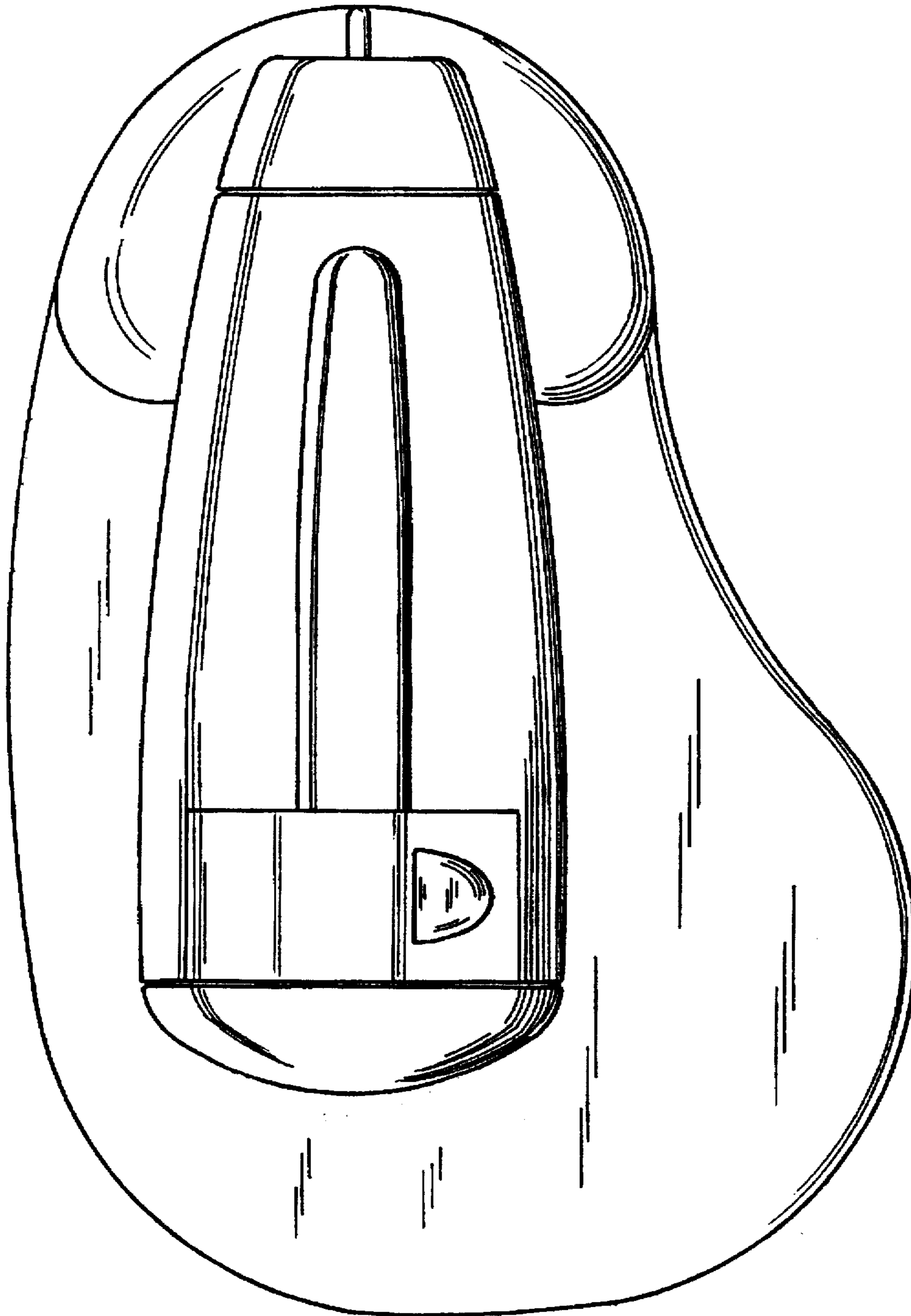

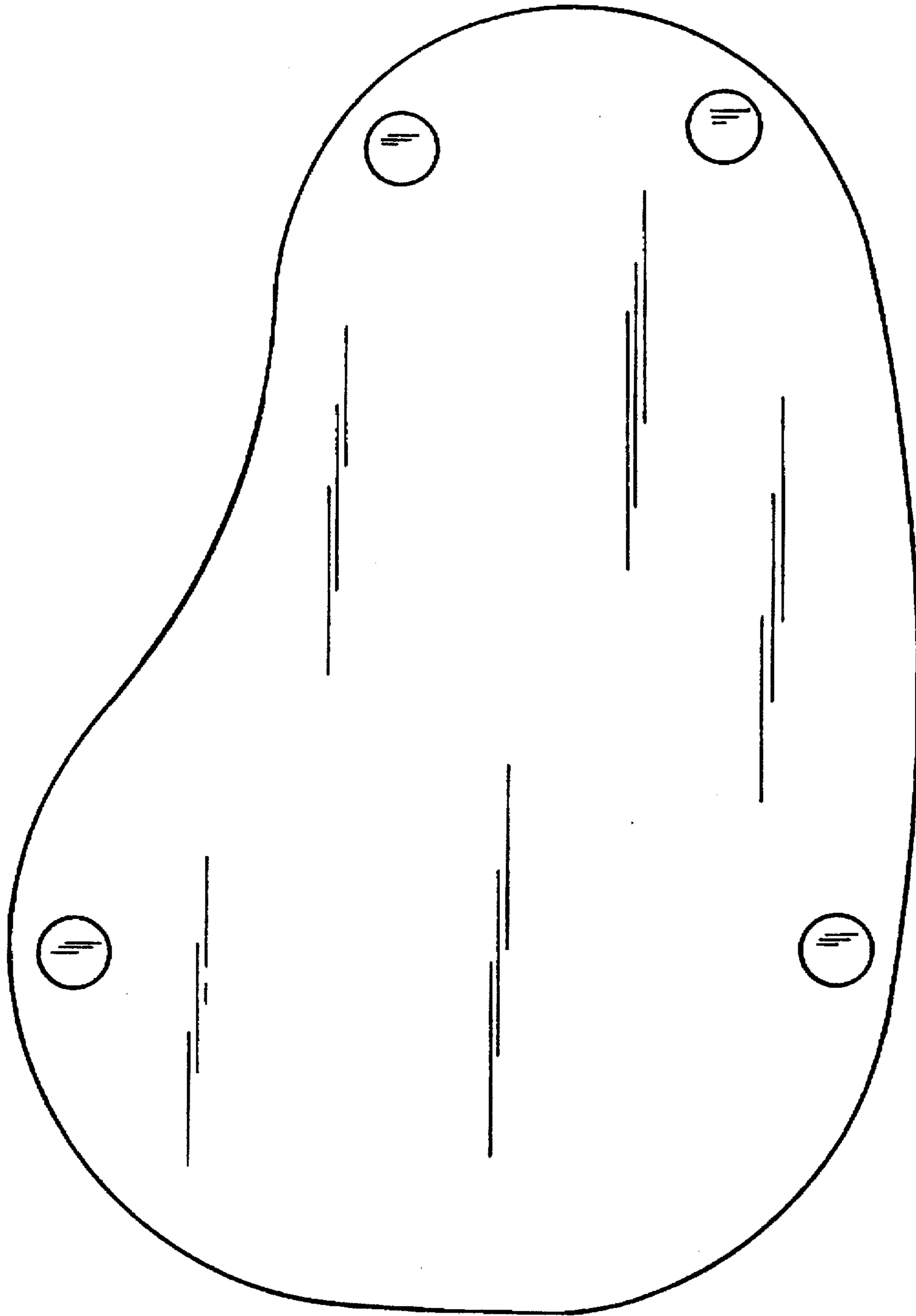
