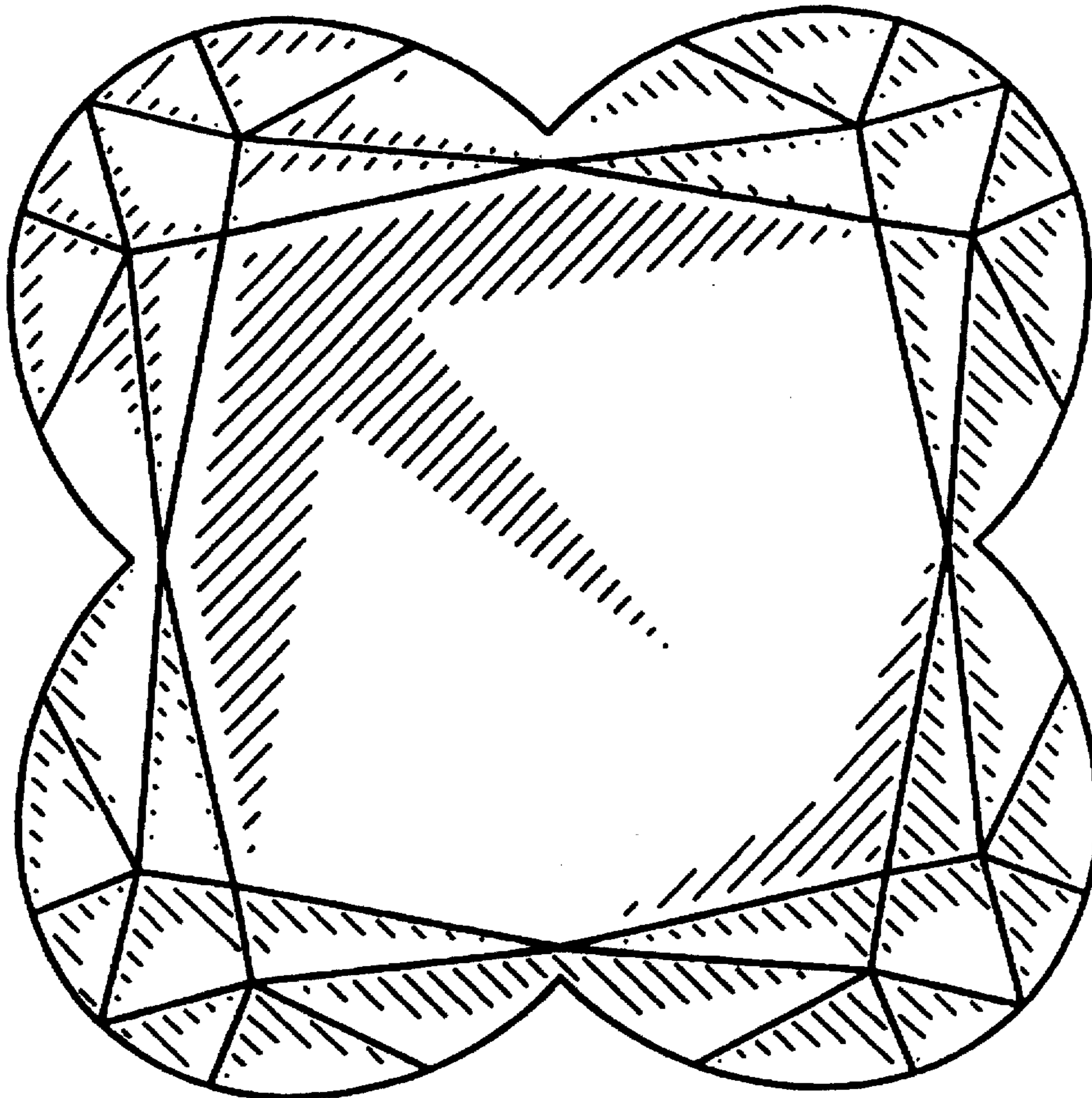
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a polished diamond in accordance with the invention;
FIG. 2 is a bottom view of the polished diamond seen in FIG. 1;
FIG. 3 is a side view of the polished diamond seen in FIG. 1, seen from the left and right sides;
FIG. 4 is a side view of the polished diamond seen in FIG. 1, seen from the front and rear sides; and,
FIG. 5 is a perspective view of the polished diamond seen in FIG. 1.

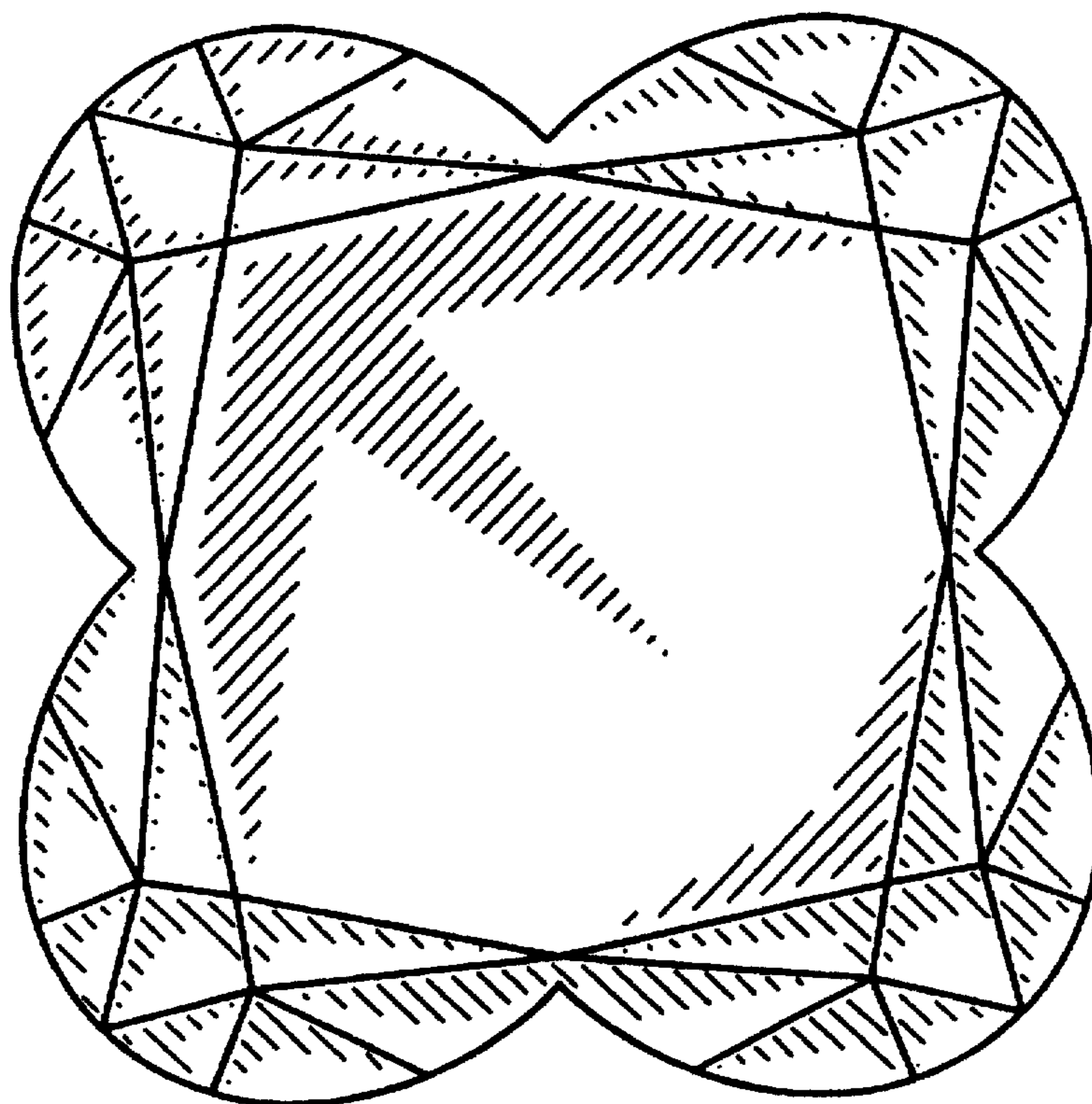

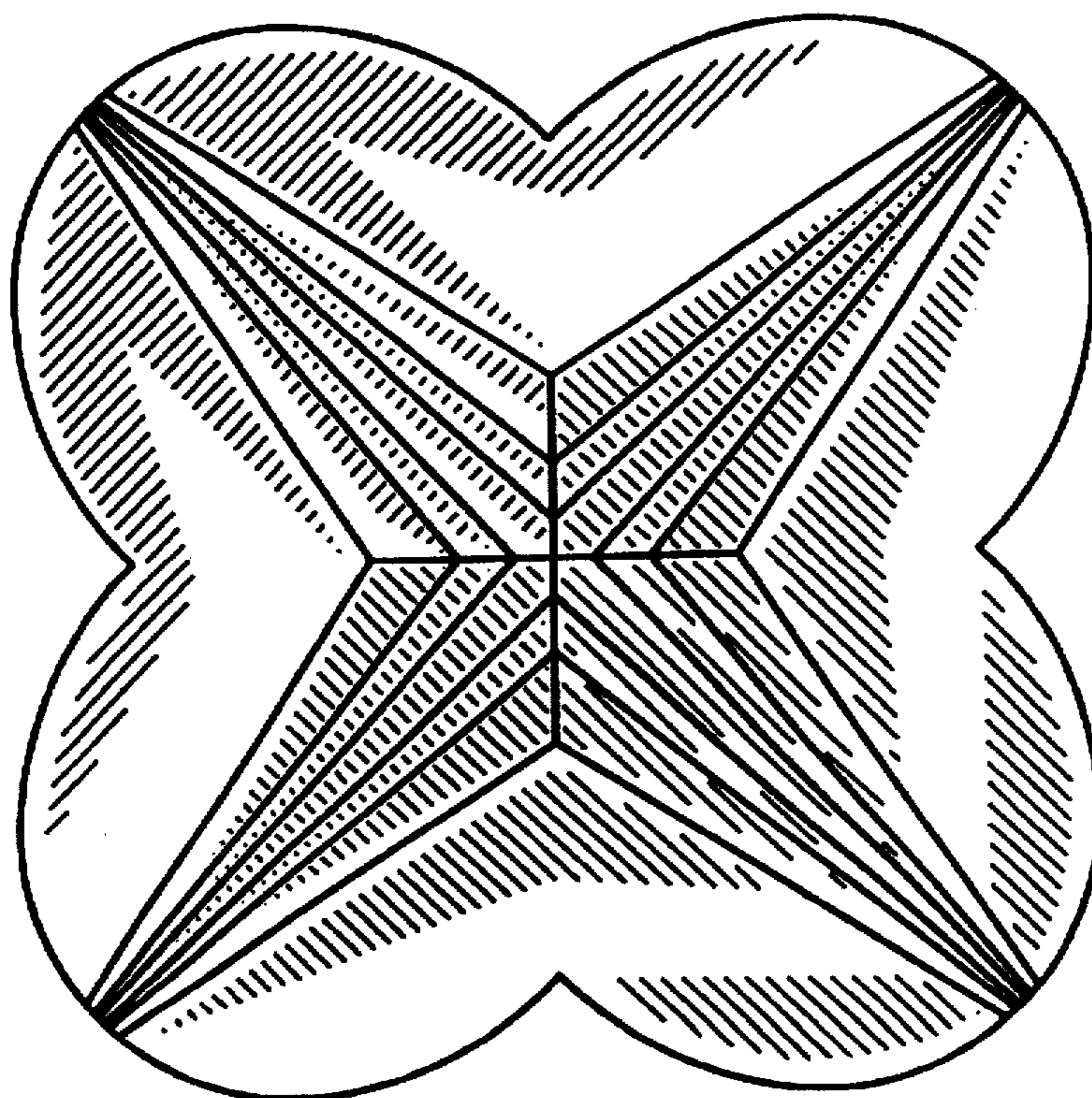

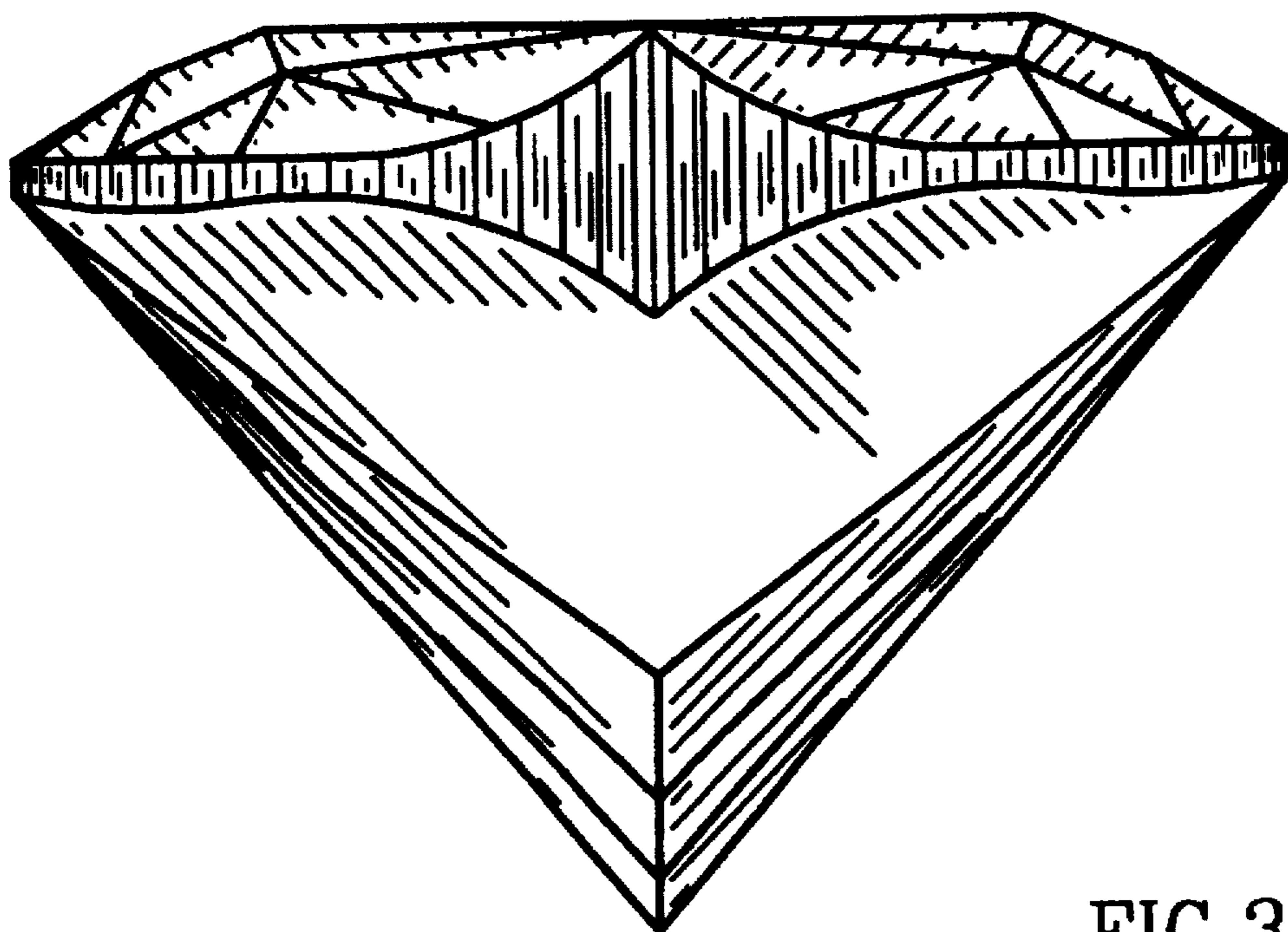

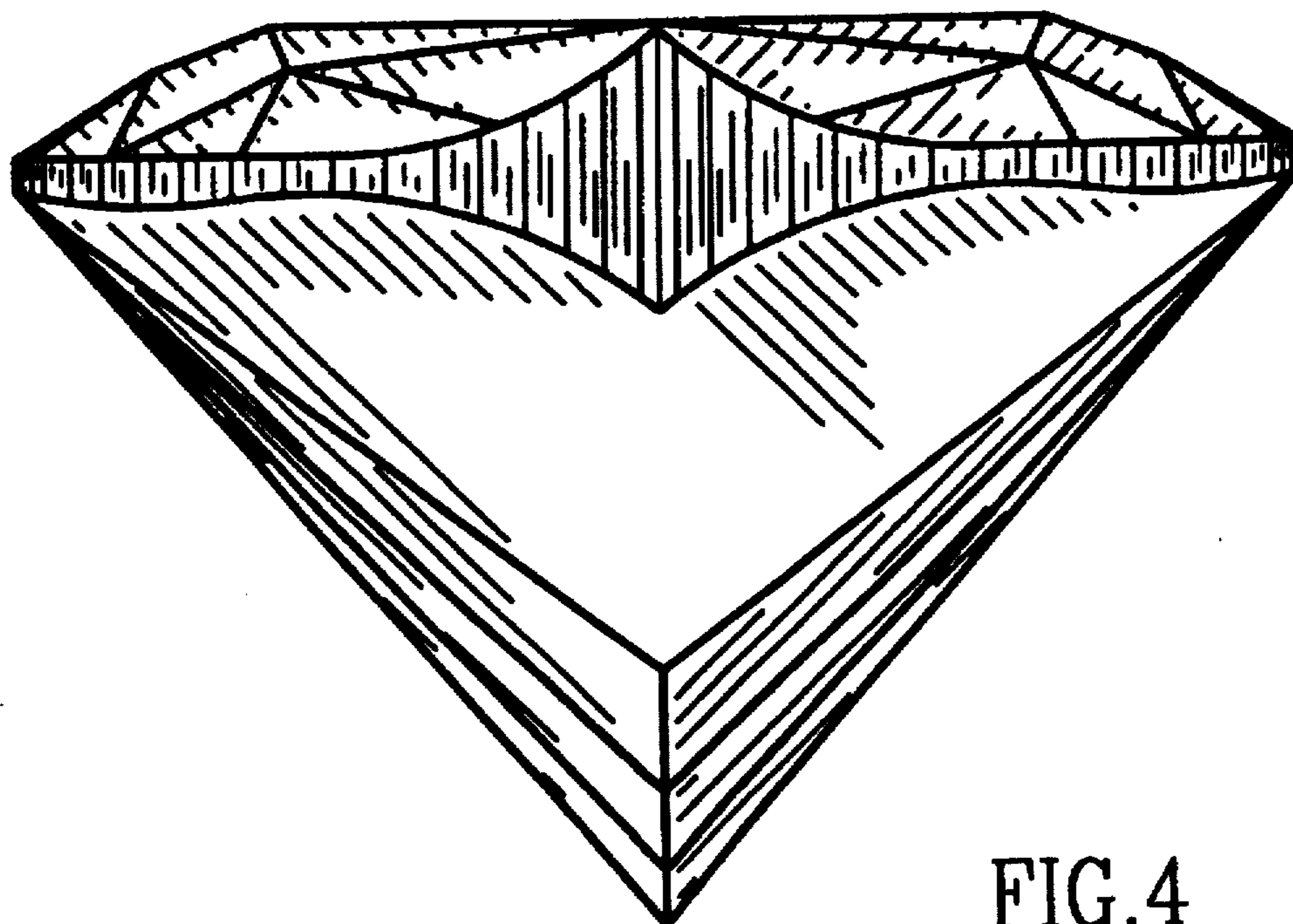

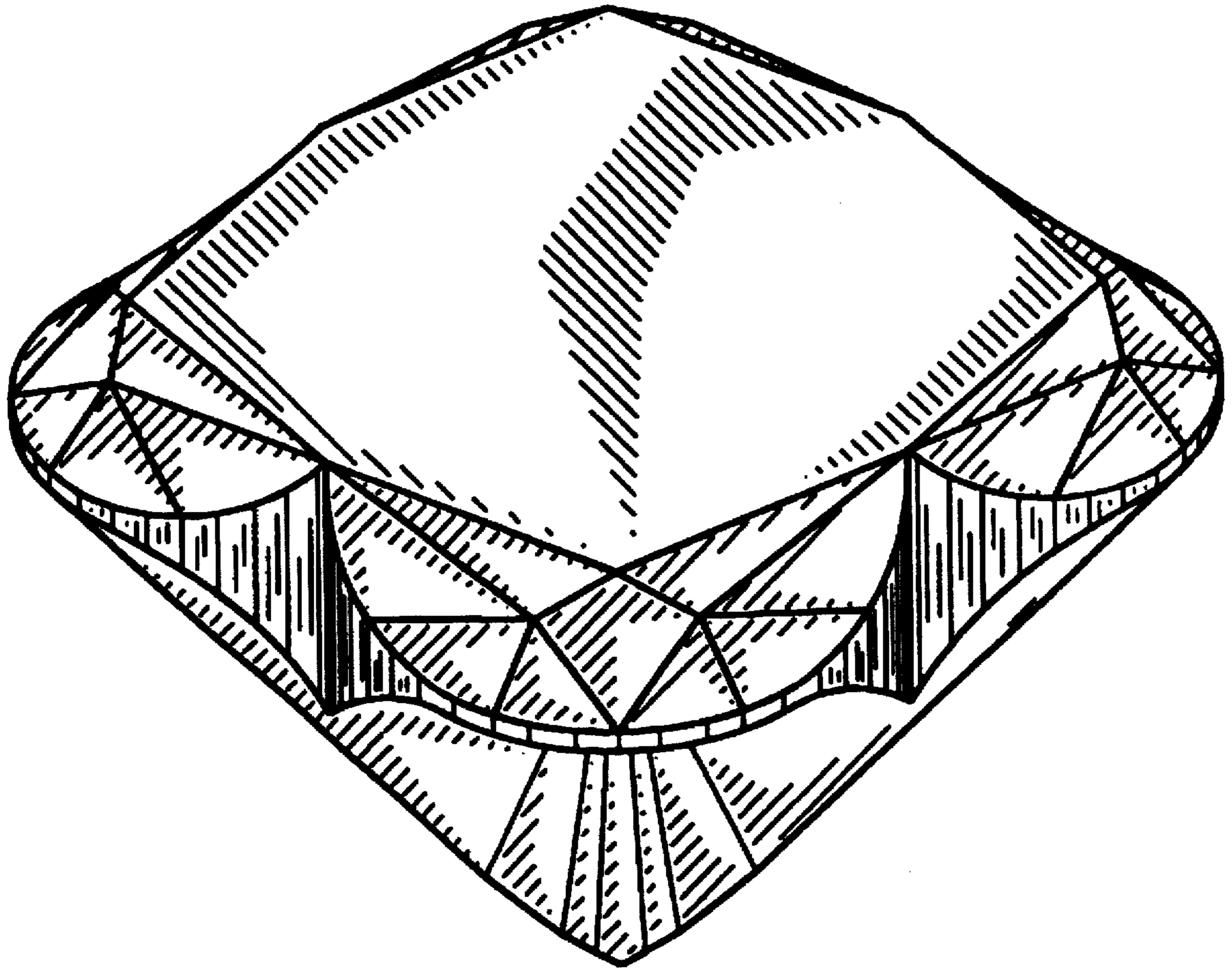

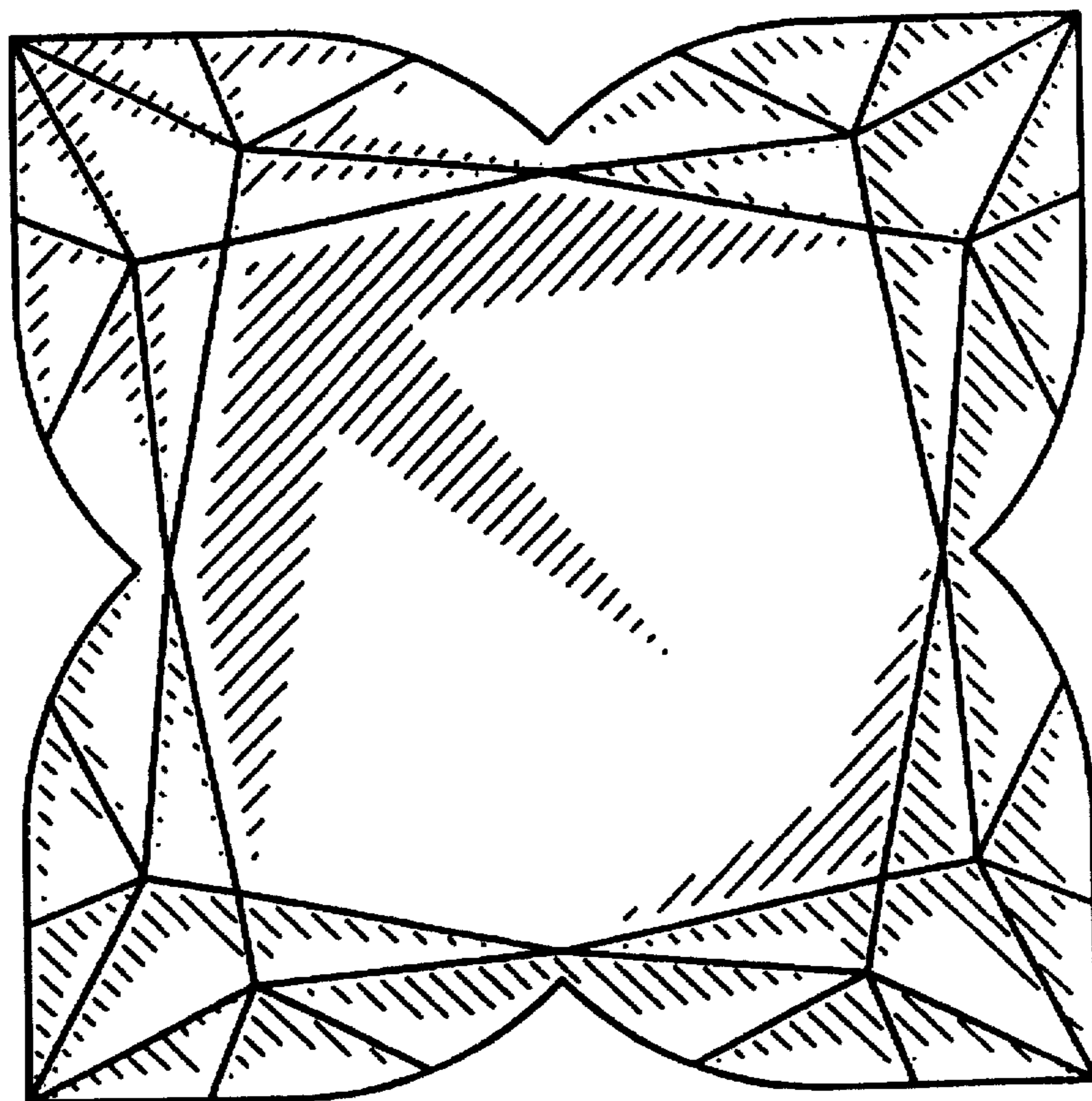

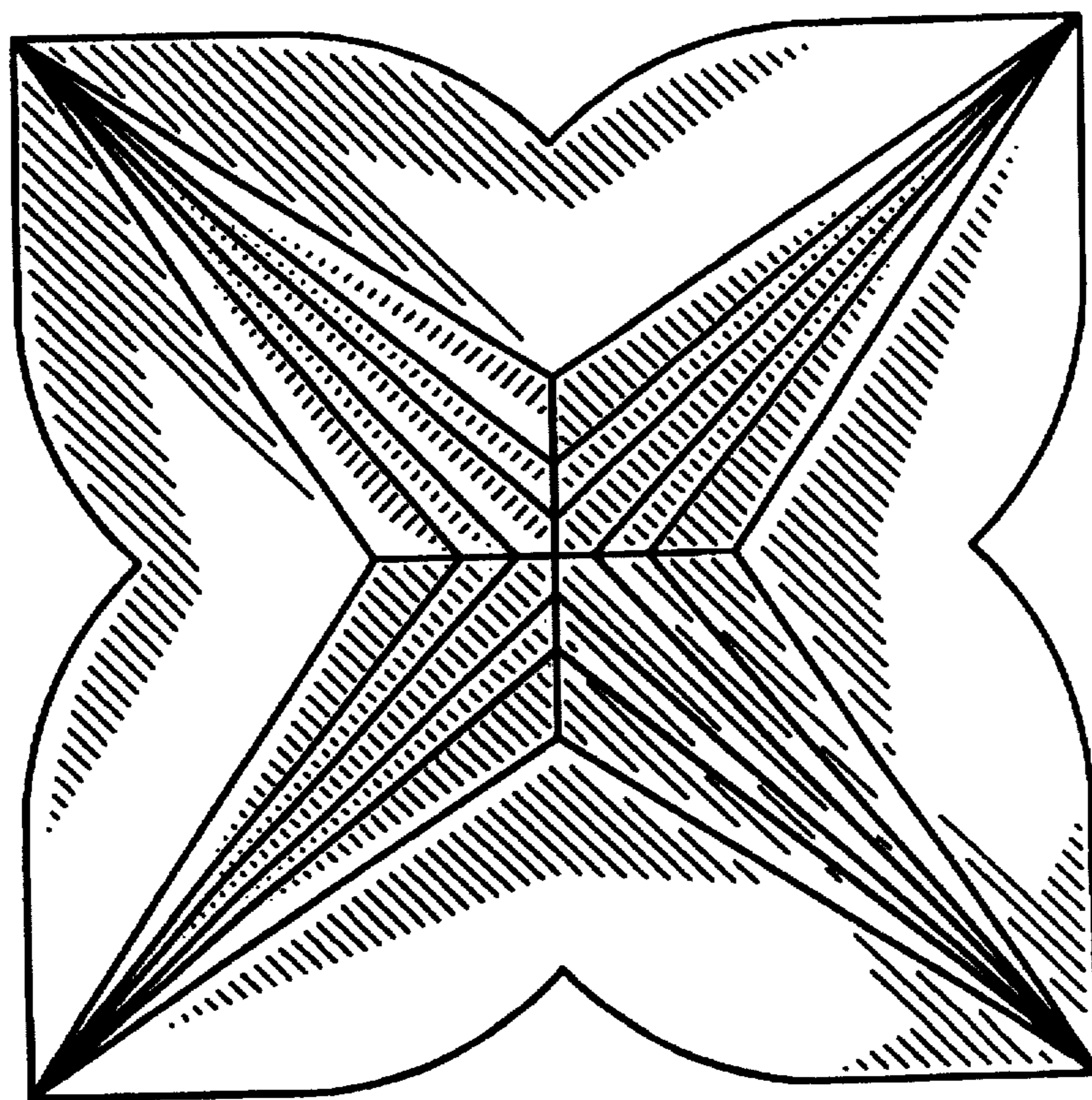

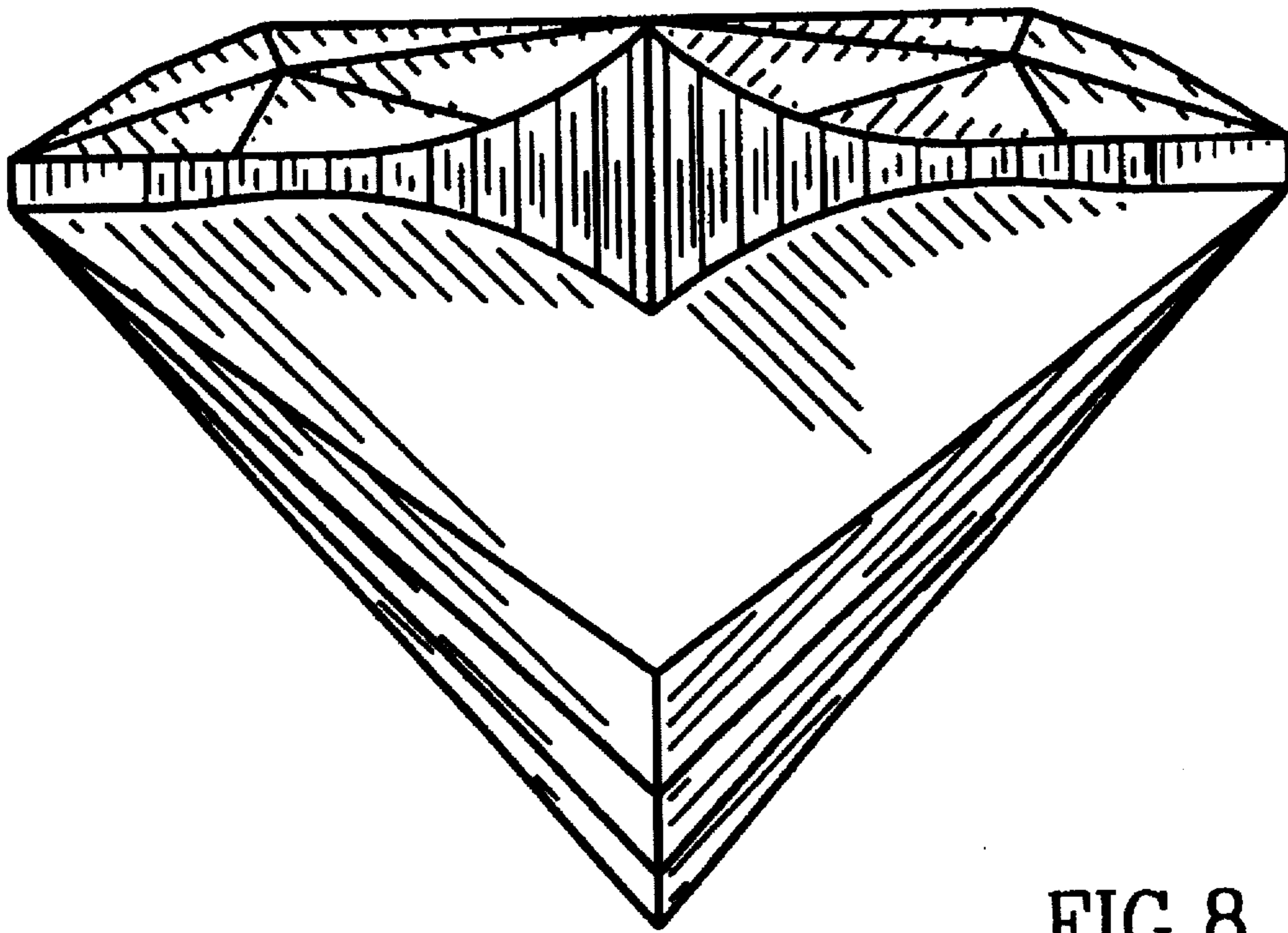

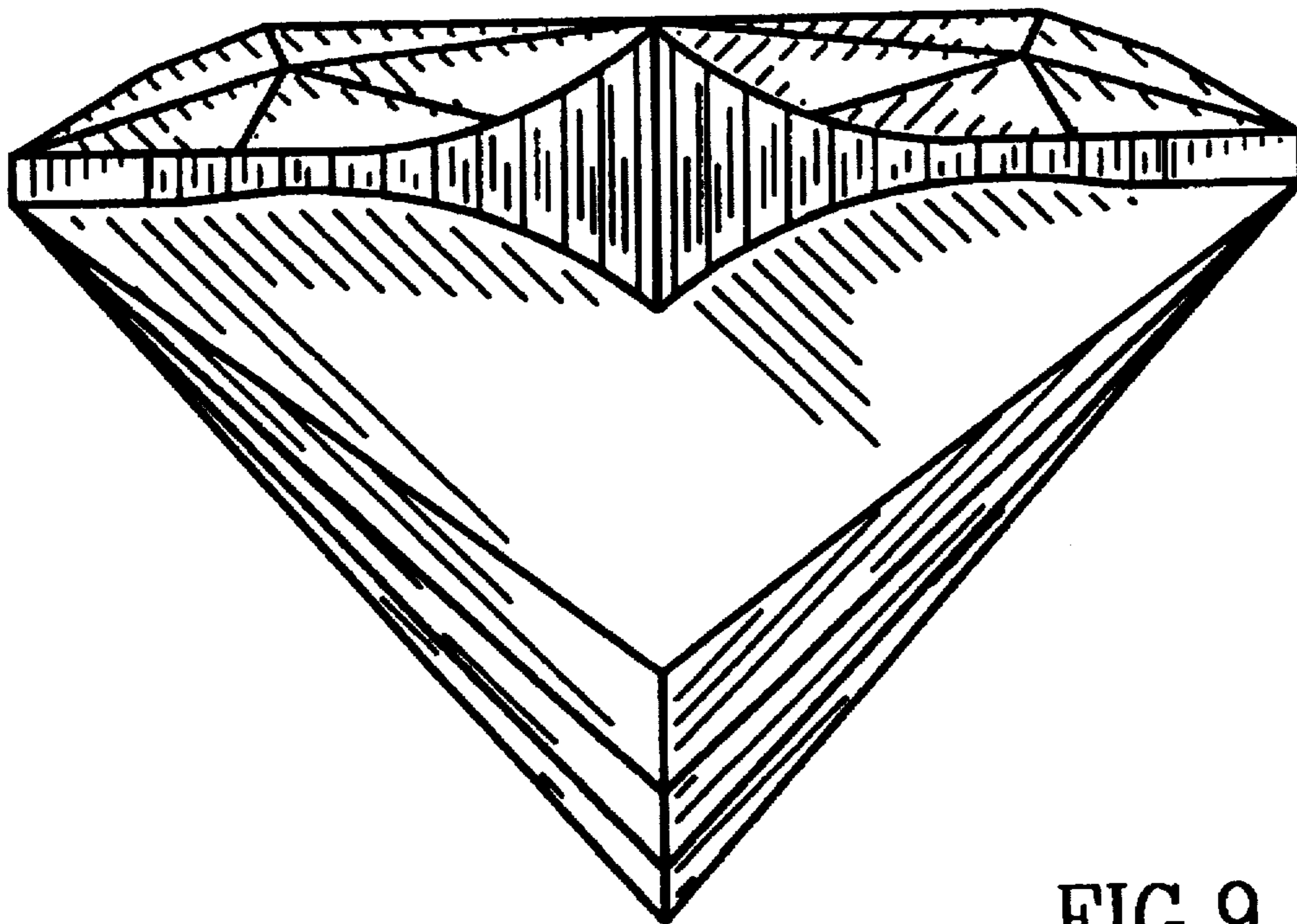

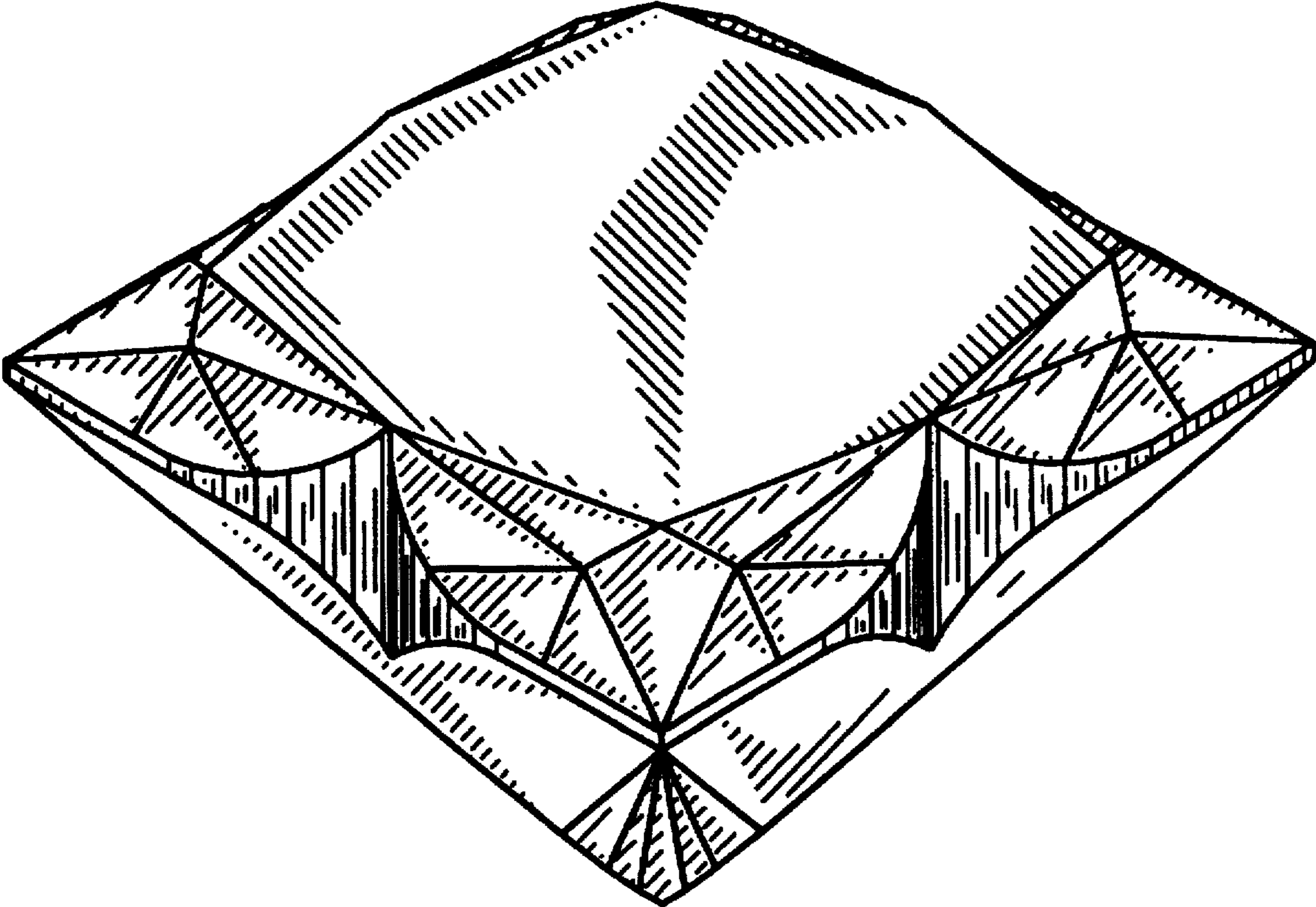
