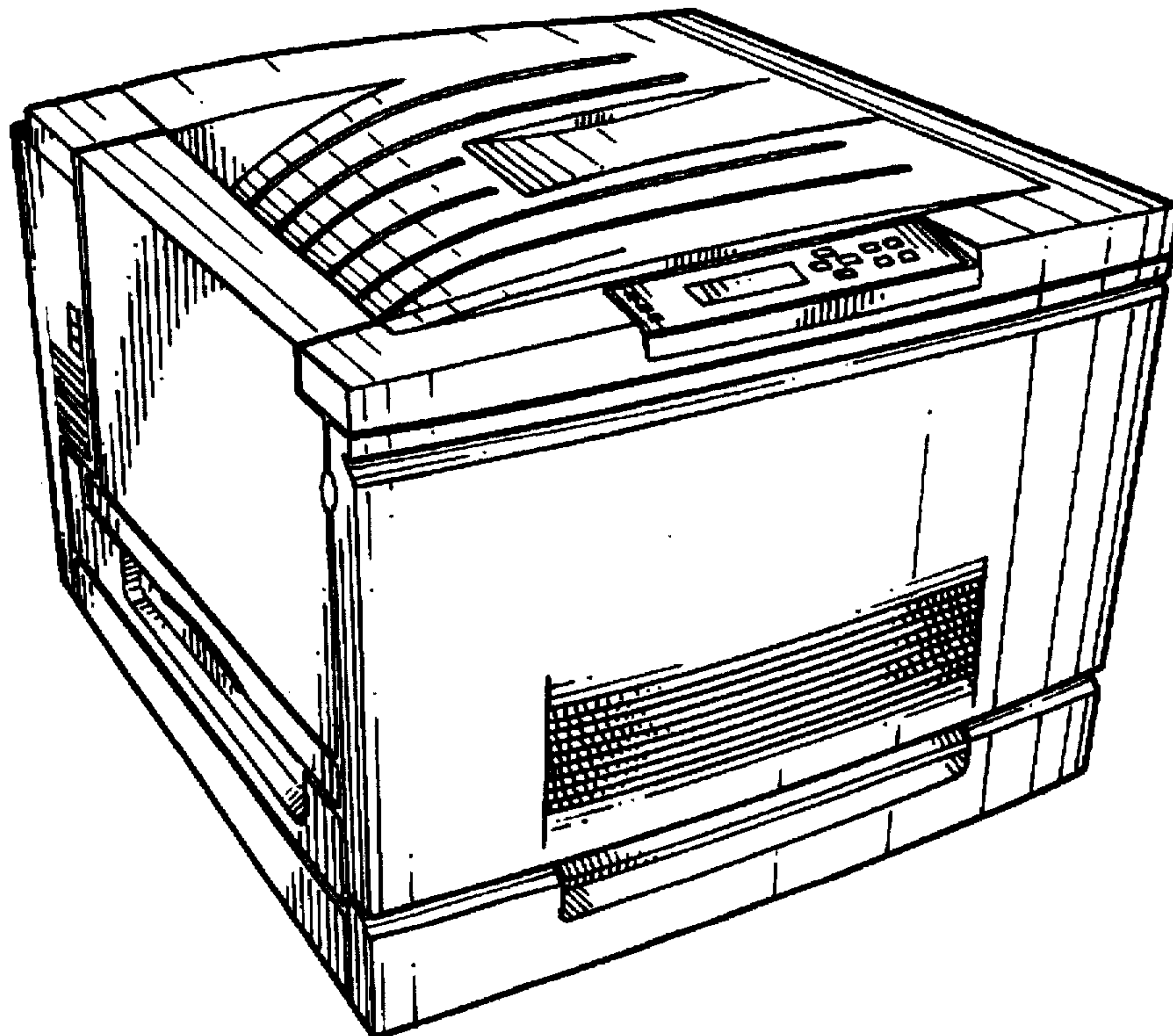
[57] **CLAIM**

The ornamental design for a printer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a printer showing our new design; FIG. 2 is a top plane view of the printer of FIG. 1; FIG. 3 is a right side view of the printer of FIG. 1; FIG. 4 is a left side view of the printer of FIG. 1; FIG. 5 is a rear view of the printer of FIG. 1; FIG. 6 is a bottom view of the printer of FIG. 1; FIG. 7 is a cross sectional view of the printer taken along the line A—A in FIG. 2; FIG. 8 is a cross sectional view of the printer taken along B—B line in FIG. 2; and, FIG. 9 is a perspective view of the printer of FIG. 1.

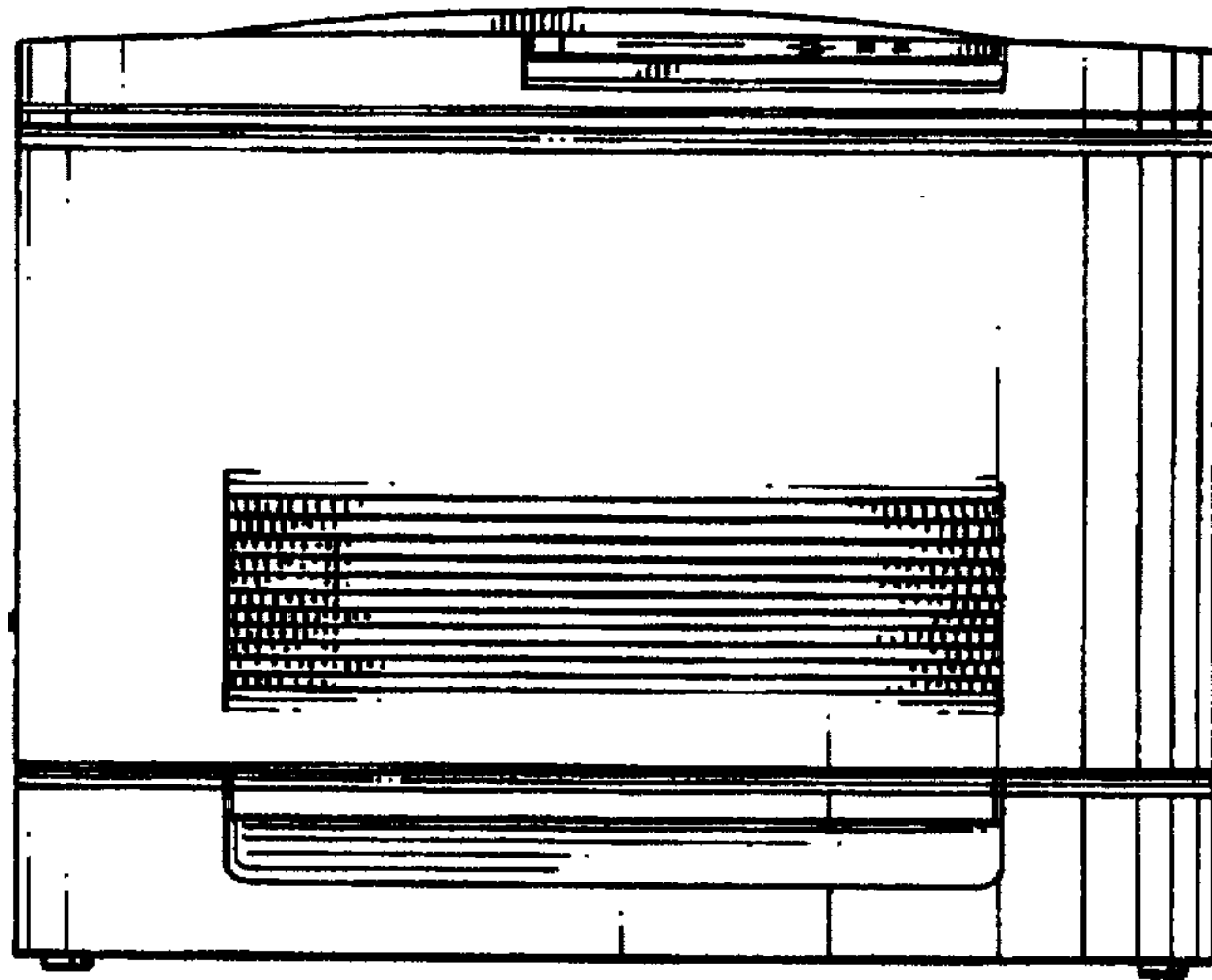

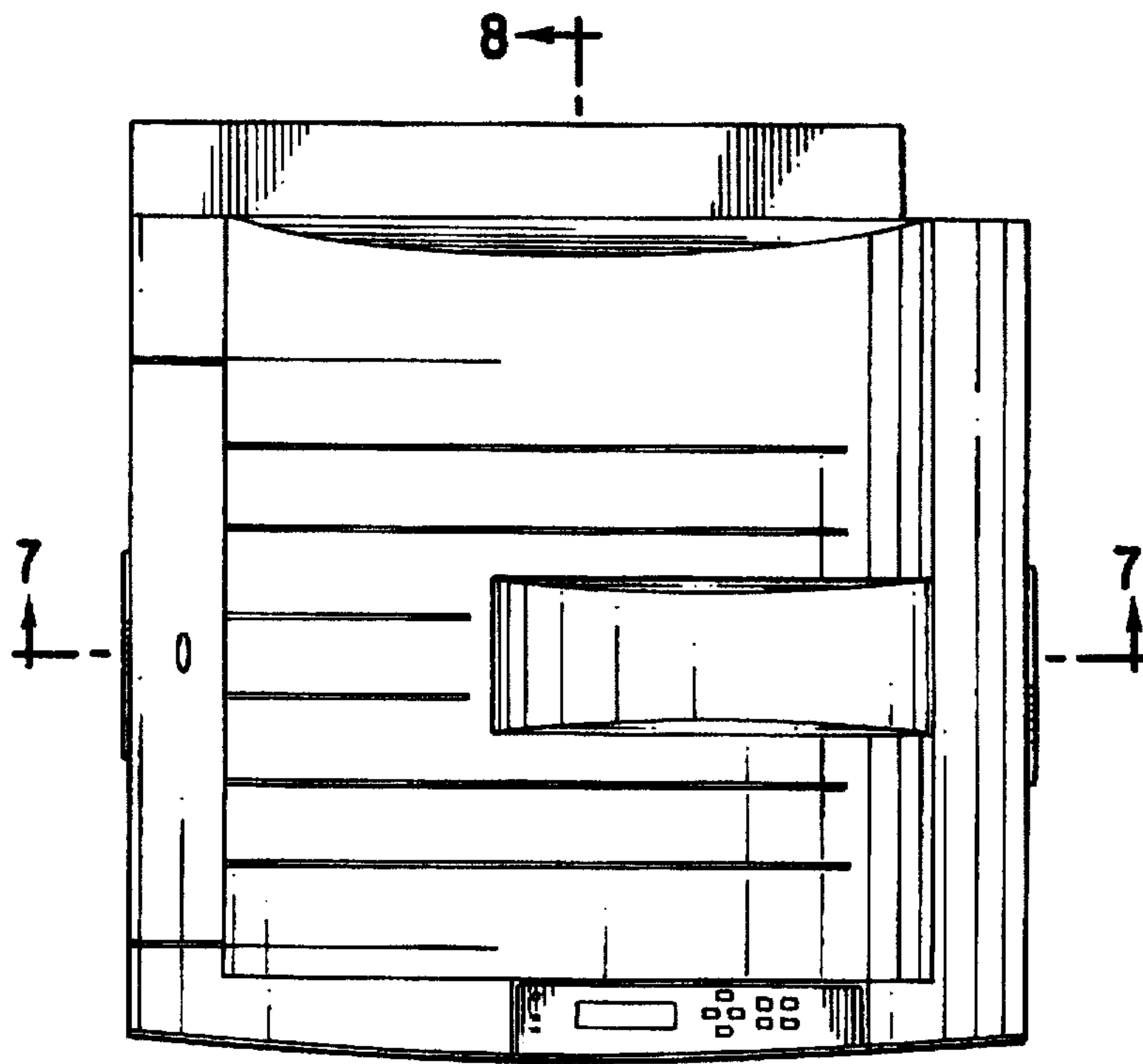

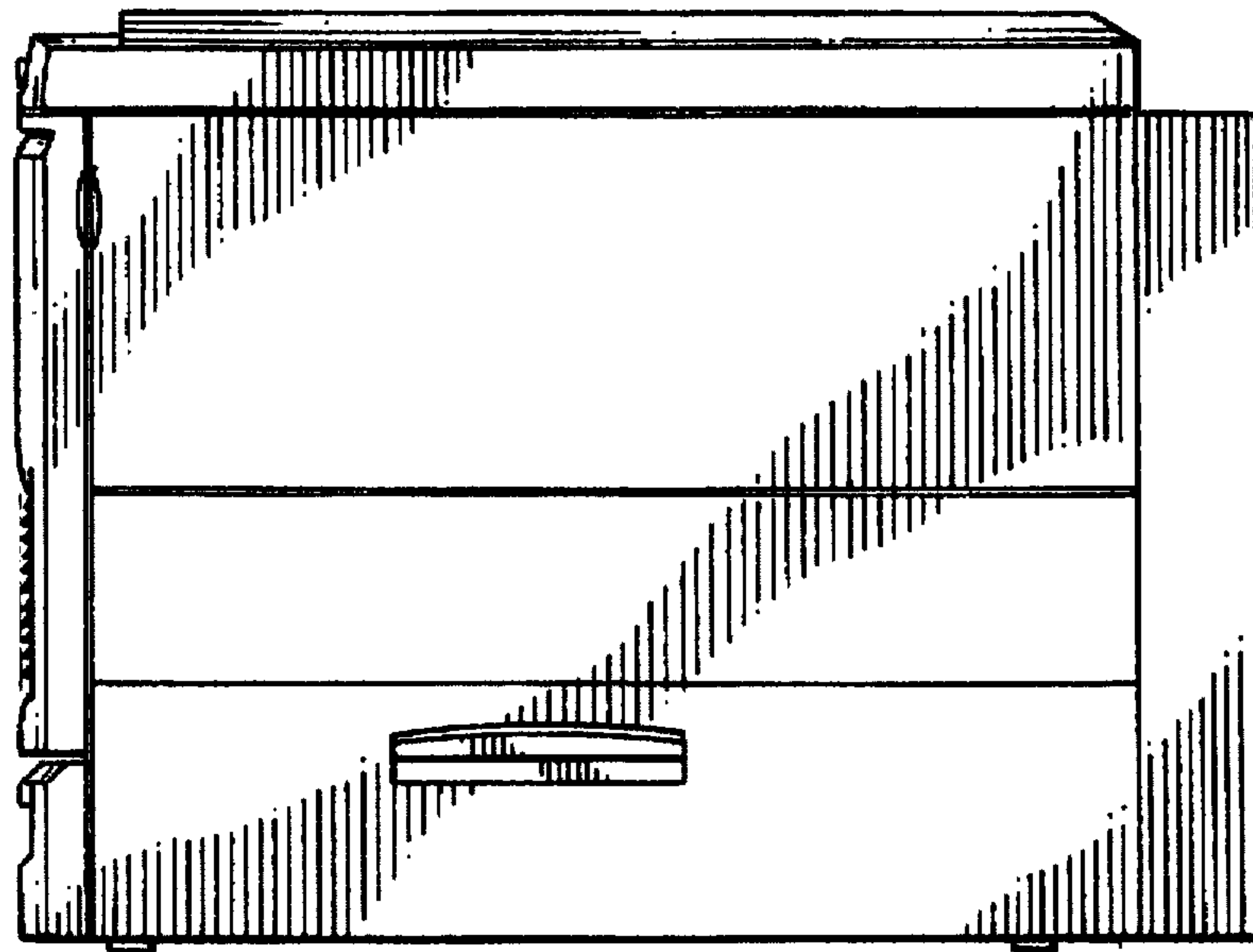

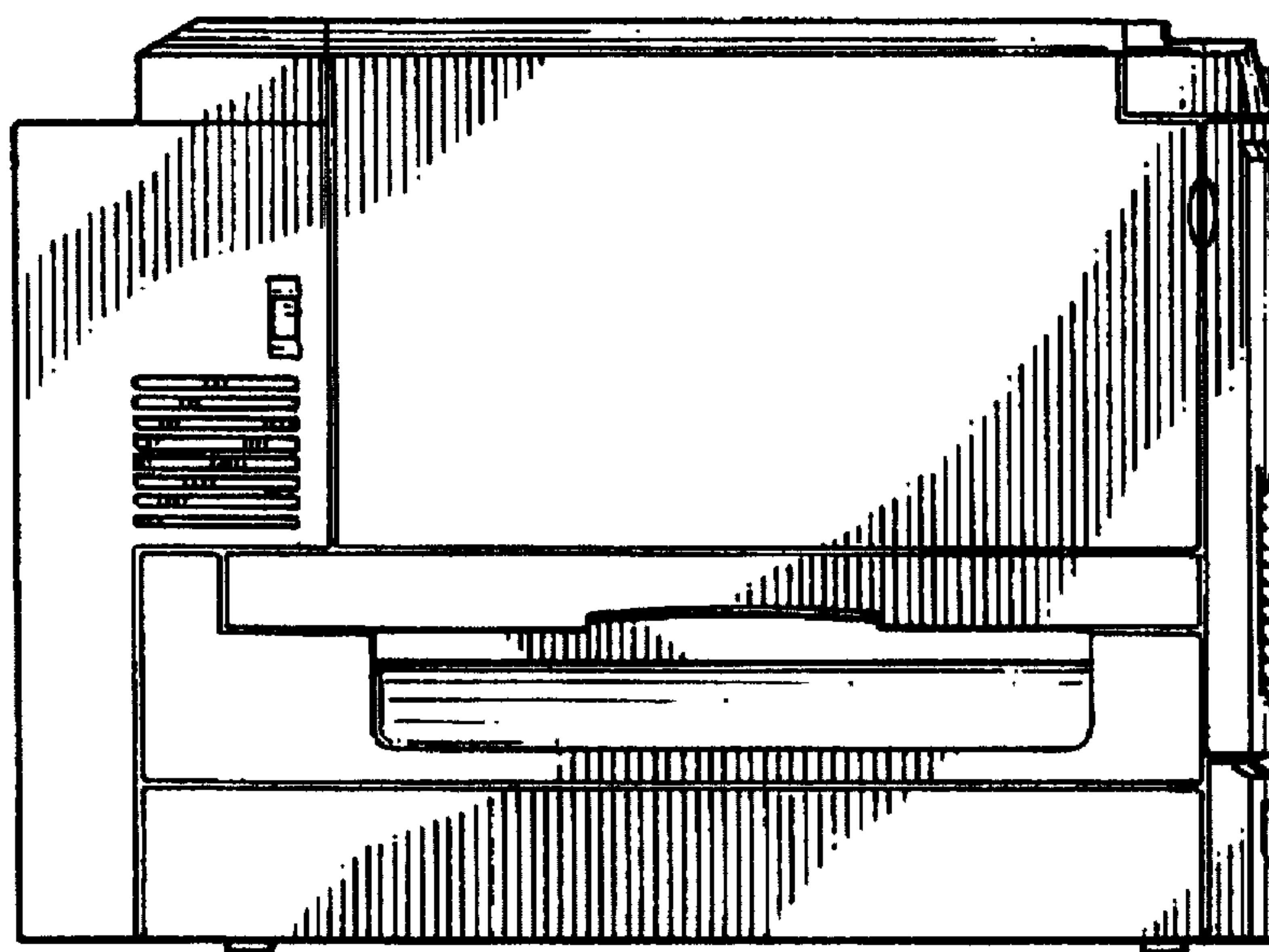

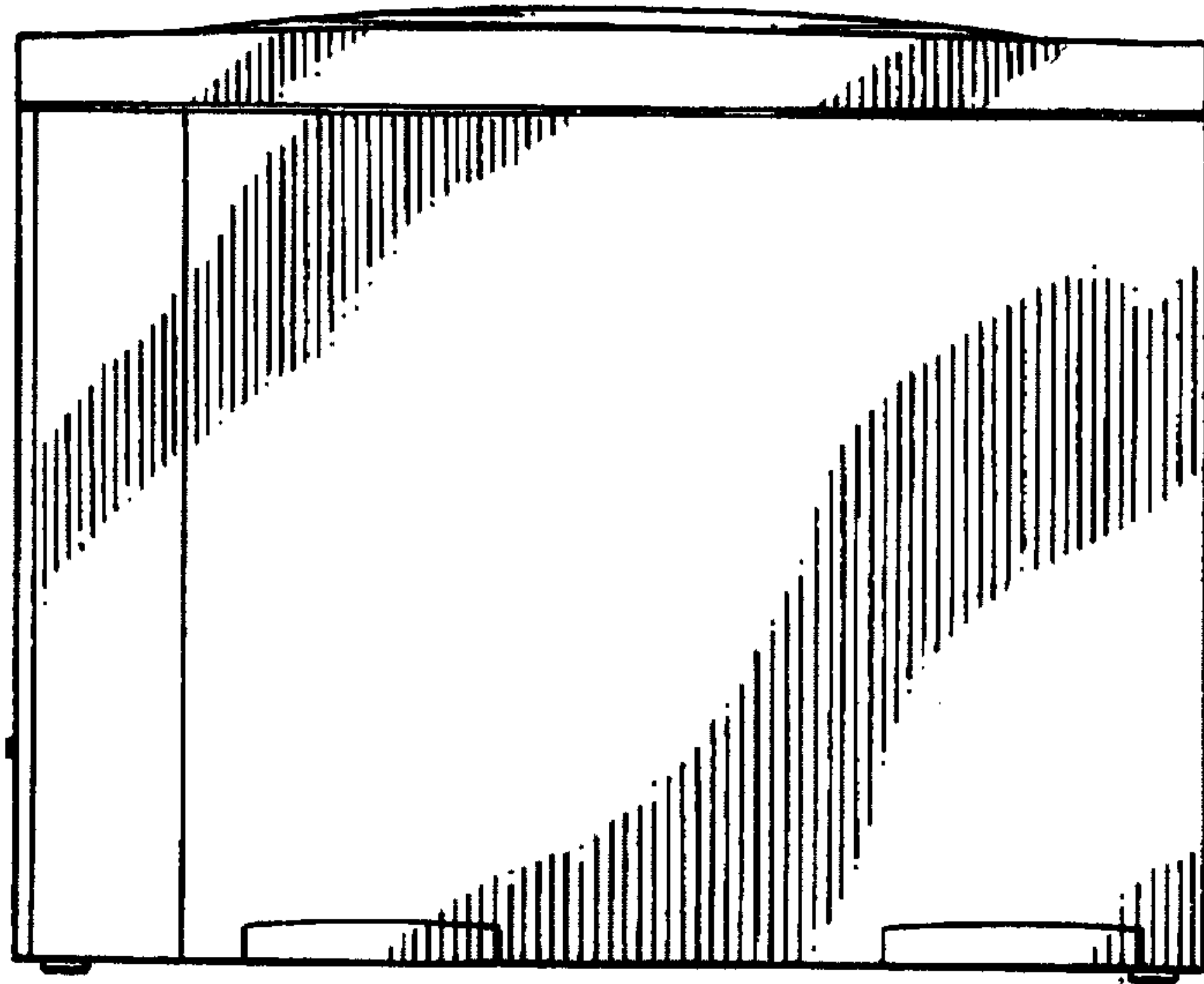

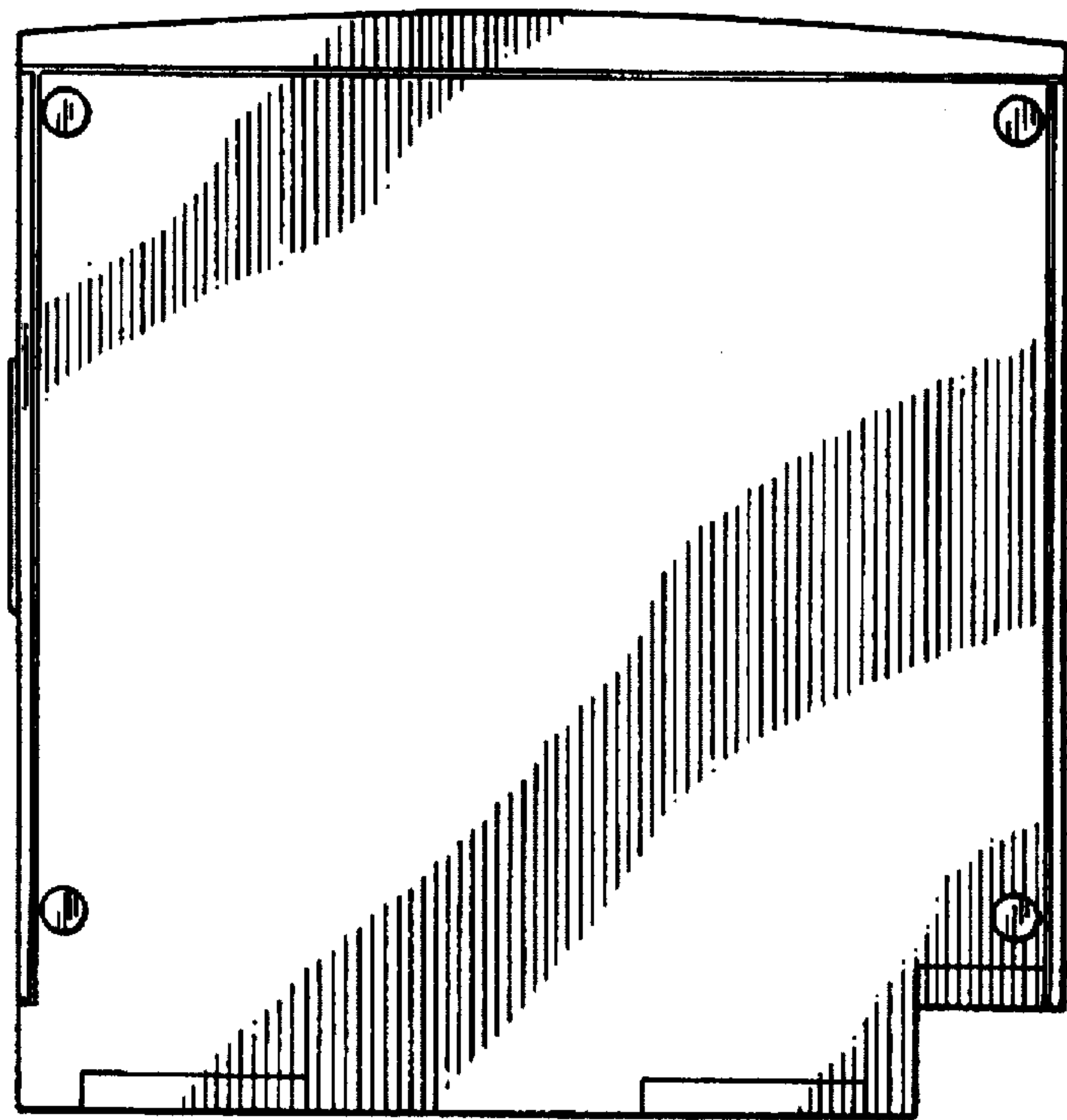

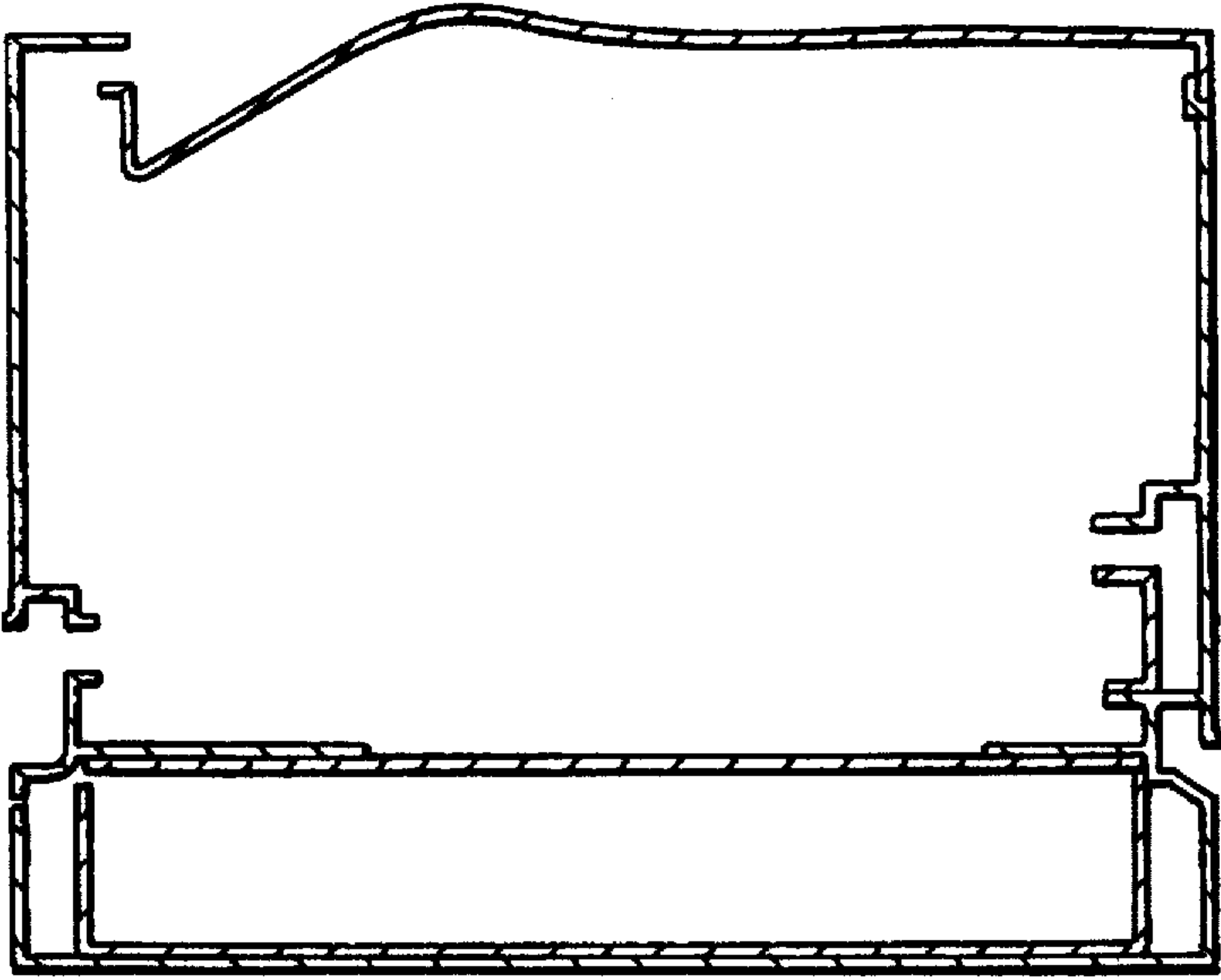

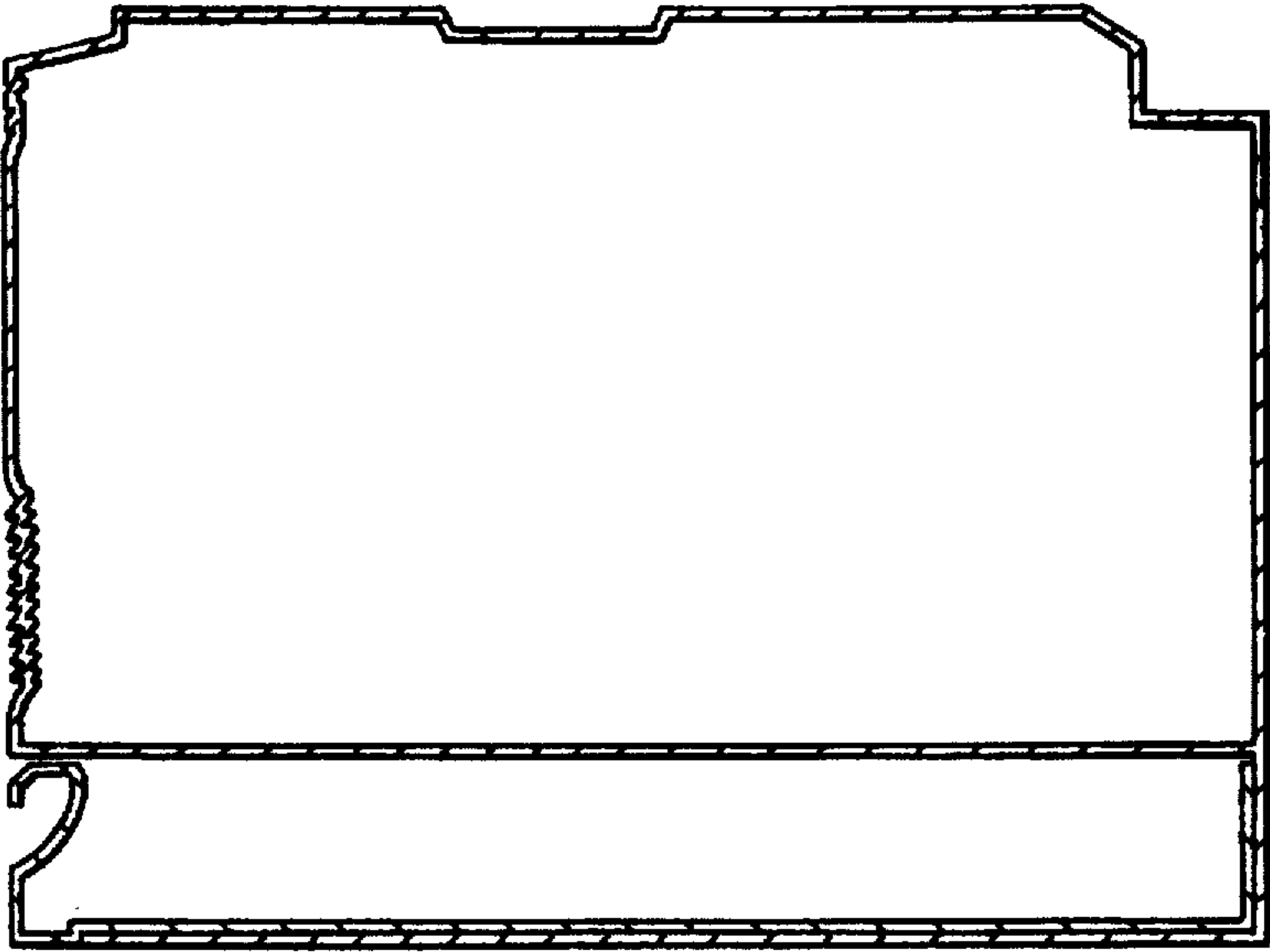

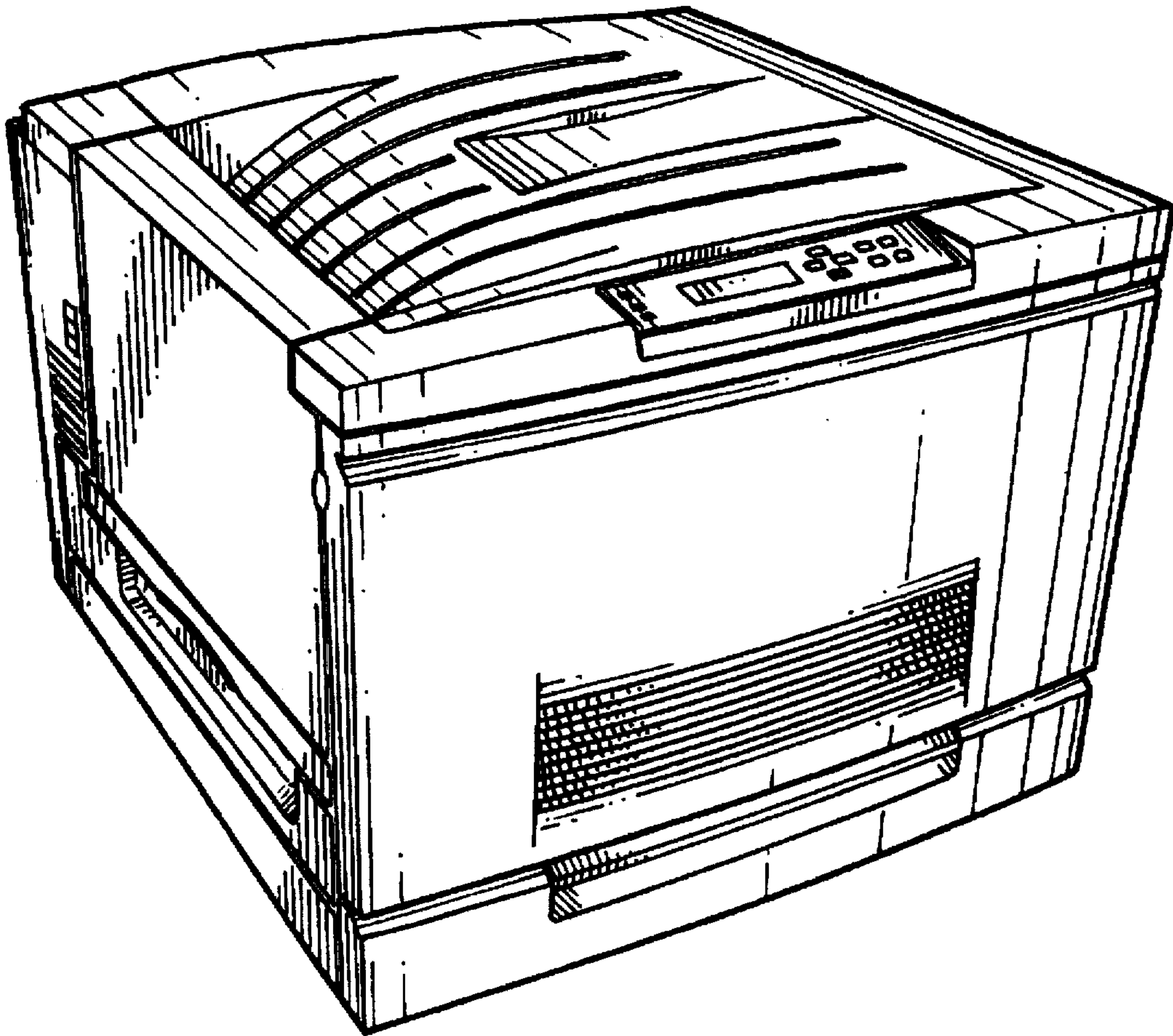
