### [57] CLAIM

The ornamental design for a combined ceiling fan housing and lighting assembly mount, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a combined ceiling fan housing and lighting assembly mount, showing my new design;

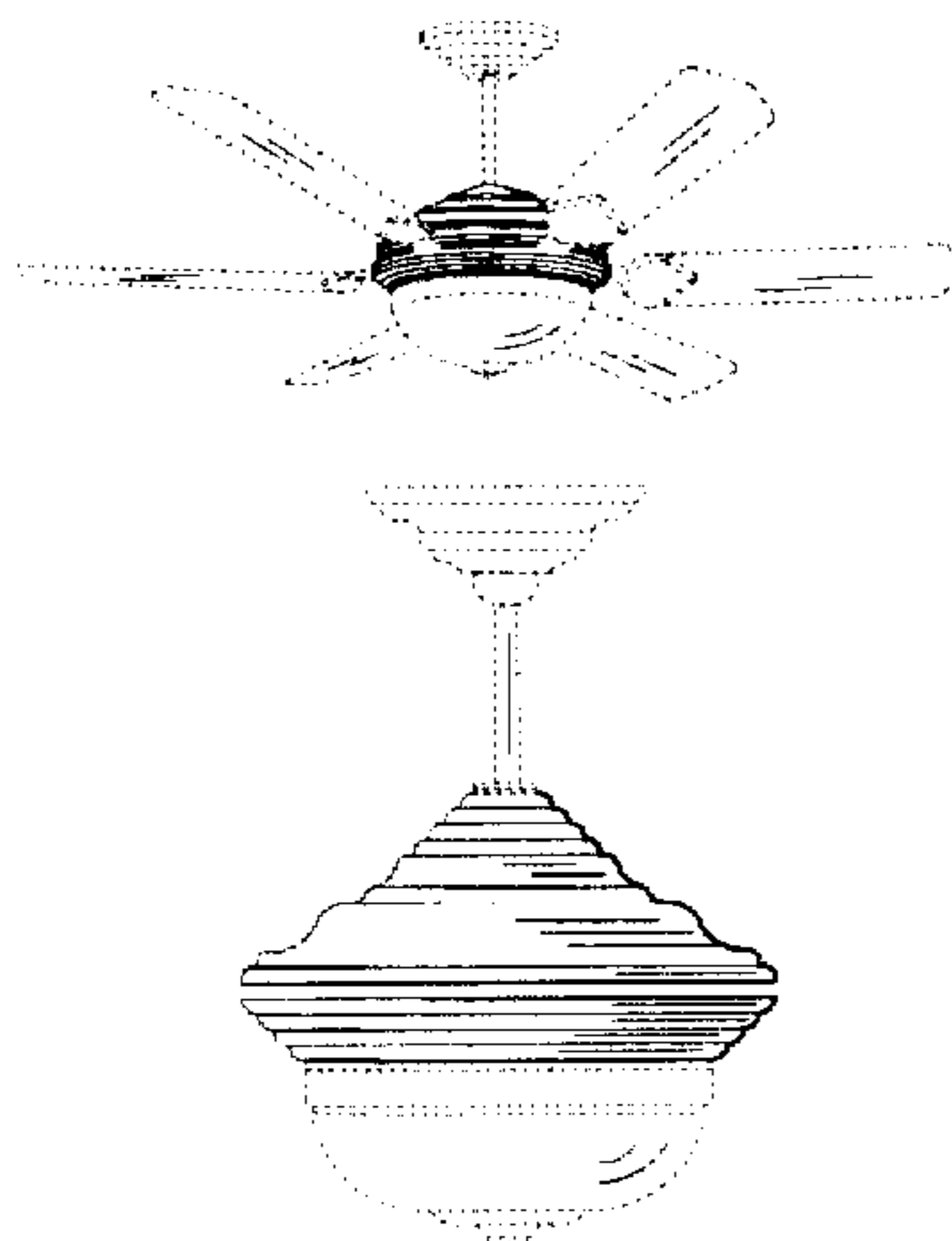
FIG. 2 is an enlarged side view thereof, the other sides being identical to that shown;

FIG. 3 is an enlarged top view thereof; and,

FIG. 4 is an enlarged bottom view thereof.

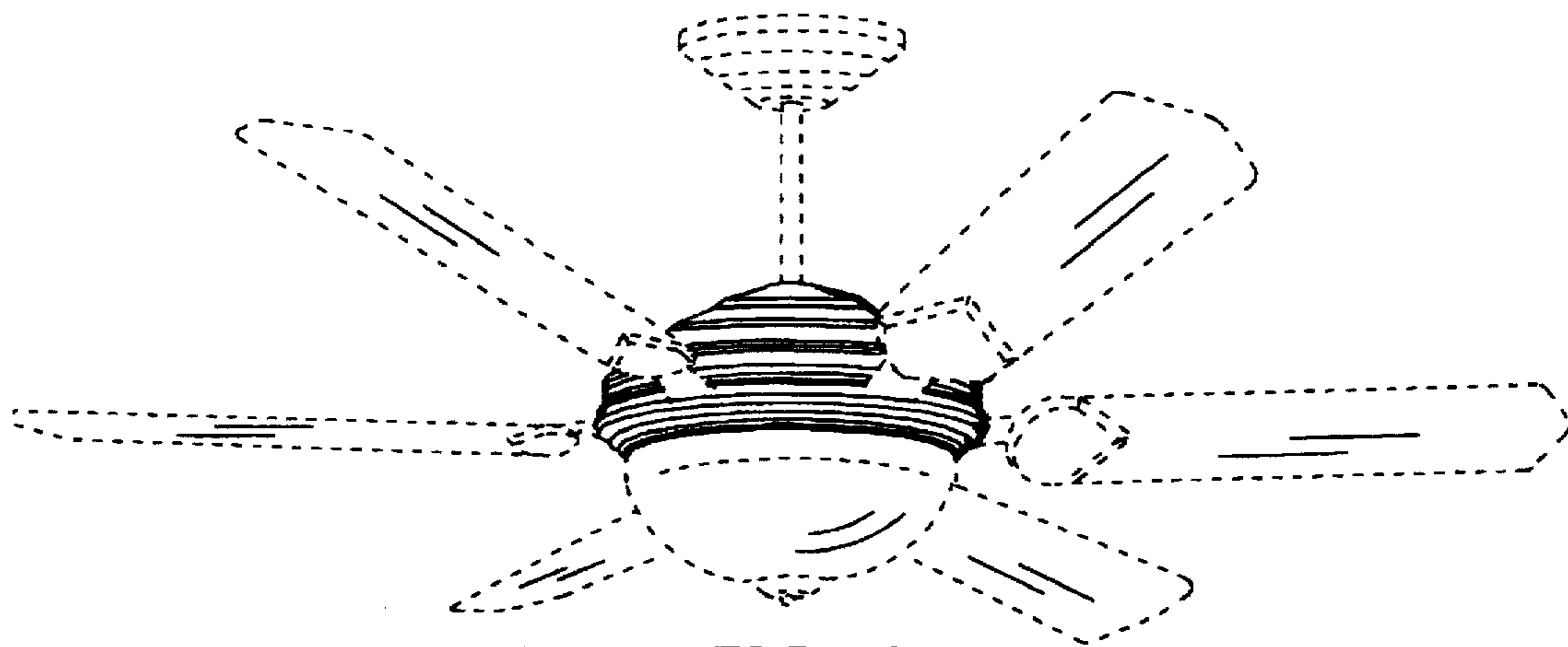

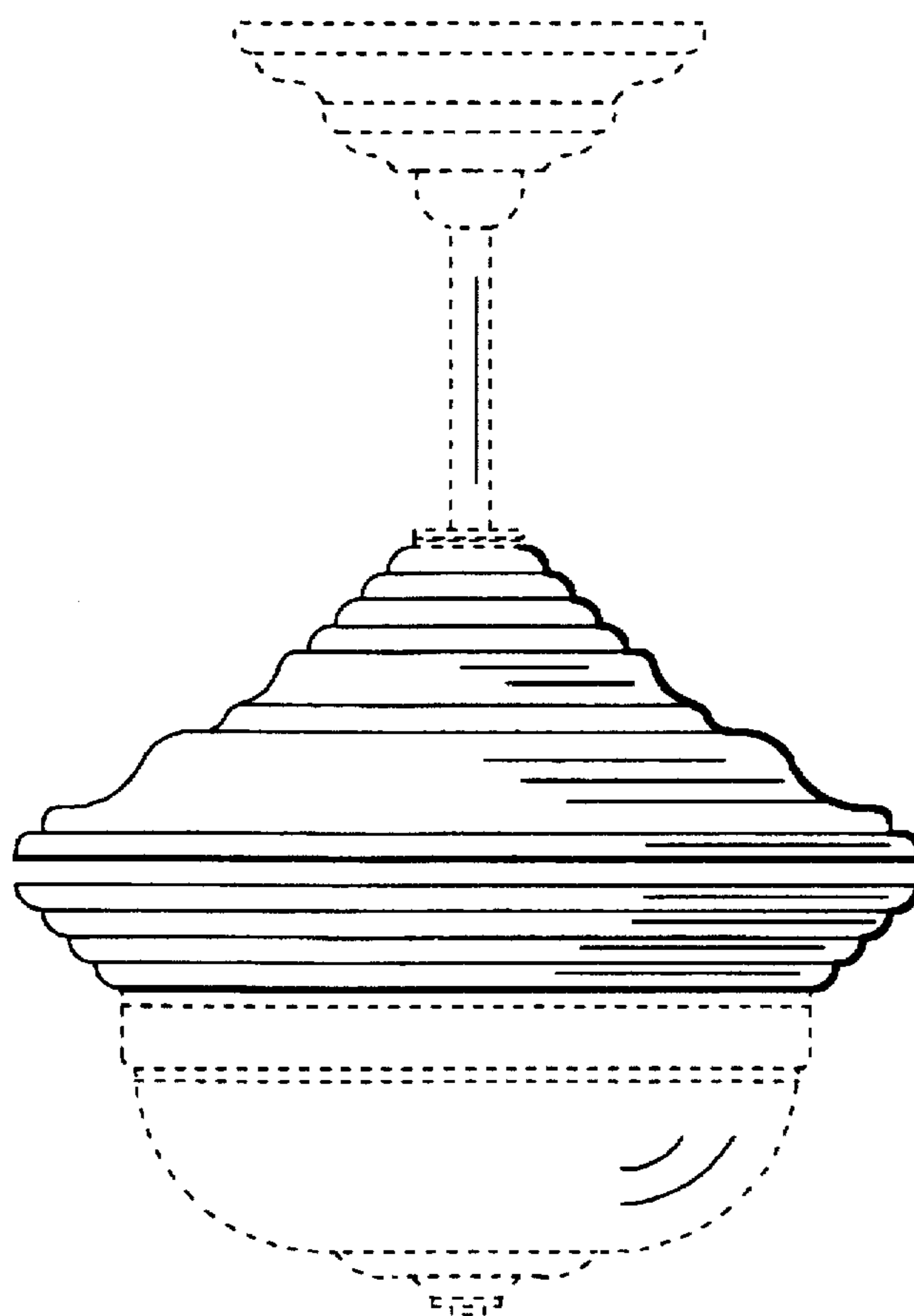

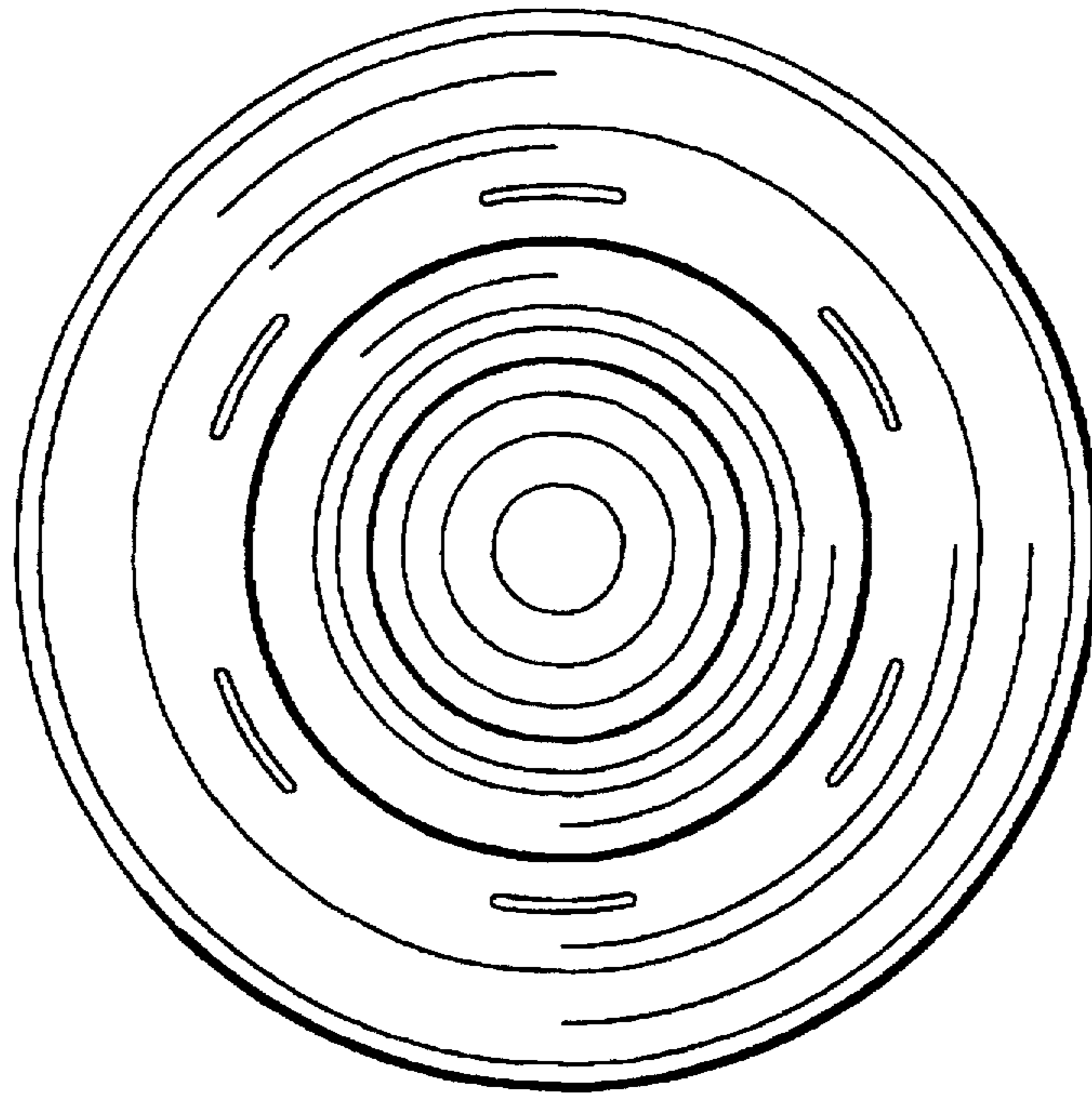

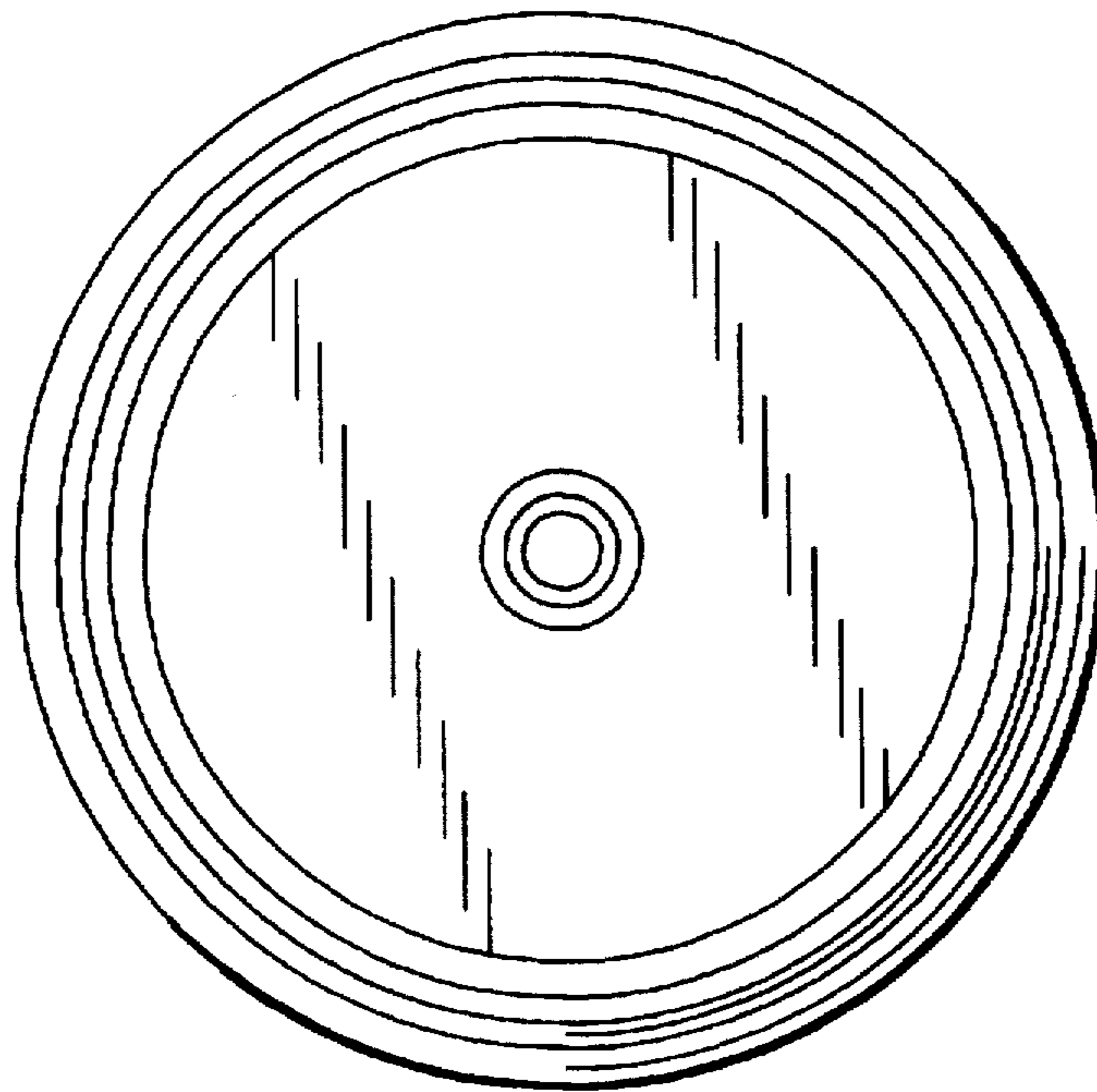
