The ornamental design for a portable stand-alone restroom facility having handicap access, as shown and described.

DESCRIPTION

- FIG. 12 is a top plan view thereof.

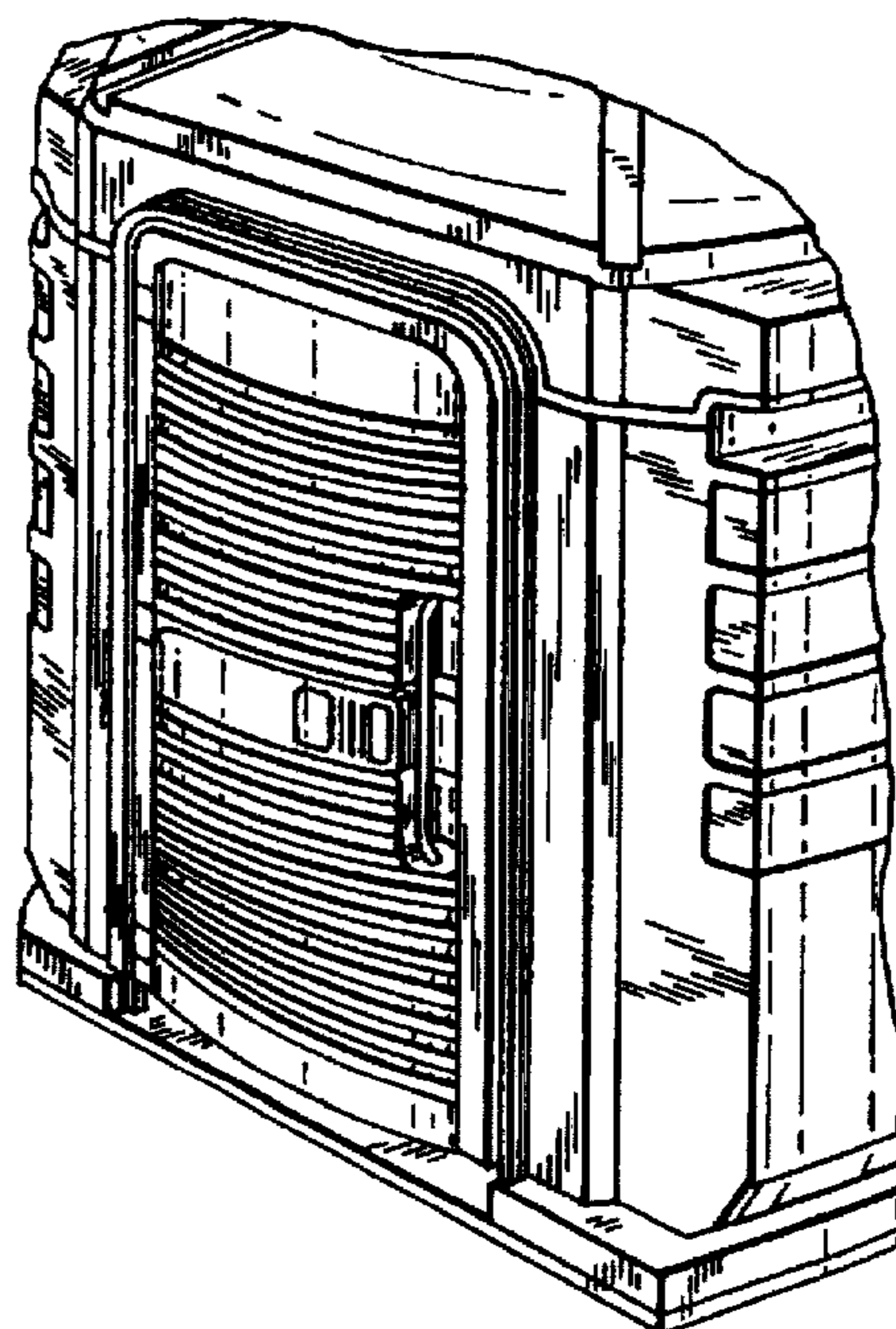
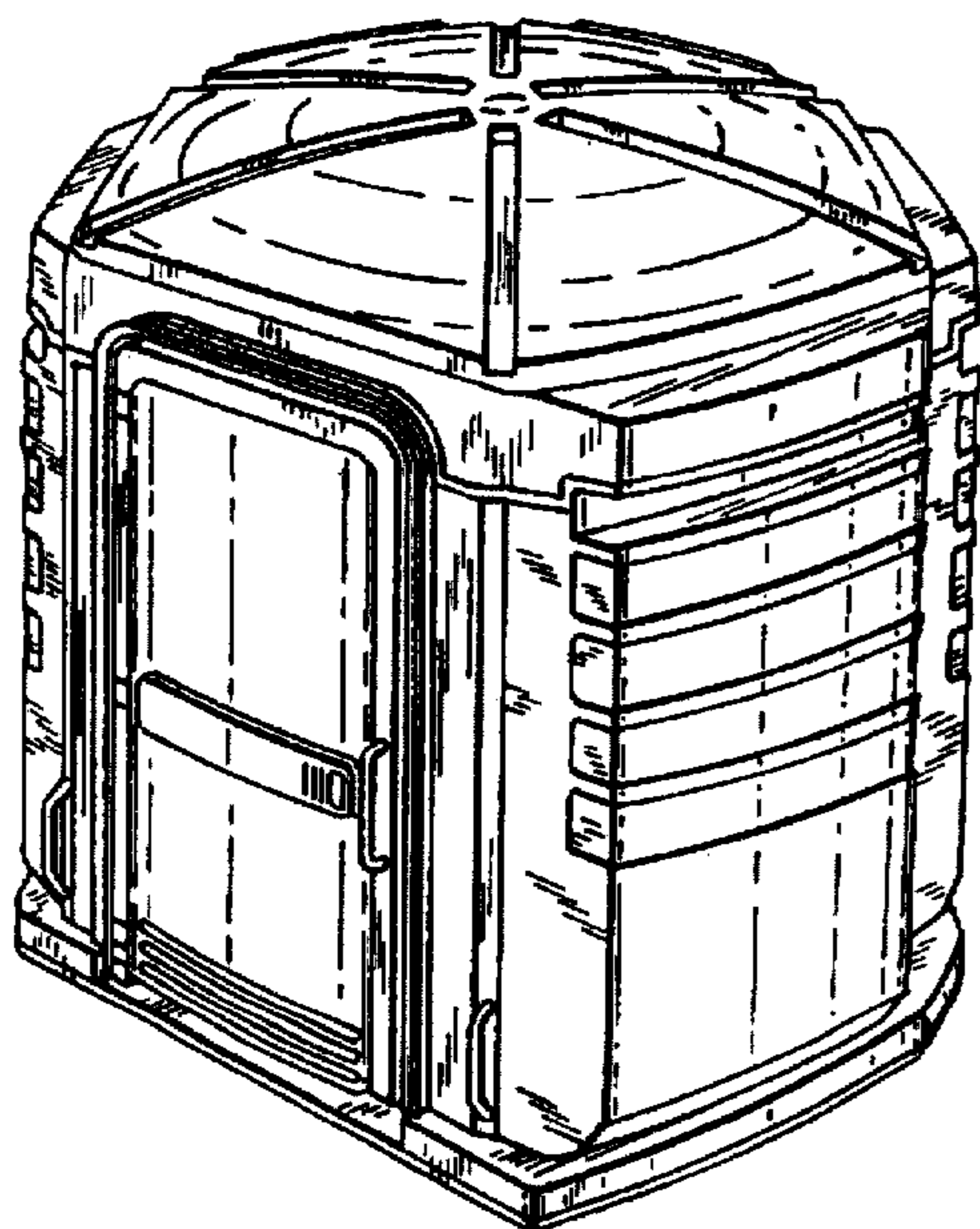
The remainder of the second embodiment not shown is identical to corresponding portions of the first embodiment.

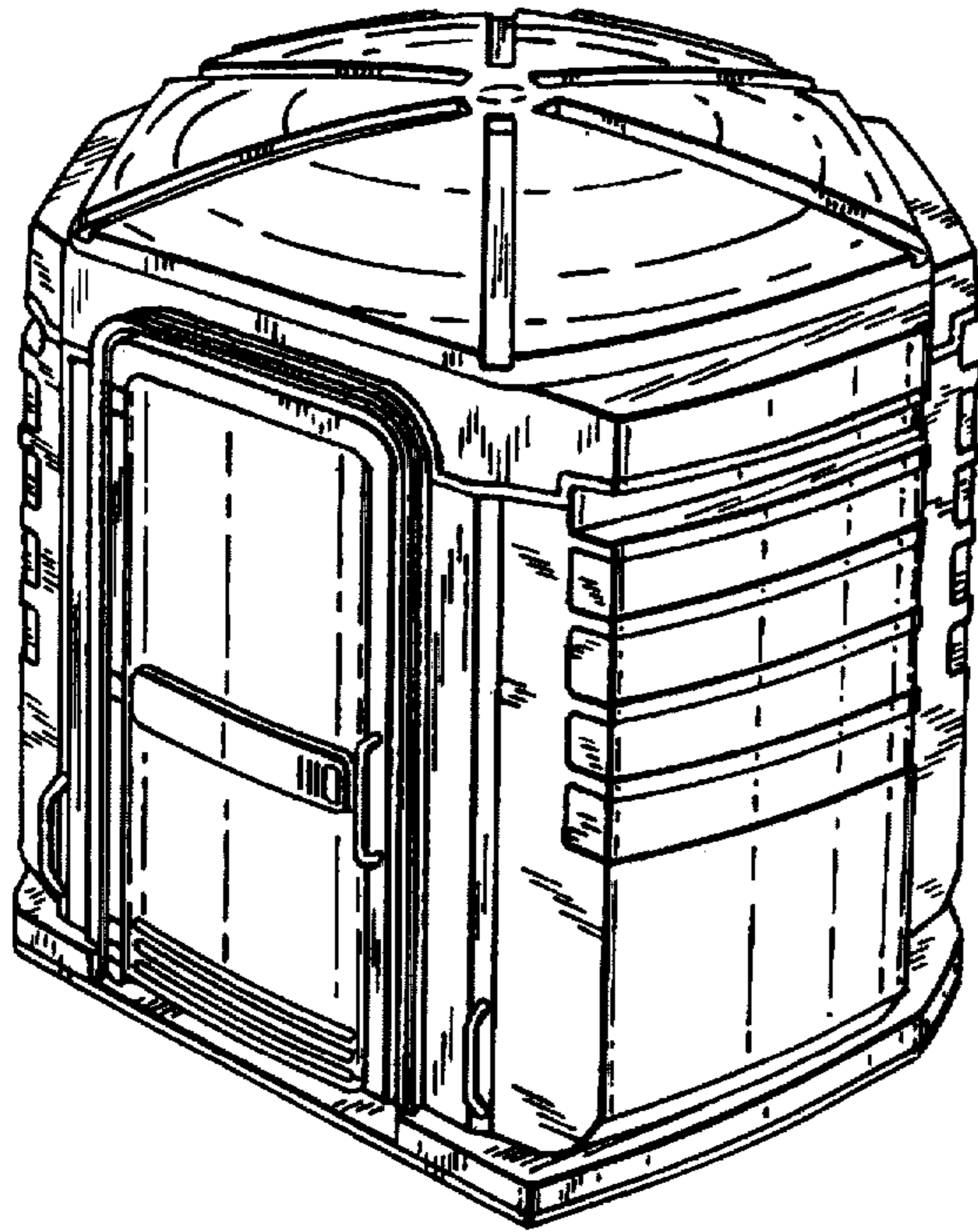

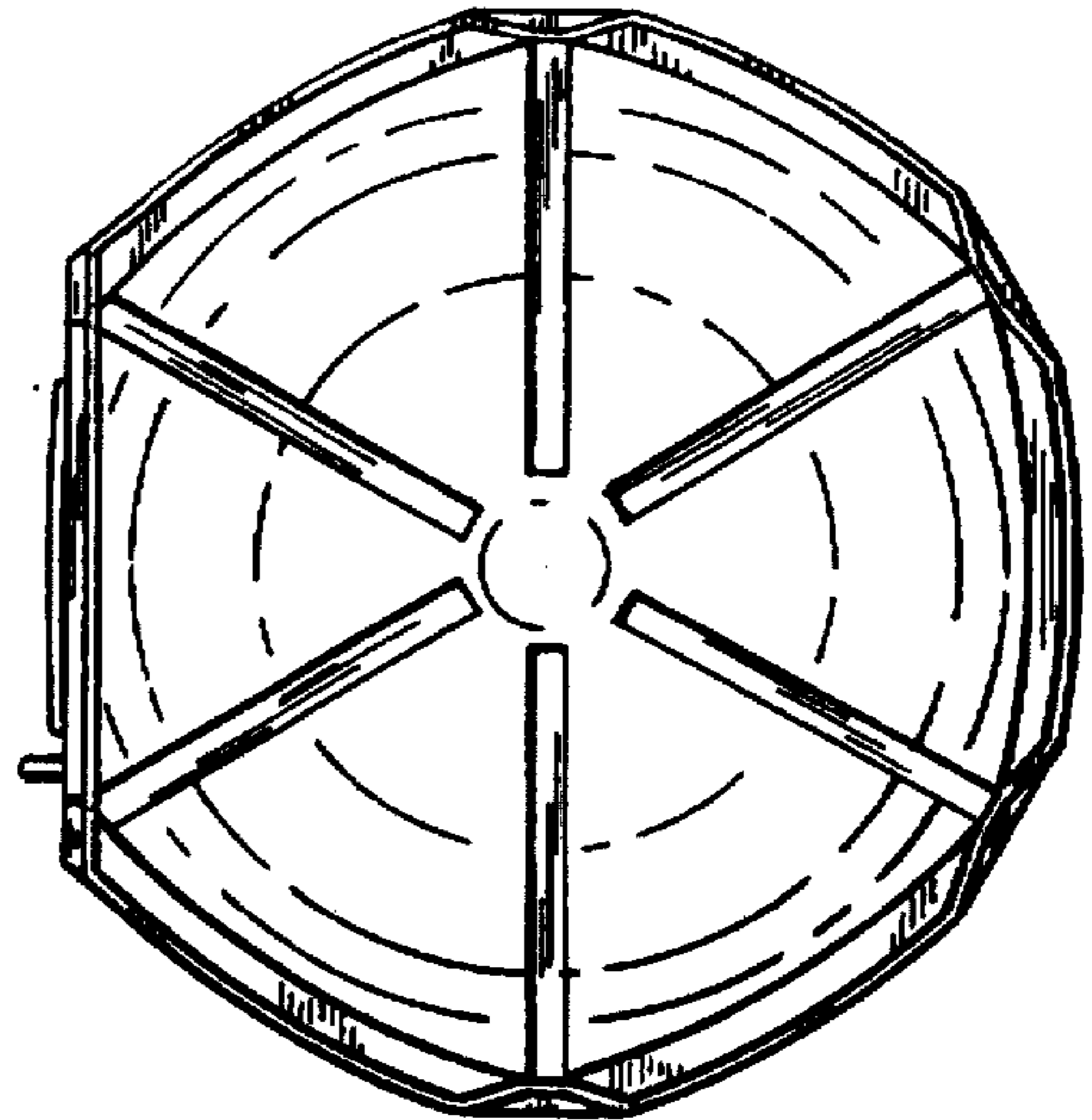

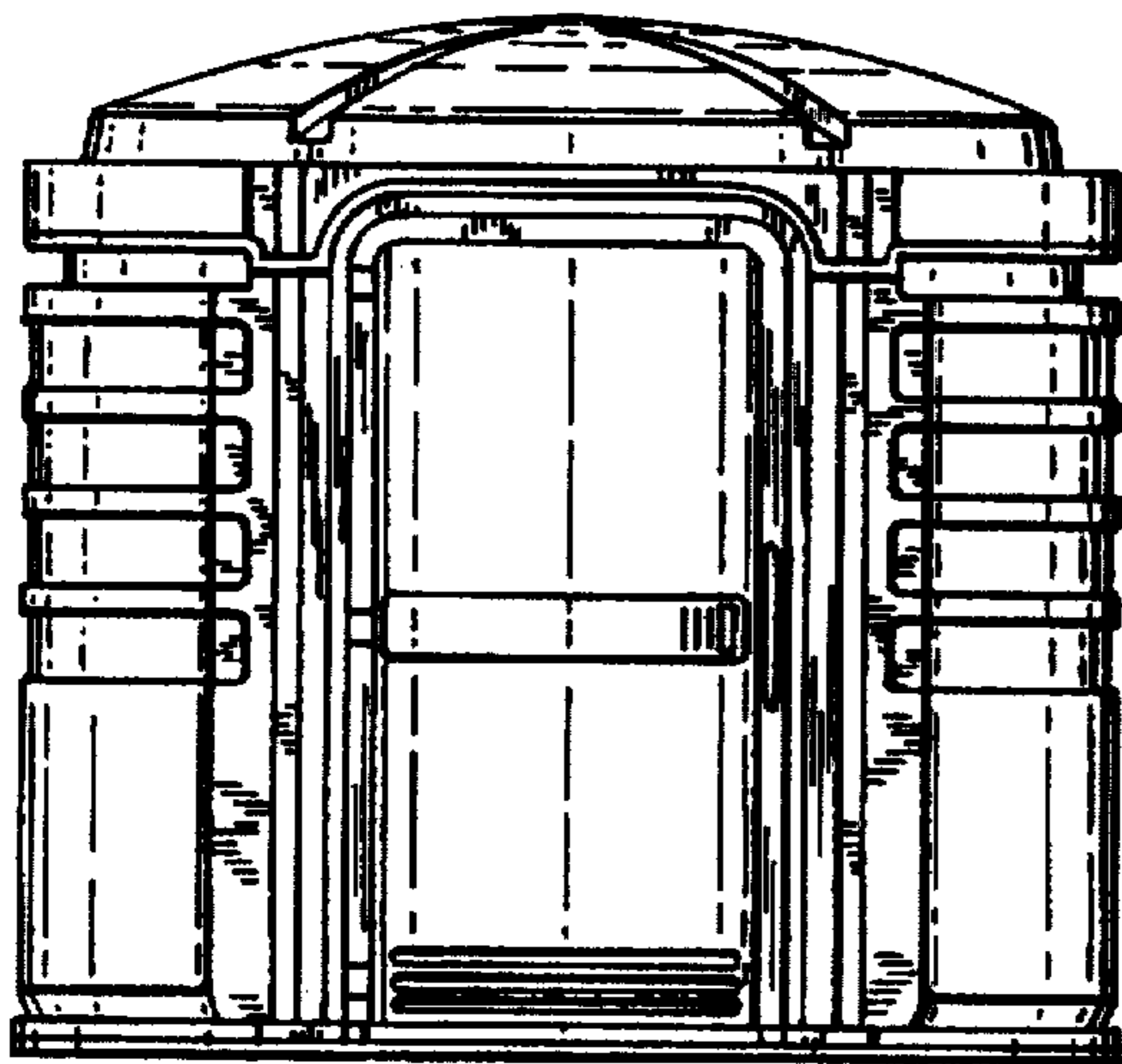

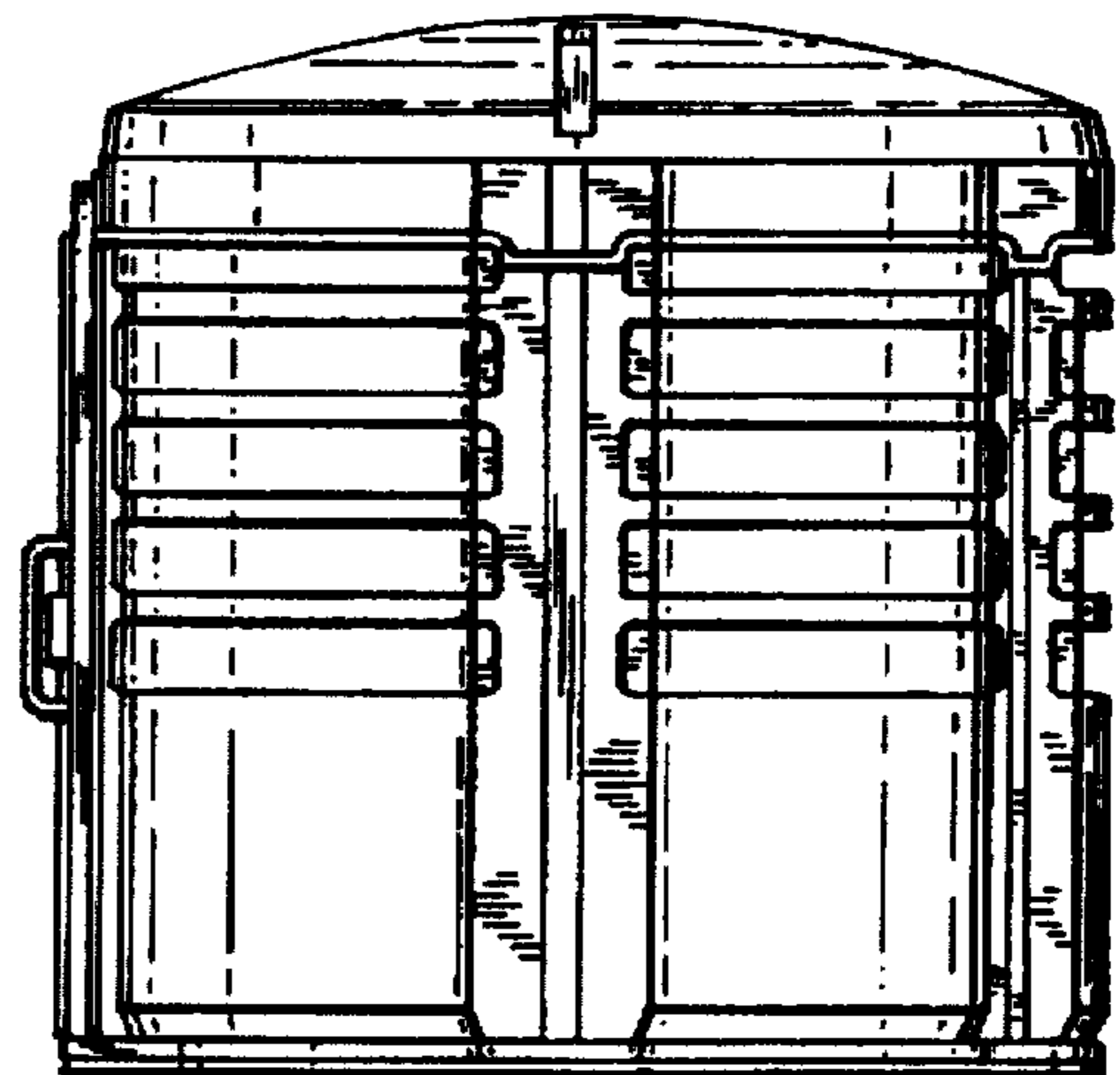

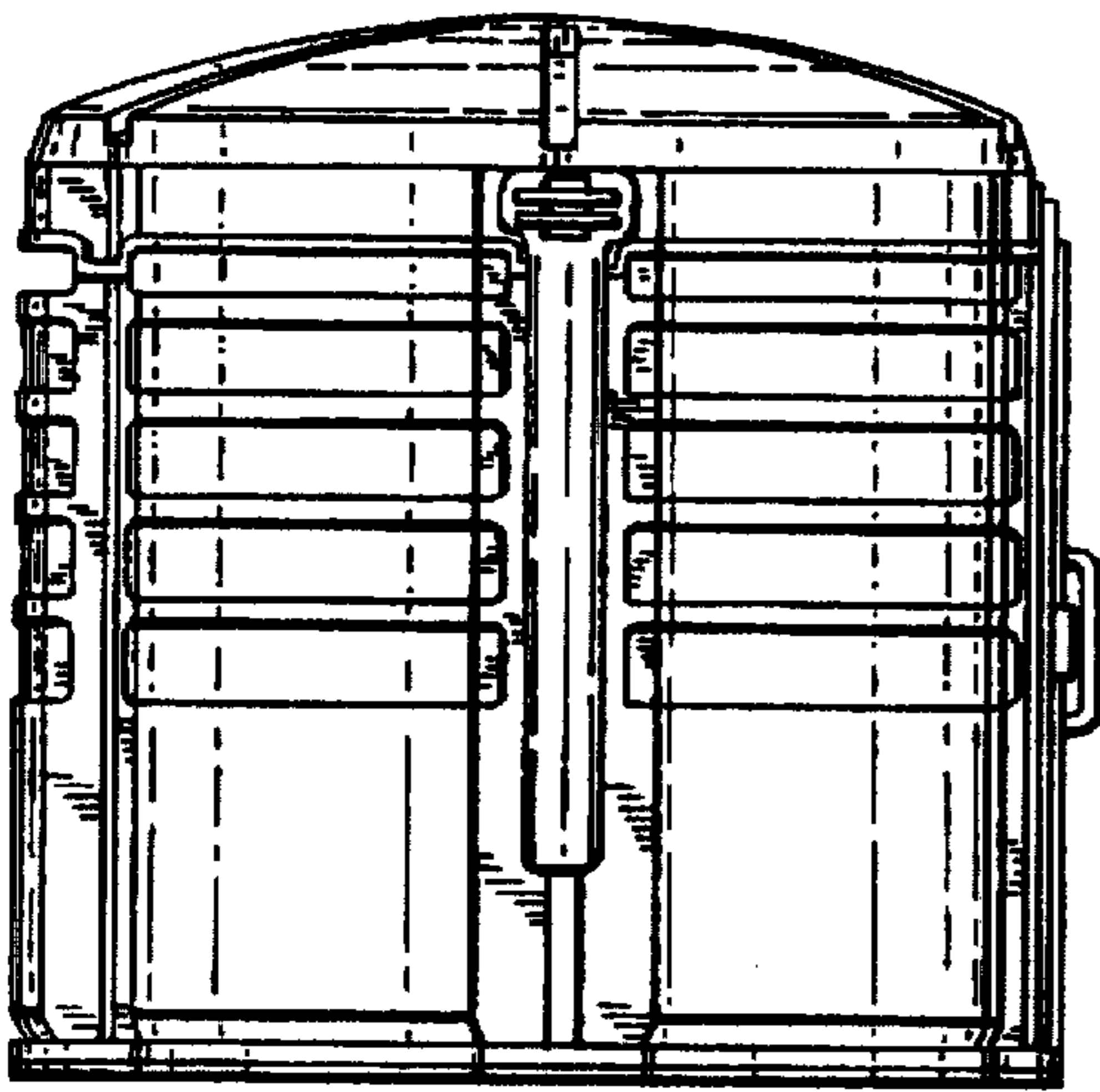

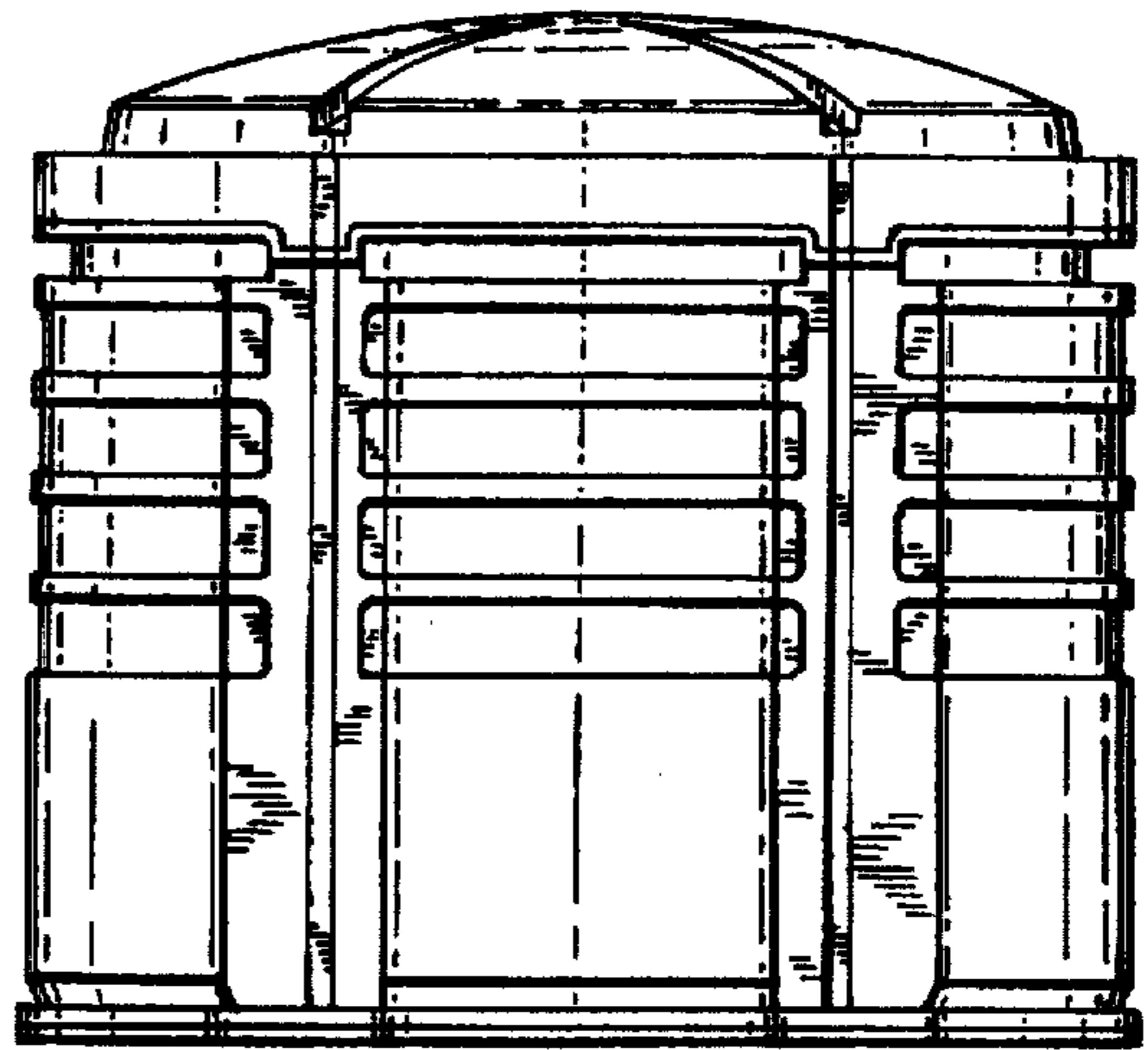

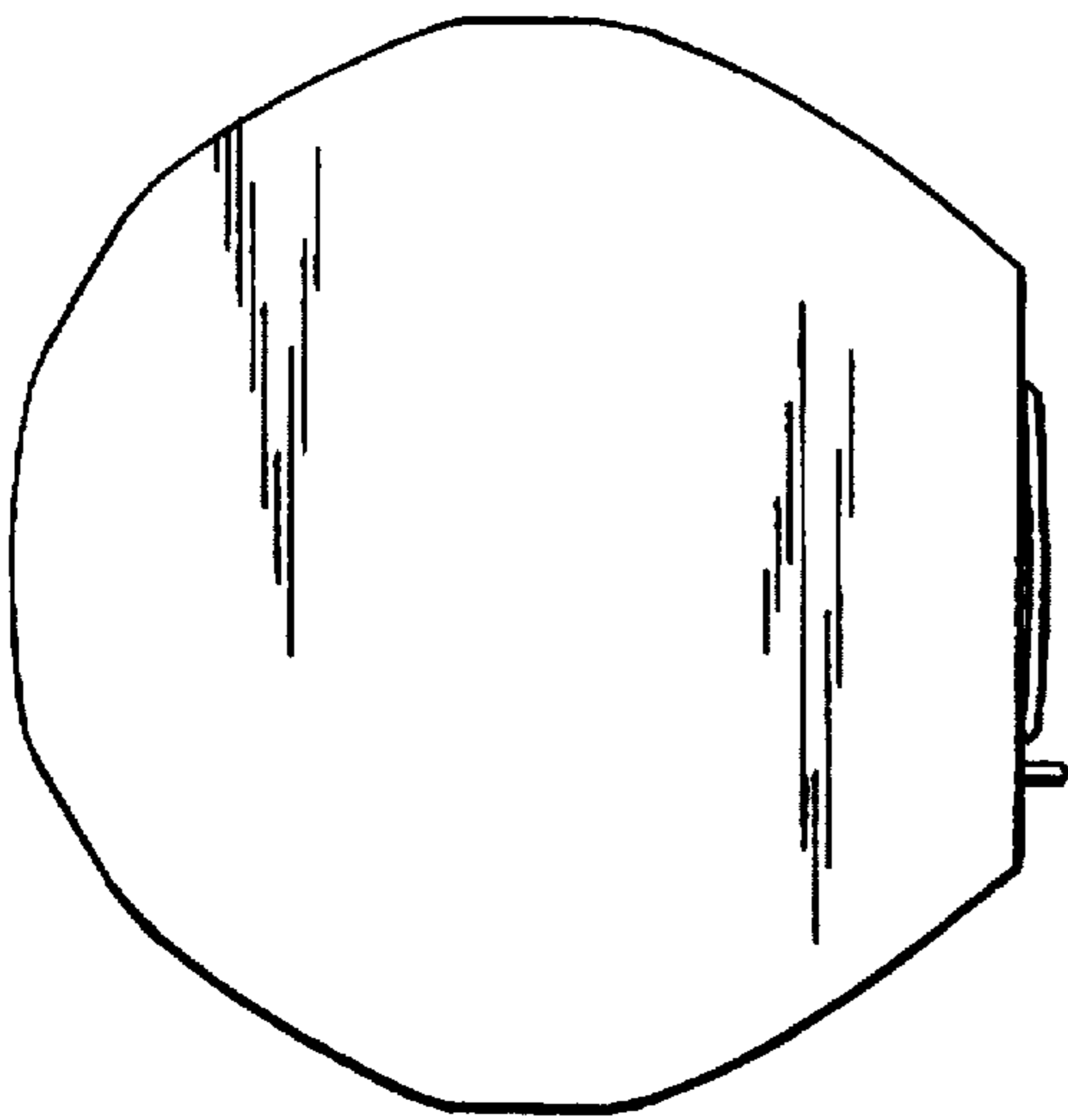

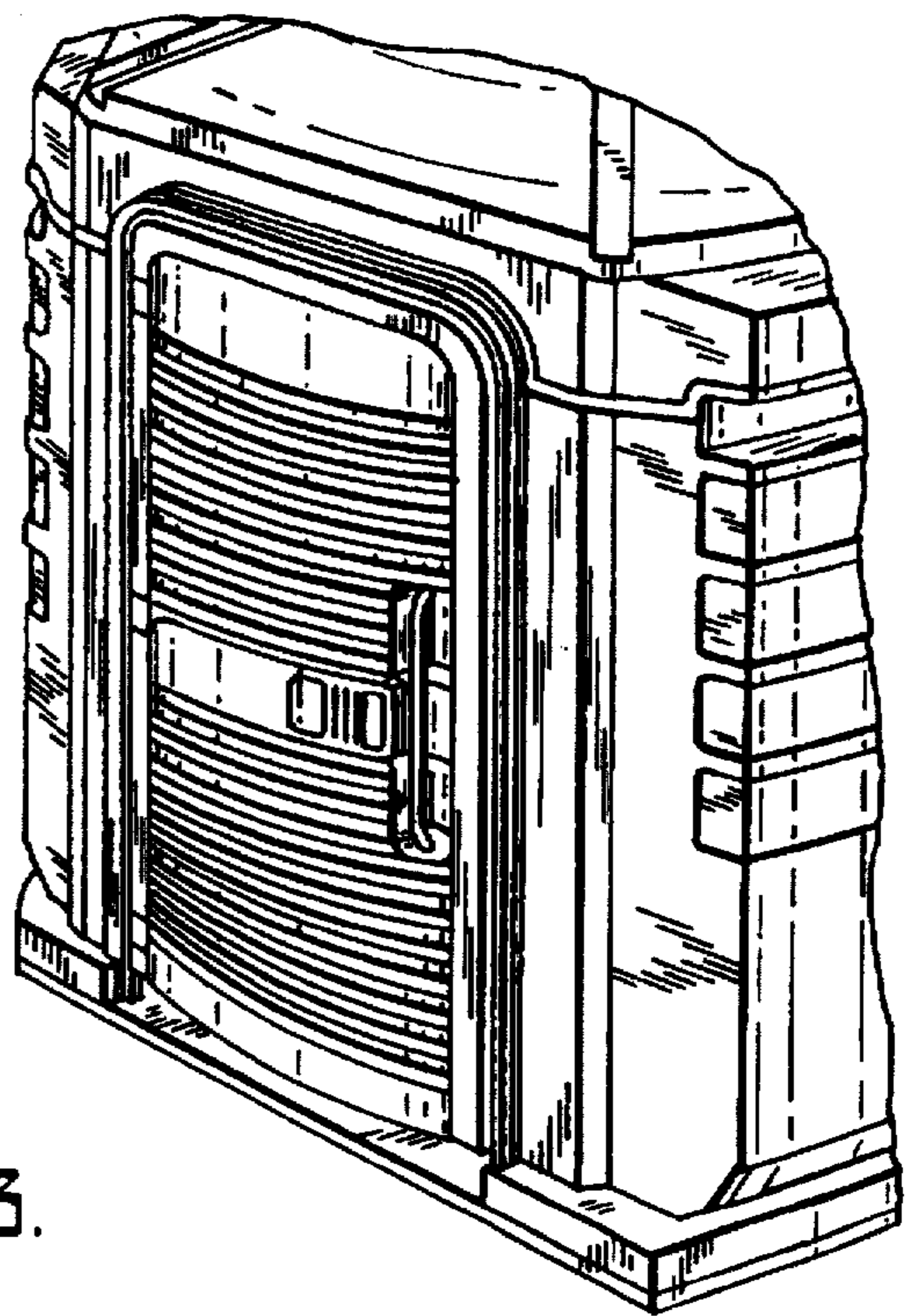

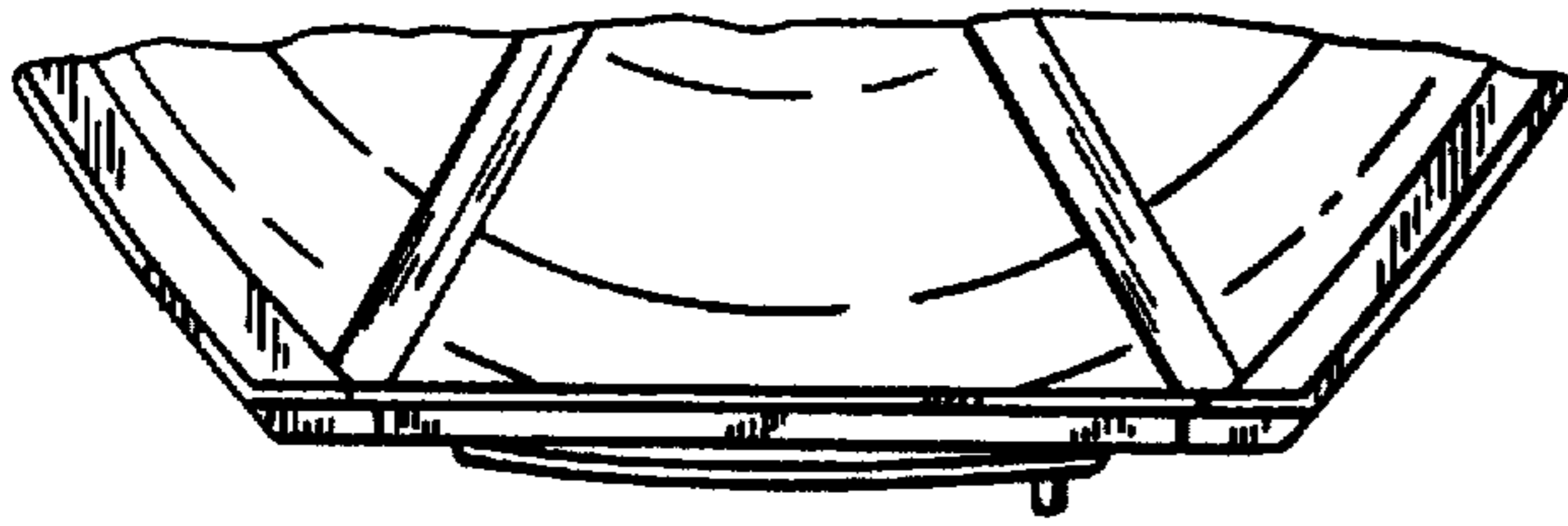

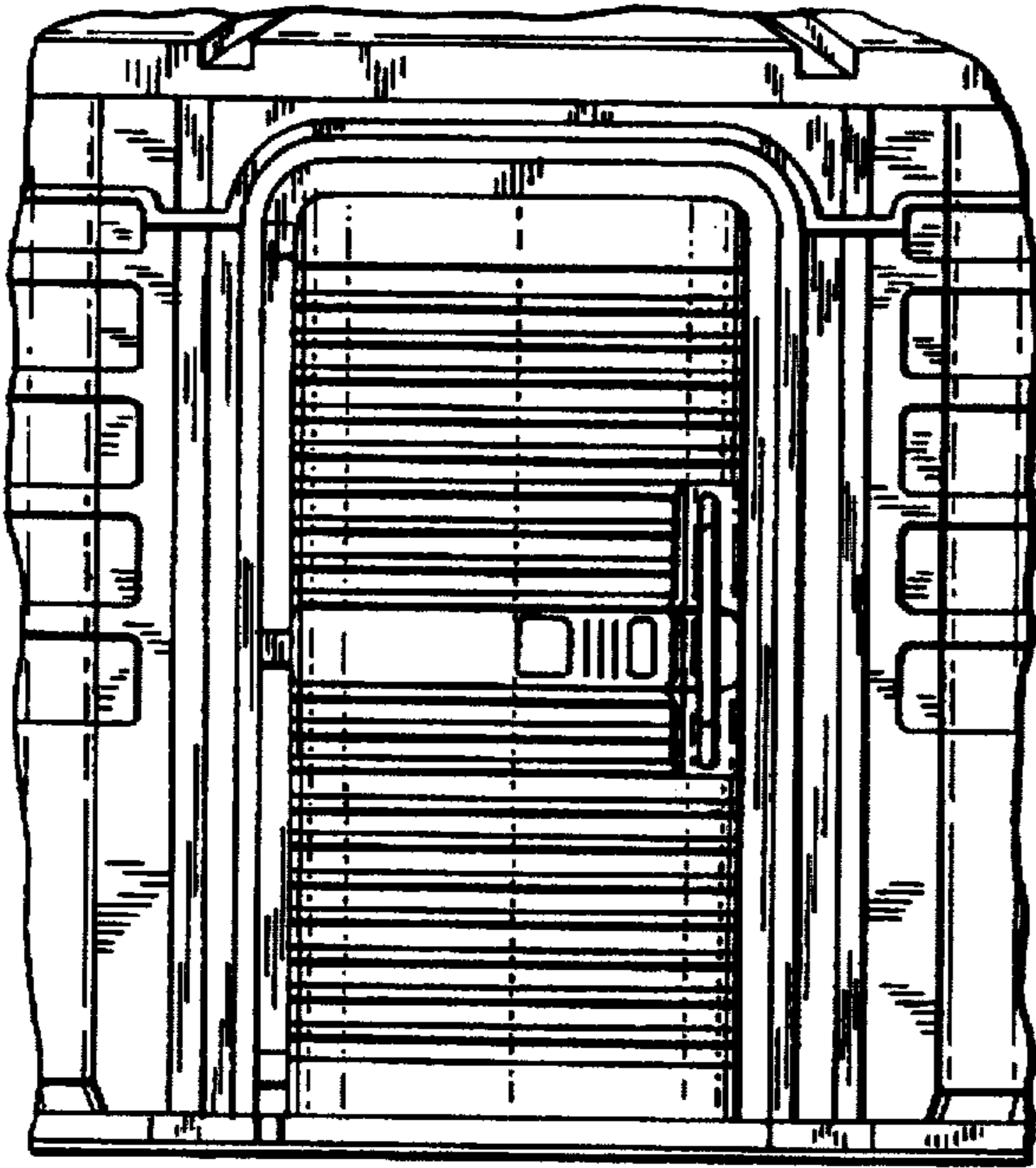

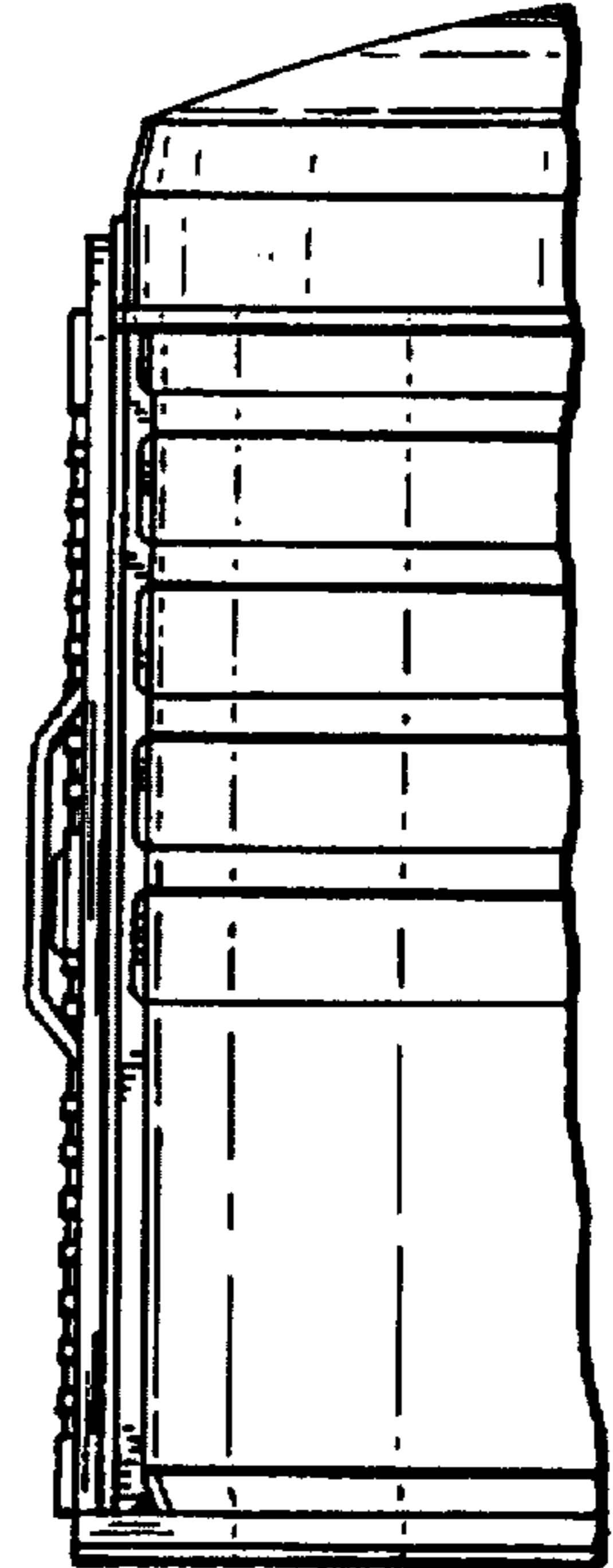

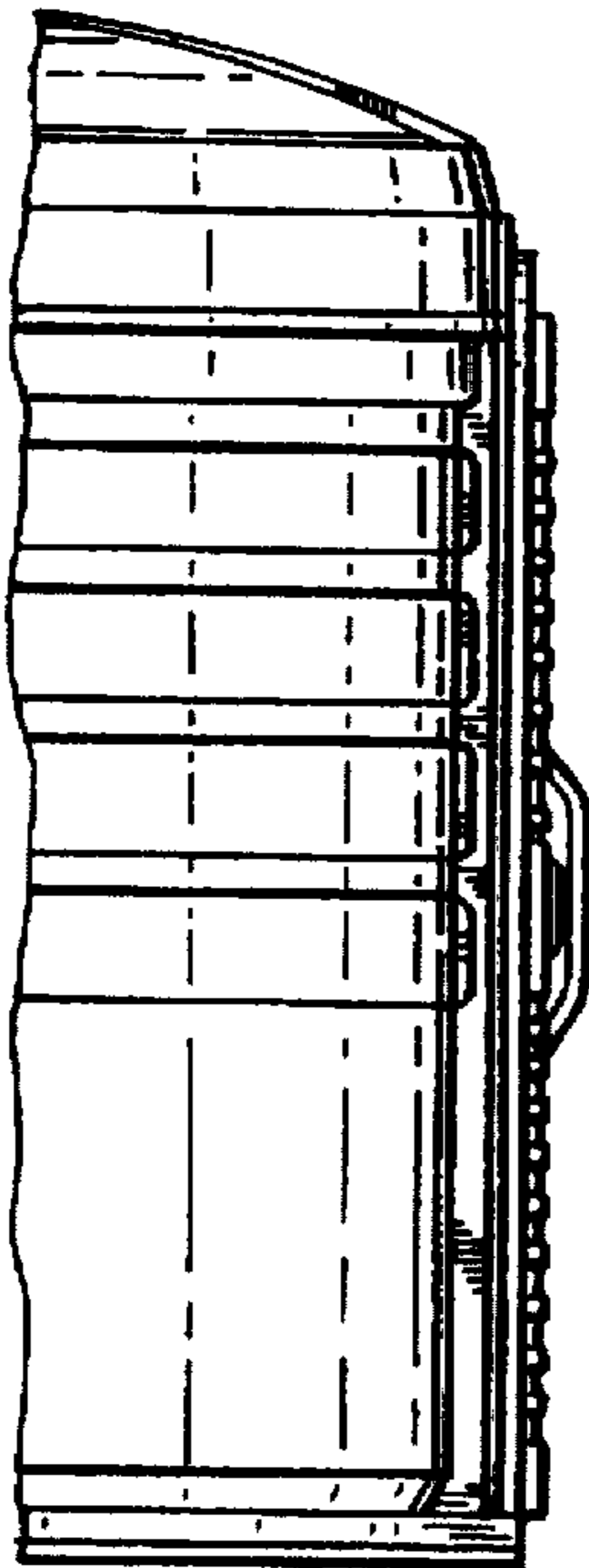
