[57] **CLAIM**

The ornamental design for a big foot carpet mat, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the big foot carpet mat of the present invention;
FIG. 2 is a front elevation view of the big foot carpet mat of FIG. 1;
FIG. 3 is a rear elevation view of the big foot carpet mat of FIGS. 1 and 2;
FIG. 4 is a right side elevation view of the big foot carpet mat;
FIG. 5 is a bottom plan view of the big foot carpet mat; and,
FIG. 6 is a left side elevation view of the big foot carpet mat.

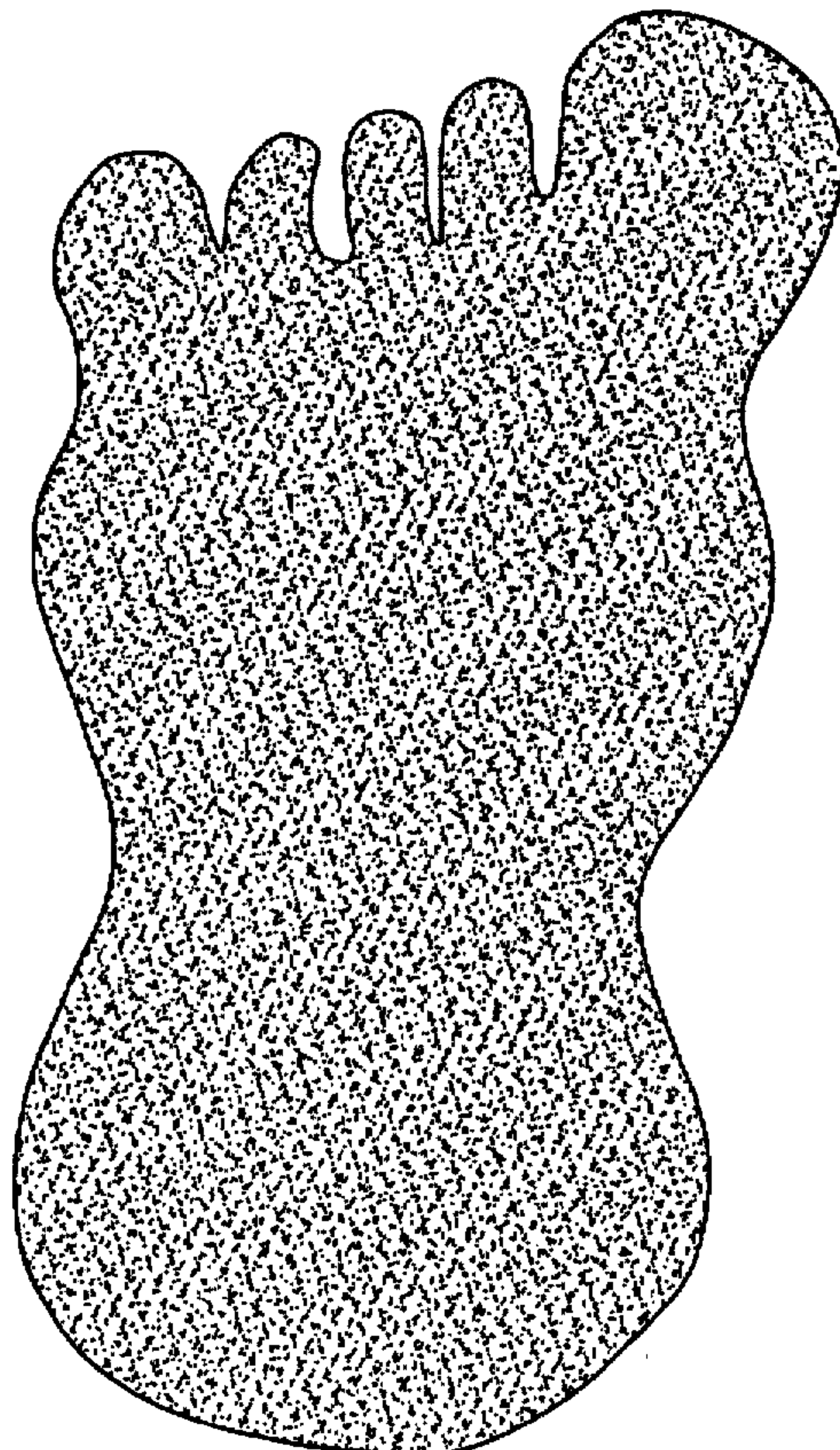

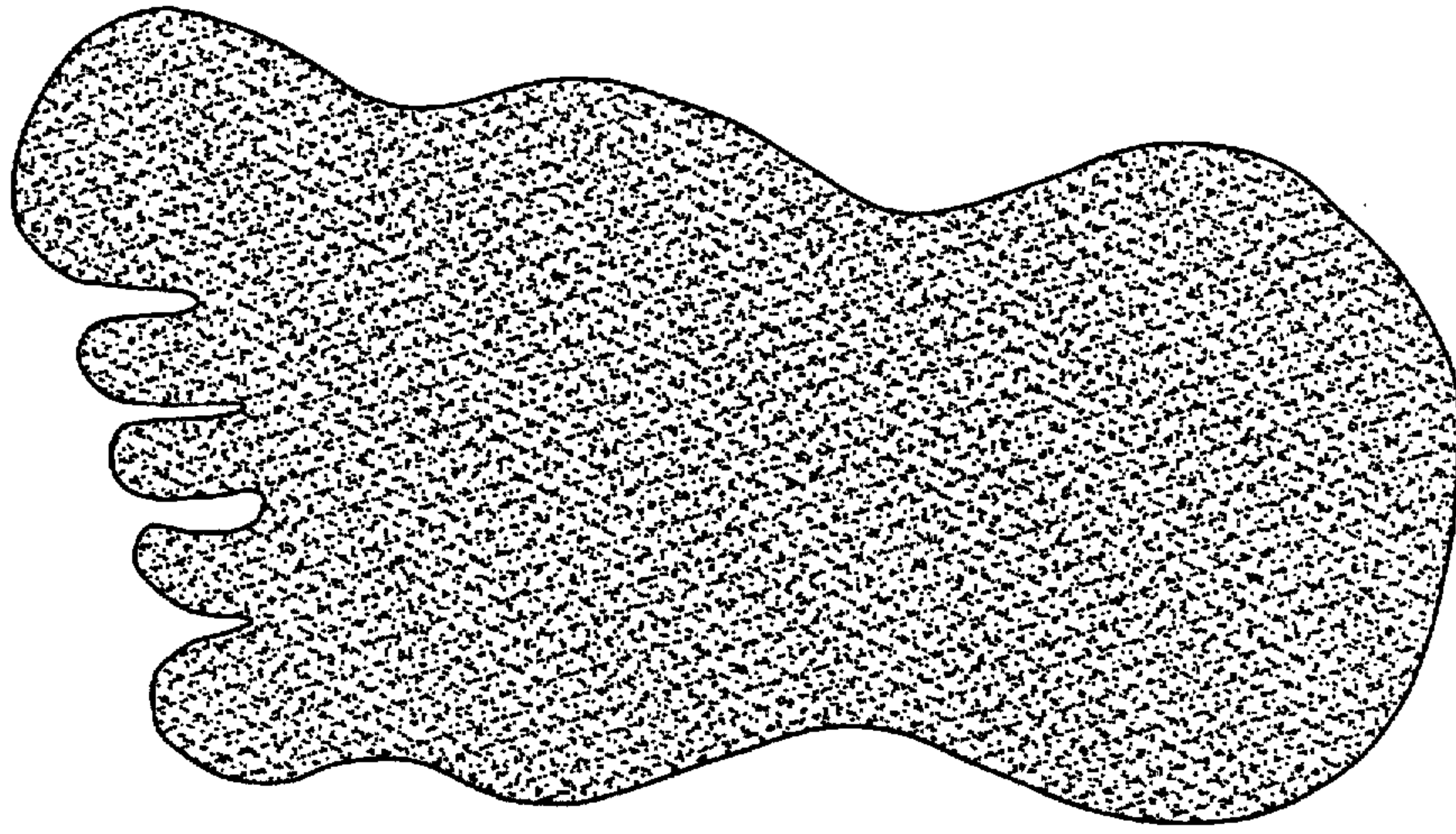

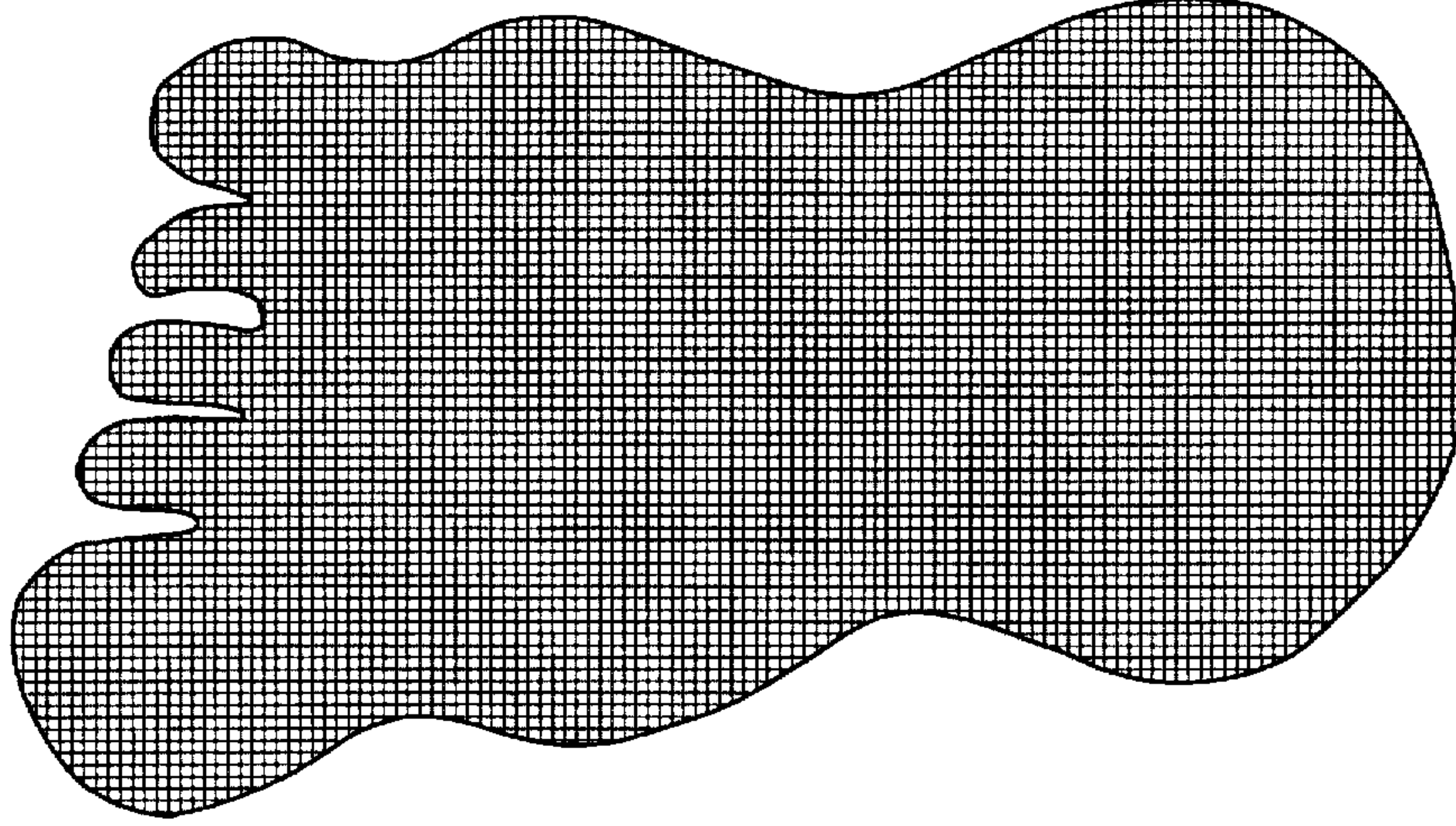
