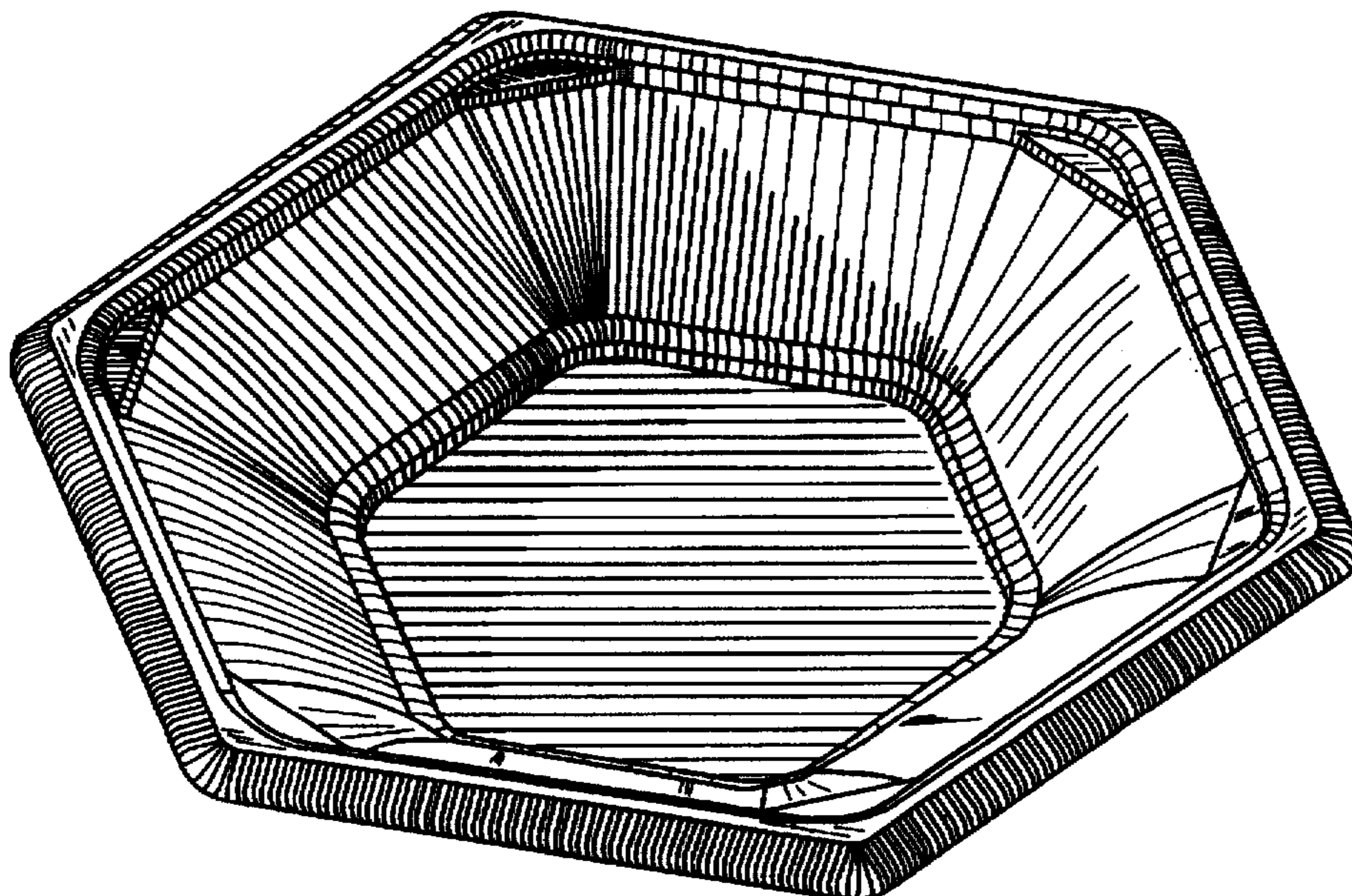
### DESCRIPTION

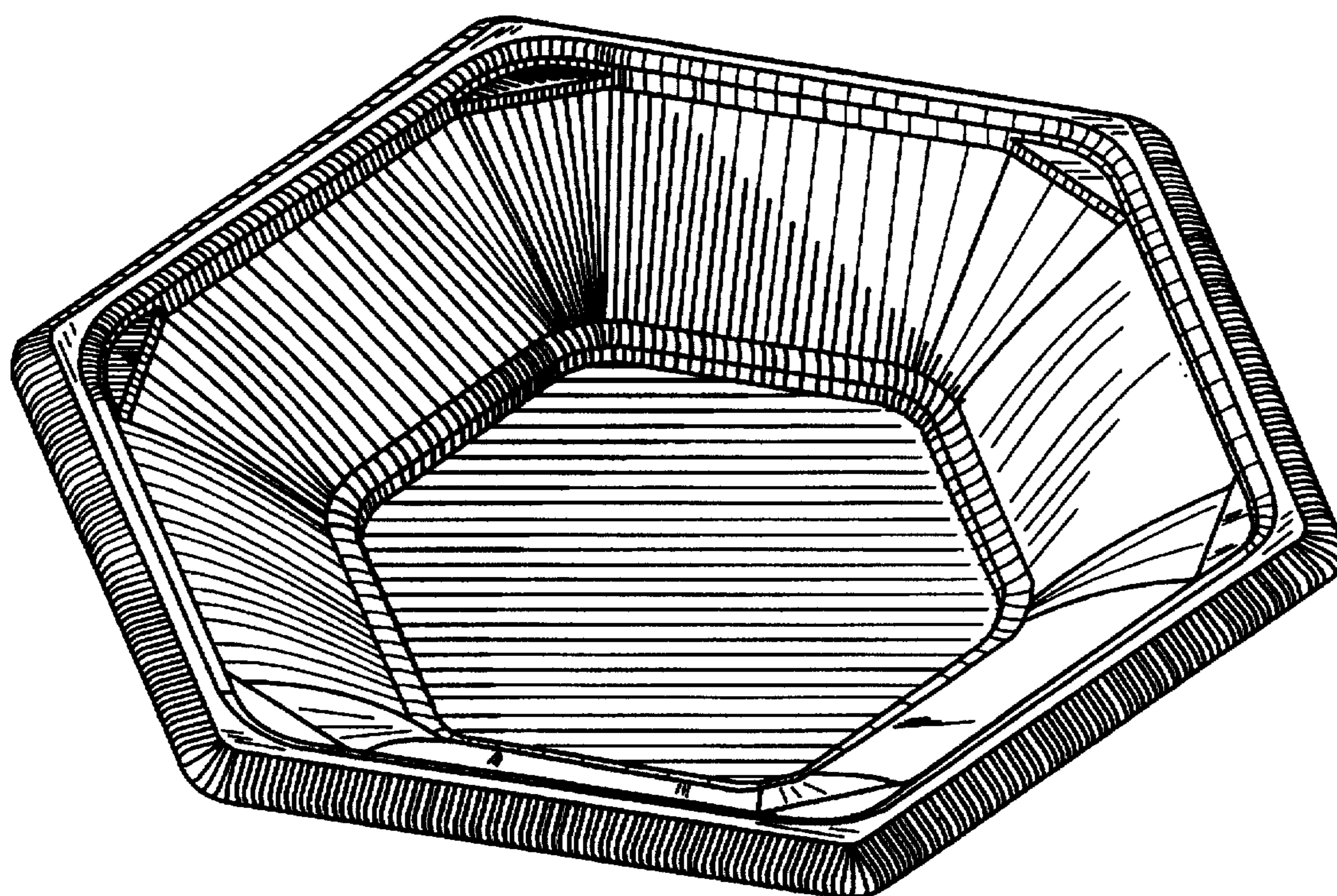

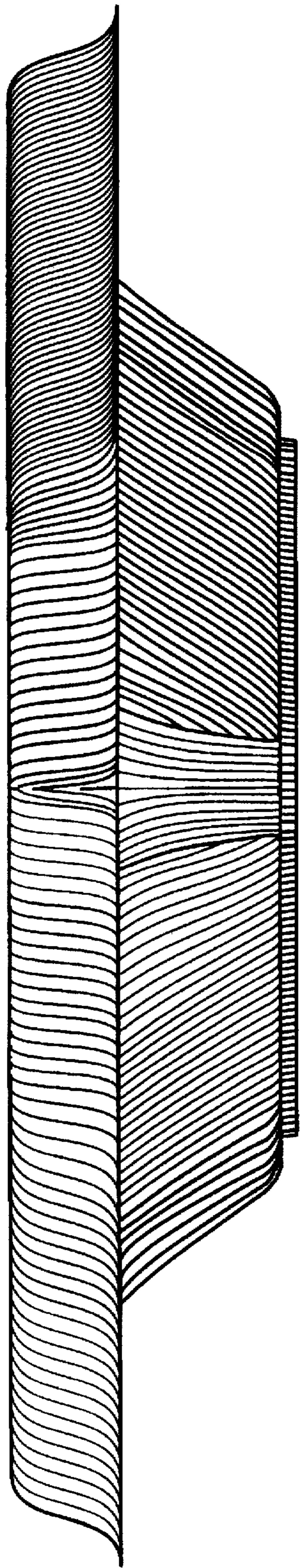

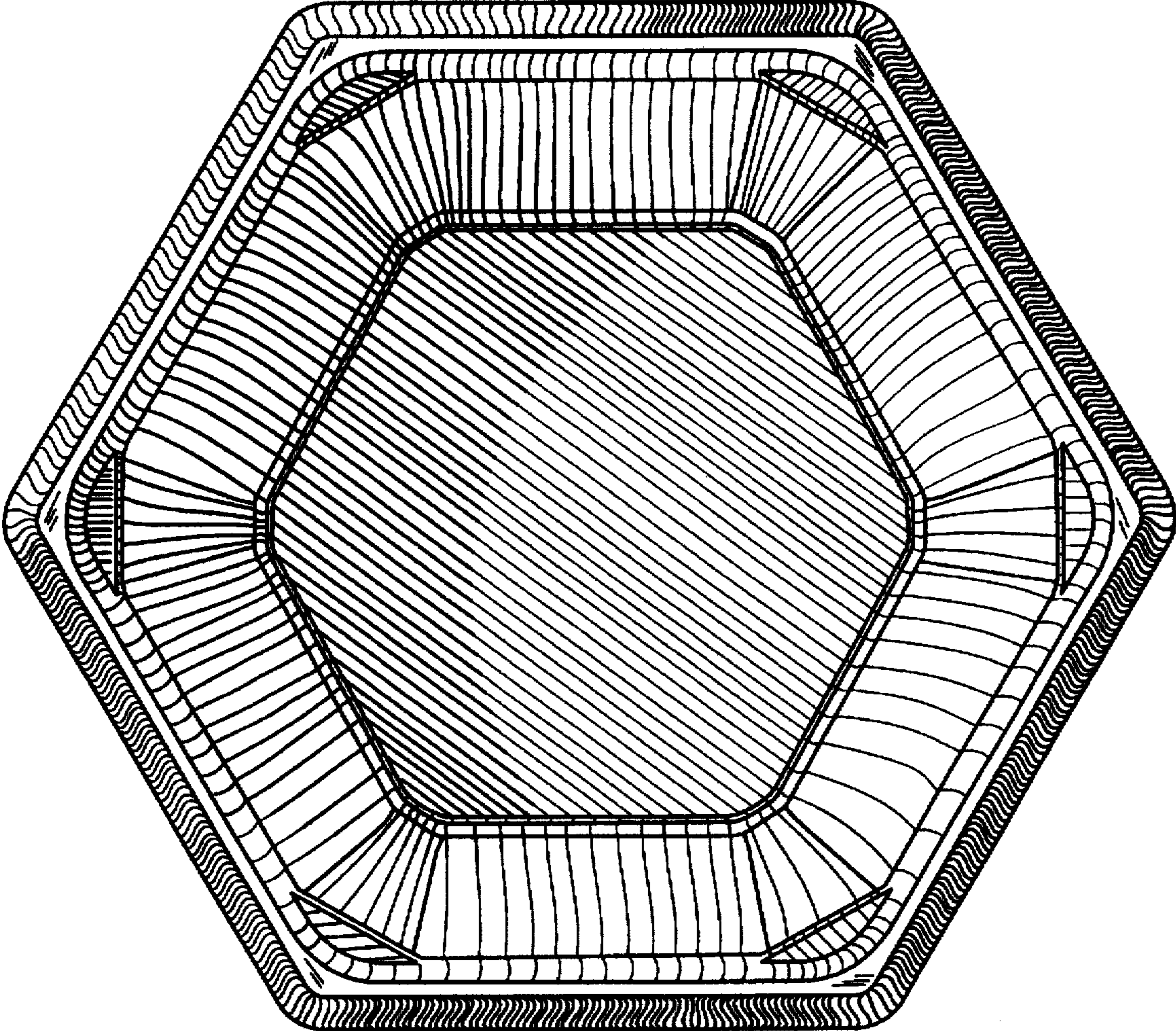

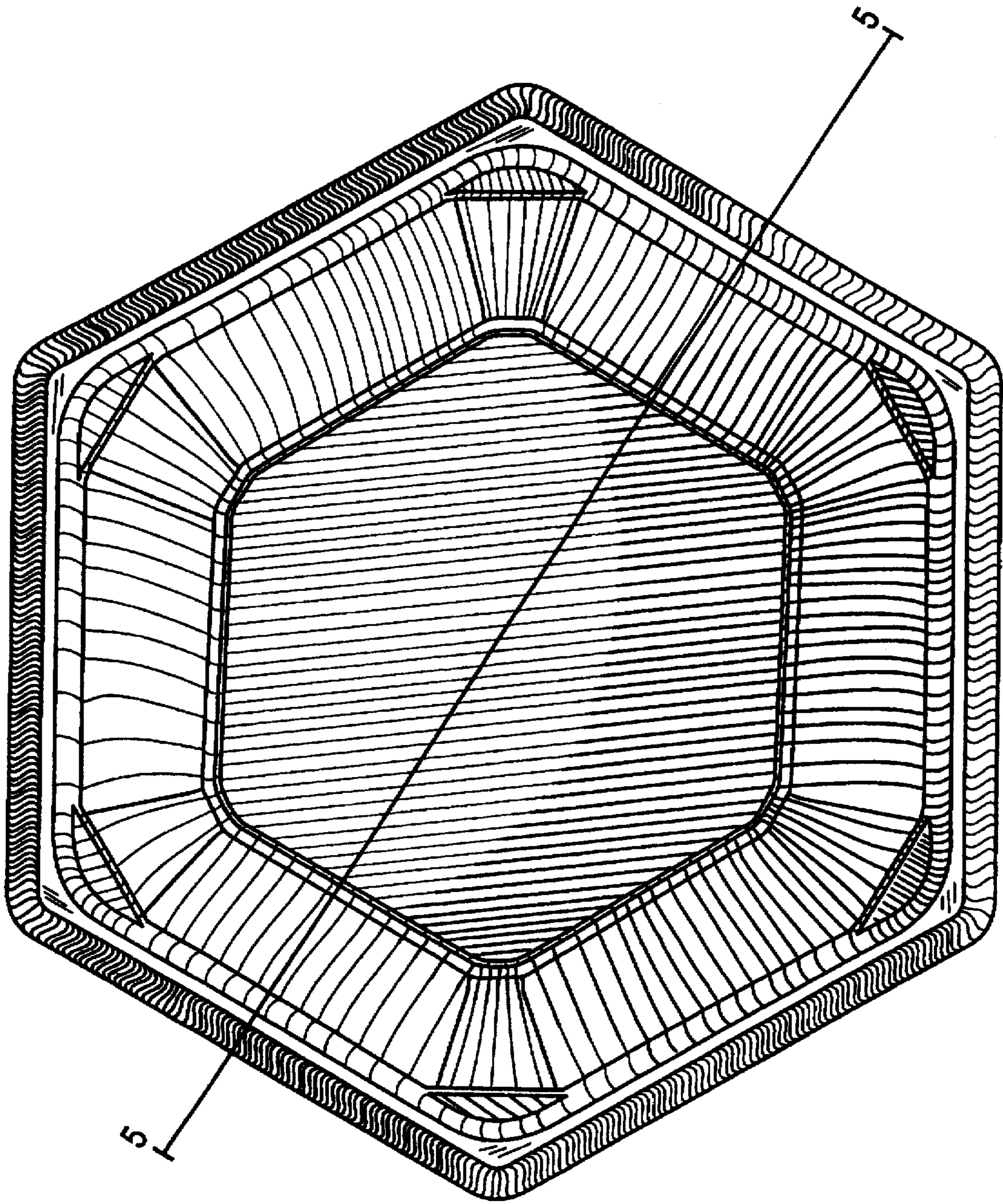

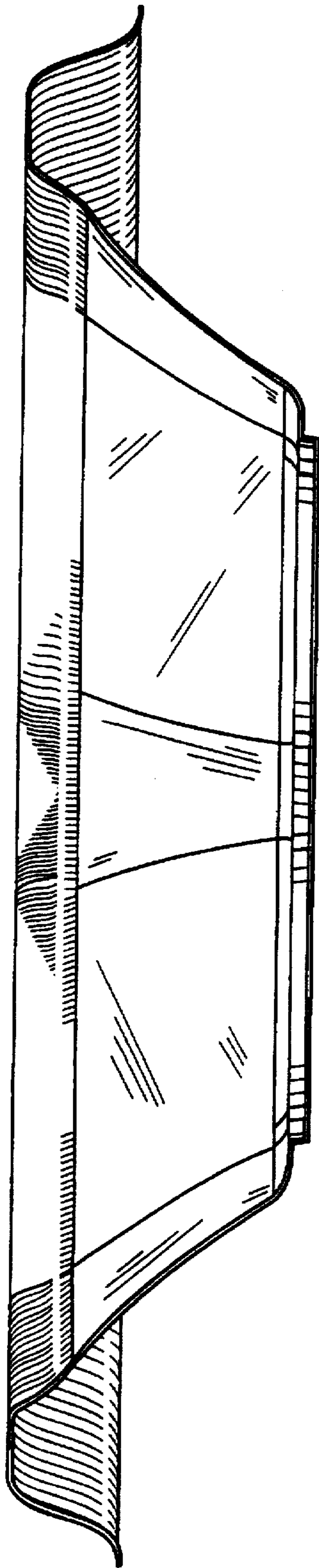
