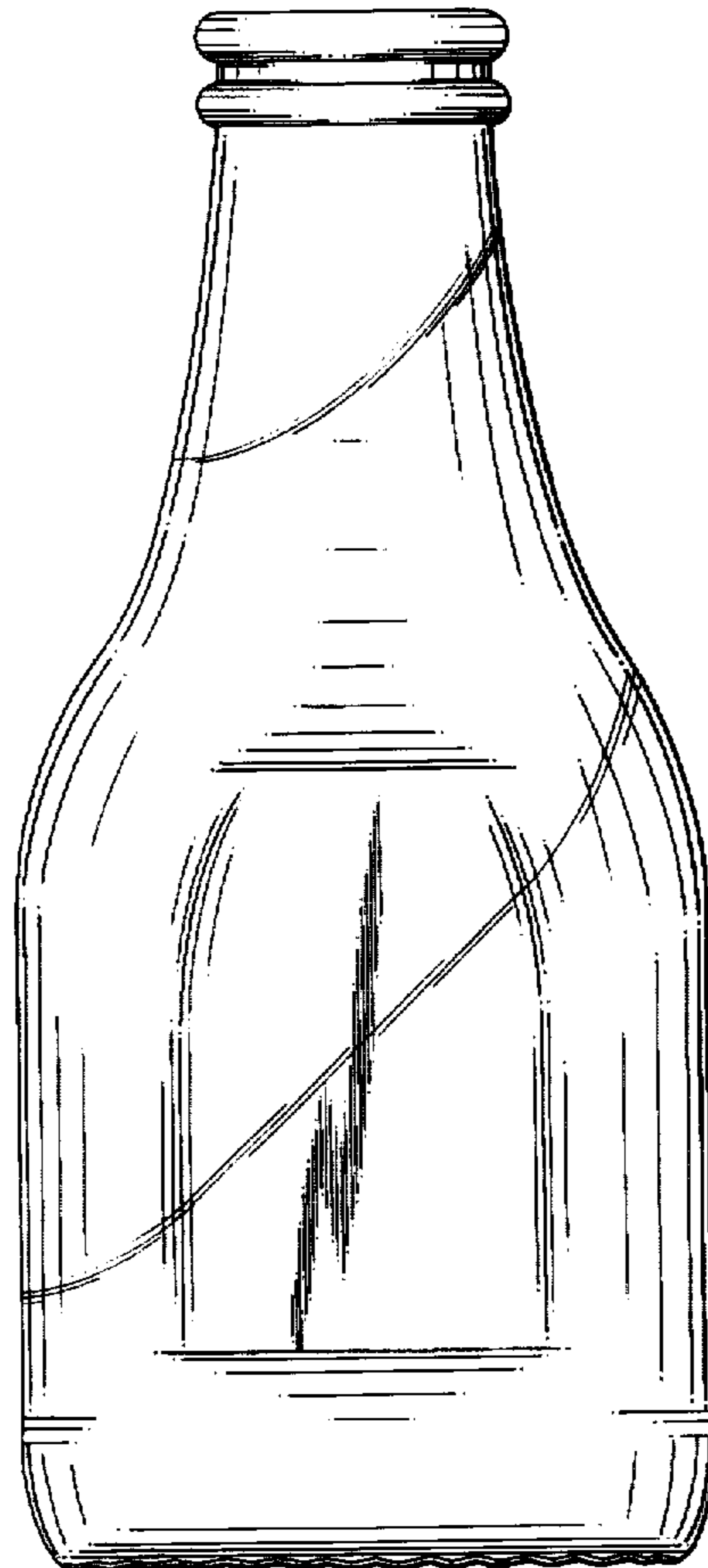
[57] **CLAIM**

The ornamental design for a milk bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a milk bottle showing my new design, the rear elevational view being a mirror image thereof;
FIG. 2 is a left end elevational view thereof, the right end elevational view being a mirror image thereof;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a bottom plan view thereof.

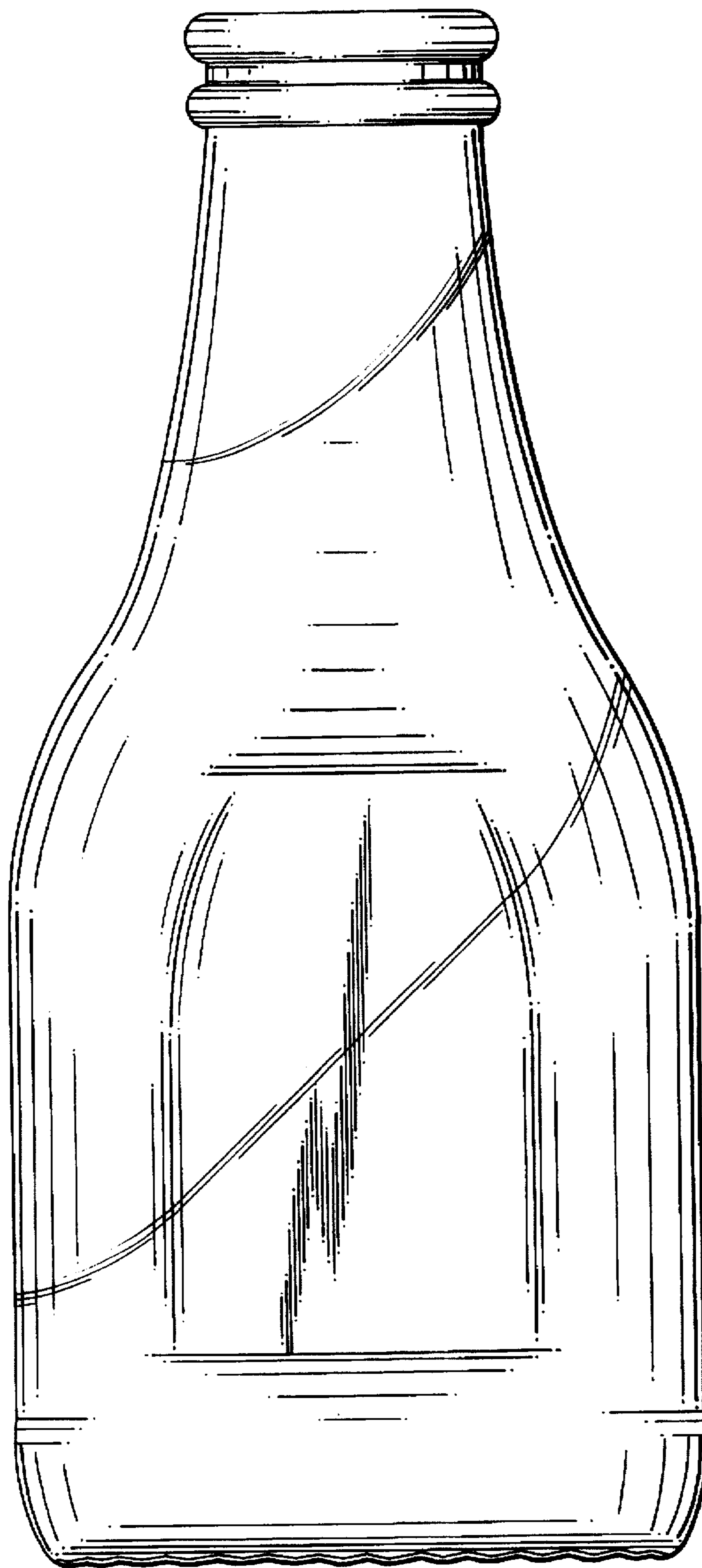

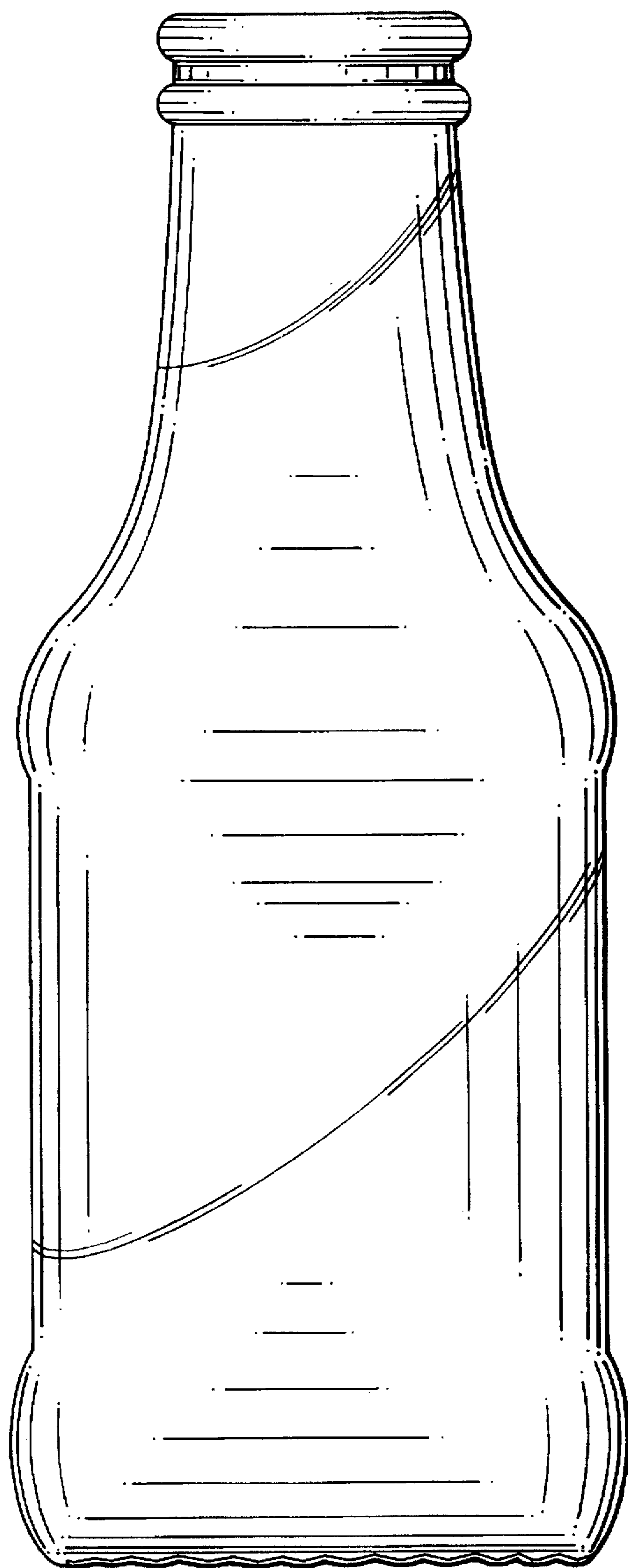

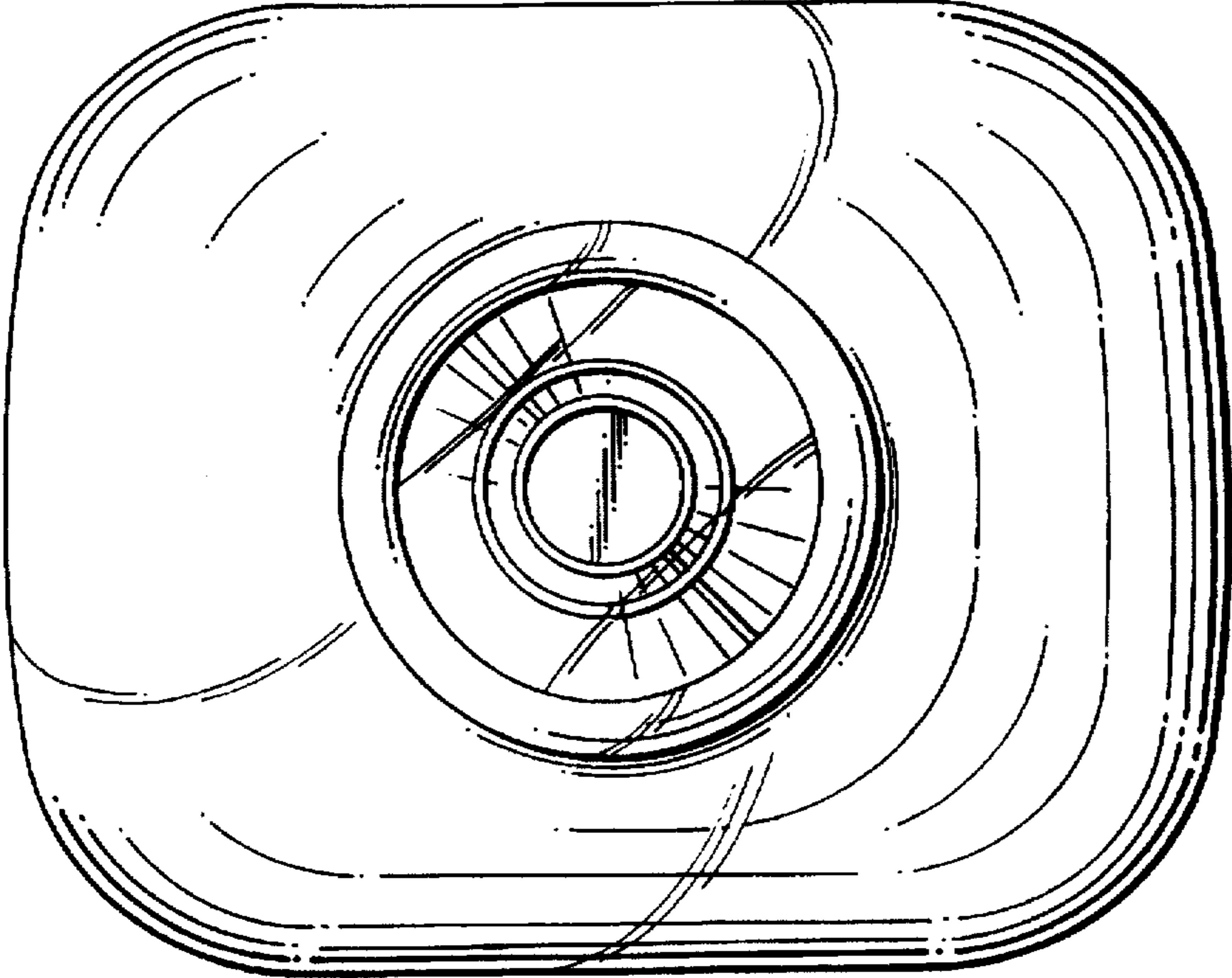

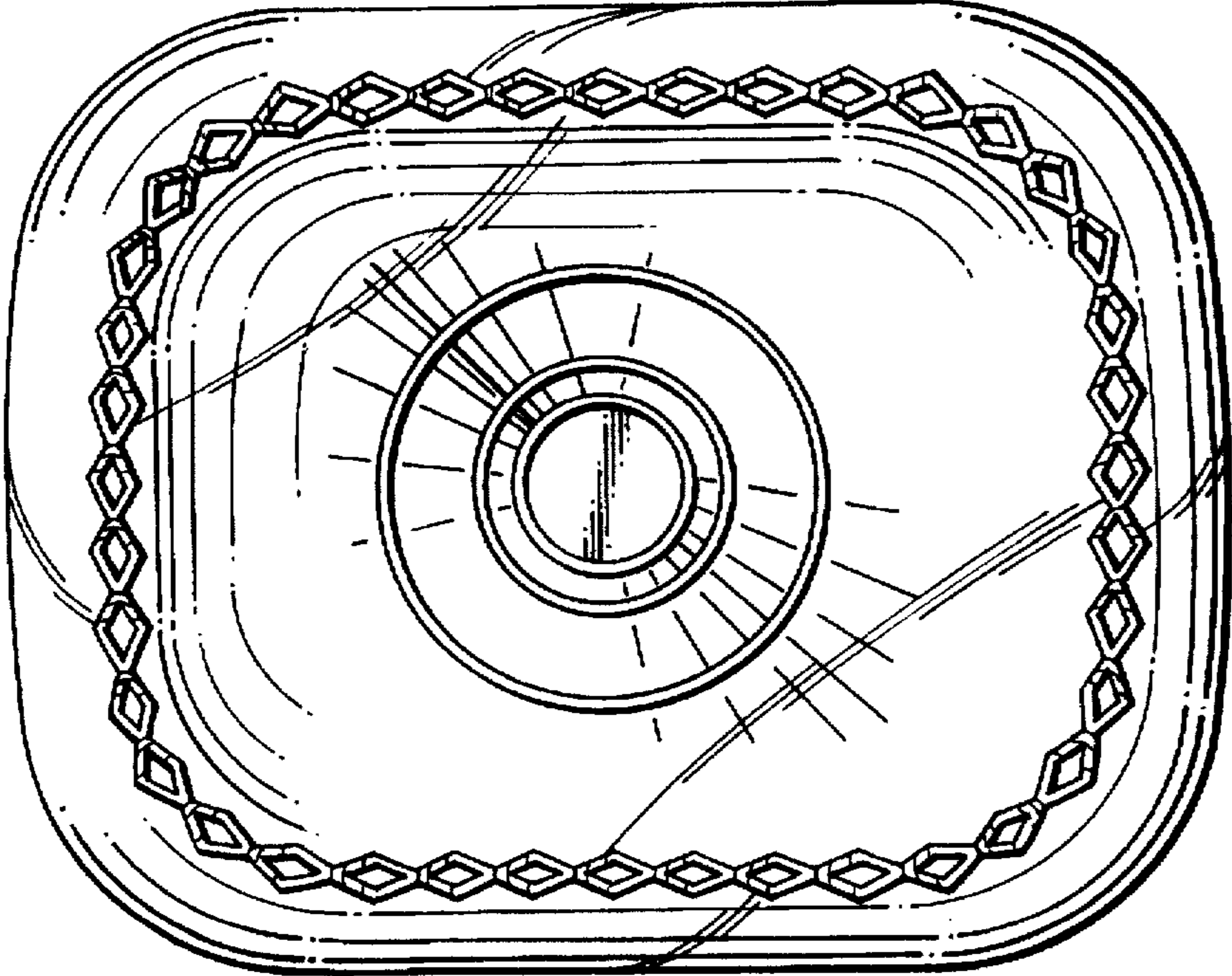
