[57] CLAIM

The ornamental design for a telephone combined with an answering machine, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right-side perspective view of a telephone combined with an answering machine, showing our new design;

FIG. 2 is a top, front and right-side perspective view thereof, shown with hand-set separated therefrom;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

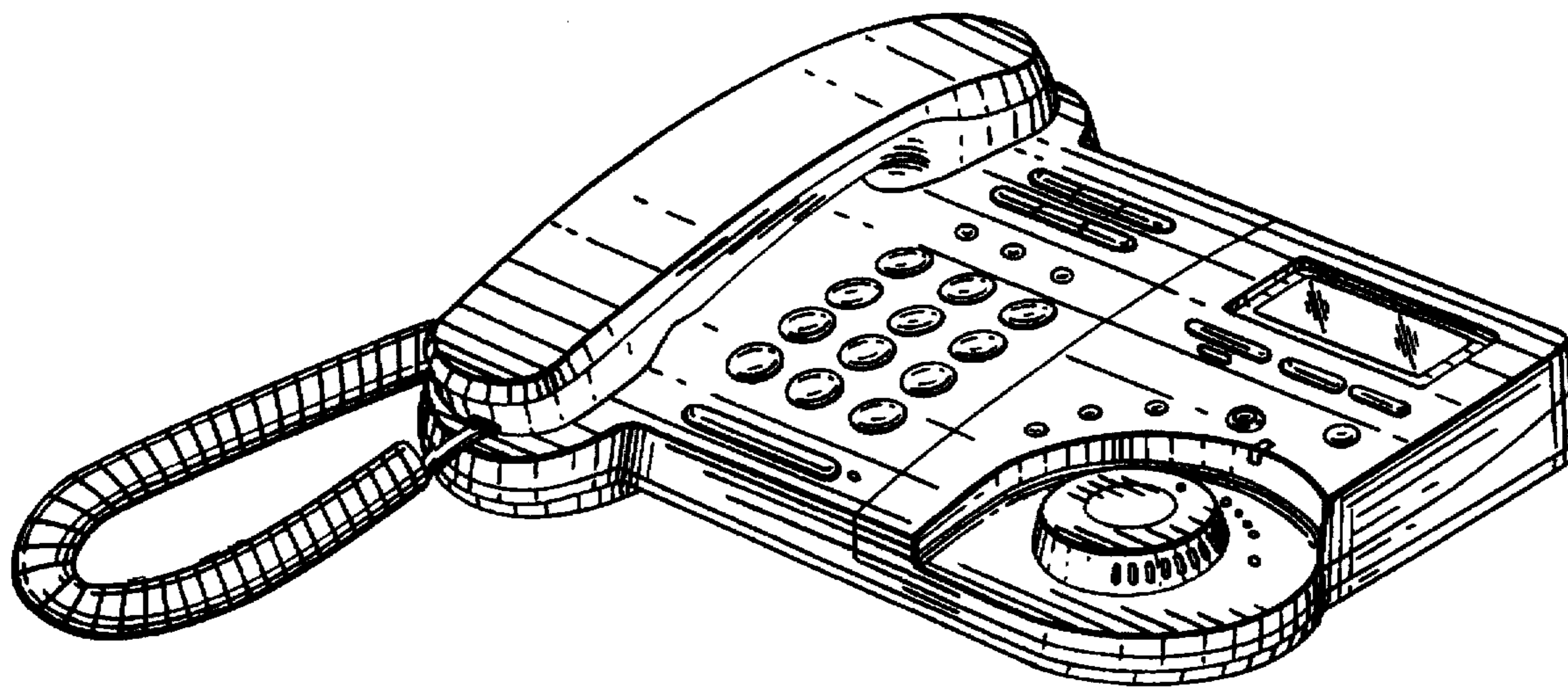
FIG. 5 is a left-side elevational view thereof;

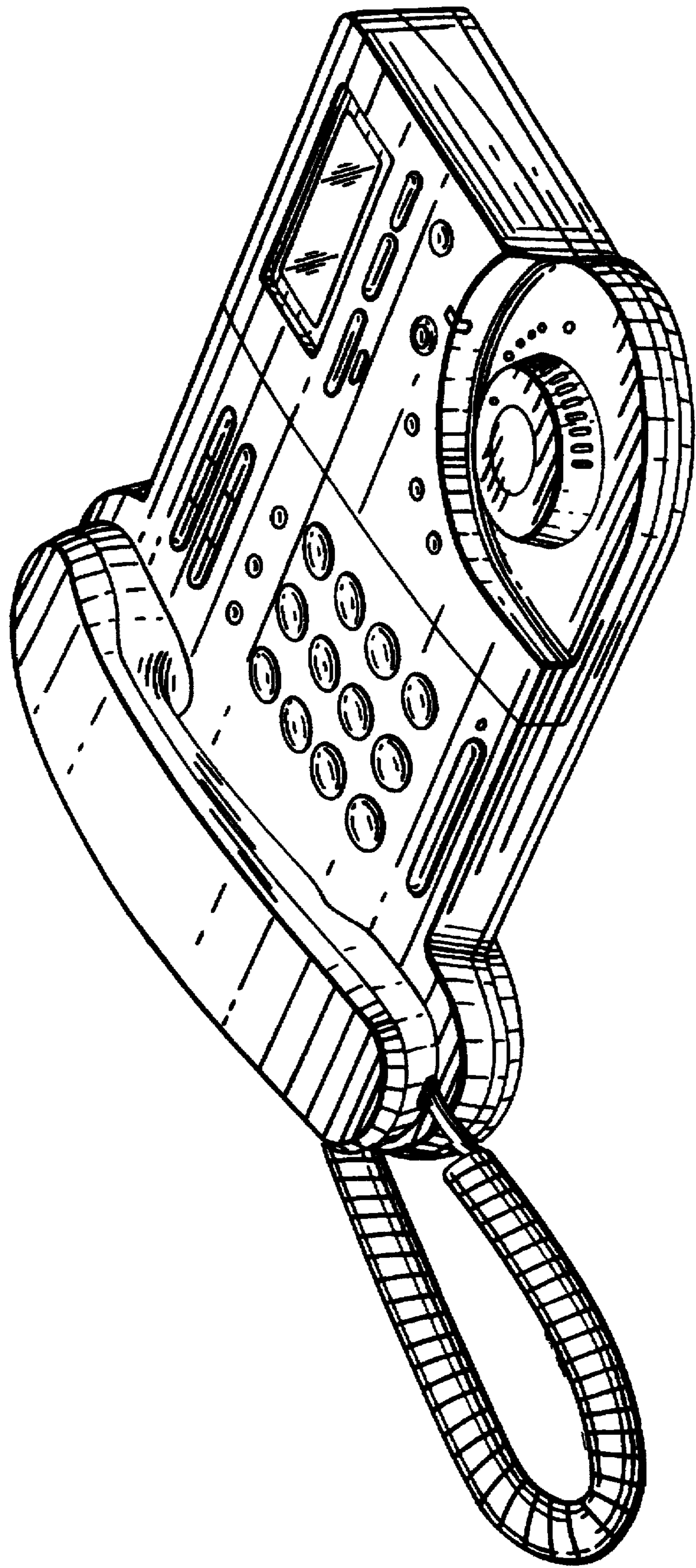

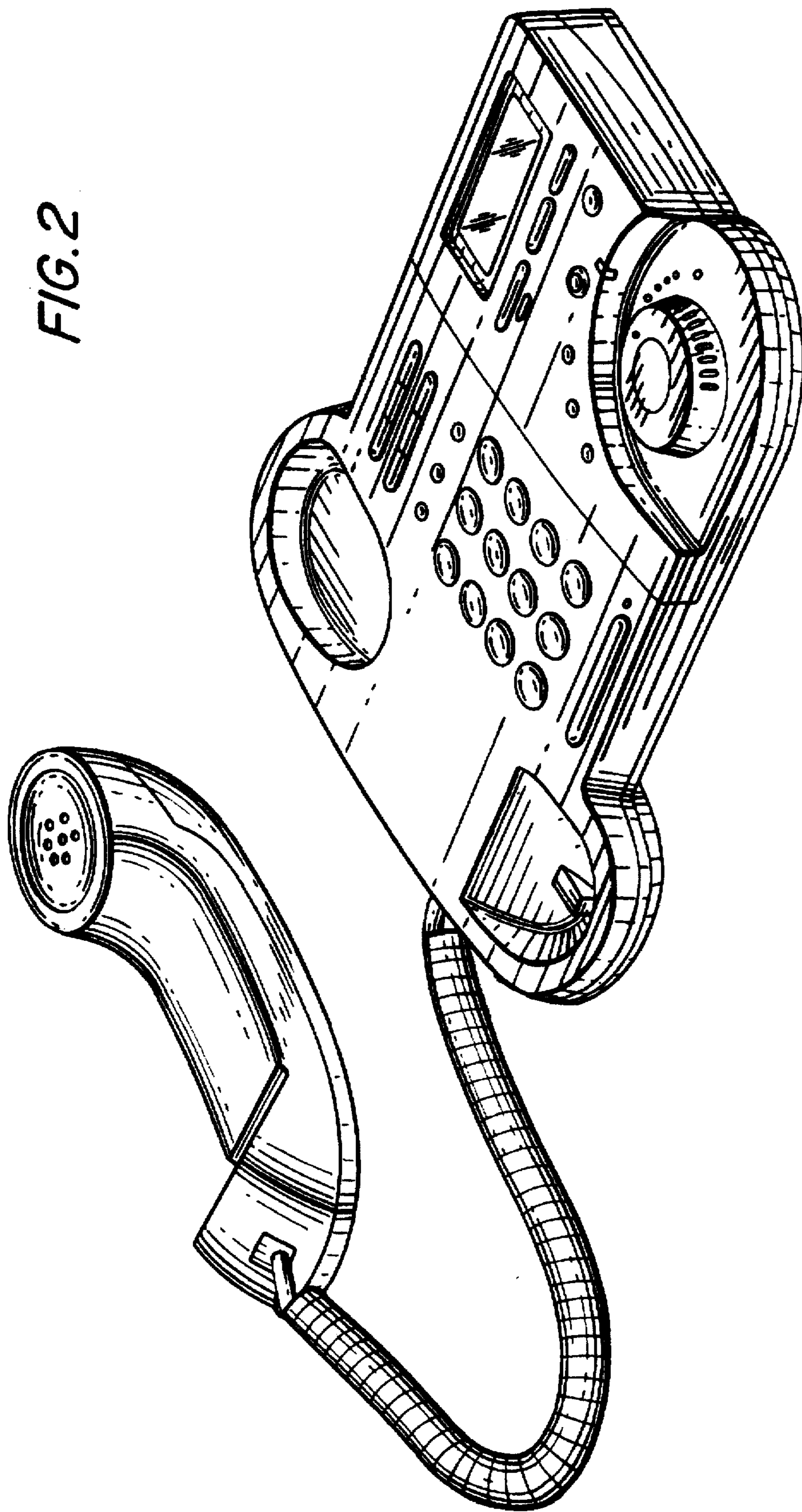

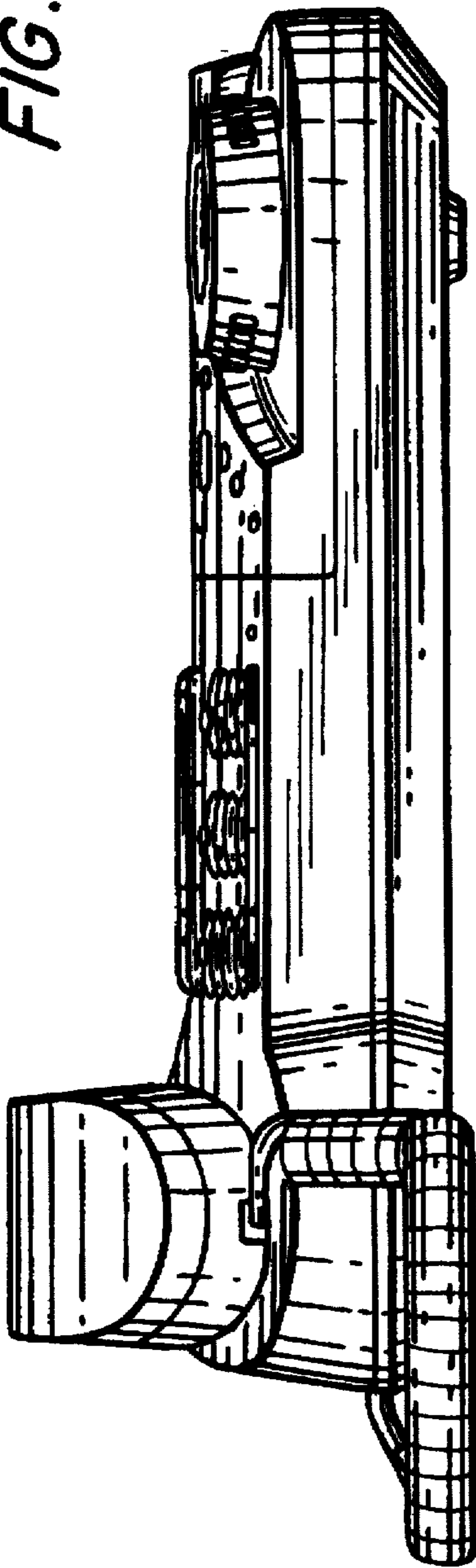
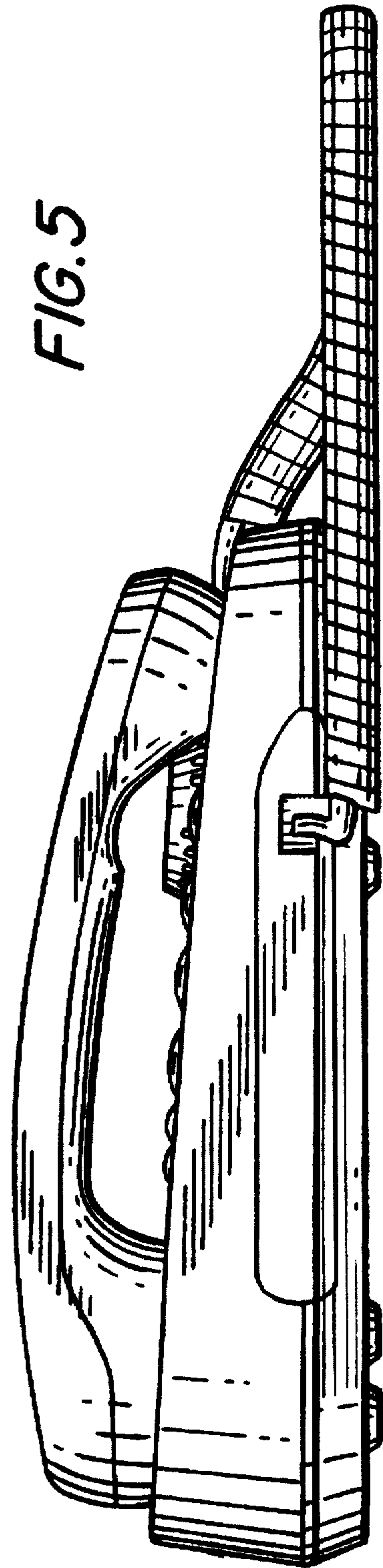

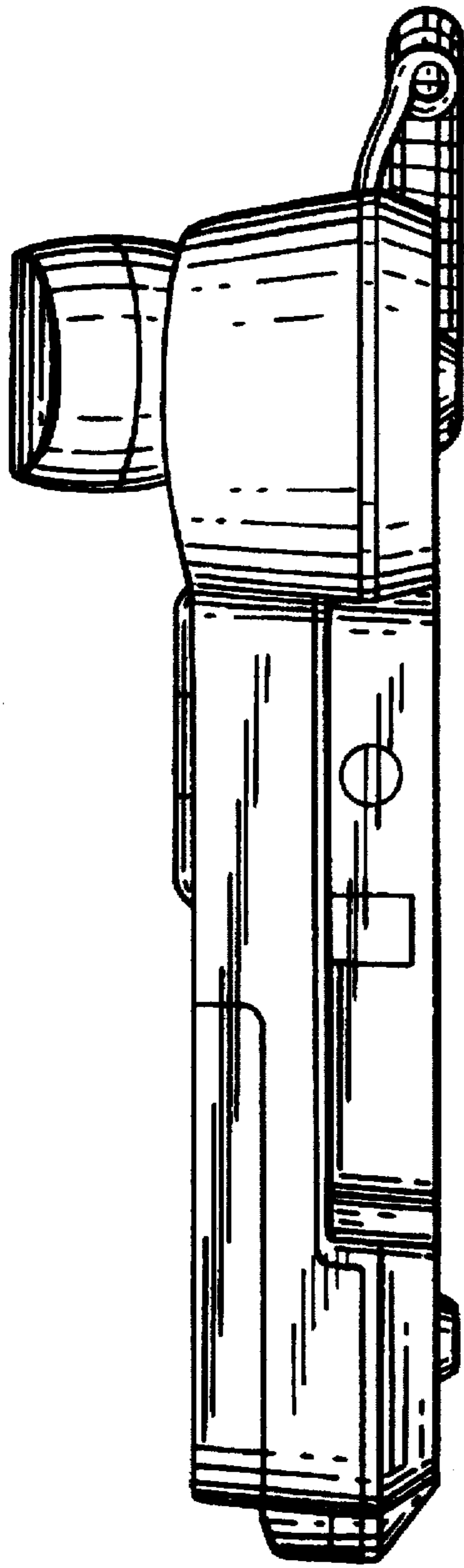

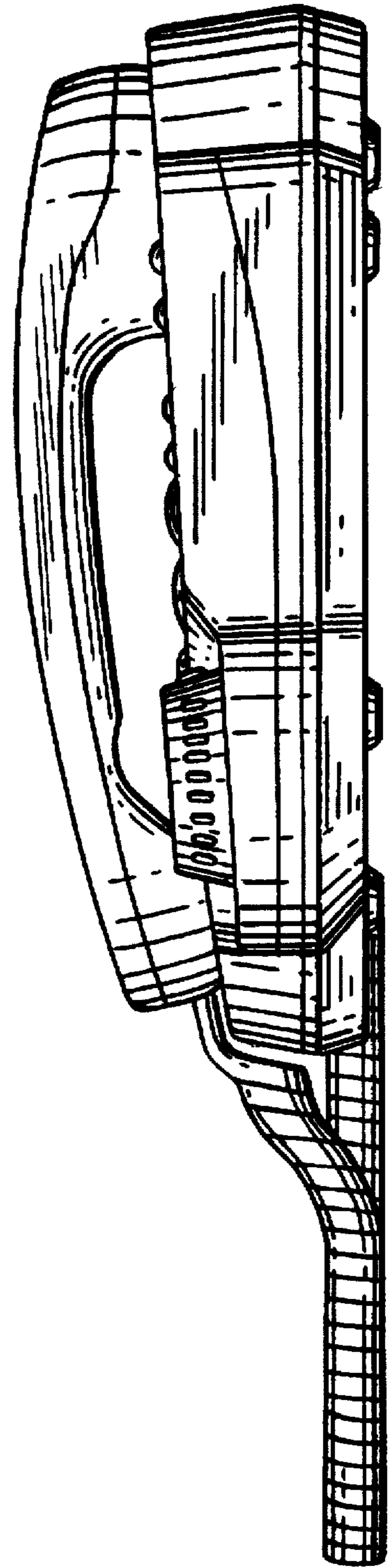

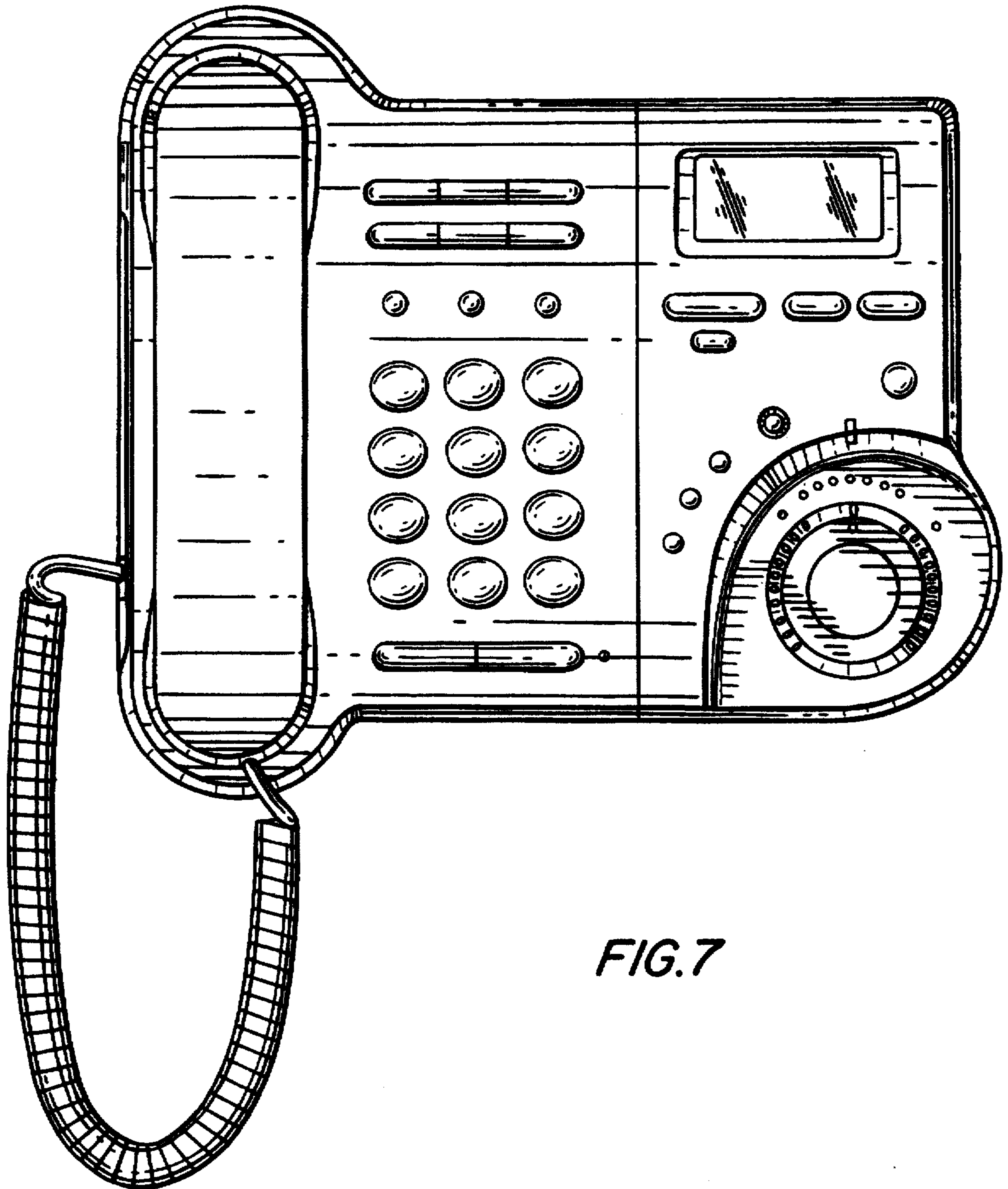
